Transbocation of a Single Stranded DNA Through a Conform ationally Changing Nanopore

W e investigate the translocation of a single stranded DNA through a pore which uctuates between two conformations, using coupled master equations. The probability density function of the rst passage times (FPT) of the translocation process is calculated, displaying a triple, double orm ono peaked behavior, depending on the interconversion rates between the conformations, the applied electric eld, and the initial conditions. The cum ulative probability function of the FPT, in a eld-free environment, is shown to have two regimes, characterized by fast and slow timescales. A n analytical expression for the mean rst passage time of the translocation process is derived, and provides, in addition to the interconversion rates, an extensive characterization of the translocation process. R elationships to experimental observations are discussed.

INTRODUCTION

Translocation of biopolymers through a membrane pore occurs in a variety of biological processes, such as gene expression in eucaryotic cells (B A lberts et al., 1994), conjugation between procaryotic cells, and virus infection (Madigan et al., 1997). The importance of translocation in biological systems and its applications, have been the motivation for recent theoretical and experim ental work on this topic. In experim ents one usually measures the time it takes a single voltage-driven single stranded DNA (ssDNA) to translocate through hem olysin channel of a known structure (Song et al., 1996). Since sed NA is negatively charged (each m onom er of length b has an e ective charge of zq, where q is the electron charge, and z (0 < z < 1) is controlled by the solution pH and strength), when applying a voltage the polymer is subject to a driving force while passing through the transmem brane pore part (TPP) from the negative (cis) side to the positive (trans) side (for an illustration of the process see M eller 2003, qure 4). Because the presence of the ssDNA in the TPP blocks the cross-TPP current, one can deduce the FPT probability density function (pdf), F (t), from the current blockade duration tim es (K asianow icz et al., 1996; M eller et al., 2001).

Experiments by K asianowicz et al. (1996), show F (t) with three peaks. It was suggested that the shorttime peak represents the non-translocated events, while the other two, longer-time peaks, represent translocation events of di erent son A orientations. In addition, the times that maximize the translocation peaks were shown to be proportional to the polymer length and inversely proportional to the applied etd. In experiments by M eller et al. (2001), F (t) was shown to be monopeaked, with a corresponding maximizing time that has an inverse quadratic etd dependence. More recently, Bates et al. (2003) m easured the FPT cum ulative probability function (qpf), which is the probability to exit the channel until time t, G (t) = ${}^{R_{t}}_{0}$ F (s)ds, in a eld-free environm ent. G (t) was approximated by two wellseparated timescales with the ratio of 1=20.

In previous theoretical works, the translocation of a ssDNA through a nanopore was described by statisticalm odels that focused on calculating the free energy of the process as a function of the translocation state. The free energy contained terms that represent the entropy and the chem ical potential of the polym er parts on both sides of a zero thicknessm em brane (Sung and park, 1996; M uthukum ar, 1999). The role of the m em brane thickness was studied by Am b jornsson et al. (2002), Solonika and K olom eisky (2003), and F lom enbom and K lafter (2003a). The obtained free energy was used to calculate the m ean

rst passage time (MFPT), which asymptotically was found to scale linearly with the polymer length for a eldbiased process. This is the expected MFPT dependence of a Markovian biased random walk in a nite interval (Redner, 2001).

A di erent approach was suggested by Lubensky and N elson (1999) and was further developed by B rezhkovskii and G opich (2003), where a di usion-convection equation was used to describe the translocation process, under the assumption that the polymer parts outside the membrane hardly a ect the translocation. B rezhkovskii and G opich (2003) showed that by changing the cis absorbing end to be partially absorbing, the mono-peaked F (t) obtained by Lubensky and N elson (1999) changes to a superposition of a decaying non-translocation pdf and a peaked translocation pdf. U sing the fractional Fokker-P lanck equation, M etzler and K lafter (2003) suggested an explanation for the slow relaxation time of the experimentally obtained G (t). W e have shown by using the master equation (M E) that F (t) can be double or monopeaked, depending on the applied eld and on the initial condition (Flom enbom and Klaffer, 2003a).

In the approaches sum marized above the structure of the pore is taken to be rigid, namely, governed by a single conformation. Although it is known that the hem olysin channel has a rigid structure that allows its crystallization (Song et al., 1996), during the translocation of a long polymer (larger than the pore length) with the same width that of the channel at some cross sections along the channel, sm all uctuation in the channel structure may occur, which give rise to a more complex process than what was assumed so far. In this work we relax the assumption of a single pore conformation and introduce a second conform ation coupled to the rst one. In a continuum formalism, the process takes place in an e ective two dimensional system, where one dimension represents the translocation itself, and the second dimension represents the structural uctuations. This picture is richer and is more realistic, since sm all structural changes in physiological conditions are known to occur in large biom olecules, certainly during interaction with other large biom olecules.

The function that represents best the translocation process is F (t) (or its integralG (t)). Through the dependence of F (t) on the system parameters, we learn about the important degrees of freedom which participates in the translocation process. The characteristics of F (t) are the dependence of its shape, moments, and times that maxim ize its peaks on the system parameters. U sing the generalized model that takes into account uctuations in the pore structure, we calculate F (t) and show that it can display one two or three peaks, depending on the applied voltage, the temperature and the interconversion rates between the two conformations. A nalytical expressions for the M FPT are derived and related to the experimental

ndings. In addition, we calculate the cum ulative probability G (t) in the eld-free limit, and show that it also provides valuable information about the system param – eters. Thus, these tools help in gaining insight into the translocation of a polymer through a narrow pore, and in explaining the diversity of the experim ental observations (K asianow icz et al., 1996; M eller et al., 2001).

THEORETICAL MODELLING

Basic M odel

The basic model we use to describe the translocation relies on a one-dimensional process. To use this sim – pli cation, we map the three-dimensional translocation process onto a discrete one-dimensional space containing n (= N + d - 1) states separated from each other by a unit length b. The translocation takes place within a TPP of a length that corresponds to d monomers. An n-state M E is introduced to describe the translocation of an N – monom er long ssDNA subject to an external voltage V and temperature T. The occupation pdf of the j state is $[\vec{P}(t)]_j = P_j(t)$, where the state index j determ ines the number of monom ers on each side of the membrane and

within the TPP (m_j) . P_j(t) satis es the equation of motion:

under absorbing boundary conditions on both sides of the membrane (the polymer can exit the TPP on both sides). Eq. 1 can be written in a matrix representation:

where the propagation matrix A is a tridiagonal matrix that contains inform ation about the transitions between states in terms of rate constants, $a_{j;j-1}$, which are given by:

Here k_j is the rate to perform a step, $p_{j;j-1}$ ($p_{j;j+1}$) is the probability to move one state from state j to the trans (cis) side, and $p_{j;j+1} + p_{j;j-1} = 1$.

 k_j is taken to be sim ilar to the longest bulk relaxation time of a polymer (D oi and E dwards , 1986):

with two exceptions: the parameter $_{\rm p}$ represents the sSDNA-TPP interaction and cannot be calculated from the Stokes relation, and serves as a measure of the polymer sti ness inside the con ned volume of the TPP, and is bounded by the conventional values (Doi and Edwards, 1986): 0 1:5.

A ssum ing a quasi-equilibrium process, which enables using the detailed balance condition, and using the approximation $a_{j;j}$ $_1=a_j$ $_{1;j}$ $p_{j;j}$ $_1=(1 p_{j;j})$, the probability $p_{j;j}$ is found to be:

The free energy di erence between states, $E_j = E_{j-1} = E_{j-1}$ E_j , is computed considering three contributions: electrostatic, entropic, and an average attractive interaction energy between the ssDNA and the pore. More explicitly,

E_j is given by E_j = E^p_j + _j, where E^p_j 0 represents the e ect of the eld which directs towards the trans-side and _j > 0 (for j > d) represents an e ective directionality to the cis-side, which originates from the entropic factors and the average attractive interaction energy between the ssDNA and the pore. For a more detailed discussion see F lom enbom and K lafter (2003a).

Several features emerge from the simple onedimensionalmodel. For hom opolymers, poly-dnu, where nu stands for the nucleotide type, we estimate $_{\rm p}({\rm A}_{\rm nu})$ 10 4 m eV s=nm², $_{\rm p}({\rm C}_{\rm nu})=_{\rm p}({\rm T}_{\rm nu})=_{\rm p}({\rm A}_{\rm nu})=3$ and (C $_{\rm nu}$)=1, (A $_{\rm nu}$)=1:14, (T $_{\rm nu}$)=1:28. Here A $_{\rm nu}$, C $_{\rm nu}$ and T $_{\rm nu}$ stand for adenine, cytosine and thym ine nucleotides, respectively. Interestingly, $_{\rm p}$ is three order of m agnitude larger than the bulk friction constant, which is consistent with the role assign to $_{\rm p}$ to represent the interaction between the polymer and the channel.

In addition, from the expressions for E_j and $p_{j;j-1}$, the important parameter $V=V_C$ zjqjV (1+1=d) comes out naturally. This ratio determ ines the directionality of the translocation, and, in particular, for $V=V_C > 1$ there is a bias towards the trans-side of the mem brane.

Translocation Through a Conform ationally Changing Pore

A more realistic description of the translocation can be obtained by taking into consideration uctuations in the TPP, either spontaneous or interaction induced. A ccordingly, we introduce an additional pore conform ation which is represented by the propagation matrix B. The changes in the pore conform ation between A and B are controlled by the interconversion rates, $!_A$ and $!_B$. $!_A$ ($!_B$) is the rate of the change from the A (B) to the B (A) pore conform ation.

The physical picture of the process is that when the pore conformation changes, a di erent environment is created for the set NA occupying the TPP. This im plies a change in $_p$ and . For a large polymer, N > d, we take B A, where is a (dimensionless) parameter that represents the e ect of the conformational change on $_p$ and . The parameter may be interpreted as a measure of an e ective available volume in the TPP, when the am ino acids residues protruding the TPP change their positions.

The equations of motion of the ssDNA translocation through the uctuating pore, written in matrix representation, are:

where \dot{P} (t;i); i = A; B is the occupation pdf vector of con guration i, $!_i = !_i I$, and I is the unit matrix of n dimensions.

As a general note we refer to the form of Eq. 6, which was used to study the resonant activation phenomenon (BarHaim and Klaffer, 1999). This phenomenon, which was rst reported by Doering and G adoua (1992), is the occurrence of a global minimum in the MFPT as a function of the interconversion rate for a system in which $!_{\rm A} = !_{\rm B}$. Because of the assumption B = A, the system investigated here cannot exhibit this phenomenon (Flom enborn and Klaffer, 2004).

DENSITY OF TRANSLOCATION TIMES

Param eters Tuning

To study the translocation of ssD NA through a uctuating pore, we start by computing F (t). Form ally, F (t) is dened by

Here, S (t) is the survival probability, namely, the probability to still have at least one monomer in the pore, and is given by sum ming the elements of the vector that solves Eq. 6; see Appendix A for details. Using the known values of $_{\rm p}$ and from the single conformation model, we examine in this subsection the elect of the parameters , ! A and ! B on F (t).

First, we check the e ect of on F (t) for several limiting cases. For = 0 m ovem ent in any direction occurs only under the A conform ation environm ent. The B conform ation traps the polym er for a period of time governed by the interconversion rates. For = 1, namely, B = A, the environm ental changes do not a ect the translocation, and the process reduces to a translocation through a single conform ation. For > 1 the environm ental changes enhance the process. In this paper we restrict ourselves to the range 0 1.




Figure 1 Poly-dT_{nu} F (t), for several values of , with: N = 30, d= 12, x=N + d=2, T = 2° C, V=V_C = 2, !_B = 10^{2} H z, != 1, and z 1=2. The left peak represents the non-translocated events, whereas the other two peaks represent translocation. Inset: The range for which yields three peaked F (t) is show n to be 0:1 0:3, when given the above param eters.

The picture is less intuitive for interm ediate values of . Fig. 1 shows that by choosing properly, three peaks in F (t) can be obtained. In particular, as shown in the inset of Fig. 1, the range of values for which F (t) exhibits three distinct peaks is 0:1 0:30. For the single conformation case we found that F (t) can be either m ono or double peaked depending on $V=V_{\rm C}$, and on the initial state of the translocation x. The short tim e peak represents the non translocated events, while the long time peak represents the translocation events. The generalization for two pore conform ations may yield two translocation peaks in addition to a short time non translocation peak. Indeed, Fig. 1 supports the expected behavior for the limiting values, and shows that as ! 1, F (t) possess only one translocation peak, as well as for ! 0, where the B conform ation peak spreads out

tow ards larger times, which results in its disappearance. A lthough Fig. 1 is obtained for a given value of the interconversion rates, our explanations regarding the F (t)

behavior for the limiting cases = 1;0, are valid for any system conditions. This is demonstrated by calculating the MFPT (Appendices B and D). In Appendix B we show that when = 1, the MFPT of the two con gurations m odel reduces to that of the single conformation m odel. In Appendix D we show that for = 0, the B conformation contribution for the MFPT is a term which is inversely proportional to the interconversion rate, $!_{B}^{-1}$.

Therefore, serves as a tuning parameter that leads to either one or two actual translocation peaks in F (t). The question of interest is how depends on the system parameters. We assume a small eld perturbation in the $V = V_C$ regime of biological interest [0 3, using V_c 50m V (Flom enbom and Klafter, 2003a)], so that (V) follow s $_0$ + V=V , and keeping (V) 1. Here $_0$ and V might be expansion coe cients, where 0 1 is im plied from recent experim ents (Bates et al., 2003), as we discuss later. The process can be viewed such that as the voltage increases, am ino acids residues protruding the TPP that constitute obstacles for the translocating ssDNA clear the way. W hile the dependence on the voltage is assumed here, its dependence on other system param eters (e.g., tem perature and pH) is unknown and is folded into V .

To check how interconversion rates a ect F (t), it is convenient to de ne two dimensionless parameters, ! !_A =!_B and !_B =k (or !_A =k), where k is the dominate rate of the A conformation for a su ciently large N, k = R = d. The rst ratio set the dominance of a given conformation over its counterpart; namely, for ! 1 m ost of the translocation events take place in the A conformation. The second ratio gives an estimate of the number of m oves done in a given conformation before a change in the pore structure occurs, and thus relates the ssDNA dynamics to the structural changes dynamics.




Figure 2 Poly- $dT_{nu} F$ (t), for several values of !_A and xed !_B (!_B = 10^2 H z), with = 1=4, and the other parameters as in Fig. 1. Inset: For sm all values of !, ! . 10^2 , F (t) displays one translocation peak that corresponds to conform ation A, whereas for large values of !, ! & 10^2 , F (t) displays one translocation peak that corresponds to conform ation B. For ! 1 two translocation peaks are obtained.

As shown in Fig. 2 and in the inset of Fig. 2, F (t) exhibits two peaks corresponding to actual translocation only when ! 1. For ! 1 and ! 1 only one peak corresponding to an actual translocation survives. For all cases there is a peak representing non-translocation events. In addition, we nd that for two translocation peaks to be obtained, the ratio $!_B = k$ (or $!_A = k$ due to ! 1) m ust full $1!_B = k$ 10³ (data not shown). The low er lim it of the interconversion rates is inversely proportional to the order of the m easurem ent tim e otherw ise only one conform ation will be detected.

F inally, we assume that the rate of the conform ational changes is controlled m ainly by tem perature; namely, we take $!_A$ and $!_B$ as voltage independent in the regime of biological interest: $0 \quad V = V_C \quad 3$.

Translocation Velocity

To study further the translocation process, we check the voltage dependence of the times that maxim ize the peaks of F (t), denoted as $t_{m \ ;i}$ where i= 1;2;3 (e.g. $t_{m \ ;1}$ characterized the short time peak). In previous works (F lom enborn and K lafter , 2003a; M eller et al. , 2001), t_m^{-1} for one translocation peak was regarded as the most

probable average velocity of the translocation (up to a multiplicative constant). We show below that our assumptions regarding the voltage dependence of the system parameters, yield either linear or quadratic dependence of the translocation velocity on the voltage, and can be used to explain the di erent experimental observations.

Fig. 3 shows $t_{m,i}(V_C = V)$ and $t_{m,i}^1(V = V_C)$, for V = 350 mV, in a voltage window that leads to 0.215

(V) 0:30, and accordingly to a triple-peaked F (t). $t_{\rm m\ ;1}$ is almost independent of $V_{\rm C}$ =V (see Fig. 3a). Although the non translocation peak amplitude decreases upon increasing V=V_C, the location of its maximum hardly changes. This happens since exiting against the eld must happen within a short time window at the beginning of the process, otherwise the polymer is more likely to cross the membrane due to the electric bias. Sim ilar behavior was observed experimentally (K asianow icz et al. , 1996).




Figure 4 $t_{m,2}^{1}$ for poly-dT_{m u} for the same parameters as in Fig. 3 except for V = 120 mV. This value for V leads to 0:625 (V) 0:875 and accordingly for one translocation peak. The solid line is a polynom ial t. Inset: $t_{m} \ _{;1}$ and $t_{m} \ _{;2}$ behave qualitatively the same as for the case V = 350 m V.

For the single conformation case, we showed that $t_{m\ ;2}^{1}$ scales linearly with V=V_C when the initial state of the translocation is near the cis-side of the mem – brane (Flomenborn and K lafter, 2003a). Fig. 3b shows that the linear scaling of $t_{m\ ;2}^{1}$ (V=V_C) persists. How – ever, $t_{m\ ;3}^{1}$ (V=V_C) (Fig. 3c) displays a quadratic behavior, which is a consequence of the form of (V), as discuss in the next section when computing the M FPT.On the other hand, setting V = 120m V leads to one translocation peak, and to sm all deviations from linearity towards a weak quadratic behavior of $t_{m\ ;2}^{1}$ (V=V_C); see Fig. 4.

The model of two conform ations not only yields one or two actual translocation peaks as a function of V, but can account for either a linear or quadratic dependence of the translocation velocity with the voltage, again, as



a function of V. Thus, varying V we obtain di erent behaviors of the translocation, which can be related to the di erent experim ental observations.

THE M FPT

Sm all Field B iased Translocation

W e now turn to calculate the M FPT, which allows for an analytical estim ation of the characteristic tim es of the

FPT pdf and cdf. In general, the m m om ent of F (t) is calculated by raising to the m power the inverse of the propagation m atrix. For the two conform ations translocation this matrix is given on the right hand side of Eq. 6.

A fter som ew hat lengthly calculations, which are given is Appendices B and C, the expression for the MFPT, >, reads:

where is the MFPT for the single con guration model, and is given by Eq. C 5, and $P_{A;0}$ ($P_{B;0}$) is the probability that the process starts in conform ation A (B). For $P_{A;0}$ and $P_{B;0}$ the equilibrium condition is assumed, $P_{A;0} =$ $!_{B} = (!_{A} + !_{B}) \text{ and } P_{B_{i}0} = 1 P_{A_{i}0}.$

Eq. 8 is valid for not too high elds, $V = V_c \& 1$, and the relations between the interconversion with k found in the previous section, $!_A = k; !_b = k$ 1. The rst term in the brackets of Eq. 8, $P_{A;0} + P_{B;0}$, represents the translocation peaks and can be compared with t_m ; and t_{m} :3. The second term in the brackets, $(!_{A} + !_{B})=2$, represents the coupling time cost, and is of the order of $o(10^{-2})$ for voltages that obey V=V_C 1:5. Keeping the rst term in Eq. 8, we have

where x N for a translocation process that starts near the cis-side of the membrane.

Eq. 9 provides a solid basis for the num erically obtained dependence of the translocation velocity on the voltage. < > consists of two terms that can be attributed to the A (rst term in the brackets) and B (second term in the brackets) pore conform ations. For 120m V we can replace the expression in brackets V by one in the relevant voltages window. Thus, we nd that $< > / (V V_c)^{-1}$, which implies that F (t) has one translocation peak for this choice of V . For higher values of V and voltages of biological interest, the two terms in the brackets are separated. This leads to a term that represent the A conform ation and scales as $(V = V_{c})^{-1}$, and a term that represents the B conform ation that scales as V_{c})]¹. [V (V

Accordingly, Eq. 9 captures the physical essence of the translocation of the ssDNA through the conform ationally changing pore, under a relatively small eld.




Figure 5 G (t) for poly-dA_{nu}, full curve, for V = 0, and the initial state x = n=2, $!_A = 10^{-2}$ Hz, ! = 1=2 and the other parameters as in Fig. 1. Also shown is the approximate cdf G_{ap}(t), dashed curve, and its modi ed version, dotted curve. Inset: F (t) for poly-dA_{nu} for the corresponding cdf shown in the main Fig.

Field-Free Translocation

eld-free experim ents by Bates et al. (2003), In recent the cdf G (t) = $\int_{0}^{R_{t}} F$ (s)ds was shown to have two regimes that were approxim ated by a fast and a slow tim escales, $_1$ and $_2$, with the ratio $_1=_2$ 1=20. M otivated by these experimental result, which implies, within our approach, that 0 ful ls 0 1, we study in this subsection

the zero eld translocation, V ! 0. We start by computing G (t) for a translocation process that starts at the middle state, x = n=2. This is the the same initial condition that was in posed in the experiments (Bates et al., 2003). As shown in Fig. 5 (full curve), G (t) displays two regimes, a fast increase at short times and a slow increase from intermediate to large times. A coordingly, we try the approximation

M atching the rst and the second moments obtained from F (t) and from the approximated F (t) we nd that the characteristics timescales of G_{ap} (t) are (see Appendix D):

which, when used in G_{ap}(t), lead to the dashed curve plotted in Fig. 5. A lso shown, dotted curve, is a modi ed version of G_{ap}(t), where 1 ! t_m is used in Eq. 10. Note that for the short times, t < 1, the later approximation ts better G (t), but from intermediate times, t > 31, G_{ap}(t) and G (t) coincide.

The two conform ations model produces a tem poral behavior that agrees with experimental observation, and provides a good explanation for it. In the limit, V ! 0, the B conformation acts as a trapping conformation; namely, the polymer is stuck in its position when subject to the environment due to the B conformation. Movement occurs only through the A conformation. As a result two regimes are obtained for G (t). The fast increase in G (t) at short times, is a consequence of exiting due to the A conformation (at either side of the membrane),

while the slow saturation at longer times is a result of the release from the trapping in the B conformation.

In the inset of Fig. 5 we show both F (t), the approximate F (t), and the modi ed version of the approximation, which is obtained when using $_1$! t_n . Because the process starts in the middle state, x = n = 2, F (t) has only one peak, which coincides with previous results (F lom enborm and K lafter , 2003a). A lthough the approximate F (t), or any other approximation of two exponentials with positive coeccients, does not exhibit a peaked shape, inform ation about the maxim alpeak value of F (t) and the interconversion rates can still be extracted from G_{ap}(t) timescales by using Eq. 11. For example, the timescales suggested by Bates et al. (2003), in ply that t_m 165 s, and $!_B$ 300H z.

CONCLUSIONS

The model introduced here describes the translocation of ssDNA through a uctuating pore structure. As a consequence the ssDNA within the transmem brane pore part is exposed to a changing environm ent, which can be re ected in the rst passage tim es pdf, F (t). By com puting F (t), com paring our results to experim ental results, and using physical argum ents, we obtained theoretically a behavior which was previously observed experim entally -F (t) having three peaks. This behavior is obtained by tuning the dimensionless parameter, which controls the e ect of the change in the pore structure on the transbcating ssDNA, and the interconversion rates between the pore conformations, $!_{\rm A}$ and $!_{\rm B}$. In particular, has to ful 110:1 0:30, and the interconversions rates have to be of the same order of magnitude, and much smaller than the typical rate of the A pore conform ation, k, $!_{B} = k$ 10^{3} . This implies that the relaxation tim escale of the ssDNA in the pore is much shorter than of the pore conform ational changes tim escale. From these relations the maxim alvalues of the interconversion rates can be deduced from the value of k, given by Eq. 3, to be: !_A $!_{\rm B} = 10^2 \, {\rm H} \, {\rm z}$.

We have been able to show, both numerically and analytically, that the times that maximize the F (t) actual translocation peaks, $t_{m,i}$; i = 2; 3, and the MFPT, are inversely proportional to the second power of the eld, depending on V. This emphasizes the crucial role of V on the translocation extracted functions, and may explain the di erent experimental results for F (t) discussed in the introduction, meaning that V is sensitive for the speci c experimental set up, and biological conditions.

The probability to exit the channel until time t, G (t), in a eld-free environment, has been shown to have two regimes that can be approximated by two timescales, 1 and 2, which are about one order of magnitude apart, and are closely related to the -, $t_{\rm m}$, and the interconversion rates: $_1$ = -(1+3=2!), or $_1$! $t_{\rm m}$, and $_2$ = $-(1=2+!)+1=!_{\rm B}$. From these relations the interconversion rates can be deduced when analyzing experimental data.
