U sing a m odi ed spin-wave approach, we show that in the presence of an inhom ogeneous magnetic eld or an in-plane inhom ogeneous electric eld a mesoscopic antiferrom agnetic Heisenberg ring with integer spin (i.e., a Haldane-gap system) exhibits a persistent circulating spin current. Due to quantum uctuations the current has a nite limit on the order of (g_B) c=L at zero temperature, provided the staggered correlation length exceeds the circum ference L of the ring, in close analogy to ballistic charge currents in mesoscopic norm al-metal rings. Here c is the spin-wave velocity, g is the gyrom agnetic ratio, and _B is the Bohr magneton. For L the current is exponentially suppressed.

I. IN TRODUCTION

In a recent paper,¹ henceforth referred to as I, we have shown that the m esoscopic persistent current in a norm alm etal ring threaded by an A haronov-B ohm ux has an analog in spin rings: speci cally, we have calculated the persistent spin current $I_{\rm s}$ in them alequilibrium that circulates a ferrom agnetic H eisenberg ring subject to a crown-shaped m agnetic eld with m agnitude β j. W ithin linear spin-wave theory we have shown that the associated m agnetization current $I_{\rm m}$ = (g $_{\rm B}$ =~)I_{\rm s} (where g is the gyrom agnetic ratio and $_{\rm B}$ is the B ohrm agneton) is of the form 2

where L is the circum ference of the ring, $_k$ is the energy dispersion, and $v_k = \sim {}^1 \ell_k = \ell k$ is the velocity of the m agnons, $j_1 j = g_B j_B j_and T$ is the temperature. In the presence of a crown-shaped inhom ogeneous magnetic eld the direction of the magnetization in the classical ground state covers a nite solid angle $_m$ on the unit sphere as we move once around the ring. Then the B loch wave vectors are quantized as $k_n = \frac{2}{L} (n + \frac{m}{2})$, where in the continuum approximation the allowed values of n are n = 0; 1; 2;:::.

The magnetization current (1) vanishes for T ! 0. Physically, this is due to the fact that no quantum uctuations are present in a ferrom agnet, so that at T = 0there are no m agnons to carry the spin current. It is thus tem pting to speculate that the analogous current for an antiferrom agnetic H eisenberg ring will be nite even at T = 0 due to quantum uctuations. In this work we shall show that this is indeed the case and present a quantitative calculation of the current in H aldane-gap antiferrom agnets (i.e., antiferrom agnetic H eisenberg rings with integer spin S) using a m odi ed spin-wave theory.^{3,4,5} O ur m ain result is that the ground state of a H aldane-gap spin ring subject to an inhom ogeneousm agnetic eld supports a nite m agnetization current, which in the lim it where the staggered correlation length is large com pared with




FIG.1: Classical ground state of an antiferrom agnetic H eisenberg ring in a crown-shaped magnetic eld; m $_{1}^{A}$ and m $_{1}^{B}$ are the directions of the spins on sublattices A and B.

L has a saw tooth shape as a function of the geometric ux ,

where c is the spin-wave velocity. Here is the solid angle on the unit sphere traced out be the localN eelvector as one moves once around the ring. Such a state can be produced by an inhom ogeneousm agnetic eld, as depicted in Fig. 1. Sim ilar to the case of a ferrom agnet discussed in I, the magnetization current is carried by magnons which are subject to m esoscopic interference due to the geom etric phase associated with the inhom ogeneous nature of the classical ground state. Due to quantum uctuations, the ring is endowed with an electric dipole moment even in the ground state. The absence of true long-range order in one-dim ensional H eisenberg antiferrom agnets leads for integer spin S to a nite spin-correlation length and a Haldane gap of the order of $\sim c =$ between the groundstate energy and the lowest triplet excitation. These features are correctly captured by a modied spin-wave theory^{3,5} which we use here to calculate the spin current in Haldane-gap systems. Note that this approach is only appropriate for integer S, where the low-energy excitations can be viewed as renormalized spin waves. In contrast, for half integer S the spectrum is gapless and spin correlations decay algebraically.⁶ The elementary excitations are then spinons, so that the modi ed spin-wave theory does not correctly reproduce the low – energy physics. In this case the e ective low –energy theory is a Tom onaga-Luttingerm odel. R ecently M eier and $Loss^7$ used such a model to discuss the spin current in S = 1=2 antiferrom agnetic spin chains for a two-term inal geom etry.

W hile Eq. (1) is the bosonic analog of the persistent charge current^{8,9} in a norm alone-dimensionalmetalring threaded by an Aharonov-Bohm ux , Eq. (2) is formally identical with the persistent charge current in a ballistic metalring at zero temperature. Recall that for spinless fermions at constant chemical potential the charge current in the ballistic regime can be written as^{10}

Here $_{k}$ is the energy dispersion and v_{k} is the corresponding velocity of an electron in the state with wave number k. Due to the A haronov-B ohm ux the wave vectors are quantized as $k_{n} = \frac{2}{L} (n = _{0})$, where $_{0} = hc=e$ is the ux quantum. For free fermions at zero temperature Eq. (3) reduces to a saw tooth function. For an even number of electrons at T = 0 one obtains

where v_F is the Ferm i velocity. W ith the replacements e ! g _B, v_F ! c, and = 0 ! =2 the zero-tem perature charge current (4) is form ally identical with the zero-tem perature magnetization current (2) in a Haldane-gap spin ring. Finite tem perature, disorder, and phase-breaking scattering all have a sim ilar e ect on the persistent charge current in one dimension.¹⁰ For a weak perturbation, they sm ooth the discontinuity around

= 0 and with increasing strength higher harm onics are exponentially suppressed such that a sinusoidal shape is approached. In the lim it of a very strong perturbation the current is exponentially suppressed with the relevant length or energy scale, i.e., the current becom es proportional to exp(T=T), exp(L=L), or exp(L=L) under the in uence of a nonzero tem perature, strong disorder or strong inelastic scattering, respectively. Here T is the tem perature scale associated with the discrete level spacing, L is the localization length, and L is the phase-coherence length. Below we show that in the case of spin currents in Haldane gap systems the correlation plays a similar role: for length L the magnetization current is exponentially suppressed and becom es sinusoidal.

The rest of the paper is organized as follows. In Sec. II we apply linear spin-wave theory to an antiferrom agnet subject to an inhom ogeneous magnetic eld. A fler calculating the spectrum of magnon excitations, we obtain the spin current as a gauge-invariant derivative of the ux-dependent part of the free energy and discuss the result for T = 0 in na ve spin-wave theory. To justify and generalize the spin-wave approach, we then apply a modi ed spin-wave theory, where the absence of long-range order in a one-dimensional antiferrom agnet is taken into account. In Sec. III an antiferrom agnet in an inhom ogeneous electric eld is considered. In Appendix A, the classical ground state is obtained explicitly for the sim – ple geometry of a crown-shaped eld, and Appendix B contains som e m athem atical details of the calculation of the m agnetization current.

II. SPIN-WAVE THEORY

A. Spectrum

W e start with a nearest-neighbor antiferrom agnetic (J > 0) H eisenberg ring in an inhom ogeneous m agnetic eld

where S_i are localized spin operators at sites l_i of a onedimensional lattice with lattice spacing a = L=N, and $S_i^2 = S(S+1)$. Periodic boundary conditions $S_{N+1} = S_1$ are used, $h_i = g_{B}B_i$, and N is assumed to be even. For a spin-wave expansion the classical ground state has to be determined by minimizing the energy in Eq. (5) with S_i replaced by Sm[°]_i, where m[°]_i is a unit vector. To consider uctuations, the spin operators are then represented by bosonic creation and annihilation operators in the standard way,

where $e_i^+ = e_i^1 + ie_i^2$, and e_i^1 and e_i^2 are two unit vectors in the plane perpendicular to m_i, such that $fe_i^1;e_i^2;m_ig$ is a right-handed local basis in spin space. There is a local gauge freedom in the choice of the transverse basis vectors e_i^1 and e_i^2 which can be arbitrarily rotated around m_i. W ith the notation of I the spin-wave H am iltonian then reads

where $!_{i!j}$ is the angle of rotation around m_i that takes m_i m_j into e_i^1 . The transformation to another local right-handed triad, associated with site i and the bond (ij) according to $fe_i^1; e_i^2 = m_i m_j; m_ig$, then reads

Equation (7) is manifestly invariant under the U (1) gauge transform ation $!_{i! j} ! !_{i! j} + ..., b_i ! e^{i \cdot i} b_i$. We will

now assume a su ciently large ring so that the direction of the magnetic eld varies only slightly on the scale of the lattice spacing a. The classical ground state then locally resembles a Neel state and the local Neel vector $n_i = (1)^{i+1} m_i$ varies smoothly as a function of position on the lattice and is oriented almost orthogonal to the local direction of the magnetic eld. We thus have $m_1 m_{+1} = 1 + 0$ (1=N) and the term s involving the com bination $b_{i}^{y}b_{i+1}$ in Eq. (7) can be neglected to leading order in 1=N. In this approximation a local spin deviation follows the direction of the classical ground state as it moves around the ring. It picks up a geometrical phase leading to interference of its wave function in close analogy to A haronov-Bohm interference in charge transport. The e ect of the inhom ogeneous eld can be incorporated via the gauge transform ation

where the upper/lower sign is valid for sublattice A/B (odd/even i). The resulting quadratic bosonic Ham iltonian is standard for an antiferrom agnetic ring with nearest-neighbor interactions

except for the twisted boundary condition (10). An additional staggered eld h_s in the direction of the classical ground-state vectors has been introduced as a technical tool for the discussion in Sec. IIC. H_{AFM} is diagonalized as usual by rst performing Fourier transform ations with di erent signs on the two sublattices:

The diagonal Ham iltonian contains constant terms due to quantum uctuations,

Thus we have shown that to leading order in 1=N therm odynam ic quantities depend on the inhom ogeneity of the eld only via the single phase . Geometrically is the anholonom y associated with the parallel transport of a vector orthogonal to the local N eel vector,¹¹ in analogy to the ferrom agnetic case. To see this more clearly, we consider for each bond (ij) two additional sets of local right-handed triads containing the N eel vector n_i instead of m_i. These triads are given by $fe_i^1 = e_i^1; e_i^2 = (1)^{i_i+1}e_i^2; n_i g$ and $fe_i^1; e_i^2 = n_i \quad n_j; n_i g$, and are related by a rotation around n_i . For the associated spherical vectors this reads

which is of the form obtained in I for the ferror agnet. is thus the anholonom y of a vector orthogonal to the local N eel vector that is transported around the ring by discrete rotations around $n_i \quad n_{i+1}$. A lternatively, a continuous parallel transport can be used around a path of geodesics connecting the unit vectors n_i on the unit sphere. is therefore equal to the solid angle subtended by this closed path of geodesics.

B. M agnetization current

In I we have shown that the U (1) gauge symmetry associated with the choice of the local transverse basis is connected with a conserved current that was identified with the longitudinal component of the spin current. For an antiferrom agnet the longitudinal spin current is conveniently de ned in the direction of the local N eel vector and can be written as a gauge-invariant derivative of the free energy

where $I_{i!}_{i+1} = JS_i$ S_{i+1} is the spin current from site i to i+ 1. Sim ilar to the ferrom agnetic case, the presence of a longitudinal spin current can be understood sem iclassically as follows. The local spin deviation from the classical ground state is essentially perpendicular to n_i and varies slightly from i to i+ 1. The spin deviations on neighboring sites are therefore in a plane that does not contain n_i, so that their cross product appearing in $I_{i!}$ is a nonvanishing component I_s in the direction of n_i . This spin current I_s corresponds to a current of m agnetic dipoles that are locally oriented in the direction of the Neel vector n_i, which varies sm oothly as we move along the ring. The spin current generates an electric dipole eld which has the same form as discussed in I. For the magnetization current we obtain

where $q_k = -\frac{1}{2} e_k = 0$ is the velocity of a magnon with wave vector k and $n_k = 1 = [exp(k = T) \ 1]$ is the Bose occupation factor. The extra factor of 2 is due to the two degenerate spin-wave modes. Equation (23) is the antiferrom agnetic spin analog of Eq. (3). It clearly shows that the magnetization current is carried by antiferrom agnetic m agnons, which at this level of approxim ation are the only quasiparticles available for transport. The current has a nite limit, even for vanishing Bose occupation factors, due to quantum uctuations. From Eq. (23) the current is clearly seen to be a periodic function of $\ ,$ so that the nite momentum sum can be further evaluated using the Poisson summation formula.¹⁰ Some details of the calculation are given in Appendix B. For a vanishing staggered eld in the zero-tem perature lim it we obtain the sim ple result announced in the Introduction,




FIG.2: Magnetization current in a ring with 100 spins for di erent values of the energy-gap param eter . The plots are produced by num erically evaluating Eq. (23). For $= 10^{-3}$ the curve is indistinguishable from the approximate expression in Eq. (28), and Eq. (29) provides a good approximation for $= 2 10^{2}$.

Here $I_m^0 = g_B c = L$ is the magnetization current carried by a single magnon with the spin-wave velocity $c = c_{k! 0^+}$ at the center of the Brillouin zone. The saw tooth shape (see the solid line in Fig. 2) of the current in Eq. (24) is rem in iscent of Eq. (4) for charge transport. Indeed, for T = 0 Eq. (23) is form ally equivalent to Eq. (3) for charge transport when the Ferm i edge is replaced by the lower edge of the m agnon band.

C. M odi ed spin-wave theory

The usual spin-wave theory employed so far is inconsistent when zero m odes appear. A lthough the spin current 4

remains nite, the sublattice magnetization diverges in the lim it ! 0. This failure is related to the absence of long-range order in one-dimensional systems. It can be resolved by a modi ed spin-wave theory which was rst used by Takahashi for a one-dimensional ferrom agnet and then extended to various spin system swithout longrange order, including antiferrom agnets.⁴ The constraint that is introduced in these theories was recently shown to follow naturally from a calculation at constant order param eter.⁵ In the present context, we introduce the additional constraint

which suppresses Neel order on average. This constraint is enforced via the staggered eld h_s in Eq. (11) which acts as a Lagrange multiplier. The expectation value in Eq. (25) can be evaluated from $@F_{sw} = @h_s$, yielding the self-consistency condition

Although the self-consistently determined h_s is itself a periodic function of the geometric ux , the leading order for large N is a constant and can be determined by replacing the sum in Eq. (26) by an integral. For T = 0 the solution of Eq. (26) yields the Haldane gap 2JS , which is inversely proportional to the staggered correlation length

The functional form of the magnetization current shows a crossover between the two qualitatively di erent regimes L and L (see Fig.2). In the former case 2 = N and at most one wave vector can be in the region < k < where the dispersion relation deviates strongly from the dispersion in the limit = 0. When the contribution from this single wave vector is taken into account separately, we obtain

In the case = 0 this reduces to Eq. (24), provided N 1. Thus, the e ect of a nite is to remove the discontinuity at = 0;2. On the other hand, in the limit L m any k values are a ected by the energy gap. An analytic result for the spin current can nevertheless be derived as described in Appendix B. We obtain the scaling form

im plying that the sinusoidalm agnetization current is exponentially suppressed in the bulk \lim it, L $\,$.

III. ELECTRIC FIELD

M oving magnetic dipoles represent an electric dipole moment¹² and are therefore a ected by electric elds. D ue to this relativistic e ect, which is essentially equivalent to spin-orbit coupling, the magnetic moments acquire an Aharonov-Casher phase.¹³ For localized spin system s described by a H eisenberg H am iltonian, the electric eld can be taken into account phenom enologically by a substitution in the interaction term,

as long as the electric eld varies only weakly on the scale of the lattice spacing. Here,

with = $\hat{}$. For ferrom agnetic coupling, inhom ogeneous electric elds can lead to persistent m agnetization currents¹⁵ and a spin analog of the H all e ect was also shown to exist in electric elds.⁷




FIG.3: A ntiferrom agnetic H eisenberg ring in the electric eld produced by a line charge.

W e now consider the antiferrom agnetic ring in an electric eld in the x-y plane, e.g. produced by a charged line in the z direction (see Fig. 3). The rotation vectors $_{i,i+1} = _{i;i+1}e^z$ are then all parallel to the z axis and the H am iltonian for vanishing m agnetic eld becom es

The classical ground state is easily shown to be a doubly degenerate N eelstate with m_i = e^{z} . The spin-wave expansion is thus straightforward. If a gauge transform ation is used to eliminate the phase factors, we again obtain the standard bosonic H am iltonian H_{AFM} of Eq. (11) with the boundary condition (10), where is replaced by the total A haronov-C asher phase

The spin current then only has a z component which can be written as a gauge-invariant derivative of the free energy,

This leads again to Eq. (23) with replaced by $_{AC}$ and all the results derived in the previous sections are also applicable in this context.

It is also interesting to note that the situation of a radial electric eld with $_{i;i+1} = \frac{2}{N}$ and an additional hom ogeneous magnetic eld tilted with respect to the z axis can be form ally mapped onto a crown-shaped magnetic eld alone via the transform ation

It would therefore be interesting to further investigate the combined e ect of arbitrary inhom ogeneousm agnetic and electric elds on the produced spin currents to nd situations that could be realized more easily in the laboratory for a possible experim ental detection of the e ect.

IV. SUMMARY AND OUTLOOK

In the last two decades, a lot of theoretical work focused on persistent equilibrium currents in m esoscopic norm al-m etal rings.^{8,9,16} In the 1990s, the experim ental di culties for the detection of the currents were overcom e and an oscillating magnetization as a function of the magnetic ux was observed under various conditions.^{17,18,19,20,21,22} In the ballistic regime, the main features of the experiment¹⁹ can be understood within a simple model of free fermions,¹⁰ but in the di usive regime a generally accepted explanation of the experiments^{17,18} is still lacking.

In this work, we have shown that persistent magnetization currents are present in antiferrom agnetic H eisenberg rings in inhom ogeneous magnetic elds as well as in a radial electric eld. Quantum uctuations lead to groundstate currents, but uctuations in low dimensions also produce exponential dam ping when the circum ference L of the ring becom es larger than the staggered correlation length. We have obtained explicit expressions for the current at T = 0 in the two lim its L and L within a modied spin-wave approach valid for integer spins, i.e., for Haldane-gap system s. The determ ination of the current for half-integer spin rings remains an interesting open problem . A lso, we have only considered clean systems in this work, i.e., we have focused on the ballistic regime. Since for persistent charge current disorder is known to be important, it would also be very interesting to consider persistent m agnetization currents in the di usive regime of disordered magnets.

In the past few years a new eld of research (\spintronics") has emerged, where the spin degree of freedom is used as a medium to transport information.23 For technicalapplications (such as quantum computation) it is im portant to control the quantum coherence in m esoscopic spin systems. The persistent spin current discussed in this work can be viewed as a quantitative measure for the degree of quantum coherence in the ground state of the system . Sim ilar to the ferrom agnetic case discussed in I, the magnetization current circulating a Heisenberg antiferrom agnet generates an electric dipole eld. Due to screening e ects, the corresponding voltage drop m ay be rather di cult to detect experim entally. How ever, in view of the rapid developm ent of the eld of spintronics, it does not seem unreasonable to expect that before the end of this decade new experimental techniques will be available to detect persistent spin currents in Heisenberg rings.

For very strong m agnetic elds the classical unit vectors m i will be aligned parallel to the eld and the ground state will have the full rotational sym m etry of the applied eld. Below a critical spin-ip eld h_c (#) it will be energetically favorable to form two sublattices with di erent angles $\#_m^{A=B}$ to the z-axis (see Fig. 4). Introducing the relative and average angles



Thus for large rings the magnetic eld h JS=N necessary to produce an inhom ogeneous classical ground state is well below the spin-ip eld h_c JS. For =2 and the classical JS=N JS we have ground state locally resembles a Neel state as assumed in Sec. II.
