Two-component Bose gas in an optical lattice at single-particle lling

The Bose-Hubbard model of a two-fold degenerate Bose gas is studied in an optical lattice with one particle per site and virtual tunneling to empty and doubly-occupied sites. An elective H am iltonian for this system is derived within a continued-fraction approach. The ground state of the elective model is studied in mean-eld approximation for a modulated optical lattice. A dimerized mean-eld state gives a M ott insulator whereas the lattice without modulations develops long-range correlated phase uctuations due to a Goldstone mode. This result is discussed in comparison with the super uid and the M ott-insulating state of a single-component hard-core Bose.

I. IN TRODUCTION

An ultracold Bose gas is brought into an optical lattice, created by a stationary Laser eld¹. If the corresponding periodic potential is su ciently strong, such that tunneling of atom s between the potential wells is strongly suppressed, the phase coherence of the Bose gas is destroyed due to the repulsive interaction between the bosons. In this case the Bose gas becomes a M ott insulator. This ground state is characterized by a xed num ber of bosons in each lattice well and strong incoherent phase uctuations of the quantum state, in contrast to the phase coherence of the Bose E instein condensate with a strongly uctuating local particle num ber. The M ott insulator and the transition to the super uid state were discussed theoretically some time ago^{2,3,4} and observed experimentally recently¹.

B esides the phase of the bosons and the local particle num ber there can be other degrees of freedom in an ultracold gas of bosonic atom swhich may also establish some long-range ordering. A possible candidate for such a consideration is a Bose gas in an optical or a magnetic trap⁵, where the uctuations between nearly degenerate hyper ne states represent an additional degree of freedom. This can play a role in establishing new types of ordering, sim ilar to the spin degree of freedom in ferm ionic systems. Here the case of a strongly interacting Bose gas with one particle per site will be considered. U sing a Bose-H ubbard m odel, the interaction and the chem ical potential of a grand canonical ensem ble are a justed such that there is one particle per optical lattice site. A coording to the statem ents given above, the xed num ber of particles per site w ould represent a M ott insulator. On the other hand, the local particle num ber n_r is a sum of the particle num bers of both components (represented by a "spin" " or #)

The individual particle numbers of the two components are uctuating quantities and can lead to a new state when long-range correlations develop. A similar situation can be found in a single-component hard-core Bose gas in an optical lattice. Then each lattice site is either empty with the quantum state ji or singly occupied with jli. Form ally these two states correspond with the states j"i and j#i of the two-component gas. It is known from analytic^{2,3} and num erical calculations⁶ that the hard-core Bose gas develops a super uid phase for abitrarily sm all tunneling rates if the states jli and jli are degenerate, i.e. when $h_r i = 1=2$. This behavior will be discussed in Sect. 3.1. U sing the form alcorrespondence with the two-component Bose gas the development of a long-range correlated state would also take place for any tunneling rate if the states j"i and j#i are degenerate. A consequence would be that these two states could easily separate in space, leading to an entangled state in the Bose gas.

O rdering phenom ena can be studied perturbatively, starting from isolated potential wells of the optical lattice and system atically turning on the tunneling between these potential wells. Because of the degeneracy with respect to the spin degrees of freedom in the isolated wells this requires a degenerate perturbation theory. Instead of using a perturbation theory for the tunneling H am iltonian a continued-fraction approach will be applied in the following.

The centralaim of this paper is to derive an elective H am iltonian for the two-component B ose gas with $m_r i = 1$ and to discuss the properties of this system. In this case a particle is a superposition of the states j"i and j#i. W ithout tunneling between lattice sites it represents a "param agnetic" state, i.e. a state without ordering. Tunneling, on the other hand, preserves the "spin": starting with a boson of a given spin this boson will spread to neighboring potential wells. This process requires virtual states which are empty or occupied by more than one particle. Here only occupation with two particles will be allowed to keep the calculational e ort low. However, the continued-fraction approach proposed in this paper can be extended to higher orders of occupation.

A fter introducing the two-com ponent B ose H ubbard m odel in Sect. 2 the single-com ponent hard-core B ose gas is considered for comparison in Sect. 3. and treated in m ean-eld approximation in Sect. 3.1. The ground states of a two-component B ose H ubbard m odel with h_{ri} 1 and a single-component hard-core B ose gas are evaluated for a two-site system in Sect. 3.2. Then the elective H am iltonian for a projected system of interacting particles is derived

by a truncated continued fraction in Sect. 4 and applied to the two-component Bose gas with $m_r i = 1$ in Sect. 5. Finally, the two-site system (Sect. 5.1) and a mean-eld approximation (Sect. 5.2) are discussed for the elective model.

II. THE MODEL: INTERACTING BOSE GAS

In order to describe a multi-component interacting B ose gas the interaction of bosons can either be included as a hard-core interaction or in terms of the B ose-H ubbard model. C nucial is only that a repulsive interaction stabilizes an incompletely led lattice with vanishing compressibility. From this point of view the actual form of H $_0$ is not important except for the fact that it depends only on the local particle number at site r

with boson creation (annihilation) operators a^y (a). For a more specic discussion, a Bose-Hubbard model with

shall be considered, where is the chemical potential and U > 0 the interaction constant. Eigenvalues of the local particle number are n = 0;1; ... w ith corresponding energies per lattice site

For $0 < \langle U \rangle$, the case considered throughout this paper, the lowest energy is E (1) = for n = 1, and next higher energies are E (0) = 0 and E (2) = 2 (U) and even higher energies for n > 2.

The dynam ics of the bosons is described by the tunneling H am iltonian

where $< r; r^0 >$ are nearest-neighbor sites on the optical lattice. The parameter 0 $_{r,r^0}$ 1 describes a modulation of the optical lattice. The interaction is crucial for nding new physical states, since the noninteracting B ose gas (i.e. for U = 0) the H am iltonian H₁ gives only two independent B ose E instein condensates.

A grand-canonical ensemble of bosons at the inverse tem perature , de ned by the partition function

can be used to evaluate the average density of particles as

with the number of lattice site N. W ithout tunneling (i.e. for t = 0) the average density of particles n gives (n=0) = 0 (i.e. incompressible states) for all non-integer values of =U.

III. SINGLE-COMPONENT HARD-CORE BOSE GAS:SUPERFLUID AND MOTT-INSULATING STATES

B effore discussing the two-component B ose gas the single-component hard-core B ose gas shall be considered because its properties are known from a number of other approaches. The hard-core interaction can be described by a bosonic creation (annihilation) operator A^{y} (A) with the additional condition $A^{y^{2}} = 0$. The Ham iltonian of the hard-core B ose gas then reads

and acts on the Hilbert space with jDi and jLi as basis states at each lattice site. There is a close form al connection between hard-core Bose and spin-1/2 operators, since one can write

The Hamiltonian can be expressed in term softhese spin operators as an XY model with a magnetic eld in z direction:

For su ciently large values of j j the ground state is ferrom agnetic: if > 0 the m agnetization is hS^zi> 0 and vice versa. Therefore, for > 0 (< 0) these ground states correspond in term s of the hard-core bosons with a completely led (empty) lattice, where the led lattice represents a M ott-insulating state^{2,3,4}. = 0 is a m arginal situation, where the bosons develop a super uid state for any positive value of the tunneling rate t. M ore general, the super uid state persists if the tunneling dom inates.

The advantage of the spin representation is that it provides a simple qualitative picture for the existence of a M ott-insulating state and a transition to a super uid state. A more quantitive description is obtain from a mean-eld approximation which is discussed in the next section.

A. M ean-eld approxim ation of the hard-core Bose gas

A possible complex mean-eld state for the hard-core Bose gas is

from which matrix elements can be calculated. For instance, the tunneling term in the Hamiltonian H $_{\rm hcb}$ gives

where the phases appear only in the phase di erence r = r r. Thus this term of the H am iltonian has a global U (1) symmetry because it is invariant under a shift r r r r r and r r r r r. Thus this term of the H am iltonian H action is independent of the phases:

is an order parameter for a super uid state which vanishes in the cases $\sin^2 = 0;1$. It should be noticed that in this regime h_{MF} $H_{hcb}j_{MF}$ is independent of _r. This rejects the absence of a super uid. In the case $\sin^2 = 0$ it is an empty state and for $\sin^2 = 1$ a M ott insulator with one particle per site. This result is in agreement with M onte C arbo simulations⁶.

B. Hard-core vs. Bose-Hubbard model: a two-site system

To study the tunneling between neighboring potential wells of the optical lattice a two site model with $t_r = t_{\#} + t_r$ is considered. This was already discussed in great detail for the model under consideration, using the leading order of an expansion in $t^2=U^{7,8,9}$. Here the study shall be performed without assuming $t^2=U$ 1. As a rst example the single-component hard-core B ose gas is considered in terms of the H am illonian in Eq. (4). The ground states are

This result corresponds with the three di erent mean-eld ground states in (7). Thus already the two-site system indicates the three phases of the full d-dimensional lattice: the empty lattice, the condensate and the n = 1 M ott insulator. An analogous calculation for the two-component Bose-Hubbard model with empty and singly-occupied sites gives the ground states

For t< < t there are two (degenerate) ferrom agnetic states, where the degeneracy can be lifted by an in nitesimal magnetic ekd. It is expected that these are the states which form a condensate. The four-fold degeneracy for > t may be lifted when a virtual tunneling through empty and doubly-occupied sites is included. This degeneracy also raises the question whether or not an analogue of the super uid ground state is allowed due to virtual tunneling in this regime. A reason for having long-range correlations is that one of the two components, e.g. j #i, can be form ally considered as an empty site, the other component as a hard-core boson and since the hard-core B ose gas has a super uid state for su ciently large tunneling rate. To study this regime, a projection of the trace in the partition function to singly-occupied states is considered subsequently. This projection allows virtual tunneling through empty and doubly-occupied sites.

IV. A CONTINUED-FRACTION APPROACH TO THE PROJECTED PARTITION FUNCTION

The many-body system is defined by the Ham iltonian H and the transferm atrix e^{-H} . Physical quantities at inverse temperature are derived from the partition function Z defined in Eq. (3). A continued-fraction approach shall be developed in this section to derive an elective Ham iltonian from H that describes the physics of a projected transferm atrix P₀e^{-H} P₀. A line H is bounded from below it may have negative eigenvalues. A positive operator can be obtained by adding a constant diagonal term E to shift the ground state energy E₀ to positive values E (1) = E₀ + E. Then the transferm atrix can be represented by the integral

Them odynam ic properties at low tem peratures are dominated by the ground states and low-energy excitations. The trace of the grand-canonical partition function Z includes states with all possible number of bosons. For the H am iltonian H the highest statistical weight comes from the ground state. If $H = H_0 + H_1$ with a perturbation H_1 , the H ilbert space is projected on the degenerate ground states of the H am iltonian H_0 by P_0 . In the example of Sect. 2 the H am iltonian preserves the number of particles. Therefore, in this case it is expected that the system with xed particle lling gives the dominant contribution to the trace, especially at low tem peratures. This situation can be described by the P_0 -projected partition function with the corresponding trace T r_0

with $P_1 = 1$ P_0 . (:::)_{0,1}¹ is the inverse with respect to the $P_{0,1}$ -projected space. This identity can be directly shown by a multiplication of the matrix and its inverse. It can be generalized to a recurrence relation (s. Eq. (23) of Appendix

A) if the H am iltonian H satis as the special conditions (22). For the two-component B ose gas this is indeed the case, since the H am iltonian $H = H_0 + H_1$ of Sect. 2 is of the special form

where P_0 is the projection to the degenerate ground state of H_0 with 0 < < U, i.e. one particle per site. Thus the H am iltonian H_1 is responsible for an interaction between the P_0 - and the P_1 -projected H ilbert spaces. H_0 , on the other hand, acts only inside the P_0 -projected space. Starting from singly-occupied states, the tunneling H am iltonian H_1 can only create a pair of an empty and a doubly-occupied site (PEDS). If P_2 is the projection from P_1 to one with only a single PEDS, the second term in the inverse matrix of Eq. (11) reads

In general, the operator $P_{2k+1}H_1P_{2k}$ creates a new PEDS in the H ilbert space with k PEDSs. Thus the continued-fraction representation of Appendix A, applied to the two-component Bose gas at single-particle lling, is based on the creation of PEDSs.

In order to truncate the continued fraction the creation of new PEDS and multiply-occupied sites is excluded. This is related to the approximation

Since $P_0H_1^2P_0$ is a non-negative operator, this result in plies that the ground state of $P_0H_1^2P_0$ is the ground state of H_{eff} .

If $P_0H_1^2P_0$ is small in comparison with (E)², a perturbation theory with respect to the $P_0H_1^2P_0$ can be applied to H_{eff} . This leads to an expansion with respect to $t^2=U$. In leading order the approximation is

in agreem ent with the results of $Refs.^{7,8,9}$.

This method of deriving an elective H am iltonian by projecting the partition function is quite general as long as the H am iltonian H has the structure shown in Eq. (12). The speci c case of a two-component B ose gas will be discussed subsequently.

Num erous possibilities were discussed in the literature for the creation of a two-component system in atom ic gases^{10,11,12,13}. For instance, if ⁸⁷Rb is coupled to a radiation eld there are pairs of nearly degenerate hyper ne $F;m_F$ istates, namely j"i = 1; 1i and j#i = 2;1^{10,14} or j"i = 1; 1i and j#i = 2; 2¹². j#i and j"i are form alnotations to specify the two (alm ost) degenerate states. The interaction of the atom s does not depend on the states but only on the local density of the bosons. Therefore, the interaction in H₀ of Eq. (1) is a good description.

In a dilute regime (i.e., for a lling less than one particle per site) the interaction is weak. This opens the opportunity to apply a classical approach for the two-component condensate order parameter, leading to a lattice version of the G ross-P itaevskii equation. The optical lattice means that the kinetic term has a special band dispersion (k) in Fourier space, depending on the lattice, instead of the k^2 dispersion in the case without an optical lattice. It is believed that this model has a ferrom agnetic ground state with respect to the two-component bosons¹⁵, a result that is also supported by the result of the two-site system in Eq. (9). On the other hand, it is well known from the theory of the ferm ionic Hubbard model that the type of spin order depends crucially on the lling of the lattice 16,17 , and can change, for instance, from ferrom agnetic to antiferrom agnetic order by changing the lling. In particular, the ferm ionic Hubbard model has an antiferrom agnetic ground state at half-lling. To study this e ect in the two-component Bose gas in an optical lattice, the strongly interacting case with single-particle lling of the lattice shall be considered here. Then the two-component degeneracy has to be taken fully into account and the projection approach of the previous Sect. for the tunneling term H $_1$ should be applied. In this case the H am iltonian $P_0H_1^2P_0$ reads

are creation and annihilation operators of hard-core bosons, when j#i is form ally identi ed with a vacuum state ji and j"iw ith a one-particle state jli. As shown in Appendix C, the operator $P_0H_1^2P_0$ reads in term s of the hard-core Bose operators as

This Ham iltonian describes a hard-core Bose gas with a repulsive nearest-neighbor interaction. The competition between tunneling (favors particles) and nearest-neighbor repulsion (favors a ground state with checkerboard order) leads to a complex situation. Sim ilar to the single-component hard-core Bose gas, this can also be discussed in term s of spin-1/2 states. The representation of Ham iltonian (16) as a spin Ham iltonian via Eq. (5) gives an anisotropic Heisenberg Hamiltonian.

A. Projected two-site model

The situation of the projected partition function of the two-site model can be discussed and compared with the previous results for the hard-core Bose gas and the two-com ponent Bose-Hubbard gas. Using the hard-core Bose Ham iltonian of the projected model in Eq. (16) with $t_r = t_{\#}$ t and $r_{rr} = 1$, the corresponding 4 4 m atrix for the four di erents states with # and " at the two sites has the eigenvalues f $2t^2$;0;0;0g. The unique ground state of

The Po-projection has apparently selected a non-degenerate ground state from the four degenerate ground states of the Bose-Hubbard model with one particle per site in Eq. (9). This is a consequence of the virtual tunneling to empty and doubly-occupied states in the model with the projected partition function, which was not included in the derivation of the state j $_0$ i of Eq. (9). This state is not an eigenstate to S_r^z but has a vanishing expectation for S_r^z . This releases the fact that the ground state has no tendency to develop a ferrom agnetic order.

The projected partition function (14) reads for this two-site model

Thus the interaction reduces the tunneling rate of the two-site model by a factor $(1 + U^2 = 2t^2)^{1=2}$.

U sing the hard-core Bose representation of the Ham iltonian in Eq. (16) its mean-eld approximation is studied with the complex mean-eld state (6). The repulsive nearest-neighbor interaction is

This H am iltonian agrees form ally with the mean-eld H am iltonian of hard-core bosons in Sect. 3.1 at the point of degeneracy = 0. How ever, its interpretation in terms of the physical bosons, given by the Bose operators a^{y} and a, is di erent. This is clearly indicated by the fact that the order parameter of a super uid state vanishes:

Thus the long-range correlated phase uctuations are not related to a super uid state but to a spontaneously broken symmetry, associated with the order parameter

These phase uctuations prevent the system to become a genuine M ott insulator, since the latter is characterized by a gap and short-range correlated uctuations (cf. with the M ott-insulating state of the single-component hard-core gas in Sect. 3.1). However, a M ott insulator can be obtained in the lim it $t_r t_{\#} = 0$. This is a lim it sim ilar to the Falicov-K im ball lim it of the ferm ionic Hubbard m odel¹⁷.

A nother mean-eld approximation can be constructed for a generalization of the two-site model to a modulated lattice model, using dimers with tunneling rates $r_{;r^0} = 0$ as building blocks of the lattice. These dimers are weakly coupled with tunneling rate $r_{;r^0} = 1$ 0. A corresponding complex mean-eld state is

where D is a set of dimers $f < r; r^0 > g$ with $r; r^0 = 0$. This state is a lattice generalization of the two-site state of Eq.(17). The Ham iltonian of the two-component Bose gas at single-lling (16) reads in this mean-eld approximation

For $t_r t_{\#} = 0$ this result agrees with the H am iltonian of solution (18) but has a low erenergy for any $t_r t_{\#} > 0$. Moreover, the state $j_D i$ has always a low er energy than the hom ogeneous mean-eld state $j_M F i_h$. This can be sum marized by comparing the ground-state energies: The di erence between the ground-state energy of the hom ogeneous (E_h) state $j_M F i_h$ and the inhom ogeneous (E_i) state $j_M F i_h$ is

It should be noticed that the hom ogeneous state $j_{M} \in i_h$ and the dimerized state j_D i have the same ground-state energy in the case of a single-component hard-core Bose gas, provided that the dimers ll half of the lattice. This means that the dimerce of the ground-state energies in the H am illonian of Eq. (16) is due to the repulsive interaction.

The H am iltonian of Eq. (21) creates short-range correlated uctuations, since the set D contains only isolated dim ers. Therefore, it represents a M ott insulator. If the m odulation of the lattice is weak (i.e. $_0$ __1), a sum m ation of the state in Eq. (20) over di erent dim er con gurations is required. This m ay lead again to long-range correlated phase uctuations, since the global U (1) sym m etry of the phase uctuations can be spontaneously broken. Thus a phase transition from a M ott insulator at strong m odulation to a state with long-range correlated phase uctuations at weak m odulation is expected.

VI. SUMMARY

A two-component Bose gas with creation operators a_{π}^{y} , $a_{\#}^{y}$ in an optical lattice with lattice modulations and one particle per site is studied. By allowing only virtual tunneling to empty and doubly-occupied sites, an elective H am iltonian is derived for hard-core bosons, de ned by the creation operator

where P_0 is the projector on one-particle states. The elective H am iltonian decribes tunneling and a repulsive nearestneighbor interaction between hard-core bosons. It is studied in terms of two types of mean-eld states: a product of single-particle states and a dimerized state. The ground-state energies of a hom ogeneous single-particle product state (E_h), of a inhom ogeneous single-particle product state (E_i), and of a dimerized state (E_D) are related as

where the $\mbox{ rst equality sign holds for }t_{*}t_{\#}=0$ and the second for $t_{*}=t_{\#}$.

The repulsive nearest-neighbor interaction prefers the dimerized state, indicating a M ott insulator at least in the presence of a lattice m odulation. This state is characterized by short-range correlated phase uctuations. For sm all or even vanishing m odulation, however, a superposition of di erent dimerized states m ay lead to a spontaneously broken U (1) symmetry of the phase uctuations. This would be accompanied by a G oldstone m ode with long-range correlated phase uctuations, indicating the destruction of the M ott insulator and the creation of an ordered state in terms of the two components of the B ose gas.

A similar model with N components and hard-core interaction was studied in the N ! 1 limit¹⁸. It has a M ott-insulating phase with n = 1 and indicates a symmetry-breaking phase for 0 < n < 1.
