Sierpinski signal generates 1=f spectra

We investigate the row sum of the binary pattern generated by the Sierpinski automaton: Interpreted as a time series we calculate the power spectrum of this Sierpinski signal analytically and obtain a unique rugged ne structure with underlying power law decay with an exponent of approximately 1.15. Despite the simplicity of the model, it can serve as a model for 1=f spectra in a certain class of experimental and natural systems like catalytic reactions and mollusc patterns.

The phenomenon of 1=f noise is found in a widespread variety of systems [1, 2, 3]. Usually a noise signal is said to be 1=f (or 1=f) if its spectrum follows over som e decades a power law S (!) ! with an exponent near to one. Despite 1=f noise is being known for a long time, up to now there is no general explanation for universal mechanisms (if they exist). However, on a very general level it is believed that complex systems [4] are able to generate 1=f noise. W hile real complex system s are usually not exactly solvable, extremely sim pli ed models are under investigation. One prominent example is the sandpile-sketching Bak-Tang-Wiesenfeld m odel [5], a two-dim ensional cellular autom aton, which itself does however not reproduce 1=f su ciently.

In this work we study an even more simplied model introduced in 1984 by Wolfram [6], which is known to be able to exhibit complex behavior: the Sierpinski autom aton. Looking not at the generated fractal Sierpinski gasket itself, but on the row sum, corresponding to the total (in-)activity of the whole system, we have a signal as shown in g.1 with increasing mean and increasing spatial size of the corresponding system; thus every physical realization of the system will be nite size-limited.

D espite on a rst glance being a theoretical toy model only, Sierpinski patterns have been found in nature. Detailed models have explained mollusc patterns by reaction-di usion models and cellular automata [7, 8]; Sierpinski patterns also occur in kinkbreeding dynamics [9] and have been observed in catalysis [10]. This phenomenon occurs generically for suitable parameter choices in four standard types of nonlinear spatiotem poral dynamics including the Bonhoe ervan der Pol and the complex G inzburg-Landau equation [11].

Consequently, catalytic processes can exhibit similar time-signals as the Sierpinski sum signal. A comparison of the reaction rate of a catalytic process with the Sierpinski sum signal X (t) = x_i (t) has been given in [12,13]. A single state x_i (t) at a time to can be interpreted to indicate the activity of a local catalysis process, i.e. reaction (activity) when x_i (t) = 0 and no reaction (inactivity) when x_i (t) = 1. The authors [12] observe a qualitative similarity between the experimental and theoretical time series. Due to dominating nite size elects a 1=f spectra (or long-time correlations) could not be

identi ed in the spectrum of the experim ental data [14]. Asm odels of chemical reactions, cellular automata have been studied widely [15], explaining spiral waves and patterm formation in chemical reactions. CO-oxidation on Pt(110) and its control by global delayed feedback has been studied and compared to models [16], including the occurrence of patterns similar to Sierpinski structures in the intermittent turbulent phase. Recently, 1=f spectra have been measured directly in a chemical reaction [17] by a SQUID setup that allows for much higher resolution in time, space and signal-to-noise ratio than the direct gravim etric m easurem ent of the reaction rate in [12]. The power law extends over more than two decades, indicating the spatiotem poral dynam ics of the catalytic reaction exhibits avalanches on all sizes and self-organized critical behavior [17]. Interestingly, the Sierpinski gasket wasmore recently found in a video feedback system [18]. Apart from observation of the Sierpinski pattern itself, its geom etry has been used widely, e.g., for sandpile dynam ics [19] and measurements of magnetoresistance on fractal wire networks [20].

De nition of the model: The dynamics of the so-called Sierpinski autom aton is related to the generation law of the Pascaltriangle. This pattern can be generated by the following simple one-dimensional cellular automaton: We consider a linear array of sites (or spins) \mathbf{x}_i (t) which can take the values 0 or 1 at discrete time steps t. We restrict ourselves to the special initial condition, that for t=0 only one spin is dierent from all others:

The dynam ics is de ned by the following next-neighbor interaction:

i 2 [1;1], x_i (t) 2 f0;1g at discrete time t. In the context of catalytic processes [10, 12, 13] a simplied chemical interpretation of this rule reads: A catalytic process is stopped when too less (i.e. no) or too many (i.e. 2) neighbor sites are active. A catalytic process is initiated (or continued) when only one neighbor site is active. This can origin from a minimal catalysis temperature combined with a local self-limiting reaction rate.

The spatiotem poralevolution is obtained from the rows of the Pascaltriangle by applying modulo 2 elementwise,

which is also known as the Sierpinski gasket. The Sierpinski gasket is a well-known self-sim ilar structure (with point dimension $\ln 3 = \ln 2$ in x for t! 1) that is obtained by twofold replication of the rst four rows to the subsequent four rows, and iteration of this process with the whole triangle.

Instead of considering the fractal pattern itself, we look at a scalar observable that can be compared to experimental time series. Before considering the spectrum, we brie y sketch a direct solution [21] and illustrate the analogy to a form allanguage approach. The row sum (or total (in-)activity) over space at time t, de ned by

is referred to as Sierpinski signal. The Sierpinski autom aton rule then generates a time series X (t) (g.1) starting from t=0 with

Being interested in an analytic expression for (4), we




FIG. 1: The self-sim ilar Sierpinski signal X (t) for T = 128.

rst note that X (t) can be generated up to $t=2^{N}-1$ from the start sequence $u_0=(1)$ by N iterations of the sequence replication rule

Strikingly, this appears to be the number of ones in

i.e. the binary decom position of the time variable t starting with t=0. Therefore the observable is given by

which is no longer recursively de ned. This analytic solution has already been known in 1852 by Kummer [21] in a number-theoretic context.

A convenient closed expression can be obtained by expressing time by a number of spins

By these expressions for $t(f_{ig})$ and $X(f_{ig})$, we have a param etric expression param eterized by a set of N spins for all X(t) with times up to $t=2^N$ 1.

Spectrum of the Sierpinski signal: The periodogram X (!) of the time signal now is calculated analytically. The binary time decomposition allows a Fourier transformation of X (t) fairly direct from the denition,

where all sums over $_j$ are taken over the two possible values $_j=0$ and $_j=1$. We now calculate the periodogram's power spectrum, i.e. χ (!) γ . The absolute value of X (!) simplies to a trigonom etric product which the logarithm converts into a sum,

showing a rugged ne structure as shown in g.2. A rough estimate of the sum in eq. (12) is obtained approximating the sum by an integral $(y = ! 2^j)$,

The integral over the integral cosine is nearly independent of the upper boundary for high values of the boundary. Thus, we can substitute the upper boundary! 2^{N-1} by some N-dependent constant, say $q_N = 1$. Finally, substituting the cosine by one yields in mediately a rough approximation of eq. (12):

Due to the increase of the mean of X (t), spectral estim ation from the periodogram X (!) (in plying a periodical extension in time domain) has to be discussed carefully. As $_{t=0}^{P} {}_{t=0}^{N} X$ (t) = 3^{N} , the average increase is iX (t)i_L = hX (t)i_{f0:::2}N $_{1g} = t$ with = log(3=2) = log(2) 0:585. Further, the signal exhibits an increasing variance hX (t)²i_{f0:::2}N $_{1g} = t$ with = log(5=2) = log(2) 1:32. Consequently, we investigate two variants of X (t): A suitable per de nitionem mean-free sum signal de ned by Y (t) = X (t) (1+)t, and a mean-free signal with non-increasing variance

The spectrum of Y (!) can be directly obtained from eq. (11) and the evaluation of the Fourier transform of t:

The power spectrum of the periodically extended function t decays (for small values of the frequency) like a power law with an exponent of approxim ately -2. Thus, the decay is much stronger than X (!) and the power spectra of Y (t) and X (t) deviate only slightly. Hence, it follows that Y (!) f **⅓** (!)³ ! . Sim ilarly, $X (!)^{\frac{1}{2}}$ also estimates $Z (!)^{\frac{1}{2}}$. We now compare these results with numerically applied discrete Fourier transform ation. The power spectrum is tted (least-squares) in q.3 by a power law with exponent about 1.11, being in good agreem ent with the analytical result eq. (15). If one m easures a power spectrum experim entally, this may generically be done by observation of resonances, where the system is coupled with a tuneable oscillator of given frequency and nite bandwidth. Therefore it is quite natural to consider an averaged spectrum. The (incom m ensurable) averaging procedure applied in g.4 sm oothes the peaks at $! = 2^k$. The peak amplitudes decay as the average spectrum itself. For commensurable averaging (inset of g.4) the peaks at ! = 2 disappear completely.

Note that the spectra X (!) f, and Y (!) f, from FFT for $T=2^{2^2}$ (not shown) also display 1=f behaviour, with exponents X=1:12, and Y=1:11, respectively. Moreover, we have used the method of a sliding window that normalize the uctuations [28] of the detrended signal Y (t), i.e. Z (t) = Y (t+ 1)=hY 2 $^{1=2}_{ft}$ $^{1=1}_{tt+1}$ $^{1}_{tt+1}$




FIG. 2: Power spectrum of X (t) for T = 1024 time steps up to the Nyquist frequency of T=2 (from FFT). The lower Envelope is constituted by ! (k) = $b^{\frac{2^k+1}{3}}c;k$ 2 f2;3;:::g:




FIG .3: Power spectrum of the time signal Z (t) up to T=8 for T = 2^{20} time steps (from FFT) and least-square-t! $^{1:11}$.




FIG. 4: A veraged power spectrum of Z (t) up to T=8 for T= 2^{20} using (incommensurable) 1.1^k -bins, i.e. the k-th interval is de ned by [dl.1 ke;dl.1 k+1 e] where the brackets de denote rounded integer values. The inset shows the same spectrum, averaged using 2^k -bins, i.e. the k-th interval is de ned by 2^k ; 2^{k+1} 1]. Both correspond to a constant !=! ratio.

For dierent values of the window width 21, the power spectra exhibit power law behaviour with exponents of about 1:1. Thus 1=f spectra appear to be a robust property of Sierpinski signals.

Am plitude distribution: M any system s exhibiting 1=f noise possess a G aussian am plitude distribution [22]. In this paragraph we calculate the am plitude distribution H $_{\rm N}$ (2^k) of X (t) analytically where H $_{\rm N}$ (2^k) denotes the frequency occurrence of X = 2^k; k = 0;1;::: for a signal length of T = 2^N . The number of 2^k s in the signal up to t = 2^N 1 is the number of 2^k s plus the number of 2^k 1s in the signal sequence up to t = 2^N 1, i.e. H $_{\rm N}$ (2^k) = H $_{\rm N}$ 1(2^k) + H $_{\rm N}$ 1(2^k 1). For the boundary condition H $_{\rm N}$ (1) = H 1(2) = 1 we obtain a sum of binomial coe cients H $_{\rm N}$ (2^k) = $\frac{1}{j=1}$ we obtain a sum of binomial coe cients H $_{\rm N}$ (2^k) = $\frac{1}{j=1}$ we sthe G aussian distribution:

Hence, the amplitude distribution of the occurrence of powers of 2 is Gaussian for $\,$ xed N . The (averaged) amplitude distributions for Y (t) and Z (t) di er from H $_{\rm N}$ (2 $^{\rm k}$) but possesses a similar shape as H $_{\rm N}$ (2 $^{\rm k}$). Note that the variance distributions for X (t), Y (t), and Z (t), are not Gaussian but well de ned by eq. (18).

As a nalpoint, num erical simulations show that the averaged signals are robust against noise, i.e. in itial conditions with more than a single 1.

In analogous situations in less simply de ned systems, power laws have also been observed in spatial spectra of the scum on uid surfaces and in the random baker map [23], and in the temporal spectra in dissipative dynamics governed by the Lorenz equations [24] being related to the Thue-Morse sequence [24, 25, 26, 27]. In fact the Thue-Morse dynamics 1! (1; 1); 1! (1;1) itself maps on the string replication rule u_n ! (u_n ; (1) u_n) for generation of the spatial sequence. Being not equivalent, but of striking similarity to eq. (5) for generation of the temporal Sierpinski signal series, the Sierpinski dynamics itself does not follow a replication rule. While the analytic solution of the Thue-Morse sequence is (1) u_n u_n

To conclude, the one-dimensional Sierpinski automaton generates l=f spectra in the number of active states, and can therefore be considered as one of the simplest models generating l=f spectra. While the Sierpinski automaton is rather a caricature, the approach of studying the sum signal, or total (in-)activity, and its spectrum, can be transferred to more realistic models and compared directly with experiments. Although exact Sierpinski patterns with long-range correlations remain to be experimentally challenging, we conjecture that l=f spectra in a suitable sum signal can be identified in every experimental setup exhibiting Sierpinski patterns.
