# A nisotropy and percolation threshold in a m ultifractal support

#### Abstract

Recently a multifractal ob ject, $Q_{m} \mathrm{f}$, was proposed to study percolation properties in a multifractal support. The area and the num ber of neighbors of the $b l o c k s$ of $Q_{m} f$ show a non-trivial behavior. The value of the probability of occupation at the percolation threshold, $\mathrm{p}_{\mathrm{c}}$, is a function of , a param eter of $Q_{m f}$ which is related to its anisotropy. We investigate the relation betw een $p_{c}$ and the average num ber of neighbors of the blocks as well as the anisotropy of $Q_{m f}$.

R ecently，a m odel to study percolation in a multifractal was proposed 还］in the lit－ erature．In fact，the authors have created an original multifractal object，$Q_{m} f$ ，and an e cient way to estim ate its percolation properties．In this work we study in detail the $m$ ethod to estim ate $p_{c}$ for this $m$ ultifractal and discuss the relation betw een $p_{c}$ ，som e topologic characteristics，and the anisotropy of $Q_{m f}$ ．

T he m ultifractal ob ject we develop，$Q_{m \mathrm{f}}$ ，is an intultive generalization of the square lattioe $\left.{ }_{[15}^{15}\right]$ ．Suppose that in the construction of the square lattioe we use the follow ing algorithm ：take a square of size 1 and cut it sym $m$ etrically $w$ ith vertical and horizontal lines．Repeat this process $n$ tim es；at the $n^{\text {th }}$ step we have a regular square lattice $w$ ith $2^{n} \quad 2^{n}$ cells．The setup algorithm of $Q_{m f}$ is quite sim ilar，the $m$ ain di erence is that we do not cut the square in a sym $m$ etric w ay．In section 2 we explain in detail this algorithm ．

T he developm ent of $Q_{m f}$ has a tw ofold $m$ otivation．$F$ irstly，there are system $s$ like oil reservoirs that show m ultifractal properties $\left[\frac{1}{1}\right]$ ］and are good candidates to be m odeled by such object．Secondly，there is indeed a m uch m ore general scope：we want to study percolation phenom ena in lattiges that are not regular，but that are multifractal in the geom etrical sense．It is im portant to know how site peroolation transition happens in lattioes in which the cells vary in size and also in the num ber of neighbors．

In this work we analyse som e geom etric and topologic properties of the percolation chuster generated on $Q_{m} f$ at the percolation threshold．T he paper is organized as follow s： in $x 2$ we present the process of construction of $Q_{m} f$ and the algorithm for the estim ation of $p_{c}$ ，in $x 3$ we show the num erical sim ulations conceming the percolation threshold $p_{c}$
and the topologic properties of $Q_{m f}$; and nally in $x 4$ we present our nal rem arks and com $m$ ents.

## 2-THEMODEL

In this section we show the process of buidding of the $m$ ultifractal $Q_{m f}$ and the key concepts to estim ate $\mathrm{p}_{\mathrm{c}}$. W e start w th a square of linear size 1 and a partition param eter $0 \ll 1$. For reasons that $w$ ill.be clear later, $=\frac{s}{r}$, where $s$ and $r$ are integers. $W$ e call the multifractal buitt from this param eter as the " $Q_{m f}$ ", or " ( $r$; s) $Q_{m f}$ ".

The rst step, $\mathrm{n}=1$, consists oftw $\circ$ sections of the square: a vertical and an horizontal. Initially the square is cut in two pieces of area $\frac{r}{s+r}=\frac{1}{1+}$ and $\frac{s}{s+r}=\frac{1}{1+}$ by a vertical line. This process is shown in gure '1.1. (a), where we use as an example $=\frac{s}{r}=\frac{2}{3}$. The horizontal cut in which we use the same partition is shown in gure in (b). The rst partition of the square generates four rectangular blocks: the largest one of area $(\overline{1+})^{2}$, two of area $\frac{}{(1+)^{2}}$ and the sm allest one of area $\left(\frac{1}{1+}\right)^{2}$. The di erence betw een the largest area and the sm allest one increases as ! $0, m$ oreover, the blocks get $m$ ore and $m$ ore stretched in this lim it. Therefore $m$ easures the anisotropy of $Q_{m f}$.

In the second step, $\mathrm{n}=2$, we repeat the sam e process of vertical and horizontal sections as in step 1. Generically we get $2^{2 n}$ blocks after the $n^{\text {th }}$-step. The partition process produces a set ofblocks $w$ th a variety of areas. W e calla set of allelem ents $w$ th the sam e area as a $k$-set. At the $n^{\text {th }}$-step of the algorithm the partition of the square in blocks follow s the binom ial rule:

$T$ he number of elem ents of a k -set is $\mathrm{C}_{\mathrm{k}}^{\mathrm{n}}$. In reference [1], we see that as $\mathrm{n}!1$ all the $k$-sets determ ine a monofractal whose dim ension is $d_{k}=\lim n_{n!1} \frac{\left.\log c_{n}^{k} s^{k} r^{(n n} k\right)}{\log (s+r)^{\frac{n}{2}}}$. In this lim it, the ensem ble of all $k$-sets engenders the $m$ ultifractal ob ject $Q_{m f}$ itself.
$F$ igure $i_{1}^{2}$ show $s$ a picture of $Q_{m}$ for $=\frac{1}{3}$ and $n=4$. W e use the follow ing code color: blocks of equal area have the sam e tonality. In other words, all the blocks of a sam e k -set share a com m on gray-tone. The general view of the ob ject show s an anisotropic,
heterogeneous lattige $w$ ith a non-trivial topology. T he anisotropy of $Q_{m f} w$ ill change the percolation threshold as we investigate in the next section. Before that we study in $m$ ore detail the problem of percolation.

The $m$ ain subject of this work is the study of percolation properties of $Q_{m}$. To perform such a task we develop a percolation algorithm. T he peroolation algorithm for $Q_{m f}$ start $m$ apping this ob ject into the square lattioe. T he square lattioe should be large enough that each line segm ent of $Q_{m f}$ coincides $w$ ith $a$ line of the lattice, this condition imposes that is a rational number (边 $m$ eans, $r$ and $s$ are integers). Therefore we consider that the square lattioe is more nely divided than $Q_{m \mathrm{f}}$. In this way all blocks of the multifractal are com posed by a nite num ber of cells of the square lattioe. To explain the percolation algorithm we suppose that $Q_{m f}$ construction is at step $n$. We proceed the percolation algorithm by choosing at random one am ong the $2^{2 n}$ blocks of $Q_{m f}$ independent of its size or num ber of neighbors. O nce a block is chosen all the cells in the square lattioe corresponding to this block are considered as occupied. E ach tim e a block of $Q_{m f}$ is chosen the algorithm check if the occupied cells at the underlying square lattioe are connected in such a w ay to form a spanning peroolation cluster. T he algorithm


## 3-N UMERICALRESULTS

In this section we show num erical results conceming the peroolation threshold. B efore the num erics we introduce som e de nitions. W e call lattice the square lattice underlying $Q_{m f}$. Follow ing the literature [in [1] we call p the probability of occupation of a lattige site. $R_{L}$ is the probability that for a site occupation $p$ there exists a contiguous chuster of occupied sites which crosses com pletely the square lattice of size L. $\mathrm{p}_{\mathrm{c}}$ is the probability of occupation at the percolation threshold. T here are several ways $\left[\frac{1}{1} 1\right]$ to de ne $\mathrm{R}_{\mathrm{L}}$. W e use tw o of them : $R_{L}^{e}$ is the probability that there exits a cluster crossing either the horizontal or the vertical direction, and $R_{L}^{b}$ is the probability that there exits a cluster crossing both directions. At the $\lim$ it of in nite lattioe size $R_{L}^{e}$ and $R_{L}^{b}$ converge to a com $m$ on value for the square lattine case. Besides we call $p_{c}^{e}$ the value of $p_{c}$ estim ated from $R_{L}^{e}$, it $m$ eans,
the average $\mathrm{p}_{\mathrm{c}}$ over lattices that percolate in one direction, the horizontal or the vertical. A nd, sim ilarly, $p_{c}^{b}$ the value of $p_{c}$ estim ated from $R_{L}^{b}$.

Figure ${ }_{-1}^{-1}{ }_{-1}^{-1}$ ilhustrates the behavior of $p_{c}^{e}$ and $p_{c}^{b}$ for 7 di erent lattice sizes. T w o typical values of are used: $=\frac{2}{3}$ (solid line) and $=\frac{1}{4}$ (dashed line). In ${ }_{-1 / 3}$ (a) we show both $p_{c}$ versus $\frac{1}{\mathrm{~L}}$, the upper values corresponds to $\mathrm{p}_{\mathrm{c}}^{\mathrm{b}}$ and the bottom values to $\mathrm{p}_{\mathrm{c}}^{e}$. T he lattioe size, $L=(r+s)^{n}$, corresponds to $4 n \quad 10$, in both cases $r+s=5$. The data of the upper branch of the gure collapse into a single curve, diversly from the lower branch. In other words, the curves of $(2 ; 3) \quad Q_{m f}$ and $(4 ; 1) \quad Q_{m f}$ share roughly the sam e $p_{c}^{e}$ but dinerse $\mathrm{p}_{\mathrm{c}}^{\mathrm{b}}$. The reason for this feature is the strong anisotropy of $(4 ; 1) \quad \mathrm{Q}_{\mathrm{mf}}$ com pared to the case $(2 ; 3) \quad Q_{m f}$. The anisotropy of the percolation cluster does not a ect $p_{c}$ in both directions, but it a ects $\mathrm{p}_{\mathrm{c}}$ in one direction. In fact, the percolation in both directions com es from an average over both directions, in such situation, any eventual anisotropy of the percolation cluster vanishes because of the average.

An usefulw way to de ne $p_{c}$ is to take the average value $p_{\text {Cave }}=\frac{p_{c}^{e}+p_{c}^{b}}{2}$. In gure $\mathbf{K}_{1}^{2}(\mathrm{~b})$ we plot $p_{\text {cave }}$ versus $\frac{1}{\mathrm{~L}}$ corresponding to the same data gure $\operatorname{Sin}^{(a)}$. We observe in this gure that both curves converge to a saturation value that is not the sam e . The di erence betw een the tw o cases is related to the curve of $p_{c}^{b}$. The anisotropy (stretching of the blocks) due to im plies an anisotropy in the percolation cluster. Such anisotropy determ ines that the percolation cluster does not have a correlation length independent of the direction. Because the percolation chuster is anisotropic the sym $m$ etry betw een $p_{c}^{e}$ and $p_{c}^{b}$ should fail. Therefore, we expect that for sm aller ( $m$ ore anisotropy in the multifractal) a greater di erence in $\mathrm{p}_{\text {cave }} \mathrm{w}$ ill appear. F igure $\mathrm{L}_{1}$ in m this tendency for diverse values of .
$F$ igure, ${ }_{-1}^{4}$, show $s p_{c}$ versus . To obtain $p_{c}$ wem ake an average of $p_{\text {cave }}$ after the saturation process, it $m$ eans, for $n$ 8. The param eter is indicated in the gure. These values are also show $n$ in $T a b l e ~ I . T$ he straight line in the gure is the linear tting of the data. We focus our attention on two features of the gure: the general tendency of decreasing $p_{c}$ $w$ ith , and the anom alous case $(3 ; 1) \quad Q_{m f}$. Them ain tendency of decreasing $p_{c} w$ ith we have discussed in connection with anisotropy. W e com $m$ ent the anom alous situation of $(3 ; 1) \quad Q_{m f}$ in relation to topologic properties $\circ \mathrm{f}_{\mathrm{m}} \mathrm{f}$ which are analyzed in what follow s . The ob ject $Q_{m f}$ is build of a set of blocks i w ith di erent areas, $A_{i}$, and number of
neighbors, ${ }_{i}$. The num ber $i$ is a central quantity in the study of topology. A topologic quantity, that is im portant in the investigation $\underset{P}{ }$ of the percolation threshold, is ave which is an average of ${ }_{i}$ over $Q_{m f}$. It $m$ eans ave $=\frac{i^{i}}{N}$ where $N=2^{2 n}$ is the total number ofblocks and the sum in the num erator is perform ed over the fullm ultifractal. Typically ave is a num ber that does not increase with $n$, but attains a constant value after $n \quad 6$. W e plot in Table I this topologic quantity for $n=8$ and several values of .

We observe in the row of ave that all these values are roughly the sam e, the exception corresponds to the case of the $(3 ; 1) Q_{m f}$. The conclusion we take is that the variation of the average num ber of neighbors causes the uctuation in percolation threshold observed in gure ${ }_{-1}^{2} .1$. The $p_{c}$ of the $(3 ; 1) \quad Q_{m}$ is a little bit greater than the other cases because it has a sm aller average num ber of neighbors. In other words, because each block of the $(3 ; 1) Q_{m f}$, in the average, has less neighbors, it percolates $w$ ith $m$ ore di culty than the tendency am ong its group.

4-FINALREMARKS

To sum $m$ arize we analyze in this w ork the role of the an isotropy and the average num ber of neighbors of $Q_{m f}$ on its percolation threshold, $p_{c}$. Themultifractal ob ject is com posed by a set ofblocks w ith di erent areas and num ber of neighbors. A s the param eter de ning $Q_{m f}$, , goes to zero, them ultifractalbecom esm ore and $m$ ore anisotropic. This anisotropy re ects in the percolation cluster creating an asym $m$ etry between $p_{c}^{e}$ and $p_{c}^{b}$.

The anisotropy of $Q_{m f}$ is evident when we com pare $p_{c}^{e}$ and $p_{c}^{b}$. The observed curves of $p_{c}^{e}$ show a sim ilar behavior, in contrast to the curves of $p_{c}^{b}$. A ctually, the $m$ easure of $p_{c}^{b}$ $m$ akes an average overboth directionsw hich erases any anisotropice ect of the percolation
cluster. This erasing e ect does not exist when we m easure $p_{c}^{e}$. The anisotropy of $Q_{m} f$ decreases w ith (w th ! 0 the blocks becam e m ore stretched).

A special case in our analysis is the $(3 ; 1) \quad Q_{m f}$. This case is singular com pared to others analyzed cases. For a sam e num ber ofblocks, the (3;1) $Q_{m f}$ case has less neighbors than the multifractal blocks corresponding to other values of . This phenom enon is intrinsic to the topology of $Q_{m f}$. It im plies that the $(3 ; 1) \quad Q_{m f}$ is less connected, and, as a consequence, it show sm ore di culty to percolate. Therefore the case of the (3;1) Q mf has a percolation threshold slighter greater then its neighbors in the sequence. In a fiuture work we intend to study in m ore detail the e ect of other topologic properties on the percolation properties.
