Dephasing of solid-state qubits at optim alpoints

M otivated by recent experiments with Josephson-junction circuits, we analyze the in uence of various noise sources on the dynamics of two-level systems at optimal operation points where the linear coupling to low-frequency uctuations is suppressed. We study the decoherence due to non-linear (quadratic) coupling, focusing on the experimentally relevant 1=f and 0 hm ic noise power spectra. For 1=f noise strong higher-order e ects in uence the evolution.

For quantum—inform ation processing it is crucial to preserve phase coherence. Recent experim ents [1, 2, 3, 4, 5] with Josephson—junction circuits demonstrated long—lived coherent oscillations. They showed resolution, sufcient for detailed studies of the dephasing times and decay laws, stressing the need for the theory analysis of the dissipative dynamics of qubits subject to relevant noise sources.

In solid-state system s decoherence is potentially strong due the host of microscopic modes. In Josephson qubits the noise is dominated by material-dependent sources, such as background-charge uctuations or variations of critical currents and magnetic elds, with power spectrum peaked at low frequencies, often 1=f. A further relevant contribution is the electrom agnetic noise of the control circuit, typically 0 hm ic at low frequencies. The 1=f noise appears di cult to suppress and, since the dephasing is dominated by low-frequency noise, it is particularly destructive. On the other hand, V ion et al. [2] showed that the e ect of this noise can be substantially reduced by tuning the linear longitudinal qubit-noise coupling to zero. The same strategy, suppressing the linear qubit-detector coupling, was used to m in im ize the e ect of the quantum detector in the o-state. The achieved coherence time was 2{3 orders of magnitude longer than in earlier experiments.

The 1=f noise (more generally, strong low-frequency noise) plays a major role in many solid-state systems. The long-range correlations in time make the analysis of its e ect di cult. In this letter we analyze the dynam ics of a qubit subject to singular noise, with a focus on non-linear coupling and higher-order e ects. We also apply the developed formalism to an environment with regular (e.g., 0 hm ic thermal) noise.

The dynam ics of a dissipative two-level system (spin 1/2, qubit) can be described by the H am iltonian:

The longitudinal (V) and transverse (U) uctuations may result from various microscopic noise sources, described by H $_{\rm bath}$. In this letter we analyze the dephasing

in the situation of quadratic longitudinal coupling,

to a source of G aussian noise X (t), with noise power S_X (!). Here X (t) is a basic physical quantity (e.g., voltage or magnetic eld), which controls the qubit's Ham iltonian [15]. This model is relevant to a Josephson qubit at an optimal point, investigated in recent experiments [2]. To emphasize specic features of this model, we rst recall the description of the dissipative qubit dynamics when the noise is either short-correlated or G aussian longitudinal. Then we motivate model (2) and show that it can describe the elect of both longitudinal and transverse low-frequency noise. We discuss the statistics of X and V, and then analyze dephasing in model (2).

For weak short-correlated noise the dynam ics is described by the B loch equations, regardless of the noise statistics. The weak dissipative elects from many uncorrelated time intervals (the correlation time) accumulate and the elect of both longitudinal and transverse noise can be described by the markovian B loch equations. The dissipative rates are given by the golden rule: the z-relaxation rate $1=T_1=S_U$ (! = ")=2 and the rate of dephasing (decay of x,y) $1=T_2=1=(2T_1)+1=T_2$, the bure' dephasing rate $1=T_2=S_V$ (! = 0)=2 being dominated by low ! . This approach applies for weak noise with a short correlation time c T_1 ; T_2 .

One can still rely on the lowest order of the cum ulant expansion (but beyond the golden rule) for G aussian longitudinal noise V (U = 0), even for long correlations. The coherence h (t)i (here = ($_{\rm X}$ i $_{\rm Y}$)=2) decays then

where $S_V = \frac{1}{2} h N(t); V(0)_{+} ii_{+} ii_{+} is$ the noise power. For instance, for a linear coupling, V(X) = aX, to a Gaussian-distributed 1=f (icker) noise X, when T_2 de ned above vanishes, one nds the dephasing law $\exp\left(-\frac{a}{2}X \frac{c}{f}t^2j\ln\left(!_{ir}t\right)_{j=2}\right)$ (cf. Refs. 6, 7). Here X_f^2 sets the magnitude of the noise,

and m ay depend on the external conditions, such as temperature. The infra-red cuto $!_{\rm ir}$ m ay be set, and controlled, by the details of an experiment. For instance, when a measurement of dephasing, performed over a short time t, is averaged over many runs, the uctuations with frequencies down to the inverse of the total signal acquisition time contribute to the phase random ization [7] (this averaging improves the accuracy and is needed to monitor the oscillations of expectation values [1, 2, 3, 4, 5]). In an echo-type experiment the contribution of slow uctuations can be suppressed [6]. The controlled frequency of the compensating echo pulses sets $!_{\rm ir}$ (in Ref. 6 $!_{\rm ir}$ 1=t but it can be varied). Here we focus on the case $!_{\rm ir}$ to

Typically, in them entioned regime of linear coupling to 1=f noise dephasing is strong. To increase the coherence time one tunes the system to a point where the linear term vanishes, a = 0 [2]. The elect of the remaining quadratic coupling is described by the model (2). Moreover, thism odel can also account for low-frequency transverse uctuations U $_{\rm lf}$. Indeed, in the adiabatic approximation we diagonalize (1) to $\frac{1}{2}^{\rm p} \frac{({\tt l}+{\tt V})^2 + {\tt U}_{\rm lf}^2}{({\tt l}+{\tt V}_{\rm e})}$, where Ve = V + U $_{\rm lf}^2$ (2"). Hence as long as the relaxation due to the resonant (! ") part of U is negligible, it is su cient to analyze the model (2).

This analysis requires an account of higher orders, and thus the know ledge not only of S_V (!) but of the full statistics of V. The latter depends on the statistics of the basic quantity X as well as on the qubit-noise coupling. In this letter we consider a Gaussian-distributed X (see below), but due to the nonlinear coupling in Eq. (2) the qubit is subject to non-Gaussian uctuations $V=X^2$. In combination with long correlations of 1=f noise, this shows that further analysis is needed.

The statistics of the low-frequency uctuations of the basic quantity X deserves further discussion. The assum ed Gaussian statistics is generic for noise produced by m any m icroscopic m odes, due to the central lim it theorem and regardless of the noise mechanism. As for the icker (1=f') noise in m esoscopic circuits, it m ay be dom inated by only a few modes (bistable uctuators) or contain com parable contributions of many of those, depending on the sample, and one may expect non-Gaussian resp. Gaussian noise. This was demonstrated in experim ents at kH z-and lower frequencies [8]. W hile the noise at higher frequencies M H z {G H z, relevant for the dephasing of qubits, is less explored, recent data suggest that it m ay have the sam e nature [5, 6, 9]. Here we focus on the analysis of the in uence of Gaussian noise X; the e ect of a few bistable systems was discussed recently in Ref. 10. Our analysis on one hand, indicates interesting features of decoherence for quadratic coupling; on the other hand, one can consider the qubit as a probe of the noise, thus our ndings may help in identifying the noise mechanism.

Analysis of dephasing in model (2). To be de nite, we assume that > 0; the sign change has no e ect

on the dephasing laws, but reverses the phase accumulated due to the nonzero average of V. We follow the evolution of the o-diagonal entry of the qubit's density matrix h (t)i = $h_{\rm k}^{\rm y}$ Si, with the evolution operator S = T exp($\frac{\rm i}{2}$ $_0$ V $_z$ dt 0), which yields h (t)i = P (t)ei"t=h h (0)i, where

with averaging over noise realizations. T and T denote time resp. reverse-time ordering; their combination in Eq. (5) corresponds to the K eldysh-time ordering. Note the same signs in T exp and T exp, selected by the operator .

G aussian approximation. In the lowest-order perturbative analysis one can use Eq. (3) [11]. For 0 hm ic uctuations of X , with noise power S_X (!) = r! coth (!=2T), one nds S_{X^2} (!) = $(r^2=3)$! (! $^2+4^2T^2$) coth (!=2T) and Eq. (3) yields for weak noise $\,$ rT $\,$ 1 the exponential decay with rate

This dephasing is stronger suppressed by cooling compared to the case of linear coupling, when $1=T_2$ T.

For 1=f noise one nds $S_{X^2} = (4=)X_f^4 \ln j! = !_{ir} - j! j!$ and $P(t) = \exp([_ft \ln (!_{ir}t) = \hat{j}^2), where$

Higher orders: results and discussion. Below we analyze e ects beyond this Gaussian approximation. For the Ohmic noise we con im that Eq. (3) holds at all relevant times, yielding the decay rate (6). In contrast, for the 1=f noise corrections are strong:

At short times we nd a very slow decay with time scale $(_{\rm f}L)^{1}$, where L In ($_{\rm f}$ =! $_{\rm ir}$) and we assum e L (our qualitative results persist down to L 1): At very short times it reduces to 1 $[_{f}t \ln (!_{ir}t) =]^{2}$ and coincides with the result of the Gaussian approximation. This slow initial decay may be advantageous for application of quantum error correction. At longer times $t_{p_{\perp}}$ ($_{f}L$) 1 the decay crosses over to a power law / 1= t. Finally, at the (param etrically longer) time t $\frac{1}{f}$ the decay becom es exponential (9), due to the high-frequency contribution. For large L 1 a substantial decay occurs already in the range of Eq. (8).




FIG. 1: Line shape $^{0}_{x}$ (!), in units of 1=($_{f}L$) and as a function of (! ")=($_{f}L$). Eq. (8) sets a singular universal shape, / (! ") $^{1=2}$. The high-frequency contribution (9, 12) washes out this singularity on scale $_{f}$ (L 1 in these units) and shifts the peak. The dashed line shows the result of the G aussian approximation F $_{2}$ combined with the phase shift F $_{1}$.

This unusual decay law translates into a peculiar line shape of the transverse spin susceptibility $\frac{00}{x}$ (!) = P (! ")=2 (at T "), shown in Fig. 1: Eq. (8) gives

a singular peak / (! ") $^{1=2}$, and the term (9) washes it out on the scale $_{\rm f}$, setting the peak height $_{\rm f}$. A part from the dephasing, we ind a phase contribution which shifts the peak by $_{\rm f}\ln{\rm (!\,_{c}=_{\rm f})}=$ (if this logarithm exceeds $\ln{\rm L}$; $_{\rm c}$ is the unltraviolet cuto).

Derivation. The Keldysh-time-ordered exponent (5) may be expanded into the linked-cluster series:




FIG. 2: a. Linked-cluster expansion. The factor $_{\rm t}$ (!) = \sin (!=2)=(!) at each vertex violates the frequency conservation. b. High/- and Now/-frequency regions dominating the integration in the cluster diagram s.

 F_n representing the contribution of all connected diagrams of order n in the perturbation V (the Gaussian approximation (3) neglects $F_{n>2}$). For them odel (2) they are visualized in Fig. 2a, with a single cluster in each order. Here the solid lines represent the bare 2 $\,$ 2 K eldysh G reen functions of the bath D $\,^{\circ}\,=\,$ iMg X (t)X (0)i, whose K eldysh and retarded components [12, 13] are related to the noise power and the response function of the bath, respectively: D $^{K}\,=\,$ 2 iSg , D $^{R}\,=\,$ x . Each vertex contributes a factor $\,^{\circ}\,$ and integration over the time interval (0;t). Thus we $\,^{\circ}\,$ nd in the n-th order:

where $_{\rm t}$ (!) $_{\rm t}$ sin (! t=2)=(!). The vertices contribute the identity m atrices $\hat{1}$ in the K eldysh space, rather than the fam iliar $\hat{\,}_{\rm z}$, as a result of the sign structure in Eq. (5); such a perturbation is called 'quantum' [13]. For the coupling (2) the averaging in (5) reduces to a Gaussian integral and thus to a determinant of an integral operator. From this standpoint our calculation may be viewed as determinant regularization.

Tractable regimes. The series (10), (11) should be evaluated for each particular time t. In general, it is dicult

due to its com plex structure: the propagators \hat{D} are diagonal in frequency and the vertices are diagonal in time. However, one can evaluate the dephasing in certain $\lim_{t\to\infty} \hat{D}$ (the exact condition to be specified) that short times the lines become time-independent, \hat{D} (the exact condition to be specified) that short times the lines become time-independent, \hat{D} (the exact condition to be specified) at short times the lines become time-independent, \hat{D} (the exact condition to be specified). These ideas are used below for the case of left noise, when \hat{D} (the exact condition to be specified).

1=f noise: (a) higher frequencies. For the 1=f noise it is technically more convenient to discuss the contributions of two frequency ranges at given t (see Fig. 2b), rather than the short- and long-time limits.

We begin with higher frequencies: In the integral (11) the adjacent frequencies may dier by 1=t due to the vertex factors $_{\rm t}$. In the (t-dependent) range j! j 1=t such a shift does not change much the propagators (noise power), and $_{\rm t}$ (!) (!) at each vertex. Thus we not the contribution of high frequencies:

The contribution of frequencies of order 1=t is only estimated by this expression. However, at long times $_{\rm f}$ t 1, when Eq. (12) dom inates P (t) (as we nd below), this contribution is negligible, and we obtain Eq. (9): $\ln {\mathfrak P}^{\rm hf}$ (t) j= 1 t, where

As for the phase shift, to the logarithm ic accuracy in the lim it ln($_{\rm f}$ t) 1 we nd Im lnP $^{\rm hf}$ (t) = $_{\rm f}$ tln($_{\rm f}$ t)= .

1=f noise: (b) lower frequencies. For the analysis of the contribution of low frequencies j! j 1=t one may replace the vertex factor $_{\rm t}($!) by its value, t=2 , at ! = 0, and the correlations between frequencies of adjacent lines are irrelevant. Thus the series (10) gives [16]:

A gain, the contribution of frequencies close to the upper lim it,! 1=t, is not given reliably by Eq. (15), but it is negligible to the logarithm ic accuracy at $\ln(1=!_{ir}t)$ 1.

The low and high (and intermediate) frequencies contribute at all times, but at short times $\ln \mathcal{P}$ (t) j is dominated by low frequencies and at long times by high frequencies. These leading terms yield Eqs. (8), (9). (The susceptibility $_{\rm X}$ (!) enters the analysis, but in the nal results we assumed a regular and hence negligible .)

We consider the case of weak-coupling and begin with the lowest order F_2 . Evaluation of this Gaussian cluster involves ${\rm tr}\hat{D}^2=(D^R)^2+(D^A)^2+(D^R)^2$ [both of the 1]. The frequency integral of the 1 rst two terms (analytic in the upper/lower half-plane) vanishes, and we not exponential decay with rate (6) at t=T (incl. $t=T_2$).

As expected for weak noise, the higher orders provide only a small correction to Eq. (6), of order $(r!_c)^2$. Indeed, only the even orders contribute to dephasing, for which $tr\hat{D}^{2k} = (D^R)^{2k} + (D^A)^{2k} + terms localized at <math>! < T$. One nds that it is su cient to evaluate the second-order contribution provided $\hat{D}(! = 0)$ 1. In the Ohm ic case this weak-coupling condition reads rT; $r!_c$ 1.

Higher (non-Gaussian) orders as screening. The exponential decay law (9) appears surprising for 1=f noise, with long-time correlations. In fact, it develops due to the screening of the long-time (low-!) uctuations, interacting via the term (2), similar to the screening of interaction in the Coulomb gas. Moreover, the calculation of P (t) parallels that of the correlation energy of the Coulomb gas [14]. The result can be found from the lowest-order cluster F_2 with the solid lines replaced by the properly renormalized (screened) Keldysh propagators D. Diagram matically this appears natural: the diagram $sF_{n>2}$ in Fig. 2a may be viewed as F_2 with additional vertices on the lines.

As a result of the screening, qualitatively, the 1=f divergence is cut o at! f, and the white low-! noise produces the exponential decay. We omit the detailed discussion but mention a speci-c property of the screened D: unlike the bare D it is t-dependent (due to the t-dependent vertices). In other words, the screening sets in gradually, with the mentioned saturation at t $^{>}$ $_{\rm f}^{1}$.

P reparation e ects. So far we worked under the assumption that at t=0 the bath and spin were disentangled and the bath was prepared in the thermal state of $H_{\rm bath}$. To see, if it can change our conclusions, we considered a typical experiment, in which one monitors the decay of a superposition of the spin states in the presence of permanent spin-bath coupling. We found that for l=f noise with a non-singular low-frequency susceptibility (!) our conculsions about the dephasing persist.

In conclusion, we have analyzed the decay laws of coherence of a qubit coupled quadratically to the environment. We have shown that higher-order e ects become important for certain noise spectra (notably, for 1=f), and found the dephasing times (6) { (9) in various regimes. We are grateful to G.
