Self-induced charge currents in electrom agnetic m aterials, photon e ective rest m ass and som e related topics

The contribution of self-induced charge currents of m etam aterial m edia to photon e ective rest m ass is discussed in detail in the present paper. W e concern ourselves with two kinds of photon effective rest m ass, i.e., the frequency-dependent and frequency-independent e ective rest m ass. B ased on these two de nitions, we calculate the photon e ective rest m ass in the left-handed m edium and the 2TD LM m edia, the latter of which is described by the so-called two time derivative Lorentz m aterial (2TD LM) m odel. A dditionally, we concentrate prim arily on the torque, which is caused by the interaction between self-induced charge currents in dilute plasm a (e.g., the secondary cosm ic rays) and interstellar m agnetic edds (am bient cosm ic m agnetic vector potentials), acting on the torsion balance of the rotating torsion balance experiment.

I.PHOTON EFFECTIVE REST MASS DUE TO SELF-INDUCED CHARGE CURRENT

In is well known that in some simple electrom agnetic media such as electron plasma, superconducting media and Lorentz dispersive materials (inside which the time-harm onic electrom agnetic wave is propagating), the self-induced charge current density J [1] is proportional to the magnetic vector potential A. Thus the interaction term $_0J$ A in the Lagrangian density is therefore transformed into an electrom agnetics for superconductivity, G inzberg-Landau superconductivity theory and Higgs mechanism. Note that in these media, the magnetic permeability $^1 = 1$, so it is easy for us to obtain J (and hence the electrice rest mass of photon) by solving the equation of motion of charged particles acted upon by electrom agnetic waves. However, for some articial composite electrom agnetic metamaterials, which are described by, e.g., the two time derivative Lorentz material (2TDLM) model (in which both the electric permittivity and the magnetic permeability are of frequency dependence and therefore of com plicated form) and some uniaxially (or biaxially) anisotropic media with permittivity and permeability being tensors, the above form ulation may be not helpful in obtaining the electrice rest mass of electrom agnetic elds. In these cases, how ever, we have shown that the follow ing form ula [2]

which arises from the E instein-de B roglie relation, can be applicable to the above problem. In the expression (1.1), n, h and c denote the optical refractive index, P lanck's constant and speed of light in a vacuum, respectively.

The two time derivative Lorentz material (2TDLM) model rst suggested by Ziolkowski and Auzanneau [3,4] is a generalization of the standard Lorentz material model. Ziolkowski has shown that this type of 2TDLM medium can be designed so that it allows communication signals to propagate in the medium at speeds exceeding the speed of light in a vacuum without violating causality [5]. For these articial metamaterials, the model encompasses the permittivity and permeability material responses experimentally obtained [6]. The \$-directed polarization and \$directed magnetization elds in such materials would have the following forms [5]

This paper is concerned with the self-induced charge currents and some related physically interesting topics such as photon e ective rest mass due to medium dispersion and its e ects in torsion balance experiments. where e_m , e_m and e_m represent, respectively, the coupling of the electric (m agnetic) eld and its rst and second time derivatives to the local electric (m agnetic) dipole moments. $!_p$, e_n^m and $!_0$ can be viewed as the plasm a frequency, dam ping frequency and resonance frequency of the electric (m agnetic) dipole oscillators, respectively. Thus the frequency-dom ain electric and m agnetic susceptibilities are given

As an illustrative example, we apply Eq.(1.5) to the case of left-handed media, which is a kind of artical composite metamaterials with negative refractive index in the microwave frequency region (10^9 Hz) . More recently, this medium captured considerable attention in various elds such as condensed matter physics, materials science, applied electrom agnetics and optics [6{11}]. The most characteristic features of left-handed media are: (i) both the electric permittivity and the magnetic permeability are negative; (ii) the Poynting vector and wave vector of electrom agnetic wave propagating inside it would be antiparallel, i.e., the wave vector k, the electric eld E and the magnetic

eld H form a left-handed system; (iii) a num ber of peculiar electrom agnetic and optical properties such as the reversal of both the D oppler shift and the C herenkov radiation, anom alous refraction, am pli cation of evanescent waves [12], unusual photon tunneling [13], m odi ed spontaneous em ission rates and even reversals of radiation pressure to radiation tension [7,8] arise. All these dram atically di erent propagation characteristics stem from the sign change of the group velocity. In what follows we calculate the photon elective rest m ass squared by m aking use of Eq.(1.5) and the expressions

for the electric parameter and magnetic permeability, where the plasma frequency $!_p$ and the magnetic resonance frequency $!_0$ are in the GHz range (e.g., $!_p = 10.0 \text{ GHz}$, $!_0 = 4.0 \text{ GHz}$ [14]); and represent the damping parameters. The parameter F may often be chosen 0 < F < 1, for example, F = 0.56 [14]. By using n^2 (!) = (!) (!), we obtain [15]

with the plasm a frequency squared $!_p^2 = \frac{N e^2}{\sigma^m e}$ (here e, m_e and N respectively denote the electron charge, m ass and electron number density in this electron plasm a).

It should be emphasized that there is a di erence in the de nition of photon e ective rest m ass between two types of experimental schemes of testing photon m ass². In the discussion of wave dispersion and potential variations of the speed of light with frequency, which are based on the M axwellian equations (rather than the H am iltonian or Lagrangian density of interacting electrom agnetic system), the e ective rest m ass squared of photons is expressed by Eq.(1.9). H istorically, this problem has been discussed by m any investigators, e.g., Feinberg who considered the possibility of the variation of the speed of light with frequency in the sharply de ned optical and radio pulses from pulsars and took into account in m ore detail the observed variation of arrival tim e with frequency for the radio waves attributed to the interaction with interstellar electrons [17]. How ever, for those experimental schemes of testing photon rest m ass, which are based on the H am iltonian density (rather than the M axwellian equations), the e ective rest m ass of photons due to m edia dispersion (i.e., the interaction of wave with charged particles in environmental dilute plasm a such as the secondary cosm ic rays) is two times that expressed in Eq.(1.9). The torsion balance experiment is just this type of schemes, which will be considered in Sec.V.

How ever, it should be noted that in Lorentz dispersive materials, m_e^2 in (1.8) depends strongly on !, and som etim espossesses an imaginary part (due to the damping parameter and resonance frequency) and the physical meanings of m_e^2 is therefore not very apparently seen. In what follows we will de ne a physically meaningful e ective rest mass of photons, which is independent of the frequency !, and will explain a method by which the frequency-independent e ective rest mass of photons in the 2TDLM media is extracted from n^2 (!). Note that the above non-physical disadvantage of frequency-dependent mass in (1.8) will be avoided in the frequency-independent e ective rest mass.

II. EXTRACTING FREQUENCY -IN DEPENDENT EFFECTIVE MASS FROM REFRACTIVE INDEX SQUARED

In this fram ework of de nition of frequency-independent e ective rest m ass, the photon should be regarded as acted upon by a hypothetical force eld, namely, it behaves like a massive de Broglie particle moving in a force eld. It is veried in the following that, for the case of de Broglie particle in a force eld, one can also consider its \optical refractive index" n. A coording to the Einstein-de Broglie relation, the dispersion relation of the de Broglie particle with rest m ass m_0 in the potential eld V (x) agrees with

In what follows, an approach to frequency-independent e ective mass extracted from the optical refractive index squared n^2 (!) is presented. It is assumed that n^2 (!) can be rewritten as the following series expansions

C om pared (2.7) with (2.5), it is apparent that the frequency-independent e ective rest mass squared m_e^2 of the photon can be read o from n^2 (!), namely, the constant term on the right-handed side on (2.7) is related only to m_e^2 , i.e.,

Generally speaking, the optical refractive index n^2 (!) is often of complicated form, particularly for the metamaterials. So, we cannot extract frequency-independent m_e^2 immediately from n^2 (!). In the following, this problem is resolved by calculating the limit value of n^2 (!)!², where ! tends to 1 or zero. We rst consider the large frequency behavior of n^2 (!)!². It follows from (2.7) that n^2 (!)!² at high frequencies (i.e., !! 1) is of the form

In the next section, we will calculate the frequency-independent e ective rest mass of photons in the 2TDLM model by making use of the method presented above.

III.FREQUENCY-INDEPENDENT EFFECTIVE REST MASS OF PHOTONS IN THE 2TDLM MODEL

A coording to the de nition of the 2TDLM model, the frequency-domain electric and magnetic susceptibilities are expressed by Eq.(1.3) and the refractive index squared is given in Eq.(1.4)

In order to obtain the frequency-independent m_e^2 from n^2 (!), according to the form ulation in the previous section, the high-frequency (! ! 1) behavior of ^e (!)!² should rst be taken into consideration and the result is

Thus the !-independent e ective rest mass squared m_e^2 is extracted from n^2 (!). Apparently, m_e^2 in Eq. (3.6) does not depend on !. The remainder on the right-handed side of Eq. M any m etam aterials which have complicated expressions for electric and m agnetic susceptibilities such as (1.3) are generally rarely seen in nature and often arises from the arti cial manufactures. M ore recently, one of the arti cial composite m etam aterials, the left-handed m edium which has a frequency band (G H z) where the electric perm ittivity () and the magnetic perm eability () are simultaneously negative, has focused attention of m any authors both experimentally and theoretically [6,9{11,15,19}]. In the left-handed m edium, m ost phenomena as the D oppler e ect,

Vavilov-Cherenkov radiation and even Snell's law are inverted. In 1964³, Veselago rst considered m any peculiar optical and electrom agnetic properties, phenom ena and e ects in this medium and referred to such materials as left-handed media [7], since in this case the propagation vector k, electric eld E and magnetic eld H of light wave propagating inside it form a left-handed system. It follows from M axwellian curl equations that such media having negative simultaneously negative and exhibit a negative index of refraction, i.e., $n = \frac{p}{m}$. Since negative refractive index occurs only rarely, this medium attracts attention of m any physicists in various elds. In experiments, the negative and can be respectively realized by using a network (array) of thin (long) metalwires [19] and a periodic arrangement of split ring resonators [9]. A combination of the two structures yields a left-handed medium. C om pared the permittivity and permeability (1.6) of left-handed medium with the electric and magnetic susceptibilities (1.3), one can arrive at

So, it is readily veried with the help of (3.6) that the !-independent e ective rest mass of photons inside left-handed media is written as follows

It follows that Eq.(3.11) is a restriction on the electrom agnetic parameters $F;!_p;!_0$; and F in the electric permittivity and magnetic permeability (1.6), since m_e^2 0. Insertion of the experimentally chosen values of the electrom agnetic parameters in the literature into Eq. (3.11) shows that this restriction condition is satis ed. For instance, in Ruppin's work [14], $F;!_p;!_0$; ; and F were chosen F = 0.56, $!_p = 10.0G H z$, $!_0 = 4.0G H z$, $= 0.03!_p$, $= 0.03!_0$, which indicates that the inequality m_e^2 0 is satis ed.

IV . SOM E APPLICATIONS OF FREQUENCY –IN DEPENDENT EFFECTIVE REST MASS OF PHOTONS

In this section we consider the applications of the concept of frequency-independent e ective rest mass of photons to some optical and electrom agnetic phenom ena and e ects.

(i) As was stated above, since the frequency-independent e ective rest m ass of photons in electrom agnetic m edia is related close to the coupling param eters of the electric (m agnetic) elds to the electric (m agnetic) dipole systems, and the damping and resonance frequency of the electric (m agnetic) dipole oscillators, it contains the information on the interaction between light and m aterials. It is shown that in certain frequency ranges this e ective rest m ass governs the propagation behavior of electrom agnetic wave in m edia, and by using this concept one can therefore consider the wave propagation som ew hat conveniently. For example, in the left-handed m edia whose permittivity and perm eability are expressed by (1.6), the potential eld V (!) approaches h $F(!_0^2 = !_p^2)$, which is constant, as the frequency tends to zero. This, therefore, m eans that at low frequencies the light propagation is governed m ainly by the frequency-independent e ective rest m ass of photons.

Likewise, in the case of the potential eld V (!) being vanishing where the frequency squared of electrom agnetic wave is

the photon can be regarded as a free" m assive particle with the rest m ass being expressed in (3.11). In the frequency region near , sine the photon is a quasi-free" particle, the light propagation behavior and properties is rather simple

³N ote that, in the literature, some authors [20,21] m entioned the wrong year when Veselago suggested the left-handed m edia. They claim ed that Veselago proposed or introduced the concept of left-handed m edia in 1968 or 1964. On the contrary, the true history is as follows: Veselago's excellent paper was rst published in Russian in July, 1967 [U sp. Fiz. N auk 92, 517-526 (1967)]. com pared with other frequency ranges in which V (!) is nonvanishing or large. For the left-handed media, the relevant frequency parameters $!_0$ and $!_p$ of which is about GHZ, the frequency in Eq.(4.1) that leads to V () = 0 is just in the frequency band (GHZ) where the permittivity and permeability are simultaneously negative. It follows that when the e ects and phenom ena associated with negative index of refraction occur in left-handed media, the wave propagation (e.g., scattering properties) and dispersion properties of the light are not as complicated as those in other frequency ranges, since in the negative-index frequency band, the optical refractive index squared simulates nearly the plasm a behavior, particularly in the region near .

(ii) H istorically, possibility of a light pulse with speed greater than that (c) in a vacuum has been extensively investigated by m any authors [5,22{27]. Z iolkow ski has studied the superlum inal pulse propagation and consequent superlum inal information exchange in the 2TD LM m edia, and demonstrated that they do not violate the principle of causality [5]. He showed that in the 2TD LM m odel, both the phase and group velocities, i.e.,

of light at high frequencies will exceed the speed (c) of light in a vacuum, so long as 2 < < 0, where denotes the coupling coe cients of the second time derivatives of electric (m agnetic) elds to the local electric (m agnetic) dipole m otions [5].

A lthough in the 2TDLM model the medium will exhibit a possibility of superlum in al speeds of wave propagation, the photon velocity (rather than group velocity of light) is by no means larger than c. This may be explained as follows: according to Eq.(3.9), the kinetic energy of a photon is $E = h! \frac{1}{1 + (!)}$. If the light frequency ! tends to in nity, then it follows from Eq.(3.7) that E ! nh!. Since the photon momentum $p = \frac{nh!}{c}$, the velocity v of the photon with a frequency-independent rest m ass approaches c, i.e., the particle (photon) velocity $v = \frac{p}{E}$! c. Thus we show that in the articical composite metam aterials such as 2TDLM media the photon velocity does not exceed the speed of light in a vacuum, no matter whether the phase (and group) velocity of light inside it is a superlum inal speed or not.

(iii) The frequency-independent rest m ass of photons is useful in discussing the plus and m inus signs of phase shifts in light scattering inside m edia. The phase shifts and its signs contain the information on the scattering between wave and potentials. A coording to Eq.(3.9), if (!) is positive (negative), then the interaction energy V (!) between light and m edia is negative (positive). For this reason, it is possible for us to determ ine the signs (plus or m inus) of phase shifts in light scattering process by calculating (!) and the frequency-independent rest m ass m_e. Now with the developm ent in design and fabrication of left-handed m aterials, the zero-index (0; 0) m aterials receive attention in m aterials science and applied electrom agnetism [28]. For this kind of m edia with the optical refractive index n 0, from Eq.(3.7) it follows that

i.e., (!) is approximately equal to $\frac{m_{eff}^2 c^4}{h^2 ! \cdot 2}$ 1 and we can determ ine the sign by comparing the light frequency with the photon elective rest mass m_e. This, therefore, means that if the frequency ! is larger than $\frac{m_{eff} c^2}{h}$, then < 0 and consequently the phase shift of light wave due to scattering acquires a minus sign; and if the light frequency ! is less than $\frac{m_{eff} c^2}{h}$, then > 0 and consequently the phase shift acquires a plus sign.

V.EFFECTS OF SELF-INDUCED CHARGE CURRENTS IN THE TORSION BALANCE EXPERIMENT

In this section, we consider the potential e ects of self-induced charge currents arising in the torsion balance experiments [29,30]. The Lagrangian density of electrodynam ics reads

In the electron plasma, due to the conservation law of the canonical momentum density, i.e., $\frac{d}{dt}$ (m_ev + eA) = 0, we have $v = \frac{e}{m_e}A + C$ with C being a constant velocity. Note that here $\frac{1}{2c^2}$ r $E \frac{J_0}{0}^2$ results from both the mass term $\frac{2}{c^2} A_0^2$ and the Gauss's law r $E = {}^2A_0 + \frac{J_0}{0}$.

It follows from (5.3) that the total e ective rest mass squared of electrom agnetic elds in electron plasma is given as follows

where $r = B = {}_{0}J$ holds when the electric eld strength E, electric current density J are vanishing in the Am pere-M axwell equation. In Eq.(5.5), $m_{d} = r^{2}I$ means that a current loop of radius r carrying current I gives rise to a magnetic dipole moment m_{d} ; S in I = J = S denotes the area vector through which the electric current density vector J penetrates; $\sim = m_{d}$ B means that an electric-current loop with a magnetic dipole moment m_{d} , immersed in a magnetic eld B, experiences a torque $\sim = m_{d}$ B. Eqs.(5.6) means in the torsion balance experiment, a toroid coil contains a loop of magnetic ux which acts as a dipole source a_{d} of magnetic vector potential via r A = B with the magnetic eld B within the toroid as the source term.

It follows from (5.3) that in the Hamiltonian density H of electrom agnetic system, there are $\frac{1}{2}B^2$ and $\frac{1}{2}$ $^2 + 2\frac{_0N e^2}{_{m_e}} A^2$ (i.e., $\frac{1}{2} (_{tot}A)^2$), which provide us with som e useful insights into calculating the torque produced by the interaction of magnetic dipole vector potential moment a_d with the ambient cosm ic magnetic vector potential acting upon the toroid in the torsion balance experiment. For convenience, the Equations (5.6) may be rewritten as follow s

Thus it follows from the analogies in the above table that, $? = (_{tot}a_d) (_{tot}A)$, i.e., the torque $\sim = _{tot}^2 a_d A$. Here the torque \sim arising from the interaction between the dipole eld of magnetic potentials (resulting from the electric current I in the toroid windings) with the ambient vector potential A acts on the torsion balance. It should be noted again that here $_{tot}^2 = ^2 + 2 \frac{_0 N e^2}{_m e}$ rather than $_{tot}^2 = ^2 + \frac{_0 N e^2}{_m e}$.

Note that there exists a term $_0$ N eC in the Ampere-M axwell-P roca equation r $B = _{0 0} \frac{\theta}{\theta t} E [^2 + \frac{_0 N e^2}{m_e}]A + _{0}N$ eC. Does this term has in uences on the torsion balance? In what follows we will discuss this problem.

In the similar fashion, we consider the familiar H amiltonian density M B, which describes the interaction of the magnetic moments with the magnetic eld B. According to the Ampere-M axwell-Proce equation with $_{0\ 0\ \frac{\theta}{\theta t}E}$ and $\frac{_{0}N e^{2}}{m_{e}}A$ being ignored, we have r $B = _{0}N eC$, which can be rewritten as r $B = (_{0\ tot}) \frac{N eC}{tot}$. In the meanwhile, H = N eC A can also be rewritten as H = $\frac{N eC}{tot}$ (ot A).

It is known that in the su ciently large space led with hom ogeneous magnetic moments with volume density (magnetization) being M, the interior magnetic eld strength B produced by hom ogeneously distributed magnetic moments is just $_{0}M^{4}$, i.e., r $A = _{0}M$ or r $(_{tot}A) = (_{0} _{tot})M$.

It follows that $? = \frac{N eC}{tot}$ (totA), i.e., $\sim = N eC$ A, which dose not act on the toroid in the torsion balance experiment.

Since we have discussed the related prelim in any preparation for the e ects of self-induced charge currents, we think the order of magnitude of its e ects in experiments (e.g., the extra torque due to the photon e ective mass acting on the toroid in the torsion balance experiment) deserves evaluation. It is shown by our evaluation that the muons and alpha-particles in secondary cosm ic rays will contribute an elective rest mass about 10⁵⁴ K g to the photon, which is compared to the new ly obtained upper limit on photon rest mass in Luo's rotating torsion balance experiment.

VI.DISCUSSION AND REMARKS:SELF-INDUCED CHARGE CURRENTS IN DILUTE PLASMA

Here we discuss the elective rest mass of photon resulting from the self-induced charge currents in the torsion balance experiments [29,30]. The self-induced charge current arises mainly from the two sources around us: (i) muon () component and alpha-particles in cosm ic rays; (ii) decay daughter (alpha-particles) of radioactive radon gas $\binom{222}{86}$ Rn, $\binom{220}{86}$ Rn) in room environment.

It is known that at the sea level, the current density of muon component in secondary cosm ic rays is about $1 \quad 10^{2}$ cm² s¹ [33]. Assuming that the muon velocity approaches speed of light, the volume density of muon can

⁴This may be considered in two ways: (i) if the direction of M is assumed to be parallel to the third component of C artesian coordinate system, then the potentially non-vanishing components of B and H are also the third ones. It follows from the Ampere's law r $H = J_{free}$ with $J_{free} = 0$ that H_3 is constant, and H_3 can be viewed as zero. be derived and the result is N = 0.3 10⁶ m⁻³. So, according to Eq.(5.4) (i.e., $m_e = \frac{h}{c} \frac{q}{\frac{2N e^2}{\sigma^m c^2}}$), electrom agnetic wave with wavelength⁵ 100 m at the sea level acquires an electric rest mass about 0.3 10⁻⁵³ K q.

It is believed that the air m olecules in the vacuum chamber of torsion balance experiment cannot be ionized by the alpha-particles of cosm ic rays, because the mean free path of alpha-particle moving at about 10^7m s¹ in the dilute air with the pressure being only 10^{-2} Pa [29] is too large (more than 10^6 m)⁶. So, the air medium has nothing to contribute to the elective rest mass of photons.

Radon $(g_6 Rn)$ possesses the -radioactivity. Generally speaking, the Rn density in room environment is 10 ⁸m⁻³ or so, which may be the same order of magnitude as particle density in secondary cosm ic rays⁷, and the decay daughter (alpha-particles) will therefore give rise to a photon e ective mass of about 10 ⁵⁴ Kg.

Thus the elective rest m assinduced by m uons and alpha-particles in secondary cosm ic rays and radon gas can be compared to the new upper limit (1.2 10^{54} Kg) obtained by Luo et al. in their recent rotating torsion balance experiment [29]. So, as far as the contribution of ions of cosm ic rays to the photon rest m ass is concerned, this upper limit (1.2 10^{54} Kg) becomes just a critical value. We think Luo's experimentally obtained upper limit is of much interest and therefore deserves further experimental investigation to get a more precise upper limit on photon mass.

V II. C O N C LU S IO N

In this paper,

i) it is veried that the expression $\frac{m_{eff}^2 c^4}{h^2} = (1 n^2)!^2$ can be applied to calculating the electric mean as of photons in the article composite electrom agnetic metam aterials with complicated permittivity and permeability.

ii) we suggest an approach to obtaining the frequency-independent e ective rest m ass of photons in certain arti cial composite m etam aterials such as 2TDLM m edia which possess the complicated electric perm ittivity and m agnetic perm eability.

iii) it is shown that the extra torque $2\frac{0N}{m}e^2a_d$ A by the self-induced charge currents will also acts upon the toroid in the torsion balance experiment whose apparatus is immersed in the dilute plasma such as the cosm ic rays and radon gas. Here the photon elective rest mass squared is $\frac{2}{e} = 2\frac{0N}{m}e^2$ rather than $\frac{2}{e} = \frac{0N}{m}e^2$.

The following dimension between these two $\frac{2}{e}$ should be pointed out: the theoretical mechanism of torsion balance experiment lies in the Lagrangian or H am iltonian (5.3) of interacting electrom agnetic system, so, the electric rest mass squared of electrom agnetic elds is $\frac{2}{e} = 2\frac{0Ne^2}{m_e}$. However, for those experimental schemes [17,31,32] of photon rest mass stemming from the Ampere-M axwell-P roca equation r $B = 0.0\frac{\theta}{\theta t}E$ [$^2 + \frac{0Ne^2}{m_e}$]A + $_0$ N eC, the electric rest mass squared of electrom agnetic elds is $\frac{2}{e} = \frac{0Ne^2}{m_e}$ rather than $\frac{2}{e} = 2\frac{0Ne^2}{m_e}$. The so-called experimental realizations stemming from the Ampere-M axwell-P roca equation are as follows: pulsar test of a variation of the speed of light with frequency [17]; geomagnetic limit on photon mass based on the analysis of satellite measurements of the Earth's eld [31]; experimental test of Ampere's law at low temperature [32], etc.. In all these experimental schemes, the electric mass squared is $\frac{2}{e} = \frac{0Ne^2}{m_e}$.

 $^{^{5}}$ Since the m ean distance of two m uons in secondary cosm ic rays at sea level is about 100 m , Lorentz's m ean- eld form ulation (Lorentz's dispersion theory, Lorentz's electron theory, 1895) is not applicable to the electrom agnetic wave with wavelength

¹⁰⁰ m. So, the above e ective m ass form ula is no longer valid for this case (i.e., 100 m). In fact, the electrom agnetic wave with wavelength 100 m dose not acquire this e ective rest m ass. But the ambient cosm ic m agnetic vector potentials (interstellar m agnetic elds) with low (or zero) frequencies will truly acquire this e ective rest m ass.

⁶A coording to some handbooks, the free paths of alpha-particles in air (with pressure 10^5 Pa) are 2.5, 3.5, 4.6, 5.9, 7.4, 8.9, 10.6 cm, corresponding respectively to the energy 4.0, 5.0, 6.0, 7.0, 8.0, 9.0, 10.0 M ev. So, in the vacuum cham berwith pressure 10^2 Pa in Luo's experiment, the free path of alpha-particles (with energy much more than 10 M ev, even perhaps more than 100 M ev) in secondary cosm ic rays is more than 10^7 times several cm, which means that the air molecules in the low-pressure vacuum cham ber cannot be easily ionized by the alpha-particles of cosm ic rays.

⁷The e ective doses of cosm ic rays and Rn hum and su er are respectively 0.4 m Sv (typical range: 0.3-1.0 m Sv) and 1.2 m Sv (typical range: 0.2-10 m Sv).

iv) the self-induced charge currents in dilute plasm a presented above (i.e., m uons and alpha-particles in secondary cosm ic rays and radon gas) will give arise to an e ective rest m ass of about 10 54 Kg, which can be compared to the new upper lim it on photon rest m ass obtained in Luo's rotating torsion balance experiment.
