Self-organized current transport through low angle grain boundaries in Y B a_2 C u_3 O $_7$ thin lm s, studied m agnetom etrically

The critical current density owing across low angle grain boundaries in $YBa_2Cu_3O_7$ thin lm s has been studied m agnetom etrically. Film s (200 nm thickness) were deposited on SrT iO₃ bicrystal substrates containing a single [001] tilt boundary, with angles of 2, 3, 5, and 7 degrees, and the lm s were patterned into rings. Their m agnetic m om ents were m easured in applied m agnetic elds up to 30 kO e at tem peratures of 5 - 95 K; current densities of rings with or without grain boundaries, were obtained from a m odi ed critical state m odel. For rings containing 5 and 7 degree boundaries, the m agnetic response depends strongly on the eld history, which arises in large part from self-eld e ects acting on the grain boundary.

I. IN TRODUCTION

High tem perature superconductors characteristically have highly an isotropic properties and a short scale of the superconducting coherence length . As a consequence, the critical current density across grain boundaries can be signi cantly reduced relative to that which ow swithin grains. For reasons that are not well understood, a large m isalignm ent of ad jacent grains suppresses the order parameter along the grain boundary (GB) and as a result, the adjacent grains are weakly linked. The weak-link behavior of a high-angle grain boundary and a near-exponential decrease in the GB critical current density J_{c}^{GB} with misorientation angle were rst studied by D in os et al.¹ in YBa₂Cu₃O₇ materials. Since then, a number of studies have been conducted on this and other high-T_c superconductors, as reviewed recently by Hilgenkam p and M annhart.² This review article provides an excellent overview of grain boundaries in these m aterials, the controlled synthesis of GBs, current transport, and related topics. M uch earlier work focussed on the properties of GBs with relatively large misorientation angles > 10, where intergrain current conduction is severely suppressed. The present work concentrates on materials with lower angle GBs, which are contained in YBCO rings for magnetom etric study.

The regime of lower angle grain boundaries is interesting, for with decreasing tilt angle , the mode of current conduction appears to cross-over from weak to strong linkage. Technologically this is highly relevant: recently developed methods for forming highly-textured coated conductors, such as rolling-assisted biaxially textured substrates (RABiTS)^{3,4} and ion-beam assisted deposition

(BAD)^{5,6,7}, vastly improve the current conduction in multicrystalline coated conductors of high-tem perature superconductors, by reducing the average m isorientation < 7. For su ciently into a regime of low angles sm all angles, the material between dislocation cores on the grain boundary is only mildly perturbed and this provides a strong conduction channel com parable to or wider than the in-plane coherence length.¹² For further developm ent of coated conductors, an understanding of low -angle GBs is in portant, for it gives guidance as to how highly textured the materials must be. Speci cally, are low-angle GBs still weak-linked and responsible for large reductions of the GB current density? How does the application of an external magnetic eld a ect the current ow?

This magnetom etric study of low -angle GBs is based on a simple equation from electrodynamics. A circulating current generates a magnetic dipolem om ent according to the equation

where J is the current density at location r. This expression tells us that once the current con guration is established, the current or (spatially uniform) current density can be calculated from the measured magnetic moment of a sample. The current con guration is related to the sample geometry. W ith the sensitivity of SQUID – based instrumentation and a simple ring geometry that helps de ne the current path, 8,9,10,11 we obtain the critical current density J_c owing through grain boundaries in the high-tem perature superconductor Y Ba₂C u₃O₇ (YBCO), and for com parison, the J_c of com panion rings

with no GBs. Furthermore, the magnetic responses m (H) of the rings are compared and contrasted. We observe a large peak in the decreasing eld branch of the m (H) curves for GB rings with = 5.1 and 7 and show that its appearance arises largely from a cancellation of the applied magnetic eld by self eld e ects on weakly linked grain boundaries.

II. MAGNETIC MOMENTS IN THE CRITICAL STATE

In the critical state model, one assumes that critical currents with density Jc ow throughout the superconductor. In this work, the currents are induced by applying a large magnetic eld H app perpendicular to at, planar samples. It is then straightforward to integrate Eq.1 and obtain the associated magnetic momentm for several of the sam ple geom etries used here. For exam ple, a at strip of thickness d, length ', and width w has

according to the sandpile model.¹³ This and following expressions have cgs units with dimensions in cm, J in A/cm^2 , and m in erg/G = emu. For the long narrow strips considered here, the factor [1 w = 3'] 1 will be neglected. Equation 2 also gives the moment of an \open circuit" thin ring of the sam e thickness and width, where '= 2 R for a ring of radius R.

A nother standard case is that of a disk of outer radius a and thickness d. Here one has

From this, it follows that a continuous ring with outer radius a and inner radius a1 has moment

For a thin ring with a $a_1 = w << a, Eq. 5$ is nearly the sam e as the sim plest expression

where I_c is the critical current and the speed of light c has value 10 in these laboratory units.

Let us now consider the case of a thin ring that crosses a grain boundary (GB). The GB is expected to have a low er critical current density $J_c^{G B}$ and low er critical current I^{GB} than the surrounding epitaxial YBCO grain Im with critical current density J_c^{Gr} . When applying a magnetic eld, we rst induce currents that circulate around the outer and inner circum ferences of the ring and that screen ux from the central hole;²⁰ simultaneously ux penetrates into the grain YBCO and more deeply into the GB.W hen the current exceeds $I_{\rm c}^{\rm GB}$, ux enters the

where currents with density $J_{\rm c}^{\rm G\ r}~$ ow throughout. Thus a portion of the current approaching a GB can cross it and generate the magnetic moment of a loop, Eq. 6. The self-organizing, rem aining portion of the current makes a $U-tum, "^{14}$ giving the magneticm om ent of a strip, Eq.2. The resulting Bean-like ux pro le is displaced from the center of the strip, just like the case of a superconducting strip carrying both a transport current and critical state currents. Let us de ne by J $_{c}^{GB}$ = (=w)J $_{c}^{Gr}$ as a measure of the GB current (geometrically =2 corresponds to the displacement of the ux pro le from the center-line of the 'strip'). Then we have

These expressions ignore term s of order $(w=a)^2$. Experin entally, we determ in $J_{\rm c}^{\rm G\,r}$ in a separate experiment, then solve Eq.8 for (=w), from which J_{C}^{GB} is obtained.

III. EXPERIMENTAL ASPECTS

In order to use the above equations e ectively for this study, sam ples were specially designed as rings in the follow ing process. Film s of YBCO were prepared on SrT iO₃ (STO) [001]-tilt bicrystal substrates by pulsed laser deposition. Three ring samples were made from each YBCO In using standard optical photolithography techniques. One ring was placed across a grain boundary so as to contain two grain boundaries (GB ring); two other rings were patterned on each of the two adjoining single crystals (grain rings). All three rings have the sam e geom etry with an outside diam eter 2a of 3 mm, an inside diam eter 2a1 of 2.8 mm giving a ring width w of 0.10 mm, and a thickness d of 200 nm . The substrate was cut into three pieces, each containing just one ring. Note that all three rings come from a single YBCO Im and as a result, the

In sper se should have the same properties, such as current density, pinning force, etc. Bicrystal substrates with 1.8, 2.8, 5.1 (two samples), and 7 [001]-tilt boundaries were used to make GB and companion grain ring sam ples. Som etim es the current density can be dim inished by external degrading factors, such as cracks on a sam ple or by m altreatm ent. To cross-check the deduced current density values of grain rings, som e grain rings were made into an open circuit by etching a line across the 100 m width (open rings). This changes the geom etry of the current path without changing the properties of the superconductor; consistent values of J_c were obtained.

Magnetic measurements were conducted with a SQUID-based Quantum Design MPM S-7 m agnetom eter. An individual sample was mounted on a Sidisk with

Duco cem ent and placed in a M ylartube for support. For each ring, the magnetic moment was measured as a function oftem perature and magnetic eld. For tem perature sweep experiments, a magnetic eld was applied parallel to the c-axes of YBC0 lm at 5K (5000e, 3k0e, and 3 k0 e for grain, GB, and open rings, respectively); the eld levels were chosen to ensure each sample geometry was fully penetrated by the eld. Subsequently the applied eld was reduced to zero (H $_{app} = 0$) to induce circulating currents in the material (and the magnet was \reset" to provide the quietest and most stable magnetic environm ent). Then we measured the rem anent-state m agnetic moment as a function of temperature from 5 K to 95 K in 1 K steps. Com plem entary eld-dependent m om ents m (H), i.e., hysteresis loops, were measured in increasing and decreasing applied magnetic elds in the range from 00 e to 30 k0 e. The eld sweep measurements were conducted at tem peratures of 5, 10, 20, 40, 60, 77, and 85 K for each ring. To obtain the critical current density J_c from the measured magnetic moments, the critical state expressions Eq. 3-8 were used for each sample con quration.

IV. RESULTS OF THE TEM PERATURE SW EEP EXPERIMENTS




FIG.1: (color online) The critical current density J_c of YBa₂Cu₃O₇ m easured m agnetically in zero applied m agnetic eld (open symbols), plotted versus temperature T. Results are shown for YBCO rings on SrT iO₃ containing a single 5.1 [001] tilt grain boundary (GB) and for comparison, a grain ring (Gr) with no GB.Filled symbols show peak values for J_c in the GB ring m easured in – eld, as discussed in the text.

For the tem perature sweep measurements, each ring was prepared in the critical state by applying a large magnetic eld and then reducing it to zero. Two exam ples of these results for $J_{c}(T)$ in zero applied eld are shown in Fig. 1, for a ring containing a 5.1 GB and its companion grain ring. Both have the same T_c near 93 K, as did all of the grain, GB, and open rings. For the grain ring in Fig. 1, the current density J_c^{Gr} was calculated using Eq. 5. These results are typical of those observed for the companion rings at 5 K in zero applied eld, 34-40 M A / cm². For the G B ring, the current density J_c^{GB} was calculated using Eq. 8. As evident in the gure, the values are strongly suppressed relative to those in the grain ring. This is particularly so at low temperatures, where J at 5 K in zero applied eld lies near 1.6 MA/cm^2 . (The higher-JGB data, shown as led sym bols, were obtained in nite decreasing magnetic eld, as will be discussed below). We reported previously¹⁵ that corresponding studies of 1.8 GB rings yielded current densities alm ost identical to those for the grain rings. It was argued that the sim ilarity between the 1.8 GB and its companion grain ring is a consequence of the large num bers of twin boundaries in YBCO thin Im s.

As the m isorientation of the grain boundary increases, the GB current density diminishes signi cantly. While J_c^{GB} is the same as the grain value for a 1.8 boundary, the values at T = 5 K fallto 50 % of J_c^{GT} at = 2.8, to 5 % at 5.1, and to 3 % at 7, respectively. Interestingly (and fortunately for coated conductor applications), the fractional transport is larger at T = 77 K, rising to 60 % of J_c^{GT} at = 2.8, to 15–20 % at 5.1, and to 10

% of $J_{\rm c}^{\rm G~r}$ at 7 , respectively. These results show that a small angle c-axis tilt boundary in the range 1.8 $\,<\,$

5:1 clearly impedes the current owing across it. More precisely, the range 1:8 < 2:8 contains the critical angle where a grain boundary begins to suppress the current ow across it.

V. RESULT OF THE FIELD SW EEP EXPERIMENTS




FIG.2: (color online) For a YBCO grain ring without grain boundaries, the critical current density J_c versus applied eld H at the tem peratures shown. Inset: the magnetic moment m (H) at 5 K showing symmetric response in increasing and decreasing eld histories.

The isotherm alm agnetic response was studied at tem peratures T = 5 - 85 K. For the grain and open rings, nicely sym m etric curves of m agnetic m om ent versus eld were obtained, as illustrated by the inset to Fig. 2. The symmetry of the hystereticm about the axism = 0 m eans that the same absolute magnitude of J ows in the ring for increasing eld (lower branch) and decreasing eld (upperbranch) histories. The critical current density was obtained from Eq.5 and Eq.3 for grain and open rings, respectively. Typical values were 34-40 M A /cm 2 in zero applied eld at 5 K.Figure 2 shows the eld and tem perature dependence of $J_c^{G r}$ for one of the grain rings. The dependence is simple, with a monotonic fallo with both H and T. As in temperature sweep experiments, the in-eld features m (H;T) for the 1.8 GB and its com panion grain ring were nearly identical in eld sweep experiments. The curves of m versus H for the 1.8 and 2.8 GB rings were as symmetric as those of grain rings. In contrast, the magnetic response of the rings with




FIG.3: (coloronline) The magnetic momentm (H) for a GB ring on SrTiD₃ containing a single 5.1 GB. The response is quite asymmetric, with a large peak in m and $J_c^{\rm GB}$ in decreasing eld. For comparison, the moment of an open ring (open symbols, heavy line) is included to show the approximate magnitude of the signal produced by \U-tum" grain currents.

5.1 and 7 grain boundaries is considerably more com plex. This is evident in Fig. 3, which shows m (H) for the 7 ring at several tem peratures. A lso included for com parison are virgin curves for a representative open ring, which shows the signal produced by a ring with a \grain boundary" of zero conductivity. Qualitatively, the \excess" magnetic moment in the GB ring (larger than the open ring) arises from currents crossing the GB and owing around the circum ference of the ring. The most prominent feature in the m (H) curves for the 5.1 and 7 GB rings is the appearance of a large peak in the decreasing eld branch; by com parison, the loops for the open ring are symmetric about the m = 0 axis, as this signal arises from grain-type currents. Com pared with the GB current density in zero applied eld, the value at the peak is considerably larger and it occurs at applied elds of several kO e m agnitude. To illustrate the di erence, the values of J_c^{GB} at the peak are included in Fig. 1 as solid symbols.

The appearance of a peak in the GB current density has been reported m any times and it is attributed to the e ect of a magnetic eld on a Josephson junction, which a grain boundary resembles.²¹ The occurrence of a peak in the m (H) curves of a GB sam ple, occurring only in decreasing eld, marks the appearance of weak-link behavior²² in the sm all angle grain boundary. It is well known that the maximum tunneling current ow s across a Josephson junction when the net m agnetic ux, which is perpendicular to the tunneling current ow, become e zero on the area of the junction. A pplying this idea, one expects that the total magnetic eld on a grain boundary H_{local} becomes roughly zero at the peak in J_c. Two

major elds acting on the grain boundary are the applied magnetic eld H_{app} and the eld H_{self} created by induced currents owing in the vicinity of and parallel to the grain boundary:

In increasing eld, the directions of those two elds are the same, giving H $_{\rm local} = H_{\rm app} + \frac{1}{2}H_{\rm self}$ j. On the other hand, decreasing the applied eld reverses the currents near the grain boundary, giving H $_{\rm local} = H_{\rm app}$ $\frac{1}{2}H_{\rm self}$ j and allowing a cancellation of the applied and self elds. At the peak where H $_{\rm local}$ 0, one has that H $_{\rm peak}$ H $_{\rm app;peak}$ $\frac{1}{2}H_{\rm self}$ j. J; the last proportionality follows from the fact that H $_{\rm self}$ is created by currents owing near the GB.




FIG. 4: (color online) The eld H $_{peak}$ where the GB J_c is a maximum in decreasing eld, plotted versus grain current density, for the sam ples shown at tem peratures 5-60 K.G rain boundary angles are [001] c-axis tilts. (a) The current density is J_c^{G r} measured in zero applied eld, H $_{app} = 0$ and (b) the current density is the grain value measured at the peak eld, i.e., at H $_{app} = H_{peak}$ for each case.

Figure 4 tests this scenario by plotting the peak eld H $_{peak}$ as a function of grain current density $J_{c}^{G r}$, where

both are measured at tem peratures from 5 K to 77 K. In Fig. 4a, we consider the sim plest approxim ation that the e ective currents have the density J_c^{Gr} of the grains, measured in $H_{app} = 0$. This is the most appropriate choice, since grain currents near the GB (where H_{local} 0) contribute most strongly to H $_{\rm self}$. Recall that the YBCO In is fully penetrated by ux and that J_c^{Gr} is determined in separate measurements on companion rings. Indeed, there is a strong correlation between the peak position H $_{\rm peak}$ and the grain current density, as shown by the straight line in the gure with correlation coe cient $R^2 = 0.983$. The gure includes data for the weakly linked GBswith = 5.1 and 7. To test further the confecture that a null local eld produces the peak in J, we reduced the current density in two sets of rings while maintaining the same overall geometry; they were partially deoxygenated by annealing in 0.2 bar of 0_2 at 500 C, followed by furnace-cooling. This decreased T_c to 65 K for the 5.1 GB and 75 K for the 7 GB.D ata for

those GBs are also included in Fig. 4 (labeled $\deO x''$) and they follow the same trend as the fully oxygenated

As seen in Fig. 4a, there is a clear correlation between H_{peak} and the grain $J_c^{G\,r}$. One might consider, how ever, that the appropriate scale of nearby currents is the density $J_c^{G\,r}$ m easured at H_{app} = H_{peak}. Thus Fig. 4b presents the peak eld as a function of this lower, ineld current density. The resulting plot is similar to that in Fig. 4a, with regression coe cient R² = 0.986. O verall, these analyses show that the position of the peaks in $J_c^{G\,B}$ tracks the nearby current density quite well. This supports the conjecture that the peaks correspond to a nulling of the local eld acting on a weakly linked grain boundary.

rings.

Next we ask whether currents in the lm can create local elds com parable with the observed H peak. This is a di cult question, as it involves the magnetic eld very near the edge of a thin sheet of current-carrying superconductor. For one estim ate, let us consider the case at T = 5 K with grain current density J_c^{Gr} 35 MA/cm^2 , 2.8 kOe (Fig. 4a). Numerical work of where H_{peak} Daum ling and Larbalestier²³ has shown that the perpendicular eld is $_{0}H$ 1:1 $_0 J_c d$ (in units of tesla) at the edge of a thin disk with radius/thickness = 10^3 ; this expression gives a eld of 1 k0 e at the edge of one disk 2 kO e, since current ow s on both sides of and H self the grain boundary. An alternative estimate com es from the work of Brandt et al., who consider a very long thin strip of type II superconductor in a perpendicular magnetic eld.²⁴ For the parameters cited, their expression for the normal eld near the edge of a single strip gives values of 1.2 k0 e at a distance 10 $_{ab} = 15 \text{ nm}$ from the edge of the strip, and 1.6 kO e at distance ab. D oubling these values as above to account for currents on each side of the grain boundary yields self elds H self that are very comparable with the 2.8 k0 e observed experim entally. W hile the geom etries (disk, edge of thin strip) dier som ew hat from the GB geometry, these estimates give som e quantitative support for the \null eld-weak link" model for the peak in GB current density.




FIG.5: (color online) M inor loops m (H) at T = 5 K for (a) a grain boundary (GB) ring with = 5.1 and (b) a grain ring with no grain boundary. In both cases, the open symbols show the envelope signal obtained by m onotonically sweeping the eld from H = 0 up to high eld, then down to zero; led symbols show the e ect of 20 Oe steps in H in the reverse direction, where the orientation of the symbols show s the direction of eld change. For the grain ring in (b), the response is symmetric, while it is quite asymmetric for the GB ring in (a).

To probe further the grain boundary system near the peak in J_c^{GB} , we perform ed m inor loop experiments on the 5.1 GB ring at 5 K. The results are shown in Fig. 5a; for com parison, identical measurem ents on one of the grain rings are shown in Fig. 5b. The following was done. A fter making a standard m (H) loop to 10 kO e and back to H = 0, we began to retrace the loop, increasing H from low eld. Then at 2.2 kO e, the applied eld was decreased in 20 0 e steps until the magnetic m om ent reached the decreasing eld branch of the m (H) curve. (The orientations of the symbols in Fig. 5 show the direction of eld change.) The changes in m were very gradual and a eld change of at least 100 0 e was needed in order to reach the upper branch. This experiment in the increasing eld branch was repeated at 4 k0 e with sim ilar results. In contrast, the GB system is much more sensitive in the decreasing eld branch: when decreasing

H from high elds to the peak at 2.6 kO e, an increase of 20 O e produced a large reduction in the magnetic moment. An increase of only 20 O e is large enough to switch the magnetic moment almost to the lower branch. At decreasing elds of 1.8 and 4.2 kO e that lie on either side of the peak, the e ect is sim ilar although less dram atic at 1.8 kO e where $J_c^{G B}$ is smaller. A smaller feature to note is the \foot" where a minor loop repins the main m (H) curve; particularly noticeable at the lower branch, this component of m develops as currents with density $J_c^{G r}$ fully penetrate the \strip-like" portion of the ring.

The major conclusion of the minor loop study is that nearthe peak in decreasing eld, the grain boundaries are very sensitive to a reversal in eld-sweep direction. Such a reversal induces oppositely directed perimeter currents in the lm and switches the sign in Eq. 9 from () to (+). Those changes quickly add magnetic ux on the

grain boundary, and this degrades the tunneling current across the GB. In contrast, the same experiments on a grain ring give a symmetric response, as illustrated in Fig. 5b. Steps in H of 20 Oe give uniform changes in m, whether increasing or decreasing; the slope dm =dH is the same as that at H = 0, as is evident from the equally spaced points for m . The latter is determined almost entirely by the geom etry of the ring through its (e ective) dem agnetizing factor D. From this perspective, one can consider that the GB ring at its peak has the very large dem agnetizing factor of a thin at ring, but increasing H in a minor loop tends to \open up" the GB and reduce D to the smaller values more characteristic of a thin strip. This discussion is, of course, only qualitative since som e current does ow across the GB. Overall, these minor loop experim ents give further support to the picture that the asymmetric, history-dependent J_c^{GB} and its peak in decreasing eld alloriginate in the weak-linkage of a grain boundary that is strongly a ected by the local eld.

Som e aspects of the magnetic eld dependence remain di cult to understand. In particular, analysis of the magnetic moments in Fig. 3 for increasing eld history suggests that the values are about a factor-of-2 sm aller than one might expect from estimates of H $_{local}$ com bined with the observed behavior in the decreasing eld branch. This \excess" asymmetry was also observed by Daum ling et al.¹⁶ in transport studies on YBCO bicrystals with higher-angle grain boundaries. Other mechanisms, of course, contribute to the transport of critical currents across grain boundaries. These can include pinning of GB vortices by facets on the boundary¹⁷ or pinning of Abrikosov-Josephson vortices on the GB by interactions with (strongly pinned) Abrikosov vortices in the grains.^{18,19}. However, none of these other mechanisms readily accounts for a strongly asymmetric response, most notably the pronounced peak in the decreasing eld branch only.

VI. ESTABLISH ING THE CRITICAL STATE




FIG.6: (color online) Them agnetic m om ent of virgin YBCO rings produced by applying sm all magnetic elds, at the tem – peratures shown. (a) an epitaxial grain ring with no grain boundaries and (b) a ring with grain boundary angle = 5.1.

W hile the results cited so far were obtained with the entire sample fully penetrated with ux, it is inform ative to exam ine how the critical state is established. For these experiments, the lm swere prepared in the virgin state by cooling them to low tem perature in zero applied eld. Then the magnetic moment was measured as the eld was increased in steps of a few Oe. For the grain In spatterned into narrow rings, the magnetic response is rather simple: m increases alm ost linearly with H with a³. This is illustrated in Fig. 6a, where a slope dm =dH the initial slopes lie within 3 % of the values calculated using Table I of B randt²⁰ with (inner radius a_1)/(outer radiusa) = 1.4 mm /1.5 mm = 0.933. This near-linearity is observed from H = 0 up to the eld of full penetration H_p 0:1 J_cd for this geom etry.²⁰ Full penetration, which is marked by a sudden departure from the nom inally linear response in Fig. 6a, occurs at progressively

lower elds as $J_{\rm c}$ deteriorates with increasing temperature.

For rings containing a pair of sm allangle grain boundaries, the initial response is similar. To show this, Fig. 6b presents m (H) for a ring with = 5.1. Com pared with the grain ring, however, there are two qualitative di erences. First, the penetration eld is much sm aller, due to the low er I_c of the GB; in the range show n, H =0-200, the Im per se is little penetrated by ux and the moment m is determined almost entirely by circulating currents that cross the GB. Second, further increases in the applied eld (above the GB penetration eld) in mediately reduce the magnitude of m. A gain, this can be attributed to the sensitivity of the GB J_c to the bcal eld, i.e., applied plus self-eld. Experimentally, the GB ring traps no ux until the applied eld exceeds the (negative) peak in m.

E stablishing the critical state in an open ring is an interesting contrast. For a thin strip of width w and length ' that the open ring resembles, the magnetic moment is




FIG.7: (color online) The magnetic response m (H) of an open ring; solid line shows a t to Eq.10 in the low eld region where ux is penetrating the 'strip' A lso included for comparison are the response of rings with = 5.1 and 7. All data are at T = 5 K.

given by²⁰

$$m (H) = (J_c dw^2 - 4c) \tanh (H = H_c)$$
 (10)

where the scaling eld H $_c = J_c d=$ and $J_c = constant$. Figure 7 shows the initial magnetization curve m (H) for an open ring at 5 K where, in comparison to the closed ring, the initial slope is much smaller and the approach to saturation is much more gradual. The solid line shows S Eq.10 drawn with the dimensions w;d; of the strip and the current density value $J_c = 35 \text{ M A}/\text{cm}^2$ obtained from a full hysteresis loop, giving H $_c = 22.5 \text{ kA}/\text{m} = 283 \text{ Oe}$. The agreement at low elds is excellent. In larger elds, the theoretical curve lies som ew hat below the experimental m because J_c is not constant, but rather decreases with H.

A lso included in Fig. 7 are the magnetic responses of GB rings with = 5.1 and 7, allat 5 K. The initial signal $(H = 0 - 10 \ Oe)$ develops very rapidly; this increase and the subsequent fallo of jn jare the same as those shown in Fig. 6b and discussed above. For larger elds H > 50 Oe, the magnitude of jn jagain increases. This additional contribution comes from currents induced and owing entirely within the grain material (not crossing the GB), as evidenced by the fact that the m (H) curves for the two GB rings are alm ost parallel to that for the open ring 'strip,' but displaced from it. The same phenom enon – generating an additional contribution to m by inducing grain currents that are re ected at the GBs – produces the 'foot' on the m inor loops in Fig. 5a.

VII. CONCLUSIONS

U sing magntic methods, we have studied current conduction and weak linkage in low angle grain boundaries. Materials investigated were ring-shaped YBCO

In swith or without [001]-tilt boundaries. Relating the m easured m agnetic m om ents to the current con gurations in GB, grain, and open ring samples, we obtained the grain boundary current density $J_c^{G\,B}$ from the ringlike contribution to the magnetic moment. The tem perature sweep experiments show that a smallm isorientation 1:8 < 7 signi cantly reduces the grain boundary current density J_c^{GB} . However, no di erence was observed between the 1.8 GB and its companion grain rings. This study suggests that to obtain the highest current density in YBCO thin Im s and coated conductors with present grain boundary structures, it will be necessary to reduce the c-axis tilt grain boundaries into the range 3 4. For the 5.1 and 7 GB rings, the m (H) (and J_c (H)) curves have a large peak in nite eld, but only for decreasing eld history. In small increasing eld, the m (H) curve of a GB ring resembles that of an open ring. These two results from the eld sweep experiments

arise from the weak-linkage in moderately low -angle grain boundaries. The high sensitivity of the current density across a GB to eld changes on the GB strongly bolsters the weak-link interpretation of low -angle grain boundaries.
