Superconductivity and Abelian Chiral Anom alies

M otivated by the geometric character of spin H all conductance, the topological invariants of generic superconductivity are discussed based on the Bogoliuvov-de Gennes equation on lattices. They are given by the Chem numbers of degenerate condensate bands for unitary order, which are realizations of A belian chiral anom alies for non-A belian connections. The three types of Chem numbers for the x; y and z-directions are given by covering degrees of some doubled surfaces around the D irac monopoles. For nonunitary states, several topological invariants are de ned by analyzing the so-called q-helicity. Topological origins of the nodal structures of superconducting gaps are also discussed.

The importance of quantum -mechanical phases in condensed matter physics has been recognized and emphasized for recent several decades. The fundam ental character of a vector potential is evident in the Aharonov-Bohm e ect where the U (1) gauge structure is essential and a magnetic eld in itself plays only a secondary role [1]. Topological structures in quantum gauge eld theories have also been studied and extensive know ledge has been accumulated [2]. Quantum mechanics itself supplies a fundamental gauge structure [3]. It is known as geom etrical phases in m any di erent contexts, where gauge structures emerge by restricting physical spaces. The quantum Halle ect is one of the key phenom ena to establish the importance of geom etrical phases [4]. The topological character of the Hall conductance was rst realized by the Chern number expression, where the Bloch functions de ne \vector potentials" in the magnetic Brillouin zone accompanied with a novel gauge structure [5]. Further the ground state of the fractional quantum Hall e ect is a com plex m any-body state w here another kind of gauge structure em erges [6]. These quantum states with nontrivial geom etrical phases are characterized by topological orders which extend an idea of order param eters in statistical mechanics to the quantum states without spontaneous symmetry breaking [7]. Also we point out an importance of boundary e ects for topologically nontrivial systems. Bulk properties are closely related to edge states and localized states near in purities and vortices[8, 9, 10, 11, 12].

Topologically nontrivial structures in superconductors also have a long history. Recently, following a prediction of ux phases for correlated electron system s[13], spin H all conductance is de ned for superconductors based on the B ogoliuvov-de G ennes (B-dG) equation [14, 15, 16] [31]. A s for singlet states and triplet states besides equalspin-pairing states, a m ap to a parameter space which represents the B dG ham iltonian is considered.[17] In the param eter space, an analogue of the D irac m onopole [18] exists and the C hern num bers are analyzed.

In this paper, we establish a topological characterization of general superconductivity based on the BdG equation on lattices. The energy spectrum of the BdG ham iltonian are fully used to calculate the Chern num bers of the superconductors. As for the unitary superconductors, condensed matter realizations of chiral anom alies for non-Abelian connections are given explicitly. Topological consideration is useful to distinguish superconductivities with the same pairing symmetry. The present analysis also clari es nodal structures of superconducting gaps with various anisotropic order param eters, which is closely related to the quantum Hall effect in three-dimensions[19, 20]. Various types of the nodalstructures are not accidentalbut have fundam ental topological origins. A possible tim e-reversal sym m etrybreaking and an unconventional gap structure are proposed based on the experim ents [32]

Bogoliuvov-de Gennes ham iltonian. Let us start from the following ham iltonian on lattices with spin-rotation symmetry:

where c_i is the electron annihilation operator with spin at site i, $t_{ij} = t_{ji}$, $V_{ij}^{1} \stackrel{2}{}^{i} \stackrel{3}{}^{4} = (V_{ij}^{4} \stackrel{3}{}^{j} \stackrel{2}{}^{1})$, $V_{ij}^{1} \stackrel{2}{}^{i} \stackrel{3}{}^{4} = V_{ji}^{2} \stackrel{1}{}^{i} \stackrel{4}{}^{3}$ and is a chemical potential. Summations over repeated spin indices are implied hereafter. The mean eld BCS approximation leads to,

where the order parameters ($_{ij}^{0} = _{ji}^{0}$) are given by $_{ij}^{1}^{2} = V_{ij}^{1}^{2i 3} {}^{4}hc_{j} {}_{3}c_{i} {}_{4}i$. The usual mean eld theory leads to the gap equation of which a solution gives an order parameter. Here we do not follow this procedure but a priori assume order parameters which may be realized for some interactions $V_{ij}^{1} = 3 4$. Let us consider the two cases separately [21, 22]: (i) singlet states $ij = ij = ij i_{j}$, (ij = ji) and (ii) triplet states $ij = ij = (d_{ij}) i_{y}$, ($d_{ij} = d_{ji}$), where (ij) = ij is a 2 2 m atrix in the spin space and ~ denotes m atrix transpose. Now assume the translational symmetry, namely, $t_{ij} = t(i j)$, ij = (i j) and also the absence of a magnetic eld, that is, t(i j) to be real. Then, except a constant, the BdG ham iltonian is given by a 4 4 m atrix h_k as

The BdG ham iltonian has a particle-hole symmetry. If $h_k \frac{u_k}{v_k} = E_k \frac{u_k}{v_k}$, then C $\frac{u_k}{v_k}$ is also an eigenstate with energy E_k where $C = {}_xK$ for singlet states and $C = i_yK$ for triplet states (u_k and v_k are the two-component vectors and K is a complex conjugate operator and the Pauli matrices operate on the two component blocks.) [34] Then it is useful to consider $h_k^2 = {}^2_{k \ 0} + {}^k_{k \ k} {}^y_{k \ k} = {}^0_{k \ k} {}^y_{k \ k}$. This is the Abelian chiral anom aly discussed in the non-Abelian gauge theories[2, 24]. Here we have considered the cubic lattice. Extensions to other lattice structures is straightforward.

Thus energies are given by $E_k = R (R = \frac{P}{k} + j k^2)$ and the states are doubly degenerate. The band with energy R is the superconducting condensates of pairs. On the other hand, the band with energy + R represents quasiparticle excitations. am ong the lled bands, we have B = B (). [38] It im plies that the Chern numbers, C; , of the condensed band in the -direction, is given by the sum of the Chem numbers of the two vectors \Re i, (= 1;2) which are the eigenstates of the 2 2 ham iltonians

Now we have reduced the problem to calculate the Chem numbers of the eigenstates of the 2 2 matrices, <math>h_k$. By mapping from the two-dimensional Brillouin zone to the three-dimensional space, $T^2 = 3$ (k; k)! R, we obtain a closed oriented surface R (T^2). The wrapping degree of the map around the origin gives a charge of the D irac monopole sitting there. This is the Chem num ber C (k)[17,25].

For the present degenerate case, the m ap from a twodimensional point to two three-dimensional points T^2 3 (k;k)! fR =1;R =2gde nes(xing k) the surfaces fR =1 (T^2);R =2 (T^2)g which determ ine the two covering degrees of the m aps around the origins, N; (k), (= 1;2). They give the Chem numbers C; respectively. Since only the condensed states are lled for the superconducting ground state, the Chem num bers of the unitary states are given by

The Chern numbers de ned here for the unitary superconductors satisfy C (k) = 4 integer for the singlet order and C (k) = 2 integer for the triplet order. [39]

Nonunitary states. In these triplet states, there are no degeneracies in solutions of the BdG equation. There are four quasiparticle bands, which are classi ed by the q-helicity as

)u . As for the helicity q_k state, one can follow almost the same procedure and obtain the reduced BdG ham iltonian similarly. Here we can de ne several topological invariants. As discussed above, the states with



where $E_{n_{qq}}(k) = \frac{p_{j_k}\hat{j} + j\hat{u}_k\hat{j} + n_{q}}{j_k\hat{j} + j\hat{u}_k\hat{j} + n_{q}}$, $(n_q = q_k$ and $n_e = 0$. Then the standard Chem num ber $C^0(k)$ in the -direction for a xed k is obtained by the standard way [5].

A lso we have topological invariants in the -direction N^q(k). They are wrapping degrees around the origin of the map (k;k) ! $q(k) = q_k$, which de ne closed surfaces $q(T^2)$ in three-dimensions[17]. Further we have other topological invariants N (k), which are also wrapping degrees of the map around the origin, (k;k) ! R q(k). (The reduced ham iltonians are fi q = R q for the q-helicity g.)

Up to this point, topological argum ents have been applied to gapful cases. However, the nodal structure of the gap function is, in fact, characterized by the topological description. Form ally we have treated a threedimensional superconductivity as a collection of twodim ensional system s param etrized by, say, $k_{\rm z}\,.\,$ In R – space, closed surfaces parametrized by $(k_x; k_y)$ are generically away from the monopole at the origin. Askz is varied, the surfaces m ove around and they can pass through the monopole. Since the distance between a point on a surface and the monopole gives a half of the energy gap $E_{\alpha}(k_x; k_y; k_z)$, the gap closes at the value of k_z when the monopole is on the surface. Thus the nodal structure of the superconductivity is point-like generically if the tim e-reversal sym m etry is broken. W hen the Chern num ber jum ps as kz varies, the superconducting gap has to be closed due to topological stability of Chem num bers. Also a non-zero Chern number implies that the corresponding two-dimensional system has a non-trivial topological order. The superconducting node is considered as the critical point of the quantum phase transition between two states with di erent toopological orders.




FIG.1: Examples of closed surfaces $R_1 (T_{xy}^2)$ which are cut by the $R_Y = R_Z$ -plane. Them onopole is at the origin. $t = d_z = 1$, = 5: (a) $k_z = 0$, (b) $k_z = 2$ =5.

To make the discussion clear, let us take an exam ple $k = d_z^0 (\sin k_x + i \sin k_y) x$, $k = 2t(\cos k_z + i \sin k_y) x$ $\cos k_y + \cos k_z$) , (t > 0) [17]. This is an analogue of the Anderson-Brinkm an-Morel (ABM) state in ³H e super uid. For a xed value of kz, the surface is reduced to that of the chiralp-wave order parameter with a mod- $2tcosk_z$. (we can recover i ed chem ical potential, the ABM state, $d_k ! (0;0;d_z^0(k_x + ik_y))$ in the lim it of ! 6t + 0;k ! 0.) There are two quantum phase transitions which are accompanied by jumps of the Chern num berbetween 2 and 0 for 6t < < 2t. These correspond to the gap nodes at the north and south poles on the Fermi surface. In Fig. 1, surfaces $R_1(T_{xy}^2)$ are shown with the monopole at the origin. The Chern num ber jumps between 2 and +2 for 2t < 2t and 0 and +2 for 2t < < 6t.

For line nodes, we need additional constraints to keep the monopole on the closed surfaces when k_z is varied. To make a discussion simple, we take singlet order or triplet order with $d_x = d_y = 0$ and $d_z \notin 0$. Further let us require that the order param eters are real, namely we have a time-reversal symmetry. Then the closed surfaces in the R-space collapse into a board like region on the $R_X - R_Z$ plane and one can expect a situation where the monopole moves along the surface when k_z is varied.[25] Thus a line node appears in the superconducting gap. As shown in this example, the nodal structure of the superconductivity has a fundamental relation to topological order. The detailed discussion on this point will be given elsewhere.[26]
