Vortex lattices in rapidly rotating Bose-Einstein condensates: modes and correlation functions

A first delineating the physical regimes which vortex lattices encounter in rotating Bose-Einstein condensates as the rotation rate, , increases, we derive the normal modes of the vortex lattice in two dimensions at zero temperature. Taking into account elects of the nite compressibility, we not an inertial mode of frequency 2, and a primarily transverse Tkachenko mode, whose frequency goes from being linear in the wave vector in the slow ly rotating regime, where is small compared with the lowest compressional mode frequency, to quadratic in the wave vector in the opposite limit. We calculate the correlation functions of vortex displacements and phase, density and super uid velocities, and not that the zero-point excitations of the soft quadratic Tkachenko modes lead in a large system to a loss of long range phase correlations, growing logarithm ically with distance, and hence lead to a fragmented state at zero temperature. The vortex positional ordering is preserved at zero temperature, but the thermally excited Tkachenko modes cause the relative positional uctuations to grow logarithm ically with separation at nite temperature. The super uid density, dened in terms of the transverse velocity autocorrelation function, vanishes at all temperatures. Finally we construct the long wavelength single particle Green's function in the rotating system and calculate the condensate depletion as a function of temperature.

I. IN TRODUCTION

Under rapid rotation, a super uid form sa triangular lattice of quantized vortices carrying the angularm omentum of the system. Such structure was seen experimentally in super uid helium in Refs. [1]. Rapidly rotating Bose-Einstein condensates of cold atoms [2{4] open up the study of the physics of vortex lattices in regimes well beyond those achievable in super uid helium [5{7]. With increasing rotational frequency, condensates go through a number of dierent regimes. At small compared with the lowest compressional frequencies, sk $_0$, where s is the sound velocity and $k_0 = R_2$ is the lowest wavenumber in the nite geometry, with R_2 the size of the system perpendicular to the rotation axis, the system is in the "sti" Thomas-Fermiregime, and responds to rotation electively as an incompressible uid. As becomes larger than the lowest sound mode frequencies, $k_0 > k_0$, or essentially that the outer edge of the cloud moves supersonically, the system enters the "soft" Thomas-Fermiregime, where the compressibility becomes important in the response to rotation.

When, in harmonically trapped condensates, approaches the transverse trapping frequency, ! ?, the centrifugal force begins to balance the trapping force, and the system attens towards a lower density and therefore more compressible, two-dimensional cloud. For ms, where m is the particle mass, the condensate wave function becomes formed primarily of particle orbits in the lowest Landau level of the Coriolis force { the mean eld quantum Hall state [8] { with approximate order parameter, for rotation about the zaxis,

Prior to discussing the modes of the lattice, it is useful to lay out the dem arcations between the various regimes in a harm onically trapped gas. We assume that the interaction between the particles, of total number N, is described

by a repulsive s-wave interaction parameter $g = 4 a_s = m$, where a_s is the scattering length; we use units in which h = 1. In Thom as-Ferm i, the transverse radius, $R_?$, is given by [17],

where s(0) is the sound velocity in the center of the cloud. If we write $k_0 = -R_2$, where '5:45 [19], the criterion for being in the soft regime, that $-sk_0$ be large, becomes

The experim ents of Ref [5] on T kachenko modes reach = sk $_0$ 1:15.

The criterion to be in the mean eld quantum Hall regime, =m s² 1, can be conveniently written in terms of the lling factor, = N =N $_{v}$, where N $_{v}$ is the total number of vortices in the rotating cloud. Since

This result is independent of the number of particles, as long as the system is in the Thomas-Fermi regime. For the parameters $!_? = !_z = 8:3=5:2$ of the Tkachenko mode experiment of Ref. [5] in 87 Rb, we nd =ms(0) 2 ′ 200= $^{2=3}$ in the lim it $!_?$.

The vortex lattice supports a number of modes, rst discussed by Tkachenko [20] for a two-dimensional incompressible uid, and later in Ref. [21] at nite temperature with fulle ects of the normal uid, dissipation and Kelvin oscillations of the vortex lines in three dimensions. The low frequency in-plane Tkachenko mode is an elliptically polarized oscillation of the vortex lines, with the sem imapraxis of the ellipse orthogonal to the direction of propagation. The Tkachenko mode is linear at small wave vector, k, in the transverse plane,

where n is the particle density, and C_2 is the elastic shear modulus of the vortex lattice; at slow rotation, $C_2 = n = 8$. In the soft regime, the dispersion relation instead becomes quadratic [11,22],

Were it possible to rotate helium su ciently rapidly one would also see this very long wavelength quadratic behavior. Such T kachenko soft modes can play havoc with the stability of a large system, causing loss of long range phase coherence even at zero temperature; they are eventually responsible for the melting of the lattice [11]. In a recent paper [22] we derived the modes of the vortex lattice for all rotation rates, through constructing the conservation laws and super uid acceleration equation describing the long wavelength behavior of the system. In this paper we focus on deriving the correlation functions of density, super uid phase and velocity, and vortex displacements from equilibrium, which enable us to understand the elects of the soft infrared structure on the stability of the super uid and lattice. This work is a generalization of Ref. [23], which discussed the elects of the oscillations of the vortex lines at nite temperature in liquid helium on the long ranged phase correlations of the super uid. As we shall see, the long wavelength T kachenko modes lead to fragmentation of the condensate, even at zero temperature. We hether

the system loses phase coherence over its volume or the lattice melts rst depends on the number of particles in the system and its rotation rate.

In Sec. II, we review the basic equations describing the dynam ics, restricting the analysis to linearized motion in two dimensions, and neglecting the normal component of the super uid as well as dissipative terms. The analysis of the full three-dimensional problem will be published separately [24]. In Sec. III we construct the correlation functions of the physical quantities of interest, and in Sec. IV study the condensate depletion by constructing the single particle G reen's function for the rotating super uid.

II. CONDENSATE PHASE AND CONSERVATION LAW S

Let us rst recapitulate the conservation laws and equation for the super uid phase which govern the long wavelength behavior of the system. While much of this material has been given in Ref. [22], we include it here in order to facilitate the derivation of the correlation functions. The basic formalism given here applies to general bosonic super uids.

A . C ondensate phase

We work in the frame co-rotating with the lattice, and describe the deviations of the vortices from their home positions by the continuum displacement eld, (r;t). In linear order in the vortex displacements, the long wavelength super uid velocity, v(r;t), can be written, following Ref. [23], in terms of the long wavelength vortex-lattice displacement eld and the phase (r;t) of the order parameter, as

The origin of Eq. (9) is the law of conservation of vorticity, \hat{y} \tilde{r} v:

where here \sim tells the rate at which the vorticity moves about. Since under uniform rotation, $\$ = 2^{\sim}$, the time derivative of the curl of Eq. (9) is just this equation linearized. The longitudinal part of the left side of Eq. (9) is trivially the gradient of a scalar. Equation (9) constrains the number of degrees of freedom in two dimensions to four from the original ve $\{n, \forall, \text{ and } \sim$.

The time derivative of Eq. (9) is the super uid acceleration equation,

The dynam ics are specified by the conservation laws of particles and momentum, together with the super uid acceleration equation, (12). The continuity equation takes its usual form,

where n is the density and $j = n \cdot v$ the particle current. Conservation of momentum reads:

Here P is the pressure, and \sim is the elastic stress tensor, discussed below. At zero tem perature, \tilde{r} P = $n\tilde{r}$, while in equilibrium, \tilde{r} P + $n\tilde{r}$ V_e = 0. To calculate the displacement autocorrelation functions, we include here, as in [23], an external driving force, \sim (x;t), acting on the lattice, derived from an external perturbation H 0 = \sim \sim .

The elastic stress tensor is derived from the elastic energy density of the lattice, which in two dimensions has the form (in the notation of [21]),

where C_1 is the compressional modulus, and C_2 the shear modulus of the vortex lattice. The elastic constants are density-dependent properties of the uid. Then the elastic stress tensor, i, is given in terms of the total elastic energy, $E_{\rm el} = d^2 r E(r)$, by

where we allow for e ects of density gradients entering through the elastic constants. In an incompressible uid, $C_2 = n = 8 = C_1$. On the other hand, in the quantum Hall regime, the shear modulus is determined by the deviations of the interaction energy caused by distorting the vortex lattice, and [25]

in agreement with the shear modulus given numerically in [11]. Calculation of the elastic constants C_1 and C_2 over the full range of from the sti Thomas-Fermito the quantum Hall limits will be given in Ref. [25].

Equations (12), (15), (18), and (20) fully specify the problem for a trapped system with a non-uniform density.

C.M odes

In the following, we neglect e ects of non-uniformity of the equilibrium density for simplicity, and proceed to derive the modes as in [22]. The curl of Eq. (20) is

The rst mode is the standard inertial mode of a rotating uid; for s^2k^2 the mode is a sound wave, while for s^2k^2 , the mode frequencies begin essentially at twice the axial trapping frequency. This mode has been calculated in realistic trapping geometries in [28] and [29]. The second mode is the elliptically polarized T kachenko mode. Equation (22) in plies that the inertial mode is circularly polarized: $_{L} = _{T}$ ' i, and in the T kachenko mode, $_{L} = _{T}$ ' i! $_{T} = 2$; the small longitudinally polarized component is $_{T} = 2$ out of phase with the transversely polarized component. The present results for the modes are valid for a uniform system over the entire range of rotation frequencies, from the slowly rotating sti regime up to the melting of the vortex lattice. The Tkachenko mode has been calculated numerically for realistic trapping geometries in [19] in the sti limit and more generally in [30].

III. CORRELATION FUNCTIONS

We turn to determ ining the e ects of the lattice modes on the lattice ordering, and the phase coherence and condensate fraction of the rotating super uid. To do so we construct the correlation functions of the density, super uid velocity, vortex displacements, and phase from the dynamical equations in the previous section. All the correlation functions of interest, including the single particle G reen's function, can be written in terms of the density-density and displacement-displacement correlation functions. As expected, the f-sum rule is dominated by the high frequency inertial mode; the low frequency T kachenko mode dominates the compressibility sum rule [31].

The mean displacement is convergent at zero temperature. However, at nite temperature it diverges logarithmically with system size if the Tkachenko mode spectrum reaches down into the soft quadratic regime; then

converges at zero tem perature, and lattice preserves long range positional order at large separation; at nite tem perature, however, $h(\sim (r) \sim (f))^2$ i grows logarithm ically with separation, (T m =4 Z C 2) $\ln N_v$ (R), where N_v (R) is the number of vortices within radius R. In the sti T hom as-Fermilim it, this expression becomes (4 =nZ 2) $\ln N_v$ (R), where is the thermal wavelength; in the quantum H all lim it we have rather (20 4 =81) (T=m s 2) $\ln N_v$ (R).

Equation (47) m ay be used with a Lindem ann criterion to estimate the point where the lattice melts at T=0 in an extended system [10,11]. The zero temperature displacements are sensitive to the entire spectrum of modes up to the lattice D ebye vector, $k_d=(4\ n_v)^{1-2}$, whereas the mode frequencies derived here are valid only for $k=k_d$. For a rst estimate, we replace the integrand by its infrared limit, letting $d^2k=(2)^2+n_v$. Then using the Tkachenko frequency at rapid rotation, (32), we have

where $'=(1=n_v)^{1=2}$ is the radius of the W igner-Seitz cell around a given vortex, and we have used (19). The \1" term arises from the inertial mode, with equal contributions from the transverse and longitudinal displacements; the nal term arises solely from the soft T kachenko mode contribution to the transverse displacements. In order to take into account approximately the mode structure at larger wave vector, we include the kinetic term $r^2 n=4m$ in the pressure. In the non-rotating weakly interacting gas, this term modi es the linear spectrum, sk, into the full Bogoliubov spectrum, $E_k = (sk)^2 + (k^2=2m)^2$. Inclusion of such a term is equivalent to replacing s^2 by $s^2 + k^2=4m^2$ in the mode spectrum, with the elect of still ening the T kachenko mode at high wave vector. The condensate density, n_0 , is most conveniently found, a la 0 nsager-Penrose, as the limit of the single particle density matrix for large separation:

Note that the phase uctuations are more divergent in the infrared \lim it by a factor $1=k^2$ than the transverse displacement uctuations.

is . The phase correlations fall o algebraically at large R , as expected for a two-dim ensional system [34]. As the phase correlations decrease, the condensate fraction also falls, as $(n_0=n)$ $N_v^{=2}$.

The fallo of the phase correlations begins to become important for (=2) $\ln N_v > 1$, which translates e ectively into the condition in the quantum Hall lim it that $< 1.7 \ln N_v$, or $N < e^{0.6}$; for $N = 10^6$, the condition is that $N_v > 5 = 10^6$; for $N = 10^4$, $N_v > 10^3$; and for $N = 10^3$, one needs only $N_v > 10^2$ to and loss of phase coherence across the system .

One may ask whether the fallo is signicant by the time the lattice will have melted. The most divergent terms in the phase uctuations are induced by the transverse displacement uctuations in Eq. (58), so that in a system of transverse radius R₂, one has roughly,

The Lindem ann criterion, $h_T^2 i = {}^2 = 0.07$, implies that for $N_v > 10^3$ the right side of Eq. (65) exceeds unity at the melting point, setting the scale for number of vortices for which loss of long range order of the condensate prior to melting becomes in portant.

At nite temperature, the phase correlation integral (60) is logarithm ically singular in the infrared for all R, indicating that in two dimensions, the system is, as expected, no longer Bose condensed. The situation is the same as in the sti Thomas-Fermilimit, where the phase correlations in two dimensions diverge in the infrared, but in three dimensions fall algebraically with separation [23].

IV.THE SINGLE PARTICLE GREEN'S FUNCTION AND CONDENSATE DEPLETION

We now determ in the structure of the single particle excitations in terms of the modes of the lattice by constructing the long wavelength behavior of the single particle Green's function,

The contribution of the inertial mode (the nalterms) is always nite in two dimensions. However, the contribution of the Tkachenko mode in the soft limit (the rst term) leads to a logarithmic divergence of n^0 in two dimensions at zero temperature [11], and a quadratic divergence at nite temperature, thus destroying the condensation in an in nite system.

It is instructive, nally, to calculate the e ect of the lattice modes on the super uid mass density, $_s$, which is related to the transverse velocity autocorrelation function by [35]

that is, the super uid mass density vanishes. As discussed in [23] the lattice excitations replenish the sum rule (75), a re-ection of the fact that the moment of inertia of a rapidly rotating super uid is e-ectively the classical value [36]. The vanishing of $_{\rm S}$ is consistent with the behavior of G (k ! 0;0), which according to Josephson's sum rule should approach $_{\rm S}^{2}$ [35], while in fact G (k ! 0;0)! ($_{\rm S}^{2}$) (2m $_{\rm S}^{2}$).
