Optical R efractive Index of M assive Particles and Physical M eanings of Left-handed M edia

Abstract

In this Letter the expression for the refractive index of de Broglie wave in the presence of a potential eld is obtained and based on this, the physical m eanings of negative index of refraction is revealed. We demonstrate that the electrom agnetic wave propagation in a left-handed medium with negative refractive index behaves just like that of antiphotons, which is required of the complex vector eld theory. It is believed that the complex vector eld theory is helpful in considering the wave propagation and photonic band gap structure in the left-handed medium photonic crystals with a periodicity in negative and positive index of refraction.

M ore recently, a kind of arti cial com posite m etam aterials (the so-called left-handed m edia) having a frequency band where the e ective perm ittivity and the e ective perm eability are simultaneously negative attracts considerable attention of many authors both experin entally and theoretically [1{6,10,11]. In 1967¹, Veselago rst considered this peculiar medium and showed from Maxwellian equations that such media having negative simultaexhibit a negative index of refraction, i.e., $n = p^{p}$ [12]. It neously negative and follows from the M axwell's curl equations that the phase velocity of light wave propagating inside this medium is pointed opposite to the direction of energy ow, that is, the Poynting vector and wave vector of electrom agnetic wave would be antiparallel, i.e., the vector k, the electric eld E and the magnetic eld H form a left-handed system; thus Veselago referred to such m aterials as \left-handed" m edia, and correspondingly, the ordinary m edium in which k, E and H form a right-handed system may be term ed the \right-handed" one. O ther authors call this class of m aterials \negative-index m edia (N IM)" [13], \backward media (BWM)" [7], \double negative media (DNM)" [4] and Veselago's media. There exist a num ber of peculiar electrom agnetic and optical properties, for instance, m any dram atically di erent propagation characteristics stem from the sign change of the optical refractive index and phase velocity, including reversal of both the Doppler shift and Cherenkov radiation, anom alous refraction, amplication of evanescent waves [8], unusual photon tunneling [9], modied spontaneous emission rates and even reversals of radiation pressure to radiation

This original paper was translated into English by W H. Furry and published again in 1968 in the journal of Sov. Phys. U sp. [12]. Unfortunately, Furry stated erroneously in his English translation that the original version of Veselago' work was rst published in 1964.

tension [2]. In experiments, this articial negative electric permittivity media may be obtained by using the array of long metallic wires (ALMW s) [14], which simulates the plasm a behavior at microwave frequencies, and the articial negative magnetic permeability media may be built up by using small resonant metallic particles, e.g., the split ring resonators (SRRs), with very high magnetic polarizability [15{17]. A combination of the two structures yields a left-handed medium. Recently, Shelby et al. reported their rst experimental realization of this articial composite medium, the permittivity and permeability of which have negative real parts [3]. One of the potential applications of negative refractive index materials is to fabricate the so-called \superlenses" (perfect lenses): speci cally, a slab of such materials may have the power to focus all Fourier components of a 2D in age, even those that do not propagate in a radiative manner [8,18].

A number of novel electrom agnetic and optical properties in left-handed media result from the negative index of refraction. But what is its physical meanings? A lthough in the literature many researchers have investigated the negative refractive index of left-handed media by a variety of means of applied electrom agnetism, classical optics, materials science as well as condensed matter physics [1{6,10}, less attention than it deserves is paid to the physical meanings of negative refractive index. In this Letter we will study this fundamental problem from the purely physical point of view.

Before we consider the negative refractive index of left-handed media, we rst deal with the \optical refractive index" problem of de Broglie wave, the results of which will be helpful in discussing the form er problem.

For the case of de B roglie particle m oving in a force eld, we can also consider its \optical refractive index" n. A coording to the E instein-de B roglie relation, the dispersion relation of the de B roglie particle with rest m ass m₀ in a scalar potential eld V (x) agrees with

where is defined to be $=\frac{V}{h}$, and k, h and c stand for the wave vector, P lank constant and speed of light in a vacuum, respectively. It follows from Eq.(1) that

C om pared Eq.(3) with the dispersion relation $\frac{1}{k^2} = \frac{c^2}{n^2}$, one can arrive at

which is the square of ϕ are index of de Broglie wave in the presence of a potential eld .

It is of physical interest to discuss the Ferm at's principle of de Broglie wave in a potential eld V. One can readily verify that the variation $R cn^2 dt = 0$ can serve as the m athem atical expression for the Ferm at's principle of de Broglie particle (for the derivation of this expression, the readers m ay be referred to the Appendix). If, for example, by using the weak-eld and low-motion approximation where $\frac{1}{r} = 1$, $\frac{v^2}{c^2} = 1$ and $\frac{1}{r} = \frac{1}{r} eq.(4)$ can therefore be ignored, $1 = \frac{m_0^2 c^4}{h^2 r^2}$, then n^2 is approximately equal to

Thus in the non-relativistic case, Ferm at's principle, R cn²dt = 0, is equivalent to the follow ing well-known action principle R L (x;v)dt = 0 (di ering only by a constant coe cient $\frac{2}{mc^{2}}$), where the function L (x;v) = $\frac{1}{2}mv^{2}$ V (x) denotes the Lagrangian of massive particle in a potential eld V (x). Hence the above formulation for the \optical refractive index" of the de Broglie particle inside a potential eld is said to be self-consistent.

 refractive index of electron and positron by regarding the positron as the negative energy solution to D irac's equation, then we can classify the solutions of D irac's equation into the following four cases:

- (i) $E = E_+$, h = hk, $n = n_+$;
- (ii) $E = E_+$, h = hk, $n = n_+$;
- (iii) E = E , h = hk, n = n ;
- (iv) E = E , h = hk, n = n ,

where h, E_+ and E_- respectively represent the helicity, positive and negative energy corresponding to the electron and positron. It is apparent that the relationship between the cases (i) and (iv) is just the charge conjugation transformation. This transformation also relates the case (ii) to (iii).

C on pare the case of wave propagation in left-handed m edia with the results presented above, we can conclude that the negative optical refractive index in left-handed m edia corresponds to the antiparticles of photons (the so-called antiphotons). However, as is well known, there exist no antiphotons in free space. The theoretical reason for this is that the four-dimensional vector potentials A with = 0;1;2;3 are always taking the real numbers. But in a dispersive and absorptive medium, as an elective medium theory, the vector potentials A of which may probably take the complex numbers. Such complex vector edd theory has been considered previously [19]. Here the Lagrangian density is written $L = \frac{1}{2}F = F$, where the electrom agnetic edd tensors F = 0 A 0 A, F = 0 A 0 A with A being the complex conjugation of A. The complex four-dimensional vector potentials A and A describe the propagating behavior of both photons and antiphotons.

Now a problem left to us is that does the complex vector eld theory apply well in investigating the light propagation inside the negative refractive index medium. Detailed analysis will show that this theory is truly applicable to the consideration of optical index of refraction and wave propagation in left-handed media. This will be proved in what follows by using another mathematical form

for the M axwellian equations, where $M = {}^{p} - E + 1 - H$, $c_n = 1 = {}^{p} - F$, and are absolute dielectric constant and m agnetic conductivity of the medium, respectively. It can be easily veri ed that the M axwellian equations can be rewritten as Eq.(6).

If > 0 and > 0 are assumed, then the light propagation inside the isotropic linear right-handed medium (regular medium) is governed by Eq.(6). For the time-harmonic electrom agnetic wave in the right-handed medium, Eq.(6) can be rewritten

with ! being the frequency of electrom agnetic wave.

Now let us take the complex conjugation of the two sides of Eq.(7), and the result is of the form

where the eld M is expressed in terms of both electric and magnetic elds, E and H , i.e., $M = {}^{p}-E$ i H . Thus, we have

Multiplying the two sides of Eq.(9) by the imaginary unit i, one can arrive at

where the magnitude of c_n (i.e., $1 = p^{-}$) does not change but it can be rewritten as a new form $c_n = 1 = q^{-}$). According to Eq.(10), one can obtain the following relations

Note that here > 0, > 0. Thus it follows from Eq.(11) that the wave vector k, the electric eld E and the magnetic eld H of the electrom agnetic wave in this medium,

through which the elds E and H propagate, form a left-handed system. This, therefore, m eans that here the Poynting vector S is pointed opposite to the direction of the wave vector of electrom agnetic wave. For this reason, it is expected that the reversal of wave vector, instantaneous helicity inversion [20] and anom alous refraction will take place when an incident lightwave from the right-handed medium travels to the interfaces between leftand right-handed media. Since the direction of phase velocity and energy ow of lightwave propagating in the left-handed medium would be antiparallel, the change of wave vector k will truly occur during the light propagation through the interfaces. The inversion of k means that its magnitude acquires a minus sign, namely, the optical index of refraction n becomes negative since the magnitude of k is dened to be k = n! = c. In view of the above discussion, it is concluded that Eq.(10) governs the propagation of time-harm onic planar electrom agnetic wave, where the electrom agnetic elds are described by E and H .

Thus by making use of the complex vector eld theory we obtain a formulation which can treat the wave propagation in both right- and left-handed media. One of the advantages of the present formulation is that the minus sign of negative refractive index can be placed into the theoretical calculations by using the above unied approach rather than by hand. Such unied approach will be useful in dealing with the electrom agnetic wave propagation and photonic band gap structures in the so-called left-handed medium photonic crystals, which are articial materials patterned with a periodicity in negative and positive index of refraction.

To sum marize, we study the \optical refractive index" of de Broglie wave and reveal the physical meanings of negative refractive index in left-handed media. It is shown that the electrom agnetic wave propagation in negative refractive index media behaves like that of antiphotons, which requires that we should take into account the complex vector eld theory. This will provide us with a uni ed form ulation to treat the wave propagation in both left- and right-handed media.

Appendix

In this Appendix, we will discuss the Ferm at's principle of de Broglie wave. First we consider the relativistic free-particle case where the Einstein-de Broglie relation $(hk)^2c^2 = (h!)^2 = m_0^2c^4$ is utilized. By applying the dispersion relation $\frac{!^2}{k^2} = \frac{c^2}{n^2}$ to the Einstein-de Broglie relation, one can arrive at

and consequently derive

C on pared Eq.(A 2) with the relativistic energy-velocity form ula (with v being the particle velocity)

we obtain $n = \frac{v}{c}$. According to the original expression for the Ferm at's principle, i.e., ^R ndl = 0, where ndl is the \optical" path element with dl = vdt = ncdt, the Ferm at's principle for the de Broglie particle can be rewritten

In order to consider the wave propagation of the Broglie particle in a potential eld, we assume that the latter formula (i.e., $R cn^2 dt = 0$) in Eq.(A4) is still valid and would also apply very well in this case. It follows from Eq.(5) that this assumption truly holds at least for the non-relativistic case.
