Solution of voter m odel dynam ics on annealed sm all-world networks

A n analytical study of the behavior of the voter m odel on the sm all-world topology is perform ed. In order to solve the equations for the dynam ics, we consider an annealed version of the W atts-Strogatz (W S) network, where long-range connections are random ly chosen at each time step. The resulting dynam ics is as rich as on the original W S network. A temporal scale separates a quasistationary disordered state with coexisting dom ains from a fully ordered frozen con guration. is proportional to the number of nodes in the network, so that the system remains asymptotically disordered in the therm odynam ic limit.

I. IN TRODUCTION

The relationship between nontrivial interaction topologies and ordering phenomena is still a largely unexplored topic. The recent burst of activity on complex networks has revealed that m any technological, social and biological systems have interaction patterns m arkedly di erent from structures traditionally studied as regular lattices and random graphs [1, 2]. The interest is now focusing on how such complex topologies a ect dynam ical processes taking place on them . M odels of ordering dynam ics play an important role in this context, since they are commonly used to study social phenomena, like cultural assimilation and opinion dynamics [3, 4, 5, 6], for which the interaction patterns are more plausibly described by complex networks than by regular lattices.

Som e ordering processes on com plex networkshave recently been considered, including the zero tem perature G lauber dynam ics of the Ising m odel on the W atts-Strogatz network [7] and the A xelrod m odel on sm all-world and scale-free networks [8].

In a recent paper [9], we have studied num erically the dynam ics of the voter m odel on a small-world network. This structure, m ore precisely the W atts-Strogatz (W S) network [10], is one of the sim plest examples of complex topology. D epending on the parameter p (to be specified below) it interpolates between a one-dimensional lattice with periodic boundary conditions (for p = 0) and a random graph (for p = 1). It has been shown [10], that in a well de ned range of interm ediate values of p, the network has, simultaneously, global properties typical of random graphs (small average distance between nodes) and local properties (clustering) typical of regular structures.

The voter m odel is possibly the simplest m odel of an ordering process [11]. On each site a discrete variable is dened, that m ay assume two values (= 1) representing two opposite options, for instance the electoral choice in favor of two dimensional evolution: at each time step one site is selected at random and set equal to one of its nearest neighbors, chosen at random in its turn. On regular lattices, in d = 1 and d = 2 the model converges to an ordered state with all variables having the same value, whereas for d = 3 the system reaches a disordered stationary state [12, 13]. The voter model on complete graphs has been considered recently [14, 15].

In Ref. [9] we have found that the nontrivial connectivity pattern of the W S network has a deep impact on the ordering dynam ics of the voterm odel. In particular, after an initial transient, the system settles in a quasi-stationary state with coexisting domains. If the system size is in nite this state persists forever: at odds with naive expectations, long-range connections prevent complete ordering from being reached. If the system size is kept nite instead, the stationary state has a nite lifetim e and the fully ordered state is quickly reached at the end of it. Interestingly, the dependence of the lifetim e on the system size is such that the ordered state is reached earlier than on a one-dimensional

lattice of the same size. This partially restores the intuitive picture that long-range connections should speed up the ordering process.

In this work we analyze the same problem from the analytical point of view. The very simple form of the transition rates for the voter model results in equations of motion for the correlation functions that are not coupled with each other. The only di-culty is to carry out the average over trajectories for a - xed realization of the network and to average over the topology afferward. To overcome this problem we use an annealed approximation, consisting in averaging over the topology before averaging over the trajectories. This approximation is exact for an e - ective network, which we call annealed W S network, where long-range interactions are not quenched from the beginning but are extracted random ly at each time step. The dynamics of the voter model on the annealed W S network is then solved, revealing a phenom enology as rich as in the quenched case. By comparing the exact results on the annealed W S network with the num erical simulations on the quenched one, it turns out that the only discrepancy between the two cases is the dependence on the parameter p of the correlation length in the stationary disordered state.

The paper is organized as follows. In the next section we de ne precisely the voter model dynamics and the W S topology on which the process occurs. Section III is devoted to the analytical solution of the dynamics. The equation of motion for the correlation function is derived, the annealed approximation is introduced and the behavior of the system is studied. In section IV we check numerically the analytical results for the annealed case and compare them with simulations of the quenched case. In section V we extend the results to the case where each site is initially connected to 2 neighbors. The nal section contains a short discussion of the ndings.

II. THE MODEL

We consider a small-world network de ned as the superposition of a one-dimensional lattice of L sites with periodic boundary conditions and a random graph [16]. In general one can start from a lattice with each site linked to neighbors on the right and on the left. We now consider = 1, deferring the discussion of generic values of to Section V. More precisely, site i is initially connected with sites i 1 and i + 1. Then a link is added between any pair of non-nearest neighbor sites with probability p=L. In this way the total number of edges in the system is L + L(L - 3)=2 p=L, so that the average degree per site is nite (2 + p) in the therm odynam ic lim it L ! 1. The generalization to an initial lattice with connections to k nearest neighbors is straightforward. This topology slightly di ers from the one originally introduced by W atts and Strogatz [10] but has the same properties and is more am enable to analytical treatment. The topology is fully specified by the adjacency matrix Q (i; j), which is 1 if i and j are connected and 0 otherwise. The probability distribution of its elements is

The voter m odel dynamics is de ned by the transition rates. If we call f g the spin con guration of the system, that is f g = f₁; 2;:::; i; ::; L g and we indicate with f⁰g_i the same con guration with the i-th spin ipped, the transition rate from state f g to state f⁰g_i is, in complete analogy with the de nition for regular lattices,

III. ANALYTICAL TREATMENT

A. Equation for the correlation function

G iven the explicit expression (2) of the transition rates, from the master equation

one can derive [17, 18] the equation of motion for the mean spin at site j, $s_j = h_j i$

For p = 0, Eqs. (4) and (5) coincide with the equations for the one-dimensional voter m odel [13].

In order to study the dynam ics of the voterm odel on the W atts-Strogatz network we must average Eqs. (4) and (5) over the disordered topology. Indicating with an overbar averaged quantities $\overline{A} = \sum_{i;j} dQ$ (i; j) A = P[Q(i; j)], the equation for the mean spin is

Explicit formulas for the functions f_2 and f_3 are given in the Appendix. In the limit of large L they tend to the simple form s

The dynamical rule corresponding exactly to rates (9) is easily found. At each time step one site (site i) of a one-dimensional lattice is random by selected. Then, with probability f_2 (p=L;L 3) one of the two nearest neighbors (i+1 or i 1) is chosen and i is set equal to it. With probability (p=L) f_3 (p=L;L 4) instead, one random by chooses one of the other L 3 sites and sets i equal to it. In this way, the elective topology over which the dynamics takes place changes at each time step. We call such network \annealed" W S network. The average properties are those of the original \quenched" W S network, but no perm anent connection exists between non nearest neighbor sites.

W e can now write down the explicit form of the equations of motion for the mean spin and the correlation function on the annealed W atts-Strogatz network

For simplicity, here and in the following, the overbar is om itted. A loo the arguments of f_2 and f_3 will often be om itted.

Eq. (16) is complemented by the boundary condition $C_{j;j} = 1$ and by the initial condition $C_{j;k}$ (t = 0). We consider an initial fully uncorrelated state $C_{j;k}$ (t = 0) = $_{j;k}$. Hence the correlation function depends only on r = jj kj for all times and the equation of motion is

B. The stationary state

We now turn to the analysis of Eq. (17) and consider st the continuum limit in real space, yielding

C. Preasym ptotic dynam ics

We now study the equation of motion (17) in Fourier space by closely following the treatment for the Ising model on a one-dimensional lattice [19]. In this way, not only the stationary state but also the preasym ptotic dynam ics can be analyzed. Introducing

The rst term is negligible because t \cdot . Hence C (r) does not depend on time and decays exponentially with r. This is a quasi-stationary state with coexisting domains of xed size. Such a regime lasts for a time which diverges for L ! 1, so that in the therm odynamic limit the system remains asymptotically in this disordered state.

Fort instead, all \hat{Q}_k (s) vanish except \hat{Q}_0 (s) = L=s. Hence C (r) = 1 and the system becomes completely ordered. This is the asymptotic regime for a system of nite size.

Let us sum marize the results obtained in this section. We have solved the dynamics of the voter model on an annealed small-world topology: in this way we have found that nite systems remain in a disordered state for a time proportional to their size, and then converge to the totally ordered con guration; in nite systems instead reach a disordered nal stationary state, with a correlation function that decays exponentially over a distance $_{\rm p}$. For small values of p the correlation length $_{\rm p}$ diverges as p $^{1=2}$.




FIG.1: Main: Plot of the fraction of active bonds n_A for p = 0.1 and system sizes L 400, 600, 800, 1000, 1400, 2000 (from left to right) for the annealed case. D at a are averaged over 1000 di erent realizations. Inset: The duration of the plateau in the main part of the gure (symbols) plotted versus L. is evaluated as the time at which n_A drops below 0.01. The straight line is a power-law regression with best-t exponent equal to 0.98 0.03.




FIG. 2: M ain: Correlation function C (r) in the quasi-stationary state for a system of size $L = 10^5$ and p = 0.025 (sym bols), compared with the analytical prediction, Eq. (26) (solid line). Only one realization of the noise is considered. The agreement is excellent. Inset: The correlation length $_p$ obtained numerically from the decay of the correlation function C (r) in the quasi-stationary state of annealed W S networks with $L = 10^5$ (circles), compared with the analytical prediction, Eq. (27) (solid line), and the same equantity computed for the quenched W S network (squares).

IV. NUMERICAL RESULTS

In order to validate the analytical results presented above we have perform ed num erical simulations of the voter model both on the annealed and on the quenched W atts-Strogatz topology.

Figure 1 reports, for the annealed case, the tem poral behavior of the fraction n_A of active bonds, i.e. the fraction of nearest neighbor sites with opposite values of , for p = 0.1 and several values of L. A fler an initial decrease, typical of one-dimensional system s, a plateau sets in. The analytical treatment predicts such a preasym ptotic regime to last for an interval proportional to L. The inset of Fig. 1 con m s the analytical nding.

In the lim it L ! 1, the disordered state corresponding to the plateau becomes the asymptotic one. The analytical solution predicts an exponential form of the correlation function [Eq. (26)] with the correlation length $_{\rm p}$ given by Eq. (27). This analytical form is a very good approximation for the correlation function also for very large, but nite, values of L in the quasi-stationary regime (t <). This is shown numerically in the main part of Fig. 2. In the inset of the same gure we report the values of $_{\rm p}$ obtained numerically, which perfectly coincide with Eq. (27).

We have introduced the annealed version of the Watts-Strogatz network as an approximation for the WS network




FIG.3: Correlation function C (r) in the quasi-stationary state for a quenched W S network of size $L = 10^5$, p = 0.025 (circles) and p = 0.2 (squares). Only one realization is considered. The solid lines are exponential ts.

with quenched topology. Hence it is interesting to compare the results of the two cases to understand how well the approximation captures the behavior of the original system. In Ref. [9] we have already performed a numerical investigation of the voter dynamics on the quenched W S topology. By comparing the results reported in Ref. [9] and the theoretical approach presented here, we see that the annealed approximation correctly reproduces many of the important features of the original system, i. e. the existence of a regime with a disordered state before full order sets in and the linear dependence on L of the temporal scale between them. C oncerning the shape of the nal correlation function in the case of in nite quenched networks, Fig. 3 shows that C (r) is exponential, another feature that is the same in the annealed and the quenched cases. W hat the annealed approximation is not able to capture is the quantitative dependence of the correlation length on p. This is shown in the inset of Fig. 2, where it is clear that, for small p, p 1 in the quenched system [9], while p 1¹⁻² in the annealed case.

V. EXTENSION TO > 1

In the previous sections we have considered an initial one-dimensional lattice with each site connected only to its nearest neighbors. When the number of neighbors connected to each site is > 1, one can quite easily extend the analytical calculations presented above. On physical grounds one expects the qualitative picture to remain the same. A loo form ulas are very similar. In general they involve, in the place of f_2 and f_3 the functions f_2 (p=L;L 1 2) and $f_2 + 1$ (p=L;L 2 2). The equation for the average totalm agnetization becomes




FIG. 4: Main: Plot of the fraction of active bonds n_A for L = 3000 and p = 0.05, p = 0.025, p = 0.01 and p = 0.008 (from top to bottom) for the annealed case. D at a are averaged over 1000 di erent realizations. Inset: The duration of the plateau in the main part of the gure (symbols) plotted versus p. is evaluated as the time at which n_A drops below one tenth of the value during the plateau. The straight line is a power-law regression with best-t exponent equal to 0.47 0.03.

Again the only solution for nite L is the completely ordered state C (r) = 1, while in the therm odynamic limit C (r) = exp[(p)r]. The correlation length is

For what concerns the preasymptotic dynamics, the only form alchange in Eq. (29) is that f_3 is replaced by f_{2+1} , but now the form of k is dimensional event

By applying the Laplace transform one gets an equation form ally equal to Eq. (36). For generic we cannot perform explicitly the integral appearing in Eq. (36) and hence we cannot write down the analogue of Eq. (37). However, we can guess that the only change will be the replacement of the factor $1=2^{p}$ with some other factor independent from L. Therefore the existence of two regimes separated by a temporal scale proportional to L will be preserved. M oreover, on physical grounds, we expect the proportionality factor to scale as p¹⁼² also for generic. To comm this, we have performed numerical simulations of a system with next-nearest neighbor connections (= 2). The results, presented in Fig. 4, comm the expectation. The temporal scale separating the quasi-stationary disordered state from the totally ordered com guration scales as Lp¹⁼². We can conclude that the behavior of the voter model on the small world topology is qualitatively the same, regardless of the number of connections between neighbors.

VI. CONCLUSIONS

In this paper we have studied analytically the voter model on the smallworld topology. We have considered an annealed version of the W atts-Strogatz network, where long-range connections are not xed, but chosen random ly at each time step. In this way each realization of the voter model dynamics takes place in an elective average smallworld topology and this allows the exact solution of the equation for the correlation function of the system.

The dynam ical behavior of the model on the annealed topology is very similar to the behavior on the quenched W S network. Systems of nite size converge asymptotically to a totally ordered frozen state after an interm ediate quasi-stationary stage, characterized by a nite correlation length. The duration of this preasymptotic regime is proportional to the number of sites. Hence systems of in nite size never reach the ordered state and remain in a

disordered stationary state with nite dom ain size. All these features are exactly the same both on the annealed and on the quenched versions of the network. A quantitative di erence arises only in the dependence of the correlation length p on the probability p of having a long-range connection. This discrepancy is not surprising, since a similar disagreem ent between the annealed and the quenched case has been noted previously for di usion on W atts-Strogatz networks [20] and the voter model is well known to be related with st passage properties of random walkers [18]. In that case, the crossover time separating short and long time behavior of the mean number of distinct sites visited scales as p 2 in the quenched network and as 1=p in the annealed one. This di erence is due to the fact that in the quenched case a walker has to di use over a distance 1=p before reaching a shortcut and deviating from the one-dimensional behavior. This clearly requires a time p². In the annealed case instead, the time needed to perform a long-range jump scales as 1=p. In the voterm odel on sm all-world topology the boundaries between ordered dom ains perform a one-dimensional random walk for short times. The behavior changes when the walkers make a long range jump. As mentioned above, this requires a time 1=p in the annealed network and p^2 in the quenched one. This di erence generates the di erent scaling of the correlation length in the two types of topology.

D expite this discrepancy the voterm odel dynam ics on sm all-world networks is relatively insensitive to the quenched or annealed nature of the topology. An interesting question for future work is whether this insensitivity extends also to other ordering processes on other com plex networks.
