A ngle-resolved photoem ission study of quasi-one-dim ensional superconductor $-N a_{0:33}V_{2}O_{5}$

We have studied the electronic structure of $-Na_{0:33}V_2O_5$, which becomes a superconductor under pressure, by angle-resolved photoem ission spectroscopy. Clear band dispersions is observed only along the chain direction, indicating the quasi-one-dimensional (1D) electronic structure. The spectra of the V 3d band are dominated by a Gaussian-like broad feature at 1 eV below the Fermi level (E_F) with negligible intensity at E_F , which we attribute to strong electron-phonon coupling as in other 1D polaronic metals. In the momentum space, the spectra show a maximum intensity at k = 4b, where b is the V-V distance along the b-axis, relating the band lling of the chain and/or ladder.





FIG. 1: Crystal structure of -vanadium bronze $A_x V_2 O_5$. Schem atic drawing of the V1 zigzag chain and the V2 ladder is also shown.

The recent discovery of superconductivity $(T_{C} = 8 \text{ K})$ under high pressure (8 GPa) in -Na_{0:33}V₂O₅ attracted considerable interest¹ because this is the rst observation of superconductivity in vanadium oxides and because the superconductivity occurs in a quasi-1D conductor analogous to organic superconductors. -N a0:33 V 20 5 belongs to a class of -vanadium bronzes which have highly anisotropic crystal structures as shown in Fig 1. There are three kinds of V sites denoted by V1, V2, V3. The V10₆ octahedra form a zigzag chain along the baxis, the V 20 6 octahedra form a two-leg ladder, and the V 30 5 pyram ids form a zigzag chain. Previously, this compound had been studied from the view point of a bipolaron conductor.² Recently, Yam ada et al.³ found that a metal-insulator transition (MII) occurs at T_{MI} = 135 K and that above $T_{M I}$ it shows metallic conductivity along the chain direction (the b-axis). Itoh et al.4 found by an NMR study that this metal-insulator transition is accompanied by a charge ordering below $T_{M I}$. They also discussed the population of delectrons at each vanadium site and concluded that the V3 is V^{5+} -like while the V1 and/or V2 are in a mixed-valence state. Nishim oto and 0 hta studied charge ordering by M ardelung potential calculations and found that electrons enter the V1 zigzag chain in the most stable charge distribution⁵. The superconductivity in this material invoked considerable interest also because of possible roles of poralons or electron-phonon interaction in the superconductivity. The electronic structure is also interesting from the view point of one-dim ensionality.6,7

In this Rapid C ommunication, we report on an electronic structure study of $-Na_{0:33}V_2O_5$ using angle-resolved photoem ission spectroscopy (ARPES).We have found that the V 3d band has a Gaussian-like broad line shape and its peak does not cross E_F even in the m etallic phase. In the momentum space, on the other hand, the maximum intensity of the V 3d band occurs at k = 4b although in the vicinity of E_F , the intensity is

suppressed. W e shall discuss the origins of these unusual spectral behaviors in the context of 1D m etal under the strong in uence of polaronic e ect.

Single crystals of $-Na_{0:33}V_2O_5$ were grown by the rf heating C zochralski m ethod as described in Ref. 1. Photoem ission m easurements were performed using a G amm adata-Scienta SES-100 electron analyzer and a G amm adata-Scienta VUV-5000 He discharge lamp with a toroidal grating m onochromator. The energy calibration and the estimation of the energy resolution were made by m easuring gold spectra. The energy resolution






FIG.3: A R P E S spectra of $-N a_{0:33} V_2 O_5$ taken at 160 K.The vertical lines indicate peak positions or in ection points.

and the momentum resolution were set at 25 meVand 0.2 near E_F and 40 meV and 0.4 otherwise. The base pressure of the analyzer chamber was 5

10¹⁰ Torr. C lean surfaces were obtained by cleaving the sample in situ. The reproducibility was checked by repeated cleaving and measurements.

Figure 2 shows the spectra in the entire valence band region taken with He I (h = 21.2 eV) and He II (h = 40.8 eV) at norm alem ission. The structures at 2.5-8 eV binding energies (E_B 's) are originated from the 0 2p band while the weak feature at E_B ' 1 eV is originated from the V 3d states. Because there is only one V 3d electron per six vanadium atom s, the intensity of the V 3d band is extrem ely weak. Am ong the three structures in the 0 2p band, A, B and C, structure B is enhanced in the He II spectrum com pared to He I, indicating that this structure is strongly hybridized with the V 3d states since the relative photoionization cross section of the V 3d states to the 0 2p states is larger for the He II spectra than for the He I spectra.⁸

Figure 3 shows the angular dependence of the spectra taken at 160 K. The left panels (a) and (c) show the spectra with momentum along the chain (b-axis) while the right panels (b) and (d) show the spectra with momentum perpendicular to the chain (i. e., along the c-axis). The vertical lines in the 0 2p band indicate local m inim um positions in the second-derivative of the spectra while those in the V 3d band indicate peak positions and the in ection points determ ined by the rst and second derivatives, respectively. C lear dispersion can be seen only along the chain direction both for the 0 2p and the V 3d bands. Structure B is the most strongly dispersive in the 0 2p band probably because this structure is most strongly hybridized with the V 3d states as mentioned above. The V 3d band has a broad line shape and the peak position is located at E $_{\rm B}$ $0.9~{\rm eV}$. The dispersional width is $0.25~{\rm eV}$.

The peak position of the V 3d band in -N a0:33V 2O 5 is closer to E_F than that in the related insulating vanadates NaV₂O₅ (E_B 1.5 eV, Ref. 9) and L_{205} (E $_{B}$ 1:3eV, Ref. 10) with d¹ electronic con guration, re ecting the smaller band lling or the lower E_F in the present com pound. How ever, the intensity is suppressed near E_F and the peak does not disperse su ciently to allow the band crossing E_F . The ARPES spectra of a quasi-1D conductor (TaSe₄)₂ I, which shows a CDW transition at 160 K, as reported by Perfettiet al^{12} also show a similar behavior in its m etallic phase and only the tail of the Ta 5d band reaches E_F . They interpreted this characteristic spectral feature of (TaSe₄)₂I in terms of a polaron picture¹³ because electron-phonon interactions are obviously important in CDW systems such as (TaSe₄)₂I. In fact, for -Na0:33V205 strong electron-phonon coupling had been proposed.² The Gaussian-like broad feature of the V 3d band and the sm all spectral weight at E_F m ay therefore be attributed to strong electron-phonon coupling. The high resistivity (10^{2} cm) for a m etalm ay indicate that electron-phonon interaction is very strong and that the charge carriers are mobile sm all polarons.¹⁴




FIG. 4: (a) Intensity plot of ARPES spectra near E_F in the E-k plane. The vertical arrows indicate k = =4b. (b) M om entum distribution curves. Dashed curves are tted Lorentzians and the vertical lines indicate their peak positions. (c) Energy distribution curves.

The intensity plot of the ARPES spectra near E_F in the E-k plane is shown in Fig. 4 (a). One can see that the contour lines become closest to the E_F at k =4b. From the tting of the momentum distribution curves (MDCs) to two Lorentzians, as shown in Fig. 4 (b), their peak positions indicated by the vertical bars are (0.22)

0.02) =b (=4b), where b is the V-V distance along the b-axis of the zigzag chains or of the ladder (see Fig. 1

(b)), and depend on E_B only very weakly (corresponding to the Ferm i velocity of > 10 eV A). This means that although most of the spectral weight of the V 3d band is con ned in the Gaussian-like broad peak centered 0.9 eV and the Gaussian peak does not cross at E_B $E_{\rm F}$, there are underlying strongly dispersive features and their Ferm i surface crossings at k ' =4b. Strongly dispersive weak feature crossing E_F has been observed in a double-layer metallic manganite La_{1:2}Sr_{1:8}M n₂O₇ (R efs. 15,16), where the spectra are also dom inated by a broad Gaussian-like peak at higher binding energy and a very weak feature reaches and cross $E_{\rm F}$. To explain this unusual spectral behavior, a polaron m odel has been proposed.15,16

The occurrence of the maximum intensities at k '

=4b is contrasted to the corresponding feature in the insulating NaV_2O_5 (Ref. 9) and LiV_2O_5 (Ref. 10), whose band maximum and hence the maximum intensity near E_F occurs at k ' =2b. The smaller value k ′ =4b in the present compound should be related to the smaller band lling of the chains and/or ladders in $-Na_{0;33}V_2O_5$. Based on this observation, in the following we discuss possible band lling of the V1 zigzag chain and the V2 ladder for several cases depending on the relative strength of the nearest-neighbor and nextnearest-neighbor V-V hopping in the chain and the relative strength of the V-V hopping within the rung and within the leg of the ladder. First, we consider the case where the bonding within the rung and the nearestneighbor hopping in the zigzag chain are strong. If the doped electrons enter the V 3d orbitals only of the ladder, the ladder would become quarter-lled (1/2 electron per V2 site) and the band lling would be similar to N aV_2O_5 . In the high tem perature phase of N aV $_2$ O $_5$, because the

bonding orbital of the rung is occupied and the antibonding orbital is empty, the quarter-lled ladder e ectively behaves as a half- lled 1D chain, and the ARPES spectra are well reproduced by the half- lled 1D t-J m odel or Hubbard model¹¹, resulting in the band maximum =2b. We expect the same situation for the at k = quarter-lled ladder in -Na):33V2O5. If the doped electrons enter only the zigzag chain, the chain would be quarter- lled and the Ferm i-level crossing (and hence the intensity maximum) would occur again at k = =2b. (Note that there are two V1 atom s per b.) If 50% of doped electrons go into the zigzag chain (resulting in the 1/8- lled zigzag chain) and the remaining 50% go into the ladder (the 1/8- lled ladder), Ferm i-level crossing would occur at k ==4b, consistent with experiment. In this case, the band lling of the chain and ladder is determined by a subtle balance between the energy levels of the chain and the ladder and therefore m ay vary sensitively under high pressure. Electrons m ay be transferred between the zigzag chain and the ladder under high pressure as in the hole-doped ladder system $Sr_{14 x} Ca_x Cu_{24}O_{41}$ (Ref. 19), which also shows a pressure-induced superconductivity.

Second, we consider the case where the bonding within the rung of the ladder is weak or the nearest-neighbor hopping in the zigzag chain is weak compared to the next-nearest-neighbor hopping in the chain. Indeed, the bonding within the rung of the ladder in $-N a_{0:33}V_2O_5$ m ay be weaker than that of $N aV_2O_5$, because the V-V distance is longer: 3.6 A for $-N a_{0:33}V_2O_5$ versus 3.45 A for $N aV_2O_5$. In that case, the ladder or the zigzag chain can be regarded as two independent single chains. Therefore, if 50% of doped electrons go into one of the two independent chains and the remaining 50% go into another chain, these chains become quarter-lled single chains and the intensity maximum would occur at k = -4b near E_F . Hence, electrons may enter both of the ladder and the zigzag chain, or may enter either the ladder or the chain, because that ladder or zigzag chain consists of two quarter-lled chains. The existence of quarter-lled single chains is analogous to the quarter-

lled quasi-1D band in organic superconductors such as Bechgaard salts. 18

Since $-N\,a_{0:33}V_2O_5$ is shown to be a 1D m etal above $T_{M\ I}$ (= 135 K), we have attempted to analyze the photoem ission spectra within the Tomonaga-Luttinger (TL) liquid frame work. In Fig. 4 (c), energy distribution curves (EDCs) nearE_F are shown for them etallic phase. A sm entioned above, the intensity is suppressed nearE_F, which is a characteristic of a TL liquid. The line shape is approximately parabolic for allmomenta. Therefore, the anom alous exponent is at least 2 in the present system, 7,21 extremely large compared to other 1D conductors ($\leq 1).^{22,23,24}$ Note that the Hubbard model predicts < 1=8 (Ref. 17). O ne possible origin of the large

is that electron-phonon interaction is strong compared to other systems. Another possibility is that the longrange C oulomb interaction is unscreened because there are few conducting carriers. Theoretically, it has been shown that if long-range interaction exists, the exponent

can be any large value.²⁰

Finally, we brie y comment on the temperature dependence of the spectra across $T_{M \ I}$. The leading edge of the V 3d band is shifted toward higher binding energies by 15 m eV in going from the metallic to insulating phases, taken at 160 K and 100 K, respectively. We have also studied changes in the band dispersion from the peak positions and the in ection points [Fig. 3 (c)]. We could not, however, observe clear change from those plots across $T_{M \ I}$.

In conclusion, we have studied the electronic structure of $-N a_{0:33}V_2O_5$. The band dispersion is nite only along the chain direction, indicating the quasi-1D electronic structure. In spite of the metallic conductivity, the V 3d band has a Gaussian-like broad feature whose peak does not cross the Ferm i level. We attributed this to the strong electron-phonon coupling in the quasi-1D metal. In the momentum space, the V 3d band show sm axim um intensities at k =4b, due to a Ferm i-level crossing or a valence-band maxim um . Based on this observation, we have discussed possible band lling of the zigzag chain and the ladder in $-N a_{0:33}V_2O_5$.
