Steady-state and equilibrium vortex con gurations, transitions, and evolution in a mesoscopic superconducting cylinder

A numerical scheme to study the mixed states in a mesoscopic type-II superconducting cylinder is described. Steady-state con gurations and transient behavior of the magnetic vortices for various values of the applied magnetic eld H are presented. Transitions between di erent multi-vortex states as H is changed is demonstrated by contour plots and jumps in the B vs H plot. Evolving a uniform ly-superconducting initial state using the sim plest set of relaxation equations shows that the system passes through nearly metastable intermediate con gurations, while seeking the nal minimum energy, steady state consistent with the square symmetry of the sample. An e cient scheme to determ ine the equilibrium vortex con guration in a mesoscopic system at any given applied eld, not limited to the symmetry of the system, is devised and demonstrated.

I. IN TRODUCTION

The electrom agnetic characteristics of type-II superconductors have been of great interest, particularly since the discovery of high-temperature superconductors. Furthermore, a recent surge in interest about nano-technology, has drawn the attention of researchers from various disciplines to a detailed understanding of the characteristics of m esoscopic superconducting sam – ples. Several phenom enological theories have been developed during decades of superconductor research, one popular choice is the G inzburg-Landau theory.^{1,2} Its tim e-dependent extension is known as T in e-D ependent G inzburg-Landau (TDGL) theory.³

In the G inzburg-Landau theory, the electrom agnetic state of a superconductor can be determ ined by solving a system of partial di erential equations. It was discovered by A brikosov that if the parameter that appears in the equations, now known as the G inzburg-Landau parameter, is larger than $1=\frac{1}{2}$, then when a bulk superconductor is placed in a su ciently large magnetic

eld, the magnetic eld penetrates the superconductor in the form of singly-quantized vortices. A round each vortex ows a supercurrent,⁴ con ning a single quantum of magnetic ux within it. Superconductors with this property are known as type-II.

Here we present the result of a numerical study about the magnetization process inside a superconducting cylinder with sub-micron lateral dimension in an external magnetic eld. We have restricted the work to a square cross section of a linear size equal to 4.65 times (the magnetic penetration depth). A typical value for is about 500 A , and then the cross-sectional area is about 0.054 $\,$ m 2 .

P revious works on the magnetization of a mesoscopic superconductor without pinning centers have been reported by Peeters et al. 5^{{8} and others^{9;10}, who have presented extensive calculations on the superconducting state in mesoscopic, type-I, superconducting thin Ims. In most cases they found transitions between giant vortex states of di erent circulation quantum numbers L, with som e multi-vortex states occasionally appearing as therm odynam ically stable states, but mostly as metastable states. These predictions appear to have already received som e level of experim ental con mation, although som e discrepancies still exist¹¹. ($\mathbb{R} \in \mathbf{f}^{10}$ have mainly compared the energy of a "3-2" vortex-antivortex molecule state with that of a single o -centered vortex state at L = 1, as both evolve to the equilibrium state of a single vortex at the center.) M isko et al.¹² have studied both type-I and type-II m esoscopic trianglular cylinders, and have shown that a vortex-antivortex m olecule appears only if the sample is type-I. They considered only one eld value at which L = 2 is favored, and did not consider vortex con gurational transitions as the eld changes 13 .

O ur aim is to simulate how vortices enter and settle in stable arrangements when a mesoscopic type-II superconductor of a given symmetry is rst cooled below the critical temperature, and then an external magnetic eld is applied. This is often termed zero eld cooling (ZFC). We nd that only vortex numbers and con gurations consistent with the sample symmetry can appear in this case. It is known that there exist global minimum -energy vortex con gurations with reduced symmetry, correspondingly to nal equilibrium states at general values of the applied eld. To nd these equilibrium states we developed, and demonstrate here, an e cient num erical scheme.

Our approach is to solve a set of simplied (and discretized) TDGL equations, in which the coupling to the electric eld is neglected, and the superconducting order parameter and the magnetic eld are assumed to relax with the same time scale. These assumptions are not physical, but are acceptable here, since we are only interested in obtaining the nalsteady-state vortex con gurations, and the sym m etry-related qualitative behavior of the transient con gurations and their evolution. (For a m ore physical set of TDGL equations see T inkham³. For an example of num erical solution of such a set of TDGL equations, see^{14} .) However, since the equations we have solved do not contain any therm al uctuation term s, and the sample we considered has a perfect square symmetry, we nd that when starting with the M eissner state with no eld penetration, then the nal steady-state vortex con gurations we obtain all have perfect square symmetry, with vortex numbers also limited to only multiples of four (the symmetry number). These con gurations would correspond to physical situations under zero- eld cooling, if the physical sam ple has indeed perfect sym m etry, and the tem perature is su ciently low, so that thermal uctuations are not able to overcom e any energy barrier for vortex entry, expulsion, or rearrangem ent. How ever, if the sample surface has slight in perfection, or if the tem perature is not su ciently low, then these con-

gurations are, in most cases, not in equilibrium at the given magnetic eld strength. Even the vortex number m ay not be correct. However, if we insert into the equations terms to simulate thermal uctuation, as in the m ethod of simulated annealing, $^{15;17}$ then the simulation program will take a much longer time to run, and may become impractical even with a supercomputer. So we have devised an e cient scheme to nd the equilibrium vortex con gurations: W e solve the same set of relaxation equations without any thermal uctuation terms. But instead of starting the solution with the Meissner state as the initial state, we devise arti cial initial states with a given number of vortices in random positions. W e present analytic expressions for such initial states, in terms of a widely known approximate expression for a singly-quantized vortex in cylinder coordinates. Then for vortex num bers not too di erent from the equilibrium num ber, the nal steady states obtained by solving our relaxation equations will, in most cases, have the num ber of vortices close to those of the initial states. By com paring the total G ibbs energies of these steady states with di erent vortex num bers som etim es we obtain more than one con guration for the same vortex num ber, (when the vortex number exceeds four,) then their Gibbs energies are also compared we can nd the state with the lowest total G ibbs energy, which we identify as the equilibrium state with the equilibrium vortex num ber. W e give an explicit dem on stration of this schem e^{18} ,

that might be very useful in view of the recent interest in nanoscience and nanotechnology. In some nanoapplications one may need to nd the equilibrium vortex con gurations in a mesoscopic superconducting sam – ple, at di erent applied magnetic elds. We note that in a bulk sample vortices like to form a triangular lattice. Thus, when the sample does not conform with this symmetry, and if the sample is su ciently small so that the boundary elect on the equilibrium vortex con gurations is in portant, then the system is frustrated, and the equilibrium vortex con gurations can be quite intriguing, and di cult to forese. The scheme devised here is then very convenient and useful for nding the answer!⁶

II. T IM E-DEPENDENT G IN ZBURG-LANDAU MODEL

In an external magnetic eld H , the G ibbs free energy density g of a superconducting state is given by³

where f_n is the free energy density in the norm al state in the absence of the ekl, is the com plex-valued order param eter, with the superscript * denoting com plex conjugation, A the magnetic vector potential, h = r A the induced magnetic ekl and H the applied magnetic ekl. The supercurrent density is expressed as $J_s = r$ r $A = \frac{e_s h}{2 \, (m_s} (r r) \frac{e_s^2}{m_s c} j j^2 A$. In the above e_s is the "e ective charge" of a C cooper pair which is twice the charge of an electron, and m_s its "effective mass" which can be selected arbitrarily, but the conventional choice is twice them assofan electron. A lso, c is the speed of light, and h = h=2 where h is P lanck's constant.

G inzburg-Landau theory postulates that the G ibbs free energy of a superconducting sample , G (;A) =

gd is at a minimum in the superconducting state. The celebrated G inzburg-Landau equations are obtained by minimizing this functional with respect to and A using the variational principle.

Since a constant term does not change the end result of the variational technique, an algebraic manipulation is made to subtract f_n and add H H = 8 to the g above, giving¹⁹

W e obtain the dimensionless gauge-invariant free energy functional (om itting primes for convenience),

The simplied TDGL model we employ to nd solutions of the static GL equations may be viewed as a gradient ow with the energy functional. That is, the variation of (;A) w.r.t. time should be in the opposite direction of the gradient of the energy functional, $\frac{\theta}{\theta t} = \frac{\theta G}{\theta}$, $\frac{\theta A}{\theta t} = \frac{1}{2} \frac{\theta G}{\theta A}$ with time, t, in units of the only relaxation time of the equations. The natural boundary conditions are: (1) the continuity of the parallel component of the magnetic eld across the boundary surface: (r A) n = H n, (for two-dimensional problem s only, see below) and (2) the vanishing gauge-invariant norm alderivative of : $\frac{r}{2}$ (A n = θ_{r}^{0} , with n denoting the outward surface norm al.

III.D ISCRET IZAT ION AND CALCULATION PROCEDURE

For long cylindrical samples, we need only solve a 2-D problem. We take A = (A (x;y);B (x;y);0) and H = (0;0;H) where $H = (r A)_z = \frac{@B}{@x} \quad \frac{@A}{@y}$.

De ning the link variables as below, the gauge invariance is preserved in discretizing the G ibbs free energy and the consequent TDGL equations. W e discretize the free energy functional on a staggered grid in shown in Fig. $1^{21;22}$ This gives us a secondorder approximation in h_x and h_y to the continuous energy functional, where the h_x and h_y are the spatial increments in the x- and y-direction. The staggered grid




FIG.1. Staggered Grid

also leads to a satisfactory way of discretizing the natural boundary conditions.²³ For a rectangular grid, the rst component of the vector potential is constant in time on one pair of the edges of the boundary, and the second component is constant in time on the other pair.²⁰

In this paper, we assume that the cylindrical superconductor has a square cross-section and is subject to an applied eld along the cylindrical axis. The applied eld is assumed to be constant in time. We further assume the order parameter varies in the cross-sectional plane of the cylindrical sample, and the vector potential A has only two nonzero components (A;B), which also lie in this plane. We also assume that the superconductor has no pinning sites. Then at steady-state conditions, the vortices settle in maximal distances due to the repulsion of each other. This requirement leads to triangular lattice of vortices in an in nitely large dom ain³.

In the staggered grid the lattice points for , A, and B are all di erent, with evaluated at the node center (i,j), A evaluated at the east cell face (i+ 1/2, j), and B evaluated at the north cell face (i,j+ 1/2). A coording to Refs. 21,22, this form ulation keeps second order accuracy in the derivative evaluations as they appear in each of the discretized equations.

Now the discrete TDGL is obtained by m in imizing the discrete energy functional G_d with respect to the variation in and A as

The nite di erence equations are solved by the Euler m ethod with $h_x = h_y = 0.15$ and t = 0.05, and taking = 4. In the num erical computations that follow, everything is kept the same except for the strength of the applied magnetic eld and/or the initial conditions.

IV.STEADY STATES UNDER ZERO-FIELD COOLING IN A PERFECTLY SQUARE SAMPLE AT LOW TEMPERATURES




FIG.2. Plots of j $\frac{2}{J}$ [left gures in (a) through (k)] and h = r A [right gures in (a) through (k)] for various H.

We rst solve the above set of equations assuming that the initial state is the perfect M eissner state with no eld penetration. A sexplained in the introduction, this corresponds to applying a magnetic eld after zero-eld cooling. Fig. 2 shows the plots of j j^2 [the left gure in (a) through (k)] and h = r A [the right gure in (a) through (k)] for the nal steady states reached at a sequence of increasing H values. In the left gures j j^2 , which is interpreted physically as the density of C ooper pairs, runs from 0 to 1, the level 1 corresponding to the full superconducting state. Each isolated group of contours is called a "vortex" representing the supercurrent J circling around the vortex core, with = 0 at the vortex core. In the 3-D plots of Fig. 2 (b), it is clear that the vortices reach close to j $\hat{j} = 0$ at the core.

Note that the number of vortices increases in multiples of 4. This is a consequence of the fact that the vortices are sym m etrically created at the m id-points of the sam ple edges. Perfect sym metry in the sam ple geometry dictates that each side creates an equal num ber of vortices. The symmetry manifests itself in this geometry-dominated problem, and vortices arrange them selves in the squaresymmetric con gurations. The resultant steady states are mostly not true equilibrium states since the vortex arrangem ents do not re ect the intrinsic tendency of vortices to form a triangular lattice known to appear in bulk sam ples. The natural next step is to add a therm al uctuation term to nd the true equilibrium states which may or may not conform with this symmetry. This approach would then be like simulated annealing.^{15;17} However, we believe it would not be practical to perfect this approach since it will likely be di cult to determ ine the appropriate rate of cooling and starting tem perature. The runtime of the computer program might also be expected to be much longer than we have found here. So we have devised a di erent approach which we believe is much more e cient for nding the equilibrium states. This is given in a later section. W e shall see that even the cases with low number of vortices are not the true equilibrium . A lso of interest is the fact that for som e H the vortex con quration has a much more di cult time to settle down, needing much longer run-times to get to a steady state. G com etry controls the settling tim em ore than the energy in these cases.

O ur results are sum m arized in Table 1, which lists the range of H for each possible number of vortices and the induced magnetic eld $B = \frac{1}{j j}$ hd. The H's listed correspond to the threshold values for each range. They were found on a trial-and-error basis, and can be rened to any desired accuracy. Below H = 0.839, there is no vortex. Between H = 0.84 and 1.144, the vortex number n = 4, and so on. Of course, these thresholds change as we change the sam ple size. For exam ple, if we double the length of each side, H = 1.0 gives n = 36.

magnetic eld B for the applied magnetic eld H.




FIG.3. plotted is B as a function of H .

The B vs H plot is shown in Fig. 3, and reveals an abrupt increase in B between the regions of di erent number of vortices. For example, when H changes from 1.144 to 1.145, B changes from 0.977913 to 1.069432. If the limit H ! O is taken, we expect a sudden con gurational phase transition increasing the number of vortices, as is apparent in Figs. 2 (c) and (d). Such m ini-

rst-order transitions are known to occur in a m esoscopic superconductor as H is changed, 5^{9} but the details are quite di erent, because di erent parameter () regimes and sample geometries (cylinder vs. Im) are studied.

P hase transition is also evident in the n = 12 case, where the vortex con guration shows a sudden change in arrangement even with the same number of vortices for a slight increase of the applied eld from H = 1.454 to H = 1.455.

In the B vs H plot, B is much lower than H when the number of vortices is small, but as the vortices increase, the curve approaches the B = H curve asymptotically. So for the given sample, the number of vortices and B increase as the applied magnetic eld H increases. This rejects the fact that the vortices are a form of magnetic penetration.

V.TIME SEQUENCE SHOW ING VORTEX ENTRY DYNAM ICS




FIG. 4. Time sequence of vortex-entry dynamics for H = 1:145.

Fig. 4 show splots of C ooperpair density for H = 1:145in time. The number of vortices is 8. The perfect symmetry in the sample geometry dominates the transient process, but in the middle of the process the whole conguration makes a rotation to rearrange itself into a new con-

guration. (Note that time advances from 3000 to 17500 between the 8th and 9th frames.) The nalresult is still

a square-symmetric con guration. We note that during the rotation process the vortex con quration loses some m irror symmetries of the sample but still preserves the 90 rotation symmetry. So these transient states do not possess the full sym m etry of the sam ple. W e think that this is possible because our num erical method has very weekly broken the sample symmetry. That is, we think that the state just before the rotation is a metastable state only within the subspace of con gurations preserving the full sym m etry of the sam ple. Thus, in the actual physical situation when the sam ple has perfect sym m etry and the tem perature is su ciently low this rotation may take a very long time to take place. For samples with im perfect sym m etry this relaxation tim e m ay be shorter. Since this is a symmetry-induced qualitative property of the vortex-entry dynam ics in a m esoscopic superconductor, we believe its general validity is independent of the fact that we have obtained it by solving a simpli ed set of TDGL equations which are not truly physical.

VI.STEADY STATES W ITH REDUCED SYMMETRY AND THE EQUILIBRIUM STATE

The previous sections present solutions for a mesoscopic type-II superconducting cylinder with initially no vortex inside the system. The validity of such solutions also requires a perfectly square sample without any defect at the boundary, and tem perature su ciently low, so that therm al uctuations are too weak to help the system nd lower-energy con gurations of reduced sym metry. This is an ideal condition, producing only solutions consistent with the sample sym metry, and, even during the transient, the system is bound to this sym metry (except in rare cases when the transient solutions can keep only fourfold rotation sym metry but not mirror sym metries | See Fig. 4). In principle, one can reproduce this ideal system in a laboratory with special care.

In real situations there most-likely exist some small defects or perturbations at the boundary. Then vortices can enter the system asymmetrically to produce steady-state congurations with reduced symmetry of lower total G ibbs energy than any symmetric solution. A strong enough thermal uctuation could also change the vortex number and rearrange the vortices to such a conguration. In previous work, to take into account these perturbations, a random uctuation term was added to the governing equation.²⁴ This term breaks the symmetry governing the equations, energizing the system to jump out of the local minima in energy, and over the energy barrier.³ But this increases the computing time greatly. (This method is basically what is called \simulated annealing^(15;17) in computer science.)

As an alternative approach, we employ perturbed initial conditions instead of the perfectly superconducting initial condition, and is similar to Peeters et al.^{7,5} but with a new idea introduced to make the num erical scheme much more e cient:

We have rst used random ly perturbed initial conditions. They can indeed lead to nal steady-state solutions with reduced symmetry and lower energies. But we nd this way is very ine cient for nding the equilibrium state at any given H. We have also tried to use a lower-symmetry con guration from such a calculation as the initial condition for a new H value, but nd that the vortex number can often be trapped in an uncontrollable non-equilibrium value due to the existence of surface energy barriers against vortex entry or exit. So thism ethod of adopting an existing solution as the initial condition can not be reliably used to nd the true equilibrium state in a given system and eld. (Peeters et al. changes the eld in sm all steps to avoid this di culty²⁵, but we believe the procedure to be unnecessarily tedious.)

To obtain the true equilibrium vortex con guration at any given magnetic eld without employing some sim – ulated annealing method, we have devised a system atic approach to generate initial states with given num bers of vortices at random distributions. It is through an analytic expression as follows: First, for one vortex at the origin in circular coordinates (r;), we use the widelyknown approximate expression²⁶^{{28}</sub>

C onverting it to C artesian coordinates, we can move the center of the vortex to any arbitrary position $(x^0;y^0)$ by

simply replacing (x;y) by $(x x^{0}; y y^{0})$. Denoting this expression as $x^{0};y^{0}(x;y)$, an n-vortex expression can be simply constructed as








FIG.5. The initial, random vortex con gurations [left gure in (a) through (o)], and the corresponding steady-state vortex con gurations they evolve to [right gure in (a) through (o)].




FIG.6. The steady-state G ibbs free energy for various ${\sf n}$.

This expression obeys the important topological condition that the phase of must increase by 2 when any one vortex center is circum navigated. The magnetic eld inside the sample does not obey any topological condition, so it can be simply set equal to zero for the initial condition. The positions of the vortices can be generated using random number generators, only if they are inside the sample. This idea may seem to be simple, but it appears to have not been employed before. W e illustrate below such initial conditions to obtain steady-state vortex con gurations of any given num bers of vortices n. Comparing the total G ibbs energies of such solutions of di erent n, we can then determ ine the equilibrium vortex num ber and con guration. For illustrative purposes, we consider the case H = 0.840. In Fig. 5, the initial conditions for with 1 through 8 random ly-placed (arti cial) vortices [the left gures in (a) through (o)], and the steady-state vortex con gurations they evolve to [the right gures in (a) through (o)], are shown. The corresponding G ibbs free energies of these steady states are plotted in Fig. 6 as a function of the vortex number n. The minimum energy con guration at n = 5 is seen to display the square-symmetry of a ve-vortex con guration with a vortex in the center. A lthough we have not yet applied this scheme to other eld values, the method we have devised to nd the equilibrium vortex con gurations for a given size and shape of the sample and di erent values of the external magnetic eld should now be clear.


VII.SUM MARY AND CONCLUSION


A num erical scheme to study the mixed states in a mesoscopic type-II superconducting cylinder in a


longitudinal external magnetic eld H has been developed. It is based on solving a set of simpli ed tim edependent G inzburg-Landau equations. W e have rst applied this scheme to the case of eld penetration into a zero- eld cooled sam ple. Case studies for various values of the external magnetic eld are presented. Contour plots of the Cooper pair density, and the induced magnetic eld inside the sam ple, display the magnetic vortex solution rst discovered by A brikosov, but in a sm all sam ple the vortex arrangem ent is not sim ply triangular. G iant vortices and anti-vortices are not found in this study, unlike previous studies of type-I mesoscopic thin Ims. (But at su ciently high magnetic eld we still expect the system to favor a single giant vortex at the center as it goes into a surface superconducting state, but only if the sample is not too small.) Since we start the solution with a uniform ly superconducting initial condition,




















































and the sample has perfect square symmetry, both the num ber of vortices and their steady-state con gurations are governed by the square sample geom etry. Changes in the con guration and the number of vortices occur as H is varied through st-order con gurational phase transitions, sim ilar to those found earlier, but di erent in detail. This phase transition characteristic is con med by the contourplots, and jum ps in the values of the induced magnetic eld B at certain discrete H values. A time sequence shows that the system passes through interm ediate con gurations, and remains in some of them for a long time, eventually settling down to the steady-state con guration, which corresponds to the lowest-G ibbs-energy con guration consistent with the symmetry constraints to the vortex number and con guration. One could nd the true equilibrium states, (which would appear in actual samples, when there are symmetry-breaking surface defects as vortex-nucleation centers, or when thermal uctuation is su ciently strong to move the system out of m etastable states, but not too strong to melt the vortex lattice,) by adding additional terms in the equations to simulate thermal uctuations, but here we have devised a di erent approach which we believe is more e cient. W e introduce a way to generate analytic initial states of prescribed numbers of vortices, but allow their positions to be random . They evolve to steadystate vortex arrangem ents of all possible vortex num bers near the equilibrium number, from which we can compare total G ibbs energy to determ ine the equilibrium vortex number and con guration. In this way we can avoid the problem of surface and bulk energy barriers, which can trap the system in non-equilibrium vortex numbers and con gurations an undesirable situation which usually happens if one chooses the initial state random ly without controlling the vorticity quantum number L.
