Controlling a mesoscopic spin environment by quantum bit manipulation

We present a united description of cooling and manipulation of a mesoscopic bath of nuclear spins via coupling to a single quantum system of electronic spin (quantum bit). We show that a bath cooled by the quantum bit rapidly saturates. A Ithough the resulting saturated states of the spin bath (\dark states") generally have low degrees of polarization and purity, their sym metry properties make them a valuable resource for the coherent manipulation of quantum bits. Specifically, we demonstrate that the dark states of nuclear ensembles can be used to coherently control the system-bath interaction and to provide a robust, long-lived quantum memory for qubit states.

An intriguing challenge for modern science and technology is the coherent manipulation of quantum systems coupled to realistic environments. Interest in these problems is in part due to fundamental aspects of quantum control and decoherence, but this research has also been stimulated by recent developments in quantum information science [1]. Although over past decades much progress has been made in the controlled manipulation of isolated atom ic and optical systems [2], the complex environment of a solid-state system makes it signicantly more challenging to achieve a similar degree of control.

This Letter demonstrates that a single quantum system (qubit) can be used to prepare and control a m esoscopic environment, turning the bath into a useful resource. We consider a system consisting of a single electronic spin in a semiconductor quantum dot interacting with a mesoscopic bath of nuclear spins within the conned volume. Recently it has been shown that cooling the spin bath to high values of polarization and purity greatly reduces the associated decoherence [3]. Furtherm ore, due to the bath's intrinsic memory, it can be used as a long-lived quantum memory for qubits and for quantum state engineering of collective nuclear states [4]. However, achieving a high degree of nuclear polarization in a quantum dot remains a major experimental challenge. Most ideas under exploration use the hyper ne contact interaction to couple polarized electron spins to the bath. Some work in situ, using either spin-polarized currents [5] or optical pum ping [6, 7]. O ther techniques use a di erent geometry for cooling, such as quantum Hall edge state tunneling near a quantum point contact [8].

We focus on in situ manipulation, when the qubit degrees of freedom are them selves used to cool nuclei. We show that such a qubit-based cooling process rapidly saturates resulting in non-thermal states of the nuclear bath with low polarization and purity. However, the symmetry properties of such \dark states" allow for complete control of the qubit's interaction with the environment. We illustrate this by showing that the mesoscopic bath prepared in saturated states can be used to provide a

long-lived quantum memory for qubit states. A combination of adiabatic passage techniques and spin-echo results in near unity storage delity even for the bath with vanishingly small polarization. Before proceeding we also note that the idea of using qubit states to cool the environment is now widely applied in atom ic systems such as trapped ions [9] or microw ave cavity QED [10].

A simple Ham iltonian can describe a single electron spin con ned in a quantum dot interacting with an applied external magnetic eld B_0 and with N spin- I_0 surrounding nucleivia the hyper ne contact interaction:

The hyper ne interaction is split into a eld aligned (O verhauser) component $\hat{V}_{zz} = a\hat{A}_z\hat{S}_z$ and a Jaynes-Cum m ingstype component, $\hat{H}_{JC} = a=2\,(\hat{A}_+\,\hat{S}_-\,+\hat{A}_-\,\hat{S}_+)$, where $\hat{A}_-=\frac{P}{k}_k\hat{T}_-$, $k=N\,v_0\,j\,(r_k)\hat{J}_-$ is the weight of the electron wavefunction at the kth lattice site, and a is the per nucleus hyper ne interaction constant.

Nuclear degrees of freedom are cooled by cycling spin-polarization through the quantum dot. A spin-down electron is injected from leads connected to a polarized reservoir or by m eans of optical excitation. It interacts for some short time , and then is ejected / recombined. Each iteration can cool the bath by ipping a nuclear spin through \hat{H}_{JC} . If the energy dierence of the injected electron spin and the ipped electron spin, $h~i=(g~_B~_{g_i~_n})B_0+ah\hat{A}_z~_1i$ is large compared to the inverse time of interaction, 1 , energy conservation considerations block the spin- ip process. However, changing the applied eld to maintain h~i~1~ allows cooling to continue e ciently [7].

Regardless of the exact details of the process, cooling will saturate. The system is driven into a statistical mixture of \dark states" \(\mathbb{D} \) i, de ned by \[7 \]

To cool past this point of saturation, either dark states must couple to other states of the bath or the geom et-




FIG. 1: Saturated state polarization P versus initial thermal polarization P_0 for N = 100 (dotted), 300 (dashed) and 10^3 (solid). Inset shows entropy per spin.

ric coupling coe cients $_{\rm k}$ m ust change. When these mechanisms are slow compared to the cooling rate, an appropriate mixture of dark states well-approximates the steady state of the bath.

The homogeneous case illustrates the essential features of cooling. With k = 1, we can rewrite \hat{A} as a collective nuclear angular m om entum vector \hat{J} , and correspondingly, \hat{J}^2 becomes a conserved quantity. The Dicke basis, characterized by total (nuclear) angular m om entum J (0;1=2)N=2), its projection into the z axis m J, and a quantum number associated with the permutation group , is then appropriate [11]. The operator \hat{J} changes neither J nor , but nuclei in a state $iJ; m_J; i are cooled to the state with lowest <math>m_J$ (dark state) jJ; i. For an initial therm albath of nuclei with polarization Po, the corresponding steady state solution is found by sum ming over J m_J J. Tracing over , we nd

with = $2 \tanh^1 (P_0)$. D (J) denotes the number of quantum numbers allowed for a given J and is independent of m $_J$. In the case of spin-1/2 nuclei, D (J) = $_{N=2}^{N}$ $_{J}$ $_{N=2}^{N}$ $_{J}$. The resulting nuclear polarization P and Von Neumann entropy associated with the \cooled" ensemble are shown in Figure 1 as a function of initial therm alpolarization P_0 . The di erences shown in Fig. 1 between the therm aland saturated baths become snegligible for large N , but the dynamics of the two baths di er dram atically. In essence, even though the purity and polarization are low, the symmetry properties of the dark states restricts evolution of the combined electronic nuclear system , analogous to a two-level system .

We illustrate the reversible nature of the coupling between dark states and the single spin by showing how a quantum state can be stored into collective nuclear states. An arbitrary qubit state j i = uj"i + vj#i will be mapped into the bath states. With just a pure state jJ; Ji, spin-down is decoupled entirely, while spin-up couples nuclei to the collective state jJ; J + 1i with a Rabi frequency $_{J} = a$ 2jJ $_{J}$. As

the motion is given by the cyclic dynam ics of a two-level system . Near resonance (\uparrow_1^2 ij. j_J^2), the qubit will oscillate fully between electronic and nuclear states. For high polarization P this is in direct analogy to the case discussed in Ref. 4. However, for low P, all states of the mixture must be in resonance; the range of J with signi cant probability goes as the width of the binomial distribution, \overline{N} , while the width of the resonance, given by h $_J$ i=a, goes as \overline{P} \overline{N} . In this regime, the resonance is much narrower than the range of populated J states.

This problem can be solved with adiabatic passage. By sweeping the detuning from far negative to far positive, the system passes through the series of avoided crossings and for each J

A diabatic passage is not sensitive to the exact value of the coupling constant (Rabi frequency) between individual pairs of levels, and is robust provided the sweep rate of the detuning is su ciently slow.

In general, the relative phase $_J$ accumulated depends on the details of the detuning sweep. Sweeping the detuning back reverses storage, but the nal state, ($u\hat{e}^{i\ J}$) j" i+vj#i) jJ; Ji, has an additional non-trivial phase which reduces the nalo -diagonal matrix element of electronic spin density matrix: "# = $uv [_J n (J)e^{2i J}]$. Spinecho avoids this strong dephasing by exactly compensating the adiabatically acquired phase [12]. An example sequence is presented in Table I. The two waiting segments should be symmetric, to compensate for other arbitrary J-dependent phases [13]. Thus a mixture of saturated states can be used as an ideal quantum memory.

In practice, the electron-spin decoherence rate \lim its the minimum speed of the adiabatic sweep, the induced error scaling as p ' T with T as the characteristic duration of the storage procedure. For a saturated ensemble state, T ' 4h $_{\rm J}$ i= , where = h-i is the rate of change of the detuning. A ssum ing a tangent-like pulse shape [14] we not that the non-adiabatic probability of ip is given by

The saturated state lifetime, the storage lifetime, and the maximum polarization are limited by nuclear spin dephasing. Spin discussion due to dipolar nuclear coupling is the dominant term for this dephasing in G aAs and is on the order of 6 $10^4~{\rm s}^{-1}$ [15]; this rate also provides an estimate for the rate of heating from the proximal thermal spins. Active correction pulse sequences such as W HH-4 can lead to sub-Hz decoherence rates and lowered spin discussion [16]. Finally, we note that these results generalize to higher spin by using the appropriate multinomial form of D (J) [17].

We now extend these results to realistic inhom ogeneous coupling between electrons and nuclei by developing a one-to-one mapping between the explicit hom ogeneous Dicke basis and its inhom ogeneous equivalent. Dicke states of the form jJ; J; i in the individual spin basis are written

Furtherm ore, \hat{J} is invariant under permutation so there exists a representation for dark states where every individual spin con guration is equally probable, i.e. \dot{j}_{U_j} ; (fig) $\hat{j}=\dot{j}_{U_j}$; (fjg) $\hat{j}=\sum_{N=2}^{N}$. Using this explicit representation for hom ogeneous dark states, we construct a mapping to the more general inhomogeneous case (A \hat{J}) (n;)i = 0). For each dark state \hat{J} ; $\hat{J}=n$ N=2; i, its inhom ogeneous counterpart is

as can be checked by direct calculation. The exact form of the norm alization constant N $_{0;0}$ is de ned below .

To quantify inhom ogeneous e ects, rst we note that $\hat{A} = \hat{A}_+ + \hat{A}_$

Non-zero $_{n}$ indicates that an inhom ogeneous equivalent of \hat{J}^{2} is not conserved under inhom ogeneous raising and lowering operators. Second, inhom ogeneous dark states are also not eigenstates of \hat{A}_{z} , i.e. $\hat{V}_{zz} p$ (n;)i = $_{n} p$ (n;)i+! $_{n} p$ (n;)i, where

If the sym m etry breaking term s ($_n$;! $_n$) are sm all relative to $_n$, cooling will proceed in a manner similar to the hom ogeneous case. The nal state density matrix should then be of the type $^{\circ}=_{n}$; (n) $\mathcal D$ (n;) ih (n;) j. When $_n$ and ! $_n$ are small we can use Eqn. 3 as an estimate for (n). As before, cooling proceeds quickly to the point of saturation, then slows down to a rate governed by the inhom ogeneous transfer of dark states into other states.

A diabatic transfer of a quantum state follows the prescription for the hom ogeneous case. However, the symmetry breaking terms lead to additional errors. When now the rate of transfer is given by now the nal state is an admixture of \mathfrak{p} (n;)i and \mathfrak{p} (n;)i, leading to an error of order $\frac{2}{n} = \frac{2}{n}$. The error from $!_n$ we estimate in the worst case by considering it as an incoherent loss mechanism. The extrince decoherence rate become $e^{\text{eff}_{pn}} = \frac{1}{n} \cdot \frac{1}{n} + \frac{1}{n}$, the spin-decoherence rate optimization used for the hom ogeneous case holds, and the resulting probability of error for the full sequence goes as $3=2(e^{\text{eff}_{pn}}=n)^{2=3}$. Combining these, the total probability of error goes as

We now consider adiabatic transfer errors num erically. The explicit form of the inhom ogeneous dark states (8) allows us to express the relevant parameters as functions of the geometric coupling constants, $_{\rm k}$:




FIG. 2: (a) $_{\rm n}$ (solid), ! $_{\rm n}$ (dotted) and $_{\rm n}$ (dashed) versus number of ipped spins n with N = 7280. Values are averaged over every 20 n values and scaled by $_{\rm 0}$ = A = $\overline{\rm N}$. (b) A verage values of $_{\rm n}$ = $_{\rm 0}$; ! $_{\rm n}$ = $_{\rm n}$, and $_{\rm n}$ = $_{\rm n}$ vs. N .




FIG. 3: Expected error of transfer and recovery for the inhomogeneous case versus nalpolarization P for N = 4145 (dotted) and 18924 (solid). Linset shows the error due to $!_n$ (dotted) and $_n$ (dashed), and total error (solid) for N = 18924.

To estimate the required N , we average over a statistically signicant fraction of the allowed fightor each n sublevel. The $_{\rm k}$'s are drawn from an oblate Gaussian electron wavefunction of ratio (1;1;1=3), and we omit spins with $_{\rm k}$ < 1=N . We plot the three parameters $_{\rm n}$; $_{\rm n}$; $!_{\rm n}$ versus n in Figure 2. The perturbative treatment used above is justiced as $_{\rm n}$. $!_{\rm n}$; and $_{\rm n}$ for all n. It also shows that increasing N in proves this ratio.

In Figure 3 we plot total probability of error for the saturated mixture as a function of the nal saturated polarization P . We used an estimated hyper ne contact interaction an '2 10^{10} s ¹ and 6 10 s ¹. In all cases, adiabatic transfer requires a small change of effective eld (' 100 m T) over 10–100 ns, which could be implemented through g-factor engineering [18] or spindependent optical stark shifts [7]. For 10^4 nuclei, delities better than 0.8 are possible with realistic spin decoherence rates even with vanishingly small polarizations. The error decreases further with increasing N .

In conclusion we have demonstrated that electron spin

qubits can be used to e ectively prepare and manipulate a local nuclear spin environment. Specifically, long coherence times and high delities for the storage of electron spin states into nuclear spins can be achieved provided the same qubit is used for the cooling process. Such \coherent" cooling and storage is effective for nuclear spin preparation due to their long coherence times. Related techniques can be used for engineering quantum states of nuclear spins from a saturated bath state [4, 19]. We further note that the techniques described in the present letterm ay be applicable to other systems involving mesoscopic spin baths. For example, we anticipate that similar methods may be used to prepare the local environment of superconducting qubits.

- [12] The necessity of spin echo can also be understood by considering the spin-wave modes, $\hat{J}_{+}^{k} = \int_{-j}^{p} e^{ik \cdot x_{j}} \hat{I}_{+}^{j}$. The cooling process only cools the completely symmetric mode $(\hat{J}_{+}^{(k=0)})$, while \hat{V}_{zz} couples the spin to all modes, dephasing the electron spin state. Spin-echo exactly cancels the \hat{V}_{zz} evolution. We note that in the faronesonant (large energy ective eld) regime, \hat{V}_{zz} is the only relevant system both coupling, and thus dephasing is reversible.
- [13] Even without adiabatic transfer and at low eld, a spinecho pulse train applied faster than h $_{\rm J}$ i $10^8 {\rm s}^1$ will entirely cancel phase and spin-exchange evolution, thereby decoupling electron spin from nuclei and completely suppressing nuclear spin-related dephasing.
- [14] The pulse is of the form (t) = ($_{\rm i}$ + $_{\rm f}$)=2 + ($_{\rm i}$ $_{\rm f}$)= $_{\rm 1}$ tan[(t T=2+ $_{\rm 2}$)=2+ $_{\rm 3}$] with param eters $_{\rm 1;2;3}$ set to give proper starting and ending detunings,
