Presence of 3d Quadrupole Moment in LaTiO₃ Studied by 47;49TiNMR

 $^{47;49}\, T$ iN M R spectra of LaT iO $_3$ are reexam ined and the orbital state of this compound is discussed. The NMR spectra of LaT iO $_3$ taken at 1.5 K under zero external eld indicate a large nuclear quadrupole splitting. This splitting is ascribed to the presence of the rather large quadrupole m oment of 3d electrons at T i sites, suggesting that the orbital liquid model proposed for LaT iO $_3$ is inappropriate. The NMR spectra are well explained by the orbital ordering model expressed approximately as 1= $\frac{1}{3}\,(d_{xy}+d_{yz}+d_{zx})$ originating from a crystal elde ect. It is also shown that most of the orbital moment is quenched.

The orbital degree of freedom has become an important topic in the physics of strongly correlated electron system s[1]. One of the recent topics is a quantum elect in the orbital ordering dominated by electron correlations. Especially, Mott insulators with t_{2g} degenerated orbitals are prospective in this viewpoint, since the Jahn-Teller (JT) coupling for t_{2g} orbitals is weaker than e_g states and the large degeneracy enhances the quantum elect.

The RT iO 3 (R rare earths) system is fascinating from the above view point [2, 3, 4, 5, 6]. RT iO $_3$ has an orthorhom bically distorted perovskite structure (space group: P_{bnm}), in which the electronic con guration of a T i^{3+} ion is t_{2a}^{1} . W hile several studies have reported that YTiO3 takes an orbital ordering state from both experim ental and theoretical aspects [5, 6, 7, 8, 9, 10, 11], the orbital state in LaT iO $_3$ is now under controversy [2, 3, 12, 13, 14]. LaT iO 3 undergoes G-type antiferrom agnetic ordering below T_N 150 K with the reduced ordered m om ent of 0.46 B [15]. The question is what interaction lifts the degeneracy of threefold t2g orbitals in the ground state. The octahedra of TiO_6 in LaTiO $_3$ exhibit small distortions. One would expect, at rst sight, quadruply degenerated single-ion ground states represented by ctitious angular m om entum = 3/2 due to spin-orbit (SO) interaction, which have unquenched orbital moment. This scenario is consistent with the observed reduced magnetic moment. However, Keimer et al. suggested that the SO interaction is not dom inantly working in this system from the isotropic spin wave dispersion [2]. Under these circum stances, a picture of strongly uctuating orbital states was proposed [2, 3], followed by a rened calculation on the orbital excitations[4]. On the other hand, M ochizuki and Im ada have successfully explained the physical properties of LaTiO 3 by an orbital state expressed approximately as $1=3(d_{xy}+d_{yz}+d_{zx})[12]$. Subsequently, corresponding distortions of the TiO 6 octahedra have been reported from detailed structural data [13, 14].

In this paper, we report the results of analyses on NMR m easurem ents for LaT iO $_3$. The NMR spectra show that the quadrupole moment of a 3d electron in LaT iO $_3$ is

rather large and unfavorable for the orbital liquid m odel, while the spectra are well explained by the 1= $\frac{1}{3}$ (d_{xy} + d_{yz} + d_{zx})-like orbital ordering state with appropriate param eters.

Experim ental procedures are mentioned in Ref.10. It is known that the magnetic properties are particularly sensitive to the oxygen content in LaT iO $_{3+}$ [15]. We used powdered samples with the Neel temperature $T_{\rm N}$ 147 K (0.0) for NMR measurements. Frequency-swept NMR spectra of LaT iO $_{3}$ were taken point by point of frequency by using a super-heterodyne coherent pulsed spectrometer at 1.5 K in the antiferromagnetically ordered state under zero external eld. As for the properties of 47 T i and 49 T i nuclei, the nuclear spin 47 I = $\frac{5}{2}$ and 49 I = $\frac{7}{2}$, the quadrupole moment 47 Q = 0.29 10 24 and 49 Q = 0.24 10 24 cm 2 , and the gyromagnetic ratio 47 N =2 = 2.4000 and 49 N =2 = 2.4005 M H z/T are used in this paper [16].




FIG. 1: $^{47;49}$ TiNMR spectra under zero external eld at 1.5 K in the antiferrom agnetic state of LaT iO $_3$ [10]. Solid circles represent experim ental data, and solid and dashed arrows represent the calculated resonance positions for 49 Ti and 47 Ti nuclei, respectively.

Figure 1 shows the frequency-swept $^{47;49}$ T iNMR spectra in the antiferrom agnetically ordered state of LaT iO $_3$, which were previously reported in Ref.10. These spectra are consistent with the data in Ref.17. Each peak

of the spectra is assigned for ^{47}Ti and ^{49}Ti nuclei as shown by the arrows in Fig. 1. The attribution of the peaks to the ^{47}Ti and ^{49}Ti nuclei is the same as previous reports[10, 17], although the parameters such as the quadrupole frequency $_{\text{Q}}$ and the asymmetry parameter of the electric eld gradient (EFG) are not unique to reproduce the spectra.

The NMR spectrum of Tinuclei is determined by the hyper ne interaction. The hyper ne interaction H in the $3d^1$ transition m etal ion is expressed as [18]

where H $_{\text{m ag}}$ represents the magnetic hyper ne interaction, H $_{\rm el}$ the electric hyper ne interaction, H $_{\rm el}^{\rm on}$ the electric tric hyper ne interaction with on-site delectrons, Hell the electric hyper ne interaction with outside ions, H $^{\rm e}$ the e ective internal magnetic eld, V e the e ective electric eld gradient (EFG) tensor, h the Planck's constant, $_{\text{B}}$ the Bohr m agneton, hr $^{3}i_{\text{m ag}}$ and hr $^{3}i_{\text{el}}$ the expectation values of r 3 for the Ti 3d electron, parameter for the Fermi contact interaction due to a core-polarization e ect, 1 the Stemheim er antishielding factor, S the spin, L the orbital momentum, I the nuclear spin operator, q the electron quadrupole moment tensor of which the components are de ned as $\frac{3}{2}$ (L L + L L) L² (, = x, y and z), ${\rm V}^{\rm out}$ the EFG tensor by the outside ions, and ${\rm V}^{\rm out}$ the components of the EFG tensor, respectively.

W hile H $_{\text{m ag}}$ generates a single resonance peak for each of ^{47}Ti and ^{49}Ti , the EFG at Ti nuclei splits the spectrum to 2I resonance peaks through H $_{\text{el}}$ in the case of H $_{\text{el}}$ H $_{\text{m ag}}$. As seen in F ig. 1, the NMR spectra of ^{49}Ti are split to seven peaks with alm ost the same frequency interval of 1.6 M H z, indicating H $_{\text{el}}$ H $_{\text{m ag}}$. Since the EFG tensor V $^{\text{e}}$ is symmetric tensor, V $^{\text{e}}$ can be diagonalized by an appropriate rotation of the coordination system . Now we take the $x^0y^0z^0$ -coordination system to

diagonalize V $^{\rm e}$, and refer to the maximum value of the diagonal components as $V_{z^0z^0}^{\rm e}$. The quadrupole frequency $_{\rm O}$ is dened using V $_{z^0z^0}^{\rm e}$ as

 $_{\rm Q}$ increases with the deviation from cubic sym m etry for EFG around the nuclei ($_{\rm Q}=$ $V_{z\,{}^0z^0}^{\rm e}=$ $V_{x\,{}^0z^0}^{\rm e}=$ $V_{y\,{}^0z^0}^{\rm e}=$ 0 in cubic sym m etry because the trace of V $^{\rm e}$ is 0). The splitting frequency is expressed by the rst order perturbation theory of H $_{\rm el}$, for example, in the case of the axially sym m etric EFG , as

I)g] where represents the angle between the z'-axis and H $^{\rm e}$. The inequality $\rm j_{\,\rm Q}$ j is valid in general for I]; (2) H $_{\rm el}$ H $_{\rm m \, ag}$. Therefore, since the present NMR spectra show $^{\rm 49}$ is about 1.6 M H z,

As mentioned above, $_{\mathbb{Q}}$ re ects the distortion of the EFG, i.e., the charge distribution. The EFG at Tinuclei is contributed from the on-site 3d electron and the outside 0^2 , La³⁺ and Ti³⁺ ions. Generally, it is very dicult to estimate the contribution of outside ions to the EFG quantitatively, because the EFG from the outside ions is largely enhanced by core electrons (the Stemheimerantishielding factor $_1$ corresponds to this e ect). However, we could naively expect that the EFG originating from outside ions is small, since the distortion of TiO $_6$ octahedra is small in LaTiO $_3$.

The above value of $\int_{0}^{49} ds$ j is much larger than those of AT iO_3 compounds with Ti^{4+} (3d⁰), in which the EFG is determined only by the contribution of the outside ions[19, 20]. It is reported that the value of 49 $_{\odot}$ is 1.1 MHz for MgTiO3, in which both of the crystalline and TiO 6 distortions are much larger than those in LaTiO 3 [19]. Padro et al. system atically and quantitatively investigated the relationship between the EFG and the structural param eters for AT iO 3 com pounds[19]. They found that the shear strain of TiO 6 octahedra well correlates with the EFG magnitude. In accordance with their argum ent, we derived the shear strain j jofLaT iO $_3$ as 0.27 using the structural data at 8 K in Ref.13. From this value of j jwe estim at the value of 49 o contributed by the outside ions as 0.15 M H z at 8 K. Even if we consider the difference of the valence of ions between $\rm La^{3+}~T~i^{3+}~O_{3}$ and A $^{2+}~T~i^{4+}~O_{3}$, it is di-cult to ascribe the origin of the large $_{\rm O}$ value in LaT iO $_{\rm 3}$ to the outside ions. Therefore, the main contribution to the EFG at Tinuclei should come from the on-site 3d electron. So, we treat only H on as the electric hyper ne interaction hereafter.

The conclusion m entioned above m eans that the shape of 3d orbital is deformed from cubic sym m etry. The




FIG. 2: Simulated and experimental $^{47;49}$ TiNMR spectra of LaTiO₃. Solid circles represent experimental spectra, and solid lines represent the resonance spectra calculated for the $1=\frac{1}{3}(d_{xy}+d_{yz}+d_{zx})$ —like orbital ordering state.

quadrupole frequency $_{\mathbb{Q}}$ is associated with the electron quadrupole m oment q. We dene $q_{z^0z^0}$ as the maximum value of the principal-axes components for q. We also introduce $r_{\rm el}$ dened as $r_{\rm el}$ hr $^3i_{\rm el}$ =hr $^3i_{\rm FI}$, in which hr $^3i_{\rm FI}$ represents the r 3 expectation value of the 3d electron calculated for a free T i^{3+} ion, 2.552 a.u.[18]. We could expect $r_{\rm el}$ < 1 due to the hybridization with oxygen 2p states. Using Eqs. (4), (6), and (8), the following inequality is obtained for $q_{z^0z^0}$:

The neutron scattering m easurem ents have shown that the ordered m agnetic m om ent is 0.46 $_{\rm B}$ in the stoichiom etric LaT iO $_3$ [15]. Since the spin-wave approximation for a three dimensional S=1/2 m odel gives shrunken ordered spin m om ents of 0.84 $_{\rm B}$, the observed m om ent is about 0.4 $_{\rm B}$ smaller. The origin of this shrinkage is unclear. The present NMR spectra show that the internal magnetic eld $H^{\rm e}$ jat Tinuclei is 92 kOe. $H^{\rm e}$ jis expressed as

where $r_{m \ ag}$ represents hr $^3i_{m \ ag}$ =hr $^3i_{F \ I}$. The rst term of Eq. (11) represents the Fermi contact eld, the second the dipole eld due to the electron spin m oment, and the third the orbital eld coming from the electron orbital m oment. $r_{m \ ag}$ is supposed to be 0.63 0.75 since the isotropic hyper ne coupling constant A $_{iso}$ (= 159:7 $_{if}$ $_{ag}$ [kO e/ $_{B}$]) by the Fermi contact interaction is generally given as 100 120 kO e/ $_{B}$ [16]. On the other hand, the ordered magnetic moment of 0.46 $_{B}$ should correspond to

So, Eqs. (12) and (13) must be satis ed at the sametime. This restriction is so hard that it makes a good test for them odels of the electronic states in LaT iO $_3$. As a rough estimation, if we assume that S and L are antiparallel, the orbital moment J_L j cannot exceed $0.29/r_{mag}$, since j S j is larger than 2=21 js qj in the present dasse.




FIG .3: O rbital states expected by the 1= $\frac{p}{3}$ ($d_{xy} + d_{yz} + d_{zx}$)-like orbital ordering m odel in LaT iO $_3$. The detailed representation of the wave function for T i 3d electrons is described in the text.

As noted above, the NMR spectra of LaTiO3 show that a certain amount of the Ti3d electronic quadrupole moment is present. Mochizuki and Imada as well as Cwik et al. proposed that 3d electrons in LaTiO $_{\rm 3}$ occupy $1=3 (d_{xy} + d_{yz} + d_{zx})$ -like orbitals and explained the physical properties of LaT iO $_3$ successfully [12, 13]. This model is consistent with the present NMR results. So we simulated the NMR spectra assuming this type of orbital state. We assumed that the magnetic moment is parallel to the a-axis[13, 21]. Furtherm ore, we set A $_{\rm iso}$ as $100 \text{ kO e/}_{\text{B}}$ with the assum ption that S and L are antiparallel. The resonance intensity was derived from the transition probability between the nuclear spin eigenstates. The result is shown in Fig. 2. The simulated spectra well explain the experimental data. Especially, the resonance frequency is completely reproduced, while the deviation of the intensity is seen for outside peaks. The used param eters are listed in Table I. The 3d orbital states of Ti(1) - Ti(4) sites in LaTiO3 are represented as ad_{xy} bd_{yz} cd_{xx} , ad_{xy} cd_{yz} bd_{xx} , $ad_{xy} + bd_{yz} + cd_{xx}$ and $ad_{xy} + cd_{yz} + bd_{zx}$, respectively, where $a^2 + b^2 + c^2 = 1$. The four Ti sites give same spectra in the case of H e parallel to the a-axis. The orbital param eters are determ ined as a= 0.565, b= 0.452 and c= 0.690, which are close to the results in Refs.12 and 13. Figure 3 shows the orbital states in LaTiO3 expected from these pa-

ram eters. It is important that $_{\circ}$ is led from the electron quadrupole moment with the reasonable parameters. The present wave functions and parameters give $5:77,^{49}$ Q = 3.2 M H z, and = 0.49. The re $q_{z^0z^0} =$ duction of $r_{m \ ag}$ and r_{el} from 1 partly originates from the hybridization between Ti3d and O 2p orbitals, although the values of 0.57 for $r_{m \ aq}$ and r_{el} appear rather sm all. It m ight be a ected by the shielding e ect of core electrons which can modulate the EFG from on-site delectrons by 10 20 % [18]. Possibly orbital uctuation might also contribute the reduction. The orbital magnetic moment $_{
m B}$ L is estimated as 0.11 $_{
m B}$, which may be overestim ated by the underestim ation of $r_{\text{m ag}}$. If we vary A $_{\rm iso}$ 80 and 120 kO e/_B , estimated $_B$ L ranges between from 0.05 to 0.15 B. In order to be more accurate at the estim ation of $r_{m \ ag}$ and r_{el} , m ore detailed analyses such as TiO 6 cluster model calculations will be needed.

Some other approaches are taken to explain the magnetism of LaTiO3 such as a strong spin-orbit interaction [14, 21]. The degeneracy of j= 3/2 quadruplet is lifted to two doublets by trigonal crystalline distortion. The resultant ground states show magnetic moment through hybridization with $\tilde{j}=1/2$. Now we consider in the ground doublet a state which reproduces the observed magnetic moment of 0.46 B parallel to the a-axis. This state exhibits an anisotropic orbital shape elongated in the (1,1,1)-direction with $q_{2} q_{2}$ 5:0, which is comparable with the orbital ordering model[12, 13], while it gives rather large orbital moment 0.44 _B. Based on this type of orbital state, the orbital magnetic m om ent would be expected to take 0.05 Eqs. (12) and (13) in the conceivable range of hyper ne coupling param eters $r_{\!_{m}\;ag}$ and $% r_{\!_{m}\;ag}$. This fact seem s to suggest that the e ect of the trigonal crystalline distortion is rather large compared with the SO interaction as is

pointed out by Cw ik et al.[13], and that some part of the reduced magnetic moment should be ascribed to other reasons. Mochizuki and Imada have accounted for the reduction by the itinerancy of the t_{2g} electrons, i.e., the double occupation of up and down spin electrons in the t_{2g} state[12]. It seems to support this account that the increase of oxygen content gradually decreases the ordered moment and nally leads to a Pauli param agnetic state.

In sum m ary, we analyzed the $^{47;49}\text{TiNM}$ R spectra of LaTiO $_3$. The NMR technique can evaluate the electron quadrupole m oment q, i.e., the order parameter of orbital ordering, quantitatively. The NMR spectra show that the electron quadrupole m oment is rather large. It is supposed that LaTiO $_3$ takes an orbital ordering state represented approximately as $1=\frac{1}{3}(d_{xy}+d_{yz}+d_{zx})$.
