W hy only half of the ferm ionic atom swere converted to molecules by a Feshbach resonance?

In some recent experiments an ultracold gas of ${}^{40}K_2$ (or ${}^{6}Li_2$) molecules has been produced from a degenerate two-component Ferm igas of ${}^{40}K$ (or ${}^{6}Li$) atoms by adiabatic passage through a Feshbach resonance. The maximum atom -molecule transfere ciency is reported to be about 50%. We propose a simple microscopic model to characterize the ground state of the gas in the vicinity of the resonance, and show that the term describing the atom -molecule coupling is responsible for the observed e ciency 50%. Our result also suggests that the experiments have produced a molecular condensate.

Recently the group at the Joint Institute for Laboratory A strophysics (JILA) has succeeded in converting an ultracold Ferm i gas of 40 K atoms into an ultracold gas of 40 K₂ molecules by sweeping a magnetic eld across a Feshbach resonance [1]. Using a similar method with ferm ionic ⁶Li atoms, several experiments have also reported the production of ⁶Li₂ molecules [2, 3, 4]. This im – pressive experimental achievem ent of ultracold molecules from ferm ionic atoms not only raises the prospect of creating novelmolecular Bose-Einstein condensates, but also sparks a hot race to realize the Bardeen-Cooper-Schrie er (BCS) transition to super uid phase of the ferm ionic components [5, 6], in which the super uid transition temperature is predicted to be maximum near a Feshbach resonance[7, 8, 9].

At present, several of the experim ental results are not wellunderstood. At rst, a common feature observed in these experiments is that the maximum atom -molecule transfer e ciency is limited to 50% at low temperatures [1, 2, 4]. This observation is not within the prediction of the well-known Landau-Zener theory [10, 11], and therefore constitutes a theoretical challenge. The Landau-Zener model, which is expected to be applicable in this case, predicts that the transfer probability is proportional to 1 exp (B^{-1}) ; when the magnetic eld is ram ped from a eld far above the Feshbach resonance to the one far below, with B_{-}^{1} being the inverse ram p rate. A ctually, the m easured fraction of ferm ionic atom s remaining in the gas as a function of B-1 exhibits the predicted exponential dependence. However, the model does not predict that the conversion should be 50% at the resonance when the ramp rate is su ciently slow. W hat m easured in the experim ents thus can not be com prehended by the Landau-Zener theory. Another mapr problem of interest is whether the molecular gas is actually a molecular Bose-Einstein condensate. In the JILA experiment, the number of the molecules produced is very large [1]. If one assum es that the molecules have a tem perature com parable to that of the ferm ionic atom s from which they were made, the number of molecules is

in fact already large enough to imply that a molecular $B \circ x = E$ instein condensate might be form ed [1].

The scope of the present paper is to give the sim plest possible physical picture of an atom -m olecule m ixture in close proxim ity to the Feshbach resonance, essentially at zero tem perature. The model is not made to give quantitative predictions, but, as we shall see, it qualitatively reproduces the experim ental observations of the maximum atom -m olecule transfere ciency of 50%, and, of course, it is consistent with the expectation that the experim ents have indeed produced a molecular condensate.

The model: Our starting point is a spatially hom ogeneous gas of the atom -molecule mixture, in which the molecules are created from a degenerate two-component Ferm igas by adiabatic passage through a Feshbach resonance. The model system in the grand-canonical assem ble can then be qualitatively described by [7, 8, 9]

Here we describe the two components of ferm ionic atom s as pseudospins = "; #. The operators c_k and b_q represent, respectively, the annihilation operator of a ferm ion atom with the kinetic energy ${}^0_k = h^2 k^2 = 2m$ and a molecular b boson with the energy spectrum $E_q^0 + 2 =$ $h^2q^2=4m+2$. The detuning or the binding energy of the Bose molecules is denoted by 2 and can be conveniently adjusted by an external magnetic eld. The background ferm ion-ferm ion interaction U_{bg} originates from the nonresonant processes, while the g is a coupling constant associated with the Feshbach resonance. The Ham iltonian (1) has been suggested to be valid at all detunings [3]. In this paper, how ever, we are only interested in the vicinity of the Feshbach resonance, in which 0. The dom inant term in this region is the last term in Eq. (1) describing the atom -m olecule coupling. We wish to show that it alone is responsible for the observed maximum transfer e ciency of 50%. For this purpose, we therefore write down a truncated e ective Ham iltonian in the vicinity of the Feshbach resonance

where the coupling constant g = 1 hereafter. The model is still too complicated to be exactly solvable. To proceed, we further restricted ourself at zero temperature in accordance with the expectation of the appearance of the molecular Bose-E instein condensation. The b bosons are then replaced by a Bose condensate in the q = 0state, described by $hb_{q=0}i = m = j_m je^i$. W ithin this simple mean-eld approximation, the Ham iltonian H_{eff} N can be easily diagonalized by constructing the Bogoliubov quasiparticles according to the general canonical transform ation [12, 13]

where the transform ation angle is specified as $2 = 2 + \arctan(=j_m)$. The resulting many-body Ham iltonian now becomes diagonal in the ferm ion operators

with $_{k} = (^{2} + j_{m} j^{2})^{1=2}$ being the corresponding quasiparticle spectrum. Hence at zero tem perature the ground state energy is obtained as

where $M = \int_{k}^{P} 1$ represents the number of available states for the fermionic atom s. The saddle point equations are derived by m inim izing the ground state energy with respect to $j_{m} \int_{2}^{2}$;

and by requiring the conversion of the number of atom s, $@E_{\rm qs}{=}0~=~N$, or




FIG.1: The fraction of the m olecules of a hom ogeneous atom – m olecule m ixture, as a function of N=M . In the dilute lim it of N=M 1, the calculated fraction of the m olecules is in excellent agreement with the maximum atom -m olecule transfer e ciency of 50%, as observed in some recent experiments [1, 2, 4].

By solving those equations, we can determ ine the occupation of the m olecules and the chem ical potential as a function of N=M .

Discussion: | We rst consider the lim it N=M 1 that m ay correspond to the real experimental situation of dilute atom ic gases. In this lim it, Taylor-expanding the saddle point equations in powers of $j_m j^2 = M$ and N=M yields to the solution (the factor g has been restored)

in leading order. This is the main result in this work. The obtained fraction of the molecules in the mixture, $2j_m j = N = 0.5$, is in excellent agreement with the experim ental result by Jochim and co-workers, that is, either a pure atom ic or molecular sample relaxes to an atom -m olecule m ixture with equal fraction [4]. On the other hand, it should also be compared with the experim ental observations of the maximum atom -molecule transfer e ciency of 50% [1, 2, 4]. As seen in the experim ents, them olecules are predom inantly form ed when the magnetic eld traverses the Feshbach resonance peak [1, 2, 3, 4]. Due to the su ciently slow ram p of the m agnetic eld, the fraction of the molecules in the ground state of the mixture is in fact equivalent to the maximum atom -molecule transfer e ciency, if we don't care about the sm all loss due to inelastic processes.

Another important feature of our model is that the chem ical potential is pinned at

in the dilute lim it of N = M 1, where $g = gM^{1=2}$ is independent on the volume V, since $g / V^{1=2}$ and M / V.




FIG. 2: The chemical potential of a homogeneous atom – molecule mixture, as a function of N =M .

This pinning can be qualitatively understood by considering a two-particle mixture, with either two atoms or one molecule, described by an e ective H am iltonian

in real space. The mixture has two states: \mathcal{P}_A ; 0_M i or \mathcal{P}_A ; 1_M i. On the basis of these two states, the H am iltonian takes the form,

Its ground state, which is the bond state of \mathcal{P}_A ; 0_M i and \mathcal{P}_A ; 1_M i, can be nicely regarded as a composite m olecule with energy g. In the dilute limit, the ground state of the N-particle mixture may therefore be viewed as a non-interacting gas with N=2 such kind of composite m olecules, distributed uniform ly in the real space. This scenario is agreement with the halfpopulated fraction of the m olecules. Adding or removing a particle from the m ixture thus costs energy g=2, which is the precise value of the chemical potential in Eq. (10).

The full solution of the saddle point equations as a function of N = M is shown in Figs. (1) and (2). The faction of the molecules is only weakly dependent on the value of N = M. We believe that, it will also be robust against the inclusion of the kinetic and ferm ion-ferm ion interaction terms, i.e., the terms in the rst and second lines of the full H am iltonian (1), which we have treated as irrelevant perturbations in the vicinity of the resonance [14].

Further, analogous to the Bose-E instein condensates with spin [15, 16], m ore profound structures m ay be expected for the atom -m olecule mixture. Besides the condensation of the molecules, the fermionic atom sm ay also acquire an o-diagonal long range order since the resonance induced an attractive pair interaction in form of $c_{i \#}^+ c_{i "}^+ c_{j "} c_{j "} c_{j \#}$ among the atom s. The interplay between the phase of the molecule condensate and the phase of the o-diagonal long range order for atom s is a new problem for both experimental and theoretical studies.

The results presented so far is only valid at zero temperature, at which the mixture is strongly degenerate. The fraction of the molecules, of course, will be qualitatively a ected by the inclusion of a nite temperature. This is the case in the ENS experiment [3], in which the atom ic component in the gas is no longer quantum degenerate [17] and therefore atom -molecule transfer efficiency can reach 85%. A theoretical investigation of the extive H am iltonian (2) at nite temperature is highly non-trivial, since it requires the treatment beyond the mean-eld approximation. We will discuss these points elsewhere.

In conclusion, we have proposed a simple physical model to characterize the essential physics of an atom – moleculem ixture in close proximity to the Feshbach resonance at zero temperature. The fraction of the molecules obtained from this model agrees well with the maximum atom -molecule transfer e ciency of 50%, as observed in some recent experiments [1, 2, 4]. This excellent agreement also justi es ourmean - eld treatment for themolecule operator, and suggests that the experiments have indeed produced a molecular condensate.
