We have measured the magnetization of a dual-subband two-dimensional electron gas, conned in a GaAs/A GaAs heterojunction. In contrast to two-dimensional electron gases with a single subband, we observe non-1=B -periodic, triangularly shaped oscillations of the magnetization with an amplitude signicantly less than 1  $_{\rm B}$  per electron. All three elects are explained by a eld dependent self-consistent model, demonstrating the shape of the magnetization is dominated by oscillations in the conning potential. Additionally, at 1 K, we observe small oscillations at magnetic elds where Landau-levels of the two dimensional electrons.

When an extra degree of freedom is added to a two-dimensional electron gas (2DEG), many-body interactions can lead to the formation of novel electronic grounds-states at the crossings of the di erent energylevels in the system <sup>1</sup> Two-dimensional electron gases with crossing energy levels can be realized in a variety of system swith di erent relative sizes of orbital and spin e ects, C oulom b energy, and di erent coupling between the components. Their study has lead to the discovery of many correlated Q uantum H all states,<sup>2,3,4</sup> and m uch e ort is put into unravelling the energy-level structure of these system s.

O ne way of realizing such a 2D system, is to increase the electron density of a III-V 2DEG such that a second subband becom es occupied. D ual-subband system s realized in a quantum wellhave recently been studied within this context.<sup>5,6</sup> A similar system is the dual-subband 2DEG in a G aA s/A IG aA s hetero junction. In transport studies, the multi-subband 2DEG is generally assumed to be a superposition of single 2DEG s: the Landau-level structure is a superposition of Landau fans, separated by the inter-subband spacing calculated self-consistently at zero m agnetic ed.<sup>7,8</sup>

In this paper we study the magnetization (M) of a dual-subband 2D EG. This is a way to directly probe a therm odynam ic property, the chem ical potential, . For two-dim ensional system s, the M axwell relation between M and is reduced to a proportionality. Since the Ferm i energy (E $_{\rm F}$ ) is equal to at low tem peratures, the m agnetization directly reveals changes in the size as well as the shape of the Ferm i energy: M =  $\frac{N}{B}$  E $_{\rm F}$ , where N is the total num ber of electrons.

The magnetization of multi-subband 2DEGs has already attracted some attention, both theoretically<sup>9,10</sup> and experimentally,<sup>11</sup> however, these studies have focussed on very high density systems with three or more lled subbands. In this regime changes in the energygap between the subbands can be ignored. In this paper we focus on the e ect of the lling of a only a second electronic subband on the Ferm i energy.

Q uantum oscillations in the magnetization of a single 2D EG are wellknown to be characterized by strictly 1=B – periodic saw-tooth-like oscillations with an am plitude of one e ective Bohr magneton ( $_{\rm B}$ ) per electron.<sup>12,13,14</sup> Here we will show that this is no longer the case in a multi-component system. D ue to a self-consistent, magnetic eld dependent redistribution of electrons between the subbands inside the hetero junction, the am plitude of the oscillations becomes considerably reduced, the saw-tooth-like steps are broadened into triangles, and the 1=B -periodicity is lost. Additionally we make the Landau-level crossings of the two subbands.

W e study the magnetization of two samples with different electron densities, realized in G aA s/A G aA s heterojunctions grown by molecular beam epitaxy: a single subband 2D EG (sample 1) and a high density 2D EG (sample 2) where two electronic subbands are occupied. Sample 1 has a density of 4.8  $10^{11}$  cm<sup>2</sup>, and a mobility of 2.2  $10^6$  cm<sup>2</sup>/V s. Our high electron density sample 2 has a carrier concentration of 8.0  $10^{11}$  cm<sup>2</sup> and a mobility of 1.4  $10^6$  cm<sup>2</sup>/V s. Most of the electrons (7.4  $10^{11}$  cm<sup>2</sup>, deduced from transport measurements on a reference sample) remain in the lowest subband; the small remaining fraction occupies the second subband. The magnetization experiments were performed using a torsionalm agnetometerwith optical angular detection.<sup>15</sup>




FIG.1: M agnetization of sample 1 (single 2DEG with n =  $4.8 \ 10^{11}$  cm<sup>2</sup>) at 4.2 K (a) and 1.2 K (b). O scillations are a strictly 1=B -periodic saw-tooth, the amplitude saturates to 1 <sub>B</sub> per electron at low . Features at lling factors 3 and 5 are related to spin-splitting.

Figure 1 shows the magnetization of sample 1, the single subband 2DEG, as a function of lling factor ( = hn=eB). It displays oscillations periodic in , i.e. 1=B -periodic oscillations. The steps at the lowest lling factors, where Landau-level broadening has the least in-uence, are saw-tooth shaped, and, with decreasing tem - perature, the amplitude saturates to 1 <sub>B</sub> per electron.

A lthough the steps are rather sharp, even at 1.2 K they still have a small, nite width indicating a nite density of states (DOS) in between Landau-levels.<sup>14,16</sup>

A part from the clear steps assigned to the Landau gap at even integer lling factors, at 1.2 K (gure 1(b)) additional features appear at odd integer lling factors. They are attributed to the opening of a spin-gap, signi cantly enhanced due to exchange interaction.<sup>17,18,19</sup>

The second sample, with two lled subbands, displays the magnetization plotted by the solid line in gure 2. The dashed line is a theoretical calculation and will be discussed later. A lso for this sample the magnetization oscillates as a function of inverse magnetic eld. C loser inspection of the data, however, reveals three distinct di erences com pared to the single 2DEG.First, the oscillations are no longer saw tooth-like, but instead they are triangularly shaped. Secondly, we nd that the oscillations are no longer strictly periodic in 1=B. This becomes clear when we see that while = 4 coincides with an oscillation minimum, there is an increasing discrepancy, and = 14 actually coincides with an oscillation maximum. Finally, the amplitude of the oscillation is about 0:5 <sub>B</sub> per electron, even for the lowest lling factors. This value is signi cantly less than the 1  $_{\rm B}$  per electron observed in gure 1b for the single 2DEG and it rem ains at this level even for the low est tem peratures (see g.3).

In order to understand the behavior of the m agnetization, it is important to realize that in a heterojunction the con ning potential of the 2DEG is formed by the electrons them selves. In a dual-subband 2DEG redistribution of charge over the two subbands can occur when a m agnetic eld is applied, resulting in a potential that is not xed as a function of m agnetic eld. The wavefunc-




FIG. 2: M agnetization of the dual-subband 2DEG with n = 8:0  $10^{11}$  cm<sup>2</sup> at 4.2 K. The dashed line is a self-consistent calculation using a G aussian Landau-level broadening with = 0.2 B m eV. Note the deviation from 1=B-periodicity.

tion of the second subband is much more extended than that of the rst one, therefore even a small change in its occupation can have profound e ects. Since the occupation of the two subbands depends on the magnetic eld that quantizes the DOS into Landau levels, and since the shape of the con ning potential, the inter-subband spacing and the spacial charge distribution are interdependent, the Schrödinger and Poisson equations have to be solved self-consistently for each value of the magnetic eld.<sup>20,21</sup>

In ourm odelling we keep the electron density xed and assume a G aussian broadened D O S with a width that increases with the square root of the magnetic eld. A s the (bare) spin-splitting is too small to have an e ect, it is neglected in the calculations. The Landau-level broadening is our, albeit only, t-parameter. W e note that the calculated am plitude decreases with increasing broadening, how ever, even in the limit of non broadened Landau levels, the calculated am plitude of the oscillations is only 0:7  $_{\rm B}$  per electron.

U sing the self-consistent m odel, we have calculated the Ferm i energy as a function of magnetic eld, from which the magnetization follows directly through the M axwell proportionality. The dashed line in gure 2 shows the resulting magnetization for a G aussian Landau-level broadening with  $= 0.2^{11}$  B m eV. It is in very good agreement with the experimental data as it reproduces all three observed e ects: triangular shape, non-periodicity, and the reduced amplitude.

Inspection of the self-consistent eld-dependent modelling of the high-density 2DEG in detail reveals two important points. First, although the number of electrons in the highest subband is small, it remains populated up to high magnetic elds. Secondly, the shape of the Ferm ienergy (and thus magnetization) is determined by the oscillations in the inter-subband spacing, caused




FIG. 3: M agnetization of a dual-subband 2D EG at 1 K.Arrows indicate the positions of Landau-level crossings, additional features can be seen at these positions in interm ediate m agnetic elds.

by self-consistent redistribution of electrons over the two subbands. A Landau-level scheme for the dual-subband 2DEG, resulting from the self-consistent model, is depicted in gure 4. W hile levels originating in the lower subband (solid lines) are linear functions of the magnetic eld, the Landau-levels of the higher subband (dashed lines) oscillate according to the inter-subband spacing. Above 1.5 T only the lowest Landau-level of the second subband is populated and the Ferm i energy lies continuously within it. It can be clearly seen that the oscillations of the con ning potential due to the redistribution of the electrons have a large e ect on the energy-level structure.

At this stage it is interesting to remark that consequently the wideness of the magnetization step is mainly caused by this redistribution and not by a nite DOS between two Landau-levels as suggested for a single subband 2DEG  $.^{14,16}$  O nly in the region nearing = 4 there is, scarcely visible in gure 2, a kink followed by a sharp step, whose nite width is related to this small, extra DOS. These features are not at all visible on the other downward slopes, where the width is determined by the electron redistribution, and including the extra DOS does not in uence the shape of the calculated Fermi-energy.

W hen reducing the temperature to 1 K, additional minima appear in the 2DEG magnetization (gure 3) around lling factor = 9:6 and = 12:0, and = 14:2. Interestingly enough these lling factors coincide with positions where two Landau levels originating from the two subbands cross, indicated by down-arrows in g.3.

On the anks of the triangular oscillations a series of crossings occurs between the lowest Landau-level of the higher subband and Landau-levels with decreasing index of the lower subband as the magnetic eld increases (see gure 4). The addition of spin-splitting to this (single-electron) picture results in energy-level schemes as depicted in the inset of g.4 for one of the crossings. When




FIG. 4: Landau-level diagram of the dual-subband 2DEG. Solid lines depict levels originating from the lower subband. Dashed lines show the Landau-levels of the higher subband. The inset is an enlargement of the circled Landau-level crossing around = 11:9, norm alized to the cyclotron energy.

spin-splitting is taken into account, there is not a single level-crossing, but a small region where the levels with di erent spin consecutively cross each other. In this region spin up and spin down do not alternate for increasing energy: the two spin down levels are lowest in energy, the spin up levels the highest.

A lthough the Landau levels in gure 4 are represented by discrete lines, they are in fact considerably broadened, creating an overlap and giving the electrons some freedom to distribute them selves over the available energylevels. W e suggest this enables electrons to form a novel electronic ground-state that is spin-polarized in the crossing region. C reation of this polarized state would be favored by the system, because exchange interaction signi cantly reduces the ground-state energy. W hen the energy gain exceeds the broadening of the energy-levels, the enhanced gap shows up as a minimum in the magnetization.

A lthough it is evident that at lower magnetic elds ( lling factors higher than 14, up-arrow s indicate the positions of the level crossings), extra structure cannot be seen due to the broadness of the Landau-levels, extra structure is also too sm all to be observed at the Landaulevel crossings of the lowest lling factors (up-arrow s in g.3). C learly the picture of the crossing region sketched above is not yet com plete and further experim ental and theoretical investigation of this many-body e ect is required.

In summary, we have measured the magnetization of the coupled 2DEGs in a dual-subband 2DEG in a G aA s/A IG aA shetero junction. We nd that the de H aasvan A lphen oscillations are changed in three ways compared to those of the single 2D EG. The shape is triangular, the oscillation amplitude is reduced to 0.5  $_{\rm B}$  and the oscillations are no longer periodic in 1=B. This behavior is well described by a self-consistent model, taking into account changes of the con ning potential with m agnetic eld. It shows the shape of the Ferm i energy and consequently the magnetization is entirely dom inated by the oscillations in this potential due to redistribution of electrons over the two subbands. We observe additional magnetization minim a at 1 K, which occur at magnetic

elds corresponding to the positions where Landau-levels originating in the two di erent subbands cross. These m inim a possibly originate from a reduction of the total energy by the form ation of a novel, exchange enhanced electronic state at the level-crossing.
