Single Particle Jumps in a Binary Lennard-Jones System Below The Glass Transition

We study a binary Lennard-Jones system below the glass transition with molecular dynamics sim ulations. To investigate the dynam ics we focus on events (\jum ps") where a particle escapes the cage form ed by its neighbors. U sing single particle trajectories we de ne a jump by comparing for each particle its uctuations with its changes in average position. We not two kinds of jumps: \reversible jum ps," where a particle jum ps back and forth between two or more average positions, and \irreversible jum ps," where a particle does not return to any of its form er average positions, i.e. successfully escapes its cage. For all investigated tem peratures both kinds of particles jum p and both irreversible and reversible jumps occur. With increasing temperature relaxation is enhanced by an increasing number of jumps, and growing jump lengths in position and potential energy. However, the waiting time between two successive jumps is independent of temperature. This temperature independence m ight be due to aging, which is present in our system. The times of jump duration are at all tem peratures signi cantly shorter than the waiting times. The ratio of irreversible to reversible jum ps is also increasing with increasing tem perature, which we interpret as a consequence of the increased likelihood of changes in the cages, i.e. a blocking of the \entrance" back into the previous cage. In accordance with this interpretation, the uctuations both in position and energy are increasing with increasing tem perature. A comparison of the uctuations of jumping particles and non-jum ping particles indicates that jum ping particles are m ore m obile even when not jum ping. The jumps in energy normalized by their uctuations are decreasing with increasing temperature, which is consistent with relaxation being increasingly driven by thermal uctuations. In accordance with subdi usive behavior are the distributions of waiting times and jump lengths in position.

I. INTRODUCTION

If a liquid is cooled and crystallization is avoided, one obtains a Supercooled liquid. Upon further cooling the system falls out of equilibrium and results in a glass. During the transition from liquid to supercooled liquid to glass the therm odynam ic properties change and even m ore drastic changes occur in the dynamics [1]. The viscosity increases by many orders of magnitude upon cooling and the mean square displacement (MSD) as a function of time develops a plateau at intermediate times. The lower the temperature the longer the waiting time within the plateau until a second rise in the mean square displacement occurs [2]. One common explanation for the plateau is that while at high temperatures one has (at late enough times) normaldi usion, at lower temperatures particles are caged in, i.e. trapped by their neighbors, and spend longer time within this cage with decreasing tem peratures. The second increase in the M SD indicates that after long enough waiting time the particles m anage to escape their cage. This escape out of the cage (\jum p") is the focus of this paper.

To set the work of this paper in context, we review brie y previous studies on the dynam ics of supercooled liquids and glasses. We restrict ourselves mostly to simple glass formers, excluding major work about strong glass formers, ionic systems, polymers and crystals.

C entral quantities in both experim ents and computer simulations are the viscosity, di usion constant and MSD. The MSD, which is an average over single particle i=1;:::;N displacements,

show jumps when viewed with ne enough time resolution, and when studied at low enough temperatures and for single con gurations β , 4, 5, 6, 7, 8, 9, 10]. Detailed studies of these jumps indicate collective motion β , 4, 5, 6].

One learns about the interplay between regular diusion and hopping motion via four-point correlation functions [11, 12, 13, 14, 15] and the van Hove correlation function G (r;t) = $G_s(r;t) + G_d(r;t)$ [15, 16, 17, 18, 19, 20, 21, 22, 23, 24] where $G_s(r;t)$ is the self part and $G_d(r;t)$ is the distinct part. The hopping shows up in an

additional peak in $G_s(r;t)$ and an increase in the amplitude at $r!\ 0$ of $G_d(r;t)$.

Recently attention has been drawn to the non-Gaussian tail of G (r;t) [25, 26, 27, 28] and the non-Gaussian parameter 2 5, 13, 25, 28, 29, 30, 31, 32, 33, 34] which is the second coe cient of the cumulant series of F_s(q;t), the Fourier transform of G_s(r;t). They are signatures of non-exponential behavior, which might be either due to hom ogeneous complex dynamics and/or due to spatially heterogeneous dynamics [35]. This has been studied both with experiments [28, 29, 30, 36] and in simulations of two-dimensional [31, 37, 38, 39, 40] and three-dim ensional systems 3, 5, 6, 11, 25, 26, 27, 32, 40, 41, 42, 43, 44, 45, 46]. Studies of the most mobile particles reveal that they move increasingly more collectively with decreasing temperature. One distinct feature of this collective dynamics is that som e particles are moving along a string [3, 8, 26, 30, 46, 47, 48].

Sim ilarm otion has been found via the study of norm alm odes which are commonly used to study the dynamics at low temperatures [8, 44, 45, 46, 47, 48, 49].

The dynam ics of glasses out of equilibrium, i.e. systems which have been quenched from high to low temperature, displays additional complexity, since the system might \age" [50]. This means that the dynamics depends on the waiting time between the quench and the measurement [51, 52, 53] which results in the violation of the uctuation dissipation theorem [53, 54].

A nother fruitful approach to gain insight into the dynam ics of supercooled liquids and glasses has been to investigate the energy landscape of the inherent structure, that means of the instantaneous congurations which have been quenched to their local potential energy minimum [14, 55, 56, 57, 58, 59, 60]. At the same temperature when the system starts slowing down drastically, the potential energy of the inherent structure undergoes a qualitative change [55]. The long time behavior of this potential energy shows jumps between metabasins, where the latter are groups of strongly correlated local minima [56, 57, 58, 59, 60]. The mean average waiting time h t_{wait} i between these jumps tums out to be dominated by the long times. h t_{wait} i together with the disconstant allow an estimate of the cage size [59].

D irect studies of the cage have been done via threetime correlations [14], velocity-velocity correlations [30, 38, 61], via the cage correlation function [62, 63, 64], and a passage time before a particle escapes [65]. The results of these studies tell us about cage properties such as the cage size and waiting time within a cage (or jump rate).

H and in hand with the experiments and simulations are the theoretical models for supercooled liquids and glasses. One of the very successful theories is the mode coupling theory of the glass transition (MCT) [66], which describes the dynamics of supercooled liquids via nonlinear dynamics of coupled density modes and makes predictions for quantities such as D, F (q;t), and the susceptibility $^{\odot}(!)$. The extended version of MCT includes hopping processes via the coupling to current uctuations

[67]. The comparison of experiment and this theory for $^{\circ\circ}$ (w) [68] and $_{2}$ [69] shows very good agreement.

The MCT is a theory for the glass transition for temperatures above the glass transition. Below the glass transition there exists no equivalent of a microscopic theory such as MCT. Some phenomenological theories which are more general models for solids build in hopping either indirectly as in the free volume model [70] or directly in hopping models [71, 72, 73]. Direct hopping models are based on the assumption that hopping is the main process which explains the dynamics. The starting point in these models is usually a random walk and the anomalous diffusion is incorporated via a distribution of waiting times (or jump rates). The jumping entities are either defects [71], uncharged carriers [72] or (in the case of predictions for ac and do conductivity) charged carriers [73].

The goal of this paper is to obtain via single particle trajectories direct in form ation about jum p processes such as jum p sizes and waiting tim es between jum ps. Speci c exam ples of the dynamics of single particle jumps, in the form of a plot of one component of r_i (t) [16, 17, 18, 74] or in the form of a two-or three-dimensional picture of the particle trajectory [6, 28, 29, 30, 31, 40, 57, 61], are very helpful to get an idea of som e qualitative features of jum ps, such as the detailed geom etry of jum p processes [16, 17, 57, 74]. In this paper, however, we go beyond single examples by de ning a systematic search algorithm for jump processes. For the case of single particle trajectories a similar approach has been used in the work [17, 19, 34, 43], where the jump criterion is a minimum hopping distance, which is the same for all particles. In contrast, we use a relative criterion, where for each particle its size of uctuations is compared to its jump size. We choose this relative criterion to be able to identify jum ps of particles of di erent sizes and neighborhood. That means the criterion is adjusted to the cage size of each individual particle. As criterion for the occurrence of a jump we use the positions of particles instead of their energy. While both approaches are fruitful, we believe that many theoretical models and interpretations of simulations and experiments are based on an intuitive picture of the particle motion in real space. Sim ilarly our goal is to m in ic a careful observer of each particles motion in our system. We therefore use single particle trajectories, instead of a quantity which is an average over all particles (as in the work [3, 4, 5, 6, 7, 8, 9, 10]). For the case of single particle trajectories the distinction between vibrational and hopping motion turns out to be clearer by taking time averages than by using trajectories of the inherent structure.

In the following we de ne our model, and give details about the simulation (Sec. II). Our precise de nition of a jump is given in Sec. III. We nd two types of jumps (irreversible and reversible). The latter are distinguished for the rest of the paper (in distinction from [17, 19, 34, 43].) In Sec. IV we count as a function often perature the number of jumping particles, and in Sec. V the number of visited di erent cages. In Sec. VI we investigate the

tim es during a jum p and between successive jum ps. The jum p size both in position and in potential energy are presented in Secs.VII and VIII. In Sec.IX we conclude with a sum mary of our results, a comparison with the results of previous work and with our resulting picture of jum p processes.We nish with open questions suggesting future work.

II. MODEL AND SIMULATION

W e use a binary Lennard-Jones (LJ) m ixture of 800 A and 200 B particles with the samemass. The interaction potential for particles i and j at positions r_i and r_j and of type ; 2 fA ,Bg is

where $r=jr_i$ r_j j and $r_{AA}=1.0$; $r_{AB}=1.5$; $r_{BB}=0.5$; $r_{AA}=1.0$; $r_{AB}=0.8$ and $r_{BB}=0.88$. We truncate and shift the potential at r=2.5 . From previous investigations [75, 76] it is known that this system is not prone to crystallization and dem ixing. In the following we will use reduced units where the unit of length r_{AA} , the unit of energy is r_{AA} and the unit of time is $r_{AA} = (48 r_{AA})$.

We carry out molecular dynamics (MD) simulations using the velocity Verlet algorithm with a time step of 0.02. The volume is kept constant at $V = 9:4^3 = 831$ and we use periodic boundary conditions. A coording to previous simulations [54, 75, 76] the kinetic glass transi-0:435. W e analyze here simulations tion is around T at T = 0.15 = 0.2 = 0.25 = 0.30 = 0.35 = 0.38 = 0.40 = 0.41 = 0.42 and 0:43 as they have been described in [42]. We start with 10 independent well equilibrated con gurations at T = 0.446.[77] Each of these con gurations undergoes the following sequence of simulation runs. After an instantaneous quench to T = 0.15 we st run a (NVT) simulation for 10⁵ MD steps. The temperature is kept constant by replacing the velocities of all particles by new velocities drawn from the corresponding Boltzmann distribution every 50 time steps. We then run the simulation for 10⁵ MD steps without the temperature bath (NVE) and subsequently raise the temperature instantaneously to the next higher tem perature T = 0.2. (NVT) and (NVE) runs of 10^5 MD steps each follow and the tem perature is again raised, and so forth. The nalconqurations of these (NVT) runs are the initial con qurations for the (NVE) production runs (for 5 10MD steps) presented in this paper. During each production run the positions of all particles (con gurations) are stored every

For the here investigated temperatures the relaxation times are much larger than the waiting time before the production runs (at T=0.446 is $8^{-5}1)0$. We therefore study relaxation processes out of equilibrium and nd aging e ects, which is consistent with previous

2000 MD steps which are then used for analysis.

detailed studies of aging of the same binary Lennard-Jones system [53, 54].

III. DEFINITION OF JUMP AND JUMP-TYPE

We focus in this paper on the process of a particle escaping its cage, using single particle trajectories r_i (t) given by the periodically stored congurations.




FIG.1: Sketch of a particle trajectory to illustrate the definition of a jump by comparison of the uctuations of the particle $_{i,\text{est}}$ and the di erence in average positions $\overline{r_i}$.

To distinguish vibrations around an average position from a change in the average position, we average 20 consecutive positions r_i (t) to obtain $\overline{r_i}$ (m) as sketched in Fig.1.W e identify jumps by comparing changes in these averaged positions j $\overline{r_i}$ jw ith the uctuations in position itest for each particle i where

(see Fig. 1) and $_{i,est}$ is de ned in [79]. We use in speci c for j \overline{x}_i jnot consecutive but instead average positions which are four averages (each of 20 con gurations) apart. This choice of time interval in j \overline{x}_i j is to allow identication of not only sudden but also more gradual jumps. We de ne that a jump of particle i occurs whenever

Notice that we use a relative criterion, namely for each particle is a comparison of j $\overline{r_i}$ jwith its i_{jest} . Our motivation for this relative criterion is that we would like to identify jumps of both A and the smaller B particles. A lso even for particles of the same type their jump size might dier due to dierent cage sizes. i_{jest}^2 is an estimate for the cage size of each individual particle and is therefore used as criterion for the occurrence of a jump.




FIG. 2: Sketch of typical particle trajectories to illustrate the distinction between irreversible and reversible jumps

When we apply the above jump de nition, we nd two types of jum ps which we call \irreversible" and \reversible" jumps (see Fig. 2). A particle which undergoes an irreversible jum p succeeds in escaping its cage (for the tim e w indow of the sim ulation) w hereas a particle undergoing a reversible jum p returns back to one of its previous average positions. Sim ilar results have been found in previous simulations of other systems [3, 4, 6, 8, 17, 21, 74]. However, the present work diers from these that we analyze all following quantities for the reversible and irreversible jumps separately. As sketched in Fig. 2, we call a jum p reversible whenever case 1 or case 2 occurs. Case 1 corresponds to the situation of a particle undergoing multiple jumps and returning to one or more of any previous average positions (for details see Sec. V). If two average positions are equal then all jumps which happen between the previous position and the recurring position are called reversible jumps. In the example of Fig. 2 this means in case 1 that all shown jumps are reversible jum ps. To increase our resolution in time we use not only the information of the averaged positions $\overline{r_i}$ (m) but also the complete information of r_i (t). In case 2 (see Fig. 2) the spikes in r_i (t) indicate returns to the average position before the jump [80]. If a jump satis es neither case 1 nor case 2, then it is called \irreversible jum p."

In the following we distinguish between the jump events, as they have been de ned so far, and the corresponding jumping particles which may undergo multiple jumps of dierent types. Any reversible jump designates the corresponding particle as a reversible jumper for the entire time window.

IV. NUMBER OF JUMPING PARTICLES




FIG. 3: Number of jumping particles normalized by the number of corresponding particle type as a function of temperature T. Irreversible and reversible jumpers are distinguished.

We apply now the above de nitions to identify all jum ps occurring in our sim ulations. The number of identi ed jum ps depends on the time interval of the production runs and, since the system is out of equilibrium, also on the waiting time before the production runs. The straightforward counting of jump events would give reversible jum pers (which sometimes jum pm any times) a larger weight. We therefore present the number of jumping particles. Fig. 3 shows the number of jumping particles normalized by the number N of particles in the 2 fA, Bq. With increasing temperasystem of type ture T the number of jumping particles increases consistent with an increasing number of relaxation processes. A sim ilar tem perature dependence has been found indirectly via the participation ratio in the work [3, 48, 81]. More surprisingly, we not that not only the small Bparticles are jumping but also a considerable fraction of A particles. However, the fraction of jumping B particles is larger than the fraction of jumping A particles due to the smaller size and therefore higher mobility of the B particles. Furtherm ore, both irreversible and reversible ium ps are not only occurring in a certain temperature





FIG. 4: Number of irreversible jumping particles divided by the number of both reversible and irreversible jumping particles. The inset shows the number of irreversible jump events divided by the number of jump events.




FIG. 5: This picture illustrates our interpretation of irreversible and reversible jumps and Fig. 4.

Fig. 4 illustrates the fraction of these jumping particles that are irreversible jumpers. At low to intermediate temperatures this ratio is, within the large error bars, roughly constant. At intermediate to larger temperatures irreversible jum pers becom e m ore likely than reversible jum pers with increasing tem perature. This increase is even more pronounced for all temperatures if one considers the number of irreversible jump events (instead of jum ping particles) divided by the number of all jum p events (see inset of Fig. 4). Gaukel et al. [6, 8, 21] com e to a sim ilar conclusion via a model for their sim ulation data. Their irreversible jumps become more likely with increasing temperature. We interpret this increase in the fraction of irreversible jumps as sketched in Fig. 5. Both irreversible and reversible jumps start out the same, with the jumping particle leaving the cage (form ed by the neighboring particles) possibly through an opening in the cage. In the case of the irreversible jump, the entrance of the cage gets m eanwhile blocked by a particle, loosely speaking the door gets closed, and the jumping particle can no longer return and has successfully escaped its cage. With increasing temperature all particles becom e m ore m obile, which increases the likelihood of the blockage of the entrance back into the cage which in turn

leads to an increase in the fraction of irreversible jumps as shown in Fig. 4. We do not intend to make here a statement about the exact geometric process, for example that a doorm ade up of a single particle gets open and closed, but more generally the process of rearrangement of the cage. Interestingly enough, this blockage happens more often in the case of the larger A than the smaller B-particles which leads to larger ratios for A than B particles in Fig. 4.

V. NUMBER OF AVERAGE POSITIONS

With each jump a particle either returns to one of its form er average positions within a cage or to a new overall average position. We call the average positions before and after a jump $h_{\overline{i}}i_i$ and $h_{\overline{i}}i_f$ (for details about the time averages $h_{i,k}$ see Fig. 11 and Sec. VII). We use as criterion for two average positions to be the same that the distance between them $h_{\overline{i}}i=\frac{1}{2}h_{i}i_f$ $h_{\overline{i}}i_j$ and the average uctuations before the jump $h_i^2i_i$ (for the de




FIG. 6: The number of average positions (as de ned in Sec. V) visited by jumping particles in a) as a function of temperature and in b) its distribution for irreversible jumping B particles.

shows an average of the number of distinct average positions which are visited by a particle. A coording to the higherm obility of the smaller B particles, they visit more average positions than the A particles. For low temperatures most jumping particles visit only two average positions during our simulation. For intermediate to larger temperatures, however, not only increasingly more particles jump (see Sec. IV) but these particles also jump more often. The distribution of the number of dierent visited average positions at the highest temperatures (as shown in Fig. 6b), broadens with increasing T such that some particles visit up to seven dierent average positions during the simulation run.

VI. TIMES




FIG. 7: Sketch to illustrate the de nitions of the starting time t_i and ending time t_f of a jump (here for jumps I and II) and the times before the rst jump of a particle t_{head} , during a jump t_d , between successive jumps t_b and after the last jump t_{tail} .




FIG. 8: Times between jumps t_b for A (circles) and B (diamonds) particles and times during jumps t_d for both A and B particles.

In this section we investigate the time scale of jumps. As sketched in Fig. 7 we determ in the time duration of a jump $t_d = t_f$ the time before the rst jump of a particle the time after the last jump of a particle t_{tail} , and the time between two successive jumps I and II to be $t_b = t_i^{II} \quad t_i^{I}$ where t_i and t_f indicate the starting and ending time of a jump [85]. Notice that to is only de ned if a jum p particle jum ps twice or m ore and that we analyze thead and tail separately as presented shortly. For the distinction of irreversible and reversible jum ps, we assign the jum p type of to according to the jump ending to, for example in Fig. 7 the jump type of to is determined by jump II. This means that to is a measure of the waiting time before a jump occurs. t_b which tells us in hind-Fig. 8 illustrates that t_d sight why we could identify jumps as rare events with the above described procedure. Since the time resolution is

of the order of 1000 (20 2000 0:02), i.e. of the same order as t_d , we do not draw further conclusions about the tem perature dependence of t_d . However, t_b is well above our time resolution and small enough to be detected during our simulation run of length 1 f0. In accordance with the picture of reversible jumpers which try but do not succeed to escape their cage, these trials happen on a shorter time scale than irreversible jumps. However, to our surprise, t_b seems to be independent not only of the particle type but also of temperature. The question arises if this temperature independence of t_b is a consequence of the nite time window of our simulation. To take this nite time interval t_{ot} into account, we make a crude approximation to correct the time intervals

 $t_{\rm b}$, $t_{\rm head}$ and $t_{\rm tail}$ by assuming that jumps happen equally likely at any time in the window [0; $t_{\rm tot}$] (which is not accurate due to aging). The probability $P_{\rm corr}$ (t) of nding the complete interval treduces to the probability of nding the during [0; $t_{\rm tot}$] in the simulation




FIG. 9: Times t_b , t_{head} and t_{tail} a) for irreversible jumps and b) for reversible jumps of A and B particles using Eq. (10).




FIG. 10: Log-log plot of P (t_b) using Eq. (9) for irreversible jumps of A and B particles. The line is a linear tto the data with slope 0:84.

Fig. 9a and Fig. 9b show the resulting corrected times h ticorr for irreversible and reversible jumps respectively. For simplication of notation we drop h_{col} in the following. The tail and head times, ttail and thead, revealthat we nd aging, since tail > t_{head}, i.e. jum ps are more likely to occur at the beginning of the simulation than later. This particular aging e ect decreases with increasing temperature. t_{tail} and t_{head} are both larger than to because to includes only times of particles which jump multiple times whereas thead and ttail include also times of particles which jump only once. Interestingly, to is (although approximately corrected) still independent of tem perature. Together with our results of Secs. III { V we therefore nd that with increasing tem perature relaxation processes are accelerated via m ore jum ping particles and m ore multiple jum ps, but the times between multiple jumps do not become shorter. This is contrary to previous results [19, 34, 58, 59, 82] in which waiting times decrease with increasing temperature. In our system, however, the tem perature independence seem s to be true not only for the averages but even for the distribution P_{corr} (t_b) (see Fig. 10). We interpret this tem perature independence as being due to aging

which is consistent with our data for t_{tail} and t_{head} and with the results of Doliwa et al. [58, 59] who nd that the distribution of waiting times in itially is temperature independent and becom es tem perature dependent at later times. As shown in Fig. 10 for irreversible jumps of A and B particles, P (t_{b}) approximately follows a t_b with = 0:84. Even though powerlaw P (t_b) / we expect the system to show normaldi usion on a time scale much larger than our simulation run, the intermediate dynamics is subdi usive [83]. Please notice however that a direct comparison of our result with the scheme presented in Fig. 1 of [83] is not possible because in our case the multiple jumps of one particle at dierent times as well as the jumps of dierent particles are not independent, which changes the dynamics [84].




FIG. 11: Sketch for the de nitions of R $_{\rm if}$ R $_{\rm max}$ and R $_{\rm avg}$.

In the last sections we have investigated how many particles jump and how often jumps occur. Next we study how far these particles jump. To be able to test if our qualitative results are dependent on the denition of jump length, we use three quantities: R_{if} , R_{max} and

 R_{avg} as sketched in Fig. 11. For a jump of particle i the jump distance of the jump starting at t_i and ending at t_f (for the de nition of t_i and t_f see [85]) is

and the maximaldistance being detected during the jump

(here 3200 = 4 20 2000 0.02 as in [79] and Sec. II where t is varied over times twhich satisfy $t_{i,detect}$ t < $t_{f,detect}$ ([85]). The third length R $_{avg}$ is less dependent on uctuations than R $_{if}$ and R $_{max}$. It is the distance of the overall average positions before and after the jump






FIG. 12: a) The jump sizes R $_{\rm if}$, R $_{\rm max}$ and R $_{\rm avg}$ (sketched in Fig. 11 and de ned in the text) as function of temperature T . The averages are over both irreversible and reversible jumps of both A and B particles. b) The jump size R $_{\rm avg}$ as function of temperature T separately for irreversible and reversible jumps of A and B particles.

For the averages h $_{\rm f}$ iand h $_{\rm i}$ ithe positions $\overline{r_{\rm i}}$ (t) are averaged over times before and after the jump excluding a broadened time window around the jump $t_{\rm i}$ 800; $t_{\rm f}$ + 800]. Fig. 12a shows that the dierent jump lengths have the same qualitative behavior, namely, as one might expect, an increase with increasing temperature T . We therefore show in the following mainly results for only

 $R_{\rm avg}$ but $\;$ nd very sim ilar behavior in the case of $\;R_{\rm if}$ and $\;R_{\rm m.ax}$. An increase in jump size with increasing temperature has been seen in previous simulations $[3,\,19,\,34,\,48,\,81]$. However in the case of $[3,\,48,\,81]$ the jump size is for a jump in the MSD, i.e. an average over all particles, which includes two elects: an increasing number of jumping particles and an increase in the jump size of single particle jumps. Our approach has the advantage of keeping these two elects separate. Furthermore, in our case the single particle jumps are larger than in $[3,\,34,\,48,\,81]$.

Fig. 12b is the same as Fig. 12a for R $_{\rm avg}$ but broken down by both jump and particle type. The smaller B particles are jumping further than the A particles. Furthermore reversible jumps are shorter than the irreversible jumps, which is due to two features in the distribution P ($\rm R_{avg}$).




FIG.13: The distribution of jump sizes R $_{\rm avg}$ for irreversible and reversible jumps of A and B particles at T = 0.43. The inset shows R $_{\rm avg}$ of irreversible jumping A particles for different temperatures.

As illustrated in Fig. 13 both irreversible and reversible jumps have a peak at about 0.8 and 1.0 for A and B particles respectively. These peaks are relatively similar for reversible and irreversible jumps, taking aside that for irreversible jumps this peak position is slightly shifted to the right and slightly broadened (partly due to multiple jumps which are not resolved in time). This similarity and the peak positions around unity are consistent with our picture that irreversible and reversible jumps start out the same, namely with a particle jumping out of its

cage. A new feature, however, is that the distribution of reversible jumps for T=0.43 (and similarly for all other temperatures) has a bim odal distribution with an additional peak at a distance smaller than 0.2, contrary to the distribution of irreversible jumps. This seems to indicate for reversible jumps another process than a jump out of a cage because the latter would be of the order 0.5 and larger.

The increase of R $_{\rm avg}$ with increasing tem perature is a consequence of both a shift of the peak position and a broadening of the distribution of jum p sizes. This is illustrated in the inset of F ig. 13 for irreversible jum ps of A particles and we nd similar distributions for irreversible jum ps of B particles. At the largest investigated tem perature T = 0.43 some of the particles m ove as far as four particle spacings. Some of these large jum ps m ight correspond to multiple jum ps of a smaller time window than our time resolution.




FIG .14: Log-log plot of the distribution of jump sizes R $_{\rm avg}$ for irreversible jumps of A and B particles including all temperatures. The lines are linear tswith slopes 6:3 for A and 4:8 for B particles.

For irreversible jumps of size unity and larger we not that the distribution for all temperatures follow roughly a power law P(R) R (see Fig. 14) with = 6:3 for A and = 4:8 for B particles. This is in accordance with subdictive behavior for intermediate times as presented in Sec. VI for the distribution of waiting times [83].




FIG. 15: Fluctuations in position for jumping particles $_{jump}$, of the original estimate for jumping particles $_{est}$, and for non-jumping particles $_{no\;jum\;p}$. For the average of $_{jum\;p}$ uctuations during the jump have been excluded from the average.

As commented on earlier (see Sec. I and Sec III), our de nition for a jump is not based on a specied size but instead a multiple of the uctuations of the particle. Let us therefore next look at the uctuations. Fig. 15 shows a comparison of the uctuations of jumping particles $_{\rm jum\,p}$ and of non-jumping particles $_{\rm no\,jum\,p}$. Also included in Fig. 15 is an average over all particles $_{\rm est}$ of the estimates for uctuations $_{\rm jest}$ as they have been used for the jump

identi cation (see Sec. III and [79]). $_{\rm est}$ is very sim ilar to $_{\rm no\,jum\,p}$ and represents the uctuations of an average particle. For the average of $_{\rm jum\,p}$ we exclude uctuations during the jum p: for jum ping particle i we take

where $_{i}$ and h $_{i}$ are de ned as in [79] and earlier in this section respectively. Although jump times are excluded, the uctuations of jumping particles are clearly larger than the uctuations of non-jumping particles. This means that jumping particles are not only moving farther than an average particle during single events but are also oscillating within their cages with a larger than average amplitude.




FIG .16:a) Normalized jump size R $_{\rm avg}=_{\rm jump}$ as function of temperature separately for irreversible and reversible jumps of A and B particles. b) D istribution of normalized jump size P (R $_{\rm avg}=_{\rm est}$) of irreversible jumping A particles and reversible jumping B particles in the inset.

Fig. 16a shows an average of jump size relative to the particle's uctuation $R_{i,avg} = i,j_{llm}p$ for jumping particles i. $R_{avg} = j_{llm}p$ seems independent of temperature for reversible jumps and for irreversible jumps slightly increasing with increasing temperature.

The distribution of R = gives us the opportunity to estimate the in uence of the cuto in our de nition of a jump. Similar to our approach for the search of a jum p, we use $_{\rm est}$, and obtain P ($R_{\rm avg} = _{\rm est}$) as shown in Fig. 16b for irreversible jumps of A particles. We nd a peak at ($R_{avg} = est$) 5:5 (for B-particles ie. larger than our cuto at $(R =) = \frac{1}{20}$ 4:5. This gives us the hope that we have included the major contribution of jum ps consistent with our approach. We have to bear in m ind, however, that $R_{avg} = est$ is not the identical measure to the one used in our search procedure. Furtherm ore, in the case of reversible jumps there is some additional peak at smaller values of ($R_{avg} = est$) (see inset of Fig. 16b) which is consistent with Fig. 13 and m ight indicate som e additional process.

VIII. ENERGY

In the previous sections we have investigated relaxation processes by solely using the positions (trajectories) of

single particles. As the work [55, 56, 57, 58, 59, 60] shows, an approach via potential energies can also be fruitful. We therefore study in this section what happens to the potential energy during jumps. As sketched in




FIG. 17: Sketch for the de nitions of hE i; and hE if.

Fig. 17, we still use single particle trajectories to identify the jumping particle and do similar averaging for the according time windows h $_{\rm i}$ iand h $_{\rm f}$ i(see Sec. V II). We investigate both the total potential energy per particle

where V $(r_{i,j}(t))$ is de ned in Eq. (5). To obtain in addition the energies of the inherent structures [86] we minimized the congurations (fr (t)g) via a steepest decent procedure. With the thus obtained conguration (fr (t)g) we determine

Similar to the jump size in position (see Fig. 17 and Sec.VII) we then determ ine



and sim ilarly for the energies of Eq. (16) { (18).

We nd in most of our analysis that E_{avg} and E_{if} (and all other equivalents for E^0 ; E_i and E_i^0) are showing the same qualitative behavior, and therefore present in the following results for E_{avg} using Eq. (19) and






FIG .18: As a function oftem perature T a) jump size in total potential energy E $_{\rm avg}$ and b) absolute value of the jump size in m in im ized single particle potential energy j E $_{\rm i,avg}^{\rm 0}$ j.

Fig. 18a shows E_{avg} as a function of tem perature averaged separately over irreversible and reversible jumps of A and B particles. Notice that the energy jumps are sm all compared to energy values hE $\mathbf{i}_{i,f}$ 7. The irreversible jum ps lower the energies more than reversible jumps and more so for A than B particles, because a jum p of a larger A particle results in a bigger change in environm ent than for a smaller B-particle. The low ering of the total potential energy happens mostly at interm ediate tem peratures and less at the lowest and highest investigated temperatures. This might be an aging effect: at low temperatures the system is basically frozen in, at intermediate temperatures the system has time to partially age, and at higher tem peratures the system has already aged before the production run starts. This effect is lost when we look at the jumps in single particle

energies $E_{i;avg}$ (T) which is basically zero for all jumps. We therefore nd that the total potential energies E_{avg} ,

 E_{if} , E_{avg}^{0} , and E_{if}^{0} show a more system atic dependence on temperature than their single particle equivalents $E_{i;avg}$ etc.. For the absolute values j E_{avg} jetc. and all following quantities, however, we not the opposite, i.e. the single particle equivalents j $E_{i;avg}$ jetc. show a more pronounced behavior. We therefore show from now on the results which use Eq. (16) and Eq. (18) only.

We next look at the absolute value j E $_{i;avg}^{0}$ jas a function of tem perature (see Fig. 18b). As one might expect, the irreversible jumps show larger changes in energy than reversible jumps, due to larger jumps in position (Fig. 12b) and therefore more change in the environment of the jumping particle. And similarly the larger A particles in comparison with the smaller B particles experience a larger change in energy because A particles are surrounded by more neighbors, i.e. a larger environment. With increasing temperature the absolute value of the jump in energy (Fig. 18b) is increasing (with the one exception of irreversible B particles) which is consistent with the increase in jump position (Fig. 12b).





FIG. 19: Fluctuations in single particle potential energy as a function of tem perature. The average is in a) over irreversible and reversible jump events of A and B particles separately and in b) over jumping particles ($_{\rm E}$ $_{\rm i,jump}$) and over non-jumping particles ($_{\rm E}$ $_{\rm i,jump}$).

sim ilar to the uctuations in position [79] where \overline{E}_i (m) is the time average $\frac{1}{20}$ $\sum_{m=0}^{m} p^{-10} E_i$ (m 0). The energy uctua-

tions are also increasing with increasing tem perature and are larger for A than B particles (see Fig. 19a). The uctuations of irreversible and reversible jumps are however very similar, which is consistent with the picture that reversible jumps are \failed" irreversible jumps and in that sense start out the same way as irreversible jumps.

Fig. 19b is a comparison of energy uctuations of jumping (both irreversible and reversible and of both A and B) particles $E_{i,jump}$ and of non-jumping particles $E_{i,nojump}$ [87]. In $E_{i,jump}$ we exclude the times during the jump by using the time windows $h_{i,j}$. We not that the energy uctuations of jumping particles are larger than for non-jumping particles which is consistent with the corresponding uctuations in position (see Fig. 15).




FIG. 20: Absolute value of single particle potential energy divided by its uctuation jE $_{i;avg}$ j= $_{E_{\,i}}$ in a) as a function of tem perature and in b) its distribution .

By nom alizing j $E_{i,avg}$ jw ith the uctuations E_i we obtain F ig. 20a. Sim ilar to the case of norm alized jumps in position (F ig. 16a) we not that j $E_{i,avg}$ $\not\models_{E_i}$ is for reversible jumps basically independent of temperature. For irreversible jumps, however j $E_{i,avg}$ $\not\models_{E_i}$ decreases signicantly with increasing temperature. This indicates that with increasing temperature the jumps are increasingly more driven by uctuations. Contrary to the equivalent in position (Fig. 16a), the normalized energies are signicantly smaller, in the range 0.5 { 1.4 rather than 3 { 7, and the distribution of j $E_{i,avg}$ $\not\models_{E_i}$ (see Fig. 20b) is monotonous decreasing with a less far reaching tail than

IX. CONCLUSIONS

We study the dynamics of a binary Lennard-Jones system below the glass transition. Our focus is on jump-

processes, which we identify via single particle trajectories. Two kind of jum ps are found: \reversible jum ps," where a particle jumps back and forth between one or m ore average positions, and \irreversible jum ps," where a particle does not return to any of its form er average positions, i.e. successfully escapes its cage of neighbors. Both irreversible and reversible jumps of A and B particles occur at all tem peratures. With increasing tem perature m ore particles jump, m ore average positions are visited, the jump size both in position and in the ab-and j E_i⁰ j (total and single-particle, not m in im ized and m in im ized) increase, and the $\,$ uctuations in position $_{R}$ and potential energy $_{\rm E}$ increase. The uctuations are larger for jumping particles than for non-jumping particles even if uctuations during the jump are not part of the average, which indicates that jumping particles are not only during jump times more mobile than nonjum ping particles. The ratio $j E_i = E_i$ of irreversible jum ps decreases with increasing tem perature. This con-

rm s a commonly used assumption that with increasing temperature the irreversible jumps become more driven by uctuations.

With increasing temperature also irreversible jumps become proportionally more frequent than reversible jum ps. We interpret this such that irreversible and reversible jumps are similar in that sense that a particle tries to escape its cage. In the case of reversible jumps the particle nds its way back into the cage whereas in the case of an irreversible jump the path back into the cage becom es blocked due to rearrangem ents of the cage. At larger tem perature these rearrangem ents of the cage become more likely (since for example the uctuations increase) and therefore irreversible jum psoccurm ore often. Irreversible and reversible jumps show in most quantities qualitatively the same behavior, such as their temperature dependence of jump size in position and energy, and di er only in size. An exception to this sim ilarity is the distribution of jump sizes, which suggests that there might be an additional jump process in the case of reversible jumps indicated by an additional peak at small jum p sizes.

Them ost surprising result of our work is that the times between successive jumps are independent of temperature. This is most likely due to aging, which could mean on the time scale of our simulation that to re ects the time scale of T = 0:446 from which we quenched the system , and that t_b m ight show tem perature dependence at later times. The latter would be consistent with the work of Doliwa et al. [58, 59] who nd in their simulations of very long times that the distribution of waiting times (however, identi ed via the collective quantity of the minimized potential energy) initially is temperature independent and ofdi erent power law than at later tim es when tem perature dependence occurs. We do nd aging in that sense that the times before the rst jump are shorter than the times after the last jump of a particle (an e ect which becomes less for temperatures near $T_{\rm c}$).

Future work (which is in progress) will tell us if in our system t_b becomes temperature dependent after longer times. However, the dynamics does depend on temperature for all other here investigated quantities such as the number of jumps and the fraction of reversible jumps.

Another question which we would like to raise for future work is how much single particle jumps can tell us about relaxations of a glass which might include collective motion. It seem splausible that single particle jumps are strongly correlated with collective jumps and in that sense give us very sim ilar inform ation to studies of collective quantities. We nd that many of the single particle jumps in our system are spatially and temporally correlated, i.e. are showing collective motion. Systematic studies for con mation remain to be done in the future. We also not the signature of many-particle e ects conm ed in the result of the increasing ratio of irreversible jum ps with increasing tem perature, since this indicates that not only the jum ping particle itself but also its cage are dependent on temperature. There might, however, be also collective jum ps, where each particle jum ps a too sm all am ount to be detected by our search algorithm. It remains to be studied of how much importance such processes are in our system.
