D ielectric photonic crystal as medium with negative electric perm ittivity and magnetic perm eability

Abstract

We show that a two-dimensional photonic crystal (PC) made from a non-magnetic dielectric is a left-handed material in the sense de ned by Veselago. Namely, it has negative values of both the electric permittivity and the magnetic permeability in some frequency range. This follows from a recently proven general theorem. The negative values of and are found by a numerical simulation. U sing these values we demonstrate the Veselago lens, a unique optical device predicted by Veselago. An approximate analytical theory is proposed to calculate the values of and from the PC band structure. It gives the results that are close to those obtained by the numerical simulation. The theory explains how a non-zero magnetization arises in a non-magnetic PC. About 35 years ago V ictor Veselago [1] considered theoretically propagation of the electrom agnetic waves (EMW 's) in a hypothetical left-handed m edium (LHM), where both the electric permittivity and the magnetic permeability are negative in some frequency range. Since the square of the speed of light $c^2 = c_0^2 = is$ positive, the EMW 's propagate but they have unusual properties, like anom abous D oppler and C herenkov e ects, negative light pressure, and negative refraction (NR) at the interface with a regular m edium. The latter property enables three-dimensional (3D) im aging. The origin of all these properties is the fact that the energy ux, S and the wave vector, k are antiparallel in the LHM. An important assumption of Veselago's theory is the absence of spatial dispersion, which means that both and are k-independent. However both of them are functions of frequency. A generalization of Veselago's theory for the case of spatial dispersion would not be simple because in this case the expression for the Poynting vector includes an extra term [2].

To create the LHM Veselago proposed to combine two independent di erent subsystems [1], one with a negative and another with a negative . As an example, he considered a ferrom agnetic m etal at frequency close to the ferrom agnetic resonance and below the plasm a frequency of the m etal. Following this line, the San D iego group β] has observed a NR in an articial composite system and attributed this e ect to a two-dimensional (2D) LHM. Their system consists of two elements: 2D m etallic photonic crystal (PC) creating negative

below a cuto frequency and the so-called split-ring resonators creating negative due to anom alous dispersion near the resonance. The experiments of the San D iego group are very important because they have ignited the whole eld, started by Veselago about 35 years ago but completely forgotten since then. However they caused new hot debates concerning di erent aspects of their experiments and interpretations [4, 5, 6, 7, 8].

M any groups[9, 10, 11, 12, 13] predicted and observed NR in PC's using for the prediction the dispersion relation of EMW 's and m ethods of geom etrical optics. However, the \e ective refractive index" they found was, in general, a function of k. W e think that it originates from the spatial dispersion of the dielectric constant for EMW with k deep in the Brillouin zone. Several authors[9, 10, 12] found that near the point this index becom es k-independent. A swe show below, together with the negative group velocity this indeed is a manifestation of the LHM.

The main idea of this work is based upon the theorem proved in Ref. [14]. It reads that the group velocity $v_g = 0! = 0k$ in an isotropic medium is positive in the regular

media (RM)(> 0, > 0) and negative in the LHM. This means that vectors 0!=0kand k are parallel in the RM and antiparallel in the LHM. This theorem follows from the therm odynamics requirement that the energy of electromagnetic elds is positive.

Now we generalize this theorem to a 2D PC illustrated in the left bottom inset of Fig. 1. The PC represents a square lattice of period d, comprising cylindrical holes in a dielectric m edium with the axes of cylinders along z-direction. We consider propagation of EMW's with the electric eld E in this direction (s-wave). The calculated [15] low frequency spectrum of EMW's in this PC is shown in Fig. 1 for the case when the dielectric m aterial of the crystal is characterized by $_{\rm m} = 12$, $_{\rm m} = 1$. The elds in the PC are represented by the B loch functions with a 2D wave vector $k = (k_{\rm x}, k_{\rm y})$. O ne can see from Fig. 1 that in the frequency range a little below the top of the band 1 at the point, the group velocity 0! = 0! is not degenerate at -point. Near the -point the wavelength is much larger than the lattice period of the PC and one can introduce k-independent $_{\rm ik}$ and $_{\rm ik}$. Since z-axis is the axis of C₄ symmetry, we have a uniaxial crystal and both tensors in the principal axes have only two components $_{\rm zz}$, $_{\rm i} = _{\rm yy}$ and $_{\rm zz}$, $_{\rm i} = _{\rm yy}$ respectively. The electrom agnetic energy density of the s-wave can be represented in the form [2]

where $n^2 = z_{z_2}$. In the rest of the paper we use notation $z_z = r_{,2} = ...$ Since U > 0 we get $(v_g = k) > 0$, where 2D group velocity $v_g = 2c_0^2 k = [d(!^2n^2)=d!]$. Thus, negative $v_g = k$ means negative and vise versa. For the propagating waves it also means < 0. It follows that this PC is a LHM in the frequency range under study.

Note, that the p-wave (magnetic eld in z direction) is characterized by $_{?}$ and $_{zz}$. These components might also be negative in the vicinity of the point but within a di erent frequency range.

We nd and by microscopic calculations and show that they are indeed both negative in the frequency range under study. For this purpose we consider a PC slab in nite in z-direction and embedded in a hom ogeneous medium with ⁰, ⁰. A 2D point source (an in nite dipole along z-axis) is located in the hom ogeneous medium to the left of the slab. If we now choose ⁰ and ⁰ so that the cylindrical wave in the system is the same as it would be in a completely hom ogeneous medium with ⁰ and ⁰ (though inside the slab there is a m icroscopic eld), the values of ⁰ and ⁰ obtained in this way are the m acroscopic and of the slab at a given frequency. The best choice for ⁰ and ⁰ at the working frequency $! = 0.3 (2 c_0=d)$ is obtained by a tting procedure and the result is shown in Fig. 2. It yields = 1.2, = 0.096. Thus, at this frequency the PC slab is a LHM and this result is in accordance with the above theorem. Note, that in the case of the LHM the vectors S and k are in the opposite directions (see an in ation [16]).

One can calculate independently the refractive index of the slab $n^2 = from$ the dispersion relation of the band 1. At small k it can be written in a form $!^2 = !_1^2 \quad c_0^2 k^2 \cdot 0$ ur calculation of spectrum gives $= 0.94, !_1 = 0.314 (2 \ c_0 = d) \cdot U$ sing the alternative de nition of n^2 namely, $!^2n^2 = c_0^2k^2$ one gets

Note, that n ! 0 as $! ! !_1$. At the working frequency $n^2 = (0.32)^2$, which agrees with and found above.

If we choose 0 = j jand 0 = j jas the parameters of the hom ogeneous medium surrounding the PC, we obtain a unique device proposed by Veselago [1] that we call the Veselago lens. It is shown schematically in Fig. 3a. The computer simulation of the Veselago lens is shown in Fig. 4 (also see an imation [16]). In the above simulations the PC is cut in the direction [10]. We have checked that the results do not change if the PC is cut in the direction [11]. This con most he absence of spatial dispersion at the working frequency. The size of the focus is of the order of the wavelength as predicted by the direction theory [17].




FIG. 1: The lowest bands of the 2D photonic crystal that is shown in the left bottom inset. The cylindrical hole radius is 0.35d. D ashed line indicates the working frequency. Central insets show signs of electric eld in a unit cell for bands 2, 3 at k = 0. Points M and X are at the boundary of the B rillouin zone in directions [1;1] and [1;0] respectively.

Now we explain how the starting theorem that follows from Eq.(1) and is form ulated in terms of macroscopic electrodynamics can be interpreted microscopically. The negative group velocity shown at Fig. 1 results from the repulsion of bands 1 and 2, 3. Therefore a microscopic explanation of negative should be found in terms of the interaction between these bands. We propose a quantitative explanation by writing Maxwell's equation for the microscopic eld e_z (r) in a matrix form [18, 19] in the basis of B loch functions at k = 0. Taking into account that near the -point the bands 1, 2, 3, 4 are far from the other bands, we truncate the matrix keeping only these four bands. This approximation is analogous to the K ane model in semiconductor physics[20]. By diagonalizing the truncated matrix we nd the spectra of all four bands and the correct combinations of basis functions for each band at nite k. We have checked that the dispersion law for all bands 1–4 as obtained from the truncated model does not dier by more than 4% from the result presented in Fig. 1 at kd=2 < 0.1. At small k the microscopic electric eld for the band 1 has the form

where r is the 2D -vector, u_1 , u_2 , u_3 and u_4 are the B loch functions at k = 0, the positive parameters k_0 , k_1 have the dimensionality of a wave vector and they are integrals from these functions. The symmetry of the function u_1 is $X^2 = Y^2$. The function u_4 has $X^2 + Y^2$ symmetry. The functions u_2 and u_3 have the symmetries X and Y respectively. The parity of X and Y functions within the elementary cell is shown in the central inset of Fig. 1.

If the material of the PC were metallic, the electric eld in the bands 2 and 3 would create two currents in opposite directions. These currents would induce a magnetic moment in x and y directions. In case of the dielectric PC these currents are imaginary displacement currents and they do not create any magnetic moment in the modes 2 and 3. However, as follows from Eq.(3) the admixture of bands 2 and 3 to band 1 is also imaginary. Therefore the band 1 has a realmagnetic moment.

The magnetization can be calculated using the expression

where $P = ze_z(r) [(r) 1]=4$, z is a unit vector in z direction, (r) = 1 inside the holes and $_{\rm m}$ otherwise, the integration is performed over the unit cell, and e_z (r) is given by Eq.(3). Only the second and the third terms from Eq.(3) contribute to the magnetization. The result can be expressed through the integrals from u_2 and u_3 . These functions have been taken from the computation of the spectrum shown at Fig. 1. The macroscopic vectors B and E are connected by the relation $B = c_0 k$ E = !, where E = z < q (r) > and < ::: >m eans averaging over the unit cell. Only the function u_4 gives a non-zero contribution after the averaging. It gives the main contribution to E. O ther basis functions give non-zero contribution only when multiplied by r-dependent terms in the expansion of the exp (ik r) within the unit cell. Their contributions to E are of the same order in k but they are much smaller than the contribution from u_4 since (!₄ !₁)=!₁ 1, where $!_1$ and $!_4$ are the frequencies of the bands 1 and 4 at k = 0. In fact, the latter strong inequality permits truncation of the matrix in our analytical model.

C om paring Eq.(2) and Eq.(5) one can see that the root of $at ! = !_1$ is responsible for the root of n^2 . This means that is non-zero and negative $at ! = !_1$. On the other hand, changes its sign $at ! = !_1$. Thus, the gap $at ! > !_1$ is due to < 0.At ! = 0.3 (2 g=d) one gets = 0.084 and that is very close to the value obtained above by the tting procedure. Thus, we have found analytically the value of .

The 3D LHM can be obtained in the same way, for example, using the PC with the cubic symmetry proposed by Luo et al.[12]. This PC also has a negative group velocity near the point with no other bands at this frequency.

Thus, we have shown that the LHM can be readily obtained using only one dielectric PC that creates both negative and .W e have presented the physical explanation of this phenom enon in a 2D case. The working frequency can be easily changed in a wide range by changing the lattice constant and $_{\rm m}$ of the PC. It is important for applications that the losses in a dielectric PC are much smaller than in a metallic one. We have found not only n but also and that are necessary to describe the dynam ical properties of the interfaces. This is especially important for the creation of the Veselago lens, which requires no relation at interfaces, thus imposing two matching conditions on and .By matching n only one gets a modi cation of the Veselago lens with multiple foci (Fig. 3b) [21]. We realize, that we have not presented a method of matching the LHM with the surrounding medium. This matching is very easy in computational approach but it must be handled creatively on the way toward real devices.




FIG. 2: Finding the values of and of PC using the propagation of EMW's from the 2D point source through the slab of the PC.Param eters of the hom ogeneous medium are $^{0} = 12$, $^{0} = 0.096$. B lack curves show the circles centered at the point source. One can see that EMW's in the hom ogeneous medium almost ignore the slab. We conclude from this that $= ^{0}$, $= ^{0}$. Vectors S and k are opposite to each other as it should be in the LHM. The computations are performed by the nite-element method with perfectly matched layers at the boundaries.




FIG. 3: 3D in aging by the lenses based upon LHM. The objects are marked by bulbs. The negative refraction at the interfaces is obtained from electrodynamics conditions of continuity of the tangential component of k and the norm alcomponent of S, and from the main LHM property that the direction of S is opposite to the direction of k (shown by arrow s). a) The lens proposed by Veselago (Veselago lens[1]). In this case 0 = j j 0 = j j the rejected waves are absent and the lens has only one external focus. b) Multifocal lens[21] with 0 = 0 . The multiple foci appear due to rejected waves.




FIG. 4: C om puter simulation of the 2D Veselago lens. In this case $^{0} = jj$, $^{0} = jj$. The curves show the circles centered in the point source to the left of the PC slab and at the focus to the right of the slab. D etails of the simulation are similar to Fig. 2.
