# D ielectric photonic crystal as m edium with negative electric perm ittivity and $m$ agnetic perm eability

#### Abstract

W e show that a two-dim ensional photonic crystal (PC) m ade from a non-m agnetic dielectric is a left-handed $m$ aterial in the sense de ned by Veselago. $N$ am ely, it has negative values of both the electric pem ittivity and the $m$ agnetic perm eability in som e frequency range. This follow s from a recently proven general theorem. The negative values of and are found by a num erical sim ulation. U sing these values we dem onstrate the Veselago lens, a unique optical device predicted by Veselago. An approxim ate analytical theory is proposed to calculate the values of and from the PC band structure. It gives the results that are close to those obtained by the num erical sim ulation. The theory explains how a non-zero $m$ agnetization arises in a non-m agnetic PC .


A bout 35 years ago V ictor Veselago [ī1] considered theoretically propagation of the electrom agnetic waves (EM W 's) in a hypothetical left-handed medium (LHM), where both the electric perm ittivity and the $m$ agnetic perm eability are negative in some frequency range. Since the square of the speed of light $c^{2}=c_{0}^{2}=\quad$ is positive, the EM $W$ 's propagate but they have unusual properties, like anom alous D oppler and C herenkov e ects, negative light pressure, and negative refraction (NR) at the interface with a regular m edium. The latter property enables three-dim ensional (3D ) im aging. The origin of all these properties is the fact that the energy $u x, S$ and the wave vector, $k$ are antiparallel in the LHM. An im portant assum ption of Veselago's theory is the absence of spatial dispersion, which $m$ eans that both and are k -independent. H ow ever both of them are fiunctions of frequency. A generalization of Veselago's theory for the case of spatial dispersion would not be sim ple because in this case the expression for the P oynting vector includes an extra term

To create the LHM Veselago proposed to com bine tw o independent di erent subsystem s [i] ], one with a negative and another with a negative. A s an exam ple, he considered a ferrom agnetic $m$ etalat frequency close to the ferrom agnetic resonance and below the plasm a frequency of the $m$ etal. Follow ing this line, the San D iego group tē] has observed a NR in an arti cial com posite system and attributed this e ect to a two-dim ensional (2D ) LHM . Their system consists of two elem ents: 2D m etallic photonic crystal (PC) creating negative below a cuto frequency and the so-called split-ring resonators creating negative due to anom alous dispersion near the resonance. The experim ents of the San D iego group are very im portant because they have ignited the whole eld, started by Veselago about 35 years ago but com pletely forgotten since then. H ow ever they caused new hot debates conceming di erent aspects of their experim ents and intenpretations
 the dispersion relation ofEM $W$ 's and m ethods ofgeom etricaloptics. H ow ever, the \e ective refractive index" they found was, in general, a function ofk. W e think that it originates from the spatial dispersion of the dielectric constant for EM $W$ w ith $k$ deep in the $B$ rillouin zone.
 A s we show below, together with the negative group velocity this indeed is a m anifestation of the LHM .

The $m$ ain idea of this work is based upon the theorem proved in Ref. $\left.{ }_{[1]-\overline{1}}^{1}\right]$. It reads that the group velocity $\mathrm{v}_{\mathrm{g}}=@!=@ \mathrm{k}$ in an isotropic m edium is positive in the regular
media $(R M)(>0,>0)$ and negative in the LHM. This means that vectors $@!=@ k$ and $k$ are parallel in the RM and antiparallel in the LHM. This theorem follows from the therm odynam ics requirem ent that the energy of electrom agnetic elds is positive.

N ow we generalize this theorem to a 2D PC illustrated in the left bottom inset ofF ig. 'ī1. The PC represents a square lattice of period $d$, com prising cylindrical holes in a dielectric $m$ edium w th the axes of cylinders along $z$-direction. W e consider propagation of EM W 's $w$ th the electric eld $E$ in this direction (swave). The calculated lipil low frequency spectrum of EM $W$ ' $s$ in this PC is show $n$ in $F$ ig. for the case when the dielectric $m$ aterial of the crystal is characterized by $m=12, m=1$. The elds in the PC are represented by the $B$ loch functions with a 2D wave vector $k=\left(k_{x}, k_{y}\right)$. O ne can see from $F$ ig. . ${ }_{1}$, that in the frequency range a little below the top of the band 1 at the point, the group velocity $@!=@ k$ is negative and there are no other bands in this frequency range. It is also im portant that band 1 is not degenerate at -point. Near the -point the wavelength is much larger than the lattice period of the PC and one can introduce $k$-independent $i k$ and $i k$. Since $z$-axis is the axis of $C_{4}$ sym $m$ etry, we have a uniaxial crystal and both tensors in the principal axes have only two components zz , ? $=\mathrm{xx}=\mathrm{yy}$ and zzr ? $=\mathrm{xx}^{=} \mathrm{yy}$ respectively. The electrom agnetic energy density of the swave can be represented in the form [íl

where $n^{2}={ }_{z z}$ ?. In the rest of the paper we use notation $z=, \quad=\quad$. Since $U>0$ we get $\left(v_{g} \quad k\right)>0$, where 2D group velocity $\mathrm{v}=2 \mathrm{c}_{0}^{2} \mathrm{k}=\left[\mathrm{d}\left(!^{2} \mathrm{n}^{2}\right)=\mathrm{d}!\right]$. Thus, negative $\mathrm{v}_{\mathrm{g}} \quad \mathrm{k}$ $m$ eans negative and vise versa. For the propagating waves it also means < 0. It follows that this $P C$ is a LHM in the frequency range under study.
$N$ ote, that the $p$-wave ( $m$ agnetic eld in $z$ direction) is characterized by ? and zz . $T$ hese com ponents $m$ ight also be negative in the vicinity of the point but within a di erent frequency range.

W e nd and by microscopic calculations and show that they are indeed both negative in the frequency range under study. For this purpose we consider a PC slab in nite in $z$-direction and em bedded in a hom ogeneous medium with ${ }^{0},^{0}$. A 2D point source (an in nite dipole along $z$-axis) is located in the hom ogeneous m edium to the left of the slab. If we now choose ${ }^{0}$ and ${ }^{0}$ so that the cylindrical wave in the system is the same as it would be in a com pletely hom ogeneous medium with ${ }^{0}$ and ${ }^{0}$ (though inside the slab there is a
$m$ icroscopic eld), the values of ${ }^{0}$ and ${ }^{0}$ obtained in this way are the macrosoopic and of the slab at a given frequency. The best choice for ${ }^{0}$ and ${ }^{0}$ at the working frequency $!=0: 3\left(2 c_{0}=d\right)$ is obtained by a tting procedure and the result is shown in $F$ ig. $\overline{\mathrm{Z}}$. It yields $=1: 2,=0: 096$. Thus, at this frequency the PC slab is a LHM and this result is in accordance with the above theorem. N ote, that in the case of the LHM the vectors $S$ and k are in the opposite directions (see anim ation [1] $\overline{-1}]$ ).

O ne can calculate independently the refractive index of the slab $n^{2}=$ from the dispersion relation of the band 1 . At sm all $k$ it can be written in a form $!^{2}=!_{1}^{2} \quad \xi_{8}^{2} k^{2}$. O ur calculation of spectrum gives $=0: 94,!_{1}=0: 314\left(2 c_{0}=d\right) . Ifwe choose ${ }^{0}=j$ jand ${ }^{0}=j$ jasthe param eters ofthe hom ogeneousm edium surrounding the PC, we obtain a unique device proposed by Veselago lens. It is shown schem atically in $F$ ig. 'İ-1. The com puter sim ulation of the Veselago lens
 the direction [10]. W e have checked that the results do not change if the PC is cut in the direction [11]. This con m sthe absence of spatialdispersion at the working frequency. The size of the focus is of the order of the wavelength as predicted by the di raction theory .

Now we explain how the starting theorem that follows from Eq.(그) ) and is form ulated in term $s$ of $m$ acroscopic electrodynam ics can be intenpreted $m$ icroscopically. The negative group velocity shown at Fig. '1.1 results from the repulsion of bands 1 and 2,3. Therefore a $m$ icroscopic explanation of negative should be found in term $s$ of the interaction between these bands. W e propose a quantitative explanation by writing $M$ axw ell's equation for the $m$ icroscopic eld $e_{z}(r)$ in a matrix form [ī $\left.\overline{-1}, 1 ; 1 \overline{1}\right]$ in the basis of $B$ loch functions at $k=0$. Taking into account that near the -point the bands $1,2,3,4$ are far from the other bands, we truncate the $m$ atrix keeping only these four bands. This approxim ation is analogous to
 nd the spectra of all four bands and the correct combinations of basis functions for each band at nite $\mathrm{k} . \mathrm{W}$ e have checked that the dispersion law for all bands 1-4 as obtained from
the truncated $m$ odel does not di er by $m$ ore than $4 \%$ from the result presented in $F$ ig. 'ilin at $k d=2<0: 1$. At sm all $k$ the $m$ icroscopic electric eld for the band 1 has the form

$w$ here $r$ is the $2 D$-vector, $u_{1}, u_{2}, u_{3}$ and $u_{4}$ are the $B$ loch functions at $k=0$, the positive param eters $\mathrm{k}_{0}, \mathrm{k}_{1}$ have the dim ensionality of a wave vector and they are integrals from these functions. The symm etry of the function $u_{1}$ is $X^{2} \quad Y^{2}$. The function $u_{4}$ has $X^{2}+Y^{2}$ sym $m$ etry. The functions $u_{2}$ and $u_{3}$ have the sym $m$ etries $X$ and $Y$ respectively. The parity of $X$ and $Y$ functions w thin the elem entary cell is shown in the central inset of F ig. in

If the $m$ aterial of the PC were $m$ etallic, the electric eld in the bands 2 and 3 would create tw o currents in opposite directions. These currents would induce a m agnetic $m$ om ent in x and y directions. In case of the dielectric $P C$ these currents are im aginary displacem ent currents and they do not create any $m$ agnetic $m$ om ent in the $m$ odes 2 and 3. How ever, as follow s from Eq. ( the band 1 has a realm agnetic $m$ om ent.

Them agnetization can be calculated using the expression

where $P=\mathrm{ze}_{\mathrm{z}}(\mathrm{r})[(\mathrm{r}) 1]=4, \mathrm{z}$ is a unit vector in z direction, $(r)=1$ inside the holes and $m$ otherw ise, the integration is perform ed over the unit cell, and $e_{z}(r)$ is given by Eq. $(\overline{\mathrm{N}})$. Only the second and the third term $s$ from Eq. (3-1) contribute to the $m$ agnetization. The result can be expressed through the integrals from $u_{2}$ and $u_{3}$. These functions have been taken from the com putation of the spectrum shown at $F$ ig. 'in. Them acroscopic vectors B and E are connected by the relation $\mathrm{B}=\mathrm{c}_{0} \mathrm{k} \quad \mathrm{E}=$ !, where $\mathrm{E}=\mathrm{z}<\mathrm{e}_{\mathrm{L}}(\mathrm{r})>$ and $<:::>$ $m$ eans averaging over the unit cell. Only the function $u_{4}$ gives a non-zero contribution after the averaging. It gives the $m$ ain contribution to $E$. Other basis functions give non-zero contribution only when multiplied by r-dependent term $s$ in the expansion of the exp ( $\mathrm{ik} r$ ) w ithin the unit cell. Their contributions to $E$ are of the sam e order in $k$ but they are $m u c h$ sm aller than the contribution from $u_{4} \operatorname{since}\left(!_{4} \quad!_{1}\right)=!_{1} \quad 1$, where $!_{1}$ and $!_{4}$ are the frequencies of the bands 1 and 4 at $k=0$. In fact, the latter strong inequality perm its truncation of the $m$ atrix in our analyticalm odel.

 root of $n^{2}$. This $m$ eans that is non-zero and negative at $!=!_{1}$. On the other hand, changes its sign at $!=!_{1}$. Thus, the gap at $!>!_{1}$ is due to $<0$. At $!=0: 3(2 \quad \mathrm{G}=\mathrm{d})$ one gets $=0: 084$ and that is very close to the value obtained above by the tting procedure. Thus, we have found analytically the value of .

The 3D LHM can be obtained in the sam eway, for exam ple, using the PC w th the cubic sym m etry proposed by Luo et al [1] $\overline{1}]$ ]. This PC also has a negative group velocity near the point w ith no other bands at this frequency.

T hus, we have shown that the LHM can be readily obtained using only one dielectric PC that creates both negative and. We have presented the physical explanation of this phenom enon in a 2D case. The working frequency can be easily changed in a wide range by changing the lattioe constant and $m$ of the PC. It is im portant for applications that the losses in a dielectric PC are much sm aller than in a m etallic one. W e have found not only $n$ but also and that are necessary to describe the dynam ical properties of the interfaces. $T$ his is especially im portant for the creation of the Veselago lens, which requires no re ection at interfaces, thus im posing two $m$ atching conditions on and. By $m$ atching $n$ only one
 we have not presented a $m$ ethod ofm atching the LHM with the surrounding $m$ edium. $T$ his $m$ atching is very easy in com putational approach but it $m$ ust be handled creatively on the w ay tow ard real devices.
