## Sequence Space Localization in the Immune System Response to Vaccination and Disease

We introduce a model of protein evolution to explain limitations in the immune system response to vaccination and disease. The phenomenon of original antigenic sin, wherein vaccination creates memory sequences that can increase susceptibility to future exposures to the same disease, is explained as stemming from localization of the immune system response in antibody sequence space. This localization is a result of the roughness in sequence space of the evolved antibody a nity constant for antigen and is observed for diseases with high year-to-year mutation rates, such as in uenza.

IN T R O D U C T IO N

Our immune system protects us against death by infection [1]. A major component of the immune system is generation of antibodies, protein molecules that bind speci c antigens. To recognize invading pathogens, the immune system performs a search of the amino acid sequence space of possible antibodies. To nd useful antibodies in the e ectively in nite protein sequence space, the immune system has evolved a hierarchical strategy. The rst step involves creating the DNA sequences for B cells that code for moderately e ective antibodies through rearrangement of immune-system-speci c gene fragments from the genome [2]. This process is called VDJ recombination. This combinatorial process can produce on the order of 10<sup>14</sup> di erent antibodies through recombination of pieces of antibodies. The second step, which occurs when a speci c antigen invades our body, is som atic hyperm utation. Som atic hyperm utation is the process of mutation that occurs when the B cells that produce the antibodies divide and multiply. Only those B cells that produce antibodies that bind the antigen with higher a nity are propagated by this mutation and selection process, and another nam e for this process is a nity maturation. Som atic hypermutation is essentially a search of the amino acid sequence space at the level of individual point mutations [3].

The consequence of an immune system response to antigen is the establishment of a state of memory [4]. Immunologicalmemory is the ability of the immune system to respond more rapidly and e ectively to antigens that have been encountered previously. Speci c memory is maintained in the DNA of long-lived memory B cells that can persist without residual antigen.

A lthough our im mune system is highly e ective, som e lim itations have been reported. The phenom enon known as \original antigenic sin" is the tendency for antibodies produced in response to exposure to in uenza virus antigens to suppress the creation of new, di erent antibodies in response to exposure to di erent versions of the u [5]. Roughly speaking, the immune system responds only to the antigen fragments, or epitopes, that are in common with the original u virus. As a result, individuals vaccinated against the u may become more susceptible to infection by mutated strains of the u than would individuals receiving no vaccination. The details of how original antigenic sin works, even at a qualitative level, are unknown.

In this Letter, we o er an explanation for the reported limitations in the immune system response using a model of protein evolution. We describe the dynamics of a nity maturation by a search for increased binding constants between antibody and antigen in antibody sequence space. It is shown that an immune system response to an antigen generates localized memory B cell sequences. This set of localized sequences reduces the ability of the immune system to respond to subsequent exposures to di erent but related antigens. It is this competitive process between memory sequences and the VD J recom binations of secondary exposure that is responsible for the reported limitations in the immune system.

W e use a random energy m odel to represent the interaction between the antibodies and the in uenza proteins. Thism odel captures the essence of the correlated ruggedness of the interaction energy in the variable space, the variables being the antibody am ino acid sequences and the identity of the disease proteins, and the correlations being mainly due to the physical structure of the antibodies. The random energy model allows study of the sequence-level dynam ics of the imm une/antigen system, which would otherwise be an intractable problem at the atom ic scale, with  $10^4$  atom s per antibody,  $10^8$  antibodies per individual, 6 10<sup>9</sup> individuals, and many possible in uenza strains. Use of random energy theory to treat correlations in otherwise intractable physical system s goes back at least to B ohr's random m atrix theory for nuclear cross sections [6] and has been used for quantum chaos, disordered mesoscopic systems, QCD, and quantum gravity [7]. C lose to the present application is the study of spin glasses by random energy models [8, 9], protein folding by coarse-grained models [10, 11], and

evolutionary system s by NK -type m odels [12, 13, 14, 15].

In detail, the generalized NK m odel we use considers three di erent kinds of interactions within an antibody: interaction within a subdom ain  $(U^{sd})$ , interactions between subdom ains  $(U^{sd})$ , and direct binding interaction between antibody and antigen  $(U^{\circ})$ . In the context of protein evolution, parameters of the model have been calibrated [12, 16, 17]. The energy function of a protein is given by

where M is the number of antibody secondary structural subdom ains, and P is the number of antibody amino acids contributing directly to the binding. The subdom ain energy U  $^{\rm sd}$  is

where N is the number of am ino acids in a subdom ain, and K is the range of local interaction within a subdom ain. All subdom ains belong to one of L = 5 di erent types (e.g., helices, strands, loops, turns, and others). The quenched Gaussian random number \_\_\_\_i is di erent for each value of its argument for a given subdom ain type, \_\_i. All of the Gaussian values have zero mean and unit variance. The energy of interaction between secondary structures is

We set the number of interactions between secondary structures at D = 6. Here  ${}_{ij}^{k}$  and the interacting am ino acids,  $j_{1}$ ;  ${}_{K}$ ; jare selected at random for each interaction (k; i; j). The chem ical binding energy of each antibody am ino acid to the antigen is given by U $_{i}^{c} = {}_{i}(a_{i}) = P$ . The contributing am ino acid, i, and the unit-norm al weight of the binding,  ${}_{i}$ , are chosen at random. Using experimental results, we take P = 5 am ino acids to contribute directly to the binding event. Here we consider only we chem ically distinct am ino acid classes (e.g., negative, positive, polar, hydrophobic, and other) since each di erent type of am ino acid behaves as a com pletely di erent chem ical entity within the random energy m odel.

The generalized NK model, while a simpli ed description of real proteins, captures much of the therm odynam ics of protein folding and ligand binding. In the model, a speci c B cell repertoire is represented by a speci c set of am ino acid sequences. Moreover, a speci c instance of the random parameters within the model represents a speci cantigen. An immune response that nds a B cell that produces an antibody with high a nity constant to a speci cantigen corresponds in the model to nding a sequence having a low energy for a speci c parameter set.

The random character of the generalized NK model makes the energy nugged in antibody sequence space. The energy is, moreover, correlated by the local antibody structure (K = 4), the secondary antibody structure (U<sup>sd sd</sup>), and the interaction with the in uenza proteins (U<sup>c</sup>). As the immune system explores the space of possible antibodies, localization is possible if the correlated nuggedness of the interaction energy is su ciently great.

Since the variable region in each light and heavy chain of an antibody is about 100 am ino acids long, and m ost of the binding occurs in the heavy chain, we choose a sequence length of 100. We choose M = 10 since there are roughly 10 secondary structures in a typicalantibody and thus choose N = 10. The immune system contains of the order of  $10^8$  B cells divided into di erent speci cities, and the frequency of a speci cB cell participating in the initial immune response is roughly 1 in  $10^5$  [18]. Hence, we use  $10^3$  sequences during an immune response.

The hierarchical strategy of the immune system is used to search the antibody sequence space for high a nity antibodies. Initial combination of optimized subdom ains is followed by a point mutation and selection procedure [12]. To m imic combinatorial joining of gene segments during B cell development, we produce a naive B cell repertoire by choosing each subdom ain sequence from pools that have N pool amino acid segments obtained by m inimizing the appropriate U <sup>sd</sup>. To t the theoretical heavy-chain diversity of 3  $10^{11}$  [18], we choose N pool = 3 sequences among the top 300 sequences for each subdom ain type.

Som atic hypermutation occurs at the rate of roughly one mutation per variable regions of light and heavy chains per cell division, which occurs every 6 to 8 hours during intense cell proliferation [19]. Hence, in our sim ulation, we do 0.5 point mutations per sequence, keep the best (highest a nity) x = 20% sequences, and then amplify these back up to a total of  $10^3$  copies in one round, which corresponds to 1=3 day. That is, the probability of picking one of the, possibly mutated, sequences for the next round is  $p_{select} = 1=200$  for U  $U_{200}$  and  $p_{select} = 0$  for  $U > U_{200}$ , where  $U_{200}$  is the 200th best energy of the  $10^3$  sequences after the mutation events, and this equation is employed 10<sup>3</sup> times to select random ly the  $10^3$  sequences for the next round. G iven a speci c antigen, i.e. a speci c set of interaction param eters, we do 30 rounds (10 days) of point mutation and selection in one imm une response. In this way, memory B cells for the antigen are generated.

The a nity constant is given as a function of energy,

where a and b are determined by the dynamics of the mutation and selection process. A nity constants resulting from VDJ recombination are roughly  $10^4$ , a nity constants after the st response of a nity maturation are roughly 10<sup>6</sup>, and a nity constants after a second response of a nity maturation are roughly 107 [18] (values that x the selection strength, x). By comparison to the dynamics of the model, we obtain a = 18:56; b = 1:67.

The memory B cells, key to immunological memory, give rapid and e ective response to the same antigen due to their increased a nity for previously-encountered antigens. We focus on the role of the memory cells in the immune response to di erent antigens. The distance between a stantigen and the second antigen is given by the probability, p, of changing parameters of interaction within subdom ain (U<sup>sd</sup>), subdom ain-subdom ain  $(U^{sd} s^{d})$ , and chem icalbinding  $(U^{c})$  term s. W ithin  $U^{sd}$ , we change only the subdom ain type, i, not the param -, which are probably xed by structural biology eters and should be independent of the antigen.

W e estim ate the num ber of m em ory and naive B cells that participate in the immune response to the second antigen by the ratio of the respective a nity constants. From the de nition of the a nity constant,  $K^{eq} =$ [Antigen : Antibody] = f [Antigen] [Antibody]g, the binding probability is proportional to the a nity constant and to the concentration of antigen-speci c antibody, which is  $10^2$  times greater for the memory sequences [18]. W e m easure the average a nity for the second antigen of the  $10^3$  m em ory cells, K  $_{\rm m}^{\rm eq}$  , and that of the  $10^3$  B cells from the naive repertoire of optim ized subdom ain sequences, K  $_{n}^{eq}$ . The ratio  $10^{2}$ K  $_{m}^{eq}$ =K  $_{n}^{eq}$  gives the ratio of m em ory cells to naive cells. For exposure to the second antigen, we perform 30 rounds (10 days) of point mutation and selection, starting with  $10^{5}$ K  $_{m}^{eq} = (10^{2}$ K  $_{m}^{eq} + K _{n}^{eq})$ memory cells and  $10^{3}$ K  $_{n}^{eq} = (10^{2}$ K  $_{m}^{eq} + K _{n}^{eq})$  naive cells, since both memory and naive sequences participate in the secondary response [20].

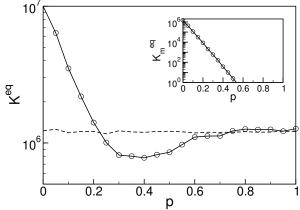


FIG.1: The evolved a nity constant to a second antigen after exposure to an original antigen that di ers by probability p (solid line). The dotted line represents the a nity constant without previous exposure. The a nity constant is generated by exponentiating, as in Eq. (4), the average of the best binding energy, using 5000 instances of the model. In inset is shown the a nity of the memory sequences for the mutated antigen.

Figure 1 shows the evolved a nity constant to a second antigen if the exposure to a rst antigen exists (solid line) or not (dashed line) as a function of the di erence between the rst and second antigen, p, or \antigenic distance" [21]. W hen the di erence is small, the exposure to a rst antigen leads to higher a nity constant than without exposure, which is why immune system memory and vaccination is e ective. For a large di erence, the antigen encountered in the st exposure is uncorrelated with that in the second exposure, and so immune system memory does not play a role. Interestingly, the immunologicalmemory from the stexposure actually gives worse protection, i.e. a lower a nity constant, for intermediate di erences which is original antigenic sin.

The dynam ics of the imm une response (Fig. 1) depend upon the constants of Nature, i.e. the param eters of the model. For example, in an organism with a smaller im -

m une system, such as the m ouse, there are fewer starting sequences and less favorable binding constants are m easured in the same number of rounds: a factor of 0.5reduction in the number of starting sequences leads to a 0.64 reduction in the evolved binding constant, but a sim ilar degree of original antigenic sin as in Fig. 1. On the other hand, if m ore rounds are perform ed, better binding constants are found in the primary and secondary responses, but the secondary response is not as in proved over the prim ary response as when using 30 rounds, because the evolved sequences are becoming more localized in ever deeper wells. The degree of original antigenic sin is, however, sim ilar in the range of 30 to 60 rounds per response. Sim ilarly, if the roughness of the energy upon disease mutation is increased, for example by assuming that mutation of the in uenza actually changes the , the degree of original antigenic sin increases substantially, by a factor of 2, because the barriers between the regions of localization in sequence space are increased. On the other hand, if the concentration of the memory cells is decreased, the contribution of the memory cells to the dynam ics is reduced, and the original antigenic sin phenom enon decreases, alm ost disappearing when the mem ory and naive antibody concentrations are equal. The average number of mutations leading to the best antibody, a measure of the localization length when original antigenic sin occurs, is 15 for the st response and rises from 5 to 15 for the second response in the range p < 0:30. Interestingly, the average num ber ofm uta-0 tions rises slightly above 15 in the range 0:30 p < 0:70, indicating that in the original antigenic sin region more

m utations are necessary for the compressed ensemble of m em ory sequences from the prim ary response to evolve to a suitable new state in the secondary response. Larger selection strengths (x < 20%) cause m ore localization and original antigenic sin, in shallower wells for sm all x, and sm aller strengths (x > 20%) lead to less evolution.

For small values of p, p < 0:19, the memory B cells produce antibodies with higher a nities,  $K_m^{eq} > 10^4$ , for the new antigen than do naive B cells. The binding constant of the memory antibodies steadily decreases with p, reaching the non-speci c value of  $K_m^{eq} = 10^2$  at p = 0.36 (see inset in Fig. 1), which, interestingly, is less than the range to which original antigenic sin extends,  $0.23 . These model predictions are in good agreement with experimental data on cross-reactivity, which ceases to occur when the amino acid sequences are more than 33{42% di erent [22].$

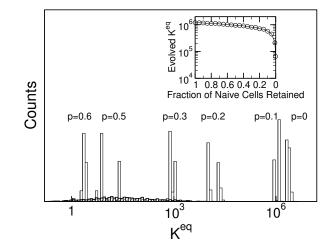


FIG.2: The a nity distribution of antibodies from naive B cells (hatched) or memory cells (open) for the antigen of second exposure. In the inset is shown the binding constant that evolves in the primary response when an initial selection step retains only the top fraction of the naive cells.

The ine ectiveness of immune system memory over a window of p values can be understood from the localization of memory B cell sequences. Figure 2 displays distributions of m em ory and naive a nity constants for the second antigen. Notice that the memory sequences are highly hom ogeneous and lack diversity compared to the naive sequences. Indeed, original antigenic sin arises mainly because the memory sequences from the primary response suppress use of naive sequences in the tail of the distribution for the secondary response. A lthough those naive sequences initially look unprom ising, they may actually evolve to sequences with superior binding constants. The inset to Fig. 2 illustrates this phenom enon. Interestingly, when half of the distribution is removed, the reduction in the binding constant is just about that which occurs in original antigenic sin, Fig. 1.

In sum m ary, the generalized NK m odel is show n to successfully model immune system dynamics. A localization mechanism for the original antigenic sin phenomenon observed in the u is explained. Localization of antibodies in the am ino acid sequence space around m em ory B cell sequences is shown to lead to a decreased ability of the immune system to respond to diseases with year-toyearm utation rates within a critical window. This localization occurs because of the ruggedness of the evolved a nity constant in am ino acid sequence space. From the model dynamics, we nd that memory sequences can both outcompete the non-vaccinated immune response and become trapped in localm in in a. Memory sequences with a nity constants initially superior to those from naive sequences can be selected by the dynamics, and these m em ory sequences can lead to poorer evolved a nity constants, to the detrim ent of the immune system for interm ediate disease mutation rates. These results suggest several in plications for vaccination strategy: the difference between vaccinations adm inistered on a repeated basis should be as great as practicable, and suppression of the memory B cell response may be helpful during vaccination against highly variable antigens.
