Jamming, two-uid behavior and 'self-ltration' in concentrated particulate suspensions

We study the ow ofm odel experimental hard sphere colloidal suspensions at high volume fraction driven through a constriction by a pressure gradient. Above a particle-size dependent limit o, direct microscopic observations demonstrate jamming and unjamming conversion of uid to solid and vice versa during ow. We show that such a jamming ow produces a reduction in colloid concentration x downstream of the constriction. We propose that this 'self-litration' e ect is the consequence of a combination of jamming of the particulate part of the system and continuing ow of the liquid part, i.e. the solvent, through the pores of the jammed solid. Thus we link the concept of jamming in colloidal and granularmedia with a 'wo-uid'-like picture of the ow of concentrated suspensions. Results are also discussed in the light of O shorme Reynolds' original experiments on dilation in granularmaterials.

In this paper we consider the pressure-driven OW of concentrated suspensions of model colloidal particles. Concentrated suspensions of particles in liquid solvents are ubiquitous in 'soft matter' technology (cosm etics, foods, building m aterials, paints, detergents, pharm aceuticals, waste management) as wellas in natural phenom ena (soil and wet sand, form ation of porous rocks and sediments, landslip, etc). Much industrial processing of soft matter, and many examples of natural ow phenom ena, involve pressure-driven ow; moreover the ow often features 'com plex' geom etries where convergent and divergent elements generate extensional com ponents of strain (e.g. constricting and widening pipes in a transport system). Fundam ental studies of suspension behavior in such complex ow remain rare in comparison to the wealth of studies of soft matter under simple shear [1]. R heom etrical work on concentrated suspensions has dem onstrated com plicated e ects such as stress-induced thickening, erratic ow response, and uctuating viscosity [2,3].

In the rheology of very concentrated suspensions and other crowded soft m atter system s a concept that has excited m uch recent speculation [4] and theoretical and experim ental work [5, 6, 7, 8, 9] is that of jam m ing. Here we shall de ne jam m ing as the conversion of a liquid system into a solid by im posed stress. Jam m ing is very obvious in hourglass' ow of dry sand where stress-supporting solid arches form across the convergence, even though the sand typically ow sm ore or less like a liquid in sim pler geom etries. D ilation' of wet sand is a related exam ple w ith a venerable history, having been considered m ore than 100 years ago by R eynolds [10]. How ever there rem ains no clear picture of the generic conditions required for nor the consequences of jam m ing in soft m atter. O ur study of a m odel system is aim ed toward such a goal. O ur experim ental system consists of polym ethylm ethacrylate (PMMA) spheres sterically stabilised by short grafted polym ers (polyhydroxystearylalcohol), suspended in a non-polar hydrocarbon solvent (decalin). This system is a good model of the conceptual hard sphere' suspension [11]. The particles can be manufactured in almost monodisperse batches (polydispersities typically less than 6-7%). Here we study three batches of particles of radii 318 10 nm, 656 20 nm and 1000 50 nm respectively, spanning the particle size range from bolloidal' (where Brownian motion dominates in dilute suspensions) toward 'granular' where gravity is dominant.

We rst demonstrate quantitatively one important and striking consequence of jamming in a concentrated suspension: that jamming in a convergent ow can induce a signi cant reduction in concentration downstream of the constriction, what one might call a 'self-ltration' behavior by the suspension. We study the e ect of convergent ow on concentration by extracting a portion of a bulk sample through a constriction | put simply, by sucking a small volume out of a bulk cell through a narrow - barrelled syringe and com paring the resulting 'extracted' concentration x with the bulk concentration b.

Sam ples are prepared as follows. D ilute suspensions are centrifuged until the particles form 'solid' sedim ents (see below for a discussion of jam ming e ects on sedimentation). To obtain given bulk volume fractions measured amounts of solvent are added to the sediments. In practice we prepare pairs of sam ples which have been subjected to exactly the same treatment (i.e. duration and rate of centrifugation etc.) and which thus have equal $_{\rm b}$ to within the (sm all) uncertainties associated with measuring masses of sediment and added solvent. (We use pairs of sam ples for the comparison because, if

 $x \in b$, extracting som e sam ple by syringe to measure $_{\rm x}$ and then m easuring $_{\rm b}$ for the same sample would introduce system atic errors.) For one member of the pair we obtain the bulk colloidal mass fraction by scooping out a measured mass of the sample, allowing all solvent to evaporate, and m easuring the m ass of solids rem aining. From the other member of the pair we extract a portion not by scooping but by syringe, and similarly m easure the m ass fraction of this extracted portion. W e convert m ass fractions into volum e fractions (the m ore commonmeasure of concentration in studies of colloidal suspensions) assuming a particle density $_{p} = 1:188 \text{ g}$ cm 3 (the bulk density of PMMA) and solvent density $_{\rm s}$ = 0.897 g cm⁻³. If there is no e ect of convergent ow in the syringe on extracted volume fraction we should nd x = b. A large num ber of experiments is carried out on rediluted and new ly centrifuged pairs of sam ples to ensure that statistical variations due to m easurem ent imprecision are minim ised.

There are a number of ways of estimating for a colloidal suspension, none of which is without drawbacks. As is well known [12] the mass fraction' measure of tends to give system atically lower values compared to the other common measure in the PMMA system, that based on mapping experimental phase boundaries onto com puter simulated uid-crystal hard-sphere phase coexistence boundaries. G iven the core-shell nature of the sterically-stabilised particles no sim ple m easure can give an absolutely correct result in the sense of a 'true hard sphere' volume fraction. The important point for this work is that all measures are carried out in the same way so that we obtain volume fractions that are consistent and comparable with each other. In these experiments, given the sm all volum es (see below) of extracted suspension, the possible experim ental errors are m in im ised by using the mass fraction' to obtain ; dilution and mapping onto phase boundaries is simply not possible with such sm all sam ple volum es. How ever care must be taken when comparing the num erical values of given here with those quoted elsewhere in the literature, which are often obtained by m apping onto the com puter-sim ulation phase diagram .

All experim ents are carried out in identical geom etry: the bulk' cells are cylindrical glass cuvettes of diam eter 25 mm with sediment heights 2:5 cm giving a total sam ple volum e of 12 cm³; the syringes used have m axim um volume 1:0 m lwith an entry barrel internal diam eter of 1:6 m m; volum es extracted are typically 0:4 0:5 ml, ie. always < 5% of the total bulk volume. The sucking' procedure is as follows: the syringe plunger is pulled out quickly by hand to generate an empty barrel volum e of 0:6 m l, so that a pressure drop $(P_b = P_{atm})$ 0:03)is instantaneously applied between the outside surface of the bulk at atm ospheric pressure Patm and the surface inside the syringe barrel at reduced pressure P_b. In the majority of the experiments reported here we study




FIG.1: Bulk volum e fraction $_{\rm b}$ vs volum e fraction extracted by syringe $_{\rm x}$. The line indicates $_{\rm b}$ = $_{\rm x}$, i.e. the expected result if convergent ow into syringe has no belf-ltration' effect. Filled circles, empty diam ond and empty circles, particle radius 1000nm; lled triangles, radius 656nm; lled squares, 318nm. Empty circles show experim ents extracting through a ne needle rather than syringe barrel; the diam ond shows an experim ent using a larger initial pressure drop. E mor bars on are 0:005, i.e. approxim ately the size of the sym bols.

this limiting case of a suddenly applied initial pressure drop (the pressure drop slowly decreases as the sample is extracted and enters the syringe barrel). A few experiments have also been carried out using larger initial pressure drop and using narrower constrictions.

Results for $_{\rm b}$ vs $_{\rm x}$ are shown in Figure 1, for the three particle sizes given above. As is clear, when $_{\rm b}$ is above some limit volume fraction $_0$ the sample 'pum ped' through the contraction into the syringe barrel has a signi cantly reduced volum e fraction x < b. The lim it concentration $_0$ is strongly dependent on particle size, decreasing with increasing particle size. Thus the effect is more visible with larger particles (approaching the granular scale) but even for the smallest particles, very much within the colloidal regime, there is a clear e ect at the highest volume fractions. The reduction in extracted volum e fraction is som ew hat m ore severe with a sm aller constriction geom etry or with a larger initial pressure drop (see example open circles and open diam ond, respectively, in Fig. 1), though we have yet to carry out detailed investigations on the e ect of di erent pressure drop. In any case, since extraction of samples from bulk for e.g. observation in a m icroscope or m easurem ent in a rheom eter is very often achieved using syringes, pipettes etc., it is in portant for experim entalists to be aware of the sensitivity of key parameters such as volume fraction to such 'processing' prior to experiments. Of course sim ilar ow situations involving concentrated suspensions are comm on in technological applications such as product delivery, waste processing, and so on.

A though it seems that this 'self- tration' e ect has not been reported in the colloidal literature, actually it is not too surprising if we consider the suspension as a 'two-uid' system, that is a combination of particulate uid and liquid solvent, where interaction between the particles may lead to a rheological 'separation' of the two uids. There are a few studies of squeeze ow where a separation between solvent and dispersed phase is discussed [13, 14], but such a two-uid picture of ow, though fam iliar in studies of polymer systems, is not often encountered in the colloidal literature. W e propose that our results can be explained in a two-uid spirit as an 'extrem e' rheological separation of the particulate and solvent parts of the suspension. The particles jam and form a solid that resists the pressure drop and does not ow at all. M eanwhile the solvent, rem aining liquid, cannot resist the pressure gradient and continues to ow through the pores of the jammed colloid. Hence there is an increased ow rate of solvent relative to particles, resulting in a reduced downstream particle volum e fraction.




FIG.2: Im ages of the ow of a suspension of 1000 nm colloids, volume fractions (a) = 0.534; (b) = 0.578; (c) = 0.60. The horizontal bar in (a) is 0.5 mm. At the left extreme of each im age the entrance to the capillary can be seen, as indicated by the schematic in (d) showing the viewing and ow geom etry. In (b) and (c) dark lines form in arch-like patterns around the end of the capillary, while ow in (a) is sm ooth. Still-im ages are taken from digitised movies, see R ef. [15] experiments 2, 3 and 6 for (a), (b), and (c) respectively.

But is colloidal jam m ing really responsible for the m easurements in Fig 1? To elucidate directly what is actually happening in our convergent pressure-driven ow we have carried out direct observations by opticalm icroscope. To enable m icroscope observations, the PMMA particles are suspended in a mixture of solvents (decalin and tetralin) to partly m atch the particle refractive index and reduce multiple scattering, and sam ples are prepared (centrifuged) inside thin rectangular cuvettes. Extraction' is achieved by inserting a cylindrical glass capillary into the sediment, internal diameter 1:0 mm, connected to a syringe whose plunger is withdrawn using a xed-speed syringe pump. The ow in the region of the capillary tube entrance is observed with bright eld microscopy, the eld of view positioned at the region around the entrance to the capillary as shown in Fig. 2 (d). Results in the form of digitised movies are available at [15], while gures 2(a)-(c) and 3 show extracted still-in ages. In all but one of the movies, the height of the eld of 1 mm and the entry to the capilview corresponds to lary can be seen at the left of the picture. At such low m agni cation individual colloids cannot be resolved. In one movie (Ref. [15] experiment 4) the magni cation is increased by a factor of 10 and the eld of view is centred

0:5 mm diagonally from the lower corner of the capillary entry; in this case the particles, 1000 nm radius, are just resolvable.

Sum marising our observations, ow sathigh are typically very erratic, demonstrating very clear transient jam ming of the sam ples in the region of the tube entrance, involving slowing of ow, sudden 'fracture' events followed by speed-up, repeated re-jam ming, and so on. Jam ming as a transient 'conversion' of owing liquid to stationary solid is strikingly apparent. In the movie at higher magni cation (Ref. [15] experiment 4) the sam -




FIG. 3: A sequence of im ages of the ow of a suspension of 318 nm colloids, volume fraction = 0:61. The stills (a) to (f) are each separated by 0.08 seconds. At the left extrem e of each im age the entrance of the capillary can be seen. In the top left im age, the horizontal bar is 0:5 mm, while the arrow shows a line of dust particles from whose motion and distortion one m ay obtain an approximate idea of the velocity eld owing into the capillary entrance. Dark lines form [toward the right hand side of im ages (b) to (e)] in arch-like crossing con gurations, then disappear very suddenly in (f) as the jam bollapses'. See movie at R ef. [15] experiment 1.

ple, blurred whilst owing (i.e. liquid), can be seen to repeatedly momentarily freeze (become solid).

At the highest concentrations ow is localised near the entry of the capillary (Ref. [15] experiment 6). However dark lines form in arch-like shapes, often travelling in sudden waves' or Shocks' out from the end of the capillary [Figs. 2 (b) and (c) and Fig 3]. The Shocks' are associated with subsequent speed-up of the ow, i.e. collapses of the jammed particle structure. Collapse is followed by rejamming, generating erratic changes in ow speed. The most likely optical origin of the dark lines is smallangle scattering (their appearance is very sensitive to refractive index contrast consistent with this), indicating localised changes in volume fraction. The exact nature of these waves or shocks of dark lines is unclear. They exhibit similarities with density or kinematic waves observed in granularmedia, such as hourglass' ow of sand [16]. More detailed study and comparison with granular density waves will be the subject of future work [17].

As $_{\rm b}$ is lowered toward the lim it $_0$, the jam -collapserejam behavior cycles faster (R ef. [15] experiments 3 and 4), suggesting that below some limiting concentration jam se ectively collapse in mediately, in other words the sample no longer jam s during ow . Below $_0$, we indeed observe sm ooth non-jam ming ow of the suspension into the convergence [Fig. 2 (a) and R ef. [15] experiment 2].

Continued ow of the reduced volume fraction (partially Self-Itered') sample downstream presum ably accounts for the transience of the jam m ing: jam s give w ay just as, in hourglass ow of sand, solid arches give w ay to allow ow.

Collapse of jams apparently involves a sliding-solid fracture-like behavior (Ref. [15] experiment 5), sliding occurring at the dark lines visible in the sample. We speculate that such sliding-fracturing m ay also be a consequence of the combination of jamming and solvent permeation through the jam . Fractures may be localised by geometry-dependent pressure gradients driving solvent through the pores of the jam s into regions of decreased particle concentration som etim es called In icrocracks' in the rock fracture literature which we associate with the dark lines we observe in the suspensions. The excess solvent in these regions lubricates localised sliding ('cataclastic shear bands' [18]) of opposing solid regions. Such a 'lubricated slide' picture has been proposed for slip of porous rocks in earthquakes (see e.g. [18]). The possibility that model suspensions might ultim ately be used as simple 'soft' analogues of geological system s deserves further investigation.

A further demonstration of jamming is provided by simple observations of the behavior of sediments of the largest particles. Though apparently solid under carefulhandling, we have observed that the sediment formed after centrifugation very easily reliquies under a slight deliberate lateral shaking. The sediment thus behaves as an example of what has been called 'fragile matter' [8]: it solidies (jams) under application of a unidirectional force in the centrifuge (or over a longer time period in normal gravity) but cannot support (liquies under) small stresses applied in any other direction.

F inally we note that the 'sucking' experim entsm ay be com pared to the early granular experim ents of 0 shome Reynolds, who squeezed rubber balloons led with ball bearings and water [10]. Reynolds observed that on applying pressure, water was drawn into the balloon quite the reverse of the case of a balloon completely led with a simple uid, which would be forced out. The ball-bearing system inside the balloon can only strain by decreasing its local volum e fraction, i.e. by dilation and increase of the total volum e of the exible balloon. W ater is then naturally drawn in to 11 the extra volume. Our observations in colloidal suspensions may also be interpreted in terms of dilation in the zone of convergent ow as follows. To allow ow in response to the applied pressure drop the region of sam ple just downstream of the convergence must dilate, i.e. decrease its volum e fraction by taking on m ore solvent; but this solvent m ust com e from som ewhere, i.e. from the region upstream, hence generating an increase in upstream . This increase in in tum leads to jamming of the colloidal particles.
