N on-abelian Berry's phase and Chern numbers in higher spin pairing condensates

We show that the non-Abelian Berry phase emerges naturally in the s-wave and spin quintet pairing channel of spin-3=2 ferm ions. The topological structure of this pairing condensate is characterized by the second Chern number. This topological structure can be realized in ultra-cold atom ic

system s and in solid state system s with at least two K ram ers doublets.

I. IN TRODUCTION

Topological gauge structure and Berry's phase¹ play an increasingly in portant role in condensed m atter physics. The quantized Hall conductance can be deeply understood in term softhe rst Chem class^{2,3}. The fractional quantum Hall e ect can be fundam entally described by the U (1) topological Chem-Sim ons gauge theory⁴. The e ective action for ferrom agnets⁵ and one dimensional antiferrom agnets^{6,7} contain Berry phase term swhich fundam entally determ ine the low energy dynam ics. More recently, Berry's phase associated with the BCS quasiparticles in pairing condensates has also been studied extensively.^{8,9,10}.

However, most of the well known applications of the geom etrical phase in condensed matter physics involves Berry's¹ original abelian U (1) phase factor. More recently, the non-abelian SU (2)^{11,12,13} Berry's phase (or holonomy, to be precise) has been system atically investigated in the context of condensed matter system s. D em ler and Zhang¹⁴ investigated the quasi-particle wave functions in the uni ed SO (5) theory of antiferrom agnetism and superconductivity, and found that the SDW and the BCS quasi-particle states accumulate an SU (2) Berry's phase (or holonom y) when the order parameter returns to itself after an adiabatic circuit. Zhang and Hu¹⁵ found a higher dimensional generalization of the quantum Halle ect based on a topologically non-trivial SU (2) background gauge eld. Rather surprisingly, the non-abelian SU (2) holonom y also found its deep application in the technologically relevant eld of quantum spintronics^{16,17}. All these condensed matter applications are underpinned by a comm on mathematical framework, which naturally generalizes the concept of Berry's U (1) phase factor. This new class of applications is topologically characterized by the second Chern class and the second Hopfm ap, and applies to ferm ionic system s with tim e reversal invariance.

In this paper, we investigate the non-trivial topological structures associated with the higher spin condensates. We rst review the momentum space gauge structure of the spin one condensate, namely the A phase of ${}^{3}\text{H}$ e. A sit has been pointed out⁸, the momentum space gauge structure of the pairing condensate is given by that of

the t'Hooft-Polyakov monopole. We then investigate the new system of spin 2 (quintet) pairing condensate of the underlying spin 3/2 ferm ions. The most general Hubbard m odel of spin 3/2 ferm ions has recently been introduced and investigated extensively by W u et al.¹⁸, who found that the model always has a generic SO (5) symmetry in the spin sector. Building on this work, we show here that the ferm ionic quasi-particles of the quintet pairing condensate can be described by the second H opfm ap. Sim ilarto the SDW + BCS system investigated by Dem lerand Zhang¹⁴, the quasi-particles of the quintet pairing condensate also accumulate an SU (2) holonomy. The quintet pairing condensate can be experim entally realized in a number of systems. Cold atoms with spin 3/2 in the continuum or on the optical lattice can be accurately described by the model of local contact interactions¹⁸ U_0 and U2. These interaction parameters can be experimentally tunes over a wide range, including the range for stable quintet condensates. E ective spin 3/2 ferm ions can also be realized in solid state systems with at least two K ram ers doublets, for example in bands form ed by $P_{3=2}$ orbitals.

In the rest of this paper, we shall use spin-1/2 system to be short for the spin-1=2 super uid ³H e-A and spin-3=2 system for the s-wave spin-3/2 superconductor in the quintet channel. The repeated indices are sum m ed assum ably throughout this paper.

II. SUPERFLUID ³He-A

A. Goldstone manifold and the 1st H opfm ap

The general form of the equilibrium order parameter in the $^3{\rm H}$ e-A phase can be written as 8

where the spin index (a) and and orbital index (i) run from 1 to 3. $_{\rm k}$ is a complex number that contains the information of the magnitude and the U (1) phase. $\hat{\rm d}$ is the normal vector of the plane to which the spin direction is restricted. The orthogonal vectors $\hat{\rm e}^{(1)}$, $\hat{\rm e}^{(2)}$ and $\hat{\rm l} =$ $\hat{\rm e}^{(1)}$ $\hat{\rm e}^{(2)}$ form a local physical coordinate fram e. The Goldstonem anifold of the order parameter is given by 8

Here SO (3)_{relative} denotes such rotations about the axis Î that lead to new degenerate states which are relative towards gauge transform ations⁸. The U $(1)^{\text{com bined}}$ com es from the fact that the A-phase state is invariant under combined transform ation⁸ of the gauge transform ation with the parameter from the U(1) group and the orbital rotation of $e^{(1)}$, $e^{(2)}$ and $\hat{1}$ about axis $\hat{1}$ by the sam e angle . The $\mathrm{Z}_2^{\,\mathrm{com\,\,bin\,ed}}$ denotes the com bined operation that â! d**;** k ! k. This combined discrete symmetry leads to the existence of half-quantum vortices⁸. A round a half-quantum vortex, the vector eld d is continuously rotated into \hat{d} and the U (1) phase of k continuously evolves from 0 to when the order parameter returns to itself after an adiabatic circuit.

If we x the local orthogonal frame in an arbitrary direction and adiabatically move the quasi-particle around a line defect of half-quantum vortex, the trajectory of the order parameter is a closed loop on the $S^2=Z_2$ space. On the other hand, the degrees of freedom of the quasi-particle (a 2-dimensional spinor) forms a 3-dimensional sphere S^3 and the trajectory of the quasi-particle on S^3 is not closed. This adiabatic evolution denes the following map

In the topological term inology, Eq.(3) is determ ined by the third hom opotic group denoted by $_3$ (S²=Z₂). Due to a theorem in the Hom opoty theory¹⁹

Eq.(3) is hom opotically equivalent to the rst H opfm ap S^3 ! S^2 i.e., U (1) Berry phase in the FQ HE and other nano-structure in the sem iconductors^{20,21}.

B. Berry connection, $1^{\rm st}$ C hern num ber, t'H ooft-P olyakov m onopole and D irac m onopole

If we de ne the spinor as

the mean eld Hamiltonian for ³He-A is given by

where $_{k} = _{k}\hat{d_{a}}^{a} R$ and $R = i^{2}$. $_{k}$ is the kinetic energy on the lattices referenced from the Ferm i surface and the sum m ation of m on entum k is over half of the Brillouin zone to avoid the double counting. Here, ⁰ is the 2 2 identity m atrix and ^{1;2;3} are Paulim atrices.

The Berry phase connection (BPC) is de ned by the di erential change of states projecting to them selves. In this paper, it will be illustrated by using the state with a positive eigenvalue. BPC obtained from the state with a negative eigenvalue is simply the complex conjugate to the one with the eigenvalue of a di erent sign. The BPC and its eld strength can be obtained respectively.

The gauge invariant magnetic eld can be de ned as

This is a U (1) magnetic-monopole like eld in the dspace. It emerges when there are line defects in the \hat{d} eld, eg;, half-quantum vortices in the super uid H e 3A phase. If we transport the spin-1/2 ferm ion adiabatically around the vortex, the electronic wavefunction gains the phase accumulated due to the \hat{d} eld, as we discussed previously. Moreover, the rst Chem number can be computed easily.

This is the famous t'Hooff-Polyakov monopole $(TPM)^{8,22}$. Dierent from the Dirac monopole, the gauge eld of TPM is non-abelian and nite everywhere over $S^2=Z_2$ while the Dirac magnetic monopole is abelian and has a singularity string. There is a deep and direct relation between them, which can be achieved by a singular gauge transform ation^{23,24,25}.

The present SO (3) Berry phase de nes a SO (3) gauge theory on $S^2=Z_2$. U sing the covariant derivative $D_a = Q_a + A_a$, the SO (3) generators in the presence of t'H ooff-Polyakov monopole can be written as^{26}

with ; = 1;2. is the antisymmetry tensor which has only one component $_{12} = 1$ in this case. It is obvious that J = J_{12} form sthe U (1) generator on $S^2=Z_2$. From the de nition of Eq.(12), one can extract the U (1) BPC regardless the unnecessary $\frac{3}{2}$.

We should notice that the singular gauge transform ation we used has a singularity string along the negative z-axis. Therefore, while the covariant SO (3) BPC is - nite over the whole \hat{d} eld, the U (1) BPC has a singularity string which is rejected through the transform ation. This transform ation is only valid on the northerm hem is sphere including the equator of the $S^2=Z_2$. One is able to choose another gauge which has the singularity along the positive z-axis to describe the transform ation on the southerm hem isphere.

The role of this singular gauge transform ation is very intriguing. We can view the covariant SO (3) gauge potential A_a^c in Eq.(8) as a vector d_c pointing in the isospin space. The singular gauge transform ation is nothing but the rotation of the spin vector from d_c to d_3 . Therefore, the invariant subgroup of SO (3) is emerged from the isometry group of the equator of $S^2=Z_2$, which is U (1). This mechanism accounts for the appearance of the U (1) Berry phase in this problem. As a result, the SO (3) Berry phase.

III. S-WAVE QUINTET PAIRING CONDENSATE IN SPIN-3/2 SYSTEM

A. Goldstein manifold and the $2^{\rm nd}$ H opfm ap

Another candidate for non-trivial gauge structures is the spin-3/2 ferm ionic system with contact interaction, in which an exact SO (5) symmetry was identied recently¹⁸. It may be studied in the ultra-cold atom ic systems, like ⁹Be, ¹³²Cs, ¹³⁵Ba, ¹³⁷Ba. The four-component spinor $(c_{\frac{3}{2}}; c_{\frac{1}{2}}; c_{-\frac{3}{2}})^{T}$ forms the spinor representations of the SU (4) group which is the unitary transform ation of the four-component complex spinor. The kinetic energy term has the explicit SU (4) symmetry. How ever, the s-wave contact interaction term breaks the SU (4) symmetry to SO (5). Because of the s-wave scattering, there are only the singlet and quintet channels as required by the Pauli's exclusion principle. Interestingly, the spin SU (2) singlet and quintet channels interaction can also be interpreted as SO (5) group's singlet and 5-vector representations.

The Cooper pair structures has also been studied in spin-3/2 system ^{18,27}. The singlet and quintet pairing channel operators are described by

The quintet pairing structure is spanned by the vepolar like operators $^{y}_{1}$ ₅, whose expectation value has a 5-vector and a phase structure as d_aeⁱ. The Goldstone manifold for the quintet pairing is

Because the 4-component spinor forms the 7dimensional sphere, similar to the spin 1=2 case, the adiabatic transportation of the quasi-particle around a halfquantum vortex in our spin-3/2 system de nes a map

B. Berry connection, 2nd C hern num ber, SO (4) m onopole and Yang m onopole

Let us introduce the spinor

The subscript a runs from 1 to 5. d_{a} forms a 4-dimensional sphere S⁴. ⁰ is the 4 4 identity matrix, and ^a are given by Eq.(19). The eigenvalues of Eq.(25) are

We are interested in the system with the presence of half-quantum vortices. The form ation of this kind of vortices is very sim ilar to the ones in the spin-1/2 system. If we transport the spin-3/2 ferm ion adiabatically around one of them, a nontrivial phase is accumulated due to the \hat{d} eld. The BPC and the covariant eld strength can be obtained respectively by

in the pseudoparticle eld in high dimensions 28,29,30 . Instead of the rst Chern number, we have the non-vanishing second Chern number.

Similar to the projection operator $\hat{q} \hat{q}$ in QED, $P_{ab;cd}$ is the transverse projection operator from 10-dimensional space to 6-dimensional space satisfying $d_{a}P_{ab;cd} = 0$. The relation between F_{abc} and ordinary eld strength f_{ab} can be revealed if we de ne G_{ab} which is dual to F_{abc} by $G_{ab} = a_{bcde}F_{abc}^{29,30}$. Then, one can show

Because of the projection operator $P_{ab;cd}$ in f_{ab} , the fundam ental degrees of freedom of the gauge structure in this problem is not SO (5) but SO (4), because SO (4) has six generators. We shall show that it is able to make a route from f_{ab} to the SO (4) gauge eld strength using a singular gauge transform ation. Sim ilar to the analysis in the second section, the transform ation operator in this SO (5) case has the follow ing form

where are the SO (4) generators in the $(\frac{1}{2};0)$ $(0;\frac{1}{2})$ representation which have the following form

where $i = {}_{i} {}_{4} + {}_{i} {}_{4}$ is the t'H ooft symbol, and runs from 1 to 4. In this reducible representation of SO (4) gauge group, one can easily distillate the SU (2) ingredients because SO (4) = SU (2) SU (2). The selfdual SU (2) gauge eld is given by

Similar to the spin-1/2 system, we obtain the SO (4) BPC which is only dened on the northern hem isphere with the equator. The singularity string along the negative z-axis inherits from the singular gauge transform ation. The role of the singular gauge transform ation by U can be also interpreted as the rotation of a 5-dimensional vector from an arbitrary direction d_a to d_5 in the 5-dimensional isospin space. Therefore, the invariant subgroup is the isometry group of the equator $S^3=Z_3$, which is SO (4). Surprisingly, the the representation we achieve in SO (4) gauge theory is the reducible $(\frac{1}{2};0)$ ($0;\frac{1}{2}$), which is the direct sum of two SU (2) gauge theory. Thus, the SU (2) Berry phase naturally arises in this system.

This SU (2) nature of the Berry phase in the spin-3/2 system is manifested if we choose a special spinor j i such that $_{k}$ j i = j $_{k}$ je i j i, which is studied by D em ler and Zhang¹⁴. In this representation, j i is not only a SU (4) spinors but also a SO (5) one. Then, the BPC is given by

This is exactly the SU (2) holonomy in the context of D em ler and Zhang¹⁴. The special choice of the spinors j i is equivalent to xing $\hat{d}_a = \hat{d}_5$ in our notion.

IV. CONCLUSION AND DISCUSSION

In summary, we found that the SU (2) non-Abelian Berry phase emerges naturally in quintet condensates of

spin 3/2 ferm ions. The underlying algebraic structures for the 3 H e and the spin-3/2 system are the 1st and the 2nd Hopfm ap respectively. The Chern num bers for both cases were obtained in a standard manner. In the previous case, only the rst Chem number is non-vanishing, while in the later case, only second Chem number is nonzero. Both system s appear to have nite gauge potential, which means that the BPC can be de ned covariantly everywhere over the d-eld. However, the corresponding U (1) and SU (2) gauge connections can only be dened patch by patch in the d-space. The bridge across between the nite gauge connection and the one with singularity is constructed by the singular gauge transform ation, which can only be de ned patch by patch in the d-space as $w \in \mathbb{R}^{31}$. The singular gauge transform ation also bear with som e physical meaning. It can be understood as the rotation in the spin (isospin) space, namely da. W hen the spin (isospin) points to the north pole, the invariant subgroup becom es the isom etry group of the equator. W hen it is rotated by the gauge transformation, the gauge structure becomes nite and covariant over the whole d space.

To experimentally manifest this topological e ect, the spin-3/2 ultra-cold atom ic systems may serve as a promising candidate. It may also shed some light on measuring the second Chem number, which has not be revealed by any system so far. Furthermore, our calculation can also be generalized to consider the spin- $\frac{7}{2}$ superconductors in which the algebraic structure is suggested to be the third H opfm ap³².
