### M agnetoelectric subbands and eigenstates in the presence of Rashba and D resselhaus spin-orbit interactions in a quantum wire

#### A bstract

We derive the eigenenergies and eigenstates of electrons in a quantum wire subjected to an external magnetic eld. These are calculated in the presence of spin orbit interactions arising from the Rashba (structural inversion asymmetry) and Dresselhaus (bulk inversion asymmetry) elects. We consider three cases: the external magnetic eld is oriented (i) along the axis of the wire, (ii) perpendicular to the axis but parallel to the electric eld associated with structural inversion asymmetry (Rashba electric), and (iii) perpendicular to the axis as well as the electric eld. In all cases, the dispersions of the eigenenergies are non-parabolic and the subbands do not have a xed spin quantization axis (meaning that the spin polarization of the electron is wavevector dependent). Except in the second case, the dispersion diagrams are also, in general, asymmetric about the energy axis.

#### 1 Introduction




Figure 1: A generic sem iconductor quantum wire de ned by split gates at a heterostructure interface.

Consider a sem iconductor quantum wire de ned by split gates on a two dimensional electron gas con ned at a heterointerface. We will derive the eigenstates and the dispersion relations of the eigenenergies in this wire when it is placed in an external magnetic eld of ux density B (Fig. 1).

Referring to Fig. 1, the potential in the y-direction (perpendicular to the heterointerface) is approximately triangular which leads to a structural inversion asymmetry and an associated Rashba spin orbit interaction [1]. Additionally, if the material has bulk inversion asymmetry (e.g. InAs), then there will be a Dresselhaus interaction [2] which is important at large wavevectors. The potential in the z-direction will be approximately parabolic and hence symmetric about a center under inversion. Thus, there is no signicant overall Rashba interaction associated with the z-directed electric eld.

We will consider three cases corresponding to the external magnetic eld being oriented along three possible coordinate axes  $\{x, y \text{ and } z.$ 

### 2 Magnetic eld directed along the wire axis (i.e. x-axis)

When the magnetic eld is oriented along the axis of the wire, the elective mass Hamiltonian for the wire, in the Landau gauge A = (0, Bz, 0), can be written as

$$H = (p_x^2 + p_y^2 + p_z^2) = (2m) + (eB zp_y) = m + (e^2B^2z^2) = (2m) (g=2)_B B_x$$

where g is the Lande g-factor,  $_{\rm B}$  is the Bohrm agneton,  $_{\rm V}$  (y) and  $_{\rm V}$  (z) are the con ning potentials along the y- and z-directions, -s are the Pauli spin m atrices, is the strength of the D resselhaus spin-orbit interaction and is the strength of the R ashba spin-orbit interaction.

The quantities are de ned in ref.  $[\beta]$ . We will assume that the wire is narrow enough and the temperature is low enough that only the lowest magneto-electric subband is occupied. Since the Ham iltonian is invariant in the x-coordinate, the wavevector  $k_x$  is a good quantum number and the eigenstates are plane waves traveling in the x-direction. A coordinally, the spin Ham iltonian (spatial operators are replaced by their expected values)  $\sin pli$  es to

where E  $_0$  is the energy of the lowest magneto-electric subband,  $_1$  (B) =  $\{k_y^2 > < k_z^2 > + (e^2B^2 < z^2 > =h^2)\}$ , (z) is the z-component of the wavefunction, (y) is the y-component of the wavefunction,  $\{k_y^2 > = (1=h^2) < (y)\}$  ( $\{k_z^2 = (y^2)\}$ ) (y) > ,  $\{k_z^2 > = (1=h^2) < (z)\}$  ( $\{k_z^2 = (y^2)\}$ ) (z) > , and  $\{k_z^2 = (y^2)\}$  (z) > , and  $\{k_z^2 > (y)\}$  (z)  $\{k_z^2 > (y)\}$ 

Since the potential V (z) is parabolic (V (z) = (1=2)m  $!_0^2 z^2$ ), it is easy to show that  $< k_z^2 > = m$  !=(2h) and  $< z^2 > = h=(2m$ !) where ! $^2 = !_0^2 + !_c^2$  and ! $_c$  is the cyclotron frequency (! $_c = eB = m$ ). Furtherm ore, E $_0 = (1=2)h! + E$  where E is the energy of the lowest subband in the triangular well V (y).

D iagonalizing this Ham iltonian in a truncated Hilbert space spanning the two spin resolved states in the lowest subband yields the eigenenergies




Figure 2: Energy versus wavevector  $k_x$  in a quantum wire where we have assumed  $_1$  =  $_1$  = 10  $_1$  eV-m, the magnetic ux density = 1 Tesla, the electron mass m is 0.05 times the free electron mass and the Lande g-factor = 4. This corresponds to = 0.115 meV. The magnetic eld is in the x-direction (along the wire).

The dispersion relations given by Equation (3) are plotted in Fig. 2 for the case Note that the dispersions are clearly nonparabolic and asymmetric about the energy axis. More im portantly, note that the eigenspinors given in Equation (4) are functions of kx because ky depends on  $k_x$ . Therefore, the eigenspinors are not xed in any subband, but change with  $k_x$ . In other words, neither subband has a de nite spin quantization axis and the orientation of the spin vector of an electron in either subband depends on the wavevector. Consequently, it is always possible to nd two states in the two subbands with non-orthogonal spins. Any non-magnetic scatterer (impurity, phonon, etc.) can then couple these two states and cause a spin-relaxing scattering event.

#### Spin com ponents 2.1

The spin components along the x, y and z directions are given by

$$S_{m}^{(1)} = [ (1)]^{y} [_{m}] [(1)] m = x; y; z$$

This yields  $S_x^{(1)}$   $(k_x) = \sin(2_{k_x})$ ,  $S_y^{(1)} = 0$  and  $S_z^{(1)}$   $(k_x) = \cos(2_{k_x})$ It is easy to see that, in general,  $S_x^{(1)}$   $(k_x) \in S_x^{(1)}$   $(k_x)$  and  $S_z^{(1)}$   $(k_x) \in S_z^{(1)}$   $(k_x)$ . However, if the D resselhaus interaction vanishes ( $_1 = 0$ ), then  $S_x^{(1)}(k_x) = S_x^{(1)}(k_x)$  and  $S_z^{(1)}(k_x) = S_z^{(1)}(k_x)$ . This does not always mean that, in the absence of D resselhaus interaction, oppositely traveling electrons have anti-parallel spin components along the wire axis, and parallel spin components in the z-direction. The reason being that the velocity operator is not p=m and hence electrons with opposite signs of wavevector  $k_x$  need not have opposite signs of velocity.

## 3 M agnetic eld perpendicular to wire axis and along the electric eld causing R ashba e ect (i.e. along y-axis)

W ith this orientation of the magnetic eld, we will use the Landau gauge A = (B z, 0, 0), and the Ham iltonian for the wire can be written as

$$H = (p_x^2 + p_y^2 + p_z^2) = (2m) \quad (eB zp_x) = m + (e^2B^2z^2) = (2m) \quad (g=2)_B B_y$$
$$+ V(y) + V(z) + [_{x x} + _{y y} + _{z z}] + (=h)[(p_x + eB z)_z p_{z x}] \quad (6)$$

U sing the de nition of the  $\neg$ s, and noting that the expected values  $\langle z \rangle = \langle p_z \rangle = 0$ , the spin H am iltonian can be simplified to

$$H = (h^2 k_x^2) = (2m) + E_0 + {}_2 k_x x y + k_x z$$
 (7)

where  $_{2}$  (B) =  $[< k_{v}^{2} > < k_{z}^{2} > ]$ .

Again, diagonalizing this Ham iltonian in a truncated Hilbert space spanning the two spin resolved states in the lowest subband yields the eigenenergies

$$E^{(2)} = \frac{h^2 k_x^2}{2m} + E_0 \qquad q \frac{}{2 + \frac{2}{2} k_x^2 + \frac{2}{2}}$$

and the corresponding eigenstates

where  $_{k_x}^0 = (1=2) \arctan \left[ \begin{array}{ccc} p & \hline \\ \hline (_2k_x)^2 + & ^2) \end{array} \right] = k_x \, ]$  and  $_{k_x} = \arctan \left[ \begin{array}{ccc} = _2k_x \, \end{array} \right].$




Figure 3: Energy versus wavevector  $k_x$  in a quantum wire where the magnetic ux density is along the y-direction. We have assumed  $_2$  =  $_1$  = 10  $_2$  = 10  $_2$  = 10  $_3$  eV-m . All other parameters are the same as in Fig. 2.

In Fig. 3, we plot the dispersion relations for the case = 2. Note that the dispersions are again clearly nonparabolic, but this time they are symmetric about the energy axis. The eigenspinors are functions of  $k_x$  because  $0 \le k_x$  and  $0 \le k_x$  depend on  $0 \le k_x$ . Therefore, the eigenspinors are again not xed in any subband, but change with  $0 \le k_x$ . Neither subband has a denite spin quantization axis and the spin of an electron in either subband depends on the wavevector. Consequently, it is again always possible to not two states in the two subbands having non-orthogonal spins and a non-magnetic scatterer can couple these two states causing a spin-relaxing scattering event.

#### 3.1 Spin components

The spin components along the x, y and z directions are given by

Again,  $S_x^{(2)}$  ( $k_x$ )  $\in$   $S_x^{(2)}$  ( $k_x$ ) and  $S_z^{(2)}$  ( $k_x$ )  $\in$   $S_z^{(2)}$  ( $k_x$ ). However, if the D resselhaus interaction vanishes ( $_2$  = 0), then  $S_x^{(2)}$  ( $k_x$ ) =  $S_x^{(2)}$  ( $k_x$ ) and  $S_z^{(2)}$  ( $k_x$ ) =  $S_z^{(2)}$  ( $k_x$ ).

# 4 Magnetic eld perpendicular to wire axis and the electric eld causing Rashba e ect (i.e. along z-axis)

In this case, using the Landau gauge  $A = (B (y y_0), 0, 0)$ , the H am iltonian for the wire can be written as

$$H = (p_x^2 + p_y^2 + p_z^2) = (2m) + (eByp_x) = m + (e^2B^2y^2) = (2m) (g=2)_B B_z$$
$$+ V(y) + V(z) + [_{x x} + _{y y} + _{z z}] + (=h)[(p_x + eBy)_z p_{z x}]$$

where  $y_0$  is a gauge constant.

U sing the de nition of the -s, the spin H am iltonian can be simplied to

$$H = (h^{2}k_{x}^{2}) = (2m) + (eB h = m) (< y > y_{0})k_{x} + E_{0}^{0} + (_{3}k_{x} + )_{x}$$

$$_{z} + (k_{x} + eB (< y > y_{0}) = h)_{z}$$

where E  $_0^0$  is the energy of the lowest magneto-electric subband,  $_3 = [< k_y^2 > < k_z^{0^2} > ]$ , and = (eB = h)I(B) where  $I(B) = _1^{R_1} (y y_0)(0 (y;B) = 0 y)^2 dy$ ,  $_2(y;B)$  is the y-component of the wavefunction and  $_3(y) = _1^{R_1} (y;B)^2 y dy$ . We choose the gauge constant  $_3(y) = _3^{R_1} (y;B)^2 y dy$ . This simplies the Hamiltonian to

$$H = (h^2 k_x^2) = (2m) + E_0^0 + (_3 k_x + )_x z + k_x z$$

Finally, diagonalizing this Ham iltonian in the truncated Hilbert space spanning the two spin resolved states in the lowest subband yields the eigenenergies

and the corresponding eigenstates

where  $_{\mathbf{k}_{\mathbf{x}}}^{0}$  = (1=2)arctan[(  $_{3}\mathbf{k}_{\mathbf{x}}$  + )=(  $\mathbf{k}_{\mathbf{x}}$  )].




Figure 4: Energy versus wavevector  $k_x$  in a quantum wire where the magnetic ux density is along the z-direction. We have assumed = 0.115 meV and  $_3$  = 10  $^{11}$  eV-m . All other parameters are the same as in Fig. 2. This dispersion is sym metric about the energy axis only because the parameters were so chosen that  $_3$  = ; otherwise, it would have been asym metric.

In Fig. 4, we plot the dispersion relations for the case = 3 and = . As before, the dispersions are clearly nonparabolic and unless  $_3$  = , they are asymmetric about the energy axis. The eigenspinors are functions of  $k_x$  because  $_{k_x}^0$  depends on  $k_x$ . Therefore, the eigenspinors are again not xed in any subband, but change with  $k_x$ . Neither subband has a denite spin quantization axis and the spin of an electron in either subband depends on the wavevector. Consequently, it is again always possible to not two states in the two subbands having non-orthogonal spins and a non-magnetic scatterer can couple these two states causing a spin-relaxing scattering event.

#### 4.1 Spin components

The spin components along the x, y and z directions are given by

$$S_{m}^{(3)} = [ (3)]^{y} [_{m}] [ (3)] m = x;y;z$$

This yields  $S_x^{(3)}$   $(k_x) = \sin(2 \frac{0}{k_x})$ ,  $S_y^{(3)} = 0$  and  $S_z^{(3)}$   $(k_x) = \cos(2 \frac{0}{k_x})$ .

In this case,  $S_x^{(3)}(k_x) \notin S_x^{(3)}(k_x)$  and  $S_z^{(3)}(k_x) \notin S_z^{(3)}(k_x)$  unless the D resselhaus interaction vanishes so that  $s_x^{(3)}(k_x) = s_x^{(3)}(k_x) = s$ 

#### 5 Conclusion

We have shown here that the dispersion relations of the lowest eigenstates in a quantum wire placed in a magnetic eld are always non-parabolic and the subbands do not have xed spin quantization axes since the eigenspinor in any subband changes with the wavevector. As a result, a non-magnetic scatterer can always couple two states in two subbands and ip spin. However, if the magnetic eld is absent, then the eigenspinors become wavevector-independent since then = 0 = 0 = 0 = 0 (1=2) arctan [m = 1,2,3). In that case, each subband has a definite spin quantization axes

and the eigenspinors in two subbands are orthogonal. Consequently, a non-magnetic scatter cannot couple the two subbands and ip spin. Spin transport can then be ballistic, particularly because the Elliot-Yafet spin ip mechanism [4] will also be suppressed since the eigenspinors are wavevector independent. This elect, whereby a magnetic eld can cause a crossover from ballistic to non-ballistic spin transport, can have applications in magnetic eld sensors [5].
