## Delocalised states in 1D diagonally disordered system

1D diagonally disordered chain with Frenkel exciton and long range exponential intersite interaction is considered. It is shown that some states of this disordered system are delocalized contrary to the popular statem ent that all states in 1D disordered system are localized.

I. IN TRODUCTION AND MAIN RESULT

It is well known that all wave functions of translationary symmetric systems are delocalized. One of the most interesting properties of the homogeneous disordered systems is the possibility of localized wave functions.

The m athem atical problem s of the theory of disordered system s are very complicated and for this reason the theory of disordered system s is not so well developed as the theory of symmetric system s. Despite this fact some statements related to disordered system s are considered to be well established and reliable. The above mentioned occurrence of the localised band is one of them. The next example of statement of this kind is that all states in 1D disordered system are localised [4]. Recently appeared the reports [3,2] about the delocalisation in 1D systems with intersite interaction in the form:  $J_{n,m} = J=jn m j; 1 <$ 

< 3=2. In this letter we consider 1D diagonally disordered chain with exponential intersite interaction and present arguments (computer simulations and theoretical treatment) in favor of partial delocalisation in this system. In this section we describe the system and present num erical results and in the next section we review the reasons which made us to study this system and present the approximate expression for the mobility edge.

Let us consider 1D Frenkel exciton in diagonally disordered chain. The mathematical problem is reduced to the following random matrix of the Hamiltonian:

R and om values " $_r$  are supposed to be independent and having the distribution function:

The therm odynam ic lim it N ! 1 is in plied. To separate the localised and delocalised wave functions one should use some criterion of localisation. We use the num ber of sites covered by the wave function [7] determ ined as follows. Let us consider some eigen vector of the H am iltonian (1) with components r;r = 1;...;N. W hat contribution one should ascribe to the arbitrary site r? It is naturally to accept that this contribution is zero if  $j_r f = 0$  and equal to unit if  $j_r f = m \arg j_1 f;...;j_N fg$ . So we come to the conclusion that the contribution of the arbitrary site r is  $j_r f = j_{max}^2$ . The total number of sites n () covered by normalised eigen function is the sum of contributions of all sites:

Debcalisation in (1),(2),(3) appear when R >> 1. Below we study the properties of the eigen vectors of (1) with R = 20;  $v_0 = 0.5$ ; = 4; N = 1000.

The dependance of number of sites covered by the wave function against corresponding energy for the Ham iltonian (1) is presented on g.1 (top). It is seen that n (E) is drastically increasing for energies higher than  $E_0$ . A dditional calculations shows that n (E) do not depend on the number of sites N for  $E < E_0$  and is N for  $E > E_0$ . For all these reasons we conclude that states below  $E_0$  are localised and states above  $E_0$  are delocalised.

## II.QUALITATIVE TREATMENT

On our opinion the main properties of the above model which are responsible for the delocalisation are long range of intersite interaction R and the fact that function (") di ers from zero only in the nite region. For these reasons for the qualitative interpretation we apply the following exactly solvable simple model of disordered system. Let the radius of interaction be in nite and write down the simplie of H am iltonian in the form:

Taking advantage of the coherent potential approximation [5,4] one can show that the density of states for H am iltonians (1) and (5) is coincide in the lim it R ! 1;  $v_0$  ! 0;  $2Rv_0 = v$ . We show below that the H am iltonian (5) has one delocalised and N 1 localised eigen functions. Consequently at least one delocalised function should appear in the set of eigen functions of the H am iltonian (1) in the lim it R ! 1. The desire to see how this take place was the starting point for our study of the H am iltonian (1) with R >> 1. Now let us turn to the proof of the above properties of the H am iltonian (5).

The equation for eigen vector e and eigen value of the H am iltonian (5) can be written in the form :

(6) gives an explicit expression for the eigen vectors of (5) as a functions of r and eigen number  $\cdot$  By substituting  $e_r$  in the form ula for S one can obtain the equation for the eigen values :

For Anderson's model (3) all quantities " $_{r}$  are different each other. For the graphical treatment of (7) the qualitative form of (E) function is presented on g2. From g2 one can see that N 1 eigen values are belong to [0; ] and the last eigen value E  $_{m}$  is not belong to this interval and in the therm odynam ic limit can be determined from the equation:

So in the therm odynam ic lim it  $E_m$  is separated from any of "r by nite interval. From (6) one can see that sharp extrem um s of the wave function related to the localisation can appear if 2 [0; ].  $E_m$  do not belong to this interval and we come to the conclusion that the corresponding eigen vector in the case of hom ogineous disorder is delocalised. Now let us show that all others eigen vectors are localised. For this reason introduce the G reen's function in t-representation exp (itH)<sub>rpr</sub> which describe the dynam ics of the wave function on the site r if it was equal to 1 on this site at t = 0. If the nite part of eigen states of the H am iltonian H is delocalised this function goes down to zero when t ! 1 and N ! 1 . If G reen's function do not decrease it means that the main part of eigen vectors is localised and the part of delocalised states is extrem ely sm all [4]. It is convenient to introduce the G reen's function in E-representation:

In the case of H am iltonian (5) the D yson's series for G :

can be exactly sum m ed and give the following expression for G  $_{\rm rr}$  :

In the therm odynamic limit the term 1=N should be omitted and we come to the conclusion that the Green's function have a single pole  $E = "_r$ . This corresponds to the oscillations of the wave function with constant amplitude and we can conclude that the main part of states are localised. It is easy to see that above described oscillations corresponds to the wave function localised on the site r and having an eigen value "\_r + 0 (1=N). From  $g_2$  one can see that there are N 1 eigen values of this kind and we come to the conclusion that the H am iltonian (5) have N 1 localised states and one delocalised with eigen number  $E_m$  (9).

Note that the appearance of the separated delocalised state for (5) is possible only if the distribution function (") is di er from zero in nite interval. For this reason we expect that delocalisation in (1) is also possible if (") is di er from zero in nite interval or at least goes down to zero rapidly enough. This statement con rms by calculations for L byd's model with (") =  $(1 = ) = (2 + m^2)$  when no delocalisation was found.

The energy dependance of number of covered sites for H am iltonian (5) is presented on g.1 (bottom) for v = 20. O ther parameters are the same as for the top picture. One can see that niteness of the interaction radius results in appearance of delocalised states in the gap [;  $E_m$ ] but the boundary energy of spectrum and the mobility edge are the same for both H am iltonians (1) and (5) and are equal  $E_m$  (9) and respectively.




FIG.1. Energy dependance of number of sites covered by the wave function for the H am iltonian (1) with N = 1000, = 4, w (r) =  $v_0 \exp jr = R j v_0 = 0.5$ , R = 20 (top). The same for the H am iltonian (5) with v =  $2R v_0 = 20$  (bottom).


