## Little-Parks e ect in a superconducting loop with magnetic dot

W e have studied the nucleation of superconductivity in a mesoscopic Alloop, enclosing magnetic dot with the perpendicular magnetization. The superconducting phase boundary  $T_{\rm c}$  (B), determined from transport measurements, is asymmetric with respect to the polarity of an applied magnetic eld. The maximum critical temperature has been found for a nite applied magnetic eld, which is antiparallel to the magnetization of the dot. Theoretical phase boundary shows a good agreement with the experimental data.

A great deal of experim ental and theoretical work has been devoted to the investigation of m esoscopic superconductors (e.g. ref. [1, 2] and references therein). Over the past few years hybrid superconductor/ferrom agnet system s have attracted a bt of attention [3, 4, 5, 6, 7, 8, 9, 10, 11, 12]. It has been revealed that a m agnetic dot, em bedded into a superconductor, attracts a vortex, resulting in an enhanced pinning when the m agnetic m om ent m of m agnetic dot and an applied m agnetic eld B have parallel orientation [7, 11, 13]. M oreover, it was recently dem onstrated that perpendicularly m agnetized m agnetic dots could e ciently be used not only to enhance the ux pinning, but also to tune the nucleation of superconductivity [12].

Theoretical studies of individual mesoscopic superconductor/ferrom agnet structures in the disk geom etry were carried out in the fram ework of the G inzburg-Landau form alism, with the emphasis on the vortex phases and transitions deep in the superconducting state [6, 8]. A mesoscopic superconducting Al disk with a perpendicularly magnetized m agnetic dot was recently fabricated and its superconducting phase boundary  $T_c(B)$  was measured [3]. These measurem ents demonstrated that the superconducting critical tem perature is system atically higher when the applied magnetic eld is parallel to the magnetization of the dot. However, in this sample the superconducting phase boundary seems to have been a ected by the proximity e ects between the superconducting disk and magnetic dot.

In this paper the nucleation of superconductivity in a mesoscopic superconducting Alloop, with a magnetic dot at the centre of the opening, is investigated. Given the spatial separation of the superconducting bop and magnetic dot, it is clear that the dot interacts with the bop exclusively through the stray eld and proximity e ects are absent. Therefore, any peculiar features in the  $T_c$  (B) phase boundary can undoubtedly be attributed to the magnetic interaction between the superconducting condensate and the stray eld of the dot.

The sam plew as prepared by electron beam lithography in three steps on a SiO<sub>2</sub> substrate using positive PMMA 950K and the corresponding co-PMMA electron beam resists. The lithography was carried out in a JEOL 5600 scanning electron micrograph modi ed for electron beam writing. The contacts pads, with the size of 500 m, leads and alignment markers were patterned rst and 5nm of Cr and 30 nm of Au were thermally evaporated. A flerwards, the resist was removed with a lift-o procedure, using warm acetone and ultrasonic agitation. The sam ple was covered again with the e-beam resist. A fler the alignment, the mesoscopic loop and contacts were patterned. The designed width of the loop and contacts is 400 nm, whereas the inner radius of the loop is 600 nm. In order to avoid proximity e ects, the mesoscopic contacts next to the loop are 22 m apart from the Cr/Au leads. 35 nm of Alwas therm ally evaporated and a lift-o was carried out. In the nal step, the sam ple was yet again covered with the e-beam resists. A fler a quite precise alignment procedure, magnetic dot with the radius of 200 nm was patterned. A magnetic dot consisting of 2.5 nm Pd bu er layer and 10 bilayers of 0.4 nm Co and 1 nm Pd was subsequently evaporated. The resist was rem oved in a lift-o.




FIG.1: A scanning electron m icrograph of the structure.

Fig. 1 shows an electron m icrograph of the structure. The bright area at the centre is magnetic dot. The actual dimensions of the loop and magnetic dot were obtained from atom ic force m icroscopy. The inner radius of the loop equals  $R_i = 0.55 \text{ m}$ , outer radius is equal to  $R_o = 1.05 \text{ m}$ , whereas the Co/Pd magnetic dot has the radius of  $r_d = 0.27 \text{ m}$ . The m esoscopic contacts next to the loop, used for m easuring voltage, are closer to the loop than initially designed. This electively increases the outer radius of the loop, since the supercurrent can spread into the contacts, thereby a ecting both the periodicity and background of the phase boundary [1].

The superconducting phase boundary  $T_c(B)$  was obtained by four-point transport measurements in a cryogenic setup at tem peratures down to 1:11K, applying the magnetic eld perpendicularly to the sample surface. A transport

current with the rm s of 150 nA and frequency 27:7 H z was used. The response was measured by a PAR124A lockin amplier. The phase boundary was determined resistively by sweeping the magnetic eld at a very low rate, whilst keeping the temperature constant.  $T_c(B)$  curve was afterwards extracted from the magnetoresistance using the resistive criterion  $R_n=2$ , where  $R_n$  is the resistance in the normal state. The temperature and eld steps were 500 K and 5 T, respectively, with the temperature stability 100 K. In order to minimize the in uence of possible temperature gradients, the temperature was being monitored by two independent temperature sensors placed at two di erent positions on the sample holder.

The resistance of the sample at room temperature is 6:6 , the resistance in the norm all state at low temperatures is  $R_n = 2:5$ , whereas the maximum critical temperature  $T_{cm}$  is 1:3422 K.

The multilayer Co/Pd magnetic dot provides a perpendicular magnetization [12, 14]. The hysteresis loop in the




FIG.2: The hysteresis loop of a co-evaporated Co/Pd plane lm obtained by the magneto-opticalKerrm easurements at room temperature. The shaded area indicates the range of the applied magnetic eld.

perpendicular magnetic eld of the co-evaporated plane lm with the same composition, obtained by the magnetooptical K err measurements at room temperature, is presented in Fig. 2. The shaded area indicates the range in which the applied magnetic eld was varied in the experiment. The remanence is complete, whereas the coercive eld is approximately 70 m T. W hen saturated, Co/Pd structures patterned at the sub-micrometre scale are in the single-domain state [12].




FIG.3: The calculated stray eld of the m agnetic dot, averaged over the thickness of the superconducting bop. The stray eld is norm alized to the m agnetization of the m agnetic dot and was calculated assuming a single dom ain structure. The darker shaded area indicates the position of the dot, whereas the lighter shaded area shows the position of the superconducting bop. The arrow shows the direction of the m agnetization.

Fig. 3 shows the calculated stray eld produced by a Co/Pd m agnetic dot, averaged over the thickness of the superconducting loop. The stray eld is norm alized to the m agnetization of the m agnetic dot. The darker shaded area shows the position of the m agnetic dot, whereas the lighter shaded areas indicate the position of the superconducting loop. The arrow shows the direction of the m agnetization m of the dot. The stray eld was calculated assuming a single-dom ain state of the m agnetic dot. Prior to the m easurem ents the dot was m agnetized perpendicularly in

300 m T.As the applied magnetic eld in our experiment never exceeded 30 m T (Fig. 2), it has been assumed that the magnetization of the magnetic dot remains unaltered during the measurements [12].

The uxes of the stray eld (see Fig. 3) through the opening of the loop (r < 0.55 m) and loop itself (0.55 < r < 1.05 [m]) have di erent orientations and, in qualitative terms, there should be a competition between the e ects of these two uxes on the superconducting condensate. Assuming that the loop is su ciently big compared to the coherence length at zero temperature (0) ( $R_i$ ; $R_o >>$  (0), where  $R_i$  and  $R_o$  are the inner and outer radius of the loop, respectively) the loop is similar to a stripe at temperatures much lower than the maximum critical temperature the system can attain  $T_{cm}$  (we will be referring to these temperatures as low temperatures). C learly, the superconducting state of the stripe depends only upon the ux value within the stripe. In other words, at low temperatures the behaviour of the loop is governed by the ux through the loop and not by the ux in the opening of the loop. Therefore, at low temperatures the shift of the  $T_c$  (B) phase boundary along the B -axis is expected to be in the direction of the dot magnetization. At temperatures close to the maximum critical temperature (we will be referring to these temperatures as high temperatures), the direction of the shift of the  $T_c$  (B) phase boundary along the B -axis is expected to be in the direction of the dot magnetization. To describe quantitatively the  $T_c$  (B) phase boundary the G inzburg-Landau theory has been used. The free energy of the superconducting structure can be expressed as

where is the modulus of the order parameter, A is the vector potential, an integer number L stands the winding number (vorticity) of the order parameter,  $_0$  is the superconducting ux quantum, whereas and represent the G inzburg-Landau parameters. The integration is performed over the area of the bop. In Eq. (1) cylindrical symmetry of the order parameter near the phase transition to the normal state has been taken into account. As the thickness of sample is much smaller than (T) within the temperature range of interest, there is no modulation of the order parameter in the direction of the applied eld. For this reason, the stray eld can be averaged out over the thickness of the sam ple and the problem is reduced to the 1D case. eld is equal to the sum of the stray eld and an applied magnetic eld. Therefore, the vector potential may be expressed as  $A(r) = A_s(r) + Br=2$ , where  $A_s(r)$  is the vector potential of the stray eld and B is an applied magnetic

eld. We represent (r) as a Fourier expansion within the range  $R_i$  r  $R_o$  and consider the coe cients of the expansion the variational parameters. The values of these parameters can be calculated by a minimization of the free energy, yielding the solution of the full G inzburg-Landau system of equations. The transition to the normal state corresponds to = 0. We have found that for our sample and experimental conditions, only the rst term in the Fourier expansion is important, that is, is constant within the sample, whereas all other terms are negligibly sm all and practically do not a ect the position of the phase boundary.




FIG. 4: The measured (open symbols) and calculated (solid line) superconducting phase boundary given as  $1 T_c(B) = T_{cm}$  versus the normalized ux =  $_0$ . Here  $T_{cm}$  is the maximum critical temperature and  $_0$  is the superconducting ux quantum.

Fig. 4 presents the superconducting phase boundary, given as 1  $T_c(B)=T_{cm}$  versus the normalized ux =  $_0$ .  $T_{cm}$  is the maximum critical temperature and  $_0$  is the superconducting ux quantum. Applied elds parallel to the magnetization of the dot are taken as positive and vice versa. The open symbols are experimental data, whereas the solid line corresponds to the theoretical curve for  $R_i = 0.55 \text{ m}$ , and  $r_d = 0.27 \text{ m}$ . The coherence length at zero temperature (T = 0) has been used as a tting parameter as it depends upon the preparation procedure and can show moderate variations even amongst samples prepared simultaneously. Due to the in uence of the mesoscopic contacts, the outer radius has to be used as a tting parameter, since the supercurrent is not con ned only by the ring, but can well ow into the mesoscopic contacts, thus e ectively increasing the outer radius. The best thas been obtained for the coherence length at zero tem perature (0) = 96 nm and the outer radius  $R_o = 1130 \text{ nm}$ . The latter is quite close to the actual radius  $R_o = 1050 \text{ nm}$ .

The theoretical  $T_c$  (B) curve is in a good agreem ent with the experim ental data. The asym m etry, shift and periodicity of the experim ental data have been reproduced well. The asym m etry and the shift can be explained by considering Eq. (1). From this equation it follows that the maximum critical tem perature, for a xed L, is attained when the applied eld is equal to

The corresponding critical tem perature is

where  $T_{c1}$  stands for the bulk critical tem perature of Al. For the sake of sim plicity, we assume that the stray eld does not change considerably over the width of the loop. Denoting the average eld in the opening of the loop and within the loop as  $B_{op}$  and  $B_1$ , respectively Eqs. (2) and (3) reduce to

The maximum critical temperature  $T_{cm}$  can be found by the minimization of the right-hand side of the Eq. (5) with respect to the integer L.Eq. (4) gives the shift of the  $T_c$  (B) curve along the B-axis close to the  $T_{cm}$ , caused by the

presence of an additional magnetic eld. This shift is a sum of two contributions. The rst term is just a compensation of the stray eld  $B_1$  within the loop. The second term describes the eld of the inhomogeneity of the stay eld. This contribution behaves rather nontrivially due to the discreteness of L. For instance, when  $0 < R_1^2 (B_{op} - B_1) < 0.5_0$ , it follows from Eq. (5) that L = 0, and the second contribution to the shift is negative. If the size of the dot and/or the intensity of the stray eld are increased  $0.5_0 < R_1^2 (B_{op} - B_1) < 0.1_0$ , L switches to 1, and the second contribution become spositive. Physically, this means that it is energetically more favorable for the system to change the vorticity by 1 in order to decrease the modulus of the current in the loop. As a result, the current and the total shift, de ned by Eq. (4), can change the sign. Thus, we may conclude, that the contribution to the shift, which is caused by the stray eld inhom ogeneity, is a periodic function of  $B_{op} - B_1$  and vanishes in the case of a hom ogeneous eld,  $B_{op} = B_1$ . The total shift of the  $T_c (B)$  curve along the B-axis close to the  $T_{cm}$  can be of both signs for the same orientation of magnetization of the dot.

O ur calculations have shown that at low temperatures the shift of the phase boundary is controlled only by the average stray eld within the loop and is equal to  $-B_1$ , which is in accordance with the preliminary qualitative analysis. If the additional magnetic eld were hom ogeneous, the shifts of the  $T_c(B)$  phase boundary for low and high temperatures would have the same direction. The inhom ogeneity of the stay eld gives rise to two di erent and mutually independent shifts of the phase boundary in the low and high temperature ranges, which, in turn, twist the whole superconducting phase boundary, as presented in Fig. 4.

We would like to note that the discrepancy between the theoretical and the experim ental data for low tem peratures can be attributed to the e ect of contacts, since they change the geometry of the sample, which cannot be entirely accounted for only by using the outer radius of the loop as a tting parameter.

To sum marize, we have fabricated a mesoscopic superconducting loop with a magnetic dot at the centre of the opening and investigated the onset of superconductivity in this structure by measuring the superconducting  $T_c(B)$  phase boundary. The phase boundary has been found to be asymmetric with respect to the polarity of an applied magnetic eld. The structure exhibits the maximum critical temperature for a nite value of the applied magnetic eld, which is antiparallel to the magnetization of the magnetic dot. The theoretical superconducting phase boundary, obtained in the fram ework of the G inzburg-Landau theory, is in a good agreement with the experimental data. It has been demonstrated that the inhom ogeneous stray eld shifts the  $T_c(B)$  phase boundary along the B-axis independently in the low and high temperature ranges. In the limit of a thin loop with a large radius, these shifts are determined by the average value of the stray eld in the opening of the loop and within the loop.
