## Abstract

Multivariate probability density functions of returns are constructed in order to model the empirical behavior of returns in a nancial time series. They describe the well-established deviations from the G aussian random walk, such as an approximate scaling and heavy tails of the return distributions, long-ranged volatility-volatility correlations (volatility clustering) and returnvolatility correlations (leverage e ect). Free parameters of the model are xed over the long term by thing 100+ years of daily prices of the D ow Jones 30 Industrial A verage. The multivariate probability density functions which we have constructed can be used for pricing derivative securities and risk management.

The methods developed in studying complex physical system s have been successfully applied throughout decades to analize nancial data [1{3] and they continue to attract gradual interest [4{11]. The eld of research connected to modeling nancial markets and development of statistically based real-time decision system s has recently been named E conophysics. The properties of certain observables of dierent nancial markets appear to be quite similar, indicating the existence of universal driving mechanism s behind market evolution. The understanding of the dynamics of complex nancial system s has an in uence on the decisions of market participants and on the market behavior and represents a scientic challenge for research. The methods of E conophysics have made previous progress connected to the occurrence of quantitatively based nancial management rm s and the development of high performance online system s which use methods of statistical inference from real-time and historical prices as well as other economic information.

The behavior of a nancial time series can be described by a generalized W interprocess. In terms of a drift rate , the evolution of a market index value or a stock price S (t) is governed by equation [4]:

The value d (t) is a noise added to the path followed by S (t) with the expectation value and variance of

The volatility (t) represents a generic measure of the magnitude of market uctuations. It quantiles risk and enters as an input to option pricing models. We consider a discrete random walk and set dt  $\[mathbf{t}\]$   $\[ma$ 

The random walk model proposed by Bachelier in the year 1900 [1] is equivalent to the Gaussian multivariate probability density function (PDF) of the increments  $_i$ :

The statistically signi cant correlations of the increments  $_{i}$  are absent from a time frame greater than  $t_{i}$   $t_{i} = 20 \text{ M}$  in [5]. The absence of the correlations,

has been widely docum ented (see e.g. R ef. [11]) and is often cited as a support for the e cient m arket hypothesis [9]. The m odel (4) constitutes a solid zero-order approximation to the empirical distributions of the increments  $_{i}$ . The multivariate PDFs constructed in this work are extensions of the G aussian PDFs, aim ed to model the well-established deviations in the behavior of nancial time series from the G aussian random walk.

The Levy stable truncated univariate PDFs [2,10,11] are known to provide, for a nancial time series, (i) an approximate scaling invariance of the univariate PDFs with a slow convergence to the Gaussian behavior and (ii) the existence of heavy tails. We propose the multivariate Student PDFs,

for modeling the empirical PDFs with increments  $_{i}$ . It is not discult to verify that the marginal PDF (6) is again PDF (6). If we integrate out all of the  $_{i}$  except for one, we get (6) with n = 1. The tails of the distributions behave empirically like [5]  $d = {}^{4}$ ; and so

In Fig. 1, we compare the n = 1; = 3 Student PDF with the Gaussian PDF and with the empirical univariate PDF constructed for the 100+ years of the daily prices of the D ow Jones 30 Industrial A verage (D JIA), starting on the M ay 26, 1896 and ending on the D ecember 31, 1999 (i.e. a total of 28507 trading days). The drift rate was determined to be = 0:000257; while Var[] = 0:000117. The PDFs are shown as functions of the = with <sup>2</sup> = Var[]. The Student PDF ts the empirical data very well. The common scale parameter is derived from Eq.(8) using the empirical value of Var[].

The correlation of the increments is the same as in the Gaussian random walk and given by Eq.(5). A coording to Eqs.(2), (3), and (7), (8), the square of the volatility equals

The correlation function (9) is positive and does not depend on the lag l = i j:Notice that  $C \operatorname{orr}[j_i j; j_k j] = 2 = (2 + ) = 0:39$ , while the empirical value is two times lower (see below). The correlation function diverges at  $r = \frac{3}{2}$  due to the heavy tails.

The variance of the increases linearly with n; in agreement with the empirical observations. Eq.(12) represents the exact scaling law for the nancial time series, observed empirically by M and elbrot [3] and discussed by m any authors [5,10,11].

The Student conditional PDF at n l = n k that gives a forecast density l steps ahead has the form

The conditional PDF of the values  $_{n}$ ; ...;  $_{k+1}$  is therefore close to the Gaussian PDF. The ARCH models [16] propose that the increments are distributed as  $N(0; ^{2})$ ; with the volatility being a function of the lagged increments. The estimator (14) is one of the possible estimators quantifying the volatility within the ARCH framework.

The multivariate Student PDFs have therefore heavy tails and the exact scaling invariance from the start. The PDFs (6) are apparently a reasonable starting approximation for a precise modeling the empirical PDFs. These distributions can be modiled further to describe two other well well-established stylized facts which are (iii) long ranged volatility-volatility correlations that are also known as volatility clustering [13] and (iv) return-volatility correlations that are also known as leverage e ect [14,15].

The empirical facts show that there is a slow decay of the correlation function. An extension of the PDF (6) that has the value  $\operatorname{Corr}[j_i j_i^r; j_j j_j^r]$  which is decaying with time is rather straightforward. From the representation (11) it is clear that the long ranged correlations occur, since the denom inator  $p_{-2=}$  is common to all of the increments  $_i$ . In order to provide a decay of the correlations, it is su cient to use di erent 's for di erent groups of the  $_i$ 's. The analogy with the Ising model can be useful: The components  $_i$  of the random vector with the same denom inator  $p_{-2=}$  can be treated as domains of spins aligned in the same direction. We assign the usual probability for every such con guration:

we use a superposition of (16) with di erent values of the . The absence of the correlations would form ally correspond to = +1 (= +1). This is the case when the multivariate PDF is a product of the n univariate PDFs.

In order to incorporate leverage e ect, we consider the PDFs (6) with  $!_i$  depending on the signs  $_{ip} = \text{sign}(_{ip})$  of the lagged increments (p = 1;2; ...): The values  $_i = 1$ are assumed to be independent variables which take the two values 1 with the equal probabilities. Taking volatility clustering and leverage e ect into account, we obtain:

The empirical correlation functions for the daily prices of the DJIA are tted using a superposition  $w_1 = c_1 e^{-11} + c_2 e^{-21}$  for 1 > 0 with  $c_1 = 0.18$ ;  $c_2 = 0.08$ ;  $_1 = 1=1200$ ; and  $_2 = 1=233$  (else  $c_0 = 0.74$  and  $_0 = +1$ ; so that  $P_{m=0}^2 c_m = 1$ ): The values (15) can be interpreted as conditional probabilities, while the  $c_m$  are probabilities to get the  $_m$ . We have also used = 1 and  $= \exp(-1=16)$ : The results shown in Fig. 2 are in a very good agreement with the data. The value  $Corr[_i; j_k j]$  vanishes at i > k in agreement with the data.

Finally, the multivariate PDF of the increments is given by

U sing a Pentium IV M icroprocessor, the straightforward calculation of the n = 13 PDF (22) takes = 10 sec. The value of  $c_0 = 0.74$  turned out to be unexpectedly large. It indicates that approximately 75% of the empirical PDF consists of the product of the univariate Student PDFs. The second m on ents of i are nite, so the product does converge to the G aussian PDF due to the central limit theorem [12]. One should thus verify that the PDF (22) nevertheless supports the approximate scaling observed for nancial time series [3,5,11]. In Fig. 3, we plot the scaled PDFs of the values  $= \prod_{i=1}^{P} \prod_{i=1}^{n} i$  for n = 1;2;3;5;8; and 13 as functions of =Var $[\frac{1}{3};$  together with the scaled G aussian PDF.W e see that the convergence to the G aussian PDF is very slow. A qualitative explanation of this phenom enon is based on the fact that the Levy stable PDF ts the central part of the empirical distributions [5,10] and therefore the central part of the Student PDF (see Fig. 1), providing an exceptionally slow convergence to the G aussian PDF. In Fig. 4, we com pare the scaled n = 13 distributions based upon the PDF (22) with the empirical n = 13 PDF. The results are in excellent agreem ent, whereas the n = 1 Student PDF and the G aussian PDF disagree clearly with the data.

The PDF (22) is constructed for the daily increments. There are no a priori reasons to believe that the daily scale is more appropriate than other time scales. The criterion for selection of the best time interval is the quality of the tof the empirical univariate PDF. It is seen from Fig. 4 that e.g. t = 13 days would be an inaccurate choice. At the same time,

the excellent t of the daily empirical PDF, shown in Fig. 1, indicates that the assumption t = 1 day on which the PDF (22) is based is quite reasonable.

If we work with an ensemble of uncorrelated stocks and calculate ensemble averages, we should use the marginal probabilities. If we work with a single index, we only calculate the time averages. In such a case, the conditional probabilities should be used. The previous discussion refers to the calculation of the marginal probabilities. If no correlations exist, as in the case of the Gaussian random walk, the marginal probabilities coincide with the conditional probabilities.

We now present some results for the time averages represented by the conditional probabilities. They are distinct from the marginal ones, since the absolute values of the increments  $_{i}$  are correlated. In our case, the ergodic hypothesis is valid, since all of the values  $_{k}$  and  $\ln(1=)$  are distinct from zero, so the correlation lengths are all nite. This means that the time averages are equivalent to the ensemble averages, provided that the time scale used for the estimation is much longer than the largest correlation length ( $1=_{1}$  5 calendar years). Using smaller time scales, however, the distinction between these two types of the probabilities can be significant.

while the volatility (10) can be referred to as the marginal (unconditional) volatility. The ensemble average of (27) provides (10).

The value in  $S_i=S_{i,1}$  determines the log-return on an asset per interval  $[t_i;t_{i,1}]$ : The increments in  $10^2$  and the drift rate are small, and so i' i to a retapproximation. The Ito's lemma (see e.g. [4]) can be applied to  $\ln S$  (t) where S (t) is governed by Eq.(1) provided that  $E[(d (t))^n] < 1$  for all n. In our case, the asymptotic distributions of the increments are such that  $E[(d (t))^{2n}] = 1$  for n 2. Eq.(1) is therefore equivalent to equation

that cannot be simplied further by expanding the logarithm in the power series of the  $_i$  and discarding the averages of the higher order term s in  $_i$ .

The multivariate PDF of log-returns can be written as dW  $[i] = S_n (i)_F \int_{i=1}^{Q} d_i$  where i is de ned directly by Eq.(28): The know ledge of the multivariate PDF provides, in principle, the most complete information on the future market behavior.

To make a simple check, let us consider the fair value of a stock or a market index at  $t = t_k$ :

The largest one-day variation of the DJIA took place on the October 19, 1987, so the value of is constrained from below by & 0.25:

To illustrate possible applications of the model, let us consider pricing of the log contracts [17]. The fair value of a long position,  $L = \ln S_n = S_k$ ; is dened as the conditional expectation value:

The result depends on the lagged increments through  ${}^{2}_{ik} = Var[{}_{ijk}; ...; {}_{l}]_{F}$  given by Eq.(26). The pricing of log contracts is well de ned both with respect to the fair value and the dispersion.

It is hard to distinguish empirically between the increments  $_{i}$  and log-returns  $_{i}$ . The small distinction results in particular to small return-return correlations due to the non-vanishing correlations of  $_{i}^{2}$  and  $_{k}$ : This e ect is, however, statistically not signi cant for empirical tests. The asymptotic dW  $d = ^{4} e^{3} d$  implies  $E[S_{n}] < 1$ ; and  $Var[S_{n}] < 1$ ; while dW  $d = ^{4} d = (f_{n})$  would cause severe theoretical problem s:  $E[S_{n}] = Var[S_{n}] = 1$ : The asymptotic behavior  $d = ^{4}$  refers apparently to the increments  $_{i}$ .

The asymptotic behavior of the return distribution is in portant for correct estimates of nancial risks. The G aussian walk underestimates the probability of large uctuations, and in particularly, the probability of crushes. The use of the multivariate Student PDF (22) gives a more precise idea on the involved risks, and in particular, on those connected to large market uctuations.

The following four stylized facts (i) heavy tails, (ii) scaling of the returns, (iii) volatility clustering and (iv) leverage e ect are well established empirically, but missing in the Gaussian random walk model. We constructed the multivariate PDFs of incremenets and returns for nancial markets, that take approximately those four elects into account. This model can be useful for more accurately pricing derivative securities and risk management.
