## Possible unconventional superconductivity in N $a_x$ C oO $_2$ yH $_2$ O probed by SR

## Abstract

The superconducting property of recently discovered sodium cobalt oxyhydrate, N  $a_{0.35}$ C oO  $_2$ 1.3H  $_2$ O ( $T_c$  = 4.5 K), has been studied by means of muon spin rotation/relaxation (SR) down to 2 K. It was found that the zero-eld muon spin relaxation rate is independent of the temperature, indicating that no static magnetism appears in this compound, at least above 2 K. The result also provides evidence against the breakdown of time-reversal symmetry for the superconducting order parameter. Meanwhile, the muon Knight shift at 60 kO e shows no obvious reduction below  $T_c$ , suggesting that the local spin susceptibility is preserved upon a superconducting transition. Considering these observations, possible unconventional superconductivity of N  $a_{0.35}$ C oO  $_2$ 1.3H  $_2$ O is discussed.

The recent discovery of superconductivity in a novel cobalt oxide,  $Na_xCoO_2yH_2O$  (x = 0.35; y = 1.3), with the transition temperature  $T_c$   $5\,\mathrm{K}$ , is attracting much interest[1]. The compound has a lam ellar structure consisting of  $CoO_2$ , Na and  $H_2O$  layers, where the two-dimensional (2D)  $CoO_2$  layers are separated by thick insulating Na or  $H_2O$  layers. This structure is similar to high- $T_c$  cuprate superconductors (HTSCs) in the sense that they also have a layered structure of 2D- $CuO_2$  sheets separated by insulating layers. It is well established that  $Cu^{2+}$  (S = 1=2) atom s on a square lattice exhibit antiferror agnetic (AF) ordering in the parent compounds of HTSCs, where the superconductivity occurs when the AF state is suppressed by carrier doping. On the other hand, Co atoms form a 2D triangular lattice on the  $CoO_2$  layers, where a strong magnetic frustration is anticipated. Thus, while  $Na_{0.35}CoO_21.3H_2O$  may be viewed as an electron-doped M ott insulator for a low-spin  $Co^{4+}$  (S = 1=2) with electron doping of x= 35%, the electronic statem by econsiderably different from cuprates.

A lthough several experiments have revealed interesting properties of the present system [2, 3, 4, 5, 6, 7], the situation is far from reaching a consensus on the important issues, including that on the pairing symmetry of superconductivity. Meanwhile, based on the unique structure of the 2D-triangular Collattice, many theoretical models predicting a variety of unconventional superconductivity have been proposed. For example, superconductivity with symmetries of the p+ ip state[3], the  $d_{x^2-y^2}+id_{xy}$  state[9, 10, 11, 12], and the f state[13] are argued. It is notable that some of these states break the time-reversal symmetry of the Cooper pairs, leading to the appearance of a weak spontaneous internal magnetic eld in accordance with the superconducting transition. Such an internal eld can be detected with utmost sensitivity by the zero-eld muon spin relaxation (ZF-SR) technique.

Furtherm ore, the muon K night shift give crucial inform ation about the pairing sym metry of the Cooper pairs. Up to now, there are two  $^{59}$ Co-NMR K night shift measurements. Waki et al. reported a K night shift that is independent of temperature through  $T_c$ , which suggests a spin triplet state for the pairing sym metry [5]. On the other hand, K obayashiet al. showed a decrease of the K night shift with decreasing temperature [4]. The K night shift results are presently a controversial issue. Thus, it is quite important to obtain more clues brought by other experimental techniques, including SR, to settle the issue of paring sym metry. Since the muon has a spin of 1/2, one can deduce the muon K night shift without any complication due to electriceed a gradient. This feature is an advantage of the muon K night shift over

NMR at  $^{59}$ Co (I = 7=2) in which a complex signal pattern is observed.

In this letter, we report on the magnetic and superconducting properties of  $Na_{0.35}CoO_21.3H_2O$  studied by means of the muon spin rotation/relaxation method (SR) down to 2~K. It is inferred from the ZF-SR measurement that there is no appreciable static magnetism over the entire temperature range across  $T_c$ , indicating that the time-reversal symmetry is preserved in the superconducting state. The muon Knight shift at 60~kOe is almost independent of the temperature irrespective of the superconducting transition, which suggests a spin triplet symmetry for the order parameter.

Powder specimens of N  $a_{0.35}$ C oo  ${}_{2}1$  3H  ${}_{2}$ O, including a deuterated one (D  ${}_{2}$ O ' 75%), were synthesized, as described in Ref.[1]. Each specimen was characterized by measuring the magnetic susceptibility prior to a SR measurement. Conventional SR measurements under zero eld and a weak transverse eld (TF, H = 374 Oe) were carried out at the A-port of the Meson Science Laboratory, High Energy Accelerator Research Organization (KEK). The muon Knight shift measurements (TF-SR at 60 kOe) were performed on the M15 beam line of TRIUMF. In both cases, a positive muon beam with a momentum of 27 MeV/c was in planted to a powder specimen placed in a He-gas exchange cryostat, where special precaution was taken to cooldown the specimen rapidly below 100 K to preserve its water content. For ZF-SR, residual eld was reduced to below 10 mOe by using three pairs of correction magnets. For a high-eld measurement at 60 kOe, a powder specimen was secured with Apiezon-N grease to prevent an alignment of ne crystals in the specimen by a strong eld.

Fig. 1 shows the time evolution of the muon spin polarization in Na<sub>0.35</sub>CoO<sub>2</sub>1 3H<sub>2</sub>O at 10 K and 2 K under zero magnetic eld. At 10 K, the muon spin depolarizes due to a static random local eld, which originates from the <sup>59</sup>Co, <sup>23</sup>Na and <sup>1</sup>H nuclear magnetic moments. These spectra can be described by the K ubo-Toyabe relaxation function,  $G_{KT}$  (;;t) [14], as indicated by the solid line in Fig.1. Here, = is the second moment of the eld distribution at the muon site, with being the muon gyrom agnetic ratio (= 2 13.55 kHz/Oe), and is a uctuation rate of the nuclear dipolar eld. From a tting analysis, we obtained =  $5.0 \, \text{G}$  and  $0.22 \, \text{s}^1$  at  $10 \, \text{K}$ . By comparing the experimental value of in the normal phase (10 K) of Na<sub>0.35</sub>CoO<sub>2</sub>13H<sub>2</sub>O (= 0.425(4) s <sup>1</sup>) and that in the deuterated specimen (= 0.243(3) s <sup>1</sup>, also appears in Fig.1), together with calculated mapping of , the muon stopping site was identified near (0.2,0.25,0.12).

As evident in Fig. 1, we observed no signi cant change in the ZF-SR time spectrum while the temperature passed  $T_c$ . Fig. 2 shows the temperature dependence of the dipolar width (), which is nearly independent of the temperature within an accuracy of 0.1 Oe. This result clearly demonstrates the absence of static magnetism over the time window of SR (10  $^9$  10  $^5$  s). The upper bound for the possible magnetic moment was estimated to be 0.001  $_B$ /Co in Na<sub>0.35</sub>CoO<sub>2</sub>1.3H<sub>2</sub>O by using the hyper ne coupling constant,  $A_{hf} = 134.0 \, e/_B$ , which we derive later.

It is theoretically suggested that spontaneous magnetic elds are induced below the superconducting transition when the superconductivity is carried by the magnetic' Cooper pairs. For example, W and et al. proposed that the system falls into a pairing state described by  $d_{x^2-y^2}+id_{xy}$ , and that the orbital current produces a spontaneous magnetic eld, which is estimated to be 10-100 O e[11]. Tanaka and Hu proposed a chiral p-wave state, which also breaks the time-reversal symmetry [8]. Such a spontaneous eld has been observed in a spin-triplet superconductor,  $Sr_2RuO_4$  [15, 16], and quite recently in a heavy fermion superconductor, PrO  $s_4Sb_{12}$  [17]. However, the results given in Figs. 1 and 2 indicate that there is no such enhancement of in the ZF-SR spectra below T  $_c$  in N  $a_{0.35}CoO_21.3H_2O$ , which demonstrates the absence of an additional spontaneous magnetic eld above 0.1 O e in the superconducting phase. This result strongly disfavors a pairing symmetry, like  $d_{x^2-y^2}+id_{xy}$  in N  $a_{0.35}CoO_21.3H_2O$ .

Prior to the muon K night shift measurement, we performed weak transverse eld SR measurements to evaluate the elect of the lux line lattice (FLL) in the mixed state. At 374 Oe, the dumping rate of the spin precession signal slightly increases with decreasing temperature below  $T_c$ , which rejects the formation of FLL, as follows. In the mixed state of a type-II superconductor, an applied magnetic eld ( $H_{cl} < H < H_{cl}$ , with  $H_{cl}$  and  $H_{cl}$  being the lower and upper critical eld, respectively) induces FLL, where the internal magnetic eld distribution is determined by the magnetic penetration depth (), the vortex core radius, and the lattice structure of FLL. When the system falls into the superconducting state with a typical length scale of from  $10^2$  to  $10^3$  nm, it leads to additional dumping of the muon spin precession due to the inhomogeneity of the local eld associated with the FLL state. Unfortunately, in Na<sub>0.35</sub>CoO<sub>2</sub>1 3H<sub>2</sub>O turned out to be too long to deduce detailed information about the structure of vortices, such as the core radius. In such a situation, one can represent the muon spin relaxation approximately by a simple G aussian relaxation,

where the rst term corresponds to the signal from the specimen and the second term to that from the backing silver. The damping factor,  $_s$  (= 0.21 (1) s  $^1$  at 10 K), comes from the relaxation in the normal phase, which is determined by random nuclear dipolar elds, and is thus proportional to , measured by ZF-SR (i.e., =  $^p$ - $_5$   $_s$  [14]).  $f_s$  denotes the volume fraction of the superconducting part in the present specimen, which is estimated to be 0.5 at 2.0K from the tring result. Note that the relaxation rate of backing silver ( $_b$ ) is negligibly small. The internal eld distribution probed by muons is a convolution of the nuclear dipolar eld distribution, and that due to FLL and  $_{\rm FLL}$  indicate the elect of FLL. Fig. 3 shows the temperature dependence of  $_{\rm FLL}$  at 374 Oe, where  $_{\rm FLL}$  increases with decreasing temperature below  $_{\rm FLL}$  in an isotropic superconductor with a hexagonal FLL, the second moment (h B  $^2$ i) is approximately given by [18]

where  $h = H = H_{c2}$  and  $_0$  is the magnetic ux quantum. From these relations, the average penetration depth () is estimated to be 7(1)  $_0$  nm at 2 K under H = 3740e.

The presence of line nodes on the superconducting gap is suggested from recent Co-NQR measurements [6, 7]. Such a structure of the order parameter should be rejected on the temperature/eld dependence of the penetration depth. Unfortunately, the observed in this compound is too long to obtain such information with reliable sensitivity.

The eld inhom ogeneity h B  $^2$ i decreases with increasing eld due to the strong overlap of the ux lines and the increased contribution of vortex cores, leading to a diminishingly small spin relaxation ( $_{\rm FLL}$  0) at higher elds. This tendency is more enhanced when the superconducting order parameters has a nodal structure. In this situation, we can not distinguish the superconducting fraction from the normal fraction in the specimen, and thereby the spectra at 60 kO e can be analyzed by using the following simple relation:

where we neglect the signal from the small amount of Apiezon-N grease, and om it the background term  $(A_b)$  because the measurements at 60 kO e are made without silver backing.

The relaxation rate (s), where the obtained data are shown in Fig. 3 by open circles, is independent of the temperature, indicating that the elect of FLL is negligible. In this case, the frequency shift due to FLL is also estimated to be negligibly small (see below) and the m uon K night shift can be observed. Since  $H_{c2}$  is reported to be 610 kO e with  $T_c$  staying alm ost constant up to 40 kO e by a magnetization measurement [2], the system should be in the superconducting state at 60 kO e. In general, the muon K night shift K (T) is expressed as K (T) =  $K_s(T) + K_{orb}$ . Here,  $K_s$  and  $K_{orb}$  are the spin and orbital components of the K night shift and only K  $_{\rm s}$  (T ) is tem perature dependent. Then, K  $_{\rm s}$  (T ) is determined by the gradient of the muon K night shift versus the magnetic susceptibility (K - ) plot, as shown in Fig. 4 (a), irrespective of K orb (which was set to zero in this analysis). Fig. 4 (b) shows the tem perature dependence of  $K_s$  (T) and the uniform susceptibility at 10 kO e in a random ly oriented sample of Na<sub>0.35</sub>CoO<sub>2</sub>1.3H<sub>2</sub>O. The muon Knight shift decrease with decreasing tem perature below 100 K, and levels o below 10K. Above 10 K, K $_{\rm s}$ (T) is proportional to the uniform susceptibility, which clearly indicates that the upturn of the (T) below 100 K is not due to impurities, but due to some intrinsic origin. The spin part of the muon Knight shift is expressed as K  $_{\rm s}$  = A  $_{\rm hf}$  , where A  $_{\rm hf}$  is the hyper ne coupling constant. From the above relation,  $A_{\rm hf}$  is estimated to be 1340e/  $_{\rm B}$ . It should be noted that the anisotropic term of the Knight shift, or the so-called powder pattern, is not seen in the spectra. This implies that the anisotropy of the Knight shift is too small for the present resolution. In the case of s-wave pairing superconductivity, K  $_{\rm s}$  decreases to zero with decreasing temperature following the Yosida function [19]. However, as shown in the inset of Fig. 4, the muon Knight shift does not show any appreciable reduction below T<sub>c</sub>. Indeed, the average of  $K_s$  for 4.7-10 K (>  $T_c$ ) is 14.4 (5) ppm which is in good agreement with 15:1(5) ppm for 2.0-4.4 K (<  $T_c$ ). This result shows that the spin susceptobility is

Since the observed muon Knight shift is negative, there remains a possibility that the reduction of  $K_s$  below  $T_c$  may be cancelled by the diam agnetic shift upon the formation of FLL. We estimated the magnitude of such a diam agnetic shift by taking account of the exts of a dense overlap of vortices and the Doppler shift; the latter is present when the superconducting gap has nodes, leading to a further enhancement of [20]. This is reasonable considering the recent NQR measurements [6, 7], suggesting line nodes in this compound. Our simulation yielded that '12 m, where the associated diam agnetic shift by the FLL

unchanged in the superconducting state.

form ation is less than 2.8 ppm at 60 kO e, which is too small to cancel out the predicted e ect due to spin singlet superconductivity. Thus, we conclude that the result given in Fig. 4 is entirely attributed to  $K_s$ .

Here, we discuss the sym metry of the Cooperpair. We observed no signicant reduction of the spin part of the muon Knight shift within the error bar below 10 K. If we assume that the residual density of state is 35%, as estimated from one of the reported NMR measurements [7], the reduction in the Knight shift is too small for the spin singlet superconductivity. This suggests that the paring of the Cooperpair is a spin triplet state, which is in line with the result by Waki et al., who observed no reduction of the  $^{59}\text{Co}$  Knight shift below  $T_{\text{c}}$ . Quite recently, a nearly ferrom agnetic spin uctuation was proposed by Ishida et al. These observations seem to be promising for spin triplet superconductivity from the analogy of the super uidity of  $^3\text{He}$ . Our result is inconsistent with the Knight-shift results in Ref [4], which was measured in 15 kOe. The inconsistency might be related to the difference of the applied eld.

Theoretically, p+ip or f wave superconductivity is suggested for the spin triplet superconductivity. Since our result of ZF-SR excludes the possibility of time-reversal symmetry breaking superconductivity, the chiral p-wave superconductivity is strongly disfavored. When the spin triplet d-vector is pinned to some direction, it is expected that 1/3 (d=z-axis) or 2/3 (d? z) of the muon K night shift would decrease in a polycrystalline specimen. The absence of such a reduction in the K night shift suggests that the elective spin-orbit coupling is much weaker than 60 kOe, leading to an alignment of the divector against the external eld.

In sum mary, we have demonstrated by ZF-SR that no static magnetism appears in Na $_{0.35}$ CoO $_2$ 1.3H $_2$ O down to 2K. This leads us to conclude that the time-reversal symmetry is preserved in the superconducting order parameter. The muon Knight shift at 60 kOe exhibits no obvious reduction below  $T_c$  down to 2 K, suggesting that the spin part of the Cooper pair is a spin triplet state.










