Sensitivity and Linearity of Superconducting Radio-Frequency Single-Electron Transistors: E ects of Quantum Charge Fluctuations

We have investigated the elects of quantum uctuations of quasiparticles on the operation of superconducting radio-frequency single-electron transistors (RF-SETs) for large values of the quasiparticle cotunneling parameter $= 8E_J = E_c$, where E_J and E_c are the Josephson and charging energies. We indicate that for > 1, subgap RF-SET operation is still feasible despite quantum uctuations that renormalize the SET charging energy and wash out quasiparticle tunneling thresholds. Surprisingly, such RF-SETs show linearity and signal-to-noise ratio superior to those obtained when quantum uctuations are weak, while still demonstrating excellent charge sensitivity.

The radio-frequency single electron transistor (RF-SET) is a highly sensitive, fast electron eter, and has been suggested as a potentially quantum -limited linear am pli er suitable for m easurem ents of individual electronic charges [1, 2, 3, 4]. Recent investigations have addressed use of the RF-SET as an electrom eter[4, 5, 6], a readout device for charge based qubits [7, 8, 9], and a sensor for real-tim e electron counting experiments [10]. Linearity is a fundam ental assumption of theoretical discussions of the quantum limits of am pli ers [1, 11]. Nonetheless, there has been no detailed investigation of the range of linear response for the RF-SET.

Most theoretical studies of RF-SET perform ance focus on norm alm etal SETs, either in the sequential tunneling [1, 12, 13] or cotunneling regimes [2], while most experim ents are perform ed using a superconducting SET (SSET) [6, 7, 8, 10]. Transport in the SSET can be divided into two regimes, depending on the relative sizes of the bias voltage V_{dc} and superconducting gap : abovegap ($eV_{dc} > 4$), dominated by Coulomb blockade of quasiparticles, and subgap (eV $_{\rm dc}$ < 4), dom insted by combinations of quasiparticle and resonant C ooper pair tunneling known as Josephson-quasiparticle (JQP) cycles [14, 15]. W hile the best charge sensitivities are found for above-gap operation [6], the SSET backaction the rate at which it dephases a measured system | is largest there [1, 3, 9]. Recent work has focused on subgap operation for which backaction is signi cantly reduced, and shot noise is non-Poissonian [3, 7, 16]. Theoretical studies of quantum uctuations in the SSET have been limited to above-gap cotunneling of quasiparticles [17]. In this Letter we nd that linearity and subgap quantum charge uctuations in superconducting RF-SETs are intim ately related: as quantum uctuations strengthen, linearity and signal-to-noise ratio (SNR) improve, while charge sensitivity remains excellent.

Our SSETs consist of a small island connected to macroscopic leads via two A 1/A D_x/Altunnel junctions J1 (2) with normal state resistances R₁₍₂₎ as illustrated




FIG.1: (a) Schem atic diagram of the SET illustrating RF operation. A voltage v_{in} consisting of dc and RF biases V_{dc} and v_{rf} is incident on a tank circuit consisting of an inductor L, a capacitor C_p , and the SET, with tunnel junction resistances and capacitances $R_{1(2)}$ and $C_{1(2)}$. A sm all charge oscillation $q_0 \cos !_m t$ m odulates the rejection coe cient of the tank circuit and therefore the rejected voltage v_r . (b) Electron m icrograph of S2 (taken after all m easurem ents). G ates G1 and G2 were used vary the SET o set charge. (c) Power spectrum of v_r for $q_0 = 0.063e$ rm s and $!_m = 2 = 100 \text{ kHz}$. The m easured sideband power and noise oor were used to nd the charge sensitivity and SNR of the RF-SET.

in Fig. 1 (a). We have fabricated and characterized three samples, S1, S2, and S3 with total resistance $R_n =$ $R_1 + R_2$ of 58, 38 and 24 k; an electron m icrograph of S2 is shown in Fig. 1 (b). The samples were mounted on the mixing chamber of a dilution refrigerator at its base tem perature of 20 m K . A Nb chip inductor L 120 nH together with the parasitic capacitance Cp 02pF of the SET contacts constituted a tank circuit with resonant frequency f_{LC} 1 G H z and quality factor Q 16. We measured the samples' current-voltage (I-V) characteristics in an asymmetric voltage-biased conguration [Fig. 1 (a)] by varying the dc bias voltage V_{dc} in the ab-

sence of an RF excitation. Details of RF operation are similar to those discussed elsewhere [4, 6]. The SET o - set charge Q₀+q₀ cos!_m t consisted of a dc component Q₀ that set the overall working point and an ac component of am plitude q₀ that m odulated the rejected voltage v_r. Power spectra of v_r [Fig. 1 (c)] were used to determ ine the charge sensitivity q and SNR.




FIG. 2: I-V characteristics for (a) S1 (b) S2 and (c) S3 (note scale change), were chosen for Q₀ showing the DJQP process (red), the JQP process (blue), and an interm ediate value of Q₀ (green). The arrows and vertical hash m ark show the peak-to-peak RF amplitude 2Q v_{rf} and dc bias V_{dc} for optim al RF-SET operation. Inset: variation in the m easured charging energy E_c relative to the bare charging energy E_c for S1 (solid triangle), S2 (circle) and S3 (square). Error bars indicate uncertainty in E_c⁰. Solid line: theoretical prediction.




FIG.3: Various JQP cycles. Here J2(1) is on the left (right) and $V_{dc} > 0$. Solid (empty) circles indicate quasielectrons (quasiholes) created during a cycle. (a) JQP cycle. Beginning in the state n = 0 (n = 1), where n is the number of excess electrons on the SET, the transition 0 ! 1 (1 ! 0) is allowed, bringing Josephson tunneling through J1(2) into resonance. Cooper pair tunneling 1, 1 (0, 2) is interrupted by quasiparticle tunneling through the opposite junction 1 ! 0 (2 ! 1), com pleting the cycle. (b) D JQP cycle. When Josephson tunneling is simultaneously resonant through both J1 and J2, transport occurs via the sequence 0, 2, 2 ! 1, 1, 1, 1 ! 0. (c) Proposed V JQP cycle. If the transition 0 ! 1 (1 ! 0) is forbidden, it may still occur virtually. The rem aining JQP transitions are allowed for relevant V_{dc} .

In Fig. 2, we show representative I-V characteristics of the samples in the superconducting state, measured for di erent Q_0 , with $q_0 = 0$. For S1, we observe clear abovegap (V_{dc} > 800 V) current m odulation corresponding to Coulom b blockade of quasiparticle tunneling [Fig. 2(a)]. The main sub-gap features corresponding to the JQP [14, 15] cycles are sharp and clearly distinguished. As illustrated in Fig. 3, the simplest JQP cycle consists of resonant tunneling of a Cooperpair through one junction and dissipative tunneling of two quasiparticles through the other, transporting two electrons through the SET. The cycle can occur only when the transition 0 ! 1(1 ! 0) is allowed, i.e., for $eV_{dc} > E_c + 2$ where $E_c = e^2 = 2C$ is the charging energy of the SET and $C = C_1 + C_2 + 2C_g$ its total capacitance. W hile the JQ P cycle is forbidden at lower bias, at $Q_0 = e = n_q$ $\frac{1}{2}$ and $eV_{dc} = 2E_c$ Cooper pair tunneling is resonant at both junctions and the double JQP (DJQP) cycle becomes possible. The fact that sequential tunneling cannot occurvia either cycle for $2E_{c} < eV_{dc} < E_{c} + 2$ is rejected in S1 by a sharp drop in current at V_{dc} 630 V just below the JQP feature.

As R_n decreases, so does current modulation for $eV_{dc} > 4$, consistent with suppression of the C oulom b blockade by quasiparticle cotunneling [17]: the modulation is reduced for S2, and nearly absent for S3 [Fig.2(b) and (c)]. In contrast, features corresponding to the JQP cycles still exist but become progressively less sharp. Since these cycles involve both C coper pair and quasiparticle tunneling, we hypothesize that subgap quantum

uctuations of quasiparticles are strong, while quantum uctuations of Cooper pairs remain weak. Since to the best of our know ledge no theoretical description of subgap quantum charge uctuations in the SSET exists, we provide sim ple arguments supporting our hypothesis.

We rst compare with known results for above-gap transport. Following Ref. [17] we de ne a parameter $\frac{1}{E_{\circ}} \frac{h}{e^2} (R_1^{-1} + R_2^{-1}) = \frac{3E_{\circ}}{E_{\circ}}$ characterizing the strength of quantum uctuations for quasiparticles, assuming $R_{1(2)} = R_n = 2$ and using the Ambegaokar-Barato rela-

tion for the Josephson coupling energy $E_J = \frac{R_K}{4R_n}$ where $R_K = \frac{h}{e^2}$. Quantum uctuations are negligible for 1. Determ ining E_c from the location of the DJQP peak and E_J from the total junction resistance we calculate as in Table I. None of our samples satisfies 1, although for S1 (= 0.78) some above gap C culom b m odulation survives. The progressively weakening m odulation for S2 (= 1.08) and S3 (= 2.65), is consistent with previous results [17].

Cotunneling as described in Ref. [17] occurs only for $V_{\rm dc} > 4 =:$ it results in two quasiparticle excitations and transfers a single electron through the SET. O ther virtual processes, however, remain in portant for $V_{\rm dc} < 4 =:$. For normal SETs, E $_{\rm c}$ can be renormalized by quantum charge uctuations: e.g.,

near $n_g = 0$, the elective charging energy $E_c = E_c^0 (1 - 4g)$ where $g = R_K = {}^2R_n$ is the dimensionless parallel conductance of the tunnel junctions and E_c^0 the bare charging energy; similar renormalization occurs in the superconducting state [5, 18]. Calculating the rst-order energy shift due to transitions n + n - 1, we not the renormalized charging energy $E_c^s = E_c^0 (1 + g_{\overline{E_c^0}} (1 + 2n_g)) + [\frac{1}{E_c^0} (1 - 2n_g)]$ where $(x) = {}_0^0 K_1^2 (u)e^{-xu}$ du and $K_1 (u)$ is a Bessel function.

U sing the expression for E_c^s , we nd empirically that $E_c^0 = 254$ eV gives the measured E_c for S1. We measure the total geometric junction area A_{tot} for the samples with an estimated accuracy of 20%, obtaining the values in Table I. Setting $E_c^0 = e^2=2C^0$ where $C^0 = C_1^0 + C_2^0 + 2C_g$ and using $2C_g = 80 \text{ aF}$, we obtain $C_1^0 + C_2^0 = 195 \text{ aF}$ as the total unrenormalized junction capacitance for S1. Scaling this result according to A_{tot} we nd C^0 , E_c^0 and nally E_c^s for S2 and S3 [Table I]; agreement is excellent given the uncertainties in A_{tot} . The inset to Fig. 2 shows the relative di erence between E_c and E_c^0 scaled by 1=g. The results agree with theory to within our experimental accuracy, providing strong evidence that subgap quantum uctuations of quasiparticles occur in our samples.




FIG. 4: False color images of $I(V_{dc};n_g)$ for (a) S2 at T = 20 mK (b) a simulation at T = 200 mK assuming an electrom agnetic environment with impedance $R_{env} = 50$ and temperature $T_{env} = 1 \text{ K}$. Cooper pair resonance lines 0, 2 (1, 1) and quasiparticle tunneling thresholds 1! 0 (0! 1) are indicated by the dashed and solid lines.

V intual quasiparticle tunneling m ay also play a role in subgap transport, as suggested by the softening of the JQP cycle cuto in S2 and S3. To illustrate such e ects m ore clearly we show a plot of the I (V_{dc} ;n_g) surface for S2 in Fig. 4(a). The JQP resonances along the 0, 2 and 1, 1 lines and the D JQP peak at their intersection are clearly visible, but there is no sharp cuto of the JQP process below the 1 ! 0 (0 ! 1) thresholds.

For comparison, in Fig. 4 (b) we show a simulation of the current in S2 based on sequential tunneling [19] at an elevated tem perature and including photon-assisted tunneling due to an electrom agnetic environment. Despite the extrem e conditions the quasiparticle tunneling thresholds are clearly visible, and the SSET current drops nearly to zero between the JQP and DJQP features. The absence of quasiparticle thresholds in Fig. 4 (a) calls for an explanation outside of the sequential tunneling picture.

A candidate process that could allow transport along the Cooper pair resonance lines between the JQP and DJQP features is illustrated schematically in Fig. 3(c). If below threshold the transition 1 ! 0 (0 ! 1) occurs virtually, the transitions 0, 2 and 2! 1 (1, 1 and 1! 0) are allowed, completing what we call the virtual JQP (VJQP) cycle. Two quasiparticle excitations are created, but two electrons are transferred through the SET, so that the process should be allowed for eV > 2. The energy barrier E $_{\rm b}$ for 1 ! 0 (0 ! 1) vanishes at threshold and $\dim bsto E_b = E_c + 2$ at the DJQP peak. The process can be neglected if the allowed quasiparticle tunneling rate qp is small compared to the inverse dwelltime of the virtual quasiparticle: $_{\rm qp}$ $E_{\rm b}$ =h.Us- $\frac{R_{K}}{E_{b}}^{2}$, which ing $_{\rm qp} = 4 = e^2 R_n$, this becomes R_n is violated for a range of voltages between the DJQP and JQP features. A detailed theoretical analysis is required to determ ine the contribution of the VJQP cycle to transport.

In contrast to the quasiparticle thresholds, features associated with C coper pair tunneling are visible in both the data and the simulation, suggesting that the num – ber of C coper pairs is well de ned. For the JQP process at resonance, the C coper pair tunneling rate is $_{\rm CP}$ $E_J^2 = h_{\rm QP} = \frac{E_J}{8} [20]$. Demanding that energy broadening due to C coper pair tunneling be small com – pared to the typical energy barrier 4E_c for virtual tunneling gives $2h_{\rm CP}=4E_{\rm C}=\frac{1}{16}\frac{E_J}{E_c}$ 1, which is easily satis ed even for S3. For S2 and S3, then, quantum uctuations are signi cant for quasiparticles but small for C coper pairs.

W e now turn to RF operation. O ptim aloperating conditions were selected as follows: a smallcharge oscillation q_0 0:006e nm s was applied and the SNR determ ined from the power spectrum of v_r as in Fig.1 (c). Subgap operation (all samples) and above-gap operation (S1) were optim ized over dc bias V_{dc} , rf bias v_{rf} and o set charge Q_0 . We measured SNR versus input amplitude q_0 for each optim ization and determ ined the charge sensitivity qusing $q = \frac{p}{BW} \frac{q_0}{10} \frac{SNR=20}{W}$ where the resolution bandwidth BW = 1 kHz and SNR is in dB [6].




FIG.5: Charge sensitivity q and SNR (linear scale) versus q_0 in e rms for (a) S1, above gap, (b) S1, subgap, and (c) S3, subgap. Charge sensitivity (solid red symbols) is plotted on the left axis and SNR (open blue symbols) on the right. For reference, the SNR for linear response is plotted as the dashed lines for q m easured at the sm allest q_0 .

The optimized biases for S1 and S3 are indicated in Fig.2 and the results of the q and SNR measurements in Fig.5. For S1 the best $q = 9 \quad 10^{6} = Hz$ was found for $V_{dc} = 860$ V, consistent with previous results [6]. Linearity, however, was poor: as q_{0} increases, the measured SNR rapidly becomes sublinear, and q

worsens [Fig. 5(a)]. Since q apparently does not saturate even for $q_0 = 4.5 \quad 10^{-3} \text{ e m s it is unclear how}$ small q_0 must be to achieve linear response. For subgap operation ($V_{dc} = \frac{600}{10}$ V) of S1 [Fig. 5(b)], we nd q 1.3 $10^5 \text{ em } \text{Hz}$, with SNR nearly linear to $q_0 < 0.01 \text{ em s}$. Since q appears close to saturation at $q_0 = 3.1 \quad 10^{-3} \text{ em s}$, we may have approached linear response.

For S3 the best operating point occurred at V_{dc} = 440 V [Fig. 5(c)], between the DJQ P and JPQ features with q 1.2 $10^5 e^{-1}$ Hz, better than that for subgap operation of S1. Moreover, linearity was vastly improved: the SNR remains linear and q nearly at to $q_0 = 0.038e \text{ mm}$ s indicating that we have achieved linear response in this sample For S2 (data not shown) the best q 1.2 $10^5 e^{-1}$ Hz also occurred subgap, and the SNR was linear to $q_0 = 0.032e \text{ mm}$ s.

W e can now make som e general statements about the e ects of quantum uctuations on RF-SET operation. For samples with smaller such as S1, transport is fairly well described by the sequential tunneling picture: I-V characteristics are sharp and vary strongly with Q_0 giving rise to excellent charge sensitivity. The same sharpness, however, prevents good linearity, since a large q_0

necessarily moves the SET far from optimal operation. For samples with larger such as S3, quantum uctuations cause at least two important e ects. First, the subgap features are smoothed and broadened, improving linearity: e.g., in S3 there is no \dead spot" between the D JQ P and JQ P features for which the SSET current is roughly independent of Q₀. Second, renorm alization of E_c moves the D JQ P feature to low er bias, so that the optimal rfam plitude of about (2 E_c)=e increases with . Finally, the smaller R_n simplies impedance matching between the RF-SET and the 50 coaxial line.

In conclusion, we have investigated the in uence of quantum charge uctuations on the charge sensitivity and SNR of RF-SETs. We nd that RF-SETs with

 $^{>}$ 1{2 (strong quantum uctuations) show both good linearity and good charge sensitivity. In contrast, RF-SETs with < 1 (weak quantum uctuations) show poor linearity and only modestly better charge sensitivity. These notings assume particular importance given interest in the RF-SET as a potentially quantum -lim ited linear ampli er. W e have achieved linear response only for subgap operation in samples with > 1 for which quantum uctuations of quasiparticles are substantial.
