M icrowave radiation induced magneto-oscillations in the longitudinal and transverse resistance of a two dim ensional electron gas

We con mm the existance of magneto-resistance oscillations in a microwave-irradiated twodim ensional electron gas, rst reported in a series of papers by Zhudov et al.[1] and M ani et al.[2]. In our experim ents, on a sam ple with a more moderate mobility, the microwave induced oscillations are observed not only in the longitudinal - but also in the transverse-resistance (Hall resistance). The phase of the oscillations is such that the decrease (increase) in the longitudinal resistance is accom panied by an increase (decrease) in the absolute value of the H all resistance. We believe that these new results provide valuable new information to better understand the origin of this interesting phenom enon.

A. Introduction

The new physics that results from subjecting a high m obility two-dim ensional electron gas (2DEG) to magnetic elds continues to provide new and fascinating phenom ena. Am ong them is the recently reported observation of oscillations in the longitudinal magneto-resistance (xx) of a 2DEG irradiated by microwaves with frequencies in the range 5 - 100 GHz [1]. These oscillations have been observed in samples with very high mobility, at moderately low temperatures T 1K, and at low magnetic elds ($\sim !_c$. $\sim !$). The periodicity of these oscillations is determined by the ratio of ~! =~! c, in contrast to the well established case of Shubnikow-de Haas (SdH) oscillations which they are determ ined by the ratio $E_F = {\sim !}_c$. Here, as usual: ${\sim !}_c = {\sim eB} = m$ is the electron cyclotron energy, with m the electron e ective mass and E_F denotes the Ferm i energy. Under strong m icrow ave irradiation and with samples that have a suciently high m obility, the minima in $_{\rm xx}$ become transformed into \zero resistance states " [2].

It has been proposed [3, 4, 5] that these m icrow ave induced resistance oscillations (M IROs) can be understood in terms of an additional, microwave-induced current which ows with or against the direction of the applied electric eld, depending on whether n $1=2 \cdot !=!_c < n$ or $n < != \sim !_c . n + 1 = 2$, with n = 1; 2; 3; ... integers. It has further been suggested that zero resistance states appear because of domain formation when the absolute conductivity becomes negative [6]. A Itematively, this e ect m ay re ect even m ore elaborate physics [2]. A characteristic of the theoretical treatments is that no microwave induced changes to $_{\rm xx}$ are expected for !=! $_{\rm c}$ exactly equal to 1,2,3,... [3, 4, 5]. Conventional cyclotron resonance absorption, which involves direct excitations and conservation of the motion of the centre of the electron

cyclotron orbit, does not result in any additional current (i.e. does not change the conductivity). The additional current appears as a result of indirect (o -diagonal) electron excitations and involves other factors, such as in purities or phonons [3, 4, 5]. Therefore M IROs are not necessarily triggered by a resonant absorption process, but m ore likely result from non-resonant m icrow ave-induced excitations of the 2D EG, with the modulation of xx being a consequence of periodically conditions for the additional current to ow preferentially with or against the applied electric eld.

Diagram matic calculations of the changes in the conductivity tensor induced by the microwave-excited disorder-scattered electrons reproduce the main experim ental trends, in particular the observed period and the phase [4]. Nevertheless, other experim ental features such as the exact shape of the oscillations as a function of magnetic eld [7] and the temperature dependence of the M IROs am plitudes are not as well understood. A nother puzzle is that while the theory [4] invokes an impuritydisorder mechanism to explain the MIROs, it is found experim entally that the oscillations become more clearly pronounced as the mobility is increased and the disorder is reduced.

In this paper we address another relevant issue, whether M IROs are a unique property of the longitudinal resistance (or alternatively $_{\rm xx}$) or whether they also appear in the transverse resistance xy. So far, M IROs have been reported exclusively in m easurem ents of xx or xx [8]. It is sometimes argued that the absence of microw ave induced features in xy implies that M IRO shave a classical origin rather than being a many-body e ect. Theoretically, it has been predicted that both xx and $_{\mathrm{xy}}$ should be in uenced by microwave irradiation and xy , at least unthat the resistance changes xx and der som e approximations, should be comparable in magnitude [4]. Results are presented here that show, for the rst time, that microwave induced changes, of a similar m agnitude, can be observed in m easurem ents of both xx

and xy. It is shown that the observed oscillations in xy

cannot be attributed to more trivial elects, such as an admixture of $_{\rm xy}$ and $_{\rm xx}$ but rather must be associated with microwave induced oscillations in both the longitudinal conductivity $_{\rm xx}$ and the transverse conductivity $_{\rm xy}$. Possible consequences of our experimental indings are discussed.

B. Experim ental

The m easurem ents have been perform ed at He 4 bath tem peratures (T = 1.4 4.2K), on a GaAs/AlGaAs heterojunction (grown at NRC) that had a 2DEG m obility of = 4.0 10^6 cm 2 =Vs and density of n = 1.9 10^{11} cm 2 after a brief illumination using a red LED. The sample was cleaved into a rectangular shape to form a 8x2 mm 2 Hallbar and contacted at the edges using small In dots. The length-to-width ratio between potential and Hall contacts was 1.3/2.

An Anritsu 69377B Signal Generator (operating at $0.01-50~\mathrm{GHz}$, with typical output power of a few mW) was used as the source of microwaves (MWs). They were delivered into the cryostat through a sem irrigid 0.085 inch coaxial cable which had a typical attenuation factor of 6-10dB near 50G Hz. The cable was term inated with a small antenna used to irradiate the sample which was mounted a few millim eters away. A small cylindrical cavity of MW absorbing material was constructed around the sample to suppress any cavity modes produced by m etallic components of the cryostat. The (perpendicular) magnetic elds produced by the superconducting m agnet were carefully calibrated using NMR and Halleffect probes and were checked by measuring the EPR signalofDPPH powderm ounted on a therm oresistor. Longitudinal and transverse resistances of the 2DEG were m easured using standard AC techniques, (at 15Hz and with measuring currents 1 A). The data presented is the di erence, , between resistivities measured for two identical eld sweeps with and without the application of MWs.

C. Results and discussion




FIG. 1: Experim ental traces of $$_{\rm xx}$$ induced by m icrowave radiation plotted against normalized inverse magnetic eld !=!c (! and !c is the radiation and cyclotron cyclic frequency correspondingly) for di erent powers (a), di erent frequencies (b), and for di erent temperatures (c).

Representative experim ental traces of the longitudinal m agnetoresistance under m icrow ave radiation are shown in Fig.1a fordi erent powers, Fig.1b fordi erent frequencies, and Fig.1c for di erent tem peratures. The data in Fig.1 is very sim ilar that previously reported for other M IROs [1, 2] (although the mobility of the sample used here was too low to achieve \zero resistance" states), and con m sagain that phenom ena is universal, independent of the source of the sample. Each xx trace is plotted against the dim ensionless parameter ! =! c, ie., the ratio of m icrow ave to cyclotron frequency, assuming the cyclotron m ass, m = 0.967m_e. In agreem ent with previ- $_{xx}$ is found to be an oscillatory ous observations [1, 2], function of the inverse magnetic eld, with the fundam en-

tal period (1=B) = (1=B)(!_c=!). It is apparent from Fig. 1 that the oscillations are damped by increasing temperature and by decreasing magnetic eld, microwave power or microwave frequency. The dependence of $_{\rm xx}$ on the magnetic eld can be roughly described as

$$_{xx} = A \exp(D_M = "!_c) \sin(2! = !_c)$$

with a phase corresponding to a positive coe cient A. The dam ping param eter D_M is relatively insensitive to m icrowave power or frequency. We not that D_M 0.3m eV at T = 1.64K and increases som ew hat at higher tem peratures. W hile Eq.(1) provides a good description of the higher order oscillations there are deviations around the fundam ental cyclotron resonance (n=1); the exact positions of the maxima and minima in com e sensitive to the experim ental param eters such as m icrow ave power and tem perature. This may be associated with the e ect of the cyclotron resonance which can produce signi cant changes in the dielectric function of the 2DEG. The most robust and well de ned feature of the M IROs are the positions of the zeros in occur when $!=!_c=1;2;3;:...$ This is in agreement with theoretical predictions [3, 4, 5].

The standard expression for the amplitude of the SdH

oscillations is [11]:

$$_{xx} = 4_{0}D_{th} (X_{T}) exp(=!_{cq})$$

where the thermal damping factor, D $_{\rm th}$, is given by X $_{\rm T}=\sinh$ (X $_{\rm T}$) with X $_{\rm T}$ = 2 $^2kT=\sim$! $_{\rm c}$ and where $_{\rm q}$ is the quantum lifetime.

If the SdH oscillations in $_{\rm xx}$ (see for example gure 2) are analysed using this expression the damping is dominated by D $_{\rm th}$ and no oscillations are visible in the low

eld region when the M IROs appear. However, measurements at lower temperatures (below 100m K) in another sample cut from the same wafer, show SdH oscillations to below .05 T which can be used to extract a value for $_{\rm q}$ of approximately 10ps. This corresponds to a damping coe cient $\sim=$ $_{\rm q}$ of 0.27 meV, essentially identical to the coe cient D $_{\rm M}$ obtained above for the M IROs.

At 0.1 tesla, $_{\rm q}$ = 10ps corresponds to a (G aussian) Landau level broadening parameter of order 0.04 meV compared with the cyclotron spacing of 0.17 meV [9]. Therefore, despite the fact that thermalblurring of the distribution function suppresses the observation of the SdH oscillations at higher temperatures a well-dened Landau level structure still exists in the density of states. Furthermore, the damping of the M IROs appears to be the same as the disorder broadening of the Landau levels. This explains why MIROs can only be observed in very high mobility 2DEG samples where a well dened Landau level structure persists in the very lowelds corresponding to !c=! . 1.

For conventional SdH oscillations convolution of the Ferm i function with the density of states produces a strong therm all degradation of the oscillations but this appears not to be the case for M IRO's. One explanation for this m ight be that the norm all role of the Ferm i function in producing a therm all sm earing is masked by a stronger perturbation of the distribution function induced by the microwave radiation. It is only at higher temperatures (above about $1.5{\rm K}$) that the Ferm i function can cause additional therm all sm earing and give rise to a temperature dependent D $_{\rm M}$.




FIG .2: M agnetic eld dependencies of (a) the tranverse m agnetoresistivity $_{\rm xy}$ and (b) the longitudinal m agnetoresistivity $_{\rm xx}$ and their deviations from dark values induced by m icrow ave radiation f= 49.8 G H z at T=1.7 K .

In the following section we show that M IROs are not only evident in the longitudinal resistance but can be also observed in the Hall (transverse) resistance $_{\rm xy}$. This can be seen in Fig. 2, which illustrates the result of simultaneous measurements of $_{\rm xx}$ and $_{\rm xy}$ (right scale) and the MW induced deviations $_{\rm xx}$ and $_{\rm xy}$ (left axis). Despite the noise in the $_{\rm xy}$ trace it is clear that microwaves a ect both resistances, and that the amplitudes of the two sets of oscillations are very similar. The noise is relatively large because the high mobility of the sample means $_{\rm xy}$ = $_{\rm xy}$ is of order 100 times smaller than $_{\rm xx}$ = $_{\rm xx}$ when MIROs are observed so the inevitable errors associated with taking differences between large numbers become much more important for

Note that xy, like xy, changes sign in reversed magnetic elds. This means the observation of MIROs in xy cannot be attributed to a trivial admixture of xx into the xy signal, due for example to misaligned contacts.

The absolute sign of $_{xy}$ depends on a sign convention but the fact that the sign of $_{xy}$ = $_{xy}$ is the opposite to the sign of $_{xx}$ is an unambiguous experimental observation that can be tested against theory.

Simple quantitative arguments can also to made to ∞ n m that $_{xx}$ and xy do not just re ect changes in $_{\mathrm{xx}}$ exclusively. If the standard expressions are used for inverting the conductivities (viz. xx = xx = (xx + xy)and xy = xy = (xx + xy)) then it is straightforward to $_{\rm xx}$ will produce changes show that a small change in in xx and xy related by xy = K = xx = xy. While this gives the correct (observed) phase relationship between the two terms K is typically 0.02 so under the actual experim ental conditions xx, in sharp conis predicted 20 times smaller than trast to the experim ental results which show the ratio is actually about 2. An equivalent calculation shows, likewise, that the observed oscillations in $_{\rm xx}$ and cannot result from changes in xy alone. We therefore conclude that both xx and xy are independently inuenced by microwaves. The results in Fig 2 showing xy oscillating in anti-phase correspond, for example, to an increase (decrease) in e ective electron concentration when the longitudinal conductivity, xx, increases (decreases). A theoretical determ ination of the $_{\rm xx}$ and phase relationship between xy has not yet been addressed directly [4].

D. Conclusions

In conclusion, we have con rmed the observation of microwave induced magneto-oscillations (MIROs) in the longitudinal resistance of a 2DEG with a periodicity dened by the ratio of microwave to cyclotron frequencies [1,2].

Our results indicate that a necessary condition for the observation of these oscillations is a pronounced modulation of the electronic density of states (Landau levels), in general agreement with predictions of existing theoretical models [3,4,5].

The tem perature dependent damping of MIROs is very dierent from the thermal damping of the Shubnikov-de Haas oscillations. It is not clear whether this is related to a temperature dependence of the Landau level broadening or some other mechanism. Experiments to address this issue are in progress.

If M IROs are due to the scattering by impurities of m icrow ave-excited electrons but at the same time require a pronounced modulation in the density of states, a subtle criteria would exist for optimum sample quality. It

would be interesting to check this if even higher mobility sam ples become available. However, phonon-assisted processes may also play a role [7] and e ects resulting from the interplay between one-particle and collective excitations in the 2DEG [10] should also not be neglected. More experiments, and in particular complementary microwave absorption measurements, are needed to achieve a better understanding of this fascinating phenomena.

The major new result reported here is that M IROs are not only present in the longitudinal resistance but can also be observed in the transverse component of the magneto-resistance. This is a non-trivial elect and requires that $_{\rm xx}$ and $_{\rm xy}$ both oscillate independently. The relative phase of the $_{\rm xx}$ and $_{\rm xy}$ oscillations experiment remains to be compared to theoretical predictions.
