A bstract

A theory which describes the share price evolution at nancialm arkets as a continuous-time random walk Scalas (2000); Mainardi (2000); Sabatelli (2002); Raberto (2002) has been generalized in order to take into account the dependence of waiting times ton price returns x. A joint probability density function (pdf) $_{X;T}(x;t)$ which uses the concept of a Levy stable distribution is worked out. The theory is tted to high-frequency US \$/Japanese Yen exchange rate and low-frequency 19th century Irish stock data. The theory has been tted both to price return and to waiting time data and the adherence to data, in terms of the 2 test statistic, has been in proved when compared to the old theory Sabatelli (2002).

1 Introduction

The idea to describe the stock market share prices as a random walk dates back to Bachelier (1900). He assumed that price returns x and waiting times t are independent, identically distributed (i.i.d.) random variables which in the long time limit, according to the Central Limit Theorem (CLT), conform to the normal distribution.

The properties of random walks are well understood [see for example Montroll (1965)] and since low-frequency market data conforms fairly well to a normal

distribution the concept of a Continuous Time Random Walk (CTRW) has been incorporated into standard economical textbooks. This approach enabled Black et al. (1973) to formulate a theory of pricing nancial derivatives for which they received the Nobel price in economics.

However there are serious problems with CTRW s. The observed probability density function (pdf) of price returns (x) shows considerable discrepancies from a Gaussian [Lux (1996); Gopikrishnan (1999); Plerou (1999)] In particular it exhibits power law tails for large values of x. M andelbrot (1963) and Fam a (1970) m anaged to generalize Bachelier's approach by introducing Levy distributions L; (x) with the normal distribution being only a particular representative of these.

Levy distributions, functions labeled by two real parameters—and—, are limit distributions for sums of independent random variables which emerge in the generalized CLT Bouchaud (1990). Taking = 0 and 0 < < 2 ensures that the functions are both positive, even (L; (x) = L; (x)), behave like a steep Gaussian for small values of x and decay according to a Pareto's power law much slower than a Gaussian for large x's. Despite technical problems, the second moment being in nite for < 2, these functions have been successfully used to model relaxation processes (die-electrical, mechanical and NMR) Montroll (1984) and in the theory of probability Levy (1937); G nedenko (1954).

Furtherm ore in most treatments so far it is assumed that price returns x are independent of waiting times t. This does not seem to be the case Raberto (2002) and it also seem s counterintuitive. One would expect larger price variations to correspond to larger waiting times since one would expect it to be more dicult, take more time, for a broker to not buyers and sellers that balance out supply and demand if the price variation is larger than if it was smaller. Such simplied reasoning implies that there should be a positive correlation between x's and t's which has not been taken into account in many works on this subject.

In this paper we will generalize the theory to take account of these two diculties. We will drop the assumption that x's and t's are independent random variables but still retain the property of independence of variables correspond—

ing to di erent times. By assuming that it is a certain function of x and t that conforms asymptotically to the Levy distribution rather than either price returns or waiting times them selves we will work out the joint pdf $_{\rm X,T}$ (x;t). Theoretical results will be compared to some high-frequency market data.

The paper is organized as follows. In section 2.1 we formulate our theory and work out analytical formulas for pdfs and cumulative pdfs under various assumptions about how price returns and waiting times are correlated. In section 2.2 we set up an equation for the probability p(x;t) of having price x at time that show that price evolution does not satisfy the Markovian property. We compare our evolution equation to that worked out under dierent assumptions Sabatelli (2002). Finally in sections 3.1, 3.2 and 3.3 we the cumulative pdfs of high-frequency exchange rate and low-frequency 19th century stock data to our theory, discuss the goodness of that assess whether the correlations between x's and t's which follow from our theory conform to market data.

- 2 A random walk with non-independent price returns and waiting times.
- 2.1 Pdfs and cum ulative pdfs.

In the following we will adhere to the convention that random variables are denoted by capital letters and values of random variables by lower-case letters. The objective is to work out the joint pdf of price returns and waiting times $x_{;T}$ (x;t) under the assumption that the random variables X and T are not independent. The rst idea which comes into a mind of a physicist is to assume a weak dependence and to develop a perturbative approach.

One could for example consider the correlation coe cient between X and T:

with E [f] being them ean off and m inim ize it as a functional of the joint pdf $_{\rm X\,;T}$ (x;t) subject to an assumption that the pdf belongs to a certain functional space, ie is a linear combination of certain basis functions. However, since it is rather unclear how to choose these functions we will develop a dierent approach.

We assume that it is not the price return x or the waiting time that conforms to a Levy distribution but that a certain function $f_t = f(x(t);t)$ has that

property. This means that there exists a random variable F_T , which depends on the random price returns X and waiting times T, the change of which in the time period $[T_1;T_N]$ takes, for large N, the following form:

where Levy (;) is a random variable conform ing to a Levy distribution with parameters and . Equation (2) is a statement of the Generalized CLT under the assumption that the increments $F_{T_{i+1}}$ F_{T_i} are i.i.d random variables. We also assume that instead of one stock there can be a set of stocks $X = fX_1; \ldots; X_p g$ the prices of which are correlated with each other and so F_T depends on all stock price returns X, ie $F_T = F(X;T)$, and F_T conforms to the Levy distribution (2).

In order to work out the distribution $x_{;T}$ ($x_{;t}$) of the returns and waiting times we consider a transform ation of variables in the p+ 1-dimensional space with Cartesian coordinates $x_1; ::: ; x_p; t$:

where $_{i}($) for i=1;:::;p are certain functions of the variables $_{i}$ which we set equal to one $_{i}=1$.




Fig. 1. Illustration of our assum ption concerning the random walk. Here the changes in lengths of consecutive hypotenuses (m arked with dashed lines) are i.i.d. random variables. Therefore, on the grounds of the generalized CLT, the length of the hypotenuse conforms, in large time limit, to a Levy distribution (compare (2)).

Now the problem is to make a proper choice of the function f = f(x;t). We will assume that f is a hypotenuse in a right triangle with edges of lengths is jained to (see Fig.1). Therefore $f = \frac{x_1^2 + \dots + x_p^2 + t^2}{x_1^2 + \dots + x_p^2 + t^2}$ and the most natural transform ation (3) that comes into mind here is a mapping into spherical polar

x and tare mutually exchanged, the cumulative density of returns S_X (x) is given by the same formula as (12) except that t is replaced by x. Let us also write down the large texpansion of the cumulative density.

where B (n;m) = (n) (m) = (n+m) is the beta function. The expansion (13) evaluated by making use of an asymptotic expansion of the Levy function and may be useful for numerical calculations of S_T (t) for large values of t.

It is interesting to compare these results with a dierent assumption for the function f. Assume that it is the sum of moduli of price returns and the waiting time that conforms to the Levy distribution $f = jx_1 j + \ldots + jx_p j + t$. Looking at Fig.1 one could say that it is the sum of neighboring horizontal and vertical sections $j_n j + jx_n j$ in one knee of the random staircase that conforms to the Levy distribution in large time lim it. The transformation of variables (3) is now given by:

The results are sum marized in Table 1.

Notice that it is not possible to derive a small we expansion of S_W (w) around w=0 even though a Taylor expansion of the Levy function $L_{0}(x)$ around x=0 exists for certain values of the parameter. Indeed S_W (w) cannot be expanded around w=0 because all its derivatives at w=0 do not exist.

Firstly, for the case $f = p \frac{p}{x^2 + t^2}$ we get from equation (9)

and see that the integral on the right-hand side of (20) diverges for t=0 since it contains an non-integrable 1=x singularity at x=0. The same happens for the case in the second row in Table 1.

2.2 The evolution equation

We now work out an evolution equation for $p(x;t) = P(X_t = x)$ is the probability that the stochastic process X_t which describes the time dependence of price returns has value x at time t. We know Montroll (1965); Balescu (1997)] that p(k;s), the Fourier transform of p(x;t) with respect to x and a Laplace transform with respect to time t, takes the form:

Here the variables in parenthesis (x;k) and (t;s) are mutually conjugate and F_x , L_t are Fourier-Laplace transforms (FLTs) with respect to x and t respectively.

The evolution equation is worked out by taking inverse FLTs of (21) (compare with equation (1) in Sabatelli (2002) and takes the form:

where the kernel (t) is related in Laplace space to the cumulative probability density \hat{S} (s) = L_t [S_T (t)] or to the probability density \hat{S} (s) by:

In general the process is non-M arkovian, ie the present value of p(x;t) depends on the whole history of both p and its time derivative $\frac{e}{e^{t^0}}$ p(x;t), unless the time dependence of the kernels reduces to a D irac delta function. To demonstrate the non-M arkovian behavior for our theory all we need to do is show that ^(s) \in 1 in (24) or equivalently that ^(s) \in 1=(1+s). Then:

The transition from (26) to (27) follows from a substitution $t = \sin$ and equality of terms (28) and (29) follows from the integral representation of the Levy function and from applying the Cauchy integral theorem.

Note that the representation of the joint pdf in Laplace-Fourier space $^{\sim}(k;s)$ can also be calculated explicitly:

Equality (31) = (32) follows from going to polar coordinates (x;t) ! (r sin ;r cos) and equality (32) = (33) follows from the same transform ation as that leading from (28) to (29). Finally the last equality (33) = (34) follows from substitution of variables =2 . Equations (25), (29) and (34) allow us to draw the conclusion that the kernel \sim (k;s) in Laplace-Fourier space does not factorize and therefore the evolution equation (23) includes a term on the right-hand-side (the double integral over x^0 and t^0) that is non-local both in time and in space. This turns out to be dierent from the evolution equation in Sabatelli (2002) where the respective term was non-local in space only.

Having obtained results (29) and (34) we can also look at the form of the evolution equation in the lim it of large price returns x and large waiting times t. It only amounts to noting the form of the joint pdf ~ (k;s) and the waiting time pdf ^ (s) for small values of k and s and inserting them into the evolution equation (21) in Laplace-Fourier space. Expanding the exponential in (29) in a power series and integrating term by term we get:

Here we merely note that the equation is dierent than that obtained in Scalas (2000) which is not a surprise since we dropped the assumption of independence of x's and t's.

3 Empirical analysis

We now analyze two sets of stock market data, the theory developed in section 2.1 to the data and nally discuss the goodness of the t.

The rst data set comprises prices for 10 stocks (5 railways and 5 banks) from the Irish stock exchange during the period 1850-54. Transactions during this period were carried on a daily basis so all waiting times are a day or longer. Over the 5 year period we have 1751 data points.

The second set contains 2220695 exchange rate quotes of US\$ to the Japanese Yen taken between 1989 to 1998 with waiting times ranging from a minute to some hours. The stock prices—uctuate with a much higher frequency than in the former case and the statistical error is much smaller due to a much larger size of the data sample. This allows a more reliable—t.

3.1 Cum ulative distributions of price returns and waiting times

The objective is to theoretical cumulative density functions $S_{\rm T}$ (t) (12,16) and $S_{\rm X}$ (x) (17) to market data

We consider both assumptions from Table 1 regarding the way returns and waiting times are correlated, assumptions which result in two dierent formulas for S_T (t). However it turns out that there is no great dierence between them. Our task consists in choosing three parameters v, w and in such a way that the chi-square test statistics $\frac{2}{T}$ and $\frac{2}{X}$ are as small as possible.

where the sums run over the measured waiting times ti and price returns x_i for i = 1; :::; n. For our data sets we chose n = 200. Param eter values can be estimated by thing a power law S_T (t) = $(a_1 t)^{b_1}$ for t 2 $(t_1;t_2)$ and $S_x(x) = (a_2x)^{b_2}$ for $x \ge (x_1; x_2)$ to the asymptotic behavior of distribution functions. The ranges $t_1 < t < t_2$ and $x_1 < x < x_2$ have to be chosen with caution. The variablest and x have to be large enough for the power law to be valid but cannot be too large because the nite size of the data le introduces a signi cant error to N $_{\rm T}$ (t) and N $_{\rm X}$ (x).

For the high frequency US\$/Yen data we have tted following power laws to the distribution functions:

with the relative error of the coe cients not larger than a couple of percent in both cases. It has to be emphasized that the t to S_X (x) is biased in the sense that the power law exponent has to have the same value as in S_T (t) for the theory to be valid. Indeed, the parameters to be tted are expressed by the m easured param eters $a_1; b_1$ of the asymptotic behavior in the following way (com pare to form ulas in Table 1):

Recall that B is the beta function de ned in terms of the gamma function as B(n;m) = (n)(m) = (n+m).




Fig. 3. Like in Fig. 2 but for waiting times. The test statistic equals $\frac{21}{100}$ $_{T}^{2} = 3.3223(2.4694)$ for 304 degrees of freedom.

From formulas (43), (44) and (45) we obtain values of parameters = 1:8662, v = 0.1649(0.1072), w = 0.0914(0.1044) for the US\$/Yen data for the cases $f = x^2 + t^2$ and f = x + t respectively. For the old Irish data we analyzed

the rst case $f = \sqrt[p]{x^2 + t^2}$ only and obtained the following results: = 0:42, v = 0.2223, w = 0.1354. The results are shown in Figs. 2,3,4,5. Firstly we notice that the assumption regarding the choice of function f (x;t) does not play a signi cant role. The relative di erence of the cumulative probability densities does not exceed 0:4 in the US\$/Yen case. The price returns distribution t is better than that of waiting times. The 2 test statistics 2_X = 0:497 (1:974) are sm aller than that for waiting times $\frac{2}{\pi} = 3.3223 (2.4694)$ for the same number of degrees of freedom 304 in both cases. This does not however discredit the m odel. The US\$/Yen waiting times data seem not to exhibit the typical features of probability distributions of nancial data, ie exponential and power law decay for small and large waiting times respectively. Indeed, an inspection of Fig. 3 reveals mysterious humps att' 100 and t' 350. This could imply that small waiting times are underestimated and large waiting times are overestimated. This could be due to a limited (two decimal digits only) accuracy of the data. Such data truncation will indeed introduce a bias toward larger waiting times. More accurate data is required to test this suggestion.

At this point we note in more details the diculties arising by computing S_T (t) from formulas (12) and (13).

Since a series expansion in taround t=0 does not exist (as proved in section 2.1) we computed the cumulative density $S_{\rm T}$ (t) numerically using a Gauss-Herm ite quadrature. The integrand in (12) behaves like a Gaussian for large values of z and the integration range is in nite therefore the Gauss-Herm ite quadrature is best suited for all integration procedures. However, since the integrand is cut of or z < vtwe use a large number of abscissas z_i and weights w_i in the quadrature

so that the contribution from the integrand for z>vt is considerable. In other words the number M $\,$ of abscissas has to be large enough so that the largest of abscissas $z_{m\;ax}=m\;ax_i\;z_i$ is much larger than vt, which, for our data, is of the order of v $\,$ 200 = 44.5. Furtherm ore since the weights w_i decrease quite strongly with increasing x_i 's we have to carry out calculations with high precision. We chose M = 3500 which yields $z_{m\;ax}=83.2$ and the corresponding weight $w_{m\;ax}$ $\,$ 7 $\,$ 10 3011 and conducted computation with a precision of 300 digits. This method is however only suited for calculating S_T (t) for intermediate times and computing the cumulative density for the largest waiting times 100 < t < 500 is marked with a considerable error.

The Gauss-Herm ite computation works quite well in the whole range of t values for the case of US\$/Yen exchange rates, Figs. 2,3. This is because the

asym ptotic expansion (13), which was derived from an asym ptotic expansion of the Levy function converges for all t> 0 for 0 < 1 and diverges for all t if 1 2 M ontroll (1984). For the old Irish stock data where = 0.42 < 1 the asym ptotic expansion (13) diverges. It is clearly di-cult to work out a num erical procedure for computing S_T (t) in the whole range of parameter 0 < 0.00 < 0.00

3.2 Goodness of the t

We know that the variables z_T and z_X conform to a $\frac{2}{n-1}$ distribution with n=1 degrees of freedom. Since for large n the variable $\frac{2}{n}$ can be approximated by the normal distribution N ormal(n;2n) with mean n and variance 2n, we see that for n = 200 the computed values z_T = 2:70527 z_X = 0:910386 are much smaller than the 2:5% -value of the distribution which is 200 + 1:96 $\frac{1}{400}$ = 239:2, which yields a satisfactory conformance to the theory.

Here a comment has to be made on the waiting time data (Fig. 3). Unlike the cumulative pdfs from previous papers, eg. the New York Stock Exchange prices investigated by Raberto (2002), that are well tted by an exponential for small values of t and by a power law for large t values the cumulative pdfs for the US\$/Yen data seem to exhibit a power law behavior in the whole range of t values and in addition show small humps or shoulders for t> 100. In this respect it is not a surprise that the function (12) does not t the data very well and however neither did the approach developed in Sabatelli (2002). At least using our approach the price returns cumulative pdfs are quite well tted with the same parameter as that used in the waiting time data.

3.3 Correlation between price returns and waiting times

We now analyze correlations between dierent functions of waiting times and price returns for the market data and try to justify the assumption made in section 2.1 regarding the choice of function f (x;t).

The main objective of this article was to show that price returns x and waiting timest cannot be regarded as independent variables and to not such functions of x and t, which, within the accuracy of data available can be regarded as independent.

Indeed a standard contingency test between x and t carried out in Table 2 shows that the null hypothesis, of the variables being independent can be rejected at a 1% con dence level.

This begs a question whether there is a mapping of x and t onto new variables that can be considered as independent. In section 2.1 we considered the mapping (3) and we assumed all functions $_{i}$ in (4) to be equal to one. This is equivalent to claim ing that the variables $f;_{1};:::;_{p}$ are independent while the original $x_{1};:::;_{x_{p}}$ are not. Let us now check this assumption numerically making use of the market data.

Consider the case p = 1 in (3)₄ ie a case of only one stock, and set up a contingency table between $r = \frac{(w \times)^2 + (vt)^2}{(w \times)^2 + (vt)^2}$ and $= \arctan(vt) = (w \times)$ in Tables 4 and 5.

The prices of stocks were given with an accuracy of two decimal digits, which allows computation of the error

From this information and from the range in which waiting times and log-price returns vary 1 t 2606 and 10 9 x 1:910 $_q$ 2 we calculate the accuracy r dr and d of random variables $r = (wx)^2 + (vt)^2$ and $= \arctan(vt) = (wx)$, the mutual independence of which we are going to investigate. Total dierentials of r and yield:

We calculate the dierentials dr and d for r; values from Table (4) and estimate the errors r and by the average value of the corresponding dierential. This yields a result r=0.165 and =0.002. If we compare this with the range of values in each box of the Table (4), we get r_{m+1} $r_m=0.206$ and r_{m+1} $r_m=0.206$ and r_{m+1} $r_m=0.206$ m easurem ents.

Since the Table (4) contains many zeros in the upper and lower right corners it would be reasonable to re ne the range of variability, introducing more rows in the center of the table where most data points are gathered and assemble a couple of top rows and a couple of bottom rows into single rows. This would however yield a re nement much below the measurement error unless the number of rows and thus the number of degrees of freedom was decreased resulting in a less certain estimate.

Indeed, a contingency test in Table (5) with the same number of rows and columns but with a rened range of the variable $= -2(1 + 8 \text{ (n} - 5)10^{-4})$ yields a much larger value of the test statistic z = 1507;7 than that from

Table (4) suggesting the null hypothesis should be rejected. However, since the values are marked with an error = 0.002, which is one order of magnitude larger than the increment $_{n+1}$ $_n$ = =2 8 10 such a test is not reliable.

The accuracy of measurements is not an issue for a contingency test between the log-returns x and the waiting times them selves.

4 Conclusions

We have developed a new generalization of the continuous time random walk that recognizes waiting times and associated jumps may not be independent. The theory has been applied to stock price data. Two data sets were used namely old 19th century Irish daily data and 20th century US\$/Japanese Yen currency data. Since our theory avails of analytical results it would be interesting to pursue further investigation of correlations between waiting times T and price jumps X. Note that averages of the kind E [X $^{n}T^{m}$] are readily expressed through derivatives of the joint pdf in Fourier-Laplace space $Q_{k}^{n}Q_{s}^{m}$ (k;s). In particular, we see from (37) that E [X]' 1, E [X ^{1}T]' 2 and E [X $^{2}T^{2}$]' 3. Once more accurate data was available these results can be used to validate the theory.




Fig. 4. The distribution of changes of logarithm s of old Irish stocks and the theoretical curve S_X^1 (x). The test statistic equals $\frac{2}{X}=4:666$ for 200 degrees of freedom . A large deviation at small x is due to the diculty of computing S_X^1 (x) for small x .




Fig. 5. Like in Fig. 4 but for waiting tipes. The test statistic equals 2_T = 1:7595 for 200 degrees of freedom .
