Spin Halle ect and Berry phase in two dim ensional electron gas

The spin Halle ect is investigated in a high mobility two dimensional electron system with the spin-orbital coupling of both the Rashba and the Dresselhaus types. A spin current perpendicular to the electric eld is generated by either the Rashba or the Dresselhaus coupling. The spin Hall conductance is independent of the stength of the coupling, but its sign is determined by the relative ratio of the two couplings. The direction of spin current is controllable by tuning the magnitude of the surface electric eld perpendicular to the two dimensional plane via adjusting the Rashba coupling. It is observed that the spin Hall conductance has a close relation to the Berry phase of conduction electrons.

Introduction. { Spintronics in semiconductor physics has become an emerging eld of condensed matter because of its potential application in information industry, and also because of many essential questions on fundamental physics of electron spin.[1, 2] It is tempting to use spin rather than charge of electron for inform ation precessing and storage. Recently a surprising e ect was predicted theoretically that an electric eld can generate a dissipationless quantum spin current perpendicular to the charge current at room temperatures in conventional hole-doped sem iconductors such as Si, Ge, and GaAs.[3] The e ect was found to be intrinsic in electron systems with substantial spin-orbit coupling, and the spin Hall conductance has a universal value. [4] Based on this effect it is possible to realize spin in jection in paramagnetic sem iconductors rather than from the spin polarized carriers in ferrom agnetic m etals, [5] which is thought as a key step to realize practical spintronic devices. The spin Halle ect due to magnetic impurities was discussed extensively.[6, 7, 8, 9] W hen a charge current circulates in a param agnetic m etal a transverse spin im balance w ill be generated, which gives rise to a spin Hall voltage or a spin current.

In two dimensional (2D) semiconductor heterostructures the spin-orbit interaction can be described in terms of two dominant contributions to the model Hamiltonian, which are directly related to symmetry of the low dimensional geometry. One type is Rashba coupling stemming from the structure inversion asymmetry of conning potential, [10]

where $_{\rm a}$ (= x;y;z) are the Pauli matrices and $k_{\rm x}$ and $k_{\rm y}$ are two components of the wave vector. The strength of the coupling can be modiled by a gate eld up to 50%,[11] such that it can be applied to control spin transport, such as in spin eld transistor.[12,13] A nother type is D resselhaus coupling from the bulk inversion asymmetry,[14]

In some materials such as GaAs the two types of spin-orbit coupling are usually of the same order of magnitudes. The interplay of them has been investigated theoretically with respect to several phenomena, such as the nonballistic spinelde ect transistor[15] and electronspin manipulation [16].

In this letter we investigate the spin Halle ect in a 2D electron system with spin-orbit coupling of both Rashba and D resselhaus types. Consider the Ham iltonian,

We not the Berry phase in the eigenstates to be 0 for jj=jj+ for jj>jj; and for jj< jj: When the system is subjected to an electric eld in the 2D plane the spin-orbit coupling leads to a dissipationless spin current perpendicular the electric eld, and polarized in the direction perpendicular to the 2D plane when $jj \in jj$: The spin Hall conductivity has a universal value except that its sign is determined by the relative ratio of two couplings or the sign of the Berry phase. As Rashba coupling is tunable by a gate eld perpendicular to the 2D plane it is possible to control the direction of spin current by adjusting the magnitude rather than direction of the gate eld when the system is near jj=jj:

: The spin states in Eq.(4) is independent of k and ': Furtherm one k! = 0 when $k_x = k_y$ or ' = =4: It is noted that there exists an additional conserved quantity, $k_x = k_y = \frac{1}{2}$. [15] The dierence of two k is given by

which is independent of k: The two energy bands are plotted in Fig. 1. In these states the Berry phase, [17] which is acquired by a state upon being transported around a loop in the k space, can be evaluated exactly,

if $j \neq j$, and is equal to zero if j = j; The disappearance of the Berry phase at j = j jm ay be relevant to the crossover of two energy bands. We notice that if we make a replacement, ! and ! the angle ! =2 : This property gives dierent Berry phases for $j \neq j$ j and $j \neq j$; A coording to the theory of Sundaram and N ii, [18] the Berry phase is closely related to the electron transport in semiconductors. It is found that the Berry phase and magnetic monopoles in momentum space generate anomalous Halle ect in some ferrom agnetic materials.[19]

Quantum dynamics in an electric eld.{ We shall consider the electron of uniform electric eld E. Our whole Hamiltonian is thus given by H = H_0 + eEx, assuming that the electric eld is along the x-direction. We start with the Heissenberg equation of motion, i $\sim\!\!\frac{d}{dt}0$ = [D;H]. The wave vector is determined by k_x (t) = k_{x0} $=\!\!\frac{eE}{-}t$ and k_y (t) = k_{y0} where k_{y0} and k_{y0} are the initial values at t = 0. The set of equations for spin operators are given by

When E = 0, the equations can be solved exactly

The characteristic frequency $!=\frac{2}{c}k ! ('): Until now$ we have no general solution for the problem in the presence of an electric eld. In this letter we are concerned with the linear response of the transport properties to the eld. For our purpose we only need an asymptotic solution for a weak eld E and a shot instant t. We expand the spin operators in terms of E: $_{a}(t) = {}^{0}(t) + {}^{1}(t) + {}^{2}(t) + {}^{2}$: For a short instant t, we have an asymptotic solution for the linear

We see that the e ective eld caused by the spin-orbit coupling has a non-zero correction to the spin operators even when t! 0:

Spin current and universal spin Hall conductance. { Of cause the electric eld will induce a charge current in an electron gas. The problem has already been studied extensively [20]. Spin-orbit coupling leads to a nonzero Hall resistance proportional to and ; $_{xy}$ / sign () j j: In this letter we focus on the spin Hall effect. We notice that the electrice eld causes a linear correction to spin operators in Eqs.(11) when t! 0: This correction will generate the spin Halle ect as discussed by M urakam iet al.[3] and Sinova et al.[4]. Spin current, polarized to perpendicular the 2D plane and owing perpendicular to the electric eld, [21] is de ned as

By using the relation in Eq.(7) we obtain the spin Hall conductance

as long as both bands are occupied. [22] We have ignored the time-dependent terms. It is an interesting observation that the spin Hall conductance is closely relevant to the Berry phase of electron states in the absence of the electric eld. It deserves for further investigation on the relation in general cases. Spin current caused by the Berry phase should not contribute to dissipation, although a charge current will do. which recovers Sinova et al.'s result[4] and followed by several authors m ore recently [23, 24]: If = 0; D resselhaus coupling can also produce a spin Hall conductance sH = e=8. Very interestingly two spin Hall conductances di er from only a sign. Competition of two couplings also cancel the e ect at = : It seem s that the e ect caused by D resselhaus coupling dominates if jj> jjwhile the e ect caused by Rashba coupling dom inates if j j > j j. Very recently Rashba[25] observed that even in the absence of an external electric eld there exist a tiny spin current $J_x^x = J_x^y \in 0$ in the open boundary condition. The type of spin current

along spin z-direction does not exist in the absence and presence of an electric eld. To explore the physical origin of the sign change of

spin Hall conductance near = we nd a new sym metry in the system with the two spin-orbital couplings. Perform ing an unitary transform ation,

The spin current along the z-direction changes a minus J_{v}^{z} as z! z:T hus this sym m etry indicates that the system with Rashba coupling and Dresselhaus coupling and the system with Rashba coupling and D resselhaus coupling , have the same spin Hall conductance (along spin z direction), but with opposite signs. At the sym metric point = , we conclude that $J_{v}^{z} = 0$, i.e., the spin Halle ect is suppressed completely. This general conclusion is based on symmetry analysis of $\frac{X}{2m}$ hk; $\frac{1}{2}$ (t) k_{y0} $\frac{1}{3}$; in_F (E (k₊) (13) the system and is mathematically rigorous. It is in agreement with the result of the linear response calculation in m ent with the result of the linear response calculation in Eq. (14).

> Now we come to address the e ects of a nite electron quasi-particle lifetime and scattering mechanism, which was discussed in a system with Rashba coupling by several authors. Schliem ann and Loss [23] discussed the correction of spin conductance due to the e ect of nite lifetime for = 0 using the K ubo formula in the zero frequency lim it and concluded that the universal value for spin conductance is valid only when the \Rashba energy" $_{R} = m^{2} = ^{2}$ should be comparable with the energy scale ~= : Fortunately in som e sem iconductors such as G aAs quantum wells $\sim=$ < $\mathbf{"}_{R}$ and it is safely to neglect these e ects. On the other hand, more recently Burkov and MacDonald found that the spin Hall conductance in a system with Rashba coupling remains the universal value e=8 in the case of strong disordering as in the case of weak disordering. [26] Thus the scattering e ect depends on the scattering mechanisms.

Controllable Rashba coupling and revertible spin current. { Rashba coupling and Dresselhaus coupling are

related to the symmetry of quantum wells. In GaAs quantum wells both terms are usually of the same order of magnitude while the narrow gap compounds like in InAs Rashba coupling dom inates.[27] However there is no di culty to achieve the situation of = . In the case of = the Elliot-Yafet spin ip mechanism is suppressed completely since the spin states in **永 ; ; =** =4i is independent of $^{\prime}$. The Berry phase of the states jk; ibecomes zero and correspondingly there is no spin Halle ect. Thus the electric eld cannot generate a dissipationless spin current. If jj> jj $_{\rm sH}$ = e=8 while $_{\rm sH}$ = e=8 if jj < jj: The spin current changes a sign (or direction). A sR ashba coupling is adjustable by a gate eld perpendicular to the electron qasplane[11]wemay change around ; = + E₂;by adjusting the perpendicular electric eld E2. Thus by using the property of sign change in the Berry phase we can realize to revert the spin current by adjusting the m agnitude rather than the direction of the gate eld.

Conclusion. { The spin Hall conductance caused by D resselhaus coupling has the same universal value, but an opposite sign to that caused by Rashba coupling. It is an interesting observation that the spin Hall conductance has a close relation to the Berry phase of single electron states. The spin current in this elect can be revertible when the amplitudes of two couplings are comparable by adjusting the gate voltage via Rashba coupling. It is anticipated that this elect will be applicable to the spintronic devices in the future.
