# XY checkerboard antiferrom agnet in external eld

A bstract. Ordering by therm al uctuations is studied for the classical X Y antiferrom agnet on a checkerboard lattice in zero and nite m agnetic elds by m eans of analytical and M onte C arlo m ethods. The m odel exhibits a variety of novel broken sym m etries including states with nem atic ordering in zero eld and with triatic order parameter at high elds.

#### 1. Introduction

A huge degeneracy of classical ground states in geom etrically frustrated m agnets can be lifted by quantum or therm all uctuations via a so called order by disorder e ect [1]. In the present work we study the therm all order by disorder e ect for the X Y antiferrom agnet on a checkerboard lattice. This lattice is a two-dimensional network of corner-sharing squares with crossings, which are topologically equivalent to tetrahedra, see F ig. 1. The present m odel can, therefore, be relevant to real pyrochlores with the easy-plane type anisotropy  $Er_2Ti_2O_7$  and  $Er_2Sn_2O_7$  [2] and also have an experimental realization as an array of the Josephson junctions or a superconducting wires network in transverse magnetic eld [3].

The considered model is described by the Ham iltonian

$$\hat{H} = J S_{i} S_{j} H S_{j}$$

where  $S_i = (\cos'_i; \sin'_i)$  are the classical planar spins and H = (H; 0) is in-plane magnetic eld. The sum is over nearest-neighbors pairs on a checkerboard lattice and J > 0 is an antiferrom agnetic coupling constant. The H am illonian can be expressed as a sum over elementary plaquettes (squares with crossings):

where  $S_p = {P \atop i2p} S_i$  is the total magnetisation of a plaquette, N is the number of sites on the lattice and  $N_p = \frac{1}{2}N$  is the number of plaquettes. M in in izing energy of a single plaquette one obtains the classical constraint

$$S_p = H = (2J)$$

The minimal total energy is reached if the above constraint is satised on every plaquette. In the eld range 0 H  $H_{sat} = 8J$  the ground state of the model remains underconstrained and in nitely degenerate with a nite entropy. This huge degeneracy is determined by two factors: (i) possible basis spin quartets, which obey the classical constraint, are parametrized by two continuous variables and (ii) by various periodic and aperiodic spin structures formed with the same basis quartet. The latter property can be seen by looking at the Fourier transform of the interactions on the checkerboard lattice [4], which has a at momentum -independent branch with minimal energy.

### 2. Therm alorder by disorder e ect

Since the degeneracy of the classical ground state is a consequence of lattice topology rather than being a symmetry in posed property, various classical ground state con gurations have di erent excitation spectra. At nite temperatures magnetic system spans a phase volume in the vicinity of the ground state manifold. Due to a varying density of excitations, the system can be electively trapped in the neighbourhood of certain ground states. Such an ergodicity breaking leads to a lifting of zero-T degeneracy of a frustrated magnet and to therm all order by disorder selection. The statistical weights of di erent ground state con gurations are given by w [] exp(F[]=T), where F[] is the partial free energy obtained by integrating out fast' excitation modes. The minimum of F[] ensures that a macroscopic system is trapped in the vicinity min and probability to nd it in another classical ground state is vanishingly sm all.

To nd which spin con gurations are favoured by them al uctuations we start with a simple perturbative treatment over the mean-eld result. In the ground state con guration a magnitude of a local eld derived from Eq. (2) is the same H  $_{\rm loc} = 2J$  for all sites and all external elds 0 H H  $_{\rm sat}$ . The harm onic spin-wave H am iltonian is expressed as

where components of every spin are taken in its local coordinate frame and  $_{ij}$  is an angle between neighbouring spins. The rst term in  $\hat{H_2}$ , which describes uncorrelated uctuations of individual spins with  $hS_i^{\gamma 2}i=T=H_{\rm loc}$ , is taken as an unperturbed spin-uctuation H am illonian, whereas the second term is a perturbation  $\hat{V}$ . The correction to the free-energy is given by  $F=-h\hat{V}^2i=2T$ :

Therm al uctuations produce, therefore, an elective biquadratic exchange, which lifts the zero-T degeneracy in favour of maximally collinear states with the largest number of  $\cos_{ij} = 1$ . The harm onic H am iltonian can be, of course, diagonalized with the help of the Fourier transform to obtain the spin wavemodes  $\binom{n}{k}$  and their contribution to the free-energy:

The problem is reduced to minimization of the sum in (6). Still the real-space second order perturbation result appears to give a correct rst insight especially for

multisublattice con gurations with n > 2, when exact diagonalization of  $\hat{H}_2$  becomes increasingly cumbersome.

An additional complication of highly fustrated magnets stem s from a presence of several branches of zero modes:  $\binom{m}{k}$  0, in which case Eq. (6) is not anymore correct. Instead the low-T contribution to the free energy becomes:

$$F = (N_2 = 2 + N_4 = 4)T \ln (J = T) + T \qquad \ln !_k^n = J + T f_4;$$

where N<sub>2</sub> is the number of usual harmonic or quadratic modes, N<sub>4</sub> is the number of zero or soft modes, and f<sub>4</sub> is a contribution from interaction between soft modes and their interaction with quadratic modes. In order to estimate the last term one has to solve a nonlinear problem, which is, generally, a very complicated task. However, a partial selection between various spin con guration can be done on a basis of the leading T ln (J=T) term. If the total number N<sub>2</sub> + N<sub>4</sub> is xed (= N for the X Y checkerboard antiferrom agnet), then, the free energy is minimal for states with the maximum number of soft modes. The number of soft modes can be found either from direct diagonalization of  $\hat{H}_2$  or from geometric consideration, which assigns a local soft mode to every void (empty square) with all spins around it being parallelor antiparallel to each other [5, 6, 7]. Thus, the soft modes act sim ilar to harmonic excitations and stabilize collinear states. The presence of soft modes is most easily seen in the low – tem perature speci c heat from a universal value of C =  $\frac{1}{2}$  N<sub>4</sub>=4N. The deviation of the speci c heat from a universal value of C =  $\frac{1}{2}$  tells how many soft modes exist in a low-tem perature state of the X Y checkerboard antiferrom agnet.

## 3. Zero eld behaviour

At zero magnetic eld the ground state constraint (3) speci es con gurations with  $S_{p} = 0$  on every plaquette. Such con gurations can be constructed either from noncollinear or collinear spin quartets. A swas argued above, therm al uctuations tend to select m axim ally collinear states with two up-and two dow n-spins on an arbitrarily chosen axis in the X Y plane. The gauge transform ation  $S_i^{ydown} = S_i^{ydown} m aps \hat{H}_2$ for an arbitrary collinear state on the same reference harm onic Hamiltonian. Every collinear state has, therefore, the same harm onic spectrum and the same number of zero (soft) modes N<sub>4</sub> =  $\frac{1}{2}$ N. Hence, the speci c heat of a collinear state is C =  $\frac{3}{8}$ . All terms in the low-T expression for the free energy (7) except the last one coincide for all collinear states. Our estim ate indicates that the Neel state with the ordering wavevector Q = (;) on the original square lattice has the low est anham on ic contribution  $f_4$  among all translationally symmetric states. This, however, does not necessarily mean an appearance of a quasilong-range order at q = Q when T ! 0. So called weathervane defects [5] or wondering (rough) dom ain walls [8] have been considered as a source of disorder for the kagom e antiferrom agnet. For the XY checkerboard antiferrom agnet there are no zero-width dom ain walls and only weathervane defects can destroy a quasi long-range translational order. They cost zero classical energy and increase the free-energy by F d "dT.A nite T-independent density of such defects can be estimated as  $n_d$  '  $(1 + e^{n_d})^{-1}$  by neglecting interaction between defects. These defects can destroy the true long-range order if their concentration exceeds the percolation threshold on the corresponding lattice. In this case only nem atic correlations described by a traceless second-rank tensor  $O_{\text{nem}} = hS_i S_i i \frac{1}{2}$ willbe present at low tem peratures.




Figure 1. Top left panel: the checkerboard lattice. Two right panels: tem perature dependence of squares of nem atic (top) and N eel (bottom) order parameters for three lattice sizes. Left bottom panel: nite-size scaling for the nem atic order parameter. Tem peratures are given in units of J.


In the absence of analytical theory to deal with this sort of behaviour we have tried to derive the necessary information from M onte Carlo simulations. We have calculated squares of the two relevant low -T order parameters:

$$S(Q) = \frac{1}{N^{2}} \sum_{i \neq j}^{X} hS_{i}S_{j} ie^{iQ(r_{i} - r_{j})}; O_{nem}^{2} = \frac{1}{N^{2}} \sum_{i \neq j}^{X} hS_{i}S_{j}S_{j}i - \frac{1}{2}: (8)$$

The results are presented in Fig.1. There is a clear signature of the nem atic order seen by the enhancem ent of  $O_{nem}^2$  (N) at low tem peratures. The Neel order parameter reaches only very small values and does not show any appreciable enhancement. Considering a change in the scaling behaviour of the nem atic order parameter  $O_{nem}^2$  (N) 1=N from = 1, short-range correlations, at high tem peratures to < 1, power-law correlations, at low tem peratures we estimate the K osterlits-Touless transition tem perature as  $T_{KT} = 0.014$  (2)J.

#### 4. Finite eld phases

In external magnetic eds  $0 < H < H_{sat}$  the ground states with intermediate magnetisation (3) are, generally, noncollinear, except for  $H = \frac{1}{2}H_{sat}$ , when a collinear usual state, Fig.2b, belongs to the ground state manifold. Selection of the usual states by therm al uctuations leads to a 1/2-m agnetization plateau, which is similar to a 1/3-plateau of a classical kagom e antiferrom agnet [7]. At all other eds only a partial collinearity is possible in the classical ground state. G eom etric consideration suggests two prime candidate states shown in Fig. 2. The rst canted state, Fig. 2a, exists

in the whole range of elds and does not break remaining spin relection symmetry about the eld direction. The second partially collinear state, Fig. 2c, with three identical sublattices appears only for  $H > \frac{1}{2}H_{sat}$  and does break the mirror symmetry. It is easy to check that the uctuation induced biquadratic exchange (5) favours a more' collinear state with broken relection symmetry  $F = (T=8)[3 + \frac{1}{3}(8h^2 5)^2]$ ,  $h = H = H_{sat}$  over a less' collinear canted state  $F = (T=8)[2 + 4(2h^2 1)^2]$  in the whole range of existence of the form er state.

The translational degeneracy of the high- eld partially collinear states is similar to the degeneracy of the usual states and corresponds to the dimer coverings of a square lattice [9], the total number of such states being  $1:157^{\rm N}$ . The problem of lifting translational degeneracy for the usual states is similar to the zero- eld case discussed above. Also, the usual have the same speci c heat  $C = \frac{3}{8}$ . For the partially collinear states there are additional features in the therm allorder by disorder e ect. A general partially collinear state does not have soft modes. Soft modes, corresponding to all parallel spins around an empty square, exist, nevertheless, for certain translational patterns. Them axim um num ber of soft modes N<sub>4</sub> = N =4 appears for a state shown in Fig.2d, which corresponds to a colum nar arrangem ent of ective dimers. Such a translational pattern has the low est T ln (J=T) contribution to the free energy. However, for all temperatures T 0:001J accessible with our M onte C arbox code we did not nd a nonvanishing value of the structure factor corresponding to the

this state. Thus, there is no a conventional Ising order parameter  $hS_i^y i = 0, 8i$  in the high-eld partially collinear state. Instead an Ising relation symmetry is broken by a unique triatic order parameter:

For M onte C arlo simulations of the X Y chekcer-board antiferrom agnet we have used the standard M etropolis algorithm discarding 10<sup>5</sup> M onte C arlo steps per spin M CS) to reach therm alonguilibrium and, then, average observables over  $10^6 \{10^7 M CS$ . The lattice sizes were up to N = 1024. In order to estimate statistical errors, all results have been averaged over 10{20 runs. The eld dependence of the specic heat C is shown in Fig. 2 for T = 0.002J. C starts at value, which is very close to analytically predicted  $\frac{3}{8}$ . In applied eld the system looses gradually soft modes up to H = 0.5H sat, where used state with C =  $\frac{3}{2}$  appears. The peaks in the speci c heat at H<sub>c1</sub> = 4.15J and H<sub>c2</sub> = 6.8J indicate the phase transitions to a high-eld state with broken re ection symmetry. The order parameters for this state are presented in the bottom right panel of Fig. 2. The square of the triatic order parameter  $T_{yyy}$ is nonzero between H  $_{c1}$  and H  $_{c2}$  . It shows a good statistical averaging and very little nite size dependence: results for sm aller clusters fall on top of the presented data for N = 1024. The inset shows  $S^{yy}(q)$  with q = (;) on a new lattice built from one sort of tetrahedra, which should be nonzero if the long-range order corresponding to Fig. 2d is present. The obtained data show that  $S^{yy}(q) = 0$  in the therm odynam ic  $\lim$  it. Thus, the high-eld state is described by the triatic order parameter T<sub>yyy</sub>, which m akes the checkerboard lattice to be sim ilar to a classical kagom e antiferrom agnet [7]. O ur results suggest that the triatic state survives up to T 0:015J.

In conclusion, we have investigated the low temperature phases of the X Y checkerboard antiferrom agnet in strong external elds. We have found that therm al uctuations stabilize interesting phases with new type of broken sym m etries: nem atic order at H = 0 and triatic order (9) in the eld range  $\frac{1}{2}H_{sat} < H < H_{sat}$ . Further theoretical investigations should focus on a unique H {T diagram of this model.
