Stable Equilibrium Based on Levy Statistics: Stochastic Collision M odels Approach

W e investigate equilibrium properties of two very di erent stochastic collision models: (i) the Rayleigh particle and (ii) the driven Maxwell gas. For both models the equilibrium velocity distribution is a Levy distribution, the Maxwell distribution being a special case. We show how these models are related to fractional kinetic equations. Our work demonstrates that a stable power-law equilibrium, which is independent of details of the underlying models, is a natural generalization of Maxwell's velocity distribution.

There is a strong analogy between the Gaussian central lim it theorem (GCLT) and the relaxation to thermalequilibrium of the Boltzmann equation ([1] and Ref. therein). However the GCLT is non-unique, which may imply that standard therm al equilibrium is non-unique. The Levy central lim it theorem (LCLT) considers the case of sum m ation of independent identically distributed random variables with an in nite variance [2]. Hence following Montroll and Shlesinger it is natural to ask if generalized equilibrium concepts based on LCLT are meaningful β]. Here we start answering this question using two very di erent types of collision models which still reveal the sam e type of equilibrium . W e note that Levy statistics has many physical applications [4], how ever its possible relation to generalized form s of equilibrium statisticalmechanics is an open eld of research. Recently, Bobylev and Cercignani [1], investigated a nonlinear Boltzm ann equation with an in nite velocity variance show ing that the solution exists, and obtaining certain bounds on it. In [1] the possibility of a relation between solutions of the Boltzm ann equation [5] and LCLT was brie y pointed out.

O ur goal in this Letter is to show that a new equilibrium concept naturally en erges from old stochastic collision m odels. O ur m odels dem onstrate that: (i) Levy velocity distributions serve as the natural generalization of the M axwell velocity distribution, (ii) generalized power law equilibrium can be derived from kinetic m odels, there is no need to postulate a speci c form of power law equilibrium, and (iii) the Levy equilibrium obtained here possesses a certain dom ain of attraction, is unique, and does not depend on certain details of the underlying models.

M odell W e consider a one dimensional tracerparticle with the mass M coupled with gas particles of mass m. The tracer particle velocity is $V_{\rm M}$. At random times the tracer particle collides with gas particles whose velocity is denoted with $v_{\rm m}$. Collisions are elastic hence from conservation of momentum and energy $V_{\rm M}^+$ = $_1V_{\rm M}$ + $_2v_{\rm m}$, where $_1$ = $\frac{1}{1+}$, $_2$ = $\frac{2}{1+}$, m=M is the mass ratio and $V_{\rm M}^+$ ($V_{\rm M}$) is the velocity of the tracer particle after (before) a collision event. The duration of the collision events is much shorter than any other time scale in the problem. The collisions occur at a uniform rate R. The probability density function (PDF) of the gas particle velocity is f ($v_{\rm m}$). This PDF does not change during the collision process, indicating that re-collisions of the gas particles and the tracer particle are neglected.

M any works considered this type of model, in posing the condition that the gas particles are distributed according to M axwell's law, i.e f $(v_{\rm m}$) is M axwellian. Since we are now investigating possible generalizations of M axwell's law we change this strategy and assume that f $(v_{\rm m}$) is non-M axwellian. The goal is to see when and how the tracer particle reaches a universal equilibrium, which does not depend on the detailed shape of f $(v_{\rm m}$).

W e now consider the equation of motion for the tracer particle velocity PDF W (V_M ;t) with initial conditions concentrated on V_M (0). Standard kinetic considerations yield the linear Boltzm ann equation

where the delta function gives the constrain on energy and m om entum conservation in collision events. U s-usual the rst (second) term in Eq. (1) describes a tracer particle leaving (entering) the velocity point V_M at time t. Eq. (1) contains convolution integrals in velocity space hence we consider now its Fourier transform (FT). Let

W (k;t) be the FT of the velocity PDF W (V_M ;t). Using Eq. (1), the equation of motion for W (k;t) is a nite di erence non-local equation

where f $(\!k\!)$ is the FT of f $(\!v_m\!)$. The solution of the equation of motion Eq. (2) is obtained by iterations

This solution has a simple interpretation. The probability that the tracer particle has collided n times with the gas particles is given according to the Poisson law $P_n(t) = \frac{(Rt)^n}{n!} \exp((Rt))$. Let $W_n(V_M)$ be the PDF of the tracer particle conditioned that the particle experiences n collision events. It can be shown that the FT of $W_n(V_M)$ is $W_n(k) = e^{ikV_M(0) \frac{n}{2}} \frac{n}{i=1} f k \frac{n}{2} : Thus Eq. (3) is a sum over the probability of having n collision events in time interval (0;t) times the FT of the velocity PDF after exactly n collision event.$

In the long time lim it $W_{eq}(k)$ lim_{t! 1} W(k;t) an equilibrium is obtained from Eq. (3). We notice that when Rt! 1, P_n(t) = (Rt)ⁿ exp(Rt)=n! is peaked in the vicinity of hni = Rthence it is easy to see that

In what follows we investigate properties of this equilibrium. We note that similar equilibrium can be obtained also if the collision process is not described by the Poisson law, any P_n (t) which is peaked on $n \ ! \ 1$ when t ! 1, with (nearly) zero support for nite values of n, will exhibit this behavior.

We will consider the Rayleigh weak collision lim it ! 0. This lim it is important since number of collisions needed for the tracer particle to reach an equilibrium is very large. Hence in this case we may expect the emergence of a general equilibrium concept which is not sensitive to the precise details of the velocity PDF f (v_m) of the gas particles. In this lim it we may also expect that in a statistical sense v_m V_M , hence the assumption of a uniform collision rate is reasonable in this lim it.

W e assume that statistical properties of gas particles velocities can be characterized with an energy scale T. Since T, m and v_{m} are the only variables describing the gas particle we have

We also assume that $f(v_m)$ is an even function, as expected from symmetry. The dimensionless function q(x) = 0 satisfies a normalization condition $\frac{1}{1}q(x)dx = 1$, otherwise it is rather general. The scaling assumption made in Eq. (5) is very natural, since the total energy of gas particles is nearly conserved. We rst consider the case where m on ents off (v_m) are nite. The second m on ent of the gas particle velocity is $hv_m^2 \stackrel{i}{\underset{R_1}{i}} = \frac{T}{m} \stackrel{1}{\underset{R}{i}} x^2 q(x) dx$. W ithout loss of generality we set $_1 x^2 q(x) dx = 1$. The scaling behavior Eq. (5) yields $hv_m^{2n} \stackrel{i}{\underset{R}{i}} = \frac{T}{m} \stackrel{n}{\underset{R_2}{in}} q_{2n}$, where the m on ents of q(x) are de ned according to $q_{2n} = \frac{R_1}{\underset{R}{i}} x^{2n} q(x) dx$. Thus the small k expansion of the gas particle characteristic function is

f (k) = 1

Inserting Eq. (6) in Eq. (4) we obtain

where $q_n() = (2)^n = [(1 +)^n (1 ^n)]$. The interesting thing to notice is that in the lim it ! 0, the second term on the right hand side of Eq. (7) is zero, thus q_4 is an irrelevant parameter in the problem. In sim ilar way one can show that all terms in the expansion containing q_{2n} with n > 1 vanish in the Rayleigh lim it ! 0. Thus using Eq. (7)

From Eq. (8) it is easy to see that the M axwell velocity PDF for the tracer particle M is obtained. Thus as expected M axwell's equilibrium is stable in the sense that for a large class of gas particle velocity PDFs M axwell equilibrium is obtained.

Now we assume that f (v_m) has a power law behavior, i.e., $q(x) / jxj^{(1+)}$ when jxj! 1 and 0 < < 2. For this case the gas particle characteristic function is



where $< 2 \cdot q$ and q are dimensionless numbers which depend of course on q(x). W ithout loss of generality we may set q = 1. In Eq. (9) we have used the assumption that $f(v_m)$ is even.

Inserting Eq. (9) in Eq. (4) we obtain a smallk expansion $\ln W_{eq}(k)$. Taking the limit ! 0 one can show that the term s containing q are much smaller than the leading term $\ln W_{eq}(k) / jkj$. Thus q, and in a similar way higher order coe cients, become the irrelevant parameters of the problem. Thus we nd that the tracer particle equilibrium characteristic function is

In Eq. (11) the Riesz fractional derivative was used [4], and the dissipation term is $= 2 \text{ R} \cdot \text{A}$ generalized E instein relation

yields the relation between the transport coe cients D and . W hen = 2 the Einstein relation is recovered. Note that [6, 7, 8, 9] investigated related fractional processes based on a stochastic approach (e.g. Langevin Eqs. with Levy noise). In those investigations dissipation and uctuations were treated as though they are independent, hence the equilibrium obtained there di ers from ours.

M odel 2 The question remaining is wether Levy equilibrium a general feature, which might be obtained from other collision m odels. Speci cally, it is interesting to see if Levy equilibrium is compatible with a non { linear B oltzm ann equation approach. Since one may suspect that the Levy behavior obtained so far is limited to linear B oltzm ann m odels. For this aim we investigated the one dim ensional driven inelastic M axwellm odel (D IM M). This m odel was investigated extensively in recent years in the context of inelastic gases assuming nite variance boundary conditions (see details below) [10, 11]. O ur goal is to investigate D IM M in the quasi elastic limit showing that Levy statistics describes the equilibrium, the M axwell-G auss distribution is recovered in the proper limit.

First consider the inelastic M axwell m odel in the absence of external driving forces $W_{-}(V;t) = I(V;W)$, where the non-linear collision integral is

In Eq. (13) p = (r + 1)=2 and q = 1 p where r is the restitution coe cient 0 < r 1. The kinetic scheme e describes a situation where m on entum is conserved during collision events, while energy is conserved only when r = 1. If r < 1 the steady state solution of Eq. (13) is $W_{ss}(V) = (V)$, re ecting the loss of energy during collision events. Note that for elastic collisions r = 1, any initial velocity distribution is a steady state solution. This is expected (and not inform ative) since two identical 1D elastic particles, exchange their velocities in collision events.

Let W (k;t) be the FT of W (V;t). The boundary conditions we will consider are




FIG.1: We show the FT of the equilibrium velocity distribution of the tracer particle. Numerically exact solutions of the problem are obtained using three long tailed gas particle velocity PDFs de ned in text: case 1 squares, case 2 triangles, and case 3 diam onds. The tracer particle equilibrium is well approximated by the Levy distribution the solid curve; W $_{eq}(k) = 2211 j \frac{k}{1+6} j^{3-2}$. For the numerical results we used T = 4.555, = 1e 5 and M = 1.

thus a Levy velocity distribution for the tracer particle is obtained. For \notin 2 the equilibrium Eq. (10) depends on , while for the M axwell's case = 2, the equilibrium is independent of the coupling constant . Eq. (10) im – plies that variance of the velocity diverges when < 2. For the non-M axwellian case the velocity distribution is characterized by the scale (T=M)⁼² which determ ines the width of the velocity distribution.

The asymptotic behavior Eq. (10) is now demonstrated using numerical examples. We consider three types of gas particle velocity PDFs, for large values of jv_m j! 1 these PDFs exhibit f (v_m) /_p jv_m j⁵⁼², namely = 3=2. Case 1 f (v_m) = N₁=(1+3^{2=3¹} m=(4T) jv_m j⁵⁼², Case 2, f (v_m) = N₂=[1 + m v_m² = (0.439T)]⁵⁼⁴, where N₁ and N₂ are normalization constants. Case 3, the gas particle velocity PDF_h is a Levy PDF with index 3=2 whose FT is f (k) = exp $\frac{T}{m}$ $\frac{3^{s4}}{(5=2)}$.

A coording to our theory these power law velocity PDFs, yield a Levy equilibrium for the tracer particle when the mass ratio becomes small, Eq. (10). In Fig. 1 we show numerically exact solution of the problem for cases (1-3). These solutions, obtained using Eq. (4) for nite values of , show a good agreem ent between numerical results and the asymptotic theory. The Levy equilibrium for the tracer particle is not sensitive to precise shape of the velocity distribution of the gas particle, and hence like the M axwell distribution is stable.

W e now consider a Fokker{P lanck equation which de-

for small k. Since W (V;t) is a non-negative PDF we have 0 < 2. Using the Boltzm ann equation (13) it is easy to show that in the elastic lim it r = 1, $\frac{(hy) j}{(t)} = 0$. For the standard case = 2 considered in [11], Eq. (14) simply rejects energy conservation, i.e. $hV^2 i$ is a constant of motion. For < 2, hy j i describes the width of the probability packet, which for elastic collision is a conserved quantity.

As mentioned, when r < 1 the inelastic collisions will shrink any initial probability packet to be concentrated on V = 0. Sim ilar to previous work [11] an in nitesim al heating term is added to the equation of motion, which compensates the energy loss. W e will consider the boundary conditions described in Eq. (14), while [11] considered the Gaussian case = 2. To obtain behavior compatible with Eq. (14) we consider the fractional D IM M

It is more convenient to consider this fractional equation in Fourier space, this yields the non-linear and non-local equation

For our aim this equation gives the denition of the fractional derivative in Eq. (15). Our aim is to investigate the steady state solution of this equation in the quasi elastic limit when D ! 0 and r ! 1. This limit is taken in such a way that the boundary condition Eq. (14) is satis ed.

Using the condition $\frac{(h) \text{ i j i}}{\theta \text{ t}} = 0$, and Eqs. (14, 16) we obtain

W ithout loss of generality we may set now hjV j i = 1. For = 1 we have D = 0, while for 0 < 1 D obtains negative values. The case = 1 m arks the transition between a nite ($\gtrsim 1$) and in nite (< 1) rst order m om ent of velocity $_{1}$ jV jW (V;t)dV. For < 1 no steady state is obtained, since the dissipation due to collisions is not strong enough to com pensate the heating. 0 ur results in what follows are restricted to 1 < 2.

Steady state solution of Eq. (16) satisfy

An iteration method is used to obtain the solution, let (k) $\ln W_{ss}$ (k), and using Eq. (18) we have

The boundary condition Eq. (14) yields (k)

jkj=(1+). The solution of Eq. (19) is obtained using the iteration rule

where $\lim_{n! 1} k = k$ and the 'initial condition' is $_0(k) = \ln [l + D kj]$. Using these rules and some algebra involving series expansions, we nd

where the condition 1 < 2 was used. Inserting Eq. (17) in Eq. (21) we obtain

The interesting thing to notice, is that the second term on the right hand side of Eq. (22) vanishes when the elastic lim it r ! 1 is considered. Inserting Eq. (17) in Eq. (21) one can show that in the elastic lim it $\lim_{r \le 1} k$ =

 $j_{k}j = (1 +)$. Hence the steady state characteristic function is a stretched exponential

the inverse FT of this equation yields the sym m etric stable Levy density [2]. It is rewarding to nd that M axwell and Levy equilibrium are obtained only in the elastic lim it, thus conservation of energy in the collision events is related to the Levy {M axwell behavior. Far from this lim it results not directly related to the G auss{Levy central lim it theorem are obtained, Eq. (21).

To conclude, we demonstrated the relation between equilibrium properties of very di erent types of collision models and Levy statistics. Thus stable behavior transcends details of individual models and hence I suspect can be found in other types of collision models. To support the idea that Levy velocity distribution might be found in other models, we note the interesting work of M in et al [12] who used numerical simulations of a longrange interacting vortex model, and showed that distribution of velocity elds are Levy stable.
