## Numerical Evidence for Stretched Exponential Relaxations in the Kardar-Parisi-Zhang Equation

## Abstract

W e present results from extensive num erical integration of the KPZ equation in 1+1 dimensions aim ed to check the long-time behavior of the dynam ical structure factor of that system. O ver a num ber of decades in the size of the structure factor we con rm scaling and stretched exponential decay. W e also give an analytic expression that yields a very good approximation to the num erical data. O ur result clearly favors stretched exponential decay over recent results claim ing to yield the exact time dependent structure factor of the 1+1 dimensional KPZ system. W e suggest a possible solution to that contradiction.

M any interesting dynam ical phenom ena in condensed m atter physics are described in term s of non-linear eld equations driven by noise. A long list of examples includes turbulence, critical dynam ics, the dynam ics of interacting polymers, ballistic deposition (as well as other grow th m odels) etc. The K ardar-Parisi-Zhang (K P Z) equation that describes a growing surface under ballistic deposition [1, 2] is such a m odel. This equation formulated in term s of a height function h (r;t) driven by external noise is given by

$$\frac{\partial h(x;t)}{\partial t} = r^{2}h + \frac{1}{2}(rh)^{2} + (x;t); \qquad (1)$$

where is a di usion constant, is the coupling constant (that controls the sticking rate of the deposited m aterial), and (r;t) is a noise term driving the equation that m odels the random ness of the falling m aterial. The noise is usually chosen to be G aussian, with zero m ean and second m om ent

where d is the substrate dimension and D  $_0$  speci es the noise amplitude.

The KPZ equation has been suggested 17 years ago [1] as an extension of the linear Edawards-W ilkinson equation [3], so that a bt of research has been done on the statistical properties of the surfaces that this equation grows. An extensive review of this work can be found in refs. [4, 5, 6, 7]. It is well known that KPZ surfaces are self-a ne, and are well described by two scaling exponents, namely the roughness exponent and the dynamic exponent z. It turns out that in the KPZ system these two exponents are not independent. D ue to symmetry of eq. (1) with respect to in nitesimal tilting [4] the fam ous scaling relation + z = 2 is established. Furtherm ore, for the special case when d = 1, the existence of a uctuation-dissipation theorem gives the exact result = 1/2 and z = 3/2.

In recent years there has been a growing interest in the dynamical properties of the KPZ system. A question of great interest regards the long-time behavior of the dynamical structure factor  $_{q}(t) = hh_{q}(0) h_{q}(t) i_{s}$ , where  $h_{q}(t)$  is the Fourier transform of the height function h (r;t), and h  $_{s}$  denotes steady-state averaging over the noise. Notice that by denition  $_{q}(0) = _{q}$ , where  $_{q}$  is the static two-point function.

U sing a self-consistent approach, Schwartz and Edwards were able to predict a stretched exponential decay for  $_{q}$  (t) [8, 9]. Regarding the KPZ system, they found the following

where c and  $are dimensionless constants (not necessarily 1), d is the dimension, and z is the dynamic exponent. The same asymptotic behavior was also predicted analytically by Colaiori and M core [10] using a mode-coupling approach. Later, Colaiori and M core solved numerically the mode-coupling equations in one dimension [11] and con med the asymptotic analysis for the long-time behavior. Surprisingly, they also found that <math>_q$  (t) decays to zero in an oscillatory manner – a fact that was not revealed by the analytical tools.

It should be stressed however that the above describe only approximations to a solution of the KPZ equation. Even an exact solution of either the Self-Consistent Expansion (SCE) equation or the mode-coupling equation would provide only an approximation for the real, time-dependant structure factor,  $_{\rm q}$  (t), of the KPZ equation. Indeed, a more recent publication by Prahofer and Spohn suggests that the envelope of the one-dimensional structure factor decays exponentially rather than as a stretched exponential [12]. They claim an exact solution for the time-dependant structure factor of another model in the universality class of the KPZ system, namely the polynuclear growth model. The actual solution for the structure factor follows a number of well de ned steps involving some direct though complicated numerical calculations. Those calculations are reported to be performed with extrem ely high precision that seems to ensure that the nal solution for the solution they present is numerical it is rather obvious that the envelope decay is exponential rather than stretched exponential.

This discrepancy motivated us to check the above results directly on the KPZ equation. In this work we nd numerical support for the existence of stretched exponential relaxations in the KPZ system in 1 + 1 dimensions in contradiction to ref. [12]. We also get direct evidence for the oscillatory behavior of  $_{q}$  (t). As a by product, we were able to verify the predicted short-time behavior of the dynam ical structure factor (given in ref. [13] for example), and the validity of the scaling hypothesis for small q's.

W e discretized the KPZ equation (1) on a one dimensional lattice, with lattice constant x, and time dimension t,

where  ${}^{2}$  2D<sub>0</sub>/ x and the random numbers (t) are uniform ly distributed between 1/2 and 1/2. In this work we used L = 1024, t = 0.05, x = 1, = 1, = 4 and D<sub>0</sub> = 1/6. A fler reaching steady state, at each time step we Fourier transformed the discrete height function, and obtained h<sub>q</sub> (t) for q = q<sub>0</sub>;2q<sub>0</sub>;...; where q<sub>0</sub> = 2 /1024. Then we calculated the two-point function hh<sub>q</sub> (0) h<sub>q</sub> (t) i<sub>s</sub> by averaging over all pairs with a time difference t, for q = 30q<sub>0</sub>;60q<sub>0</sub>;120q<sub>0</sub> and 240q<sub>0</sub>.




FIG.1: A log plot of the scaling function  $f(!_qt)$  for various sm all q's.

First, the scaling hypothesis was numerically veried, i.e. In Fig. 1 we plot  $f(!_qt)_q(t)/_q$  as a function of  $!_qt = Bq^2t$  with z = 3/2 for  $q = 30q_0$ ,  $q = 60q_0$  and  $q = 120q_0$ . The plot indicates good scaling.




FIG.2: A log plot of the scaling function  $f(!_qt)$  for  $q = 120q_0$  and  $q = 120q_0$ .

However, we found that the scaling hypothesis breaks down when taking  $q = 240q_0$  (see Fig. 2) which m eans that the scaling, which is supposed to be correct for small q's, is correct only up to q's that are of order of 10% of the largest q in the system.




FIG.3: A log plot of f  $(!_q t)$  for  $q = 120q_0$  with an error estimate.

Fig. 1 indicates good scaling at least up to  $120q_b$ . Therefore, we invested most of the computational e ort in this Fourier component, since eq. (3) indicates that the larger q we take, the faster computational time evolution we get. For  $q = 120q_b$  we took 5 1<sup>th</sup> integration time steps of t. Taking this component we found clear evidence for oscillatory behavior as shown in Fig. 3.

The error estimate in Fig. 3 was obtained using the imaginary part of  $h_q$  (0)  $h_q$  (t)  $i_s$  after averaging. Note that  $h_q$  (0)  $h_q$  (t)  $i_s$  should be real, due to averaging, while each

contribution of the form  $h_q$  (0)  $h_q$  (t) is certainly not real. This means that the imaginary part, which should vanish eventually, is a sensible error estimate. An independent argument for the estimation of the error, which yields the same order of magnitude runs as follows: consider the case where there is no correlation at all and estimate the "apparent correlation" due to the nite sample. The total number of time steps is N = 5 1<sup>10</sup>. Therefore, this is also the number of pairs ( $h_q$ ;  $h_q$ ) separated by a time t = n twith n N. The measured correlation is

In the absence of correlation, the sum on the right hand side of (5) is a sum of N random variables. Therefore, the size of the apparent correlation is of order N  $^{1/2}$ , which is of the order of e $^{12}$ .




FIG.4: A log plot of  $(!_qt)$  for sm all  $!_qt's$ .

U sing this result we extracted the short-time behavior of the scaling function. In ref. [13] Colaiori and M oore predict  $_q$  (t) /  $_q$  1 (! $_q$ t)  $^{/z}$ . Now, in one dimension = 2 ( is related to the roughness exponent via = d + 2 ) and z = 3/2, so that for a specie q

we get f  $(!_qt) / 1$   $(!_qt)^{4/3}$ . This prediction was indeed veried by our data as shown in Fig. 4.




FIG.5: A simple t is  $\cos^{n}$   $(!_{q}t)^{4=3}$  + D sin  $(!_{q}t)^{4=3}$  with = 0:034 and D = 32:7.

The error estimates suggest that the data may be useful in the range  $0 < !_qt < 55$ . Since we wanted to check a stretched exponential decay, we multiplied our numerical f (!<sub>q</sub>t) by  $\exp[!_qt]^{2=3}$ . We chose = 0:93 so as to render the resulting function to be oscillating in that region. Motivated by the predictions of ref. [13] and our previous veri cation of it we present the resulting function as a function of (!<sub>q</sub>t)<sup>4=3</sup> in Fig. 5.

We were thus led to try the te  $(!_{q}t)^{2/3} \cos^{h}$   $(!_{q}t)^{4/3} + D \sin^{h}$   $(!_{q}t)^{4/3}$  for the full scaling function f  $(!_{q}t)$ . This has the right small  $!_{q}t$  behavior as well as the envelope stretched exponential decay.

The t is very good, especially when keeping in m ind that this t involves m one than 6 orders of m agnitude in the size of the scaling function. An attempt to replace the 2/3 in the stretched exponential (in the ansatz) with an arbitrary exponent that will be determined




FIG. 6: A toff  $(!_q t)$  using e  $(!_q t)^{2=3} \cos^{h} (!_q t)^{4=3} + D \sin^{h} (!_q t)^{4=3}$  with = 0.93, = 0.034 and D = 32.7. Both curves practically join over most of the time range.




FIG.7: A toff  $(!_qt)$  using e  $(!_qt)^n \cos^h (!_qt)^{4=3} + D \sin^h (!_qt)^{4=3}$ . The best tofthat form is obtained for = 0.21, = 0.326 and D = 2.6.

by the thing procedure yields a very close value ( 0:65). A ctually, we also tried to t an exponential decay (rather than a stretched exponential one), according to the nding of ref. [12], that gave a t that was de nitely worse (Fig. 7).

At this point we are facing an interesting contradiction. First, we have results following from four independent approaches: (1) A nalytical asymptotic study of the self-consistent approximation. (2) A nalytical asymptotic study of the mode-coupling approximation. (3) N um erical solution of the mode-coupling equations. (4) The present direct num erical integration of the KPZ equation. All these independent approaches yield the same stretched exponential decay. On the other hand, we have a publication [12] claiming to be exact that yields a result that is quite di erent from the results obtained from all the above methods. It is possible that there is a aw in the study presented in ref. [12]. If there is, we have certainly not found any. We would like to suggest here another solution to the problem. Ref.

[12] does not consider directly the KPZ equation but rather the polynuclear growth m odel that was shown to be equivalent to the directed polym er problem with speci c boundary conditions, and thus in the sam e universality class of the KPZ system. However, the point is that two m odels that are in the sam e universality class m ust have the sam e exponents but not necessarily the sam e scaling functions. In fact, it is possible to construct families of exactly solvable m odels where all the m em bers of the family are characterized by the sam e exponents yet have radically di erent time dependant structure factors. W e will not go into this here but the interested reader could nd the relevant ideas, although presented in a di erent context, in ref. [14]. Our suggestion for solving the puzzle is thus that P rahofer and Spohn [12] obtain the correct decay for the polynuclear grow th m odel, which is in itself a m ost im pressive feat, but this is not the decay of the KPZ structure factors.

To sum marize, using extensive numerical integration of the KPZ equation in 1 + 1 dimensions, this work gives clear support for the scaling hypothesis (i.e. the fact that the scaling function f (!<sub>q</sub>t) is the same for any q, at least for small q's), veri es the short-time behavior given in ref. [13] (i.e.  $_{q}$  (t) /  $_{q}$  1 (!<sub>q</sub>t) /<sup>z</sup><sup>i</sup>) and establishes the oscillatory decay of the dynam ical structure factor to zero (as suggested in [11]). In addition, we show that the stretched exponential describes the decay of the structure factor over six orders of magnitude in its size. This implies that the KPZ problem is likely to be a respected member of the family of systems that exhibit slow relaxations – thus opening the door for mutual in uence between the community of surface grow th and that of slow dynam ics.

The present work consumed quite a few months of CPU time on a Pentium 4 machine. In spite of that, we believe that the results presented here should motivate a much heavier numerical e ort to deal with a region with larger  $!_qt's$  for the one-dimensional system and hopefully with the two dimensional system.
