M icrow ave Spectroscopy of P rO s_4Sb_{12} : Josephson-C oupled T w o-B and Superconductivity and Itinerant f E lectrons

W e report m icrowave surface in pedance m easurements m ade on a single crystal of P rO $s_4 Sb_{12}$ across the frequency range 0.5 to 21 G H z. The penetration depth data provide clear therm odynamic evidence for superconductivity arising in two bands coupled by Josephson pair-tunneling, indicating two order parameters with the same symmetry. D etailed conductivity spectra obtained using high-resolution bolom etry con m this picture and extend it, revealing the itinerant nature of the Prf electrons through the observation of quasiparticles with heavily renorm alized m ass.

Interest in the recently discovered skutterudite superconductor PrO s₄Sb₁₂ has focused on the possibility that this compound could provide the rst example of superconducting electron pairing mediated by the exchange of quadrupolar charge density uctuations [1, 2]. Based on magnetic susceptibility, specic heat, and neutron di raction m easurem ents, it has been suggested that the Pr^{3+} ground state in the cubic crystal eld is a nonm agnetic doublet that carries an electric quadrupolem om ent, 7 K from a low lying triplet [1, 2]. This separated by raises the interesting possibility of an electric quadrupolarK ondo e ect [3], and speci cheat C (T) m easurem ents indicate the form ation of a heavy ferm ion m etallic state [1, 2]. However, it should be noted that several investigators have concluded that the ground state of Pr^{3+} is a singlet [4, 5]. Evidence for unconventional superconductivity in PrOs4Sb12 includes a double transition in C (T) [2, 6], a report of multiple superconducting phases ofdierent symmetry in eld-dependent thermal conductivity (T;H) [7], the observation of low temperature power laws in C (T) [1, 2] and London penetration depth I. (T) [8], and spontaneous magnetic elds appearing below the superconducting transition temperature T_c, indicating time reversal symmetry breaking [9]. The occurrence of a high eld ordered phase (HFOP) between 4.5 T and 16 T below 1 K has been inferred from electrical resistivity [2, 10, 11], speci c heat [4, 6], therm al expansion [12], and m agnetization [10, 13, 14] m easurem ents. From neutron scattering studies in high m agnetic

elds it was concluded that antiferro-quadrupolar order occurs in the HFOP [5]. In this Letter we present the rst m easurements of the microwave surface in pedance Z_s of PrOs₄Sb₁₂, from which we infer a rapid drop in quasiparticle scattering below T_c , the existence of Josephsoncoupled two-band superconductivity (in plying two order parameters of the same symmetry), and heavy, it inerant quasiparticles of mass 100 m_e.

High quality single crystals of PrO s₄Sb₁₂ were grown from an Sb ux [15]. Powder x-ray di raction indicates that the sam ples are single phase, with a stoichiom etric ratio of 1 Pratom perform ula unit [10]. Sharp superconducting transitions in resistivity, susceptibility and microw ave conductivity indicate high hom ogeneity, and the low residual resistivity (< 5 on) attests to long carrier m ean free paths and low levels of disorder [1]. The sam ple used in our experiment was an as-grown single crystal measuring 0.18 mm 0.22 mm 1.1 mm, with clean, shiny faces aligned to the cubic crystallographic axes. M easurements of Z_s were made using three sets of apparatus cooled in ⁴H e cryostats. A loop {gap resonator (954 M H z) [16] and a dielectric resonator (5.49 GHz) [17] were used to make cavity perturbation measurements of the surface resistance R_s and changes in surface reactance $X_s(T)$ from 1.16 K to 120 K . Frequency scans of R $_{\rm s}$ across the range 0.5 GHz to 21 GHz were perform ed using a bolometric surface resistance probe [18], at a set of xed tem peratures. The Z_s data have been analyzed to obtain the m icrow ave conductivity = 1 i_2 by assuming the local electrodynam ic relation Z $_{\rm s}$ R_s+ 1X_s = i! 0= . 3000 A (this work and A long penetration depth $_{\rm L}$ Ref. 19) and a short coherence length $_0$ 120 A [1] m ake local electrodynam ics a valid assumption.




FIG.1: (color online). M icrow ave surface resistance R_s and reactance X_s at 954 M Hz. Inset: Q uasiparticle conductivity $_1$ (T) data at 954 M Hz and 5.49 G Hz indicate a rapid collapse in quasiparticle scattering below T_c.

Fig. 1 shows the R_s and X_s data at 954 M Hz. Above $T_c = 1.872$ K, R_s(T) and X_s(T) have the same tem – perature dependence, as expected in the classical skine e ect regime where R_s = X_s. Enforcing this condition by adding a tem perature independent o set to X_s(T) allow s us to determ ine the absolute reactance, which here corresponds to $_L$ (T = 1.2 K) = 2650 A. The strong tem – perature dependence of R_s and X_s in the normal state indicates the presence of substantial inelastic scattering. Below T_c there is a sharp drop in R_s follow ed by a gradual decrease to a residual value of 50 Sim ilar features are observed at 5.49 G Hz, and from Z_s we obtain $_1$ (T) at

the two frequencies (see inset of Fig. 1). The frequency dependence of $_1$ is weak in the normal state, consistent with a quasiparticle scattering rate much higher than microwave frequencies. Below T_c the rapid rise in $_1$ (T) and the development of strong frequency dependence together point to a sudden drop in scattering. This is a characteristic feature of strongly correlated m etals such as the high T_c cuprates [20], in which the opening of the superconducting gap quickly suppresses the electronic uctuations responsible for strong normal state inelastic scattering.




FIG.2: (color online). London penetration depth $_{\rm L}$ plotted as l= $_{\rm L}^2$ (T). Fits to the data using a two band G {L m odelw ith Josephson coupling (solid line) and quartic coupling (dashed line) are shown. Inset 1: l= $_{\rm L}^2$ (T) over a wider temperature range. Inset 2: Superconducting contribution to C=T calculated from the Josephson-coupled free energy.

Fig. 2 shows the 954 MHz $_2$ (T) data, plotted as $1 = \frac{2}{L}$ (T) ! 0 2 (T). At T_c = 1:872 K, $1 = \frac{2}{L}$ (T) has a sharp onset, less than 5 mK wide, below which it increases linearly with a slope of 1:1 m 2 K 1 . A rounded change in slope occurs 70 mK below T_c, followed by a second regime of linear T dependence with a slope of 31 m 2 K 1 . This behaviour is suggestive of two superconducting transitions and is consistent with the observation of double transitions in C (T) [2, 6] and (T;H) [7]. To model $_{\rm L}$, a thermodynamic quantity that can be derived from the free energy, we consider the case of two weakly coupled bands. The Ginzburg{ Landau (G{L) free energy density f can be written $f_{i=1}^{f} f_{i} + f_{m} + f_{c}$, where the intraband contributions f = $f_i = 1 = (2m_i) j(i - r + 2eA) i^2_j + i(T) j_i^2_j + i = 2 j_i^4_j$ with $_{i}(T) = _{0i}(T - T_{ci})$ and $_{i} = const.$ The magnetic term is $f_m = (r A)^2 = (2_0)$, and the interband couplings allowed by symmetry can be written $_{1}j_{1}j_{2}j\cos + _{2}j_{1}j_{2}j_{2}(1 + a\cos 2), with$ $f_c =$ the phase dierence between $_1$ and $_2$. Note that

1 is the strength of the interband Josephson tunneling and can be nonzero only if $_1$ and $_2$ have the same symmetry. The quartic coupling is insensitive to order parameter symmetry and contains a cos2 term originating from double pair transfer. (Depending on the sign and m agnitude of a, there can be a transition from phase aligned (= 0) to phase rotated (= $\frac{1}{2}$) states, but the data do not support this and = 0 is therefore assumed in the following.) M in im izing the free energy with respect to magnetic eld B = r A gives the London equation for the supercurrent density, from which we obtain the two-band expression for the penetration depth: $_{L}^{2} = 4_{0}e^{2}f\frac{j_{1}j_{m}}{m_{1}} + \frac{j_{2}j_{m}}{m_{2}}g$, where j_{ij}^{2} are the pair densities and m , the pair e ective m asses. Therefore, since the build-up of super uid density below the second transition in PrOs₄Sb₁₂ occurs about 30 times faster than the initial increase, we have either a small pair density in the rst band or a large pair mass. In the case $_1 = _2 = 0$, the model reduces to that of two independent superconductors with transition tem peratures $T_{\rm c1}$ and $T_{\rm c2}$. In that case the usual results follow on m inin izing f with respect to $_{i}: j_{i}j^{2} = _{0i}(T_{ci} T) = _{i}$ and $C_{i}=T = (e^{2}f=e^{T^{2}}T_{T=T_{ci}} = e^{2}_{0i} = _{i}$. That is, in each band the pair density builds up linearly with decreasing tem perature, with a double jum p in the speci c heat C . However, only the $_1$ coupling can give the delicate curvature seen in Fig. 2. To show that we consider the cases of Josephson and quartic couplings separately and, by solving the G {L equations num erically,




FIG. 3: (color online). Surface resistance spectra $R_s(!)$ taken at di erent tem peratures. From top to bottom, T = 1.69 K, 1.55 K, 1.48 K, 1.41 K, 1.27 K and 1.19 K. Inset: scattering rates $_1$ (multiplied by 10) and $_2$ inferred from ts to $_1(!)$.

t to $1 = \frac{2}{L}$ (T). Several parameters of the G {L m odel are xed by other experiments: the two heat capacity jumps in a mosaic of crystals from the same batch were mea- $C_2 = T = 0.23 \text{ Jm ol}^1 \text{K}^2$ [2], sured to be $C_1=T$ which $x = \frac{2}{0} = \frac{1}{1}$; the elective mass of the pairs in the second band is taken to be twice the average cyclotron m ass inferred from dHvA experiments, $m_2 = 9 m_e$ [21]; and T_{c1}, which is una ected by the strength of the interband coupling, is set to 1.872 K.G ood initial guesses for the ratios _{0i}= i can be obtained from the slope of $1 = \frac{2}{T}$ (T) in the linear regions and, anticipating the results of the conductivity analysis below, we set $m_1 = 30 m_2$. (Heavy-mass quasiparticles have not been detected in the dHvA experiments [21], but they may be localized in the HFOP above 4.5 T [4, 5, 6]. Analyses of speci c heat and upper critical eld data provide indirect evidence for an average quasiparticle m ass of order 50 m $_{\rm e}$ [1]. In any case, the choice of m ass ratio $m_1 = m_2$ does not a left the quality of the ts to the L data, nor the conclusions drawn about the nature of the interband coupling.) The best t to the data in the case of pure Josephson coupling ($_2 = 0$) is shown by the solid curve in Fig.2 and corresponds to setting $T_{c2} = 1.763 \text{ K}$, $_{01}=k_B = 0.024$, $_{02}=k_{\rm B}=0.012$, and $_{1}=0.0053^{\rm p}$ $_{01}$ $_{\rm p^{02}}T_{\rm c1}$, where the band-dependent G {L parameters $i = m_i^2 i = 2_0 e^2 \sim^2$ are $_1 = 99$ and $_2 = 1:72$. The pair-tunneling solution m atches $1 = \frac{2}{L}$ (T) extremely well, properly capturing the gentle rounding that occurs in the vicinity of T_{c2}. We can interpret this as an avoided crossing of $_1$ and $_2$ caused by mixing of states of the same symmetry. Shown by




FIG. 4: (color online). Solid points show the $_1$ data obtained from a K ram ers{K ronig analysis of R_s(!;T) and $l = \frac{2}{L}$ (T). Solid lines show the modi ed D rude ts to the broad background. The shaded regions undermeath are the di erence between the $_1$ data and the broad background ts.

the dashed curve in Fig. 2 is the case of pure quartic coupling ($_1 = 0$; $_2(1 + a) = 0.22$ $\overline{1_2}$), appropriate for order param eters of di erent symmetry. In that case we see level crossing, not level repulsion, for any value of $_2$. This is strong evidence that $_1$ and $_2$ have the same symmetry, and that the second phase transition reported in other experiments [6, 7] is in fact a cross over. ($_2$ is nite at all temperatures below T_{c1} .) We believe the apparent discrepancy with the (T;H) result | that the nodal structure of the order parameter changes on crossing T_{c2} | could be resolved by taking into account the sudden drop in quasiparticle scattering on cooling through T_{c1} , and the rapid build-up of $1 = \frac{2}{L}$ (T) below T_{c2} . (The average quasiparticle Doppler shift from vortex ow elds is proportional to $1 = \frac{2}{L}$ (T) [22].)

An unconventional two-band superconductor should exhibit novelphysical properties. Leggett has predicted a new collective mode, corresponding to Josephson plasm a resonance between the bands [23]. This mode is expected to be di cult to observe experimentally, as it does not perturb the long wavelength charge density and hence couples weakly to electrom agnetic radiation. (Our attempts to excite the mode with microwaves have been unsuccessful, with no indication of collective mode absorption in R_s (!;T).) Babaev has studied the magnetic properties of two-band superconductors and concludes that these systems can contain fractional vortices arising from topological defects in only one of the order param – eters [24]. In addition, Gurevich and Vinokur predict static and dynam ic solotonic phase textures that should appear in nonequilibrium transport experiments [25].

 $R_s(!;T)$ is plotted from 0.5 GHz to 21 GHz in Fig. 3, at six dierent temperatures in the superconducting state. With no sign of resonant absorption by collective excitations, we expect R_s to be due solely to thermally excited quasiparticles. To extract the quasiparticle conductivity spectra $_1(!;T)$ from $R_s(!;T)$ and $1=\frac{2}{L}$ (T) we apply a K ram ers{K ronig analysis [18, 26], which properly accounts for quasiparticle contributions to the screening of electrom agnetic elds. The conductivity spectra are plotted in Fig. 4, for tem peratures between 1.19 K and 1.69 K. At each temperature, $_1(!)$ has a sharp, cusp-like upturn at low frequencies with a broad high frequency tail. W ith decreasing T the spectra sharpen and increase in height as they draw in more spectral weight from high frequencies. Broadly similar behaviour has been observed in high quality samples of O rtho-II ordered $Y B a_2 C u_3 O_{6:5}$, where it was concluded that the cusp-like lineshapes and strongly tem peraturedependent linew idths were close to the behaviour expected for weak (Born-lim it) scattering in a superconductorwith energy gap nodes and an energy dependent scattering rate [26]. In that work a modi ed D rude spectrum $_{1}(!) = _{0} = (1 + (! =)^{y}), with y$ 1:45, was shown to capture the phenom enology of energy dependent scattering.We have attempted to t this form to our PrOs₄Sb₁₂ data, with no success. The problem lies in the combination of a very sharp low frequency peak and a broad high frequency background. The situation im proves, how ever, if we allow for the possibility of two bands with di erent scattering rates and t the sum of two modied D rude spectra at each tem perature. In Fig. 4 the broad spectra are plotted as solid lines, which have then been subtracted from the data points to reveal the narrow spectra, represented by the shaded regions. In all the ts the value of y is close to 1.50 for both the broad and narrow components. The values of $_0$ are the zero frequency intercepts, and the values of scattering rates are plotted in the inset of Fig.3 as $_1$ and $_2$. Both $_1$ and 2 decrease strongly on cooling, as inferred from the resonator data in Fig.1. 1 is about a factor of 30 sm aller than 2 over the whole tem perature range: it is this fact that allows a unique separation of the spectra. The T dependent spectral weight $\begin{bmatrix} 1 \\ 0 \end{bmatrix} = \begin{bmatrix} 1 \\ 1 \end{bmatrix}$ (!; T)d! is in good accord with the G {L model for $1 = \frac{2}{L}$ (T) if the narrow spectra are identied with band 1 and the broad spectra with band 2. To understand the form of the unusual $_1(!;T)$ spectra better we look to Ferm i-liquid transport theory where, for the case of electron {phonon coupling, P range and K adano have found that interactions do not renormalize the low-frequency transport coe cients, due to a cancellation between the renorm alizations of the life-[27]. That is, as m time and mass m increases, the width of the conductivity spectrum shrinks, but the

dc conductivity remains xed, so that the total conductivity spectral weight / 1=m . Varm a has argued that su ciently local interactions will have the same e ect in heavy ferm ion metals [28], where m 100 m_e, in plying a reduction in quasiparticle scattering rate by a similar factor. From this we infer $m_1 = m_2$ $_2 = 1$ 30 in P rO s₄Sb₁₂, motivating our parameter choice in the G {L m odel. The conductivity spectra therefore provide direct evidence for heavy quasiparticles and hence of the itinerant nature of the P r f electrons outside the high eld ordered phase.

In sum m ary, we have used m icrow avem easurem ents as a therm odynam ic and spectroscopic probe of PrO $s_4 Sb_{12}$, nding evidence for novel two-band superconductivity. The bands are coupled by Josephson pair tunneling, requiring that there be two order param eters with the sam e sym m etry. Quasiparticle conductivity spectra con rm this and provide a unique insight into the transport dynam ics, revealing a collapse in scattering below T_c , and the presence of heavy itinerant quasiparticles.
