Dom ain State Occurring in the de Haas-van Alphen E ect in Silver

Hysteresis has been observed in de Haas-van Alphen measurements of the Condon domains in silver, and it shows the rst-order nature of the transition to the domain state. The hysteresis, and thus the rst-order nature, is manifested in a nonlinear e ect where a double-valued response of the amplitude with the applied external eld is observed.

1. IN TRODUCTION

The de H aas-van A lphen (dH vA) e ect is perhaps the m ost signi cant of the quantum oscillatory phenomena in metals; as the magnetization M is a therm odynamic state function, it can be directly related to the density of states and Ferm i-D irac distribution of electrons in a metal. In order to measure this e ect, one observes the oscillatory magnetization with swept eld of an electrically conducting single crystal at a low temperature and high-magnetic eld. In the course of measuring the Ferm i surfaces of the elements, copper, silver, and gold oscillations came late because both higher elds and better sam ples were required¹. The large spheres of their Ferm i surfaces barely touch each other in reciprocal space and in turn give rise to closely spaced belly oscillations. A lthough the periods seem ed correct, the oscillations were distorted by harm onic content. An explanation was provided by Shoenberg and P ippard who realized that if the magnetization M was swinging by m ore than the period of the oscillation, the internal eld B = H + 4 M m ust be used to modify the oscillatory equation to obtain ¹




Fig. 1. The signal amplitude divided by the modulation level at various modulations and sweep rates of the applied magnetic eld at T = 0.15 K. The inset, typical trace is at 0.10 K, 80 T/s sweep, and 0.33 T_{mms} modulation. The modulation frequencies were 24 Hz.

where the variables are as in Shoenberg¹. This description seem ed to be in favorable agreement with experiment, and then Pippard realized that the elective free energy became multi-valued at high enough $elds^1$. Consequently, this result leads to coexisting phases as in the pressure-volum e isotherms in gas-liquid phase equilibria, and in the case of silver, it is Condon domains with slightly different magnetizations. NMR experiments indicated that such domains different magnetizations. NMR experiments indicated that such domains different for example, by about a mT at 9 T. This observation led to the name C ondon domains². M otivated by recent review articles on this subject^{3,4}, we describe the thesis work of one of the authors (JLS) under the direction of G eorge Seidel⁵.

2. EXPERIMENT

The hom e-built dilution refrigerator was capable of 20 mK in an 8 T superconducting magnet, which had a hom ogeneity of one part in 10^5 over a 25 mm sphere. For this eld-modulation measurement a sample holder was used that rotated in two directions. The silver single crystal was cut into a shape approximating an ellipsoid with principal axes lengths of 11 mm, 4.6 mm, and 0.61 mm, which were the < 100> directions of the sample. The measurements described here are only for the orientation of the long axis 13.5 away from the eld direction and in a < 100> plane, which yields a




Fig. 2. Pressure-volum e or m agnetization – eld isotherm s and their derivatives are shown for a rst-order transition. Because of m agnetoelastic coupling, the work involved in creating and m oving the dom ain is illustrated as the m agnetic analog to pressure-volum e work.

single dHvA oscillation from the belly of the sphere of the Ferm i surface. The results for the <100> orientation, which has two orbits, are covered in detail elsewhere⁵. The crystal had a residual resistivity ratio of 660 and a D ingle tem perature of 0.8 K.

3. RESULTS AND DISCUSSION

In the situation under investigation we show a rate-dependent hysteresis e ect in Fig. 1. The evolution of the signal am plitude divided by the modulation level is shown over four decades of modulation levels. The amplitude for dierent sweep rates, ranging from 5 T/s to 320 T/s, show similar hysteretic behavior. One can see the existence of the van der W aals eldinduction diagram for C ondon dom ains, a topic covered in detail by G ordon and cow orkers⁴. If no nonlinearities were present, all of the data would collapse to one horizontal line. In Ref. 5 this was explained as likely due to dom ain-wall pinning, which was described as an ad hoc model. Now it is clear that the dom ain state must result from a rst-order phase transition and that the nonlinearities arise from the hysteresis of form ing and moving the dom ains. Because the dom ains are form ed and moved, it is reasonable to draw parallels between pressure or magnetization versus volume or eld work, respectively, as shown in Fig. 2. The discontinuous appearance in the dHvA data is similar to experimental pressure-volume isotherms observed in gas-liquid phase equilibria. The curves in Fig. 2 illustrate m agnetic work and pressure-volum e work. At the discontinuity there is a similarity to the double-valued response of the amplitude with the applied external eld. The

derivatives are plotted in Fig. 2 to illustrate the rate dependence of the data. In general we observe the maximum value of the derivative with the lowest modulation level. In many respects this is similar to measuring the height of the speci c-heat peak through a rst-order transition⁶. Generally one will take small increments of temperature to obtain the total height of the transition. We conclude that the nonlinear dH vA e ect can be used as a tool to unambiguously identify a rst-order transition. The multi-valued amplitude as a function of eld is a hallmark of the hysteresis, and we speculate that the dam pening of the amplitude is related to the latent heat as observed independently in speci c-heat measurements⁴.
