# Interm ittency and scale-free netw orks: a dynam icalm odel for hum an language com plexity

#### Abstract

In th is paperwe try to $m$ odelcertain features of hum an language com plexity by $m$ eans of advanced concepts borrow ed from statisticalm echan ics. W e use a tim e series approach, the di usion entropy $m$ ethod (DE), to com pute the com plexity ofan italian corpus ofnew spapers and $m$ agazines. $W e n d$ that the anom alous scaling index is com patible with a sim ple dynam icalm odel, a random walk on a com plex scale-free netw ork, which is linguistically related to Saussurre's paradigm s. The netw ork com plexity is independently $m$ easured on the sam e corpus, looking at the co-occurrence of nouns and verbs. This connection of cognitive com plexity with long-range tim ecorrelations also provides an explanation for the fam ous Z ì f's law in term s of the generalized central lim it theorem.


## I. INTRODUCTION

$T$ his introduction is divided into two parts, the form er being devoted to a generaldiscussion conceming the challenging issue of the search for crucialevents, in general. The second is of linguistic interest. This division re ects the tw ofold purpose of this paper. In fact, the $m$ ain result of this paper is the foundation of the $Z$ ipf $f^{\prime}$ law, a sub ject of theoretical interest to understand the origin and evolution of language $[\underline{1} 1]$. T he foundation of th is im portant em pirical rule is here discussed from a specialperspective. This is the perspective of com plexity conceived as a new condition of physics. O fcourse, this condition is not expressed by regular dynam ics, and it is not expressed by therm odynam ics, either. $T$ his is rather a regim e of transition from dynam ics to them odynam ics lasting for a virtually in nite tim e, so as to realize a new legitim ate state of physics, a ording a perspective valid also in the case of non-physical system $s$. A paradigm for this condition is given by the renew al theory processes $\bar{\sim} 1 \mathrm{l}$ ]. Thus, we $m$ ake use of the renew al theory to de ne the concept of crucial events.

In conclusion, the rst purpose of this paper is to contribute the progress of a statisticalm ethod for the search of crucial events, using written texts as an ilhustration of the $m$ ethod. On this im portant issue we do not reach conclusive results but the form ulation of a conjecture for future work. H ow ever, we note that the linguistic results rest on a general approach to the detection of rare and signi cant events. This general approach to the detection of crucial events $m$ ight yield useful applications to $m$ any elds, from the early diagnosis of diseases to the war against terrorism. Thus, we devote the rst part of the introduction to the de nition of crucial events. The second part of the introduction serves the purpose of introducing the reader to the ideas and jargon of linguistics, so as to fully appreciate the $m$ ain result of this paper, which is, in fact, of linguistic interest.
A. De nition of crucial events

Let us consider a generic tim e series. This is a sequel of values occurring at di erent tim es and m irroring the properties of a given com plex system, this being either the heart-beating [ $[\underline{1}]$ as in this paper. Let us label, orm ark, som e of these values with a given criterion, which depends, of course, on the con jectures that we m ake about the process under study. Labeling a value im plies that we judge it to be signi cant. $T$ hus, it is evident that the $m$ ore we know about the process, the $m$ ore plausible the con jecture behind the labeling criterion adopted. To give som e ilhustrative exam ple, let us mention som e of the criteria recently adopted. In the case of heart-beating [3] ${ }^{3}$, we are observing the tim e distances $T$ betw een a $R$ peak and the next, which for a very large num bers of beats $t$ becom es equivalent to a continuous finction, $T$ ( $t$ ), of a continuous variable $t$. $W$ e divide the ordinate axis into $s m$ all interval of size $s$, and we record, or $m$ ark, the beats at which $T(t) m$ oves from one strip to another. In the case of earthquakes, we label only the seism ic uctuations of intensity larger than a given threshold []$\left.^{\prime}\right]$. F inally, in the case of a w ritten text, as explained later in this paper, we $m$ ark the salient w ords, these being the words that in a given text appear with a frequency larger than in a suitable reference text.

N ow we have to address the im portant issue of establishing whether the labeled values are crucial events, or not. $T$ his, in tum, requires that we de ne what we m ean by crucial event. Let us de ne rst the crucial events by $m$ ean
of their statistical properties. Then we shall explain why events $w$ ith these statistical properties $m$ ust be considered crucial. $W$ e use the prescriptions illustrated in the fundam ental paper of $R$ ef. [ $[\underline{l}$ $m$ arked values and the sym bol 0 to the others. Then we convert the tim e series into a set of random walks w th the $m$ ethod detailed in Ref. [G]]. W e use the walking rule that the walker m akes a step ahead by the quantity 1 any tim $e$ we m eet a m arked value, nam ely, the sym boll. W hen we m eet the sym bol 0 the walker rem ains in a state of rest. The $m$ arked values are $m$ uch less num erous that the unm arked values. Thus, we shall have $m$ any 0's and a few 1's. A sequence of $m$ any 0 's betw een two 1 's is term ed a lam inar region. It is im portant to evaluate the tim e distance betw een one $m$ arked value and the next, which is equivalent to determ ining the distribution of the tim e lengths of the lam inar regions. This will result in a tim e distribution $(t)$. Let us assum e that the waiting tim e distribution
$(t)$ is an inverse power law with index. The Poisson case corresponds to $=1$. Then we study the resulting di usion process and we establish its scaling param eter. If the index ts the condition $2 \ll 3$ and it is related to the scaling coe cient by the relation $=1=(1)$, or, if the scaling index ts the condition $>3$ and the scaling coe cient has the ordinary value $=0: 5$, the labelled values are crucialevents.

Let us explain the physicalm otivation for this de nition. First, $m$ eeting a 0 is not signi cant because the 0 's are closely correlated and $m$ eeting one of them im plies that that we shall $m$ eet $m$ any other $0^{\prime} s$, before nding a 1 again. In a sense the 0 's are driven by the 1's. A given 1 is the beginning of a lam inar region and, consequently, of a cascade of 0 's. On the other hand, if and violate the relations for the 1 's to be crucial, there $m$ ight exist a correlation betw een tw o di erent lam inar regions. This suggests that the 1'sm ight be part of a predictable cascade of som e other genuinely crucialevents, not yet revealed by the statistical analysis, and that our conjecture is not correct.

W e have to explain why $<1$ is an important condition for our de nition of crucial events. W e lim it ourselves to noticing[ $[\underline{d}]$ that $=1$ is equivalent to setting Poisson statistics, im plying, in tum, a $m$ em oryless condition that seem s to be incom patible w ith the labelled values to be crucial. This is a poorly understood property, in spite of the fact that 32 years ago B edeaux, Lindenberg and Shuler [ITIW w rote a clarifying paper on this sub ject. W e refer the reader to this fundam ental paper [ $\overline{7}$,$] to understand the reasons why we im agine the crucial events to be incom patible$ with P oisson statistics. A ctually, the labelled values seem to becom e crucialw hen the di usion process they generate is anom alous, nam ely >0:5, which implies < 3. It has to be pointed out that < 2 im plies a condition where the $m$ ean length of the lam inar region is in nite. This $m$ eans that in this region the process becom es non-stationary, due to the lack of an invariant $m$ easure [d]]. From an intuitive point of view, the origin of non-stationary behavior is as follow s. If we keep draw ing random num ber from the distribution ( $t$ ), the $m$ ean value of $t$ tends to increase $w$ ith the num ber of draw ings. $T$ his is so because, if it did not increase the overallm ean value would be nite, in con ict w ith the fact that < 2 produces an in nite $m$ ean value. T hus the condition $=2$ is the border betw een the stationary,
$>2$, and the non-stationary condition, < 2. Aswe shall see, this border has an interesting $m$ eaning for linguistics.
It would be an interesting issue to assess whether crucialevents can be located in this region. W e lim it ourselves to noticing that the results of the statisticalanalysis of tim e series seem to denote that com plex system s are characterized by values of very close to the border w ithout ever entering the non-stationary dom inion $<2$. In conclusion, w ith the prescription of Ref. $\left.\overline{5}_{1}^{\prime}\right]$ we are in a position to assess if the $m$ arked values correspond to crucial events, or do not.

## B. The m eaning of $Z$ ipf's law in linguistics

Sem iotics studies linguistic signs, theirm eanings, and identi es the relations betw een sign and $m$ eaning, and am ong signs. The relations am ong signs (letters, words), are divided into tw o large groups, nam ely the syntagm atic and the paradigm atic, corresponding to what are called Saussurre's dim ensions [9ㅟㅟ]. A clearcut de nition ofthe tw o dim ensions is outside the scope of th is paper, but one can grasp an understanding of them by looking at F ig. . 1 l . T The abscissa ax is represents the syntagm atic dim ension, while the ordinate axis represents the paradigm atic one. A long the abscissa certain gram $m$ atical rules pose constraints on how words follow each other. We can say that this dim ension is tem poral, w ith a casualorder. A $n$ article (as \a" or \the"), for instance, $m$ ay be follow ed by an adjective or a noun, but not by a verb of nite form. At a larger \tim e-scale", pragm atic constraints rule the succession of concepts, to give a logic to the discourse. The other axis, on the other hand, refers to a $\backslash \mathrm{m}$ ental" space. The speaker has in $m$ ind a repertoir of words, divided in $m$ any categories, which can be hierarchically com plex and refer to syntactical or sem antic \interchangeability". D i erent space-scales of w ord paradigm s can be associated to di erent levels of this hierarchy. A fter an article, to follow the preceding exam ple, one can choose, at a syntactical level, am ong all nouns of a dictionary. H ow ever, at a deeper level, sem antic constraints reduce the avalaible words to be chosen. For instance, after la dog" one can choose any verb, but in practioe only am ong verbs selected by sem antic constraints (a dog runs or sits, but does not read or sm oke). The sentence \a dog graduates", for instance, ts paradigm atic and syntagm atic rules behind $F$ ig. 1, but the sem antics would in general forbid the production of such a \nonsensical" sentence.
$T$ he two dim ensions are therefore not quite orthogonal, and connect at a cognitive level. $T$ he $m$ ain focus of this paper is to show that this connection, which is well known at a short scales, is in fact reproduced at all scales. W e w ill
also show that both dim ensions are scale free and that the very com plexity of linguistic structures in both dim ensions can be taken into account in a uni ed $m$ odel, which is able to explain $m$ ost statistical features of hum an language, including, at the largest scales, the celebrated $Z$ ipf's law [1] $\left.{ }^{-1}\right]$.

#### Abstract

Z ipf's law, which relates the rank r of a words to its frequency $f$ in a corpus, obviuosly points to constraints on the frequencies of words. Rem arkably, this does not $m$ ean that the probability of a word is actually de ned. In fact, a w ord $m$ ay have a sm all or large frequency depending on the genre of the corpus (i.e. a large collection of ritten text) under study, and even tw o extrem ely large conpora of the sam e type fail in reproducing the sam e w ord frequencies. It is how ever rem arkable that the occurrence of w ords is such that for any corpus and for any natural language the sam e universal property em erges, this being that there are only a few frequent words and there are, on the contraty, $m$ any w ords that are encountered, for instance, only once or tw ice. To be m ore precise, let us de ne word rank r, which is a property depending on the conpus adopted, as follow $s$. O ne assigns rank 1 to the m ost frequent word, rank 2 to the second frequent one, and so on. E ach w ord is uniquelly associated to a rank, and, although this num ber varies form conpus to conpus, one always nds that

W e shall derive this law from a com plexity model of language, along the follow ing lines. We recognize that there is no experim ental linguistic evidence that word frequencies tend to well-de ned probabilities. H ow ever, we adopt a probabilistic approach, nam ely, we assum e that there exists, for a random ly selected w ord, the probability of frequency $f$, denoted as $P(f)$. O peratively, we m easure $P(f)$ by counting how $m$ any words have a certain frequency f. In Section III we show that a P (f) com patible w ith the Zipf's law can be directly derived from the m odelproposed herein, thus providing a solid experim ental support to our m odel. In order to ful ll our program, we shall assum e a long-range statisticalm utual independence for the occurrence ofdi erent concepts. T his hypothesis is appealing, since this assum ption $m$ eans that every and each occurrence of a concept $m$ akes entropy increase, and therefore we identify the $m$ athem atical in form ation (i.e. entropy) with the com $m$ on-sense inform ation (i.e. the occurrence of concepts). U nfortunately, a concept is not, a priori, a w ellde ned quantity. H erein we shall assum e that concepts are represented by w ords (or better by lem $m$ ata) or by groups of sem antically sim ilar w ords or lem $m$ ata [2.5].

Because of the $m$ utual independence am ong di erent concepts, we can extract from a single conpus as many \experim ents" as the num ber ofconcepts. For each experim ent we select only one concept and wem ark the occurrence of the selected w ord or group of w ords corresponding to this concept. W e shalluse an advanced tim e-series analysis to study the statistical properties of the dynam ical occurrence of the $m$ arkers. In fact, as $m$ entioned_in the rst part of this introduction, we adopt the D E m ethod [ way to detect the statistics of crucialevents. W e shall discover the im portant result that the adoption of D E m ethod allow s us to assess whether a given set of $\backslash m$ arkers" can be identi ed w ith the crucialevents or the crucialevents are still unknown and we m ust consequently search for a di erent set ofm arkers.

The results of the experim ents will lead to a language $m$ odel reproducing the language \com plexity", nam ely a com bination of order and random ness at all scales. The overall dynam ics, given by the ow of concepts over tim e,
resem ble the dynam ics of interm ittent dynam ical system $s$, like the $M$ anneville's $M$ ap $\left[\underline{11} \overline{1}_{1}^{1}\right]$ : T hese system $s$ have long periods of quiescence follow ed by bursts of activity. This variability of $w$ aiting tim es betw een $m$ arkers of activity is responsible for long-range correlations.

A further aspect of the paper is the connection betw een space and tim e com plexity, and its application to linguistics. W e shall assum e that atom ic concepts exist and represent nodes of a com plex netw ork, connected by arcs representing, when existing, sem antic associations betw een a concept and another. W e assum e that ourm arkers are actually de ned as a group of neighbor nodes. W e then assum e that language is the result of a random walk, nam ely a random \associative" travel from concept to concept. The scale-free properties of this netw ork, independently m easured by severalresearch groups, inchuding ours, provides a bridge to understand the interm ittent dynam ics earlier described. In this uni ed $m$ odelthe netw ork is a representation of Saussurre's paradigm $s, w$ hose com plexity $m$ irrors the syntagm atic one in the asym ptotic lim it.

## II. DEAND CONCEPTS

 [1] ${ }^{1} 14^{1}$ ]. In short, as mentioned in the rst part of Section 1, we de ne a set of $\backslash \mathrm{m}$ arkers" am ong the sym bols or values of a tim e series, and we evaluate num erically the probability of having a num ber $x$ ofm arkers in a window of length $t$, denoted asp $(x ; t)$. This statistical analysis is done by $m$ oving a window of length $t$ along the sequences and counting how $m$ any tim es one nds $x m$ arkers inside this $w$ indow. $F$ inally, $p(x ; t)$ is obtained by dividing this num ber by the total num ber of $w$ indow s of size $t$, nam ely by $N \quad t+1$, where $N$ is the total length of the sequence. Since we typically dealw ith large values ofboth $x$ and $t$, we legitim ately adopt a continuous approxim ation. M oreover, we $m$ ake the ergodic and stationary assum ption, thereby expecting the em ergence at long tim es of the scaling condition expressed by

where $w$ is the overallprobability of observing a $m$ arker, is the scaling index and $F$ is a function, som etim es called $\backslash m$ aster curve". If $F$ is the $G$ auss fiunction, is the know $n H$ urst index, and if the further condition $=0: 5$ is obeyed, then the process is P oisson, the variable $x$ undergoes ordinary B row nian di usion. A ccording to R ef. [7, 1 the occurrence of $m$ arkers in tim $e$ is regulated by random uctuations, and the di usion process occurs $w$ ith no $m$ em ory.

It straightforw ard to show that the Shannon Inform ation

$w$ here $k$ is a constant. The evaluation of the slope according to which $S$ increases $w$ ith $\ln t$ provides therefore a $m$ easure for the anom alous scaling index .

Let us brie $y$ mention what we know about applying $D E$ to tim e series $w$ ith non $P$ oisson statistics. W e derive from the tim e series under study an auxiliary sequence, by setting $i=1$ (this $m$ eans that $w e$ nd the $m$ arker at the ith position), or $i=0$ (the $i$ th sym bol, or value, is not a marker). We then assum $e$ inform ativity" for the $m$ arkers. A s explained in the rst part of Section 1, this $m$ eans that we assum e the $m$ arkers to be crucial events, and, that, consequently, the distance betw een a given $\backslash 1 " \prime$ and the next does not depend on the distance betw een this given 1 and the preceding one. A smentioned earlier, if the lengths $t$ of the lam inar regions are distributed as

( ( $t$ ) $t$ asym ptotically is a su cient condition), then the theory based on CTRW and GCLT yields for $p(x ; t) a$ truncated Levy probability distribution function (PD F) [5]-1. DE detects the approxim ate scaling of the centralpart, nam ely

$W$ e note that $p(x ; t)$ is abruptly truncated by a ballistic peak at $x=0$ representing the probability of nding no $m$ arker up to tim e $t$. H ow ever, the di usion entropy increase is essentially determ ined by the occurrence of crucial events, thereby leading to the scaling of Eq. (i, $\left.\bar{\sigma}_{1}\right)$.

It is worth explaining why the condition $2 \ll 3 \mathrm{~m}$ eans long-range m em ory. The rst, and probably easier way, is based on observing that truncated Levy probability distribution $p(x ; t)$ yields:

$N$ ote that the $m$ em ory stem $m$ ing from the non $P$ oisson nature ofm arkers, corresponds in this case to a non-integrable correlation function, which is therefore a clear signal of in nite $m$ em ory. In the Poissonian case this correlation function would be exponential, thereby indicating a $m$ uch shorter $m$ em ory.
$T$ here exists a second, and $m$ ore im pressive way, of relating the non $-P$ oisson distribution ofw aiting tim es to $m$ em ory, according to the rst part of Section 1. We are observing the uctuations of a dichotom ous variable, w ith $=1$ im plying the occurrence of a crucial event, and $=0$ the non-occurrence of events. If the role of tim e is played by the ordinal num ber of words, we shall show that a good choice of sem antic $m$ arkers $m$ akes Eq. (5.) becom e a good $m$ odel for the dynam ics of concept of natural language. T he occurrence of P oisson statistics $w$ ould $m$ ean, according to Ref. $[\underline{1} 1]$, that the tim e evolution of $m$ arkers is driven by uctuations that are identical to white noise. In conclusion, Poisson statistics would be totally incom patible $w$ ith the existence of any form of $m$ em ory. The exponential decay of the correlation function of Eq. ( $\overline{1} 1)$ would not be a short-tim emem ory, but it would signal the com plete lack of mem ory. The long-range correlation corresponding to $<3$, on the contrary, is a clearm anifestation of the in nitely extended $m$ em ory of a text, associated to the strikingly non-P oisson character of the waiting tim e distribution of Eq. $\cdot\left(\overline{5}_{1}^{\prime}\right)$.
 intervals of w ords of duration $k$ (the distance in words betw een the $k$-th and the $k+1$-th occurrence of the $m$ arker) then $h_{i} j^{i} / i_{j}$, where $i j$ is the $K$ roeneker delta. U nder these conditions each event carries the sam e am ount of inform ation. The statistical independence of di erent lam inar regions $m$ eans that the inform ation carried by the events is $m$ axim al for a given waiting tim e distribution ( ). In a linguistic jargon, we can say that if in a conpus we nd a $m$ arker (e.g. a list of words) such that $\quad 1=(1)$ then this $m$ arker is in form ative in that corpus. If the $m$ arkers are not inform ative, this im portant condition is violated. $W$ e shall see hereby that certain $m$ arkers, e.g. punctuation $m$ arks, are not real events, but are rather m odeled by a $C$ opying $M$ istake $M$ ap (CMM) [16]. This mean that discourse com plex dynam ics are such that, although the punctuation $m$ arks carry long-range correlations, and consequently the anom alous scaling of $p(x ; t)$, the waiting tim es in the lam inar regions determ ined by these $m$ arkers are correlate. P unctuation $m$ arks are not inform ative. T heir com plexity is just a pro jection of a com plexity carried by \concept dynam ics", nam ely, by the really crucial events.
A. The CMM and non-in form ative $m$ arkers

The Copying M istake M ap (CMM) [1]] is a m odel originally introduced to study the anom alous statistics of nucleotides dispersion in coding and non-coding DNA regions. The CM M is a sequence that can be derived from the long-range sequence generated by the wating tim e distribution of Eq. (S), and corresponding to the long-range correlation function of Eq. (IG) as follow s. W e de ne the probabilities $p(1)={ }^{-}$and $p(2)=1$. For any site of the sequence, w th label $i$, we leave the value $i$ unchanged $w$ th probability $p$ (1) and, w ith probability $p$ (2) we assign to it a totally random value (copying $m$ istake).

The resulting wating time distribution undergoes an exponential decay. This is so because the occurrence of a given 1 depends on two distinct possibilities: it can be an loriginal" 1, or an original 0 tumed into 1 by a copying $m$ istake. Form ally, we w rite

W e note that rand $(t)$ and, consequently, rand $(t)$ undergo an exponentialdecay. So it does, in the asym ptotic lim it, the function exp $(t) . W$ hat about the $D E$ curve? The theory predicts [1] $]_{1}$ a random ( $=0: 5$ ) behavior for short tim es, a knee, and a slow transient to the totally correlated behavior. An exam ple of CM M is given by punctuation $m$ arks in $N$ atural Language. W e choose punctuation $m$ arks as $m$ arkers for an Italian corpus of new spaper and magazines, ofm ore than 300,000 w ords length, called Italian T reebank (hereafter TB).W e assign the value 0 to any w ord that is not a punctuation $m$ ark, and 1 when it is, nam ely to full stops, com $m$ as, etc. A sentence like \Felix, the cat, sleeps!" is therefore transform ed into \0100101".

Figs. II ( $\mathrm{a}, \mathrm{b}$ and c) show that the choice of these $m$ arkers yield a tim e series $w$ ith the typical properties of a CM M sequence. This $m$ eans that the waiting tim es $k$ are correlated. A ccording to section $1 A$ this $m$ eans that puntuation $m$ arks are not crucialevents. N otice how ever that the use of the D E m ethod detects an anom alous scaling param eter
. This $m$ eans that there are hidden crucialevents and that they generate an in nitely extended $m$ em ory.

## B. C oncepts as in form ative $m$ arkers

$M$ ore experim ents, not reported here, show that the CMM behavior is typical form any characters, and are shared by all the letters of the alphabet, w ith a $0: 6.0$ bviously, If the $m$ arker is a given letter, the role of tim e is played by the ordinal num ber of typographical characters in the text. W e note that in Italian the alphabetic characters m irror phonetic. Thus, it is worth of linguistic interest to $m$ ove from a phonetic to a m orphosyntacticallevel. To do so, a text has to be lem $m$ atized and tagged $w$ ith respect to its part of speech. A fter this procedure we can identify as a $m$ anker the occurrence ofa certain part of speech e.g. article, adverb, adjective, verb, noun, preposition, num eral, punctuation etc.). For instance, the sentence \Felix, the cat, sleeps!" is now transform ed into $\backslash \mathrm{N} P \mathrm{R} N \mathrm{P}$ V P ", where $N$, $P$, $R$ and $V$ stand for nouns, punctuation, article and verb. If we select a verb as a marker, we have \0000010". Fig 3 show $s$ the result of this experim ent for verbs and for num erals. $W$ e notioe that both cases lead to the sam e asym ptotic behavior of the D E , but to com pletely di erent behavior of the waiting-tim es distribution ( $t$ ) (where $t$ is the num ber of words betw een $m$ arkers). W e notice that $D E$ reveals a long-tim e $m$ em ory in both cases. As to (t), it show $s$ an exponential truncation at long tim es, in both cases. H ow ever, in the case of num erals we nd an extended transient with a slope num erals < 2 , corresponding to the non-stationary, as pointed out in the rst part of the introduction. $T$ his is in fact due to the uneven distribution of num erals in the corpus, since they are encountered $m$ ore often in the econom ic part of the Italian new spapers. A $s$ incom plete as this analysis is, yet it reveals that num erals reveals carry $m$ ore inform ation than phonetic $m$ arkers or even than the verbs, used as $m$ arkers. This is linguistically interesting, since num erals denote a part of speech, but also a \sem antic class".
$W$ e are therefore led to suppose that in form ative $m$ arkers are the ones associated $w$ ith a sem antically coherent class of words. This is how ever a problem, since every single concept is too rare in a balanced conpus (a long text w ith a variety of genres). T he next levelofour exploratory search for events is therefore to look for the occurrence of \salient words" in a specialist text. Such a corpus has been m ade available as the Italian corpus relative to the European pro ject POESIA [18] . POESIA is a E uropean U nion funded pro ject whose aim is to protect children from o ensive web contents, like, e.g. pomography in W W W URLs. Salient \pomographic" words were autom atically extracted by com paring their frequency in an o ensive conpus, to the frequency of their occurrence in the balanced TB conpus earlier used. T he de nition adopted was

where $f_{E C}$ (l) is the frequency, in the erotic conpus, of the lem mal, and $f_{T B}$ (l) is the sam e property in the reference Italian conpus (Italian $T$ reebank). Salient lem $m$ ata were autom aticaaly chosen as the $5 \% \mathrm{w}$ th the highest value of $s$. $N$ otioe that in this experim ent all \dirty" w ords are not taken into consideration, because they do not appear in the reference corpus, and therefore $s=1$, but, in e ect, cannot be properly de ned, especially for extrem ely rare words. $H$ ow ever an o ensive $m$ etaphoric use of term $s$ is in fact detected, leading to a com pletely new way to autom atic text categorization and lter [1]

Salient words w ere therefore used as $m$ ankers for our analysis, as earlier described. T he results are shown in $F$ ig. 4 , clearly show ing that in a specialized conpus, salient words of this gen re, pass the test of inform ativeness. Salient

words, and plausibly words in general, are therefore distributed like m arkers generated by an interm ittent dynam ical model, w ith $2: 1$ and, in agreem ent w ith ( ${ }^{(6)}$ ), $\quad 1=(\quad 1)=0: 91 . \mathrm{W}$ e see in the next section how this behavior is plausibly connected w ith a topological com plexity at the paradigm atic level, and in Section III we derive the Z ipf's law from the resulting $m$ odel.

## III. SCALEFREENETWORKS, INTERMITTENCYANDTHEZIPF'S LAW

In this section we outline a cognitive $m$ odel that serves the punpose of connecting structure and dynam ics. A llegrini et al. [20] identi ed sem antic classes in the Italian conpus, by looking at paradigm atic properties of interchangeability of classes of venbs w ith classes of nouns. T hey de ned \super-classes" of verbs and nouns as \substitutability islands", nam ely groups ofnouns and verbs sharing the properties that in the conpus you nd each verb ofthe class co-occurring,

in a context, w ith each noun of the class [20 $\left.{ }^{2}\right]$. This is precisely a direct application of the notion of $\backslash$ paradigm ". Let us call $p_{v}$ (c) and $p_{n}$ (c), respectively, the num ber of verbs or nouns belonging to a num ber cof classes. They found that

W orking along the sam e lines, other authors $\left.\overline{[ } \overline{2}_{1}^{1}\right]$ found a $\backslash \mathrm{sm}$ all w orld" topology $\left.\overline{\underline{2}} \overline{2} \overline{2}\right]$, by looking at the num ber of synonym s in an English thesaurus, for each English lem ma.W e therefore assum e that this kind of structure is general for any language. Let us therefore im agine that the paradigm atic structure of concepts is a scale-firee netw ork and
consider a random walk in this \cognitive space". Let us make the follow ing assum ptions:

N ow we im agine that selecting a concept m eans selecting a few neighbouring nodes. This collection of nodes, due to the scale-free hypothesis, shares the sam e scaling properties as the com plete scale free netw ork, nam ely p (c) c . $T$ herefore we have that

At this stage, deriving the Zipf's law f / ra, with a close to unity, becom es a simple exercise Let us de ne frequency probability $P$ (f)

$N$ ext, let us notioe that $P(f)$ m ust be a stable distribution. In fact, the $Z$ ipf's law is valid for every conpus. In particular, if it is valid for corpus A and for conpus B, it is valid also for the conpus A $+B$, where $+m$ eans the concatenation of compora. If we keep going on w ith this concatenating process, we shall have a conpus

ie., the G eneralized C entral Lim it Theorem [23] applies. This means that the probability of frequency $P$ ( $f$ ) is a Levy -stable distribution. This probability of nding $f$ occurrences of a word in a corpus of a given length can be identi ed w ith $p(x ; t)$ of Section II, if we take into proper consideration the length $t$ as a param eter. W e have earlier notioed that $p(x ; t)$ in language is Levy process, with 1 , and therefore $w$ ith a tail $P(f) f^{2}$. In other words

IV. CONCLUSIONS

W e have identi ed the cognitive process goveming hum an language, and proved it to be com plex at both syntagm atic and paradigm atic level. A though the study is conducted on Italian written conpora, we are inclined to believe that the property found is language independent, general and im portant, as em erging from a decade of studies on the $Z$ ipf's law. Thus, we nd that each concept corresponds to a scaling close to $=1$, this being consistent w th the Z ips law. The com plexity of language is located at the border betw een the stationary ( $>2$ and non-stationary ( < 2) condition [i] $[$. A s pointed out in Section 1A, we adopt the perspective of com plexity as a condition of transition from dynam ics to them odynam ics. W ithin this perspective, we notice that, although the condition $>1 \mathrm{~m}$ eans aging $\mathbb{R}$ and a transition from dynam ic to therm odynam ics in a virtually in nite tim $e$, a therm odynam ic condition exists, and di usion process tends to approach the scaling regim ewith $t$ ! 1 . In the case $<2$, no them odynam ic condition exists, and the stationary condition cannot be realized, not even ideally. W e see that specialist texts are located w ithin the ergodic regim e ( $=0: 91$ in the experim ent illustrated in this paper). W e are convinced that this is a sign of the fact that language rests on the subtle balance betw een tw o opposite needs, leamability, which is the property consenting a child to leam a language, and variability, nam ely the need of exploring a virtually in nite cognitive space. Thus we are convinced that the results of this paper $m$ ight help to understand the language com plexity and evolution in children during the leaming years, and in psychopathologicalsub ject. T hus we propose its use for fiuture research w ork that $m$ ight lead to the understanding of certain $m$ ental diseases $w$ ith no recourse to invasive diagnostic m ethods.

W e think that the results of this paper $m$ ight also help understanding the com plexity of really living system $s$. W e have seen that a random walk through the netw ork, w ith the scale-free hypothesis generates $m$ em ory and long-range correlation. The speaker sets concepts in a tem poral order, but this corresponds to complex relations in a nonlinear space. W e argue that a sim ilar $m$ echanism $m$ ay also be chosen by really living system $s$. Thus, the relational interconnectivity ofchem icals in the living cellm ay depend on the long-range $m$ em ory of the cell finction, or in uence it. From a Language Engineering point of view, this study provides a theoretical background for a com pletely new strategy of autom atic text categorization. A prototype is being im plem ented as a sem antic ler [1] $\overline{1}]$. W e think that the proposed test for inform ativness for a set of $m$ arkers $w$ ill be bene cialm ore in general for the analysis of tim $e$ series.

Finally, we want to stress that the $m$ ethod successfiully adopted in this paper to establish the inform ation content of $m$ arkers, or labeled values, of the tim e series, $m$ ight have possible applications to the war against terrorism. In fact, if the intelligence com $m$ unity a ords suggestions on the possible crucialw ords of a new wave of terrorist attack, the adoption of this $m$ ethod allow $s$ an autom atic $w$ ay to identify the $m$ essages $w$ ith a terrorist content, $m$ ore or a less in the sam e w ay here illustrated to lter text w ith a pomographic content.
