Interm ittency and scale-free networks: a dynam ical m odel for hum an language com plexity

In this paper we try to model certain features of hum an language complexity by means of advanced concepts borrowed from statistical mechanics. We use a time series approach, the di usion entropy method (DE), to compute the complexity of an italian corpus of new spapers and magazines. We nd that the anom alous scaling index is compatible with a simple dynamical model, a random walk on a complex scale-free network, which is linguistically related to Saussurre's paradigms. The network complexity is independently measured on the same corpus, looking at the co-occurrence of nouns and verbs. This connection of cognitive complexity with long-range time correlations also provides an explanation for the fam ous Zipf's law in terms of the generalized central lim it theorem.

I. IN TRODUCTION

This introduction is divided into two parts, the form er being devoted to a general discussion concerning the challenging issue of the search for crucial events, in general. The second is of linguistic interest. This division re ects the twofold purpose of this paper. In fact, the main result of this paper is the foundation of the Zipf' law, a subject of theoretical interest to understand the origin and evolution of language [1]. The foundation of this in portant empirical rule is here discussed from a special perspective. This is the perspective of com plexity conceived as a new condition of physics. Of course, this condition is not expressed by regular dynam ics, and it is not expressed by therm odynam ics, either. This is rather a regime of transition from dynam ics to therm odynam ics lasting for a virtually in nite time, so as to realize a new legitim ate state of physics, a ording a perspective valid also in the case of non-physical system s. A paradigm for this condition is given by the renew altheory processes [2]. Thus, we make use of the renew altheory to de ne the concept of crucial events.

In conclusion, the rst purpose of this paper is to contribute the progress of a statistical method for the search of crucial events, using written texts as an illustration of the method. On this important issue we do not reach conclusive results but the formulation of a conjecture for future work. However, we note that the linguistic results rest on a general approach to the detection of rare and signi cant events. This general approach to the detection of crucial events might yield useful applications to m any elds, from the early diagnosis of diseases to the war against terrorism. Thus, we devote the rst part of the introduction to the de nition of crucial events. The second part of the introduction serves the purpose of introducing the reader to the ideas and jargon of linguistics, so as to fully appreciate the main result of this paper, which is, in fact, of linguistic interest.

A. De nition of crucial events

Let us consider a generic time series. This is a sequel of values occurring at di erent times and m irroring the properties of a given complex system, this being either the heart-beating β , seism ic m ovem ent [4], or a w ritten text, as in this paper. Let us label, or m ark, some of these values with a given criterion, which depends, of course, on the conjectures that we m ake about the process under study. Labeling a value in plies that we judge it to be signi cant. Thus, it is evident that the m ore we know about the process, the m ore plausible the conjecture behind the labeling criterion adopted. To give some illustrative example, let us mention some of the criteria recently adopted. In the case of heart-beating β , we are observing the time distances T between a R peak and the next, which for a very large num bers of beats t becomes equivalent to a continuous function, T (t), of a continuous variable t. W e divide the ordinate axis into small interval of size s, and we record, or m ark, the beats at which T (t) m oves from one strip to another. In the case of a written text, as explained later in this paper, we m ark the salient words, these being the words that in a given text appear with a frequency larger than in a suitable reference text.

Now we have to address the important issue of establishing whether the labeled values are crucial events, or not. This, in turn, requires that we de ne what we mean by crucial event. Let us de ne ist the crucial events by mean

of their statistical properties. Then we shall explain why events with these statistical properties must be considered crucial. We use the prescriptions illustrated in the fundam ental paper of Ref. [5]. We assign the sym boll to all the marked values and the sym boll to the others. Then we convert the time series into a set of random walks with the method detailed in Ref. [5]. We use the walking rule that the walker makes a step ahead by the quantity 1 any time we meet a marked value, namely, the sym boll. When we meet the sym boll the walker remains in a state of rest. The marked values are much less numerous that the unmarked values. Thus, we shall have many 0's and a few 1's. A sequence of many 0's between two 1's is term ed a lam inar region. It is important to evaluate the time distance between one marked value and the next, which is equivalent to determining the distribution of the time distribution the lam inar regions. This will result in a time distribution (t). Let us assume that the waiting time distribution

(t) is an inverse power law with index . The Poisson case corresponds to = 1. Then we study the resulting di usion process and we establish its scaling parameter. If the index to the condition 2 < < 3 and it is related to the scaling coe cient by the relation = 1 = (1), or, if the scaling index to the condition > 3 and the scaling coe cient has the ordinary value = 0.5, the labelled values are crucial events.

Let us explain the physical motivation for this de nition. First, meeting a 0 is not signi cant because the 0's are closely correlated and meeting one of them in plies that that we shall meet many other 0's, before nding a 1 again. In a sense the 0's are driven by the 1's. A given 1 is the beginning of a lam inar region and, consequently, of a cascade of 0's. On the other hand, if and violate the relations for the 1's to be crucial, there m ight exist a correlation between two di erent lam inar regions. This suggests that the 1's m ight be part of a predictable cascade of some other genuinely crucial events, not yet revealed by the statistical analysis, and that our conjecture is not correct.

We have to explain why < 1 is an important condition for our de nition of crucial events. We limit ourselves to noticing [6] that = 1 is equivalent to setting Poisson statistics, implying, in turn, a mem oryless condition that seem s to be incompatible with the labelled values to be crucial. This is a poorly understood property, in spite of the fact that 32 years ago Bedeaux, Lindenberg and Shuler [7] wrote a clarifying paper on this subject. We refer the reader to this fundam ental paper[7] to understand the reasons why we in agine the crucial events to be incompatible with Poisson statistics. A ctually, the labelled values seem to become crucial when the di usion process they generate is anom abus, namely > 0.5, which implies < 3. It has to be pointed out that < 2 implies a condition where the mean length of the lam in ar region is in nite. This means that in this region the process becomes non-stationary, due to the lack of an invariant measure [8]. From an intuitive point of view, the origin of non-stationary behavior is as follows. If we keep drawing random number from the distribution (t), the mean value of t tends to increase with the number of drawings. This is so because, if it did not increase the overallm ean value would be nite, in con ict with the fact that < 2 produces an in nite mean value. Thus the condition = 2 is the border between the stationary,


> 2, and the non-stationary condition, < 2. A swe shall see, this border has an interesting meaning for linguistics. It would be an interesting issue to assess whether crucial events can be located in this region. We lim it ourselves to noticing that the results of the statistical analysis of time series seem to denote that complex system s are characterized by values of very close to the border without ever entering the non-stationary dominion < 2. In conclusion, with the prescription of Ref. [5] we are in a position to assess if the marked values correspond to crucial events, or do not.

B. The meaning of Zipf's law in linguistics

Sem jotics studies linguistic signs, their meanings, and identi es the relations between sign and meaning, and among signs. The relations am ong signs (letters, words), are divided into two large groups, nam ely the syntagm atic and the paradigm atic, corresponding to what are called Saussurre's dim ensions [9]. A clearcut de nition of the two dim ensions is outside the scope of this paper, but one can grasp an understanding of them by looking at Fig. 1. The abscissa axis represents the syntagm atic dimension, while the ordinate axis represents the paradigm atic one. A long the abscissa certain grammatical rules pose constraints on how words follow each other. We can say that this dimension is tem poral, with a casual order. An article (as \a" or \the"), for instance, m ay be followed by an adjective or a noun, but not by a verb of nite form . At a larger \time-scale", pragmatic constraints rule the succession of concepts, to give a logic to the discourse. The other axis, on the other hand, refers to a \m ental" space. The speaker has in m ind a repertoir of words, divided in m any categories, which can be hierarchically com plex and refer to syntactical or sem antic \interchangeability". Di erent space-scales of word paradigm s can be associated to di erent levels of this hierarchy. A fler an article, to follow the preceding example, one can choose, at a syntactical level, am ong all nouns of a dictionary. However, at a deeper level, sem antic constraints reduce the avalaible words to be chosen. For instance, after \a dog" one can choose any verb, but in practice only am ong verbs selected by sem antic constraints (a dog runs or sits, but does not read or sm oke). The sentence \a dog graduates", for instance, ts paradigm atic and syntagm atic rules behind Fig. 1, but the sem antics would in general forbid the production of such a \nonsensical" sentence.

The two dimensions are therefore not quite orthogonal, and connect at a cognitive level. The main focus of this paper is to show that this connection, which is well known at a short scales, is in fact reproduced at all scales. We will

also show that both dimensions are scale free and that the very complexity of linguistic structures in both dimensions can be taken into account in a uni ed model, which is able to explain most statistical features of hum an language, including, at the largest scales, the celebrated Zipf's law [10].

Z ipf's law, which relates the rank r of a words to its frequency f in a corpus, obviuosly points to constraints on the frequencies of words. R em arkably, this does not m ean that the probability of a word is actually de ned. In fact, a word m ay have a sm allor large frequency depending on the genre of the corpus (i.e. a large collection of written text) under study, and even two extrem ely large corpora of the sam e type fail in reproducing the sam e word frequencies. It is how ever rem arkable that the occurrence of words is such that for any corpus and for any natural language the sam e universal property em erges, this being that there are only a few frequent words and there are, on the contraty, m any words that are encountered, for instance, only once or twice. To be m ore precise, let us de ne word rank r, which is a property depending on the corpus adopted, as follows. O ne assigns rank 1 to the m ost frequent word, rank 2 to the second frequent one, and so on. E ach word is uniquely associated to a rank, and, although this num ber varies form corpus to corpus, one always nds that

We shall derive this law from a complexity model of language, along the following lines. We recognize that there is no experimental linguistic evidence that word frequencies tend to well-de ned probabilities. However, we adopt a probabilistic approach, namely, we assume that there exists, for a random ly selected word, the probability of having the frequency f, denoted as P (f). O peratively, we measure P (f) by counting how many words have a certain frequency f. In Section III we show that a P (f) compatible with the Zipf's law can be directly derived from the model proposed herein, thus providing a solid experimental support to our model. In order to full lour program, we shall assume a long-range statisticalm utual independence for the occurrence of di erent concepts. This hypothesis is appealing, since this assumption means that every and each occurrence of a concept makes entropy increase, and therefore we identify the mathematical information (i.e. entropy) with the common-sense information (i.e. the occurrence of concepts). Unfortunately, a concept is not, a priori, a wellde ned quantity. Herein we shall assume that concepts are represented by words (or better by lemmata) or by groups of semantically similar words or lemmata [25].

Because of the mutual independence among di erent concepts, we can extract from a single corpus as many \experiments" as the number of concepts. For each experiment we select only one concept and we mark the occurrence of the selected word or group of words corresponding to this concept. We shall use an advanced time-series analysis to study the statistical properties of the dynam ical occurrence of the markers. In fact, as mentioned in the rst part of this introduction, we adopt the DE method [5], which has been proved by earlier investigation [3, 4] to be an elient way to detect the statistics of crucial events. We shall discover the important result that the adoption of DE method allow s us to assess whether a given set of \markers" can be identied with the crucial events or the crucial events are still unknown and we must consequently search for a di erent set of markers.

The results of the experiments will lead to a language model reproducing the language \com plexity", namely a com bination of order and random ness at all scales. The overall dynamics, given by the ow of concepts over time,

resemble the dynam ics of interm ittent dynam ical systems, like the M anneville's M ap [11]: These systems have long periods of quiescence followed by bursts of activity. This variability of waiting times between m arkers of activity is responsible for long-range correlations.

A further aspect of the paper is the connection between space and time complexity, and its application to linguistics. We shall assume that atom is concepts exist and represent nodes of a complex network, connected by arcs representing, when existing, sem antic associations between a concept and another. We assume that our markers are actually de ned as a group of neighbor nodes. We then assume that language is the result of a random walk, namely a random \associative" travel from concept to concept. The scale-free properties of this network, independently measured by several research groups, including ours, provides a bridge to understand the interm ittent dynam ics earlier described. In this uni ed model the network is a representation of Saussurre's paradigm s, whose com plexity m irrors the syntagm atic one in the asymptotic limit.

II. DE AND CONCEPTS

Several papers have recently proposed a new way of detecting long-range e ects of non-Poisson statistics [4, 5, 12, 13, 14]. In short, as mentioned in the nst part of Section 1, we de ne a set of m arkers" among the symbols or values of a time series, and we evaluate num erically the probability of having a number x of markers in a window of length t, denoted as p(x;t). This statistical analysis is done by moving a window of length t along the sequences and counting how m any times one nds x markers inside this window. Finally, p(x;t) is obtained by dividing this number by the total number of windows of size t, namely by N t+ 1, where N is the total length of the sequence. Since we typically deal with large values of both x and t, we legitim ately adopt a continuous approximation. M oreover, we make the ergodic and stationary assumption, thereby expecting the emergence at long times of the scaling condition expressed by

where w is the overall probability of observing a marker, is the scaling index and F is a function, sometimes called m aster curve". If F is the G auss function, is the known Hurst index, and if the further condition = 0.5 is obeyed, then the process is Poisson, the variable x undergoes ordinary B rownian di usion. A coording to Ref. [7] the occurrence of markers in time is regulated by random uctuations, and the di usion process occurs with nomemory. It straightforward to show that the Shannon Information

It straightforward to show that the Shannon Information

with condition (2) leads to

where k is a constant. The evaluation of the slope according to which S increases with ln t provides therefore a measure for the anom alous scaling index \cdot .

Let us brie y mention what we know about applying DE to time series with non-Poisson statistics. We derive from the time series under study an auxiliary sequence, by setting $_i = 1$ (this means that we nd the marker at the ith position), or $_i = 0$ (the i-th symbol, or value, is not a marker). We then assume \inform ativity" for the markers. As explained in the rst part of Section 1, this means that we assume the markers to be crucial events, and, that, consequently, the distance between a given 1" and the next does not depend on the distance between this given 1 and the preceding one. A smentioned earlier, if the lengths t of the lam inar regions are distributed as

((t) t asymptotically is a su cient condition), then the theory based on CTRW and GCLT yields for p(x;t) a truncated Levy probability distribution function (PDF) [5]. DE detects the approximate scaling of the central part, namely

We note that p(x;t) is abruptly truncated by a ballistic peak at x = 0 representing the probability of nding no marker up to time t. However, the di usion entropy increase is essentially determined by the occurrence of crucial events, thereby leading to the scaling of Eq. (6).

It is worth explaining why the condition 2 < < 3 m eans long-range m em ory. The st, and probably easier way, is based on observing that truncated Levy probability distribution p(x;t) yields:

thereby leading, as shown in Ref. [15], to the correlation function

Note that the memory stemming from the non-Poisson nature of markers, corresponds in this case to a non-integrable correlation function, which is therefore a clear signal of in nite memory. In the Poissonian case this correlation function would be exponential, thereby indicating a much shorter memory.

There exists a second, and m one in pressive way, of relating the non-Poisson distribution of waiting times to m em ory, according to the st part of Section 1. We are observing the uctuations of a dichotom ous variable , with = 1 implying the occurrence of a crucial event, and = 0 the non-occurrence of events. If the role of time is played by the ordinal number of words, we shall show that a good choice of sem antic markers makes Eq. (5) become a good model for the dynam ics of concept of natural language. The occurrence of Poisson statistics would mean, according to Ref. [7], that the time evolution of markers is driven by uctuations that are identical to white noise. In conclusion, Poisson statistics would be totally incompatible with the existence of any form of memory. The exponential decay of the correlation function of Eq. (8) would not be a short-time memory, but it would signal the complete lack of memory. The long-range correlation corresponding to < 3, on the contrary, is a clear manifestation of the in nitely extended memory of a text, associated to the strikingly non-Poisson character of the waiting time distribution of Eq.(5).

Eq. (6) [5] rests on uncorrelated waiting times between events. This means that if two markers are separated by intervals of words of duration $_{k}$ (the distance in words between the k-th and the k + 1-th occurrence of the marker) then h $_{i \ j}i / _{ij}$, where $_{ij}$ is the K meneker delta. Under these conditions each event carries the same amount of information. The statistical independence of di erent lam inar regions means that the information carried by the events is maximal for a given waiting time distribution (). In a linguistic jargon, we can say that if in a corpus we nd a marker (e.g. a list of words) such that 1=(1) then this marker is informative in that corpus. If the markers are not informative, this important condition is violated. We shall see hereby that certain markers, e.g. punctuation marks, are not real events, but are rather modeled by a Copying M istake M ap (CMM) [16]. This mean that discourse complex dynam ics are such that, although the punctuation marks carry long-range correlations, and consequently the anom alous scaling of p(x;t), the waiting time is in the lam inar regions determ ined by these markers are correlate. Punctuation marks are not informative. Their complexity is just a projection of a complexity carried by \concept dynam ics", nam ely, by the really crucial events.

A. The CMM and non-inform ative m arkers

The Copying M istake M ap (CM M) [16] is a model originally introduced to study the anomalous statistics of nucleotides dispersion in coding and non-coding DNA regions. The CM M is a sequence that can be derived from the long-range sequence generated by the waiting time distribution of Eq. (5), and corresponding to the long-range correlation function of Eq. (8) as follows. We deen the probabilities p(1) = and p(2) = 1. For any site of the sequence, with label i, we have the value i unchanged with probability p(1) and, with probability p(2) we assign to it a totally random value (copying m istake).

The resulting waiting time distribution undergoes an exponential decay. This is so because the occurrence of a given 1 depends on two distinct possibilities: it can be an \original" 1, or an original 0 turned into 1 by a copying m istake. Form ally, we write

We note that $_{rand}$ (t) and, consequently, $_{rand}$ (t) undergo an exponential decay. So it does, in the asymptotic limit, the function $_{exp}$ (t). What about the DE curve? The theory predicts [17] a random (= 0.5) behavior for short times, a knee, and a slow transient to the totally correlated behavior. An example of CMM is given by punctuation m arks in N atural Language. We choose punctuation m arks as m arkers for an Italian corpus of new spaper and m agazines, ofm ore than 300,000 words length, called Italian Treebank (hereafter TB). We assign the value 0 to any word that is not a punctuation m ark, and 1 when it is, namely to full stops, com m as, etc. A sentence like \Felix, the cat, sleeps!" is therefore transform ed into \0100101".

Figs. II (a,b and c) show that the choice of these markers yield a time series with the typical properties of a CMM sequence. This means that the waiting times $_k$ are correlated. A coording to section 1A this means that puntuation marks are not crucial events. Notice how ever that the use of the DE method detects an anom alous scaling parameter . This means that there are hidden crucial events and that they generate an in nitely extended memory.

B. Concepts as inform ative m arkers

M ore experiments, not reported here, show that the CMM behavior is typical form any characters, and are shared by all the letters of the alphabet, with a 0:6.0 by journers of the marker is a given letter, the role of time is played by the ordinal num ber of typographical characters in the text. We note that in Italian the alphabetic characters m irror phonetic. Thus, it is worth of linguistic interest to move from a phonetic to a morphosyntactical level. To do so, a text has to be kem m atized and tagged with respect to its part of speech. A fler this procedure we can identify as a m arker the occurrence of a certain part of speech e.g. article, adverb, ad jective, verb, noun, preposition, num eral, punctuation etc.). For instance, the sentence \Felix, the cat, sleeps!" is now transform ed into \N P R N P V P", where N, P, R and V stand for nouns, punctuation, article and verb. If we select a verb as a marker, we have \0000010". Fig 3 shows the result of this experiment for verbs and for numerals. We notice that both cases lead to the same asymptotic behavior of the DE, but to completely di erent behavior of the waiting-times distribution (t) (where t is the number of words between markers). We notice that DE reveals a long-time memory in both cases. As to (t), it shows an exponential truncation at long times, in both cases. However, in the case of numerals we nd an extended transient with a slope numerals < 2, corresponding to the non-stationary, as pointed out in the rst part of the introduction. This is in fact due to the uneven distribution of num erals in the corpus, since they are encountered more offen in the econom ic part of the Italian new spapers. A s incom plete as this analysis is, yet it reveals that num erals reveals carry m ore inform ation than phonetic m arkers or even than the verbs, used as m arkers. This is linguistically interesting, since num erals denote a part of speech, but also a \sem antic class".

W e are therefore led to suppose that inform ative m arkers are the ones associated with a sem antically coherent class of words. This is how ever a problem, since every single concept is too rare in a balanced corpus (a long text with a variety of genres). The next level of our exploratory search for events is therefore to look for the occurrence of \salient words" in a specialist text. Such a corpus has been m ade available as the Italian corpus relative to the European project POESIA [18]. POESIA is a European Union funded project whose aim is to protect children from o ensive web contents, like, e.g. pornography in W W URLs. Salient \pornographic" words were autom atically extracted by com paring their frequency in an o ensive corpus, to the frequency of their occurrence in the balanced TB corpus earlier used. The de nition adopted was

where f_{EC} (1) is the frequency, in the erotic corpus, of the lem m a l, and f_{TB} (1) is the same property in the reference Italian corpus (Italian Treebank). Salient lem m ata were autom aticaally chosen as the 5% with the highest value of s. Notice that in this experiment all \dirty" words are not taken into consideration, because they do not appear in the reference corpus, and therefore s = 1, but, in e ect, cannot be properly de ned, especially for extrem ely rare words. However an o ensive m etaphoric use of term s is in fact detected, leading to a completely new way to autom atic text categorization and liter [18], using a m ethod, based on DE analysis, called CASSANDRA [19].

Salient words were therefore used as markers for our analysis, as earlier described. The results are shown in Fig. 4, clearly showing that in a specialized corpus, salient words of this genre, pass the test of inform ativeness. Salient




FIG.2: a) D i usion entropy for punctuation marks. The t for the asymptotic limit (solid line) yields a = 0:7. The dashed line marks a transient regime with = 1 b) N on-normalized distribution of waiting times for punctuation marks, namely counts of waiting times of lenght t between marks in TB. The expression for the dashed line t is 7000 exp(t=7:15). c) Second moment analysis for punctuation marks. The expression for the solid line t is 0:06 t^{57} . Notice that 1:57 3 1=0:7, namely the expression H = 3 1= of Ref. [17] for Levy processes stemming from CMM's is veried.

words, and plausibly words in general, are therefore distributed like m arkers generated by an interm ittent dynam ical model, with 2:1 and, in agreement with (6), 1=(1)=0.91. We see in the next section how this behavior is plausibly connected with a topological complexity at the paradigmatic level, and in Section III we derive the Zipf's law from the resulting model.

III. SCALE-FREE NETW ORKS, IN TERM ITTENCY AND THE ZIPF'S LAW

In this section we outline a cognitive m odel that serves the purpose of connecting structure and dynam ics. A llegrini et al. [20] identi ed sem antic classes in the Italian corpus, by looking at paradigm atic properties of interchangeability of classes of verbs with classes of nouns. They de ned \super-classes" of verbs and nouns as \substitutability islands", namely groups of nouns and verbs sharing the properties that in the corpus you nd each verb of the class co-occurring,




FIG. 3: a) DE for verbs (squares) and num erals (circles). The dashed line is a t for the verbs, with = 0.73, while the solid line is a t for the num erals, with = 0.82. b) (t) for verbs (black circles) and num erals (white circles). The dashed line is a t for the num erals, with = 1.2, while the solid line is a t for the verbss, with = 3.8.




FIG. 4: a) DE for salient \enotic" words for a corpus of erotic stories and o ensive web pages (squares), and for the italian reference corpus (circles). The solid line is a twith expression S (t) = $k + \ln (t + t_0)$, where the additional parameter t_0 is added to the original Eq. (3) to take transients into account and to improve the quality of the t, yielding = 0:91 b) N on-norm alized waiting time distribution for salient \erotic" words for a corpus of erotic stories. The expression for dashed line t is 14000 (12:0 + t)^{2:1}, yielding = 2:1.

in a context, with each noun of the class [20]. This is precisely a direct application of the notion of paradigm ". Let us call p_v (c) and p_n (c), respectively, the number of verbs or nouns belonging to a number c of classes. They found that

W orking along the same lines, other authors [21] found a \sm allworld" topology [22], by looking at the num ber of synonym s in an English thesaurus, for each English lem m a. W e therefore assume that this kind of structure is general for any language. Let us therefore in agine that the paradigm atic structure of concepts is a scale-free network and

consider a random walk in this \cognitive space". Let us make the following assumptions:

The statistical weight of the i-th node is $!_i c_i$

The dynam ics of the system is ergodic so that the characteristic recurrence time is $_{i}$ c_{i}^{1}

The above properties hold for all nodes, with the same functional form for the recurrence time distribution, e.g. $_{i}(t) = (1 = _{i}) \exp((t = _{i}))$

Now we imagine that selecting a concept means selecting a few neighbouring nodes. This collection of nodes, due to the scale-free hypothesis, shares the same scaling properties as the complete scale free network, namely p(c) = c. Therefore we have that

Thus, we recover the interm ittent m odel of Eq.(5).

At this stage, deriving the Zipf's law f / r^{a} , with a close to unity, becomes a simple exercise Let us de ne frequency probability P (f)

Next, let us notice that P (f) must be a stable distribution. In fact, the Zipf's law is valid for every corpus. In particular, if it is valid for corpus A and for corpus B, it is valid also for the corpus A + B, where + m eans the concatenation of corpora. If we keep going on with this concatenating process, we shall have a corpus

Thus, the frequency of a word in the total corpus, f_{tot} , is written in terms of the single frequencies f_1 , f_2 , :::, and of total lengths N₁, N₂, ::: of the single corpora, as follows

i.e., the Generalized Central Limit Theorem [23] applies. This means that the probability of frequency P (f) is a Levy -stable distribution. This probability of noding f occurrences of a word in a corpus of a given length can be identied with p(x;t) of Section II, if we take into proper consideration the length t as a parameter. We have earlier noticed that p(x;t) in language is Levy process, with 1, and therefore with a tail P (f) f². In other words through (14) we recover (1) i.e. the Zipf's law.

IV. CONCLUSIONS

We have identied the cognitive process governing hum an language, and proved it to be complex at both syntagmatic and paradigm atic level. A lthough the study is conducted on Italian written corpora, we are inclined to believe that the property found is language independent, general and in portant, as emerging from a decade of studies on the Zipf's law. Thus, we nd that each concept corresponds to a scaling close to = 1, this being consistent with the Zips law. The complexity of language is located at the border between the stationary (> 2 and non-stationary (< 2) condition [8]. A spointed out in Section 1A, we adopt the perspective of com plexity as a condition of transition from dynam ics to therm odynam ics. Within this perspective, we notice that, although the condition > 1 m eans aging [24] and a transition from dynam ic to therm odynam ics in a virtually in nite time, a therm odynam ic condition exists, and di usion process tends to approach the scaling regime with t! 1. In the case < 2, no therm odynamic condition exists, and the stationary condition cannot be realized, not even ideally. We see that specialist texts are located within the ergodic regime (= 0:91 in the experiment illustrated in this paper). We are convinced that this is a sign of the fact that language rests on the subtle balance between two opposite needs, learnability, which is the property consenting a child to learn a language, and variability, namely the need of exploring a virtually in nite cognitive space. Thus we are convinced that the results of this paper m ight help to understand the language com plexity and evolution in children during the learning years, and in psychopathological subject. Thus we propose its use for future research work that m ight lead to the understanding of certain m ental diseases with no recourse to invasive diagnostic methods.

We think that the results of this paper m ight also help understanding the com plexity of really living system s. We have seen that a random walk through the network, with the scale-free hypothesis generates mem ory and long-range correlation. The speaker sets concepts in a temporal order, but this corresponds to com plex relations in a non-linear space. We argue that a similar mechanism may also be chosen by really living system s. Thus, the relational interconnectivity of chem icals in the living cellm ay depend on the long-range mem ory of the cell function, or in uence it. From a Language Engineering point of view, this study provides a theoretical background for a com pletely new strategy of autom atic text categorization. A prototype is being in plemented as a sem antic liter [18]. We think that the proposed test for inform ativness for a set of markers will be bene cial more in general for the analysis of time series.

Finally, we want to stress that the method successfully adopted in this paper to establish the information content of markers, or labeled values, of the time series, might have possible applications to the war against terrorism. In fact, if the intelligence community a ords suggestions on the possible crucial words of a new wave of terrorist attack, the adoption of this method allows an automatic way to identify the messages with a terrorist content, more or a less in the same way here illustrated to liter text with a pornographic content.
