A bstract

We investigate the sensitivity of production rates (activities) of the regulatory proteins CI (repressor) and C ro at the right operator (O_R) of bacteriophage lambda. The DNA binding energies of CI, Cro, and RNA polymerase are perturbed to check the uncertainty of the activity, due to the experim ental error, by m eans of a com putational scattering m ethod according to which the binding energies are simultaneously chosen at random around the literature values, with a width corresponding to the experim entalerror. In a grand canonicalensem ble, with the random ly drawn protein-DNA binding energies as input, we calculate the corresponding activities of the promoters P_{RM} and P_R . By repeating this procedure we obtain a m can value of the activity that roughly corresponds to wild-type (unperturbed) activity. The standard deviation emerging from this scheme, a m easure of the sensitivity due to experimental error, is signi cant (typically > 20% relative to wild-type activity), but still the prom oter activities are su ciently separated to make the switch feasible. We also suggest a new compact way of presenting repressor and C ro data.

Introduction

The situation is simple: we know the genes, but we do not know how they are regulated or transcribed precisely. To understand how genetic networks behave

appears a m a jor challenge in the \post genom ic" era.¹ An example of a class of sm all genetic networks, often suitable for theoretical modeling, are the so-called genetic sw itches. Shortly explained, a genetic (regulatory) sw itch is a system consisting of a DNA region (operator) and regulatory protein (s) that are able to bind to this operator in order to foster or inhibit the transcription of a certain gene of the DNA.² Several genetic sw itching system s have been studied extensively, e.g., the tryptophan repressor and the laco perion in E. coli (procaryotic system s),³ and regulation of the galgenes in yeast⁴ (eucaryotic system s).⁴

In this work we want to study the sensitivity upon variations of the protein-DNA binding energies of the right operator (O_R) of bacteriophage lam bda (phage) in respect to experimental error. This operator is in general described elsewhere, e.g., by Ptashne.⁵ In brief, O_R is regulating two in portant genes to either side; cI and crowhich in turn act as a template for the regulatory proteins CI and C ro, respectively. U pon injection of DNA from phage into an E. collibacterium, O_R is crucially in portant to decide the fate of the bacterium. I.e., the switch funnels entry into the dorm ant lysogenic state, or into the lytic state leading to the form ation of new -phages by help of the facilities of the E. coli cell, and, ultimately to the death of the E. coli cell. Partially overlapping the switch are the prom oter regions P_{RM} , that initiates cI transcription, and P_R , that initiates cro transcription.

W e present a new m ethod for analyzing the sensitivity of the activity at the two promoters of O_R , taking into account the experimental error in the experiments used to determ ine the G ibbs free energies (GFEs) of the regulatory proteins and RNA polymerase (RNAP), by simultaneous random perturbations of the GFEs. A new way of presenting repressor data, where C ro data is implicitly given, is also discussed.

M odeling the system

A fundamental assumption in this work is the widely accepted view that the protein-DNA binding/unbinding rates of CI, Cro, and RNAP are in equilibrium, i.e., protein associations with DNA are much faster (fractions of a second) compared with relevant time-scales for protein production and thus activity (seconds).^{6,7,8} In equilibrium, the protein-DNA associations of CI dimers (CI₂), Cro dimers (Cro₂), and RNAP to O_R of phage occur in, presently identied, 40 experimentally distinguishable states. The associated probability f_s for noting the system in one of the 40 states s is^{9,6}

where R = 8:31 J/(m ol K) is the gas constant, T = 310 K is the absolute temperature (37 C), and G (s) is the GFE di erence between state s and the unoccupied state, i.e., protein-DNA binding energy. All concentrations ([X]) refer to the unbound state in solution. i_s , j_s , and k_s are the numbers of CI dimers, C ro dimers, and RNAP bound to O_R in state s, respectively.




Figure 1: a) Scattering of the protein-DNA binding energy G₁ random ly drawn from a Gaussian distribution with mean of -12.5 kcal/mol (horizontal line) and SD of 0.3 kcal/mol (see Table 1). The latter value corresponds to 67% condence intervals in the experiments. b) Corresponding scattering of the activity, due to variations of all GFEs in the same nun, at promoter P_{RM} for $[CI_t] = 200$ nM and zero C ro concentration (typical for a lysogen). Continous horizontal line (| | |) corresponds to wild type activity (0.0081 s¹) and scattered horizontal line (----) corresponds to the mean activity of the 1000 scattered values in this

The di erent G (s) in Eq. (1) are in general a sum of GFE originating from the individual and cooperative bindings of the proteins at the three di erent binding sites of O_R (for details, e.g., see Figure 1 of Shea and Ackers⁷). In this work we apply GFE data of CI from K oblan and Ackers¹⁰ C ro data from D arling et al.¹¹ and RNAP data from Ackers et al.⁶ These binding energies are sum m arized in Table 1.

Table 1: Protein-DNA binding energies (GFEs) for CI from K oblan and A dkers,¹⁰ C ro from D arling et al.,¹¹ and RNAP from A dkers et al.⁶ All GFEs are given in kcal/m ol and lim its () correspond to 67% con ndence intervals. G₁ is the GFE associated with the binding between CI and operator site $O_R I$, etc. (see, e.g., P tashne⁵ for an explanation/illustration of the di erent operator sites). G₁₂ is the GFE associated with coopertaive binding between CI at $O_R I$ and $O_R 2$, etc. GFEs with a prime (e.g., G₁₀) correspond to C ro data, otherwise analogous to CI notation. G_{RM} and G_R are GFEs associated with binding of RNAP to P_{RM} and P_R, respectively. Experimental data are obtained in vitro in 200 mM KCl, resembling \physiological" conditions.^{12,6} CI and C ro are both assumed to obey a monom er-dimer equilibrium in solution where the free energies of dimerization are 11:0 kcal/m ol¹³ and 8:7 kcal/m ol,¹⁴ respectively. In lack of C ro data at 37 C, at which temperature CI and RNAP data are measured, these data are obtained at 20 C.

In Table 2 we list the corresponding 40 di erent states of protein-DNA associations. Throughout this work we have for simplicity assumed a constant free

RNAP concentration of 30 nM $.^7$ Note that in lack of C ro data at 37 C, at which tem perature CI and RNAP data are taken, the C ro data used in the following were obtained at 20 C. It is assumed that the latter data provide a reasonable estim ate for the process at 37 C.

The main purpose of this paper is to study the sensitivity of production rates (activities) with respect to the experimental error of the GFEs. To this end, we assume that the transcription initiation (isomerization rate) is the rate-limiting step in protein synthesis.^{15,16} A coordingly, activity will be dened as the product of isomerization rate times the probability of RNAP occupancy of the promoter. The latter probability is a sum of the f_s in Eq. (1). In what follows, we use the same rate constants as Shea and A deers in enumerating these activities.⁷

Results and discussion

In a previous study we analyzed the sensitivity of O_R through a system atic oneby-one perturbation scheme of the GFEs, with a data set without monom erdimer equilibrium for Cro.¹⁷ Each individual GFE (corresponds to those in Table 1) was perturbed 1 kcal/mol, one-by-one, whereupon the change in activity compared to wild-type (unperturbed) activity was calculated. Bakk et al. show in this work that for a lysogen the sensitivity of the activity is low (upon CI and C ro perturbations), while this sensitivity is increasing for protein concentrations around induction where the -switch is turning over from the lysogenic to the lytic pathway.

The distinct novel feature in this work is that we perform a computational scattering m ethod, where the di erent GFEs are random ly chosen in the param – eter hyperspace and applied in the m odel simultaneously. This im plies that for each GFE (see Table 1), we draw from a Gaussian distribution with standard deviation equal to the experimental uncertainty (indicated by in Table 1).^k Then, 13 new values for the GFE are obtained and the activities at both promoters are then evaluated. This procedure is perform ed 10^3 times, which we checked to be signi cant to ensure reliable statistics, whereupon the mean value (mean) and standard deviation (SD) are calculated from this set. The latter value will rect typical uncertainty of the activities due to the experimental error of the GFEs. Here we de ne the sensitivity of the activity as the ratio between the standard deviation ensuing the computational scattering and wild-type (unperturbed) activity.

Figure 1a shows how the parameter G_1 is scattered around the mean value -12.5 kcal/m ol, with SD of 0.3 kcal/m ol as given in Table 1, for 1000 realizations (random draws). Figure 1b give a corresponding example of how activity is spread due to variations of all GFEs in the same run. Note in this particular example that

som e of the scattered data points are shifted toward very low values leading to a m ean value of the scattered activities which is lower (0.0077 s^{1}) compared to the wild-type activity (0.0081 s^{1}). However, as also discussed below, skewness, here and in the other simulations, is not very pronounced. The obtained mean values




Figure 2: Promoter activity versus total CI concentration for $[Cro_t] = 0$. P_{RM} corresponds to cI activity and P_R corresponds to croactivity. Fully drawn curves (\wild-type") correspond to experimental GFE data listed in Table 1, where CI data are from K oblan and A ckers,¹⁰ C ro data from D arling et al.,¹¹ and RNAP data from A ckers et al.⁶ P rom oter activity corresponds to the number of RNAP – DNA complexes that becomes transcriptionally active per second. \Scattering" () are mean values of the activities obtained from the computational scattering (described in main text) associated with standard deviations (only indicated for deviations > 0:3 10⁻³ s⁻¹). Thin vertical line indicates lysogenic concentration (200 nM). Abscissa is drawn on logarithm ic (decadic) scale.

are very close to the wild-type values. This is not a priori obvious, because these values originate from random draws in a Gaussian distribution of the GFEs, which in turn enters exponents in the grand canonical partition function (Eq. (1)) that m ight produce a skew ness in the distribution of the activities around the m ean. A general feature is that the SD relative to the wild-type activity, i.e., the sensitivity, is large and that the sensitivity is largest for a combination of m oderate/large

repressor concentrations and low activity. On the other hand, it is known from experim ents that the robustness upon perturbations, in particular of the lysogenic state, is high .^{18,19,8} Thus, in light of these latter mentioned studies, and despite the resulting large uncertainty of the activities due to the experim ental error, as found here, a lysogen remains stable due to the perturbations.




Figure 3: Promoter activity versus total CI concentration for $[C ro_t] = 50 \text{ nM}$. See also gure caption of Figure 2.

In order to study the sensitivity of the activity around induction, i.e., at concentrations where CI production is replaced by Cro production, we perform an analogous scattered computation as in Figure 2, but this time the total Cro concentration ([Cro_t]) is 50 nM. The latter value may represent a typical Cro concentration around induction.^{7,17} C om pared with [Cro_t] 0 the sensitivity of the activity is higher in this concentration regime (see Figure 3). A coordingly, the

activities of both P_{RM} and P_R are also reduced, which is reasonable because an increased C ro concentration in plies increased C ro occupancy at both promoters and transcription occurs less frequently. We also test the case [C rot] 200 nM (typical lytic concentration), that leads to smaller activity than the two previous cases. Due to the small activities, the sensitivity is high in this case.




Figure 4: a) Total C ro concentration vs. total repressor concentration (logarithm ic scale) where C ro concentration is determined self-consistently via the equilibrium ansatz d $[C ro_t]=dt = 0$ in Eq. (2). b) P rom oter activity versus total C I concentration where C ro concentration is determined self-consistently. Note that the rise of the P_{RM} curve (around 50 nM) is much sharper compared to the situation in Figures 2 and 3, indicating a larger cooperativity when the C ro concentration is determined self-consistently.

Figures 2 and 3 present the sensitivity of the activity, for a given C ro concentration, versus C I concentration. How ever, this might be done in a more compact way as shown in the following. The rate of C ro production m ay be written as (used to produce Figure 4)^{7,8}

where [C ro_t] is the total C ro concentration in nM .S 20 is the average number of C ro m ade from each transcript and R 2.5 10^{2} s¹ is the rate of transcript initiation, both estimated by A urell et al.⁸ p_R is the probability of RNAP occupancy of promoter P_R calculated from Eq. (1), dil 34 m in is the life time of a cell generation,¹⁹ and deg 2600 s is the in vivo half-life time of C ro due to degradation.²⁰ The prefactor 10^{9} is simply a conversion factor when going from numbers (of proteins) to concentrations, assuming an average cellular volume of 2 10^{15} liters.

We now assume C ro production to be in equilibrium, i.e., $d [C ro_t] = dt = 0$ in Eq. (2), which is a reasonable assumption because the C ro production occurs on time scale of seconds, while, for instance, a cell generation is of the order of half an hour.³ Thus, for a given repressor concentration we are now able to estimate the C ro concentration (see Figure 4a). One should note that the parameters in Eq. (2) are associated with large uncertainty (20%), however, this method is a valuable supplement to the presentation in Figures 2 and 3.

Above we investigated the sensitivity of the activity of the promoters by assuming a xed C ro concentration (Figures 2 and 3). In Figure 4b we show the sensitivity of the activity of the promoters by applying the self-consistent method that corresponds to Figure 4a. The activity at P_R is reduced for [C I_t] < 10 nM, compared with the situation in Figures 2 and 3. This makes sense, because due to Figure 4a [C rot] 150 nM for [C I_t] < 10 nM resulting in a self-repression of C ro. P_{RM} is also repressed by C ro in this concentration regime, leading to a zero activity. We not that the sensitivity of the activity is at the same level as in the previous analysis, with a standard deviation of the activity relative to the wild-type activity > 20%.

Finally, we implement the computational scattering method with a at distribution in an interval 1:5 SD, where SD is the standard deviation in Table 1, which corresponds to 67% condence intervals. E.g., G_2 is drawn at random in the interval from 10:8 kcal/mol to 10:2 kcal/mol. This results in a mean value of the activity similar to the wild-type and a sensitivity of the same order as obtained in the Gaussian scattering presented. Thus, the random scattering method seems to be rather insensitive to the functional form of the random drawing distribution function.

Sum m ary and conclusion

The main purpose of this work was to study the sensitivity of the production rates (activities) of the regulatory proteins CI and C ro associated with O_R (a genetic switch) in phage . The bindings of these regulatory proteins and RNA polymerase to DNA are assumed to be in equilibrium. Thus, by applying a grand canonical approach (statistical open system as presented in Eq. (1))^{9,6} we are able to nd the probability of binding to O_R , whereupon we calculate the rates of CI and C ro production (activities). We perform the computational scattering during which each of the 13 di erent protein-DNA binding energies are random ly drawn from a G aussian distribution with m ean equivalent to wild-type GFE and standard deviation corresponding to experimental error. Then, the corresponding activities associated with promoters P_{RM} and P_R are calculated. This is perform ed 10³ times, whereupon the mean and standard deviation of the resulting activities are evaluated.

The mean value emerging from this computational scattering scheme is in general close to wild-type activity, where the latter is calculated from the experimentally (wild-type) given values. The relative sensitivity of the activity, de ned as the ratio between the standard deviation ensuing the \scattering" and wild-type (unperturbed) activity, is in most cases > 20%. The sensitivity of the $P_{\rm RM}$ activity for a lysogen, where CI concentration typically is around 200 nM while C ro concentration is zero, is around 20%. Thus, according to Bailone et al.,¹⁸ perturbations of the activities of the size as performed in this work (0.1-0.5 kcal/m ol) are not enough to destabilize a lysogen. The $P_{\rm R}$ activity of $P_{\rm R}$ is here negligible. A round induction, where both CI and C ro concentrations are at com – parable levels (25-50 nM) the sensitivity of the activity is high (> 50%). The latter is also the case in the lytic regime where C ro is dom inating. D espite the relatively large error, the activities of the two prom oters seem to be separated within the error (see Figures 2, 3, and 4) making the switch feasible.

We note that the perturbations performed here (and conclusions) may to some extent take into account cell-to-cell variations of the concentrations of the proteins, i.e., noise, which e ectively may be viewed as variations in the binding energies. However, in order to study noise system atically one should, in the same m anner as we scattered GFEs random ly, choose the protein concentrations at random .^{21,8}

We also make an equilibrium ansatz for C ro production, by which we are able to calculate, for a given C ro concentration, the corresponding repressor concentration. This method leads to a more \com pact" presentation of data, because then only the CI concentration is a real variable due to the fact that the C ro concentration is in plicitly given, or vice versa. The sensitivity of the activity of the two prom oters, due to the latter method, is of the same size as we previously obtained in this work with xed C ro concentrations.
