## Universal features of charge and spin order in a half-doped layered perovskite.

W e have investigated the peculiar structure of charge and spin ordering in the half-doped layered perovskite oxide  $La_{1:5} Sn_{0:5} CoO_4$  by elastic neutron scattering. Two samples with di erent preparation histories were studied. We nd that the generic features of the ordered states, such as their short-range, glassy nature and the spin incom m ensurability, are sample-independent. At the sam e time, some subtle features of the ordered phases, such as the correlation lengths, di er.

R ecently m uch attention has been paid to exploring the charge/orbital- and spin-ordered phases in the chargedoped strongly-correlated transition-m etal oxides, such as the superconducting cuprates and the magnetoresistive manganites (see Refs. 1, 2 for a review). Competition of the spin, orbital and/or the charge/valence degrees of freedom results in non-trivial ground states, and leads to many fascinating physical properties, such as a m agnetic- eld-driven m etal-insulator transition, etc. At small doping, the charges often segregate into lines, form ing a stripe-like superstructure [3], which may be in portant for the high-tem perature superconductivity in cuprates. At half-doping, x = 0.5, there is a natural opportunity for a robust valence-ordered state with the checkerboard lling of the two-dimensional (2D) square MO<sub>2</sub> lattice (M = Cu, Mn, Ni, Co, ... is a 3d m etal) by M $^{2+}$ /M $^{3+}$  or M $^{4+}$ /M $^{3+}$  ions. At high doping, close 0:5, such a phase with the checkerboard charge to x order (CO) is often stabilized by the Jahn-Teller distortion, and is in competition with the metallic state where the charges are delocalized. Such a competition is at the heart of the strong response (CMR) of the doped pseudocubic m anganites to a m agnetic eld, which favors the m etallic phase by inducing ferrom agnetism, [4].




FIG.1:D ependence of the structural elastic di use scattering accompanying the charge order on the wavevector transfer along the c-axis in two sam ples. A l(111), A l(200) and A l(220) m ark the corresponding peaks arising from the \parasitic" scattering by the alum inium in the sam ple environm ent.

The CO and the spin-ordered (SO) phases were recently characterized in a number of the halfdoped materials, in particular, in the layered perovskites La0:5Sr1:5M nO 4 [5], La1:5Sr0:5C oO 4 [6, 7], and  $La_{1:5}Sr_{0:5}N$  iO 4 [8]. All three materials have the tetragonal crystal structure of the \HTT " phase (space group I4=mmm, see Fig. 1 (a) in Ref. 7), and with lattice spacings that only dier by . 1% . Although an \orthorhom bic" indexing based on the space group F 4=m m m , with a twice larger unit cell, 2a 2a c, is often em ployed to account for breaking of the translational sym m etry in the a b plane by the checkerboard CO superstructure, here we use the I4=m m m notation corresponding to the true crystal lattice.

W ith decreasing temperature, all three compounds rst undergo a transition to the checkerboard chargeordered state. It is accompanied by a dramatic increase of the activation energy in the T-dependence of the electrical conductivity, which is a clear evidence of the charge localization. An important generic feature of the CO in the layered materials at half-doping is its nite correlation range. It results from the combination of the random electrostatic potential introduced by the quenched disorder of the dopant ions, and the quasi-two-dimensional nature of the elastic couplings between the distortions in di erent layers [9]. If the coupling between the distortions is isotropic, as it is in the pseudo-cubic manganites, the CO may become a truly long-range superstructure.

In all three materials the spin ordering (SO) follows the charge order, but at a signi cantly lower tem perature. In the manganite, La<sub>0:5</sub>Sr<sub>1:5</sub>M nO<sub>4</sub>, the SO is com m ensurate, with the propagation vector Q = (1=4;1=4;1)[5], as for the simple two-sublattice antiferrom agnetism on each of the two elds of the CO checkerboard. In  $La_{1:5}Sr_{0:5}CoO_4$ , which is the subject of this study, the SO was found to be incommensurate, with the propagation vector Q = (;; 1) with 0258 [6]. The situation is even more complex and intriguing in the nickelate. There the SO is also incom m ensurate, but with 0:22, sm aller than 1/4, and is preceded by the transform ation of the CO from a checkerboard to a stripe-like phase with the propagation vector Q = (2; 2; 0) [8].

The correlation lengths of spin and charge order m easured in the above m aterials are sum m arized in Table I. Both SO and CO are much better correlated in the m anganite, where the SO is commensurate. A lthough a recent X -ray study [10] determined that  ${}^{(CO)}_{ab} = 200 (30)A$ and  ${}^{(CO)}_{c} = 30 (2)A$  in La<sub>0.5</sub>Sr<sub>1.5</sub>M nO<sub>4</sub>, these values are still about an order of m agnitude larger than the CO correlation lengths for the other two compounds in Table I. The situation with the SO correlation lengths is similar. Whether the spin incommensurability is in som e way related with this difference in the correlation lengths, though, is not really clear. Furtherm ore, a question arises: is there any connection at all between the CO and SO correlation ranges for a given material?

The di erence in the CO correlation lengths m easured in di erent m aterials can readily be understood from the generic cross-over phase diagram based on the random

eld Ising model (RFM) [9]. It simply indicates that the e ective random eld and/or the inter-plane coupling in the quasi-2D anisotropic RFM, which is the e ective

low-energy theory describing the CO transition, di er. However, because the source of the random eld is the crystallographic disorder, it may also vary from one sam – ple to another of the sam e material, with the sam e nom – inal stoichiom etry. How strong is this e ect, and how does it com pare to the variation of (CO), (SO) between the di erent materials?

To address these questions, we have studied two sam ples of the half-doped cobaltate, La1:5Sr0:5C oO 4, of different size and with di erent preparation histories, using elastic neutron scattering. Sample # 1 is a cylinder of 5 mm long, prepared at Nagoya Unim 1 0:5 g and versity as described in Ref. 11, and was previously studied in Refs. 6, 7. A larger sample #2 is 45 mm long, 11 g cylinder, and was grown in air atm osphere in m 2 the oating zone fumace at Brookhaven National Laboratory. Both samples were a high quality single crystals with mosaic spread of less than 0:25 . Within the accuracy of our m easurem ent they both have the sam e low T lattice constants, a = 3:830(3)A and c = 12:51(2)A.

M easurements of the wave-vector dependence of the elastic scattering associated with charge and spin ordering were performed on the BT2 spectrometer at NIST C enter for N eutron R essarch. The incident and the scattered neutron energy,  $E_i = E_f = 14.7 \text{ meV}$ , was de ned by PG (002) rejections, with two PG liters suppressing the higher-order contamination. Beam collimations were  $60^{\circ}$  and  $100^{\circ}$  before the monochrom ator and after the




FIG. 2: Incom m ensurate m agnetic peaks arising from the short-range spin order in two samples, (a) # 1, and (b) # 2. Tem perature dependence of the m agnetic intensity is essentially identical in both cases, with an onset at  $T_s$  30 K.

analyzer, respectively, and  $20^{\circ}$  20 around the sam ple. The sam ple wasm ounted in a displex refrigerator with its (hhl) reciprocal lattice zone in the horizontal scattering plane, and kept at T = 10(2) K. To establish the sim ilarity of the tem perature dependence of the SO scattering in the two sam ples, som e additional measurem ents were perform ed using the SP IN S cold-neutron spectrom eter.

The dependence of the CO scattering on the wave vector transfer along the c-axis for the two sam ples is shown in Fig. 1 (left panel, sam ple # 1; right panel, # 2). The scans through the CO peaks at Q = (h + 0.5; h + 0.5; l) in the ab-plane, di er essentially only in their intensity, and are not shown. The CO di use scattering was analyzed following the procedure described in the R ef. 7. The solid curves in Figure 1 show the corresponding resolutioncorrected ts to the \lattice Lorentzian" scattering function which describes the di use scattering by a shortrange superstructure (shaded areas show the calculated intensity in the absence of the background).

It is clear from Figure 1 that the long-period ldependence of the di use intensity is similar in both sam – ples. This indicates that in both cases it results from the same kind of local distortion of the  $CoO_6$  octahedra. In fact, the t shows that the corresponding displacements of the oxygen and Sr/La ions are, within its accuracy, the same in both samples,  $\mathbf{W}_{O(1)}^{x,y} = 0.044$  (4) A,  $\mathbf{W}_{O(2)}^{z} = 0.080$  (8)A, and  $\mathbf{W}_{La=Sr}^{z} = 0.010$  (2)A (cf. Refs. 6, 7; here we have allowed for a small modulation of the La/Sr position which slightly improves the t). W hat m akes the scattering patterns from the two samples look quite distinct, is the di erence in the CO correlation

range between the ab planes,  $c^{(CO)}_{c}$ .

The correlation lengths for the charge  $\begin{bmatrix} (C \circ) \\ ab \end{bmatrix}$ ;  $\begin{bmatrix} (C \circ) \\ c \end{bmatrix}$ and the spin order [  $_{ab}^{(S\,O\,)};\,c^{(S\,O\,)}$  ] re ned from our measurements are summarized in Table II. The inter-plane CO correlation length in the sample #1 is somewhat larger than the distance between the neighboring ab planes, c=2, and the CO peaks at integer l are well separated. On the other hand, in the case of sample # 2there are no such well-de ned peaks. This means that the inter-plane correlations are not developed at all, i.e. the correlation length is much smaller than the distance between the neighboring ab planes. In our re nem ent we  $xed_{C}^{(CO)} = 2.5A$ . At the same time, the CO correlation range within the ab layers is essentially the same for both samples. This agrees with the expectation from the an isotropic RF  $\mathbb{M}$  [9]. In the strongly an isotropic regime,  $_{\rm c}^{\rm (CO)} = _{\rm ab}^{\rm (CO)}$ 1, the in-plane correlation lenghth,  $\frac{(C \circ)}{ab}$ is essentially determ ined by the 2D RFM physics, and is not sensitive to the developing inter-plane correlations.

Typical scans characterizing the dependence of the magnetic scattering associated with the spin order on the wave-vector transfer in the ab plane are shown in the Figure 2. The solid lines are the appropriate resolution-corrected lattice Lorentzian" ts, as in Ref. 6. The spin structure is described as a dam ped at spiral polarized in the ab plane, with the propagation vector Q = (;;1). The l-scans (not shown) have much broader peaks centered at odd 1 (the inter-plane SO correlation length,  $C_{\rm c}^{\rm (SO)}$ , is also much shorter than that in the plane,  $C_{\rm ab}^{\rm (SO)}$ . They are also well described by the model.

A lthough the charge order is som ewhat better correlated in sam ple # 1, the re nem ent shows that the spin order correlation lengths are appreciably, by m ore than a factor of 1.5, larger in sam ple # 2. This supports the conclusion that, although the CO correlation range in the ab plane is quite short, the resulting disorder is still far from the 2D percolation threshold for the spin system. Therefore, it is not the source of the SO nite correlation length which, m ost probably, originates from the frustrated spin interactions [6]. This conclusion is further corroborated by the observation that the SO incom m ensurability appears smaller in the sam ple # 2, where the spin correlations are appreciably stronger (although the di erence is small, it is wellbeyond the m ost conservative error bars which are shown in Table II).

To sum marize, we nd that the generic, qualitative features of the charge and spin ordering in the half-doped layered perovskite  $La_{1:5}Sr_{0:5}C \circ O_4$ , such as their shortrange, glassy nature and the spin incom mensurability are common for the two samples that we have studied. In fact, they are also shared by the other layered half-doped materials (Table I). However, we also nd some appreciable di erences between our two samples with di erent preparation histories. The most dramatic is the di erence in the correlation lengths. While the in-plane CO correlations are essentially the same, the CO correlation between the layers is signicantly weaker in the sample # 2. This can be understood on the basis of the anisotropic RFIM [9] that describes the charge ordering in the halfdoped materials. It im plies that the weak residual interlayer CO coupling is sensitive to the impurities and the imperfections in the crystal and is sample dependent.

For the spin order, the correlation lengths are as different between the two sam ples, as those between the sam ple # 1 and the nickelate,  $La_{1:5}Sr_{0:5}NiO_4$ . In fact, the correlation lengths of the checkerboard charge order and of the SO in the nickelate are essentially the sam e as in our sam ple # 2 of  $La_{1:5}Sr_{0:5}CoO_4$ . The spin incom – m ensurability, though, is com pletely di erent, and the charge-stripe phase is not present in either of the cobaltate sam ples. Finally, the smaller incom m ensurability in the sam ple # 2 with stronger spin correlations seem s to indicate that these are related, and, perhaps, vanishes if the SO is truly long range. This may explain, why the spin structure is apparently com m ensurate in the m anganite,  $La_{0:5}Sr_{1:5}M nO_4$ , where the SO correlation length is at least twice larger than in our sam ple # 2.
