Lim its of sym pathetic cooling of ferm ions: The role of the heat capacity of the coolant

The sym pathetic cooling of an initially degenerate Ferm igas by either an ideal Bose gas below T_{c} or an ideal Boltzm ann gas is investigated. It is shown that the e-ciency of cooling by a Bose gas below T_{c} is by no means reduced when its heat capacity becomes much less than that of the Ferm igas, where e-ciency is measured by the decrease in the temperature of the Fermigas per number of particles evaporated from the coolant. This contradicts the intuitive idea that an e-cient coolant must have a large heat capacity. In contrast, for a Boltzm ann gas a minimal value of the ratio of the heat capacities is indeed necessary to achieve T=0 and all of the particles must be evaporated.

I. IN TRODUCTION

Sym pathetic cooling of ferm ionic atom s has proven to be an e cient tool to produce strongly degenerate Ferm i gases [1, 2, 3, 4, 5]. It is often thought that when the specic heat of the coolant becomes less than that of the ferm ions the cooling process slows drastically and even com es to a halt [1, 6, 7]. This belief derives from the following argument based on standard therm odynamics [8]. A coolant is not only described by its temperature but also by its heat capacity. The equilibrium temperature between two bodies initially at dierent temperatures Tf and T_b is $T = (C_f T_f + C_b T_b) = (C_f + C_b)$, where C_f and C_b are the heat capacities of the two bodies [9]. Therefore, regardless of having a very cold object b (Tb will not act as a good coolant unless it is also true that C_b C_f.




FIG.1: Shown is a diagram of the evaporative cooling process in our model. In the upper two panels, a gas of N $_{\rm f}$ ferm ions at tem perature T is in them all equilibrium with a coolant of N $_{\rm b}$ bosons or Boltzm ann particles. In the middle two panels, the tail of the number distribution of the coolant is cut and N $_{\rm b}$ particles are removed. In the lower two panels, the systems are permitted to rethermalize, resulting in a reduced common temperature T $_{\rm c}$ T. The values of T and N $_{\rm b}$ have been exaggerated for the purposes of illustration; the units are arbitrary.

However, this argument does not include the evaporation of atom s from the coolant [10, 11], a key ingredient of sym pathetic cooling. In the following, we shall consider the ideal case of sym pathetic cooling, where all losses of particles due to inelastic collisions are absent. One can then evaporate su ciently slow ly that the Fermigas and the coolant remain close to thermal equilibrium. This is in the spirit of the above argument, based on heat capacities, as heat capacity is a property of an equilibrium system. In this case, the only limitation of resources is the number of particles in the coolant. We then introduce an idealized model of sympathetic cooling: the atom ic motion is treated in the sem i-classical approximation and cooling proceeds in discrete steps. In each step, the atom softhe coolant go through an evaporation phase, and then the ferm ions and the coolant therm alize (see Fig. 1 below). This is a generalization of the discrete scheme used for evaporative cooling in Ref. [12], to the case of sym pathetic cooling. A sim ilar sem i-classical and discrete model for sympathetic cooling was put forward in Ref. [13], with the addition of features like collisional losses and space dependent e ects in the evaporation process, but without a determination of the limits of the cooling process. Using our idealized model, we shall

then show that the argument based on the heat capacities is approximately correct for fermions cooled by an ideal Boltzmann gas [14], but incorrect when cooled by an ideal Bose gas below the Bose condensation temperature $T_{\rm c}$. In fact, in the latter case, it is preferential to have $C_{\rm b}$ $C_{\rm f}$ to minimize the number of particles of the coolant whose evaporation is required to reach zero temperature [15].

II. THE MODEL

We assume that the Fermigas, denoted by the subscript f, and the coolant, denoted by the subscript b, are initially in thermal equilibrium at a common temperature T . O ne evaporates all particles of the coolant with an energy greater than $\,k_{B}$ T [10, 11, 12, 16], where $\,$ is a constant, typically 5 to 7 in current experim ents. This has the e ect of rem oving a number of particles $\,N_{\,b}$ and an energy $\,E_{\,b}$ from the coolant:

where $_{\rm b}$ () is the density of states of a particle in b and N $_{\rm b}$ () is the mean occupation number of a state of energy . In what follows we restrict ourselves to the sem iclassical regime in which the number of trap levels with an energy less than $k_{\rm B}$ T is much larger than unity, both for species f and b. Then the case of a density of states of the form

m ay be considered: this encom passes both a harm onic potential (= 3=2) and a box (= 0) [17]. Here the subscript f (b) stands for the ferm ions (coolant). In the two limiting cases of a non-degenerate gas N $_{\rm b}$ () = exp[()] and a Bose gas below T, N $_{\rm b}$ () = 1=[exp() 1], the mean energy of an evaporated particle [16] is independent of the chemical potential and proportional to T:

The function f () is di erent for a Bose gas below T_{c} and for a Boltzm ann gas, but has the same large behaviour in both cases [18]:

Once the particles are removed, the system is left to rethermalize. The decrease in temperature $\, \, T \,$ is obtained by conservation of energy,

Note that E $_{\rm f}$ is the total energy of the ferm ions, not the Ferm ienergy. The parameter is chosen su ciently large so that N $_{\rm b}$ N $_{\rm b}$ and T T. Equation (6) may be expanded to leading order in N $_{\rm b}$ and T:

where the heat capacities are dened by C $_{\rm f}$ $\,$ Q E $_{\rm f}$ and C $_{\rm b}$ = Q $_{\rm T}$ E $_{\rm b}$.

Equation (7), valid for a Boltzm ann gas or a degenerate Bose gas, will be studied for both a three dimensional




FIG. 2: Shown is the temperature of a degenerate Fermi gas sympathetically cooled by a Bose gas with a condensate present, as a function of the number of bosons evaporated in a harm onic trap, that is of the dierence between the initial number of bosons $N_{\rm b;0}$ (assumed to fulllEq.(14)) and the nalnumber $N_{\rm b}$. Two cases are depicted: $!_{\rm f}=!_{\rm b}=1$ (solid line) and $!_{\rm f}=!_{\rm b}=5$ (dashed line) where $!_{\rm f}=!_{\rm b}$ is the ratio of them ean trapping frequencies of the fermions and bosons. It is apparent that $!_{\rm f}=!_{\rm b} < 1$ requires a greatly reduced number of bosons in order to cool to T=0, and may therefore be considered as a more e cient experimental conguration. Here the choice of parameters was =6 for the energy cut-o and $T_0=T_{\rm F}=0.2$, where T_0 is the initial temperature.

box and a harm onic potential. In the form er case, the mean eld energy per particle of the coolant, due to the interaction with the Fermigas, is constant and therefore plays no role. In the latter case, it is not exactly constant, but we shall assume that it is negligible as compared to $k_{\rm B}\,T$. Additionally, for simplicity it will be assumed that the initial state of the fermions is degenerate. In this case the total energy is

where 2 (+ 3=2)=6, 2 (+ 1=2) (3)=20,

is the exponent in the density of states and the Ferm i tem perature $T_{\rm F}\,$ is given by

In Eq. (8) we shall keep term s only to second order in T in the following.

A non-interacting Bose gas with a tem perature below $T_{\text{\tiny C}}$ has a total energy

where (+5=2) (+5=2) (+5=2) is a constant and and are gamma and zeta functions, respectively [19]. Note that E_b does not depend on the total number of bosons, since the occupation of the excited states is saturated to its maximal value in the presence of a condensate. Therefore $@E_b=@N_b=0$ and Eq. (7) reduces to

where we used the fact that A_f is related to the Ferm i tem perature T_F by Eq. (9). When species f and b are in a box, $A_b = A_f$ is simply the ratio $V_b = V_f$ of the spatial volumes occupied by the two species. When species f and b are trapped harmonically, $A_b = A_f$ is given by the ratio $(!_f = !_b)^3$ where $!_{f,b}$ are the geometric means of the three oscillation frequencies for species f and b, respectively.

The term in T $^{+1=2}$ in the denominator of Eq. (11) represents the ratio of the two heat capacities:

If one m easures the e ciency of the cooling by the tem – perature decrease per num ber of bosons evaporated, i.e., $T=N_b$, it is most e cient to have C_b-C_f . In this case the rst term in the denom inator dom inates and the derivative is maximized. In Fig. 2 is shown the tem perature as a function of the number of bosons evaporated, as can be obtained from the solution of the dierential equation Eq. (11) for the case of harm onic trapping and = 6. It is apparent that it is advantageous to evaporative cooling to choose a trap frequency ratio $!_f = !_b < 1$, in order to maintain $C_b = C_f$ small at typical experimental temperatures $T = T_F$ 0.2 or 0:1.

A simple condition may be obtained from Eq. (11) for the total initial number of bosons necessary to cool to $T\,=\,0$:

where T_0 is the initial tem perature, C_0 are the initial heat capacities and N_b is the number of bosons evaporated. As the coolant is assumed to be initially a Bose gas with a condensate present, the initial number of bosons must exceed the saturated value of the population of the excited states:

Note that, as an arbitrarily large number of particles can be stored in the condensate, no connection can be established between the number of particles and the heat capacity of the coolant. Thus condition (13) cannot be considered as a constraint on $C_{\rm b;0}=C_{\rm f;0}$ [20].

Recall that T=T 1 was required to replace the nite dierences in (6) by derivatives. When the heat capacity of the Bose gas is initially much smaller that that of the Ferm i gas, one nds that this condition is satised for any value of , including $=0^+$ where f (0) is nite and strictly positive. In this case, Eq. (11) and its consequences apply also when one evaporates all the non-condensed atoms at each cooling cycle.

IV. COOLING BY A BOLT ZM ANN GAS

A Boltzmann gas has a total energy

Equation (7) then reduces to

The explicit dependence of the energy on N $_{\rm b}$ introduces a negative contribution in the num erator. However, the total num erator remains positive, since one can show, by integration by parts, that the condition

is satis ed for all > 0.

One nds that, by making a change of variables

the equation becomes separable. This leads to the constant of motion

The asym ptotic behavior of the tem perature in the lim it of the complete evaporation of the Boltzm ann particles, i.e., N $_{\rm b}$! 0, falls into two regimes. The rst is given by $\rm x_0 > 1$, where $\rm x_0$ is the initial value of x. In this case, the tem perature tends to a nite non-zero value due to an insu cient number of Boltzm ann particles. The ratio of the nal to initial tem perature is

The second regime is given by $x_0 < 1$, which implies > 1. The inequality $x_0 < 1$ is equivalent to the requirement that there be a minimal initial number of Boltzmann particles:




FIG. 3: Shown is the tem perature of a degenerate Ferm i gas subject to sym pathetic cooling by a Boltzm ann gas as a function of the number of Boltzm ann particles. Three cases are depicted: $C_{f;0} = C_{b;0} = (1) = 2$ (solid curve); $C_{f;0} = C_{b;0} = 1$ (dashed curve); and $C_{f;0} = C_{b;0} = 2(1)$ (dot-dashed curve). In the latter case the number of Boltzm ann particles is insufcient to cool to T = 0. Here the choice of parameters was = 6 for the energy cut-o parameter, $T_0 = T_F = 0.2$ for the initial tem perature, and a harm onic trapping potential.

Note that > 1 implies that the denominator is positive. Equation (22) may be equally expressed as a requirement on the initial heat capacities of the fermions and Boltzmann particles:

In this case the temperature tends to zero as

In Fig. 3 are shown three sample trajectories of Eq. (16). For $x_0 > 1$ the naltemperature is non-zero when all of the Boltzm ann particles have been evaporated. For $x_0 < 1$ the naltemperature is zero and all of the Boltzm ann particles are used in the evaporation. A third curve shows the case $x_0 = 1$, which divides the two regimes: this corresponds to constant x, which implies $T = T_F \ / \ N_b = N_f$.

Note that, for a harm onic potential, f () can be calculated exactly for a Boltzm ann gas [18]. The critical value of which corresponds to 1=0 is then $_{\rm C}=4.59:::$ For < $_{\rm C}$ the nal temperature of the fermions after evaporation of all the Boltzm ann particles is always nonzero.

V. CONCLUSION

We have demonstrated that, in an idealized experiment with no particle losses besides those due to evaporation of the coolant, sympathetic cooling of degenerate Fermi gases is not limited by the heat capacity of the coolant when the latter is a Bose gas with a condensate present. In fact, it is advantageous to obtain $C_f = C_b - 1$ in order to minimize the number of bosons that must be evaporated, where $C_{f;b}$ are the heat capacities of the fermions and bosons. In this case, T = 0 m ay be obtained provided that the initial number of bosons is su ciently large:

$$N_{b;0} > 2:7 N_f T_0 = T_F ;$$

where N $_{\rm f}$ is the number of ferm ions, T $_{\rm 0}$ is the initial tem perature which is much less than the Ferm i tem perature T $_{\rm F}$, and = 6, a typical value of the energy cut-o for evaporative cooling, was chosen.

In contrast, in the case of a Boltzm ann coolant, the naltem perature of the ferm ions depends on the ratio of the initial values of the heat capacities $C_{\,\mathrm{f};0} = C_{\,\mathrm{b};0}$. For typical values of the evaporation cut-o parameter , $C_{\,\mathrm{f};0} = C_{\,\mathrm{b};0}$ must be smaller than a critical value on the order of unity to reach T = 0 after evaporation of all the Boltzm ann particles.
