Im aging of spinor gases

We explore the dielectric properties of spinor condensates. Gases with vector (nematic) order, such as spin-1 condensates with ferrom agnetic (antiferrom agnetic) interactions, display optical activity (birefringence). This optical activity/birefringence is respectively seen for light detuned from resonance by a frequency which is not too large compared with the ne/hyper nestructure. Careful tuning of the light frequency can isolate either of these two eects. These features can be used to image spin textures in clouds of spin 1 bosons, and to discern states showing dierent types of spin order.

I. INTRODUCTION

Super uids display dram atic rotational properties. For exam ple, arrays of quantized vortices have been observed in rotating gaseous spin-polarized ⁸⁷Rb and ²³Na Bose-E instein condensates (BECs) [1]. The physics of rotating systems is even richer in the presence of spin degrees of freedom: thanks to the interplay of the spin and translational degrees of freedom, simple vortices are replaced by more complicated spin textures. These textures have been studied in many dierent contexts, from ³He-A [2] to quantum Hall systems [3] and, more recently, trapped gaseous BECs [4, 5, 6, 7]. They are closely related to three dimensional skyrm ion and hedgehog structures which could be engineered in clouds of trapped atoms [8].

Theoretical studies have analyzed the structure of spin textures in rotating spinor BECs for dierent values of the spin, the trap rotation frequency, and the atom -atom interactions [4, 5]. Experimental studies, beginning with pseudo-spin-1=2 systems [6] and continuing with spin-1 and spin-2 condensates [7], have observed individual spin textures. These experiments are complemented by studies of spin dynamics in non-rotating spin-1 and spin-2 clouds [9].

In m ost of these experiments [10], imaging is performed by rst separating the dierent spin components using a magnetic eld gradient (the method pioneered by Stem and Gerlach [11]). The spin components are then separately imaged via conventional optical absorption or phase contrast techniques. This approach is intrinsically destructive and is unable to probe coherences between the dierent spin components. Moreover, images of the individual components are very sensitive to global rotations of the order parameter [5].

In the present paper, we propose a di erent im aging schem e which is predicted to provide non-destructive, insitu, im ages of the spin textures and which directly addresses the geom etrical features of the BEC order parameter (density, spin, and nem aticity pro les) rather than its components in some specic basis. The method re-

lies on the dependence of the dielectric properties of a spinor atom ic gas on the internal state of the atom s. Focussing our attention on the case of spin-1 atoms, we derive a simple expression for the local dielectric tensor $_{ij}$ (x) in term s of the local density (x), spin density S(x), and quadrupolar (nem atic) order param eter $N_{ij}(x)$ of the atom ic gas. Using this expression for it (x), we then study the propagation of polarized light across an atom ic cloud: we show how information about the spatial pro le of the spin texture can be retrieved by analyzing the intensity, phase, and polarization pro le of the transmitted light. Our technique has analogies in other areas of condensed matter physics: the polarization of the electrons in a solid-state sample [12] as well as the order parameter of nematic liquid crystals [13] can be measured by looking at polarization changes in a transmitted, diracted, or re ected light. As the order param eter of spin-1 atom ic system s is a three-com ponent complex eld, it can simultaneously have non-vanishing vector (spin) and tensor (nem atic) components: we discuss possible ways of isolating the contribution of each of them .

II. THE LIGHT-MATTER COUPLING HAM ILTONIAN

The electric-dipole Ham iltonian describing the interaction of light with a two-level atom can be written in a second-quantized form as:

The atom ic eld operators $\hat{}$ (x) and $\hat{}$ (x) destroy an atom at spatial position x in respectively the sublevel of the excited state or the sublevel of the ground state. $\hat{E_i}(x)$ is the i-component of the electric eld operator at x and D $_i$ = he: jd_i jg: i gives the matrix element of the i-component of the electric dipole moment

between the sublevels and of respectively the excited and ground state.

For light frequencies! well detuned from the resonance frequency $!_0$ of the g! e transition, we can elim inate the excited state and write an e ective H am iltonian for the ground state atoms coupled to the electromagnetic eld:

the indices and run over the ground state sublevels and runs over the excited state sublevels.

In our case of spin 1 atoms, the matter eld is a three-component vector and can be written in terms of its (operator-valued) Cartesian components as $^{\sim} = (^{\wedge}_{x}; ^{\wedge}_{y}; ^{\wedge}_{z})$ [14]. The local one-body density-matrix $m_{ij}(x) = ^{\gamma_{y}}_{i}(x)^{\hat{}}_{j}(x)$ is the tensor product of the two distinct spin 1 objects $^{\sim}$ and $^{\sim_{y}}$, so it can be represented in terms of three irreducible tensor components with angular momentum 0, 1 and 2. Their explicit expressions in Cartesian components are:

The totally antisymmetric unit tensor is denoted " $_{jkl}$. Physically, the scalar corresponds to the total density, the vector S to the spin density, and the second-rank, symmetric tensor N to the nematicity (or quadrupole moment). An identical decomposition into the intensity I, the spin density and the nematicity N can be performed for the electromagnetic eld one-body density matrix de ned as $f_{ij} = E_{ij}^{\gamma} E_{j}$.

As we assume no external eld is present to break rotational invariance, the H am iltonian is a scalar (that is spin 0) object. Scalar objects can be found in the tensor product of two quantities only if the two quantities have the same spin. This implies that the H am iltonian (2) can be decomposed in the form:

where the three real coe cients b $_{0;1;2}$ depend on the internal structure of the atom and on the frequency of the

light. Comparing (7) with (2), one nds

In the next section, we give explicit expressions for the U tensor and the b_i coe cients for a few simple cases.

III. THE DIELECTRIC TENSOR OF A SPIN 1 GAS

The form (7) of the light-m atter H am iltonian can be used for studying the optical potential induced by light on atom s, as well as the refractive index observed by light while crossing the atom ic sample.

In the rst case, a scalar potential comes from the local intensity I (x) of light, a pseudo-magnetic eld comes from the electromagnetic spin (x), and the N (x) tensor couples to the nematicity N (x) of the atoms. A rst application of this formalism has been given in [17], where e ects arising from a kind of spin-orbit coupling induced by the pseudo-magnetic eld are analyzed for atoms propagating in suitably designed optical lattices.

In the present paper, we concentrate on the second class of phenomena, namely on how the optical properties of the atomic cloud depend on the spin state of the atoms; in particular we shall discuss how the polarization state of a light beam after crossing the atomic sample can be used to obtain information on the spin state of the atoms.

A. The general structure of the dielectric tensor

Under a mean-eld approximation in which the quantum correlations between the matter and the light eld are neglected, a wave equation for the eigenmodes of the electromagnetic eld in a homogeneous medium can be directly obtained from the Hamiltonian (2):

where 1 is the identity matrix, the projector P_2 projects orthogonally to the wavevector k and the tensor has been de ned as:

where $_0$ (= 1=4 in cgs units) is the perm ittivity of free space. By comparing this wave equation with the Fresnel equation for a generic medium of dielectric tensor:

one obtains the following explicit expression for the dielectric tensor of the atom ic sample at the frequency ! in terms of the coupling tensor U in the Cartesian basis and the one-body density matrix m:

The same symmetry arguments previously used to parametrize the Hamiltonian in the form (7) lead to the following expression of the dielectric tensor (14):

where $c_j = 2b_j = 0$. The scalar term proportional to c_0 corresponds to the isotropic polarizability of the atom s, while the vector term proportional to c_1 describes their optical activity around the axis de ned by the atom ic spin S. Finally, the tensor term proportional to c_2 gives birefringence e ects, whose principal axis coincide with the ones of the nem aticity ellipsoid de ned as:

The matrix elements D $_{ijk}$, and hence the coe cients c_j can be related to the line width of the atom ic transition [18]. For the fundamental D $_{1;2}$ transitions of a typical alkali atom such as 23 Na or 87 Rb, 5 10^{1} s and jc_j j 10 15 cm 3 =j! ! $_0$ j. A typical in-situ in aging setup [19] uses detunings in the GHz range (which are large enough that absorption e ects can be ignored [20]), and atom ic densities of order 10^{14} cm 3 , resulting in a dielectric tensor which diers from unity by an amount of magnitude jj 1jj 10^{2} . As we shall see in section IIIC, quantum interference e ects can drastically reduce the magnitude of any given c_j in some speciec frequency domains.

B. The dielectric tensor for a single transition

The coe cients $c_{\,i}$ in the parametrization (15) of the dielectric tensor depend on the internal structure of the atom . Since the ground state has been assumed to have spin $F_g=1$, absorbing a photon can bring the atom s into excited states of angular momentum $F_e=0;1;2$. In the present subsection, we shall derive a sin ple expression of the c_i coe cients in terms of the strength of the optical transition for the case where only one excited multiplet is involved. For notational sin plicity we om it the angular brackets denoting expectation values of matter eld operators.

For $F_e=0$, the D tensor in Cartesian components (j;k = fx;y;zg) has the form $D_{0jk}=D_{0jk}$, so the dielectric tensor is:

i.e. $c_0^{(0)} = A_0 = 3$, $c_1^{(0)} = A_0 = 2$, and $c_2^{(0)} = A_0$ with $A_0 = 2 \not\!\! D_0 \not\!\! J = 0 \sim (! !_0)$. This result has a simple interpretation: a photon polarized along the C artesian axis j interacts only with the component of the matter eld along the same axis.

For $F_e = 1$, the Cartesian (j;k;l= fx;y;zg) components of the D tensor have the form D $_{jkl} = D_1$ " $_{jkl}$ and therefore one has:

Finally, for $F_e = 2$, the dielectric tensor has the form:

i.e. $c_0^{(2)}=5A_2=9$, $c_1^{(2)}=5A_2=12$, and $c_2^{(2)}=A_2=6$. The coe cient A $_2$ can be obtained from the electric dipole m om ent D $_2$ of the optical transition of the F $_g=1$! F $_e=2$ transition as A $_2=2\mathcal{D}_2\mathcal{J}=_0\sim$ (! $_1^2$). More specifically, D $_2$ is defined as the electric dipole matrix element between the m $_F=1$ sublevel of the ground state and the m $_F=2$ sublevel of the excited state. The matrix elements of the transitions between the other sublevels are related to D $_2$ by the appropriate C lebsch-G ordan coecients.

${\tt C}$. E ect of the $\tt ne$ and hyper ne structures of $\tt the$ atom

If m ore than one excited state is involved in the optical process, the e ective coupling U of the ground state atom s to the light is given by the sum of the contributions (3) of each single excited state, each of them being weighted by a factor $1=(!_i\ !)$, where $\sim !_i$ is the excitation energy and ! the light frequency. C learly, the result will be dominated by the states which are closest to resonance. By tuning to frequencies where the contributions from dierent excited states cancel, one can take advantage of quantum interference e ects to make at least one of the coe cients c $_{0,1;2}$ vanish.

For example, considerable simplication is found if the detuning is large compared to either the neor hyper ne splitting. Consider the fundamentalns! nP transition of an alkaliatom such as 23 Na or 87 Rb: the S = 1=2 electronic spin couples to the excited state's L = 1 electronic orbital angular momentum to produce two ne components of total electronic angular momentum J = 1=2 or

3=2. The ground state, having instead a vanishing orbital angular m om entum L = 0, contains a single ne com ponent of total electronic angular m om entum J = 1=2. Both 23 Na and 87 Rb have a nuclear spin of I = 3=2: coupling between the nuclear and electronic spins therefore result in the ground state splitting into two hyper ne components with F = 2 and F = 1 (in this paper we lim it ourselves to F = 1). The J = 1=2;3=2 ne components of the excited state respectively split into two hyper ne com ponents of F = 1;2, and four hyper ne com ponents of F = 0;1;2;3. For these alkali atom s, the ne structure separation between the D $_1$ (S $_{1=2}$! P $_{1=2}$) and D $_2$ $(S_{1=2} ! P_{3=2})$ lines is of the order of THz. Hyper ne structure, resulting from the much weaker coupling between the electron and the nucleus, amounts to a few GHz for the electronic ground state and to a fraction of GHz for the excited state [21].

If the detuning of the light is much larger than the hyper ne splitting $_{
m H\,F}$, the nucleus, whose direct coupling to radiation is extremely weak, is not expected to play any role in the dynam ics. In this regime, the frequency denominators in the contributions (3) to the U tensor coming from the dierent hyper ne components are approximately equal. Consequently, U acts as the identity matrix in the space of nuclear states. It imm ediately follows that the dielectric tensor (14) only depends on the electronic part of the atom ic density m atrix, $m^{(e)} = Tr_n [m] = \sum_{m_I} hm_I jm_I jm_I i$, where the index m_I runs over the 2I + 1 possible nuclear spin states. As the total electronic angularm om entum of the ground state is J = 1=2, the decomposition analogous to the ones in (7) and (15) now gives two components of angular momentum respectively 0 and 1, but no component of angular m om entum 2. In physical terms, this means that, once the sum over the hyper ne components of the excited state is perform ed, one has $c_2 = b_2 = 0$ and no birefringence e ect nor any mechanical coupling of light to the nem atic order param eter N can be present. The coe cients c_1 and c_0 will, however, generally be non-zero [22]. For a large but nite detuning as compared with the hyper ne splitting, the ratio $c_2=c_{1;0}$ scales as $_{\rm H\,F}=$.

If the detuning of the light is also large with respect to the ne-structure splitting, then one can neglect the coupling between light and the electronic spin. The sum in (3) then traces out all of the spin degrees of freedom (both electronic and nuclear), leaving only the electronic orbital angular momentum. Consequently, in addition to $c_2=b_2=0$, we have $c_1=b_1=0$, and the atom sbehave as a gas of spherically sym metric scatterers, with an isotropic dielectric tensor. In this regime, the mechanical coupling between light and the atoms does not depend on their initial state. This elect is currently exploited in optical traps in order to obtain a conning potential which traps all spin states in the same way [15].

IV. THE IMAGING METHOD

The simple dependence of the dielectric tensor on the spin and nem atic order param eters (15) is an useful starting point for optically im aging the order param eter of a spin 1 atomic sample. As a simple example, consider a thin, pancake-shaped, Bose-Einstein condensate which is rotating around the sym m etry axis 2. Depending on the relative value of the s-wave scattering lengths a0;2 in respectively the singlet and quintuplet channels, the ground state of the system in the rotating frame show com pletely di erent textures [5]. As two specic exam ples, gs.1a and 2a show the nematicity and spin and patterns for the antiferrom agnetic case, $a_0 < a_2$, and the ferrom agnetic case, $a_2 < a_0$. In the form er case, the condensate shows defects such as -dislocations in the nem atic order parameter N, while the spin S vanishes outside of the cores of these defects. In the latter case, the condensate shows a spin pattern, while the nem aticity ellipsoids are pancake shaped, with their minor axis aligned with the local spin.

We imagine that the imaging beam propagates along 2, i.e. parallel to the rotation axis, and its polarization before interacting with the atoms is given by the two-com ponent, generally com plex, polarization vector $p_{in} = (p_x; p_y)$. We assume the cloud is optically thin and that the length scale of the spin pattern is much larger than the optical wavelength used for the imaging, so that di raction e ects during the propagation through the cloud can be neglected and the atom ic density matrix m can be treated as locally uniform. These assumptions are valid for su ciently detuned light (for typical atom ic densities it su ces that j! $!_0$ j> 100M Hz) and su ciently weak traps ($!_{ho}$ 10 Hz). Sm aller scale feature can be imaged by allowing the cloud to expand ballistically before im aging.

The polarization of the transm itted beam at the transverse position x_2 after propagation through the cloud is given by the following expression in terms of a column integral along the line of sight:

The assumption that the cloud is optically thin implies that the magnitude of the term involving the integral is much smaller than unity. The matrix giving the local refractive index at the spatial position $(x_2;z)$, is dened as the square root $n(x_2;z) = \frac{(x_2)}{(x_2)}$ of the reduced dielectric tensor (x_2) in the (x_2) plane, dened as $(x_2) = P_2$ where P_2 is the projection operator orthogonal to the \hat{z} axis. As one can easily see from (15), (x_2) depends on the density , on the S_z component of the spin and on the $N_{xx,yy,xy,yx}$ components of the nematic order parameter only.

If the incident beam is circularly polarized , the density $\,$ and the spin component S_z both only give a phase




FIG. 1: Nem atic order of a disclination in a rotating spinor BEC with weak aptiferrom agnetic interactions after free expansion for time t. The lengthscale is given by $a = d_{ho} = 1 + (!_{ho}t)^2$, where $d_{ho} = 1 - 2$ and 1_{ho} , and 1_{ho} is the frequency of the harm onic trap in which the disclination formed [23]. Typically, a 100 m. If 1_{ho} is small enough, then in-situ in aging (where t = 0) is possible (0^{87} Rb in an $1_{ho} = 10$ s $1_{ho} = 10$ s $1_{ho} = 10$ s m, and is amenable to in-situ in aging). Panel (a): Two dimensional projections of the nem aticity ellipsoids (16) are shown on a regular grid. A way from the center the ellipsoids are degenerate and appear as rods. Panel (b,c): Images of the disclination using circularly polarized probe light. The intensity of the generated component is shown in (b) and a phase-contrast in age after mixing with the incident light (with phase $1_{ho} = 1_{ho} = 1_{ho}$) is shown in (c). Panel (d): Image of the disclination using light linearly polarized along x and a crossed polarizer, when $1_{ho} = 1_{ho} = 1_{ho} = 1_{ho}$ and a crossed polarizer when the detuning is much greater than the hyper ne splitting so that $1_{ho} = 1_{ho} = 1_{ho}$ and a crossed polarizer when the detuning is much greater than the hyper ne splitting so that $1_{ho} = 1_{ho} = 1_{ho}$ and $1_{ho} = 1_{ho}$ are splitting so that $1_{ho} = 1_{ho} = 1_{ho}$ and $1_{ho} = 1_{ho} = 1_{ho}$ are splitting so that $1_{ho} = 1_{ho} = 1_{ho} = 1_{ho}$ and $1_{ho} = 1_{ho} = 1_{ho}$ and $1_{ho} = 1_{ho} = 1_{ho}$ and $1_{ho} = 1_{ho} = 1_{ho}$ are splitting so that $1_{ho} = 1_{ho} = 1_{ho} = 1_{ho} = 1_{ho} = 1_{ho}$ and $1_{ho} = 1_{ho} = 1_{ho}$

shift. On the other hand, the nem aticity can m ix the two circular polarizations. We assume that the frequency of the imaging light is chosen so to have a signicant coupling c_2 to the nem aticity N (see Appendix). If one illuminates the cloud with pure $_+$ polarized light of amplitude $_+^{(0)}$, the component of the eld after crossing the cloud has the amplitude:

In geometrical terms, a component is generated as soon as the (elliptical) cross-section of the nematicity ellipsoid (16) along the z=0 plane is not circular. After blocking the original $+\infty$ ponent with a polarizer, the intensity of the transmitted light $I=j-\frac{1}{2}$ will be

along the xy plane. In g.1b we have plotted the simulated intensity pro le for a dislocation in a trapped rotating antiferrom agnetic ($a_2 > a_0$) spinor condensate. In the m $_z = (1;0;\ 1)$ basis, we have taken a condensate wavefunction of the form :

w $\frac{\text{ith u} = 1}{\text{mon solution}}$ 22 and the harm onic oscillator length $d_{\text{ho}} = \frac{1}{\text{mon solution}}$ is of the order of m [5]. The corresponding structure of the nematic order parameter is shown

in g.la. In this speci c case, the magnitude of the nem aticity kN k is symmetric under rotations around the \hat{z} axis. The principal axes of N $_{ij}$ rotate by upon circling the disclination center.

M ore inform ation on the structure of the nem atic order param eter can be extracted by using phase-contrast techniques. Denoting with 0 < the angle between the \hat{x} axis and the minor axis of the nem aticity ellipsoid, it follows from (21) that the phase of the generated

component makes an angle =2+2 with respect to the incident $_+$ component. When this component is mixed with the incident $_+$ component (with a mixing phase) in a typical phase-contrast scheme [16], the deviation of the detected intensity from its background value will be proportional to the quadrature $Re[e^i = _+^{(0)}]$. As an example of such an images, we have plotted in glaasimulated image for the = 2 case. The phase of the generated at points x and x dier by as a result of the dierent orientation of the nematic order parameter. Changing the mixing phase rotates this image by .

In experiments on liquid crystals [13], one typically im ages using linearly polarized light. A crossed polarizer on the other side of the sam ple selects out the orthogonal component of the transmitted light. If the nematic order parameter is not parallel or perpendicular to the incident polarization plane, the polarization plane is rotated, and light will be transmitted through the crossed polarizer. The sam e approach can be used here, how ever, the optically active regions where S₇ & 0 can also rotate the polarization plane, making it more dicult to analyze the images. One can isolate the contribution from the nematic order by working at a frequency at which the coupling of light to the spin vanishes, i.e. $c_1 = 0$. A simulated image is shown in g.1d for incident light polarized along x: the detected intensity is maximum along the ŷ axis where the nem atic order param eter makes an angle $=4 \text{ with } \hat{x}$.

We can isolate the contribution from the atom ic spin S by working at a detuning which is large compared to the hyper ne structure of the excited state. In this case, $c_2=0$ and there is no mixing of the components. The dierence between the phase shifts of the components results in the rotation of the polarization plane of a linearly polarized beam by an angle $_{\rm rot}$, which depends on the column integral of $\rm S_z$ as,

$$_{\text{rot}} = \frac{! c_1}{2c} z dz S_z : \qquad (24)$$

The intensity of linearly polarized light passing through a crossed polarizer will be proportional to \sin^2 ($_{\rm rot}$), which in the lim it of an optically thin sample is just $^2_{\rm rot}$. One can thus get a direct measurement of the integrated magnitude of the \hat{z} component of the atom ic spins. In g.le, S_z is plotted for the -disclination, and in g.lf, a simulated image is shown.

Since $_{\rm rot}$ corresponds to the phase shift between the components, one can also measure \pm via phase con-

trast techniques. In g2c we show a simulated phase contrast in age of a texture in a ferrom agnetic gas. In the weakly interacting \lim it [5], this coreless vortex has a wavefunction in the $m_z = (1;0; 1)$ basis given by:

with u = 1.03, v = 0.81, and is illustrated in 2a,b. A gain, d_{ho} m is the oscillator length. In the external region, the spins points downwards, while they reverse direction as one approaches the center. Consequently, the image in g2c shows a low intensity region at the center, and a higher intensity region on a ring of radius $1.8a \ (= 1.8 \, d_{ho}$ for in-situ imaging).

If the system shows a repeated pattern of vortices or -dislocations instead of a single one, the imaging may be better performed in the fareeld plane. The amplitude of the B ragg-diracted light in the direction $(k_2;k_2)$ is proportional to the Fourier transform of the emerging eld after interaction with the cloud. As an example, we have plotted in g.3b the B ragg diraction pattern for the lattice of -disclinations shown in g.3a; the incident light is + polarized and diracted light is observed. The periodicity of the lattice results in an evenly spaced series of isolated diraction peaks whose strengths and geom etrical arrangement give the detailed geometry of the lattice.

V. CONCLUSIONS

In sum m ary, we have presented a novel technique for both the in-situ and post-expansion in aging of spin textures in gaseous spin-1 atom ic Bose-Einstein condensates. The technique is based on the dependence of the dielectric tensor on the local value of the density and of the spin and nem atic order parameters. By considering a series of dierent spin textures, and detection schemes, we demonstrated how a range of physical quantities, such as the z component of the spin, and the magnitude and the orientation of the nem atic order parameter can be imaged.

This polarized imaging technique can also be used to distinguish between states with and without spin order: both nematic and spin singlet states have been in fact predicted for antiferrom agnetically interacting spin-1 atoms in an optical lattice [24].




FIG. 2: Panel (a,b): geometrical structure of coreless vortex in a trapped rotating spinor BEC with weak ferrom agnetic interactions. Lengthscale a is explained in gure 1. In (a), arrows represent the in-plane component of the spin, while (b) shows the radial dependance of the 2 component. Panel (c): image of the coreless vortex by detecting the phase dierence between the transmitted components.




FIG. 3: Panel (a): Nem attic order in array of disclinations. The closest distance between disclinations whose cores have the same spin polarization is D = $\frac{p}{\sqrt{m}}$, where is the rotation speed (23 Na rotating at = $10s^{-1}$ has D = 17m). As in gure 1, this im age scales under free expansion. Panel (b): D i raction pattern seen in light when + light is incident on this array of disclinations. k_x and k_y are the transverse wave vectors of the directed light.

D ispersive imaging techniques, such as this one, require that absorption is negligible. M inimizing absorption is also crucial if one w ishes to make in-situ m easurements, as the absorption and subsequent spontaneous

em ission processes heat the sample. The present im aging scheme of the nematic order parameter requires detunings = ! ! $_0$ not too large than the hyper ne splitting in order to have a signicant coupling c_2 of light to the nematic order parameter.

Since for the D $_1$ line $_{\rm H\ F}$ = is of the order of a few tens [21], absorption can be avoided while still keeping $c_2 = c_{0;1}$ of order unity. These detunings are of the same order as those used in the experiments of [19] and the signals are therefore readily measured.
