# Im aging of spinor gases

#### Abstract

W e explore the dielectric properties of spinor condensates. G ases w th vector (nem atic) order, such as spin-1 condensates w ith ferrom agnetic (antiferrom agnetic) interactions, display optical activity (birefringence). This optical activity/birefringence is respectively seen for light detuned from resonance by a frequency which is not too large com pared w ith the ne/hyper ne structure. C areful tuning of the light frequency can isolate either of these tw o e ects. These features can be used to im age spin textures in clouds of spin 1 bosons, and to discem states show ing di erent types of spin order.

## I. INTRODUCTION

Super uids display dram atic rotationalproperties. For exam ple, arrays of quantized vortices have been observed in rotating gaseous spin-polarized ${ }^{87} \mathrm{Rb}$ and ${ }^{23} \mathrm{~N}$ a B oseE instein condensates (B E C s) [1] [1]. T he physics of rotating system $s$ is even richer in the presence of spin degrees of freedom : thanks to the intenplay of the spin and translational degrees of freedom, sim ple vortioes are replaced by $m$ ore com plicated spin textures. These textures have been studied in $m$ any di erent contexts, from ${ }^{3} \mathrm{He}$ e- $\bar{M}_{1}^{[1]}$ to quantum $H$ all.system $s$ [3] and, $m$ ore recently, trapped
 to three dim ensional skym ion and hedgehog structures which could be engineered in clouds of trapped atom $s$ [ [ilil$]$.

T heoretical studies have analyzed the structure of spin textures in rotating spinor BECs for di erent values of the spin, the trap rotation frequency, and the atom -atom interactions $\left[\underline{4}_{1}^{1}, \underline{1} \underline{N}_{1}^{1}\right]$. Experim_ental studies, beginning $w$ ith pseudo-spin $-1=2$ system $\left.\left.s{ }^{-1}\right]_{1}\right]$ and continuing $w$ ith spin1 and spin-2 condensates []$\left._{1}\right]$, have observed individual spin textures. T hese experim ents are com plem ented by studies ofspin dynam ics in non-rotating spin-1 and spin-


In $m$ ost of these experim ents [10], im aging is perform ed by rst separating the di erent spin com ponents using a $m$ agnetic eld gradient (the $m$ ethod pioneered by Stem and $G$ erlach []$\left.\left._{1}^{1}\right]\right)$. The spin com ponents are then separately im aged via conventional optical absonption or phase contrast techniques. This approach is intrinsically destructive and is unable to probe coherences betw een the di erent spin com ponents. M oreover, im ages of the individual com ponents are very sensitive to global rotations of the order param eter

In the present paper, we propose a di erent im aging schem ew hich is predicted to provide non-destructive, insitu, im ages of the spin textures and which directly addresses the geom etrical features of the B EC order param eter (density, spin, and nem aticity pro les) rather than its com ponents in som e speci $c$ basis. T he $m$ ethod re-

Hies on the dependence of the dielectric properties of a spinor atom ic gas on the intemal state of the atom s. Focussing our attention on the case of spin-1 atom $s$, we derive a simple expression for the local dielectric tensor ${ }_{i j}(x)$ in term s of the localdensity $(x)$, spin density $S(x)$, and quadrupolar (nem atic) orderparam eter $N_{i j}(x)$ of the atom ic gas. U sing this expression for $i j(x)$, we then study the propagation of polarized light across an atom ic cloud: we show how inform ation about the spatial pro le of the spin texture can be retrieved by analyzing the intensity, phase, and polarization pro le of the transm itted light. O ur technique has analogies in other areas of condensed $m$ atter physics: the polarization of the electrons in a solid-state sam ple [12"] as well as the order param eter of nem atic liquid crystals [13] can be m easured by looking at polarization changes in a transm ilted, di racted, or re ected light. As the order param eter ofspin-1 atom ic system $s$ is a three-com ponent com plex eld, it can sim ultaneously have non-vanishing vector (spin) and tensor (nem atic) com ponents: we discuss possible w ays of isolating the contribution of each of them.

## II. THE LIGHT-MATTER COUPLING HAM ILTONIAN

T he electric-dipole H am ittonian describing the interaction of light $w$ ith a tw o-level atom can be w ritten in a second-quantized form as:

The atom ic eld operators ${ }^{\wedge}(x)$ and ${ }^{\wedge}(x)$ destroy an atom at spatialposition $x$ in respectively the sublevel of the excited state or the sublevel of the ground state. $\hat{E}_{i}(x)$ is the i-com ponent of the electric eld operator at $x$ and $D{ }_{i}=$ he $j_{i} \dot{j}: i$ gives the $m$ atrix ele$m$ ent of the i-com ponent of the electric dipole m om ent
betw een the sublevels and of respectively the excited and ground state.

For light frequencies! w elldetuned from the resonance frequency ! o of the $g$ ! e transition, we can elim inate the excited state and w rite an e ective H am iltonian for the ground state atom s coupled to the electrom agnetic eld:

the indices and run over the ground state sublevels and runs over the excited state sublevels.

In our case of spin 1 atom s , the m atter eld is a three-com ponent vector and can be written in terms of its (operator-vahued) C artesian components as ~ =

The totally antisymmetric unit tensor is denoted ${ }^{j \mathrm{jkl}}$. P hysically, the scalar corresponds to the total density, the vector $S$ to the spin density, and the second-rank, sym $m$ etric tensor $N$ to the nem aticity (or quadrupole m om ent). A $n$ identical decom position into the intensity $I$, the spin density and the nem aticity $N$ can be perform ed for the electrom agnetic eld one-body density $m$ atrix de ned as $f_{i j}=\hat{E_{i}^{y}} \hat{E_{j}}$.

Aswe assum e no extemal eld is present to break rotational invariance, the H am iltonian is a scalar (that is spin 0) ob ject. Scalar ob jects can be found in the tensor product of tw o quantities only if the tw o quantities have the sam e spin. This im plies that the H am iltonian $\underline{(1)}^{1}$ ) can be decom posed in the form :

where the three real coe cients $\mathrm{b}_{0 ; 1 ; 2}$ depend on the intemal structure of the atom and on the frequency of the

In the next section, we give explicit expressions for the $U$ tensor and the $b_{i}$ coe cients for a few sim ple cases.
III. THE D IELECTRIC TENSOR OFA SP IN 1 G A S

The form $[\overline{1})$ of the light -m atter H am iltonian can be used for studying the optical potential induced by light on atom s , as wellas the refractive index observed by light while crossing the atom ic sam ple.

In the rst case, a scalar potential com es from the local intensity $I(x)$ of light, a pseudo-m agnetic eld com es from the electrom agnetic spin (x), and the $N(x)$ tensor couples to the nem aticity $N(x)$ of the atom s. A rst application of th is form alism has been given in 1 , where e ects arising from a kind of spin-orbit coupling induced by the pseudo-m agnetic eld are analyzed for atom s propagating in suitably designed optical lattices.

In the present paper, we concentrate on the second class ofphenom ena, nam ely on how the opticalproperties of the atom ic cloud depend on the spin state of the atom s; in particular we shall discuss how the polarization state of a light beam after crossing the atom ic sam ple can be used to obtain inform ation on the spin state of the atom s .

## A. The general structure of the dielectric ten sor

U nder a m ean- eld approxim ation in which the quantum correlations betw een the $m$ atter and the light eld are neglected, a w ave equation for the eigenm odes of the electrom agnetic eld in a hom ogeneous medium can be directly obtained from the H am iltonian $(\overline{\mathrm{Z}})$ :

where 1 is the identity $m$ atrix, the pro jector $P$ ? pro jects orthogonally to the $w$ avevector $k$ and the tensor has been de ned as:

where $c_{j}=2 b_{j}=0$. The scalar term proportional to $c_{0}$ corresponds to the isotropic polarizability of the atom $s$, while the vector term proportional to $c_{1}$ describes their optical activity around the axis de ned by the atom ic spin S.F inally, the tensor term proportional to $c_{2}$ gives birefringence e ects, whose principal axis coincide $w$ ith the ones of the nem aticity ellipsoid de ned as:

The $m$ atrix elem ents $D_{i j k}$, and hence the coe cients $C_{j}$ can be related to the line width of the atom ic transition [18 1 . For the fundam ental $D_{1 ; 2}$ transitions of a typicalalkaliatom such as ${ }^{23} \mathrm{Na}$ or ${ }^{87} \mathrm{Rb}, \quad 5 \mathrm{IO} \mathrm{s}^{1}$ and $\dot{\zeta}_{j} j \quad 10{ }^{15} \mathrm{~cm}^{3}=j!\quad$ ! oj. A typical in-situ im aging setup [1] uses detunings in the G H $z$ range (which are large enough that absonption e ects can be ignored (2011), and atom ic densities of order $10^{14} \mathrm{~cm}^{3}$, resulting in a dielectric tensor which di ers from unity by an am ount of $m$ agnitude $\ddot{j}$ 1 $j 10^{2}$. As we shall see in section 'IIIC', quantum interference e ects can drastically reduce the $m$ agnitude of any given $c_{j}$ in som e speci $c$ frequency dom ains.

## B. The dielectric tensor for a single transition

The coe cients $C_{i}$ in the param etrization (15) of the dielectric tensor depend on the intemal structure of the atom. Since the ground state has been assum ed to have spin $F_{g}=1$, absorbing a photon can bring the atom $s$ into excited states of angular $m$ om entum $F_{e}=0 ; 1 ; 2$. In the present subsection, we shall derive a sim ple expression of the $c_{i}$ coe cients in term $s$ of the strength of the optical transition for the case where only one excited multiplet is involved. For notational sim plicity we om it the angular brackets denoting expectation values of $m$ atter eld operators.

For $\mathrm{F}_{\mathrm{e}}=0$, the D tensor in Cartesian com ponents ( $j ; k=f x ; y ; z g$ ) has the form $D_{0 j k}=D_{0} j k$, so the dielectric tensor is:

This result has a sim ple intenpretation: a photon polarized along the C artesian axis $j$ interacts only $w$ th the com ponent of the $m$ atter eld along the sam e axis.

M ore speci cally, $\mathrm{D}_{2}$ is de ned as the electric dipole $m$ atrix elem ent betw een the $m_{F}=1$ sublevel of the ground state and the $m_{F}=2$ sublevelof the excited state. $T$ hem atrix elem ents of the transitions betw een the other sublevels are related to $\mathrm{D}_{2}$ by the appropriate C lebsch- G ordan $\mathrm{CO}^{-}$ e cients.

> C. E ect of the ne and hyper ne structures of the atom

If $m$ ore than one excited state is involved in the opticalprocess, the e ective coupling $U$ of the ground state atom s to the light is given by the sum of the contributions $(\overline{3})$ ) of each single excited state, each of them being weighted by a factor $1=\left(!_{i} \quad!\right)$, where $\sim!_{i}$ is the excitation energy and ! the light frequency. C learly, the result w illbe dom inated by the states $w$ hich are closest to resonance. By tuning to frequencies where the contributions from di erent excited states cancel, one can take advantage of quantum interference e ects to $m$ ake at least one of the coe cients $\mathrm{C}_{0 ; 1 ; 2}$ vanish.

For exam ple, considerable sim pli cation is found if the detuning is large com pared to either the ne or hyper ne splitting. C onsider the fundam entalnS ! nP transition ofan alkaliatom such as ${ }^{23} \mathrm{~N}$ a or ${ }^{87} \mathrm{Rb}$ : the $\mathrm{S}=1=2$ electronic spin couples to the excited state's $L=1$ electronic orbital angular $m$ om entum to produce two ne com ponents of total electronic angular $m$ om entum $J=1=2$ or

3＝2．T he ground state，having instead a vanishing onbital angular $m$ om entum $L=0$ ，contains a single ne com－ ponent of total electronic angular $m$ om entum $J=1=2$ ． Both ${ }^{23} \mathrm{Na}$ and ${ }^{87} \mathrm{Rb}$ have a nuclear spin of $I=3=2$ ： coupling betw een the nuclear and electronic spins there－ fore result in the ground state splitting into tw o hyper ne com ponentsw ith $\mathrm{F}=2$ and $\mathrm{F}=1$（in this paperwe lim it ourselves to $F=1$ ）．The $J=1=2 ; 3=2$ ne com ponents of the excited state respectively split into tw o hyper ne com ponents of $F=1 ; 2$ ，and four hyper ne com ponents of $F=0 ; 1 ; 2 ; 3$ ．For these alkali atom $s$ ，the ne struc－ ture separation betw een the $D_{1}\left(S_{1=2}!P_{1=2}\right)$ and $D_{2}$ $\left(S_{1=2}!P_{3=2}\right)$ lines is of the order of THz．Hyper ne structure，resulting from the much weaker coupling be－ tween the electron and the nucleus，am ounts to a few GHz for the electronic ground state and to a fraction of G H z for the excited state［21］．

If the detuning of the light is much larger than the hyper ne splyting HF ，the nucleus，whose direct cou－ pling to radiation is extrem ely weak，is not expected to play any role in the dynam ics．In this regim e，the fre－ quency denom inators in the contributions（ $(\overline{3})$ ）to the $U$ tensor com ing from the di erent hyper ne com ponents are approxim ately equal．Consequently，$U$ acts as the identity m atrix in the space of nuclear states．It im － $m$ ediately follow s that the dielectric tensor（ $\underline{1}_{1}^{14} \underline{1}_{1}^{\prime}$ ）only de－ pends on the electronic part of the atom ic density $m$ atrix， $m^{(e)}=T r_{n}[m]=m_{I} h m_{I} j m \operatorname{m}_{I} i^{\prime}$ ，where the index $m_{I}$ runs over the $2 I+1$ possible nuclear spin states．A s the totalelectronic angularm om entum of the ground state is $J=1=2$ ，the decom position analogous to the ones in $\left(\bar{T}_{1}\right)$ and（1－15）now gives tw o com ponents of angular $m$ om en－ tum respectively 0 and 1 ，but no com ponent of angular $m$ om entum 2．In physical term $s$ ，this $m$ eans that，once the sum over the hyper ne com ponents of the excited state is perform ed，one has $c_{2}=b_{2}=0$ and no birefrin－ gence e ect nor any $m$ echanical coupling of light to the nem atic order param eter N can be present．The coe－ cients $c_{1}$ and $c_{0} w i l l$ ，how ever，generally be non－zero $\left[\sum_{2}^{2} Z_{1}^{\prime}\right]$ ． For a large but nite detuning as com pared w the the $\bar{y}-$ per ne splitting，the ratio $C_{2}=C_{1} ; 0$ scales as $H F=$ ．

If the detuning of the light is also large $w$ ith respect to the ne－structure splitting，then one can neglect the coupling betw een light and the electronic spin．T he sum in（ $\mathbf{N}_{1}^{\prime}$ ）then traces out all of the spin degrees of freedom （both electronic and nuclear），leaving only the electronic orbital angular m om entum．C onsequently，in addition to $c_{2}=b_{2}=0$ ，we have $c_{1}=b_{1}=0$ ，and the atom $s$ be－ have as a gas of spherically sym $m$ etric scatterers，$w$ ith an isotropic dielectric tensor．In this regim $e$ ，the $m$ echanical coupling betw een light and the atom $s$ does not depend on their initial state．This e ect is currently exploited in optical traps in order to obtain a con ning potential which traps all spin states in the sam e way［15］．

IV．THE IMAGINGMETHOD

The sim ple dependence of the dielectric tensor on the spin and nem atic order param eters $\left(\overline{1}\left[{ }^{-} \underline{I}\right)\right.$ is an usefulstart－ ing point for optically im aging the order param eter of a spin 1 atom ic sam ple．As a simple exam ple，consider a thin，pancake－shaped，B ose $E$ instein condensate which is rotating around the sym $m$ etry axis $z$ ．D epending on the relative value of the $s$ wave scattering lengths $a_{0 ; 2}$ in respectively the singlet and quintuplet channels，the ground state of the system in＿the rotating fram e show
 ples，gs，$\overline{1} 2$ pattems for the antiferrom agnetic case，$a_{0}<a_{2}$ ，and the ferrom agnetic case， $\mathrm{a}_{2}<\mathrm{a}_{0}$ ．In the form er case，the condensate shows defects such as－dislocations in the nem atic order param eter $N$ ，while the spin $S$ vanishes outside of the cores of these defects．In the latter case， the condensate show s a spin pattem，while the nem atic－ ity ellipsoids are pancake shaped， w th their m inor axis aligned w ith the localspin．

W e im agine that the im aging beam propagates along全，i．e．parallel to the rotation axis，and its polariza－ tion before interacting $w$ th the atom $s$ is given by the tw o－com ponent，generally com plex，polarization vector $p_{\text {in }}=\left(p_{x} ; p_{y}\right) . W$ e assum e the cloud is optically thin and that the length scale of the spin pattem is much larger than the opticalw avelength used for the im aging， so that di raction e ects during the propagation through the cloud can be neglected and the atom ic density $m$ atrix m can be treated as locally uniform．These assum ptions are valid for su ciently detuned light（for typical atom ic densities it su ces that j！！oj＞ 100 MHz ）and su－ ciently w eak traps（！ho 10 Hz ）．Sm aller scale feature can be im aged by allow ing the cloud to expand ballisti－ cally before im aging．

The polarization of the transm itted beam at the trans－ verse position $\mathrm{x}_{\text {？}}$ after propagation through the cloud is given by the follow ing expression in term $s$ of a colum $n$ integral along the line of sight：

O $n$ the other hand, the nem aticity can $m$ ix the two circular polarizations. $W$ e assum $e$ that the frequency of the im aging light is chosen so to have a signi cant coupling $c_{2}$ to the nem aticity $N$ (see A ppendix). If one ilum inates the cloud w ith pure + polarized light of am plitude ${ }_{+}^{(0)}$, the com ponent of the eld after crossing the cloud has the am plitude:

In experim ents on liquid crystals [ $[13]$ ] $]$, one typically im ages using linearly polarized light. A crossed polarizer on the other side of the sam ple selects out the orthogonal com ponent of the transm ilted light. If the nem atic order param eter is not parallel or penpendicular to the incident polarization plane, the polarization plane is rotated, and light w ill be transm itted through the crossed polarizer. T he sam e approach can be used here, how ever, the optically active regions where $S_{z} \in 0$ can also rotate the polarization plane, $m$ aking it $m$ ore di cult to analyze the im ages. O ne can isolate the contribution from the nem atic order by working at a frequency at which the coupling of light to the spin vanishes, i.e. $c_{1}=0$. A sim ulated im age is show $n$ in $g$ Ind for incident light polarized along $x$ : the detected intensity is $m$ axim um along the $\hat{y}$ axis $w$ here the nem atic order param eter $m$ akes an angle $=4 \mathrm{w}$ th $\hat{x}$.

W e can isolate the contribution from the atom ic spin $S$ by working at a detuning which is large com pared to the hyper ne structure of the excited state. In this case, $c_{2}=0$ and there is no $m$ ixing of the com ponents. $T$ he di erence betw een the phase shifts of the com ponents results in the rotation of the polarization plane of a linearly polarized beam by an angle rot, which depends on the colum $n$ integral of $S_{z}$ as,

T he intensity of linearly polarized light passing through a crossed polarizerw illlbe proportionalto $\sin ^{2}($ rot $)$, which in the lim it of an optically thin sample is just ${ }_{\text {rot }}^{2}$. O ne can thus get a direct $m$ easurem ent of the integrated $m$ agnitude of the $\hat{z}$ com ponent of the atom ic spins. In g, $S_{z}$ is plotted for the -disclination, and in g'ly, a simulated im age is show.

Since rot corresponds to the phase shift betw een the com ponents, one can also m easure it via phase con-
trast techniques. In $g$ TC we show a sim ulated phase contrast im age of a texture in a ferrom agnetic gas. In the weakly interacting lim it $\left.\underline{5}_{1}^{1}\right]$, this coreless vortex has a wavefunction in the $m_{z}=(1 ; 0 ; 1)$ basis given by:

In the extemal region, the spins points dow nw ards, while they reverse direction as one approaches the center. C onsequently, the im age in 9 2how show intensity region at the center, and a higher intensity region on a ring of radius 1:8a (= 1:8 $\mathrm{d}_{\mathrm{h}}$ for in-sith im aging).

If the system show s a repeated pattem of vortices or -dislocations instead of a single one, the im aging $m$ ay be better perform ed in the far- eld plane. T he am plitude of the $B$ ragg-di racted light in the direction $\left(k_{\text {? }} ; \mathrm{k}_{\mathrm{z}}\right)$ is proportional to the Fourier transform of the em erging eld after interaction w th the cloud. A s an exam ple, we have plotted in $g$ 了ై the lattioe of disclinations show in 9 Tha; the incident light is + polarized and di racted light is observed. The periodicity of the lattice results in an evenly spaced series of isolated di raction peaks whose strengths and geom etrical arrangem ent give the detailed geom etry of the lattice.

## V. CONCLUSION S

In sum $m$ ary, we have presented a novel technique for both the in-situ and post-expansion im aging of spin textures in gaseous spin-1 atom ic Bose E instein condensates. The technique is based on the dependence of the dielectric tensor on the local value of the density and of the spin and nem atic order param eters. By considering a series of di erent spin textures, and detection schem es, we dem onstrated how a range ofphysicalquantities, such as the $z$ com ponent of the spin, and the $m$ agnitude and the orientation of the nem atic order param eter can be im aged.

This polarized im aging technique can also be used to distinguish betw een states $w$ ith and without spin order: both nem atic and spin singlet states have been in fact predicted for antiferrom agnetically interacting spin1 atom $s$ in an optical lattice [24].

D ispersive im aging techniques, such as this one, require that absonption is negligible. M inim izing absonption is also crucial if one $w$ ishes to $m$ ake in-situ $m$ easurements, as the absonption and subsequent spontaneous
em ission processes heat the sam ple. $T$ he present im aging schem e of the nem atic order param eter requires detunings $=$ ! ! o not too large than the hyper ne splitting in order to have a signi cant coupling $c_{2}$ of light to the nem atic order param eter.
