Ordered phases of X X Z-sym m etric spin-1/2 zigzag ladder

U sing bosonization approach, we derive an e ective low energy theory for X X Z -sym m etric spin-1/2 zigzag ladders and discuss its phase diagram by a variational approach. A spin nem atic phase emerges in a wide part of the phase diagram, either critical or m assive. Possible crossovers between the spontaneously dimerized and spin nem atic phases are discussed, and the topological excitations in all phases identi ed.

I. IN TRODUCTION

The appearance of unconventional spin-liquid phases in frustrated Heisenberg models around a critical point separating di erent magnetic ordered phases is a long standing, intriguing issue which has attracted notable theoretical and experimental interest in recent years¹. From a theoretical point of view, this is quite a challenging problem which calls for a deep reexam ination of standard theories. Conventionally, the stability of a spinordered phasem ay be investigated by spin-wave theory or by more sophisticated eld-theoretical approaches based on the non-linear -m odel. Spin-wave theory is in principle able to detect instabilities at any wave-vector, although a reliable description would require a system atic 1=S expansion, S being the magnitude of the spin. The non-linear -modelo ers a better description of the critical behavior close to an instability point, yet it has a m a pr lim itation. Namely, it takes into account only the long-wavelength Goldstone modes of the ordered state under consideration, but fails to describe the excitations at the wave-vector of the competing ordered state. Hence it does not provide any information about the phase which can emerge under increasing the e ect of frustration.

O ne-dim ensional spin m odels m ight turn useful to attempt an improvement of the eld-theoretical approach in view of an extension to higher dimensions. The sim – plest example of one-dimensional frustrated spin m odel is the spin-1/2 H eisenberg chain with antiferrom agnetic nearest neighbor exchange J ⁰ and frustrating next nearest neighbor exchange J. (for a recent review and references therein, see R ef2). Besides the general interest, this m odel is also relevant for realistic materials, such as C s₂C uC l₄, in which m agnetic C u ions get arranged into a zig-zag fashion.³

In the classical limit, the $J-J^0$ spin chain has a Neel long range order for $j = J=J^0 < 1=4$, with characteristic m om entum $q = =a_0$. In the Neel phase time reversal symmetry is preserved if combined with a translation by one lattice spacing a_0 . For larger values of j, a spiral ordering at momentum satisfying $cos(qa_0) = 1=4j$ is stabilized at the classical level. There parity and time reversal symmetries are separately broken.

Q uantum uctuations modify the classical phase diagram⁴. By Mermin-Wagner's theorem, spin rotational symmetry cannot be broken in one dimension: the Neel long-range ordered phase turns into a quasilong range ordered one characterized by power-law decaying correlations of the staggered m agnetization. The low-energy e ective critical theory is the level-1 W ess-Zum ino-Novikov-W itten (W ZNW) m odel (free m assless bosons with central charge C = 1). On the contrary, the spiral order disappears com pletely in favor of a spontaneoulsy dimerized phase. The transition point is slighly shifted with respect to the classical value, $j_{\rm c}$ ' 0:241^{5,6}. W ithin the W ZNW model formalism, the transition is driven by a perturbation which is marginally irrelevant (relevant) at j < j_c (j > j_c). At j = j_c a Berezinskii-Kosterlitz-Thouless transition takes place, and an exponentially small spectral gap opens up in the region $j > j_c^7$. The system continuously passes to a two-fold degenerate, spontaneously dim erized, m assive phase. U pon further increasing j, the gap reaches its maximum at the exactly solvable M a jum dar-G hosh point⁸, j = 1=2, after which it slow ly decreases⁷. Even though the ground state of the $J-J^0$ chain remains dimerized at all $j > j_c$, above the Majum dar-Ghosh point the system reveals signatures of the classical spiral phase: the spin-spin correlations becom e incom m ensurate, as it was shown num erically in Refs.7,9. Since this occurs far away from the region of applicability of the SU $(2)_1$ W ZNW model, there is little scope to improve the eld-theoretical description of the gapless phase at $j < j_c$ to account for incom m ensurate correlations that emerge well above j. More prom ising is to approach this problem from the opposite side, 1. If $J^0 = 0$, the even and odd sublattices of the i spin chain decouple, and the model e ectively describes two decoupled Heisenberg chains, one for each sublattice. C lassically this corresponds to the case when the spiral wave number is equal to $q = = 2a_0$. Switching on a sm all J⁰ transforms the model to a weakly coupled two-chain zigzag spin ladder, with the interchain coupling giving rise to a marginally relevant perturbation that opens up a gap and brings the system back to the dim erized phase.

In addition it should also move the relevant momentum q away from $=2a_0$ towards $=a_0$. Therefore incommensuration and the spectral gap are supposed to appear together in this limit, which makes a eld-theoretical description more plausible.

Indeed, in the lim it j 1, a novel, parity-breaking (twist) perturbation was identi ed in Ref. 10 as a natural sourse of the spin incom mensurabilities. The twist term has a tendency to support a nite spin current along the chains which would account for the expected shift of the m om entum. H ow ever, for the SU (2)-sym m etric zigzag ladder, the situation still remains rather unclear. Apparently, the appearance of a nonzero spin current is not com patible with the requirem ent of unbroken spin rotational sym m etry (see, how ever, the discussion in sec.V II). On the other hand, no reliable inform ation about the actual role of the twist operator at the strong-coupling xed point can be extracted from the Renorm alization G roup (RG) analysis¹⁰ because of the perturbative nature of this approach. Thus, the structure of the low -energy e ective eld theory for the SU (2)-sym m etric S= 1/2 zigzag ladder still rem ains unknown.

The situation changes much to the better in the presence of strong spin anisotropy. Namely, close to the XX lim it, a self-consistent, sym m etry-preserving m ean-eld approach shows that the twist operator can stabilize a new, spin-nem atic (chiral) phase¹⁰. In this doubly degenerate phase a nonzero spin current polarized along the easy axis ows along the ladder, and the transverse spin-spin correlations are incom m ensurate and m ay even decay algebraically within some parameter range, as it is the case at the XX point. This picture is supported by recent num erical simulations^{11,12,13,14}. In particular, the num erical work by H ikihara et al^{11,12} has indeed conm ed the existence of the critical spin-nem atic phase in a broad region of the phase diagram for spin-anisotropic chains, both for integer and half-integer spins. NMR experiments with compound CaV₂O₄¹⁵ having a spin-1 double-chain zigzag magnetic structure have revealed the gapless nature of the spectrum, which may be an indication to the critical chiral state of this material. On the other hand, num erical sim ulations have revealed the existence of a new gapped chiral phase in a very narrow region between the dimerized phase and the critical chiralphase, but, within num erical accuracy, only for integer spins. In that gapped phase, the spin current coexists with dimerization; accordingly, the spin-spin correlations are incommensurate but decay exponentially. Recently the phase diagram for general spin S has been studied by bosonization technique¹⁶ and by means of the nonlinear -m ode¹⁷, verifying the existence of both critical and gapped chiral phased for integer spin.

In this paper we present a detailed study of the phase diagram of the XXZ-symmetric, frustrated, spin-1/2 chain in the lim it $J^0 ext{J.Using a variational analysis of the bosonized H am iltonian we identify possible phases of the model. In addition to the critical spinnematic phase and to the commensurate spontaneously$

dimerized one, we nd conditions for the existence of a massive spin-nem atic region for the S = 1=2 case. We also characterize the topological excitations which occur in each region of the phase diagram.

In the following section we introduce the model and discuss the bosonization approach. In section III we demonstrate how the variational approach can be applied to the twistless ladder, in which only the dimerization operator plays a role. Critical spin nematic phase, driven only by the twist operator, is studied in section IV. The interplay between dimerization and twist operator and other emerging phases is discussed in section V. In section V I we discuss a ferrom agnetic phase which turns out to be dual to the critical spin nematic phase. In section V II the RG approach is in plemented to study the interplay between di erent twist operators at the border of these mutually dual phases. The last section contains conclusions.

II. THE MODEL AND ITS LOW -ENERGY LIM IT

We consider a frustrated spin-1/2 Heisenberg chain with 2L sites, described by the Ham iltonian

In what follows, and 0 will be treated as independent an isotropy parameters. Upon the transformation

Let us discuss som e general properties of this m odel. In the lim it J = 0, (1) describes a standard H eisenberg antiferrom agnetic chain where the spin-spin correlations are m odulated with wavevector q = 0. On the contrary, when $J^0 = 0$, the equivalent m odel (3) describes two decoupled spin chains. The m odulating wavevector in this case is q = -2. When both J and J^0 are nite, we may expect two possible behaviors of the spin structure factor S (q) = (2L) $\int_{n,m}^{n} hS_n$ is $e^{iq(n-m)}$: either it is peaked at q = -2, or it shows a single peak at an incommensurate q_0 which smoothly moves

from q = =2 at J J⁰ towards $q = w hen J^0 J$. Translated into the zig-zag ladder language, the former case im plies that, for n large,

where $F_0(\dot{n})$, $F(\dot{n})$ and $F_{=2}(\dot{n})$, as well as the primed ones, are smooth real functions describing the contributions of the q = 0, q = and q = =2 modes, respectively. The di erence between the 1-2 and 2-1 spin-spin correlators, as well as the absence of inversion sym - metry n ! n, re ect the fact that the zigzag ladder lacks two Z_2 symmetries { the 1 \$ 2 interchange symmetry and site parity P_S (understood as $P_S^{(1)} = P_S^{(2)}$). How - ever, if the model is gapless or possesses a small spectral gap inducing a macroscopically large correlation length, then site-parity is e ectively restored at long distances.

If, apart from q = 0, the spin structure factor has a peak at an incommensurate wave vector $q_0 \ 2 \ [=2;]$, then we expect that

W e notice that the presence of the m odulating factors in (4),(5) m akes the the breakdown of P_s even m ore pronounced and, contrary to the commensurate case, this breakdown will survive the continuum limit we are going to adopt. Thus, the two di erent types of spin correlations { commensurate or incommensurate { can be distinguished within a continuum, low energy description by an asymptotic restoration or breakdown of the site-parity symmetry.

As discussed in the Introduction, in this paper we are going to study the model (3), or equivalently (1), in the lim it J J^0 of weakly coupled chains. That allows us to adopt the well-known continuum description of each XXZ chain based on the bosonization approach¹⁸ (see also Ref. 19 for a recent review) and then treat the interchain coupling as a weak perturbation. Bosonization of the XXZ zigzag spin-1/2 ladder has already been discussed in Ref20. Here we review this procedure in more detail paying attention to the structure of the elective continuum model which is in portant for the subsequent analysis of the phase diagram.

W e start with the A belian bosonization of a single X X Z spin-1/2 chain. Its universal, low energy properties in the gapless Luttinger liquid phase (1 < 1) are adequately described by the G aussian m odel for a m assless

Here $\#(x) = \prime_{R}(x) + \prime_{L}(x)$ is the eld dual to $\prime(x)$, $Q_x # (x)$ being the momentum conjugate to (x) = Ja, is the velocity of the collective spin '(x), v_s excitations, and Q is the the Luttinger liquid param eter which determ ines the compacti cation radius of the eld '. The dependence Q = Q () in the whole range 1 < 1 is known from the Bethe-ansatz solution: 1=Q = 1(1=) arccos . Thus Q varies in the range 1 > Q 1 when takes values within the interval 1 < 1. In particular, Q = 2 at the XX point (= 0), and Q = 1 at the SU (2)-sym m etric (H eisenberg) point (= 1). Throughout this paper it will be assumed that < 1 (i.e. Q > 1). In this case the perturbation to the Gaussian model (6), $_{\rm U}$ cos¹ 8 ' (U J); which in term softhe Jordan-W igner ferm ions originates from Um klapp processes, is strongly irrelevant and will be dropped in what follows.

Since for each chain only the uniform and staggered low energy modes survive the continuum limit, the corresponding spin densities can be parametrized as follows:

Here a_0 is the lattice spacing, $J_{1;R\,;L}$ are chiral components of the smooth part of the magnetization of the i-th chain, and n_i is the staggered magnetization. The latter is even under site parity transformation ($P_{\rm S}$) and odd under link parity transformation ($P_{\rm L}$). A distinctive feature of the zigzag ladder is that it is invariant under mixed parity: $P_{\rm S}^{(1)}$ $P_{\rm L}^{(2)}$ and $P_{\rm L}^{(1)}$ $P_{\rm S}^{(2)}$. By this symmetry, strongly relevant terms, $n_1^a n_2^a$, which determine the spin-liquid properties of the unfrustrated spin-1/2 ladders^{21}, are instead forbidden in model (3). As a result, in the low-energy limit, the interchain perturbation, H 0 = H $_{\rm JJ}$ + H $_{\rm tw\,ist}$; is contributed by the \current-current" interaction 7,22

are chirally asymmetric operators with conformal spin 1, and $_{i}$ ($1_{i}^{p}S_{i}(n)$ S(n + 1) represent the continuum lim it of the dimerization operators. (Note that for a single chain (x) is even under P_L and odd under P_S .) The coupling constants are given by $g_x = g_y$ $g_z = J^0 a_0$; $g_z = g_z = J^0 a_0$:

The \current-current" and twist perturbations are of di erent nature. The form er are parity [i.e. $P_{S(L)}^{(1)}P_{S(L)}^{(2)}$] symmetric. If acting alone, provided that the interchain exchange is antiferrom agnetic, these lead to spontaneous dimerization of the ground state (see section III), the existence of massive topological excitations (spinons), and the onset of short-ranged commensurate interchain spin correlations^{7,23}. The twist term s, whose appearance stems from the frustrated nature of interchain interaction, explicitly break parity. However, by the previous discussion, parity can be broken either in a mild way, which is the case when the leading asymptotics of spinspin correlations are still commensurate, or more profoundly, i.e. explicitly inducing incommensurations in the spin correlations. Both patterns of the low -energy behavior of the system will be discussed below .

In model (3), only the vector part of the twist perturbation, $g_a T^a$, emerges in the continuum limit. The scalar part, $g_0 T^0$, although absent in the bare H am iltonian, is generated in the course of RG ow ¹⁰.

For this reason we will assume that such a term is present at the outset, with a bare amplitude g_0 .

Let us rst bosonize H_{JJ}. In terms of the rescaled eds, $i = (1 = \overline{Q})'_i$ and $i = \overline{Q} \#_i$, the \currents" $J_i^a = J_{i:R}^a + J_{i:L}^a$, are given by²⁴

where is the short-distance cuto of the bosonic theory, and (Q) is a nonuniversal (and yet unknown) positive constant approaching the value 1 in the SU (2) limit. The exact dependence of R on the dimensionless parameter $g_k Q = v_s$ is unknown. Therefore we will restrict ourselves to the case $jg_k jQ = v_s$ 1 and keep only linear terms in the expansion (12). For a weak interchain interaction $(jg_k \neq v_s = 1)$, this is justiled almost for the whole range j j < 1 except for a narrow region $+ 1 \qquad (g_k = v_s)^2$ close to the ferrom agnetic transition point. The parameters R then satisfy the relation

To bosonize the twist perturbation (8), we use the bosonization form ulas for the staggered m agnetization of the $S=1/2 \times X \times Z$ chain (see e.g. 19):

where $C_a(Q)$ (a = x;z) are noniniversal parameters (their exact dependence on Q was recently found in Refs. 25,26). Then, in terms of the elds , , the twist term becomes:

Thus, the bosonized continuum version of our model, $H = H_0 + H_{JJ;?} + H_{tw ist}$, represents a Gaussian eld theory of two scalar elds,

with perturbations (13) and (17) which couple the (+) and () channels together. Since H_0 is perturbed in a relevant way, the relationship between the coupling constants of the original model (1) and the parameters of H, obtained within our weak-coupling approach, is not to be

trusted. For this reason we will consider those parameters as independent. Namely, we will treat the Ham iltonian H as a low-energy elective theory for a most general class of frustrated zigzag spin-1/2 ladders, sharing the same symmetry properties with the model (1).

The scaling dimensions of the perturbing operators are:




FIG.1: The parameter space of the model

Their relevance (d < 2) or irrelevance (d > 2) can be understood from Fig.1 where the plane (K ;K₊) is shown. The point K₊ = K = 1 corresponds to the SU (2)-symmetric zig-zag ladder where all perturbations (including the Um klapp term) are marginal¹⁰. This point and its close vicinity will not be discussed in this paper. Due to the condition K₊ = K = Q^2 1, the physical part of the (K ;K₊) plane lies above the line K₊ = K and can be divided into four sectors in which at least one twist operator is relevant:

Notice that, except for the operator D, all other perturbing operators have a nonzero Lorentz spin: $S_{1;2;3} =$ 1, $S_F = 2$. Strictly speaking, the conventional criterium of relevance does not apply to such operators (see e.g. Ref. 19) because in higher orders of perturbation theory they can generate relevant scalar perturbations. U sing standard fusion rules for the G aussian model, we

have analyzed the structure of various terms appearing in the second order of perturbation theory. There are marginal terms leading to small corrections to the and the velocities \boldsymbol{v} , as well as those param eters K which renormalize the already existing coupling con-4 K₊ + , stants. Besides, new scalar operators cos2 , cos3 4 K and cos2 4 K ∞s2[•] 4 =K are generated. The rst two of them have scaling dim ensions 4Q R and 4Q = R, respectively, and are therefore strongly irrelevant (since Q > 1, R 1). The third operator has dimension 9K = 9R = Q and becomes relevant roughly at Q > 9=2, which is a region of the ferrom agnetic intrachain exchange, far away from the XX point. This region will not be considered here. Finally, the last perturbation cosŹ 4 K has dimension 4K = 4R = Q and thus becomes relevant at K < 1 = 2, which corresponds to a vicinity of the XX point Q = 2. However, even in that case its role is subdom inant, as we will show later.

The very possibility to incorporate such states within the variationalm ethod stem s from the fact that the twist operators (19) { (21) are products of elds belonging to di erent G aussian models H₀.

III. TW ISTLESS LADDER

Before addressing the role of the twist term s in (25) it is instructive rst to apply the variational approach to a simpler frustrated two-leg ladder model^{23,28} which, in the continuum limit, is free from parity-breaking perturbations yet being spontaneously dimerized. This model is the two leg-ladder version of the standard J_1 - J_2 frustrated H eisenberg plane, in which the interchain coupling includes besides the usual on-rung coupling, J_2 , a frustrating exchange, J, across the diagonals of the plaquettes. In the X X Z case its H am iltonian reads:

The $P_{S(L)}^{(1)}$ $P_{S(L)}^{(2)}$ rejection symmetry of the model (26) forbids the marginal twist perturbations to appear in the continuum limit. The additional condition $J_2 = 2J$ eliminates the $n_1^a n_2^a$ part of the interchain coupling and thus makes the two decoupled G aussian models only perturbed by the current-current interchain interaction (7) with coupling constants $g_2 = 2J$ 0a_0 and $g_k = 2J$ a_0 . So the bosonized continuum H am iltonian has the structure of Eq.(25) with $_2 \notin 0$ and $_{1;2;3} = 0$. As we shall see below, the dimenized phase it describes also occurs in the most part of sector C of the zigzag ladder, Eq.(25), where D is the most relevant perturbation to the G aussian models (22).

IV. CRITICAL SPIN NEMATIC PHASE

Now we are coming back to the continuum model (25) for the X X Z zig-zag ladder. We begin our discussion with sector A where the twist operator O_1 is the only relevant perturbation to the two decoupled G aussian models $H_0^{()}$. Making a shift $! + (1=4)^{P} = K$ we write the low-energy model in sector A as follows:

This type of ordering does not break time reversal symmetry. In sector A the spin nem atic phase is critical because the spin-density uctuations in the (+) channel remain gapless.

As the dimerized phase discissed in sec.III, the spin nem atic phase is doubly degenerate because the m ixed parity symmetry $P_{S(L)}^{(1)}P_{L(S)}^{(2)}$ is spontaneously broken in the ground state. The two degenerate phases di er in the signs of the longitudinal and transverse currents. Consequently, apart from the massless bosonic mode describing low-energy uctuations of the total magnetization, there exist massive topological Z₂ kinks corresponding to vacuum -vacuum transitions,

The presence of a nite longitudinal spin current in the ground state makes the transverse (xy) spin correlations incom m ensurate. Making use of bosonization rules (16), Eq. (43) and the fact that the eld is locked, one easily nds the asym ptotic behaviour of the transverse spin correlation function:

The last inequality, how ever, is not satis ed since the am plitude g $_{e}^{2}$ is rather sm all and, hence, the presence of the second harm onics does not qualitatively a ect the above results.

V. MASSIVE SPIN NEMATIC AND DIMERIZED PHASES

Let us now move to sectors B and C where the properties of the system s are determined by the interplay between two most relevant perturbations, O_1 and D. The

second twist perturbation, O₃, is either irrelevant (as in sector B) or the least relevant (as in sector C). In Appendix A we explicitly show that its role is indeed subdom inant in sectors B and C far from the SU (2)-symmetric point, $K_+ = K_- = 1$,

So in sector B (K $_+$ > 1) the M SN phase is energetically less favorable than the C SN phase, and the ground state should be chosen between C SN and D phases. A coordingly, in sector C (K $_+$ < 1) the competing phases are M SN and D.

Consider rst sector B. Here we need to compare the ground state energies of the D and CSN phases given by Eqs.(33) and (53). These are of the same order when the mass gaps of the two phases, Eqs. (31) and (46), become comparable. Notice that the coupling constants z_1 and z_2 are both proportional to g_2 and, hence are of the same order of m agnitude; their ratio is

As already mentioned, it is not possible to establish a precise relationship between the parameters of the original, microscopic model (3) and the elective low-energy theory (25). Therefore we are forced to consider two cases, $z_1 > z_2$ and $z_1 < z_2$, on equal footing and draw plausible scenarios for each of them, leaving the nalchoice to future numerical work.

It can be easily shown that in the case $z_1 < z_2$ the D phase, occupying a narrow region close to the line $K_+ = 1$, extends over the whole C phase.

In the opposite case, z_1 z, Eq.(67) has no solution for > 0, implying that CSN is a stable ground state in the whole sector B.M oving to sector C opens a possibility for the MSN phase. If 1 K₊ 1, the condition z_1 z adm its a small nonzero mass M₊ given by (62). Thus is sector C the upper boundary for the MSN phase is K₊ = 1. The lower boundary is found from the requirement cos < 1 (see Eq. (61)). W ithin the logarithm ic accuracy, this brings us again to Eq.(67), this time for (K) < 0.




FIG .2: Possible phase transitions in the ladder: the left one is when $z_2\ <\ z_1$, M SN phase is very narrow, and the right one is for $z_2\ >\ z_1$




FIG. 3: The st path shows one possible way of going through CSN, MSN and D phases when $z_2 < z_1$, by increasing and keeping ⁰ to be a constant. The right gure shows the qualitative change of the spin current (solid line) and the dem erization order parameter (dashed line) following this path. In the second path by decreasing ⁰ and keeping at constant value, the ladder enters the F phase.

W hen moving from sector B to sector C through the M SN phase, the mixing angle varies from =2 to 0. Correspondingly, the current J_+ decreases from its nom - inal value $[J_+\ b_{SN}$ and vanishes at the lower boundary, whereas the transverse dimerization $_2$ increases from zero at the upper boundary and reaches its value $_0$, Eq.(36), in the pure D phase at the lower boundary (see Fig. 2). A possible way of driving the ladder to pass through these phases is shown in Fig. 3.

The (+) channel remains gapless. Together with the nite spontaneous magnetization this circum stance makes the longitudinal spin correlations algebraic and incom mensurate:

VII. RG APPROACH AT A-D BOUNDARY

The results of sections IV and VI are valid far enough from the boundary between sectors A and D where one of the two twist operators, O_{1,2}, is strongly relevant while the other is strongly irrelevant. On the boundary K = 1 separating these sectors both twist operators become e m arginal. Therefore we can expect that in the immediate vicinity of the boundary,

far away from the SU (2)-symmetric point, i.e. $K_+ > 1$ in the sense that $K_+ = 0$ (1), the infrared behavior of model will be controlled by the interplay between the two parity-breaking operators with a nonzero conformal spin, $O_{1;2}$, and the longitudinal (conform al-scalar) term s $\mathcal{C}_{x} = \mathcal{C}_{x} = \mathcal{C}_{x}$ responsible for renorm alization of the coupling constants. So the starting low -energy model should therefore contain both twist term s:

Notice that the two twist terms in (76) contain vertex operators (the sines) of mutually dual and nonlocal eds,

and . M odels of this kind cannot be treated by the variational m ethod used in the preceeding sections. This is why in this section we address the RG ow of this m odel which w ill be studied using a m apping of the bosonic H am iltonian (76) onto a theory of four interacting real (M a jorana) ferm ions (c.f. Ref.10).

Let us rst make all perturbations in (76) strictly marginal. This can be done by the following rescaling

The meaning of the rst rescaling is transparent: we enforce the twist operators in (76) to have the scaling dimension 2. This rescaling generates a current-current term in the ({) channel. On the other hand, fusing the two twist operators, one generates a similar term in the (+) sector; that will renorm alize the parameter K_{+} , $K_+ ! It is understood that extra factors appearing due to rescaling of K + are absorbed into a rede nition of the coupling constants $_1$ and $_2$.

Due to its chiral asymmetry, the interaction in (82) gives rise to renorm alization of the velocities already on the one-loop level. For this reason we will discrim inate between the velocities of di erent M a prana species, and set $v_a = v(1 \quad 4 \quad a)$ (a = 0;1;2;3); where the dimensionless parameters a are subject to renormalization with initial conditions $a^{(0)} = 0$:

The cases (a) and (b) describe the CSN and F phases, respectively. Estimations (92), (94) are consistent with the power-law scaling of the corresponding mass gaps, Eqs.(46) and (72). In both cases, j_+ (1) j_- ow s to strong coupling. It goes to large negative values in the case (a), implying that K + becomes even larger upon renorm alization. In the case (b) it ows to large positive values; so the e ective K + signi cantly reduces, and that m ight indicate the importance of the neglected twist operator O₃. Stability of the F phase is therefore under question.

So, if in addition we set $g_1 = g_2$, the 1-loop RG will display a weak-coupling regime for all coupling constants. This is the self-dual point of the model where the interaction is not renorm alized: for all e ective couplings parametrizing interaction the {function vanishes. Am aizingly, in this case the Majorana action (82) decouples into two chirally asymmetric, independent parts, $S = S_1 + S_{TL}$, where

Notice that even though the present case corresponds to an essentially an isotropic regime (rem em ber that we are far away from the SU (2)-sym m etric point of the model), the e ective theory on the boundary between sectors A and D (K = 1) with the selfduality condition $g_1 = g_2$ exhibits an enlarged, chiral SO (3) SO (3) sym m etry. Consistent with this sym m etry is renorm alization of the velocities. The velocity of the singlet ferm ion, 0 , stays intact: _0 = 0. However, the triplet velocity is renormalized. The RG equation $_{\pm}$ = 4g² ($_{i}$ t i = 1;2;3) shows that 4 t (1) increases upon renorm alization and reaches values of the order of 1 in the region where $g^2 l$ 1. This sets up an infrared energy scale in the problem, $!_0$ $\exp(\cosh t = g^2)$, at which the triplet collective excitations soften signi cantly. This is in agreem ent with the exact results for the spectrum of m odel (96), recently obtained by T svelik³².

Interestingly enough, the exact solution³² shows that the chiral SO (3) symmetry of the action (96) is spontaneously broken at T = 0, and the ground state of the model represents a \chiral ferrom agnet" characterized by a nonzero expectation value of the vector current:

As long as the actions S_I and S_{II} are decoupled, there is no correlation between hIi and hIi, or equivalently, between the magnetization m = hIi + hIi and spin current j = hIi Ifi: Such correlation appears upon deviation from the A {D boundary since in this case chirallysymmetric terms that couple the actions S_I and S_{II} (and also introduce a nite XXZ anisotropy) are generated. Thus, in the A-vicinity of the A {D boundary m_z € 0, j_z = 0, whereas in the D-vicinity the situation is just inverted: m_z = 0, j_z € 0. So, the resulting picture at the A {D boundary depends on the side from which this boundary is approached, in plying that the CSN {F transition is rst-order.

Even though the action $S = S_I + S_{II}$ provides the sim – plest eld-theoretical model for a frustrated ladder with a chirally asym metric interaction and, hence, is quite interesting in its own right, we will refrain from its further discussion because it does not account for the low -energy properties of the zigzag spin-1/2 ladder with the generic SU (2) symmetry (the point $K_{+} = K_{-} = 1$).

VIII. CONCLUSIONS

In this paper we have analyzed the phase diagram of the spin-1/2 an isotropic zigzag ladder with a weak interchain coupling $(J^0 J)$. Using the Abelian bosonization method combined with a variational approach, we have found that, depending on the anisotropy param eters, the system occurs either in the parity and tim e-reversal sym m etric, spontaneously dim erized phase, or in one of those phases in which either parity is spontaneously broken while time reversal preserved, or vice versa. These are the critical and m assive spin nem atic phases (C SN, M SN) and the critical ferrom agnetic (F) phase. We have show n that the CSN phase extends well beyond the XX lim it and covers broad regions A and B in the param eter space of the XXZ model (see Figs2). Each of these phases is characterized by topological excitations carrying fractional quantum num bers.

Starting from a vicinity of the XX point, we addressed the nature of the transition between the CSN and D phases taking place upon increasing the intra-chain anisotropy parameter, say, at a xed positive value of 0 . Typical curves are shown in Fig.2. In these two Figures we show two possible scenarios whose realization depends on the ratio $(z_1=z_2)$ between the amplitudes of the main competing perturbations { the twist operator O_1 and the dimerization eld D. The reason we considered each of these scenarios on equal footing is due to the fact that the relationship between the param eters of our bosonized model, Eq.(25), and those of the microscopic Ham iltonian (3) is nonuniversal and, hence, known only by the order of magnitude. If $z_2 > z_1$, the CSN { D transition is rst order. In the opposite case, $z_2 < z_1$, the CSN and D phases are sandwiched by the MSN phase characterized by the coexistence of a nite spin current with dimerization. Then the variational approach uanm biguously shows that CSN {M SN and M SN { D transitions are continuous, even though it is inadequate to identify their universality classes. We believe that the nal choice between the two possibilities discussed in this paper will be made in future num erical work (The accuracy of the recent DM RG calculations^{11,12} for the S = 1/2zigzag ladders was reported to be inadequte to resolve this issue. M oreover, the non-linear m odel approach of Ref. 17, which excludes the massive chiral phase for half integer spins, is only valid in the vicinity of the classical Liftshitz point j = 1=4.)

Starting from the region A occupied by the CSN phase, one can also keep the in-chain anisotropy intact and vary continuously the interchain anisotropy. In particular, one can smoothly go from the case of an antiferrom agnetic interchain coupling ($g_k > 0$) to the case of a ferrom agnetic coupling ($g_k < 0$) (see Fig.1). We have shown that

in such situation the ladder crosses over from the CSN phase to the F phase, the latter being dual to the form er.

There also exist solutions in which both twist perturbations are elective. One of them corresponds to the case

The case of arbitrary values of the mixing angles, ; \notin 0; =2, should be abandoned because, as follows from Eqs.(A 3), it requires that $z_1^2 z_3^2 = z_2^2$, { a condition which represents just a point in the parameter space of the model and which, on the other hand, cannot be satis ed for all coupling constants being of the sam e order.

The m inim al value of the variational energy is again given by Eq.(32). From this expression it is obvious that in sector C (K < 1) the M phase has a low erenergy than each of its \constituents", i.e. C SN and CRM phases. So we are left to nd out if the M and M RM phases can compete with the D and M SN phase.

Consider the M RM phase assuming the most favorable condition $z_3 > z_2$. Since the M RM phase is \dual" to the M SN phase, from Eq.(68) we can read o the range where it can exist:

We see that, except for an extrem ely unrealistic case $z_3^2 > z_2$, the condition (A 4) determ ines a vicinity of the negative sem iaxis K = 1, K₊ < 1, which is located in

the unphysical part of the (K $_{+}$;K $\,$) plane, well beyond sector C . Thus the M RM $\,$ phase should be abandoned.

Let us com pare the energies of the M and M SN phases. In both cases the mass M is given by the same expression, so we only need to compare the masses in the (+) channel. Comparing the mass M₊ in the M phase, M₊ $z_3^{1=(1 \ K_+)}$, with that in the M SN phase, Eq. (62), we nd that, except for extrem ely small values of z_2 , namely $z_2 < z_1 z_3$, the M SN phase is always more favorable.

Finally, we are left to compare the energies of the M

and D phases. On one hand, in the D phase we are below the line (68). This means that $z_2^{\frac{1}{2}} \sum_{k_D} > z_1^{\frac{1}{1-k}}$ implying that the mass gap of the D phase is greater than the mass M of the M phase. On the other hand, to the left of the M SD-D transition line (A 4) we have the condition $z_2^{\frac{1}{2}} \sum_{k_D} > z_3^{\frac{1}{1-k}}$ that tells us that the mass of the D phase is greater than the mass M₊ of the M phase. Consequently, the D phase is energetically more favorable than the M phase.
