Bernoulli potential in type-I and weak type-II superconductors: Surface charge

The electrostatic potential close to the surface of superconductors in the M eissner state is discussed. W e show that beside the B emoulli potential, the quasiparticle screening, and the therm odynam ic contribution due to R ickayzen, there is a non-local contribution which is large for both type-I and weak type-II superconductors.

I.H ISTORICAL REVIEW

The electrostatic potential in superconductors is known already for seven decades. W ithin the pre-London approaches based on the ideal charged liquid, the electrostatic potential was assumed to balance the Lorentz and the inertial forces acting on diam agnetic currents.¹ The current j = env ow s along the surface and its am plitude falls o exponentially from the surface into the bulk. Sim ilarly the screened magnetic eld decays. The balancing electrostatic potential was found to be of the Bernoulli type, e' = $\frac{1}{2}mv^2$, therefore it falls o on the scale of half the London penetration depth. From the Poisson equation,

one nds that this corresponds to a charge accum ulated in the layer penetrated by the magnetic eld. To maintain the charge neutrality, the accum ulated bulk charge has to be accompanied by the opposite surface charge. This picture has been con med by the London theory.²

A.Advanced London-type approaches

The electrostatic potential equals the Bernoulli potential only at zero tem perature when all electrons are in the superconducting condensate. At nite tem peratures, a part n_n of electrons remains in the norm al state, while the rest $n_s = n - n_h$ contributes to the supercurrent, $j = en_s v$. The electric force acting on normal electrons is transferred to the condensate via a mechanism which rem inds one of the fountain e ect in super uid helium. As a consequence, the electrostatic potential reduces to $e' = \frac{n_s}{n} \frac{1}{2} m v^2$. This reduction of the potential derived by van Vijfeijken and Staas³ has a som ehow confusing name: the quasiparticle screening. It should be noted that the electrostatic potential caused by currents in superconductors is traditionally called the Bernoulli potential in spite of the quasiparticle screening and other non-Bemoulli contributions found later.

Jakem an and P ike recovered the result of van V ijfeijken and Staas from the static and the classical limit of the tim e-dependent G inzburg-Landau (G L) theory.⁴ U nlike previous studies, their approach includes the real screening due to spatial distribution of the charge, therefore it describes the surface charge as a space charge localized on the scale of the T hom as Ferm i screening length. T his picture of the surface charge was accepted for a long tim e as it looks natural and seem s to be justi ed from the sem im icroscopic theory.

Later studies of the electrostatic potential did not readdress the question of the surface charge but attem pted to overcom e the hydrodynam ic picture common to all the above mentioned studies. Naturally, they focused on a detailed description of the Bernoulli potential on the scale of the London penetration depth.

A dkins and W aldram recovered the Bernoullipotential from the BCS theory for the system at zero tem perature.⁵ They also indicated that at nite tem peratures one should expect a contribution which depends on the band structure.

The predicted contribution has been evaluated by Rickayzen.⁶ He used the therm odynam ic approach which yields

The density dependence of the condensate density can be evaluated either from the BCS theory leading to the result of A dkins and W aldram or from the two-uid relation $n_{\rm s}$ n 1 $\frac{T^4}{T^4}$. The latter gives a simple form ula

The rst term balances the Lorentz and inertial forces, while the second re ects the pairing. W e will call term s proportional to $\frac{\theta \ln T_c}{\theta \ln n}$ the therm odynam ic correction.

In the next decade, the interest in the electrostatic potential in superconductors shifted towards nonequilibrium situations, see e.g. Ref. 7. It should be noted that the B emoullipotential introduced within the theory of non-equilibrium systems is not the same as the one we discuss. W ithin the non-equilibrium theory the term B emoulli potential is used for the velocity-dependent part of the energy of C ooper pairs. Only in equilibrium, the velocity-dependent energy agrees with the electrostatic potential we discuss here.

B.GL approaches { local

New studies of the Bernoulli potential in equilibrium have been stimulated by the question of the vortex charge. Khom skii et al.^{8;9} have used the idea of van der M arel¹⁰ to derive a simple estimate of the electrostatic potential in term softhe superconducting gap. The obtained form ula corresponds to the therm odynamic correction of R ickayzen with the original balance term being om itted. While the validity of the approach is restricted to tem peratures close to T_c , it has the advantage, how – ever, that it can be applied within the GL theory. B latter et al.¹¹ have em ployed this estimate to predict a possible electrostatic eld above the surface of the superconductor with the vortex lattice perpendicular to it.

A n opposite lim it represents the treatment of the vortex charge by LeB lanc.¹² He considers only the balance term om itting the therm odynamic correction completely. A sone can see from Rickayzen's formula, this approximation is limited to the region of low temperatures.

C.GL approaches { non-local

A llthe above mentioned theories have in common that the electrostatic potential is a local function of the classical kinetic energy or of the gap. In other words, they neglect the gradient of the condensate. The non-local corrections within the GL theory have been proposed in R ef. 13. It turned out that the non-local corrections are taken into account if the classical kinetic energy in the balance equation is replaced by its quantum -mechanical counterpart.

For our next discussion it is important that the non-local contributions can be rearranged into a local form 13 Indeed, within the GL theory the sum of the kinetic energy and the GL potential is zero which allow sus to express the balance term via the local GL potential. Note that this rearrangement is possible only within the non-local theory, because gradients of the condensate density $n_{\rm s}=2j$ f, where ~ is the GL wave function, provide important contributions to the quantum kinetic energy, in particular close to the surface.

In Ref. 13, the quasiparticle screening and the therm odynamic correction have been neglected, the complete theory has been presented in Ref. 14. The detailed derivation together with estimates of material parameters and the num erical treatment of the A brikosov vortex lattice in niobium at various temperatures can be found in Ref. 15. Again, all contributions including the kinetic energy can be expressed in a local relation ' [j $\frac{2}{7}$].

The non-local form of the Bernoulli potential requires to reconsider the picture of surface charges. It is paradoxical that the possibility to rearrange the non-local corrections into a local function plays the crucial role. As noticed already by Yam polskii et al,¹⁶ if the electrostatic potential is of the form ' [j f], the GL boundary condition, r = 0 in the direction norm alto the surface, im plies that no surface charge is needed. Indeed, at the surface r' = $\frac{\theta'}{\theta}$ r = 0. The electric eld thus vanishes at the surface which is a su cient condition for the charge neutrality.

D.Plan of the paper

Apparently, there is no surface charge on the scale of the Thom as Ferm i screening length. The electric eld due to the dipole between the surface charge and the bulk charge was supposed to balance the Lorentz force, therefore one has to ask the question how the balance of forces looks if the surface charge is absent.

The charge prole in the vicinity of the surface has been num erically studied in Ref. 17. This study was limited to thin slabs and type-II superconductors, its results indicate, how ever, that the charge prole at the surface tends to organize into two layers - a narrow surface charge and a thicker bulk charge.

In this paper we discuss the charge and potential prole at the surface of a sem i-in nite superconductor in the M eissner state. In the next section we shortly describe the surface charge within the GL theory. In section III we discuss the limit of a weak magnetic eld, where all results can be derived analytically. We will show that the B emoulli potential at the surface di ers from the value predicted by R ickayzen. The correction has the form of a multiplicative factor that approaches unity for the extrem e type-II superconductor. Numerical results on strong magnetic elds are presented in section IV revealing a nonlinear mechanism which, how ever, is found to be very sm all. The conclusions and outlook are presented in section V.

II. SURFACE CHARGE W ITH IN THE G IN ZBURG -LANDAU TYPE THEORY




FIG.1. The charge prole close to the surface for 4 different magnetic elds. The magnetic eld is given in dimensionless units proportional to the magnetic ux quanta, $B_0 = _0 = (2 \ _0^2) = e_0 nh=2m$. The coordinate x is measured in units of the London penetration depth $_0$ at zero temperature. The assumed temperature t = $T=T_c = 0.9$ yields the penetration depth $= 1.7 \ _0$. The charge is scaled with B^2 so that the two lowest magnetic elds $B = 0.01B_0$ and $B = 0.1B_0$ give nearly identical curves. The magnetic eld $B = 0.34B_0$ is close to the critical value. The GL parameter $_{GL} = 1$ corresponds to weak type-II superconductors.

A typical pro le with the charge distribution close to the planar surface and hom ogeneous external m agnetic elds is shown in Fig. 1. The pro le has been obtained by a num erical solution of the GL equation

where n is the density of pairable electrons, is the linear coe cient of the speci c heat, m = 2m and e = 2e are the m ass and charge of the C ooper pair, and $t = T = T_c$ is

the tem perature on the scale of the critical tem perature. In the assumed geometry one can use the London gauge in which the GL wave function is real.

Equation (4) has been proposed by B ardeen as an extension to low tem peratures.¹⁸ In fact, B ardeen arrived to this equation independently adding the quantum kinetic energy to the G orter-C asim ir two- uid model. C lose to the critical tem perature the G L function has a sm allm agnitude $2 \frac{2}{n} \frac{n}{n}$ which allows one to expand the square-root 1= $1 \frac{2}{n} \frac{2}{c} 1 + \frac{1}{n} 2$, and one nds the custom - ary G L equation with parameters = $T_c^2 (t^2 - 1)=2n$ and = $T_c^2 t^2 = n^2$.

E quations (4) and (5) are solved together with T_c kept constant.

From the GL wave function we evaluate the Bernoulli potential 15

The density dependence of and T_c has been estimated from the experimental specic heat, theoretical freeelectron density of states, and the M cM illan form ula¹⁹, see Appendix in Ref. 15. The Thomas-Ferm i screening length, $\frac{2}{T_F} = -\frac{\frac{2}{K_H^2 - 0}}{e^2}$, is very small and its contribution can be neglected, because the general integral which is proportional to exp($x = T_F$) is zero since no surface charge form s on this scale.

In the nal step the charge pro le is evaluated from the Poisson equation (1).

III.LOW MAGNETIC FIELDS

In weak magnetic elds the GL wave function is only little perturbed from its bulk value = 1 + w ith 1. In this limit the charge prole can be solved

analytically.

In the M axwell equation (5) the vector potential is a small quantity so that the perturbation of the wave does not contribute in lowest order. The vector potential can thus be solved taking $_1 = \frac{1}{n(1 + 1)} = 2$. For both types of superconductors, this results in a simple exponential decay of the vector potential,

on the scale of the London penetration depth = $_{0}^{-1} = \frac{1}{1} t^{2}$, with $_{0}^{2} = 2m = (_{0}e^{2}n)$. Here B is the value of the magnetic eld at the surface at x = 0.

A.GL wave function

The linear approximation of the GL equation (4) reads

The general integral of (9) can also include a growing term / $\exp(\overline{2x}=)$. This term is excluded, because the perturbation asymptotically vanishes in the bulk, ! 0 for x ! 1.

From the GL boundary condition, r = 0 at x = 0, we determine the two amplitudes are linked by

where = = . We note that within Bardeen's extension of the GL theory, the ratio = depends on the tem – perature, = $_{GL}=t^2$, where $_{GL} = \frac{m}{ne} \frac{T_c}{n}$ is the ordinary GL parameter de ned at T_c . The diverging effective GL parameter at low temperatures shows that within Bardeen's approximation any system behaves as a type-II superconductor at su ciently low temperatures. This feature contrasts with the linearly decreasing e ective GL parameter one nds close to the upper critical magnetic edd.¹⁵. O f course, the strong temperature dependence of is rather an artifact of the model. Since

is the most important quantity of the GL theory, one can simply take and as input parameters.

The amplitude of the particular integral is obtained from the GL equation (9) as

The amplitude of the general integral is given by the charge neutrality, which requires r' = 0 at x = 0. From (16) follows

The relative amplitudes proportional to $_{TF}$ = and $_{TF}$ = are not su ciently small to be neglected. The charge density is given by the second derivatives so that one obtains relative amplitudes of the charge density at the surface proportional to = $_{TF}$ or to = $_{TF}$. The surface charge is an integral, i.e. the contribution in question is proportional to the amplitude at the surface multiplied with the Thom as Ferm i length. A coording to condition (19) all charges can have com parable values.

To prove that the screening on the scale of the T hom as-Ferm i length $_{TF}$ and the related surface charge can be neglected, one has to employ the GL boundary condition r = 0 at x = 0. U sing (11) one obtains

so that the general integral is proportional to the cube of the sm all ratio $_{\rm TF}$ = . A coordingly, the charge due to the general integral is sm aller by a factor $_{\rm TF}^2$ = 2 than the charge created by the particular integral. In the following we neglect this contribution for sim plicity of notation. W ithin the same level of accuracy we take C = C and C = C.

Now we are ready to evaluate the electrostatic potential. Using (11) and (12) we obtain from (16)

This linearized relation extends Rickayzen's formula to type-I and weak type-II superconductors.

Let us not take a look at the extreme type-II superconductor, 1, for which Rickayzen's form ula is recovered. For the assumed real GL wave function, the current is proportional to the vector potential $j = \frac{e^2}{m} \frac{2}{1} A = \frac{e^2}{m} n_s A$. With the velocity de ned via the current, $j = e^2 \frac{2}{1} v = en_s v$, one nds from (7) the relation between the magnetic pressure and the kinetic energy $e^{2x} = \frac{B^2}{2} \frac{n}{n} = \frac{n_s}{n} \frac{1}{2} m v^2$. Equation (21) yields then the Bernoulli potential as

We have used $n_s = n (1 \quad t)$ and $n_n = nt^4$ to express the tem perature dependence in terms of the condensate fraction.

O ne can see that R ickayzen's form ula (3) holds for extrem e type-II superconductors, ! 1 . In this lim it the general integral has a vanishingly sm all am plitude and the factor $1=(1+\frac{p-2}{2})$ goes to unity. For nite the general integral deform s the pro le of the potential and the particular integral has a reduced am plitude.

W ithin Bardeen's extension of the GL theory, Rickayzen's formula is always recovered at low temperatures as diverges with $1=t^2$. Since Rickayzen's formula approaches the plain Bernoullipotential fort! 0, the presented derivation also reproduces London's result.

C.Behavior for nite

As already shown, for the extrem e type-II superconductor, ! 1, the general integral vanishes as 1 = and far from the surface it decays faster than the particular integral. The Bernoulli potential thus extends on the scale =2.

For the nite GL parameter in the region $> \frac{P}{2}$ the overall picture is rather sim ilar. The general integral is appreciable only close to the surface so that the scale on which the Bernoullipotential extends is still =2. Besides, the amplitude of the particular integral is enhanced by the factor 1=(1 $2=2^{2}$). For the region < 2, the role of the general and par-

For the region $< \frac{1}{2}$, the role of the general and particular integrals are reversed. First of all, the amplitude of the general integral is larger than the amplitude of the particular integral. Since the general integral also decays m ore slow ly in this case, the Bernoulli potential is dom – inated by the general integral and extends on the scale

 $\stackrel{P}{=}$ $\stackrel{\overline{2}}{2}$. The reversed role is also supported by the fact that the signs of both parts are opposite as compared to the case > $\stackrel{\overline{2}}{2}$. This sign reversal appears due to the enhancement factor 1=(1 2=²).

Apparently, both components of ' diverge as approaches 2. Their sum remains regular, how ever. For this particular case the scale of both contributions is identical, namely =2. It is advantageous to use expression (21) to obtain the asymptotic form of the Bernoulli potential




FIG.2. Bernoulli potential as a function of the distance from the surface for 4 di erent magnetic elds. The parameters are the same as in Fig.1.

The Bernoullipotentials for di erent values of them agnetic eld are shown in Fig.2. The lim it of low magnetic elds agrees with the analytical form ula (22), of course. One can see that for the two lowest elds B = 0.01 and B = 0.1, the potential keeps its pro le while its magnitude scales with B^2 . For magnetic elds close to the

critical value B_{c2} ply.

D.Charge pro le

The charge density results from the Bernoullipotential (21) and the Poisson equation (1) as

Note that the relative amplitude of the two contributions is reciprocal to the relative amplitude of the potentials. Integrating from zero to in nity one can check that the total charge is zero, as it is required by the charge neutrality.

The resulting charge density is small compared to the total density of electrons en. The ratio of the amplitude of (24) to the total electron density can be written as

Even for upper estimates of the magnetic eld by the critical value, B B_c , the factor (25) is extremely small. For niobium $B^2 = _0 = \frac{1}{2} T_c^2 = 32 10^4 J/m^3$, while $m c^2 = 10^{13} J$. This suggests that the maximum charge density will be of the order of 10^{18} electrons per cubic meter. This is by ten orders of magnitude smaller than the electron density of niobium $n = 22 10^{28} m^3$. This small value of the accumulated or depleted charge justies to ignore the charge probe in the Maxwell equation (5) and the change of material parameters like , n and T_c in the GL equation (4). Similarly to the potential, the charge prole rejects two scales, =2 and = $\overline{2}$. Before we analyze its properties for various values of the GL parameter , we want to discuss a few general features. First, the surface value of the charge, obtained for x = 0 in (24), is always negative, i.e. the charge carriers are depleted. We call the layer of the negative charge the surface charge. Second, in the bulk su ciently far from the surface the charge is positive, i.e., the charge carriers are accumulated. We call the region of positive charge the bulk charge. Third, the width w of the surface is given by (w) = 0. From (24) follow s

In the extrem e type-II superconductor, ! 1, the surface charge is form ed by the contribution on the scale of the GL coherence length . The width of the surface goes to a value w ! $\frac{p}{2} \ln \frac{p}{2}$. The bulk charge extends on the scale of the London penetration depth as it is known from the classical picture.

For the limiting case $! \frac{1}{2}$ the width of the surface charge is =2. The charge density has the prole

Note the di erent sign inside the last parentheses con <u>–</u> pared to the Bernoulli potential (23). Since =2 = = 2 one cannot associate the surface and the bulk charge to the GL coherence length or to .

For $< \frac{1}{2}$, the surface charge is form ed by the contribution on the scale of the London penetration depth. For

 $\frac{1}{2}$, the width of the surface charge is w $!_{\overline{2}} \ln \frac{1}{2}$. The bulk charge extends on the scale of the GL coherence length as one can see from (24).

IV.STRONG MAGNETIC FIELD

In strong m agnetic elds the GL wave function is suppressed in the vicinity of the surface which has to be accounted for in the M axwellequation. In this case one has to face the fact that the system of equations (4) and (5) is nonlinear. We present only a few numerical solutions to point out some features typical for strong m agnetic elds.




FIG.3. The deviation of the wave function from its bulk value $_1 = n(1 t^4)=2$ 0.6 as a function of the distance from the surface. The parameters are the same as in Fig.1.

The nonlinear e ects in strong magnetic elds follow from a deviation of the wave function from its bulk value. In the dimensionless representation used in Fig. 3 the bulk value is $_1 = \frac{1}{n=2} \cdot \frac{1}{1} \cdot \frac{1}{4} = 0.6$. For the low est eld B = 0.01, the deviation is nearly zero on the scale of the graph. A lso for B = 0.1 the approximation j j $_1$ is justified. For higher elds the deviation becomes appreciable.

The suppression of the wave function at the surface shown in Fig. 3 a ects the Bernoulli potential by two di erent mechanisms. First, the screening current is reduced at the surface so that the magnetic eld penetrates deeper into the superconductor. This feature can be seen in Fig. 2, how ever, it is better visible in the prole of the charge density shown in Fig. 1, as a widening of the surface layer.




FIG.4. The charge density which is proportional to the density dependence of the linear coe cient of the speci c heat versus distance from the surface. We use the value for niobium, $@\ln =@\ln n = 0.42$, which is close to the parabolic band approximation $_{par} / n^{1=3}$, i.e., $@\ln _{par} =@\ln n = 1=3$.

Second, the therm odynamic contributions to the Bernoulli potential are nonlinear in the wave function, see (6). In contrast, the linearized approximation of the Bernoulli potential (21) or (22) does not depend on the density derivative of the linear coe cient of the speci c heat, $\ell = \ell n$, included in the derivative of the condensation energy $\frac{1}{4}$ T_c². Beyond the linearized approximation, this derivative contributes as demonstrated in Fig. 4 for parameters of niobium.

C om paring the contribution of ℓ =0 n with the total charge density shown in F ig.1, one can see that this particular nonlinear mechanism is rather small giving less than 3% of the total charge density. This small value justi es the approximations $^{8;9;11}$ using only the term proportional to $\ell T_{\rm c}=0$ n.

V.CONCLUSIONS

In conclusion, we have shown that the Bernoulli potential in superconductors can be discussed by the charge build up in the region between the surface and m ax [= $\overline{2}$; =2]. The thinner depleted charge region carries the surface charge. In contrast to former theories which assumed that the surface charge is localized on the scale of Thom as Ferm iscreening length $_{\rm TF}$, we nd that the surface charge extends over a range L = m in [= $\overline{2}$; =2]. In fact, there is a nonzero contribution on the scale of $_{\rm TF}$, but of a negligibly small amplitude proportional to $_{\rm TF}^2$ =L².

For extreme type-II superconductors we have conmed the picture known already from London with the thermodynamic corrections by Rickayzen. The bulk charge extends on the scale of the London penetration depth =2. The surface charge is localized on the scale of the GL coherence length = $\frac{p}{2}$ which is negligible in this limit anyway. This is in agreement with the classical treatment which neglects all gradient contributions.

In type-I or weak type-II superconductors, is for the GL parameter < 2, one nds the opposite situation. The surface charge is localized on the scale of the London penetration depth while the bulk extends on the scale of the GL coherence length = 2. In this case the gradient contributions are dominant and local London-type theories naturally fail.

In strong magnetic elds the Bernoulli potential becomes a non-quadratic function of the magnetic eld. This feature parallels the nonlinear susceptibility as it is dominated by the enhanced penetration of strong magnetic elds into superconductors. There is an additional therm odynam ic correction absent in low magnetic elds, how ever, for realistic material parameters (like for niobium) it accounts for less than 3% of the charge density. Thus the approximations used in^{8;9;11} are justi ed.

Finally we rem ind that the potential discussed here does not include the surface dipole which a ects the potential seen outside the sam ple. We will discuss this contribution in a forthcom ing paper.
