Enhanced Stability of Bound Pairs at Nonzero Lattice Momenta

A two-body problem on the square lattice is analyzed. The interaction potential consists of strong on-site repulsion and nearest-neighbor attraction. The exact pairing conditions are derived for s-, p-, and d-sym metric bound states. The pairing conditions are strong functions of the total pair momentum K. It is found that the stability of pairs increases with K. At weak attraction, the pairs do not form at the -point but stabilize at lattice momenta close to the B rillouin zone boundary. The phase boundaries in the momentum space, which separate stable and unstable pairs are calculated. It is found that the pairs are form ed easier along the (;0) direction than along the (;) direction. This might lead to the appearance of \hot pairing spots" on the K x and K y axes.

I. IN TRODUCTION

The short coherence length observed in high-tem perature superconductors has stimulated theoretical research on real-space pairing on the lattice. Strong electronphonon and electron-electron interactions coupled with week screening and reduced dimensionality lead to form ation of preform ed bound pairs that Bose-condense and form a super uid state^{1,2}. The two interacting particles on a lattice constitute a class of exactly solvable quantum mechanicalproblems.A number of physical characteristics can be obtained in closed analytical form s: the pairing threshold, binding energy, wave function, e ective radius, and others. It is essential that the reduction of the two-body Schrodinger equation to a one-body Schrodinger equation occurs di erently than in a continuous space. The underlying lattice introduces a preferred reference frame, which results in non-trivial dependencies of the physical quantities on the total lattice m om entum of the pair K .

In the present work we show that bound states on a lattice become more stable at large K. This property is opposite to the Cooper pairs in a BCS superconductor. The e ect is best seen through the K-dependence of the threshold value of the attractive potential. In two dimensions, the threshold is always zero if the potential is purely attractive. Therefore, it is essential to consider mixed repulsive-attractive potentials. (Such potentials are also more realistic.) A natural choice is the Hubbard on-site repulsion U combined with an attraction V acting on one or more layers of nearest neighbors. The latter mim is the overscreened C oulomb interaction resulted from electron-phonon interactions with distant lattice ions^{3,4}.

G eneral properties of the two-body states on a lattice were reviewed by M attis⁵. Lin gave the rst solution for the s-sym m etric singlet ground state in the U V m odel⁶. In fact, that solution was presented as the low – density limit of the t J m odel. Petukhov, G alan, and Verges extended the solution to the p-sym m etric triplet and d-sym m etric singlet pairs, again in the fram ew ork of the t J m odel. K omilovitch found pairing thresholds for a family of U V models, in which attraction extended beyond the rst nearest neighbors⁸. Basu, G ooding, and Leung studied pairing in a U V model with anisotropic hopping⁹. Two-body problem swere also solved for severalm odels with multi-band single-particle spectra^{10,11,12}.

P revious studies were mostly con ned to the -point of the pair B rillouin zone. (Reference [7] does contain som e results for the diagonal and the boundary of the B rillouin zone.) In this work we focus on the K -dependence of the pairs properties. We form ulate and solve the pair stability problem in its general form. We de ne the pairing surface inside the B rillouin zone, which separates the regions of pair stability from the regions of pair instability. We also show that, in general, the shape of the pairing surface is di erent from the shape of the single-particle Ferm i surface. The di erence leads to the appearance of pairing \hot spots", which are regions in the B rillouin zone where real space pairing takes place while being energetically unfavorable elsewhere.

II. THE TW O PARTICLE SCHROD INGER EQUATION

In this paper we consider the sim plest U V m odel on the square lattice, the one that includes attraction between the rst nearest neighbors only. Form ore com plex attractive potentials, see R ef. [8]. The m odel H am iltonian reads

Here m = n + 1 denotes a lattice site that is a nearest neighbor to $n, n_n = c_n^y c_n$, and $n_n = n_{n^{\#}} + n_{n^{\#}}$. The rest of notation is standard. We allow one spinup ferm ion and one spin-down ferm ion in the system. It is convenient to not to x the permutation symmetry of the coordinate wave function from outset. In this way, the singlet and triplet solutions will be obtained simultaneously. The system is fully described by the tight-binding amplitude $(n_1;n_2)$ or, equivalently, by its Fourier transform $(k_1;k_2)$. Fourier transform ation of the Schrodinger equation with H am iltonian (1) yields an equation for :

where l = (1;0); (0; 1) are the four nearest-neighbor vectors of the square lattice, E is the combined energy of the particles, and " $(k) = t_1 \exp(ikl) =$

 $2t(\cos k_x + \cos k_y)$ is the free single-particle spectrum. The integral equation (2) is solved by introducing ve functions (K) that depend only on the total lattice momentum K = $k_1 + k_2$:

The wave function is then expressed as follows:

Substituting this solution back into the de nitions (3) and (4) one obtains a system of linear equations for $_{(0;0)}$, $_{(+1;0)}$, $_{(1;0)}$, $_{(0;+1)}$, and $_{(0;1)}$. The determ inant of that system de nes energy E as a function of K :

The eigenvector of the above system, upon substitution in Eq.(5), de nes the pair wave function up to a norm alization constant.

The derived form ulae illustrate the general structure of two-body lattice solutions. The spectrum equation is a determ inant, with the dimension equal to the total number of sites within the interaction range. In the present model this number is ve, one for the Hubbard term and four for the nearest-neighbor attraction. An eigenvector of the corresponding matrix determ ines the two-particle wave function. The matrix elements are momentum integrals of the ratio of two energy polynom ials P_{n^2-1} (E)= P_{n^2} (E), where n is the number of one-particle

energy bands. On the square lattice n = 1, hence the simple form of the integrals L_p . The copper-oxygen plane is a more complex case with n = 3. The corresponding two-body lattice problem was solved in Ref. [11].

A nalytical investigation of the spectrum and wave function may be di cult, especially in cases when matrix elements are not calculable in closed form s. The pairing threshold is easier to nd because the determ inant needs to be analyzed only at one special energy point. At the same time, the threshold is a convenient and sensitive indicator of pair stability. The binding condition of model (1) will be the prime focus of the rest of this paper.

The spectrum equation (6) depends on three parameters: the interaction potentials U and V, and the total lattice m om entum K of the pair. A binding condition is de ned as a functional relation between U, V, and K, when the energy of a bound state becomes equal to the lowest energy of two free particles with the same com – bined m om entum K. At xed K, the m inim um energy is realized when both particles have equal m om enta K =2. This is because the kinetic energy of relative m otion is zero. This statement can also be derived rigorously by m inim izing a sum of two single-particle energies. The m inim um energy is given by

Thus real-space bound states are form ed by particles m oving parallel to each other. This should be compared with the Cooper pairs, which are form ed by quasiparticles with opposite m om enta.

In agine a bound state with energy E (K) just below $E_0(K)$, and let E (K) ! $E_0(K)$. The spectrum equation then de ness a relationship between U, V, and K, which is the pairing condition of interest. Before attempting general solution let us consider the point. At K = (0;0) the solution acquires additional sym metry, which simpli es analysis of the spectrum equation. The new basis functions are eigen-functions of the sym m etry operators of the square lattice. States of di erent sym m etries separate and m atrix (6) becom es blockdiagonal. W e consider the blocks separately.

and $L_{0s}^0 = 4L_{s0}^0$. Substitution $E = E_0 = 8t$ leads to logarithm ic divergence of all integrals L^0 . In order to circum vent this di culty, add and subtract L_{00}^0 , $4L_{00}^0$, and $4L_{00}^0$ from L_{s0}^0 , L_{0s}^0 , and L_{ss}^0 , respectively. The di erences converge in the lim it E ! $8t: L_{s0}^0 = \frac{1}{8t}$, $L_{0s}^0 = \frac{1}{2t}$, and $L_{ss}^0 = \frac{1}{2t}$. Upon expansion of the 2 2 determ inant the $(L_{00}^0)^2$ term s cancel while the rest yields

The equation is satis ed when the coe cient at the divergent L_{00}^{0} is zero. This results in the binding condition for the s-symmetric pair^{6,7}:

In the weak coupling lim it U;V t, the threshold reduces to $V_{\rm s}=\frac{1}{4}U$. The factor 4 here is the number of nearest neighbors: the on-site repulsion needs to be 4 times stronger to balance the attraction acting on 4 sites at once. In the lim it of in nite Hubbard repulsion, the attraction threshold $V_{\rm s}$ (U ! 1) = 2t is nite. Limited in uence of an in nite repulsive potential is explained by vanishing of the wave function at $r_1=r_2$. W ithout the repulsion, the attractive threshold goes to zero, as expected in two dimensions. Thus the Hubbard term raises $V_{\rm s}$ from zero to 2t.

p-symmetry. Two 1 1 blocks describe two-particle states with p orbital symmetry. Their energy is determined by the equation

St. Integration results in the binding condition for p-symmetric pairs⁷:

Notice that neither the spectrum nor the binding condition depends on the Hubbard potential U .




FIG.1: Phase diagram of the two-particle model (1) at K = (0;0). No bound states exist below the lowest solid curve. The phase boundaries are described by Eqs. (13), (15), and (17). The dashed line indicates the limit value of the s-state threshold $V_s = 2t$ for an in nitely strong Hubbard potential.

d-sym m etry. The last 1 1 block describes two-particle states with d orbital sym m etry. The spectrum equation is

As with p-symmetric pairs, the binding condition does not depend on U. This is because the wave functions of the p and d states are identically zero at $r_1 = r_2$. The contact potential is not felt even at smallV.

Figure 1 shows the \phase diagram " of the two-particle system at the -point.

III. THE GENERAL BIND ING CONDITION

Let us return to the full spectrum equation (6) and d nd the binding condition at an arbitrary pairm om entum K. First, using the explicit form of "(q) and shifting q by

The subscripts of M $_{\rm nm}$ refer to the frequencies of $\cos nq_{\rm x}$ and $\cos m \, q_{\rm y}$ in the numerator of the integrand. Upon substitution E $\,!\,$ E $_0$ (K) all M $_{\rm nm}\,$ diverge logarithm ically. Similarly to the -point case, a divergent M $_{00}$ is subtracted and added to each M $_{\rm nm}$. The di erences converge. A straightforw and calculation yields:

On the next step, the determ inant (6) is expanded resulting in a lengthy expression, which is in general a ffhorder polynom ial in M₀₀. However, the coe cients at the second through ffh powers cancel identically. The spectrum equation reduces to A M₀ + B = 0, where A and B are some complicated functions of M_{nm}. A is given below as the lh.s. of Eq. (21).] C ancellation of the high-order powers of logarithm ically divergent term s was observed in other two-dim ensionalm odels^{8,11,12}. It seem s to be a general property of the pairing problem in two dim ensions, although no rigorous proof is given here. In the present m odel, the divergence of M₀₀ in plies A = 0. A fier lengthy transform ations and factorizations the last condition can be written as follow s:

This is the general binding condition sought. It represents the main analytical result of the paper. The rst two factors correspond to the two p-symmetric triplet pairs. This is best seen at the diagonal of the Brillouin zone $K_x = K_y$, which implies a = b. This yields $M_{02} = M_{20} = (2)=(2 \cos (K_x=2))$, and the binding

At K $_x = 0$, the last equation reduces to Eq. (15). Hence, it is idential ed with the p-states.

Equation (22) is a particular example of the general e ect: the enhanced stability of bound states at large lattice m on enta. Indeed, the pairing threshold decreases with K $_{\rm x}$ and vanishes completely in the corner of the B rillouin zone. At any V < 5:50t, there exists a pairing surface in the B rillouin zone, which separates stable and unstable bound states with p orbital sym m etry. The concrete form of the pairing surface can be found num erically.

N ext, consider the last factor in Eq. (21), which describes the s-and d-sym m etric pairs. The binding condition does not factorize at arbitrary K. However, factorization occurs at the diagonal of the B rillouin zone where M $_{02}$ = M $_{20}$ and M $_{01}$ = M $_{10}$ = $[8 \tan (K_x=2)]^{1}$

C om paring the binding conditions on the B rillouin zone diagonalwith the -point, one observes that in both cases the hopping integralt is replaced with tcos (K $_x$ =2). The s binding condition approaches 2tcos (K $_x$ =2) in the limit of in nite U. The d binding condition does not depend on U at all. A gain, the stability of bound states increases with the pairm om entum.




FIG.2: Pairing surfaces for U = 50t and V = 1.5t. Bound pairs are stable outside the respective surfaces. At these param eters both p and d surfaces term inate at the Brillouin zone boundaries: p at (0.46 ;) and (; 0.46); d at (0.41 ;) and (; 0.41). The p and d surfaces actually cross.

At an arbitrary pair m om entum, the pairing surface can be found num erically by solving the transcendental equation (21). Figure 2 shows the pairing surfaces for V = 1.5t and U = 50t. If 0 < V < 2Ut = (U + 8t), there are four pairing surfaces corresponding to the s, two p, and d pairs. At V = 2Ut = (U + 8t), the s pairing surface shrinks to a point indicating that the s-sym m etrical bound pair is the ground state of the system at any m om entum K. Sim ilarly, there are two p and one d pairing surfaces at 2Ut = (U + 8t) < V < 5:50t, only one d pairing surface at 5:50t < V < 7:32t, and no surfaces at all at V > 7:32t.





FIG. 3: The pairing surfaces of the s-sym metrical bound state for U = 50 t and severalV, obtained by solving Eq. (21). Going from outside inward, the plots correspond to V = 0.2 t, 0.5 t, 1.0 t, 1.3 t, 1.5 t, 1.6 t, and 1.7 t. The surface shrinks to the origin at V = 2U t= (U + 8t) = 1.724 t. The pairing surface never crosses the boundaries of the Brillouin zone.

Let us discuss the evolution of pairing surfaces with V in more detail. Figure 3 shows the evolution of the s surface at U = 50t. At sm all V, the pairing surface approaches the boundaries of the B rillouin zone. For most K, the strong repulsion overcomes the weak attraction and the ground state consists of two unbound particles. But in the very vicinity of the B rillouin zone boundary the scattering phase space shrinks, allowing form ation of a bound state with a binding energy V. The pair stability region exists for any nite V, however sm all. The pairing surface never crosses the boundary of the B rillouin zone. (The latter fact was noticed in Ref. [7].) As V increases the stability region expands. The pairing

surface shrinks while assuming a circular shape. Finally, at V = 2U t = (U + 8t) it collapses to the -point.




FIG. 4: The pairing surface of one of the two p-symmetric bound states for U = 50t. Going from outside inward, the lines correspond to V = 1:0t, 2:0t, 3:0t, 4:0t, 5:0t, and 5:4t. The four end points of the V = 1:0t plot are indicated by semicircles. When V ! 5:50t, the surface shrinks to the origin but remains elliptic with the eccentricity e = 2 (3)=(3 8) = 0:63. The second family of the p pairing surfaces is obtained by rotating the plots by =2.

Figure 4 shows the V-evolution of one of the p-states pairing surfaces. At small V the surface term inates at some points along the K $_{\rm y}$ = boundaries. The K_x coordinate of the end points is given by the condition $2t\cos(K_x=2) = V$. There are no end points along the boundaries. At V = 2t, the two pairs of K_x = end points merge at (0;) resulting in an elliptically shaped critical surface. As V increases further, the critical surface shrinks to the origin while retaining the elliptic shape. The ratio of the two axes of the ellipse is (3 8)=(4) = 129. The pairing surface for the second p-symmetric bound state is obtained by rotating the plots of Fig. 4 by =2.

The d-state pairing surface is symmetric under the $K_x \$ K_y exchange, as evident from Fig. 2. There are four pairs of end points with the non-trivial momentum coordinate determ ined by the condition 2t(U 2V) cos ($K_{x,y}=2$) = UV. At V = 2U t=(U + 4t), the end points merge at (0;) and (;0). At larger V the pairing surface assumes the circular shape similar to the s-surface shown in Fig. 3. The d-surface shrinks to the origin at V = 7:32 t.

IV. DISCUSSION

In continuous space the internal (binding) energy of a composite non-relativistic particle is independent of its momentum, and the elective mass is independent of the

internal energy. In contrast, on a lattice the total mass increases with the internal binding energy⁵. In this paper, we established another unusual property of lattice pairs: the stability of a bound state increases with its m om entum. A lthough the total pair energy grows with them om entum, the corresponding energy of two free particles grows faster. As a result, at the Brillouin zone boundary the energy of the bound state always lies below the continuum of single-particle states. At the boundary, the periodicity of the pair wave function is com m ensurate with the lattice. The particles could choose to coherently \see" only one component of the potential. At the same time, the kinetic energy of the relative motion is suppressed because of shrinking of the phase space available for mutual scattering. Thus as long as the interaction potential has at least one attractive region the particles willbind.

In two dimensions the e ect is somewhat hidden by the fact that an arbitrary weak attractive potential binds particles even at the -point. As K increases no qualitative changes happen and the pair remains stable. The situation is dierent when the potential has strong repulsive pieces. At the -point the repulsion overcomes the attraction resulting in a non-bound ground state. But at the Brilloiun zone boundary the ground state is always bound. By continuity, a pairing surface must exist that separates stable from unstable bound states. The shape and size of the pairing surface is a sensitive characteristic of the potential. Exam ples of such surfaces were given in the previous section.

Imagine now a nite density of fermions. As lling increases, particles with large momenta become available. At some lling, the double Ferm i surface crosses the pairing surface. (The single-particle Ferm i surface should be multiplied by a factor of 2 for adequate com parison.) In general the two surfaces have di erent shapes. Therefore crossing begins at som e \hot" segments of the Ferm i surface. The phenom enon is illustrated in Figure 5. The pairing surface for U = 50t and V = 0.8tis compared with the double Ferm i surface corresponding to a Fermi energy 2:1t (lling = 0.35 particles per unit cell). Notice how the pairing surface is elongated along the diagonals of the Brillouin zone while the Ferm i surface is elongated along the K_x and K_y axes. The overlay of the surfaces creates four regions near (;0),) where pairing correlations are enhanced. Un-(0; der such conditions a particle with a momentum close to (=2;0) or (0; =2) can pick up a second particle with the same momentum and form a bound state. Such a pairing mechanism is in contrast with the Cooper pairing. O by jously, the presence of led states modi es the low-energy scattering dynam ics of the pair. A nalysis of

the many-body model (1) near a paring instability is a di cult problem, which warrants a separate investigation. An interesting question is whether the U-negative V " model possesses a state where bound pairs with non-zero momenta \setminus oat" atop a ferm ion sea. Apart from academ ic interest, such a state m ay be of interest for the pseudogap phenom enon in high-tem perature superconductors. (For the latter see, e.g., R ef. [13].) O ne possible approach to the problem would be the scattering matrix approximation, which has been successfully applied to the negative H ubbard model^{14,15}.

In conclusion, we have considered a two-particle lattice problem with on-site repulsion and nearest-neighbor attraction. The stability of the bound states increases with the pair's totalm on entum, which is a consequence of the lattice discreteness. The e ect is conveniently described in term s of the pairing surface that separates stable from unstable pairs. Exact pairing surfaces for s-, p-, and dsym m etric bound states have been found and analyzed. At nite llings, the appearance of \hot pairing spots" is possible, caused by the di erence in shapes between the pairing and Ferm i surfaces.
