## N on-A brikosov V ortex and Topological K not in Two-gap Superconductor

W e establish the existence of topologically stable knot in two-gap superconductor whose topology  $_3$  (S²) is xed by the Chem-Sim on index of the electrom agnetic potential. We present a helical magnetic vortex solution in G inzburg-Landau theory of two-gap superconductor which has a non-vanishing condensate at the core, and identify the knot as a twisted magnetic vortex ring made of the helical vortex. We discuss how the knot can be constructed in the recent two-gap MgB2 superconductor.

Topological objects, in particular nite energy topological objects have played in portant role in physics. In condensed matter physics the best known topological object is the Abrikosov vortex in one-gap superconductors (and similar ones in Bose-Einstein condensates and super uids), which have been the subject of intensive studies. But the advent of two-com ponent BEC and two-gap superconductors [1, 2] has opened a new possibility for us to have farm ore interesting topological objects in condensed matters [3, 4, 5, 6, 7]. The purpose of this Letter is two-fold; to present a new type of non-Abrikosov vortex which has a non-vanishing condensate at the core and to establish the existence of a stable knot in Abelian two-gap superconductors. We rst construct a new type of non-Abrikosov vortex which has a non-vanishing condensate at the core in Ginzburg-Landau theory of two-gap superconductor, and show that it can be twisted to form a helical magnetic vortex. With this we show that the twisted vortex ring made of the helical magnetic vortex becomes a topological knot whose knot topology 3 (S<sup>2</sup>) is xed by the Chem-Sim on index of the electrom agnetic potential. The knot has two supercurrents, the electromagnetic current around the knot tube which con nes the magnetic ux and the neutral current along the knot which generates a net angularm om entum which prevents the collapse of the knot, This means that the knot has a dynamical (as well as topological) stability.

There have been two objections against the existence of a stable magnetic vortex ring in Abelian superconductors. First, it is supposed to be unstable due to the tension created by the ring [8]. Indeed if one contructs a vortex ring from an Abrikisov vortex, it becomes unstable because of the tension. On the other hand, if we rst twist the magnetic vortex making it periodic in z-

In mean eld approximation the Hamiltonian of the Ginzburg-Landau theory of two-gap superconductor could be expressed by [7]

coordinate and then make a vortex ring connecting the periodic ends together, it should become a stable vortex ring. This is because the non-trivial twist of the magnetic eld forbids the untwisting of the vortex ring by any smooth deformation of eld con guration. The other ob jection is that the Abelian gauge theory is supposed to have no non-trivial knot topology which allows a stable vortex ring. This again is a comm on misconception. A ctually the theory has a well-de ned knot topology  $_3$  (S<sup>2</sup>) described by the Chem-Sim on index of the electrom agnetic potential. So a priori there is no reason whatsoever why the Abelian superconductor can not have a topologicalknot. The real question then is whether the dynam ics of the superconductor can actually allow such a knot con guration. In the following we show that indeed a two-gap Abelian superconductor does.

where  $_{ij}$  are the quartic coupling constants and  $_{i}$  are the chem ical potentials. But in this paper we will adopt the following potential for simplicity

Notice that when = 0, the Ham iltonian (2) has a global SU (2) sym metry as well as the the local U (1) sym metry, so that the term can be viewed as a sym metry breaking term of SU (2) to U (1). We choose (4) simply because the existence of the topological objects we discuss in this paper is not so sensitive to the detailed form of the potential.

we have the following equations of motion [3]

where  $\sim$  is the Paulim atrix and  $\hat{k} = (0;0;1)$ . Notice that it has the vacuum at = 0, and = (1;0) or = (0;1).

The equation allows two conserved currents, the electrom agnetic current  $j\,$  and the neutral current  $k\,$  ,

which are nothing but the N oether currents of the U (1) U (1) sym m etry of the H am iltonian (2). Indeed they are the sum and di erence of two electrom agnetic currents of  $_{\rm 1}$  and  $_{\rm 2}$

C learly the conservation of j follows from the last equation of (6). But the conservation of k comes from the second equation of (6), which (together with the last equation) tells the existence of a partially conserved SU (2) current  $\tilde{j}$ ,

This SU (2) current is exactly conserved when = 0. But notice that  $k = \hat{k}$  j. This assures the conservation of k even when 6 0. It is interesting to notice that j and k are precisely the fi and  $\hat{k}$  components of j.

Now, we impose the following boundary condition for the non-Abelian vortex,

This need some explanation. First, notice that here we have (0) = 0, not (0) = 0. This would have been unacceptable in one-gap superconductor because this would




FIG. 1: The helical vortex (solid line) with m=n=1 and the straight vortex (dotted line) m=0 and n=1 in two-gap superconductor. Here we have put g=1; =2,  $k=0:1_0$ , =0:01, and % is in the unit of  $l=_0$ . Notice that the straight vortex has no  $A_2$ .

create a singularity at the core of the vortex. But with the ansatz (10) the boundary condition allows a smooth vortex in two-gap superconductor. Secondly, we have  $A_2$  (0) = 0 in stead of a condition on  $A_2$  (0). It turns out that this is the correct way to obtain a smooth solution. Indeed we not that  $A_2$  (0) is determined by k.

With the boundary condition we can integrate (12) and obtain the non-Abelian vortex solution of the twogap superconductor which is shown in Fig.1. Notice that we have plotted  $_1 = \cos f = 2$  and  $_2 = \sin f = 2$  which represent the density of 1 and 2, in stead of and f, in the gure. There are three points that should be emphasized here. First, the doublet starts from the second com ponent at the core, but the rst com ponent takes over completely at the in nity. This is due to the boundary condition f(0) =and f(1) = 0, which assures that our solution describes a new type of non-Abrikosov vortex which has a non-vanishing condensate at the core [3]. Secondly the electrom agnetic current j of the vortex is helical, so that it creates a helical magnetic ux which has a quantized ux  $\dot{z} = 2$  n=g around the z-axis as well as a (fractionally) quantized ux  $_{n} = 2 \text{ m A}_{2}(0) = q$ along the z-axis. And obviously the two magnetic uxes are linked together. But it creates a net current  $\mathbf{i}_{^{\prime\prime}}$  only around the z-axis, with  $i_2 = i_2^{(1)} + i_2^{(2)} = 0$ . Finally the vortex has another (neutral) helical k , which has a net current  $k_{\hat{\boldsymbol{z}}}$  along the z-axis (as well as  $k_{^{\prime\prime}}$  around the vortex). Notice that  $k_{\hat{z}}=i_{\hat{z}}^{(1)}$   $i_{\hat{z}}^{(2)}=2i_{\hat{z}}^{(1)}$  . This is because the two electrom agnetic currents  $i_{2}^{(1)}$  and  $i_{2}^{(2)}$  of  $_{1}$  and 2 are equal but ow oppositely, which generates a nonvanishing  $k_2$ . This is why we call kan eutral current. In this sense the vortex can be viewed as superconducting, even though the net electrom agnetic current along the knot is zero. The two helical supercurrents j and k are




FIG. 2: The helical supercurrents with m=n=1 in two-gap superconductor. Here we have put  $g=1; =2, k=0:1_0, =0:01$ , and % is in the unit of l=0.

## plotted in Fig. 2.

Of course, the helical magnetic vortex has only a heuristic value, because it will be untwisted unless the periodicity condition is enforced by hand. But if we make a vortex ring by smoothly bending and connecting two periodic ends, the periodicity condition is naturally enforced. And the twisted magnetic vortex ring becomes a topological knot  $\beta$ . There are two ways to describe the knot topology. First, the doublet (in the vortex ring) acquires a non-trivial topology  $_3$  (S²) which provides the knot quantum number,

This is nothing but the Chem-Sim on index of the potential C. Perhaps more importantly, the knot topology can also be described by the Chem-Sim on index of the electrom agnetic potential A. Indeed we have

which describes the twisted knot topology of the real (physical) magnetic ux. It describes the linking number of two quantized magnetic uxes  $_2$  and  $_{\sim}$ . O bviously two ux rings linked together can not be separated by any continuous deform ation of the eld con guration. This provides the topological stability of the knot.

Furtherm ore the topological stability is backed up by a dynam ical stability. This is because the knot ism ade of two quantized magnetic uxes linked together. And the ux trapped inside of the knot ring can not be squeezed out, and provides a repulsive force against the collapse of the knot. This makes the knot dynam ically stable. An-




FIG .3: (Color online). The energy pro le of superconducting knot with m = n = 1. Here we have put g = 1; = 2, k = 0.1 0, = 0.01.

otherway to understand this dynam ical stability is to notice that the neutral supercurrent  $k_2$  of the helical vortex becom es a supercurrent along the knot, which generates a net angularm om entum around the knot. And this provides the centrifugal repulsive force preventing the knot to collapse. This makes the knot dynam ically stable. We can not the energy probe of the twisted magnetic vortex ring numerically. Minimizing the energy we obtain the energy probe of the knot shown in Fig. 3.

C learly the dynam ical stability of the knot comes from the helical structure of the vortex. But this helical structure is precisely what provides the knot topology to the vortex ring. The nontrivial topology expresses itself in the form of the helical magnetic ux which provides the dynam ical stability of the knot. Conversely the helical magnetic ux assures the existence of the knot topology which guarantees the topological stability of the knot. It is this remarkable interplay between dynamics and topology which assures the existence of the stable superconducting knot in two-gap superconductor.

We close with the following remarks:

1. The existence of a knot in two-gap superconductor has been conjectured before [3, 7]. In fact, similar knots have been asserted to exist almost everywhere in physics, in atom ic physics in two-component Bose-E instein con-

densates [3, 5, 6], in nuclear physics in Skyrme theory [9, 10], in high energy physics in QCD [11]. In this paper we have provided a concrete evidence for the existence of a stable knot in two-gap superconductor, which can be interpreted as a twisted magnetic vortex ring.

- 2. In this Letter we have concentrated on the Abelian gauge theory of two-gap superconductor, which is made of two condensates of same charge. But we emphasize that a similar knot should also exist in the non-Abelian gauge theory of two-gap superconductor which describes two condensates of opposite charge [4]. This is because two theories are mathematically identical to each other. This implies that such a knot can also exist in the liquid metallic hydrogen (LMH), because it can also be viewed as a non-Abelian two-gap superconductor made of opposite charge (the proton pairs and the electron pairs) [12].
- 3. One should try to construct the topological knot experimentally in two-gap superconductors. But before one does that, one must rst con rm the existence of the non-Abrikosov vortex which has a non-vanishing condensate (the second component) at the core. This is very important because this will prove the existence of a new type of magnetic vortex in two-gap superconductor. With this con rmation one may try to construct the helical vortex and the knot. With some experimental ingenuity one should be able to construct these topological objects in MgB $_2$  or LMH.

As we have remarked there is a wide class of realistic potentials which allows similar non-Abrikosov vortex and topological knot. The detailed discussion on the subject and its applications in the presence of a more general potential which includes the Josephson interaction will be discussed separately [13].
