A spherical perfect lens

It has been recently proved that a slab of negative refractive index m aterial acts as a perfect lens in that it m akes accessible the sub-wavelength in age information contained in the evanescent m odes of a source. Here we elaborate on perfect lens solutions to spherical shells of negative refractive m aterial where m agni cation of the near-eld in ages become spossible. The negative refractive m aterials then need to be spatially dispersive with "(r) 1=r and (r) 1=r. We concentrate on lens-like solutions for the extrem e near-eld limit. Then the conditions for the TM and TE polarized m odes become independent of and "respectively.

I. IN TRODUCTION




FIG.1: Radiation from a point source on one side of a slab of material with i = 1 and = 1 is reflocussed into a point on the other side. The rays representing propagating waves are bent on to the other side of the norm alat the interfaces due to the negative refractive index of the slab.

The possibility of a perfect lens [1] whose resolution is not limited by the classical di raction limit has been subject to intense debate by the scienti c community during the past two years. This perfect lens could be realised by using a slab of m aterial with " = = 1 where " is the dielectric constant and the is the magnetic permeability. Veselago p — = 1 (the negative sign of had observed [2] that such a m aterial would have a negative refractive index of n = the square root needs to be chosen by requirem ents of causality), and a slab of such a m aterial would act as a lens in that it would refocus incident rays from a point source on one side into a point on the other side of the slab (See Fig. 1). Due to the unavailability of materials with simultaneously negative " and ", negative refractive index remained an academ ic curiosity until recently when it becam e possible to fabricate structured m eta-m aterials that have negative and [3, 4, 5]. M ost of the negative refractive m aterials (NRM), so far, consist of interleaving arrays of thin m etallic [7]). Although som e wires (that provide negative "[6]) and metallic split-ring resonators (that provide negative initial concerns were expressed [8] that the observed e ects in these experiments were dom inated by absorption, the recent experiments of Refs.[9, 10, 11, 12] have con med that negative refractive materials are today's reality.

It was dem onstrated by one of us that the NRM slab acts a lens not only for the propagating waves (for which the ray analysis of Veselago is valid) but also for the evanescent near- eld radiation []. This phenom enon of perfect lensing becomes possible due to the surface plasm on states [13] that reside on the surfaces of the NRM slab which restore the amplitudes of the decaying evanescent waves [1, 14, 15, 16, 17, 18]. Indeed, it has been con med by

num erical (FDTD) sinulations that an incident pulse is tem porarily trapped at the interfaces for a considerable time [19]. For a detailed description of the perfect slab lens, we refer the reader to Ref. [1, 17, 20]. The 'perfectness' of the perfect lens is limited only by the extent to which the constituent NRM are perfect with the speci ed material parameters. Absorption in the NRM and deviations of the material parameters from the resonant surface plasm on conditions of the perfect lens causes signi cant degradation of the subwavelength resolution possible [4, 21, 22, 23]. We have suggested some possible measures to am eliorate this degradation of the lens resolution by stratifying the lens medium [24] and introducing optical gain into the system [25].

The image formed by the NRM slab lens is identical to the object and hence there is no magni cation in the image. Lenses are mostly used to produce magni ed or demagni ed images and the lack of any magni cation is a great restriction on the slab lens on which most of the attention in the literature has been focussed. The slab lens is invariant in the transverse directions and conserves the parallel component of the wave-vector. To cause magni cation this tranverse invariance will have to be broken and curved surfaces necessarily have to be involved. The perfect lens e ect is dependent on the near-degeneracy of the surface plasm on resonances to amplify the near- eld, and curved surfaces in general have completely di erent surface plasm on spectrum 26]. It was recently pointed out by us that a family of near- eld lenses (in the quasi-static approximation) in two-dimensions can be generated by a conform al mapping of the slab lens [20]. Thus a cylinderical annulus with dielectric constant " = 1 was shown to have a lens-like property of projecting in and out im ages of charge distributions. Similiarly in Ref. [27] and [28], it was shown how a general method of co-ordinate transform ations could be used to map the perfect slab lens solution for the M axwell's equations into a variety of situations including the cylinderical and spherical geom etries respectively.

In this paper, we elaborate on the perfect lens solutions in the spherical geometry and show that media with spatially dispersive dielectric constant "(r)=sim 1=r and magnetic permeability (r)=sim 1=r can be used to fabricate a spherical perfect lens that can magnify the near-eld images as well. In section-2 of this paper, we will present these perfect lens solutions of the M axwell's equations for the spherical geometry. In section-3, we will exam ine the solutions in the extrem e near-eld limit or the quasi-static limit which is useful when the lengthscales in the problem are allmuch smaller than a wavelength. Then the requirements for TM and TE polarizations depend only on " $1=r^2$ or $1=r^2$ respectively. This is useful at frequencies where we are able to generate structures with only one of " or

negative. W e will investigate the e ects of dissipation in the NRM and point out the connections to the 1-D slab lens solutions. W e will present our concluding remarks in Section-4.

II. A PERFECT SPHERICAL LENS




FIG. 2: A spherical shell with negative " (r) 1=r and (r) 1=r in ages a source located inside the shell into the external region. The media outside have postive refractive index, but " (r)i 1=r and (r) 1=r. The ampli cation inside the spherical shell of the otherwise decaying eld is schematically shown.

Consider a spherically symmetric system shown in Fig. 2 consisting of a spherical shell of NRM with the dielectric constant " (r) and (r) in bedded in a positive refractive material with " $_+$ (r) and $_+$ (r). First of all we will nd the general solutions to the eld equations with spatially inhom ogeneous material parameters:

Under these circum stances of spherical symmetry, it is su cient to specify the quantities $(r \ E)$ and $(r \ H)$ which will constitute a full solution to the problem. Let us now look at the TM polarised modes $r \ H = 0$, implying that only the electric elds have a radial component E_r . Operating on Eqn. (1) by r, we have

and similarly for the magnetic elds. Note that the $B_{lm}^{(1)}$ correspond to the eld components of the source located at $r = a_0$. For causal solutions $A_{lm}^{(3)} = 0$. Now the tangential components of the magnetic elds and the norm al components of the displacement elds have to be continuous across the interfaces. Hence apart from a scaling factor of 1=r, the elds on the sphere $r = a_1 = (a_2^2 = a_1^2)a_0$ are identical to the elds on the sphere $r = a_0$. There is also a spatial magnic cation in the image by a factor of $a_2^2 = a_1^2$.

Let us note a couple of points about the above perfect lens solutions in the spherical geom etry. First, for $r > a_3$, i.e. points outside the in age surface the eds appear as if the source were located on the spherical in age surface ($r = a_3$). However, this is not true for points $a_2 < r < a_3$ within the in age surface. Second, given that " $(a_2) = "+ (a_2)$, we have the perfect lens solutions if and only if $n_+ = n$ which implies that p = 1 in Eqn. (13). A lthough the solutions given by Eqn. (14) occur in any medium with " $1=r^2$, the perfect lens solutions only occurs for "1=r. Here we have written down the solutions for the TM modes. The solutions for the TE modes can be similiarly obtained.

III. THE SPHERICAL NEAR-FIELD LENS

As it has been pointed out in the previous section, the power'solutions are good for any "(r) f^{2} and (r) f^{4} such that p + q = 2. However the perfect lens solutions for the M axwell's equations result only for the single case of p = q = 1. In the quasi-static limit of ! ! 0 and 1 jpj jqj we can relax this condition. In particular, by setting "(r) $1=r^{2}$ and (r) = constant, we can have a perfect lens for the TM m odes alone. Sim iliarly, we can have a perfect lens for the TE polarization by having $1=r^{2}$ and "= constant. This extreme near-eld limit is both important and valid for situations when all lengthscales in the problem are much smaller than a wavelength of the radiation. This becomes useful at frequencies where we can only generate media with either negative " and positive , or, negative and positive ". Examples are the silver slab lens at optical frequencies [1], the imeta-materials (Swiss rolls) used for MRI at radio-frequencies[29]. Particularly at radio- and microwave frequencies, we currently can practically engineer the required meta-materials with spatially dispersive characteristics at the corresponding length scales. Further it also lifts the restriction that the system has to have a spatially dispersive material parameters even outside the spherical shell of NRM. In this section we will work in this extreme near eld limit. Then it is su cient to solve the Laplace equation and we present lens-like solutions to the Laplace equation below.

Consider the spherical shell in Fig.2 to be led with a material with $_2$ (r) $C = \hat{r}$ with the inner and outer regions led with constant dielectrics of "and "a respectively. Let = 1 everywhere. Now place a charge + q at the centre of the concentric spheres and a charge q at a distance a_0 from the centre inside region-1. We will consider the z-axis to be along the dipole axis and make use of the azim uthal symmetry here, although it is clear that our results do not depend on any such assumption of azim uthal symmetry. Thus all our charge and their in ages will now lie along the Z-axis.

Now we will calculate the potentials in the three regions that satis es the Laplace equation and the continuity conditions at the interfaces. The potential in region-1 ($r < a_1$) can be calculated to be (using the azim uthal symmetry):

as $"_3="_1 = (a_1=a_2)^2$. Thus, on one side of the image (the region $r > a_3$) the elds of a point charge located at a_3 are reproduced. However it should be pointed out that there is no physical charge in the image location and, the elds on the other side of the image (i.e. in the region $a_2 < r < a_3$) do not converge to the elds of the object and cannot do so in the absence of a charge in the image. Further there is no change in the strength of the charge either. There is a magnic cation in the image formed by a factor of $(a_2=a_1)^2$.

Now let us consider the case of a point source placed at a_3 in the outer region. Again assuming the z-axis to pass through a_3 , we can write the potentials in the three regions as

i.e., that of a point charge of strength $q_1 = ("_1="_3)(a_1=a_2)^2 = q$ at $a_0 = a_3(a_1=a_2)^2$. As before, for the inner region of $r < a_0$, the system behaves as if there were a single charge of strength q located at $r = a_0$. Thus the shell has a lens-like action. We note that there is a dem agnic cation of $(a_1=a_2)^2$ in this case.

A. Sim iliarities to the 1-D slab lens

Let us point out the similarities to the planar slab lens. In both cases, the electrom agnetic eld grows in amplitude across the negative medium when the perfect lens conditions are satis ed at the interfaces: as an exponential(exp[+k_x z]) in the planar lens and as a power of the radial distance r^1 in the spherical lens. The decaying solution away from the source is absent in the negative medium in both cases. Further, when the perfect lens conditions are matched at both the interfaces, there is no receted wave in both the planar slab as well as the spherical lens: i.e. the impedance matching is perfect as well. In addition this mapping preserves the strength of the charge.

The key dimension of the spherical shell of the spatial $1=r^2$ dependence of the negative dielectric constant which relates the two positive dielectric constants to be $_1 = (a_1=a_2)^2_3$. But this need not be a particular restriction as we can use the ideas of the asymmetric lens to term inate the dimension of the magnetic space of the dielectric constant which relates that the image can now be magnined (or demagnined) when the image of the charge (source) is projected out of (or into) the spherical shell, which is true in the 2D cylinderical lens as well [20].

B. Possibility of the asym metric lens

In the case of a planar slab, it was possible to have the perfect lense ect by satisfying the required conditions at any one interface – not necessarily at both interfaces[17]. Particularly, in the lim it of very large parallel wave vectors the lensing is indeed perfect, although the image intensity di ered from the source by a constant factor. Sim iliarly let us now investigate the e ects of having the perfect lens conditions in the case of the spherical lens at only one of the interfaces.

Let us consider rst, the case of projecting out the in age of a point source from inside the spherical shell to outside and enable the perfect lens conditions only at the outer interface $_2(r = a_2) = _3$ and have an arbitrary $_1$. Now the A and B coe cients com e out to be

0 nly the growing solution within the negative spherical shell remains. The coe cient of the decaying solution (B₂₁) remains strictly zero. Thus, amplication of the decaying eld at least is possible in this case as well. But there is a

nite re ectivity in this case. However, the solution outside for r > a is not the exact in age eld of the point source as the coe cient B₃₁ has an extra dependence on 1 through the dependence on the dielectric constants. Moreover, the process does not preserve the strength of the charge due to the di erent dielectric constants involved. This should be compared to the solution of the planar asymmetric slab lens where, at least in the electrostastic lim it, the system behaved as a perfect lens. In this case, the system behaves as a spherical asymmetric perfect lens only in the lim it of large 1! 1. The solution outside the spherical shell is the same when we meet the perfect lens condition on the inner interface { just as in the case of the planar slab lens. However, the rejection coe cient is again non-zero, but di erent to the earlier case. In either case, the elds are largest at the interface where one meets the perfect lens conditions or the interface on which the surface plasm ons are excited.

C. E ects of dissipation

M edia with negative real part of the dielectric constant are absorptive (as all m etals are), and hence we can write the dielectric constant "(r) = $C = r^2 + i$ "_i(r) (N ote that "_i $1=r^2$ as well for us to be able to write the solution in the following form). Consider the state of projecting out the image of a dipole located within the spherical shell where the potential outside the shell is given by Equation (27) and B₃₁ is given by Equation (33). When we have a dissipative negative medium and have the perfect lens conditions at the interfaces on the real parts of the dielectric constant alone, "₂(a₁) = "₁ + i"₁(a₁) and "₂(a₂) = "₃ + i"₁(a₂). In parallel with the case of the planar lens, we

note that the denom inator of B_{31} consists of two terms, one containing a power of the (sm aller) radius a_1 and the other containing a power of the (larger) radius a_2 . Crucially the amplication of the evanescent elds depends on the possibility that the sm aller power dom inates by making the coe cient of the larger term as close as possible to zero. The presence of the imaginary part of the dielectric constant would not allow the coe cient to be zero and the image restoration is good only as long as the term containing a_1 dom inates in the denom inator of B_{31} , i.e.,

Hence a useful estim ate of the extent of in age resolution can be obtained by noting the multipole l for which the two terms in the denom inator are approximately equal[14]. We obtain for this value:

Higher order multipoles are essentially unresolved in the image. We can similarly obtain the same criterion by considering the second case of tranferring the image of a charge located outside the spherical shell into the inner region. Again, we can consider the e ects of deviating from the perfect lens conditions on the real part of the dielectric constant as well and obtain a similiar limit for the image resolution due to those deviations.

IV. CONCLUSIONS

In conclusion, we have presented a spherical perfect lens which enables m agni cation of the near- eld im ages. The perfect lens solution requires media with "(r) 1=r and (r) 1=r and the conditions " $(a_{1,2}) = "+ (a_{1,2})$ and $(a_{1,2}) = + (a_{1,2})$ at the interfaces of the spherical shell of the NRM. We have shown that in the quasi-static lim it of sm all frequencies (! ! 0) and high-order multipoles 1 jp; this condition can be relaxed and the two polarizations (TE and TM modes) decouple. Thus a shell with negative dielectric constant " (r) $1=\hat{r}$ with = constant can act as a near- eld lens for the TM polarization while (r) $1=\hat{r}$ with " (r) = constant acts as a near- eld lens for the TM polarization in the lens material, how ever, prevents good resolution of higher order multipoles. Thus while the near- eld lens works in the asymmetric mode only in the lim it of high order multipoles. Thus one has to nd an intermediate regime where dissipation does not wipe out the near- eld lenses.

To have a solution as a single power of r, the only choices possible for the dielectric constant are either " = C, a constant { the usual case, or " = $C = r^2$. In the latter case the solution is U (r) r^{l+2} or U (r) $r^{(l-1)}$. The full solution can then be written as
